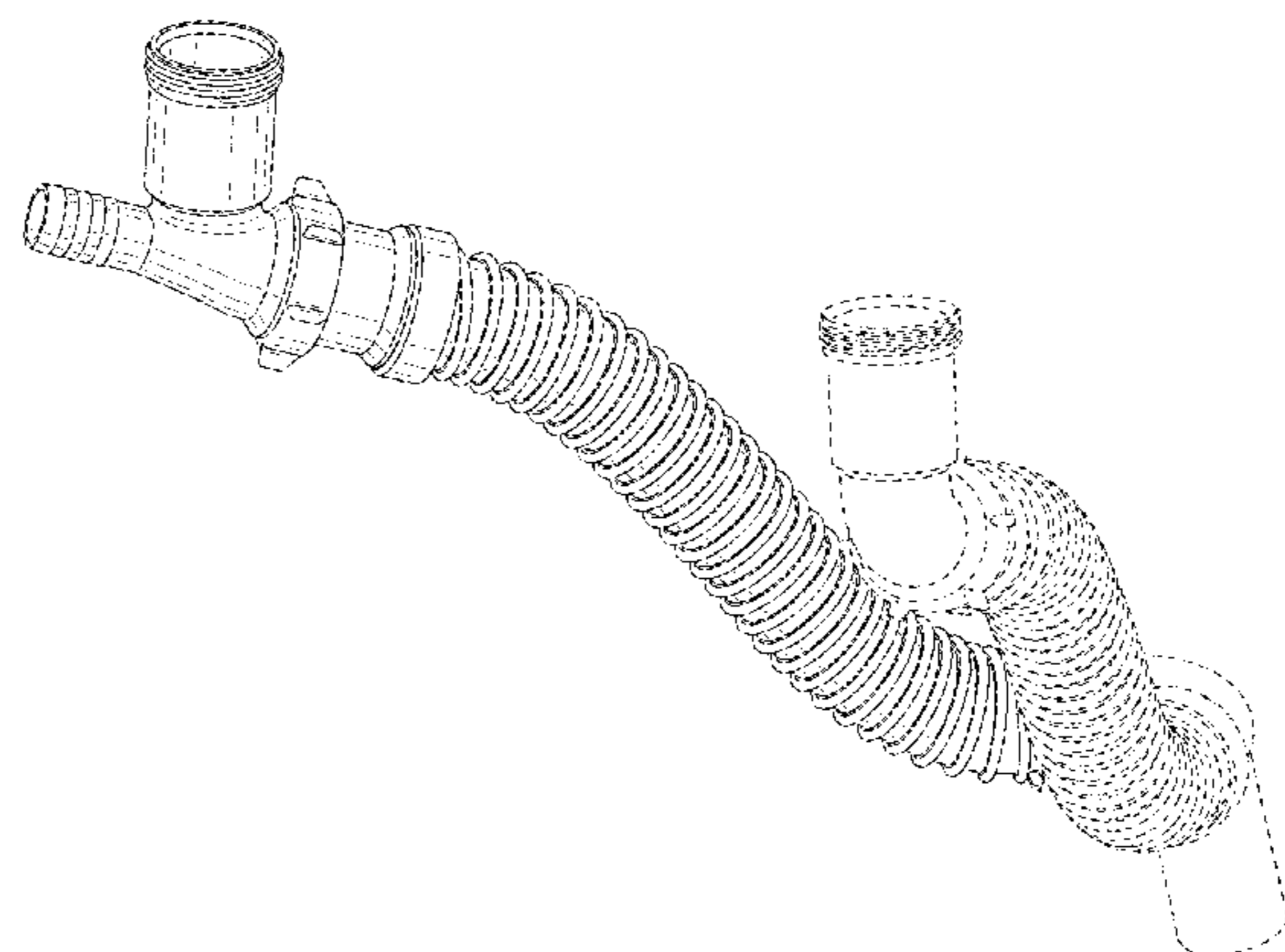
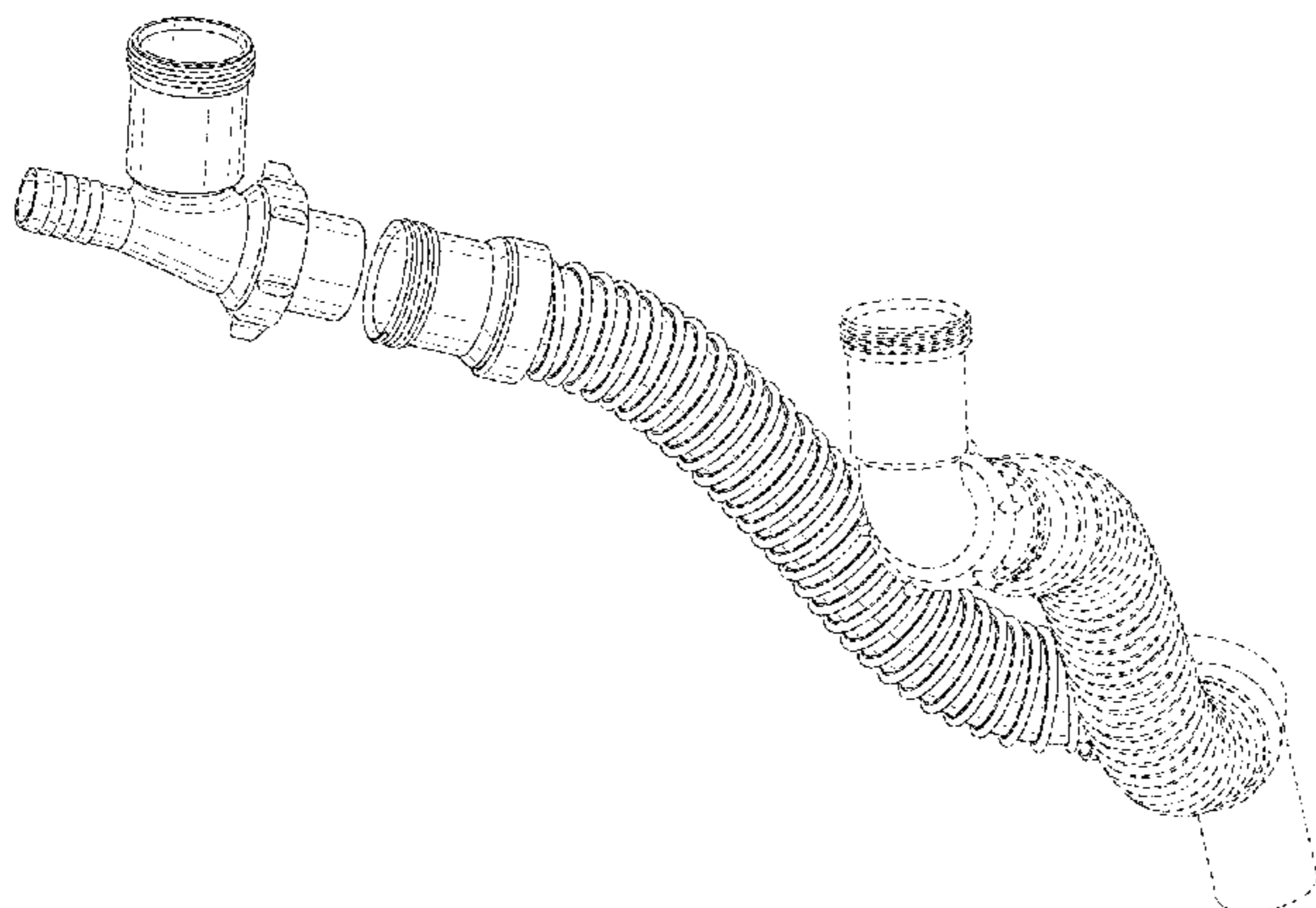
The ornamental design for an elbow piece with drainage branch and flexible hose, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an elbow piece with drainage branch and flexible hose that is unattached, shown in exemplary attachment to a second hose and elbow, in accordance with my design;  
FIG. 2 is a front view of FIG. 1;

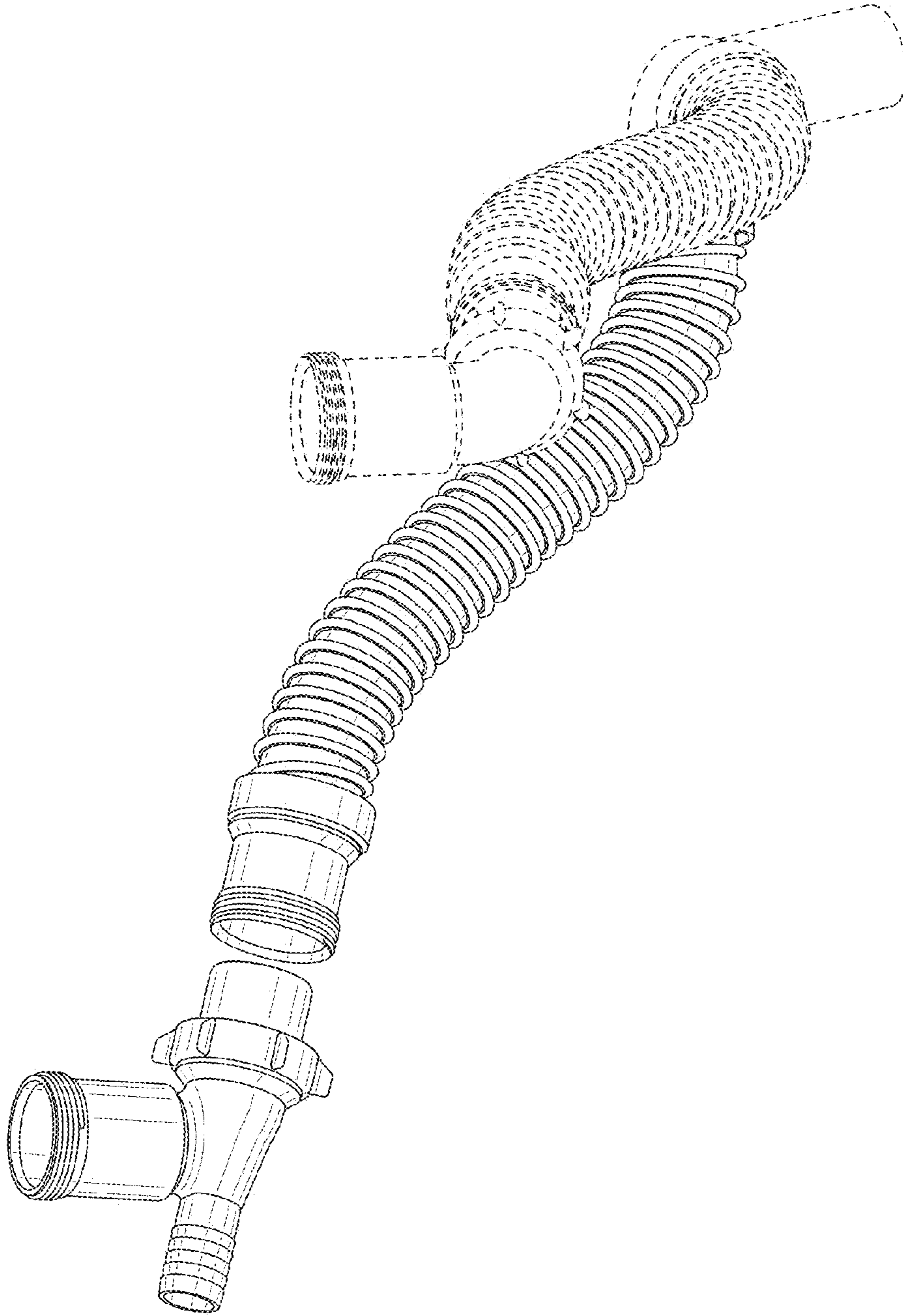

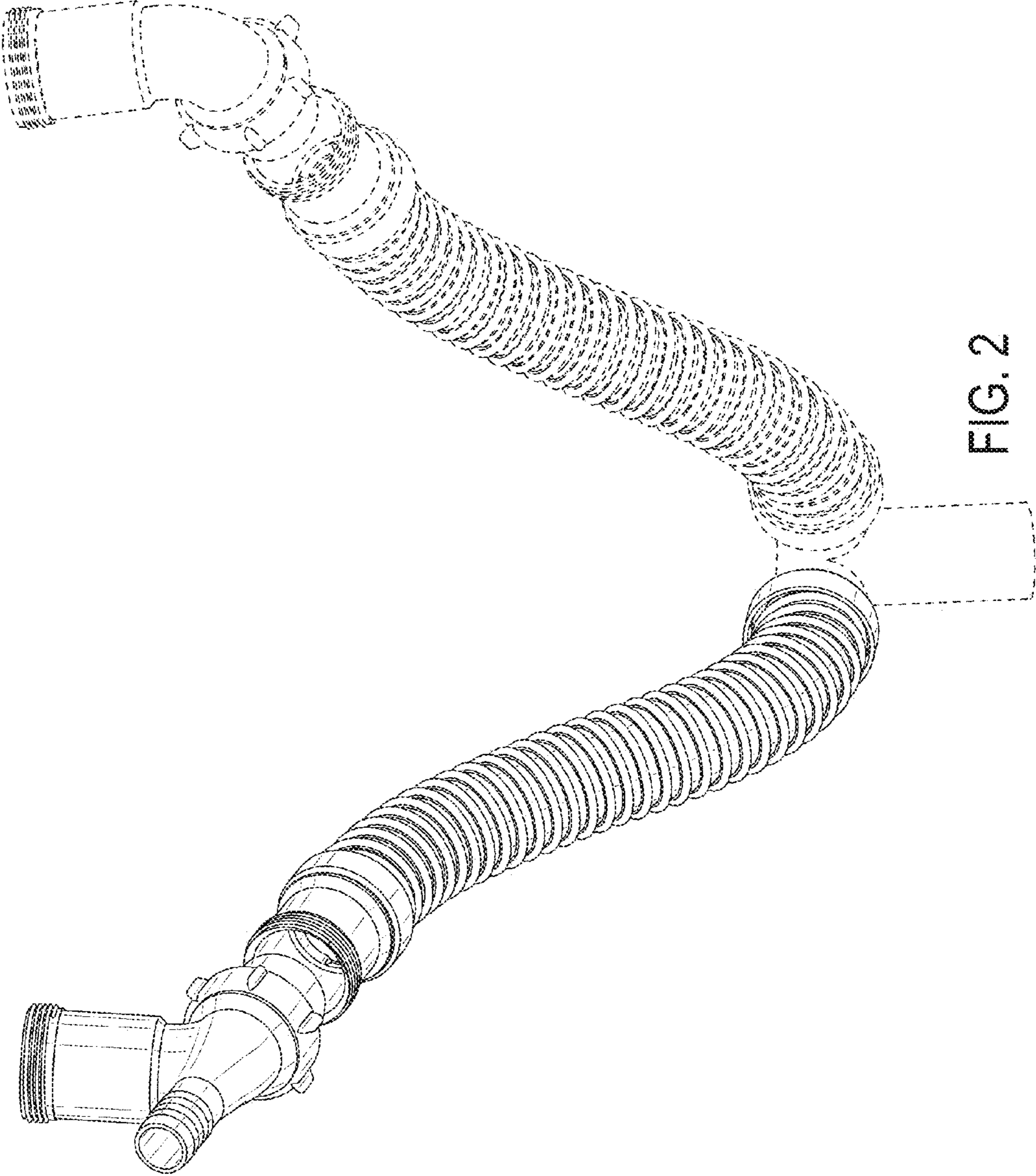

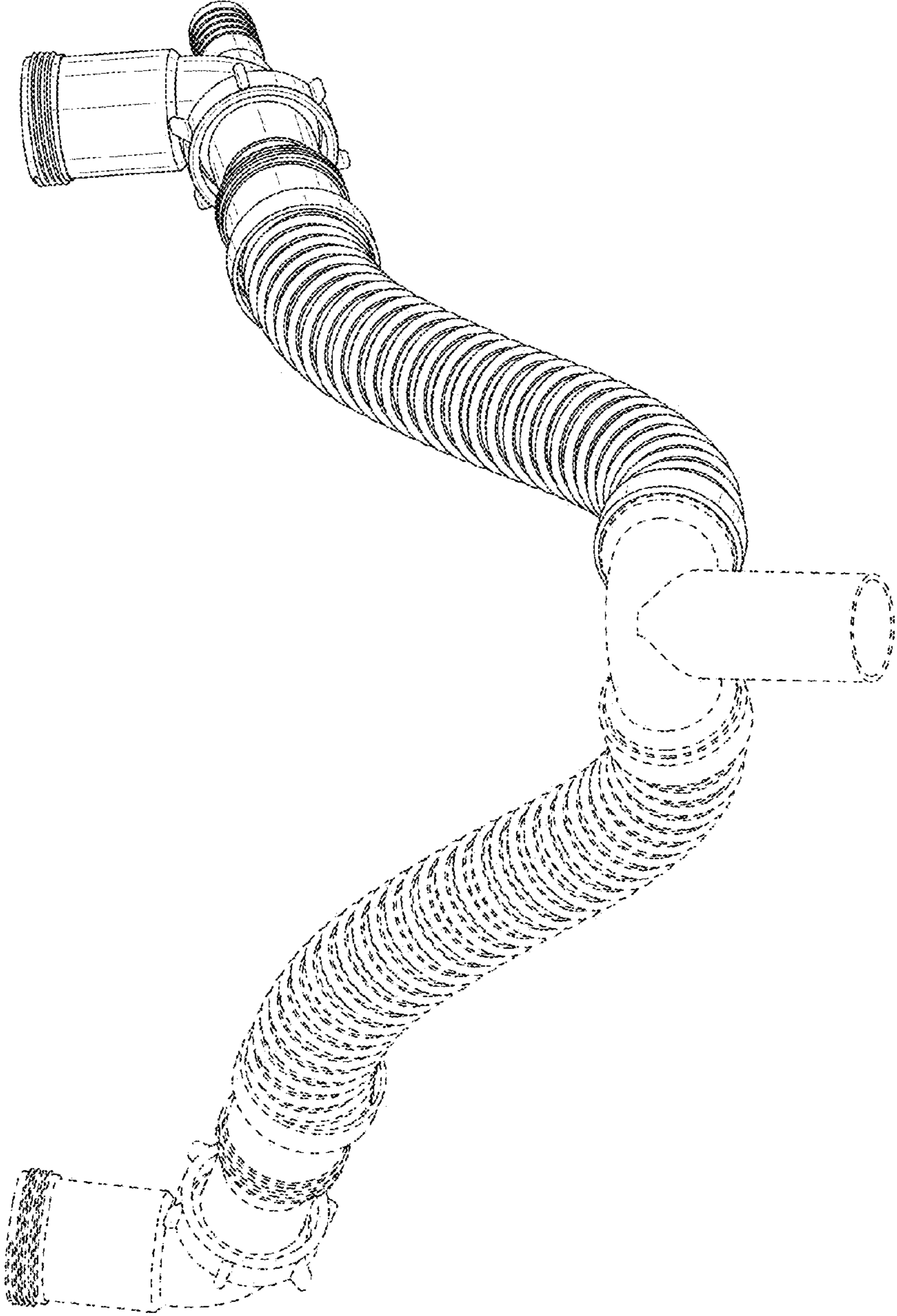

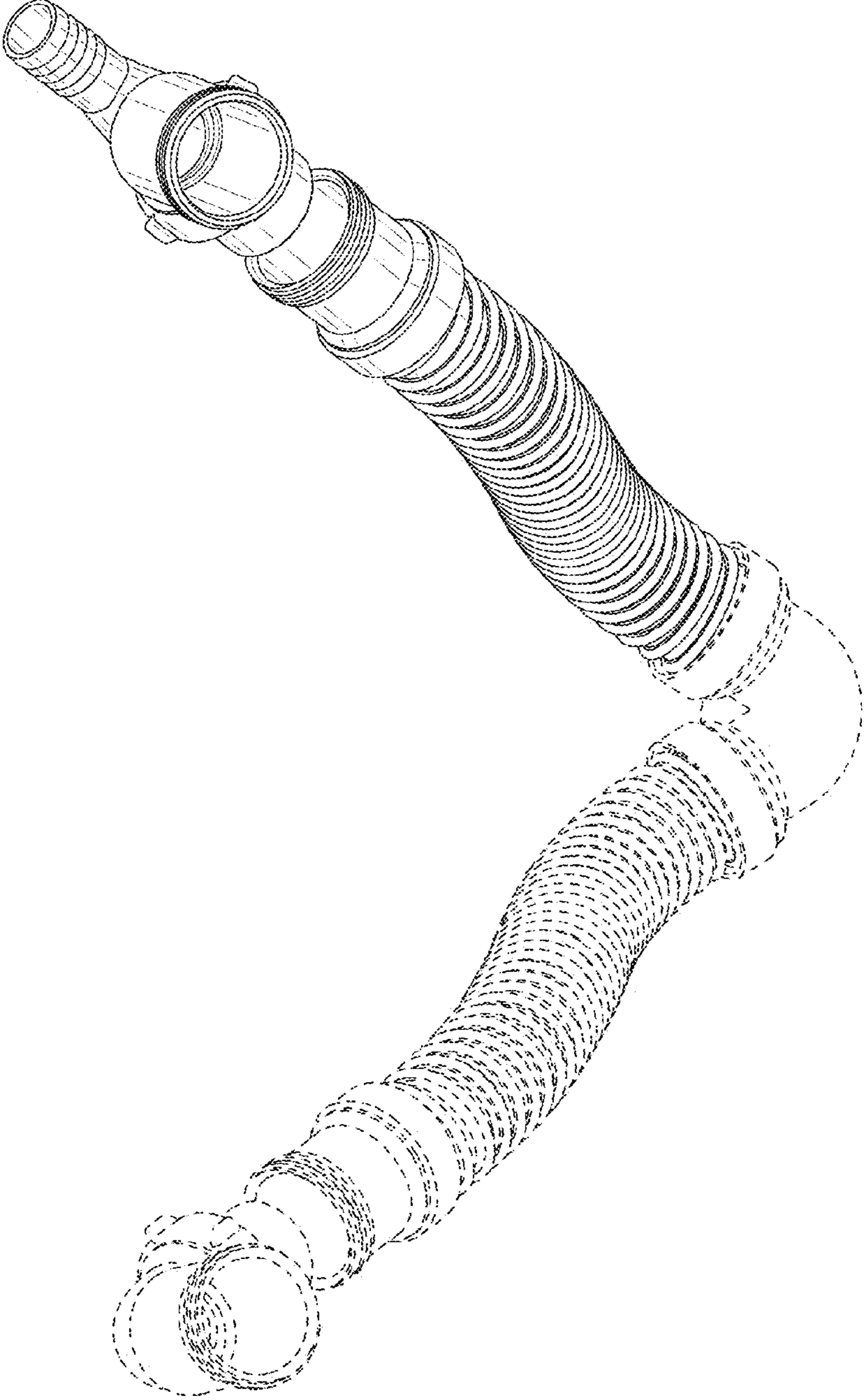

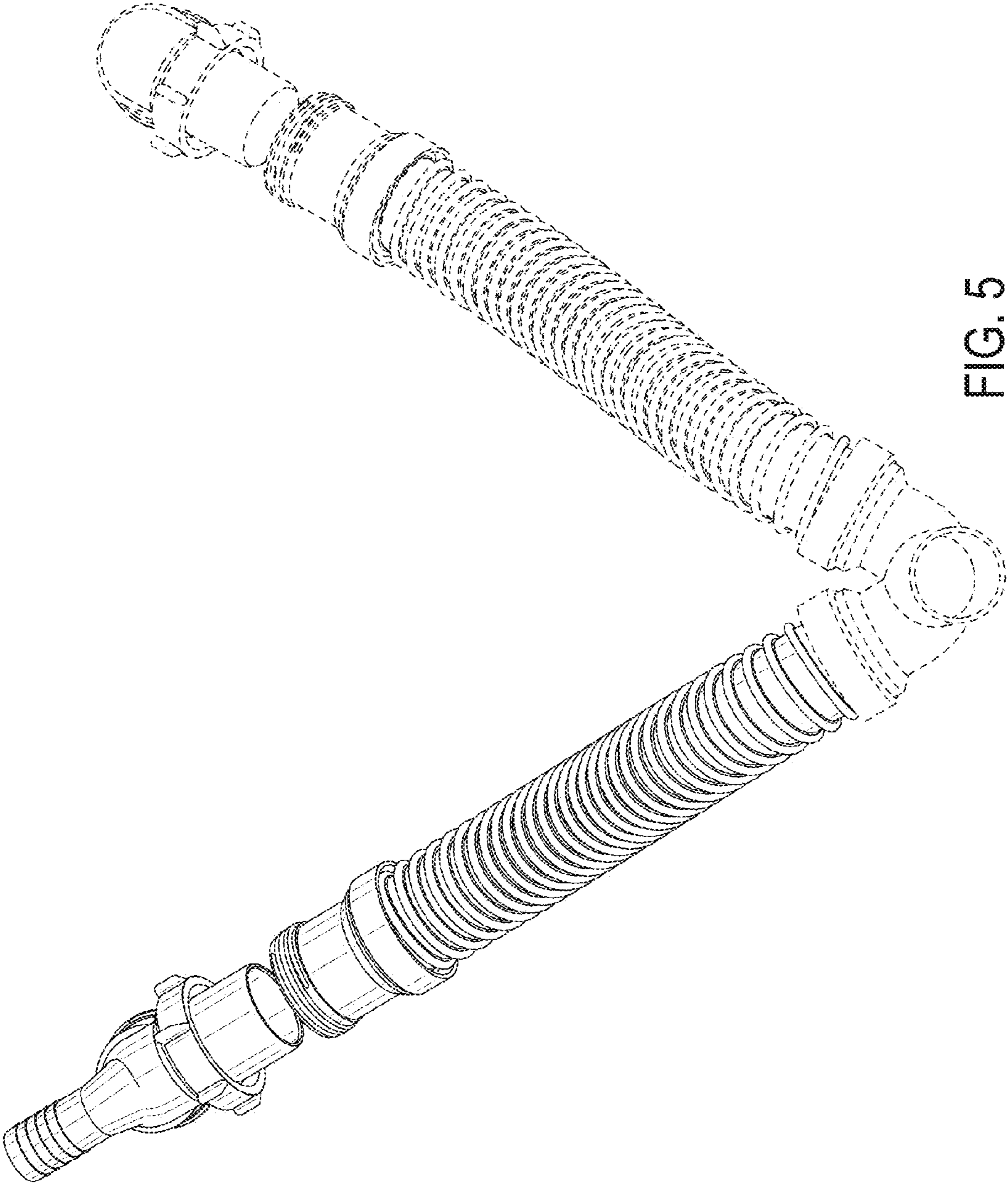

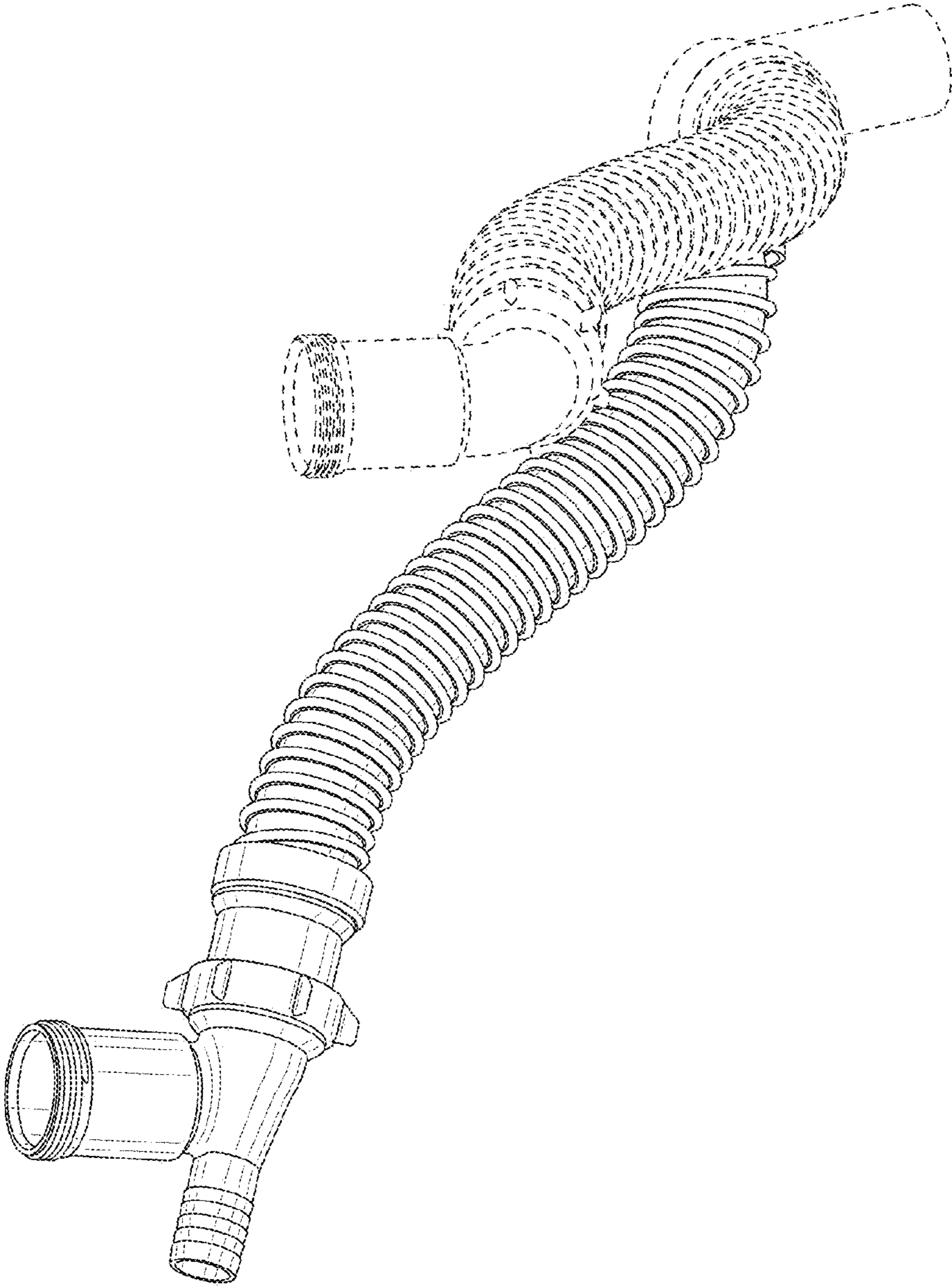

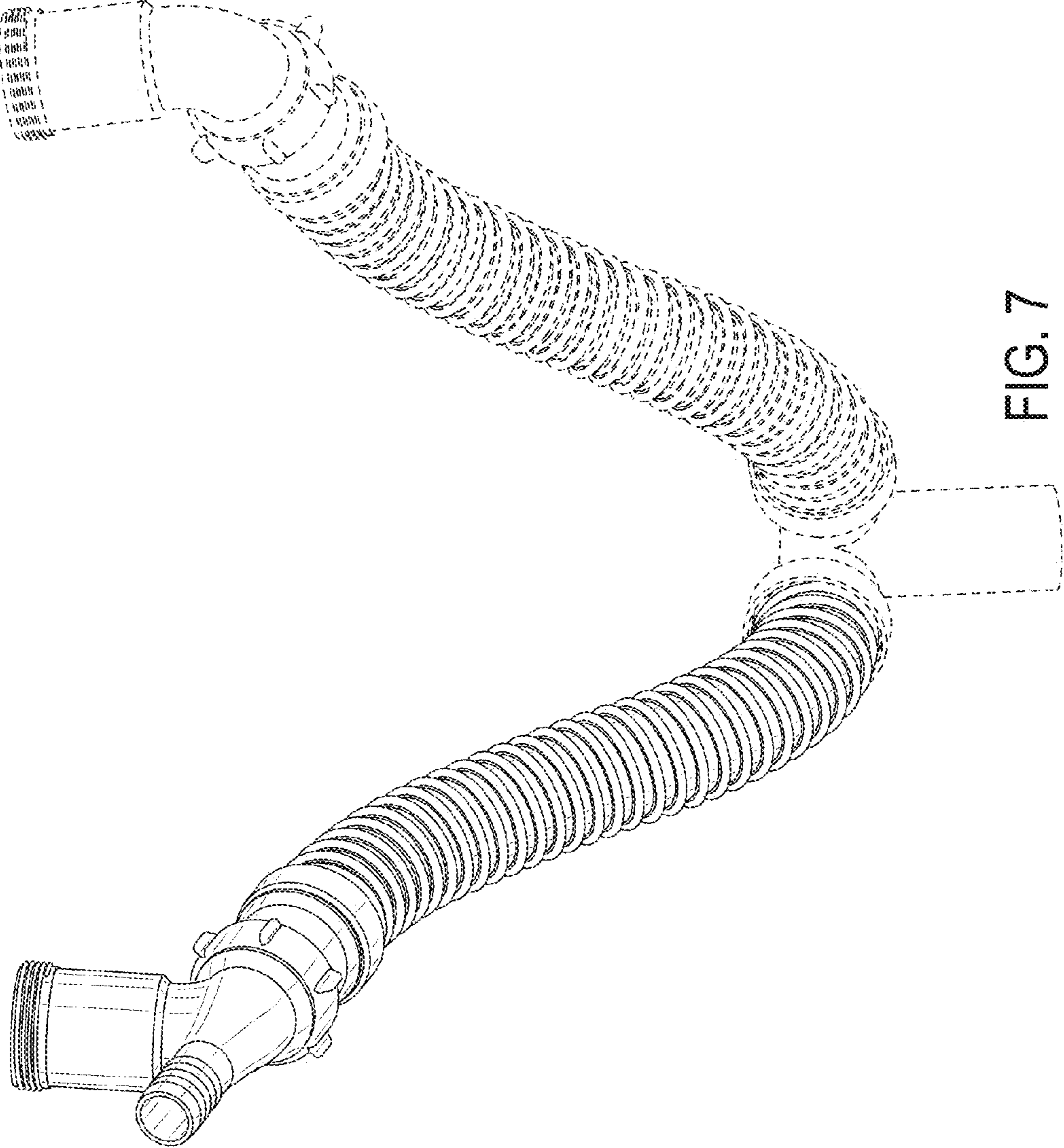

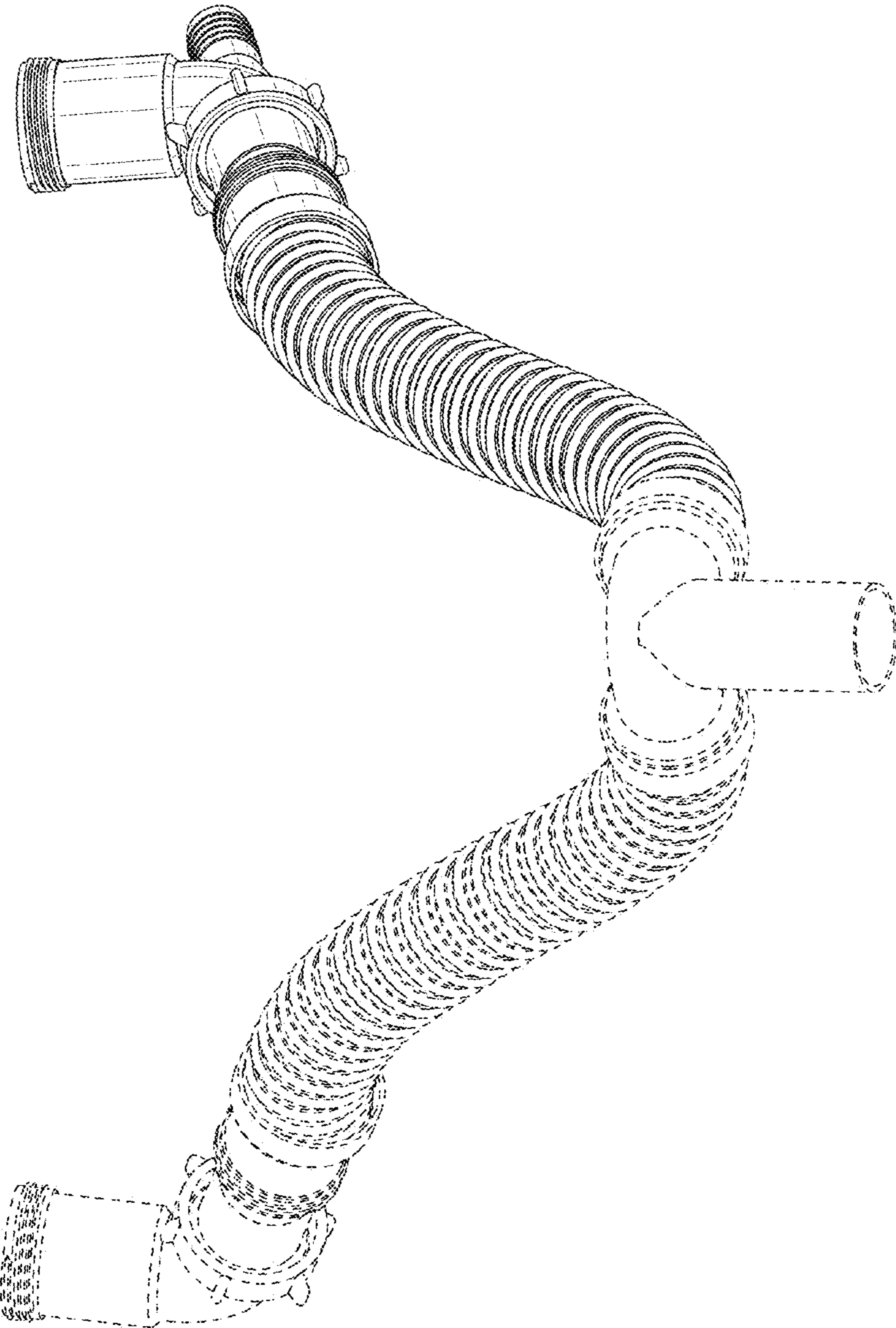

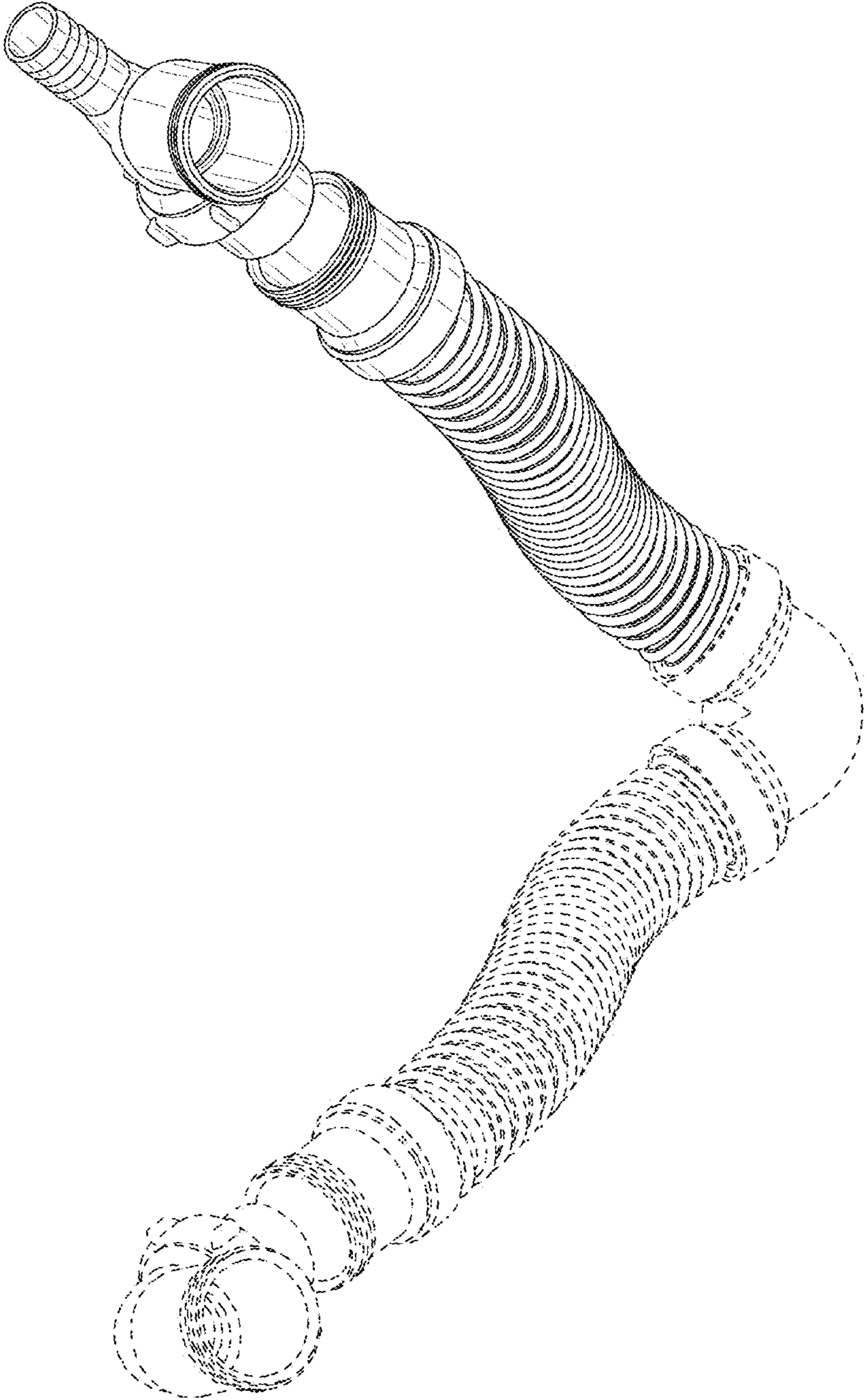

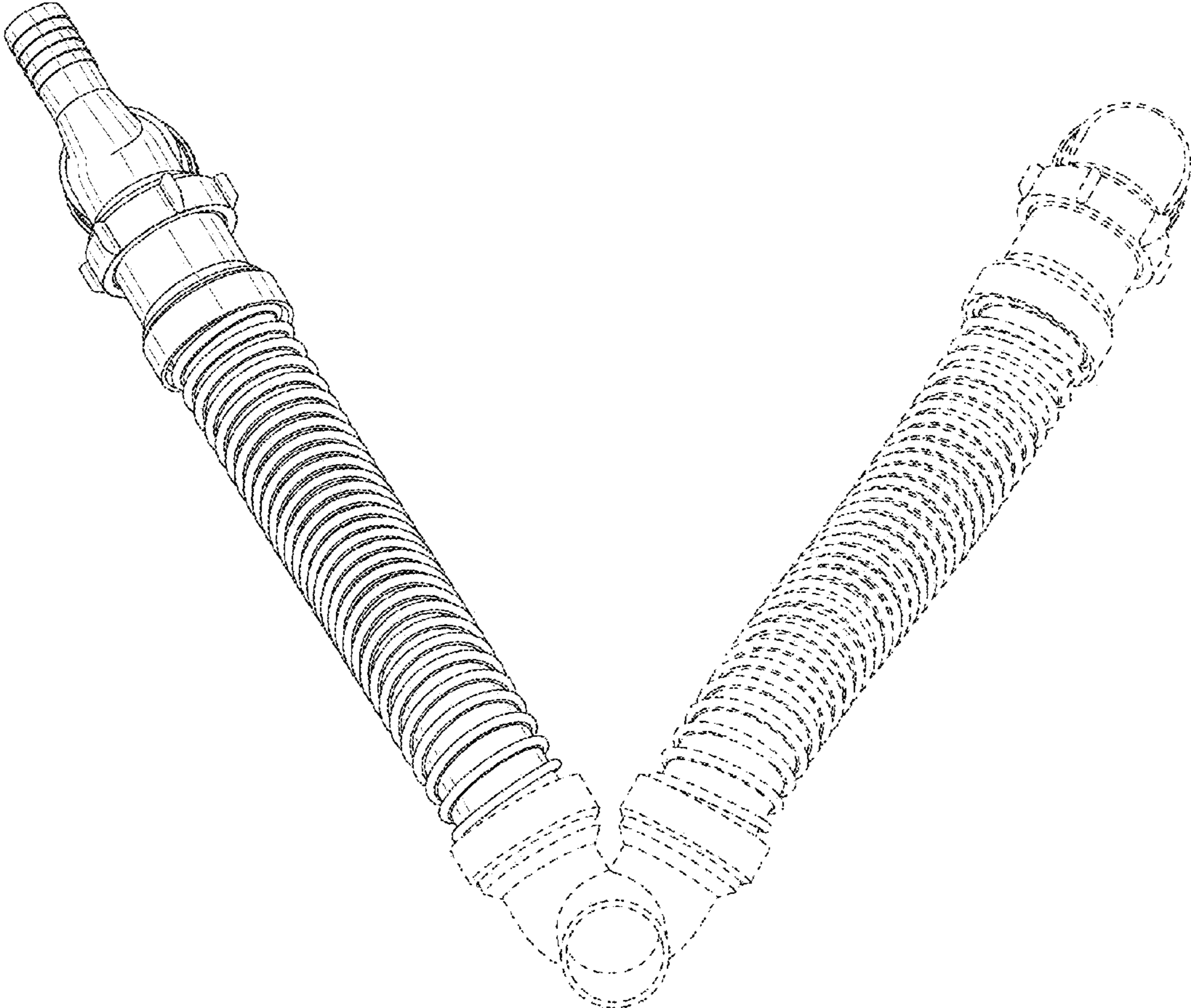

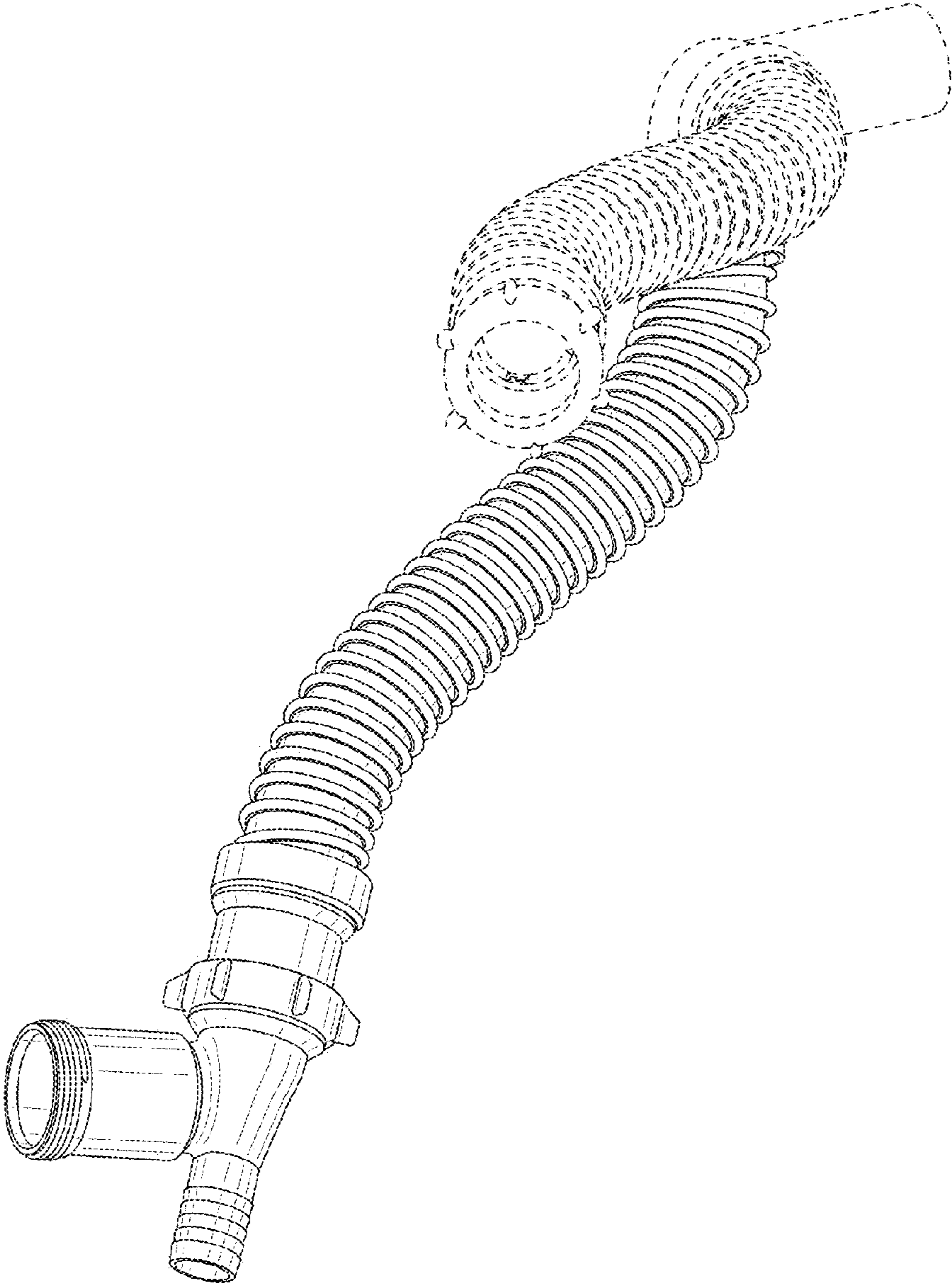

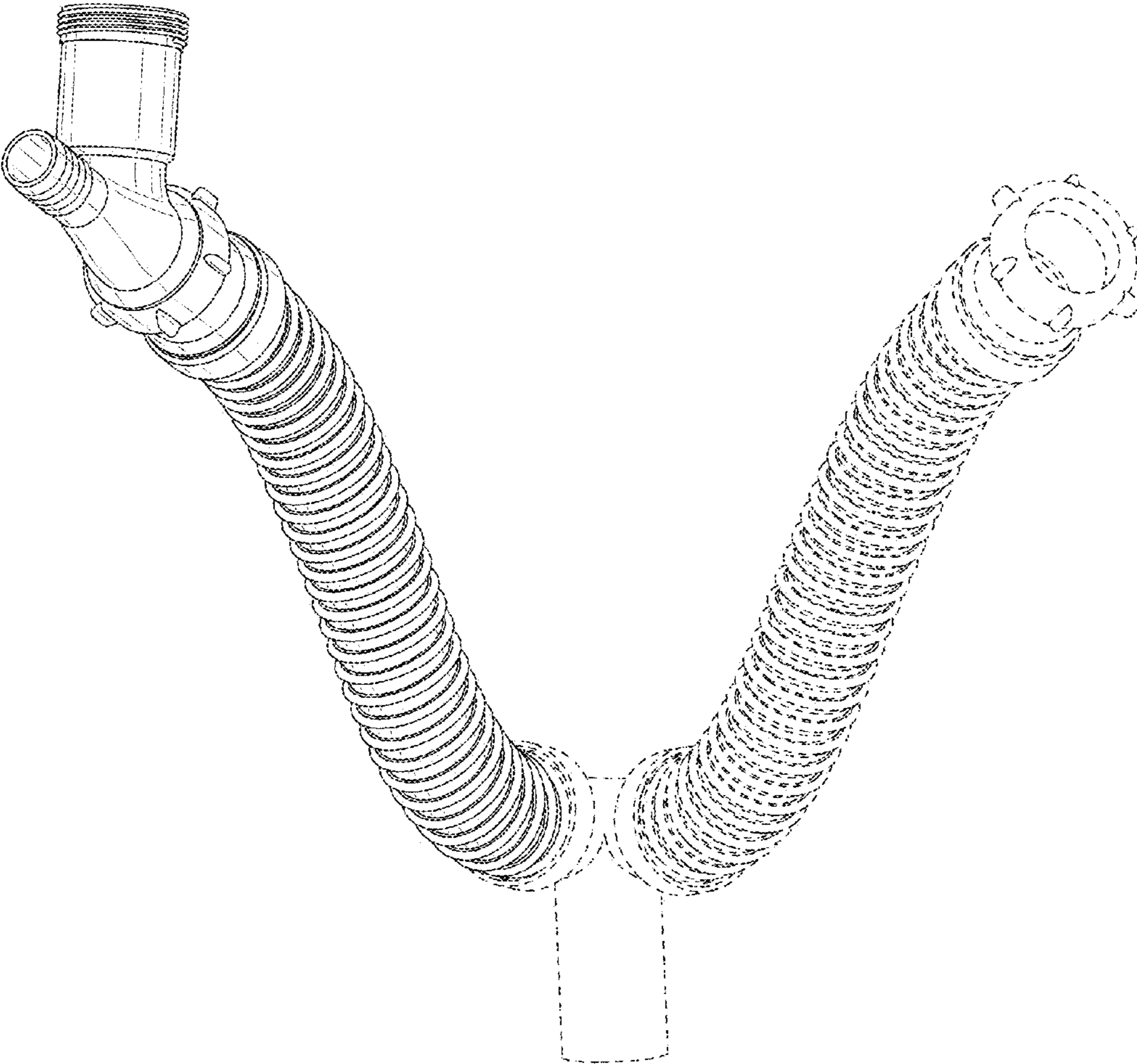

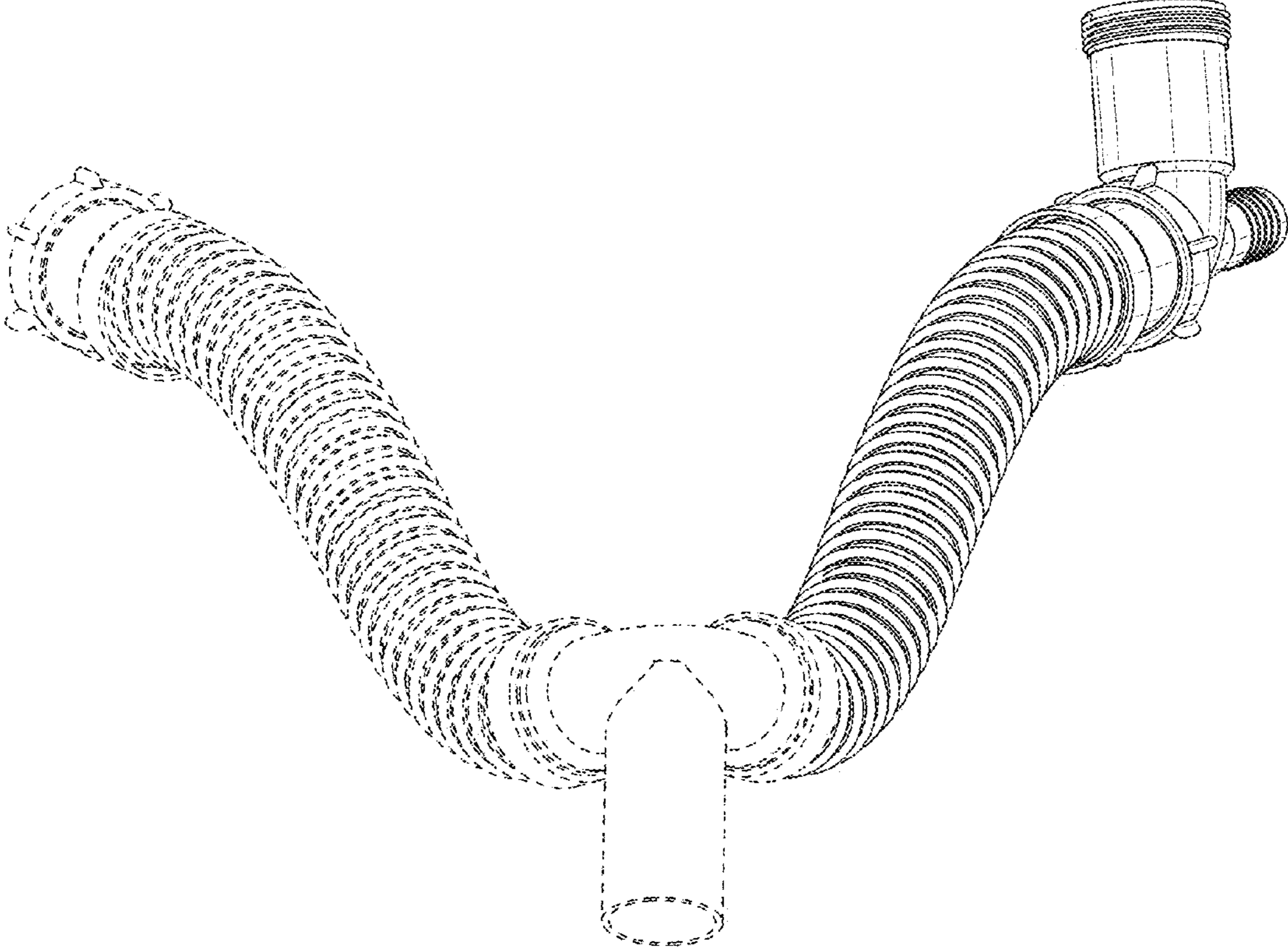

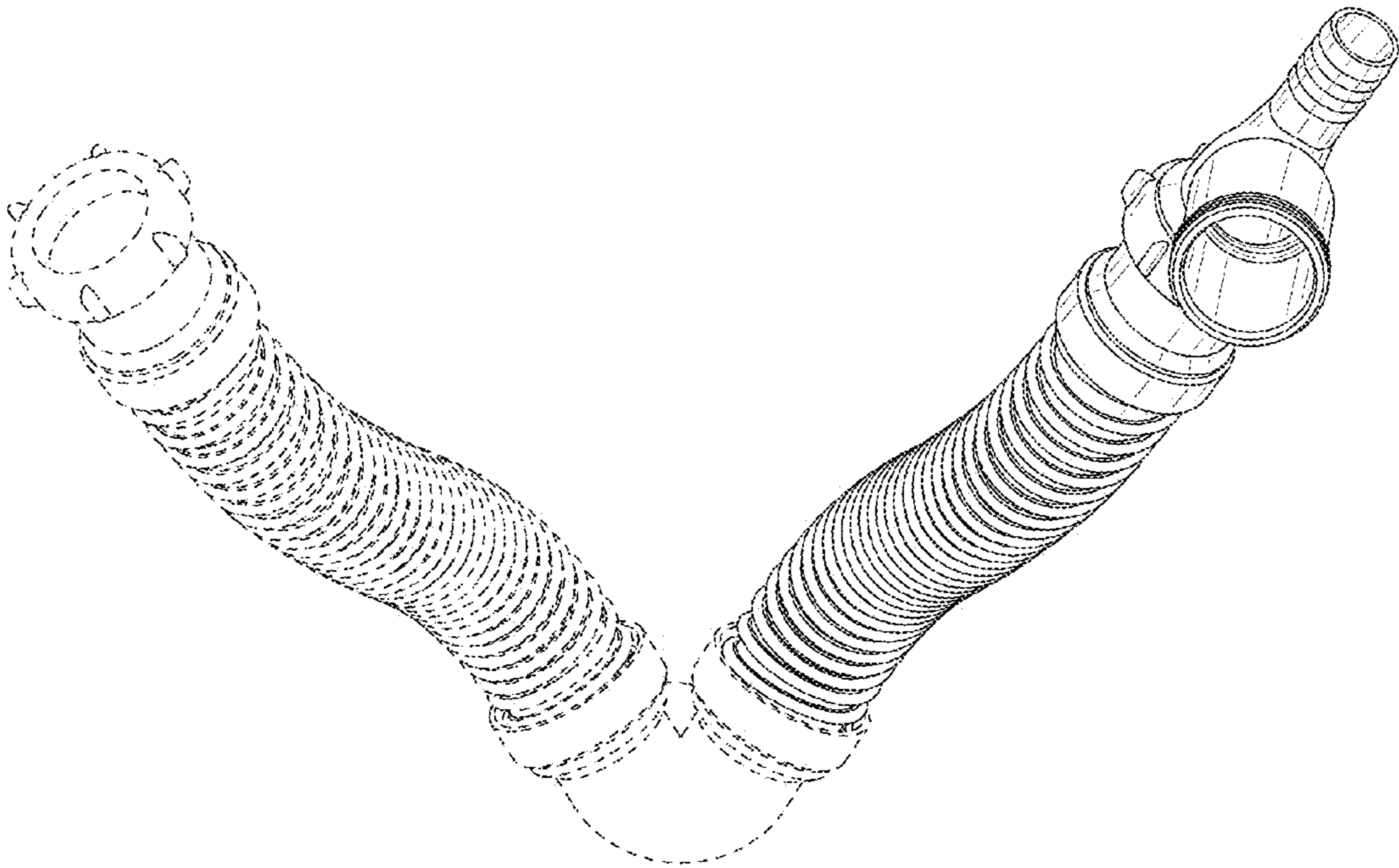

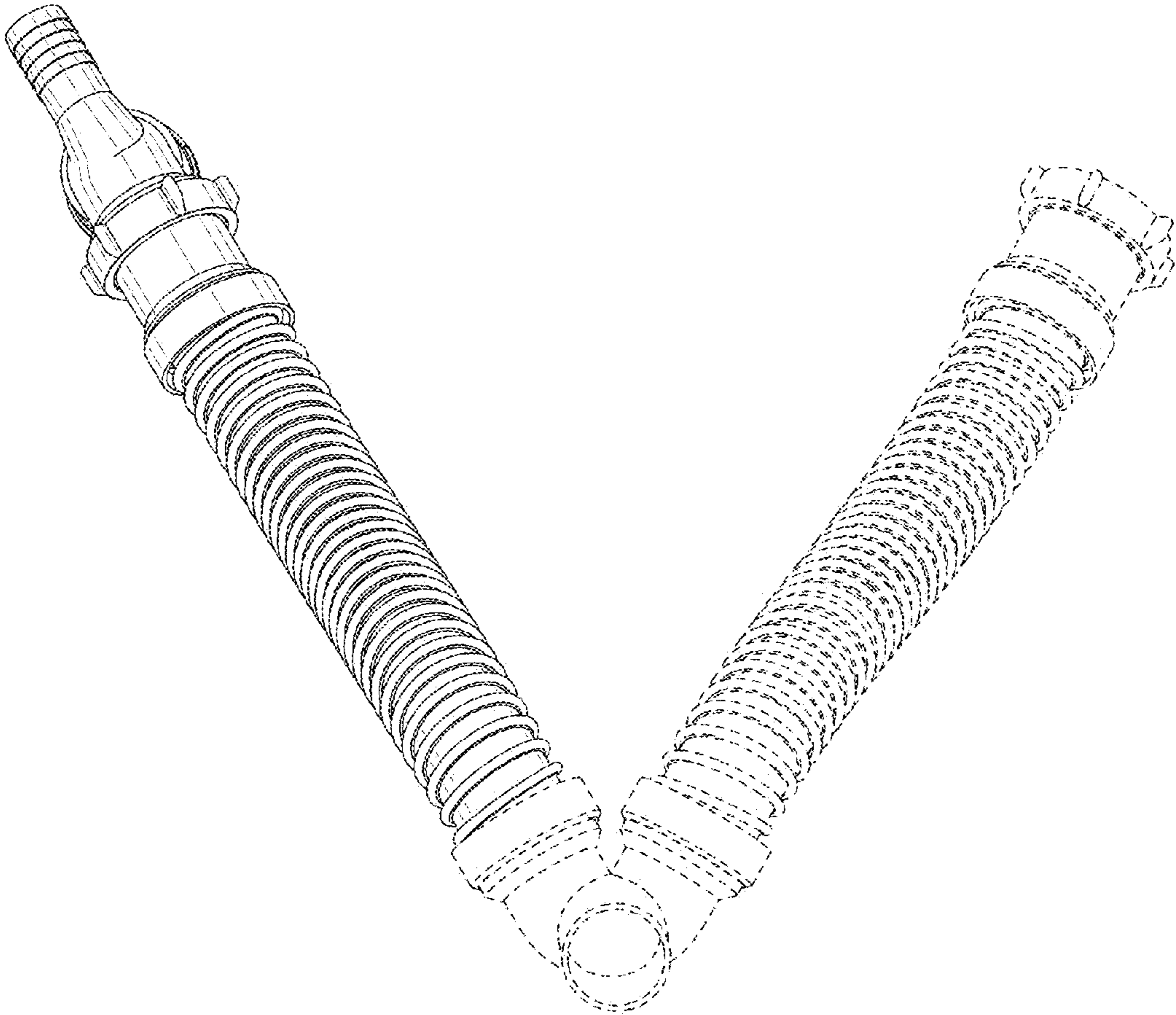
