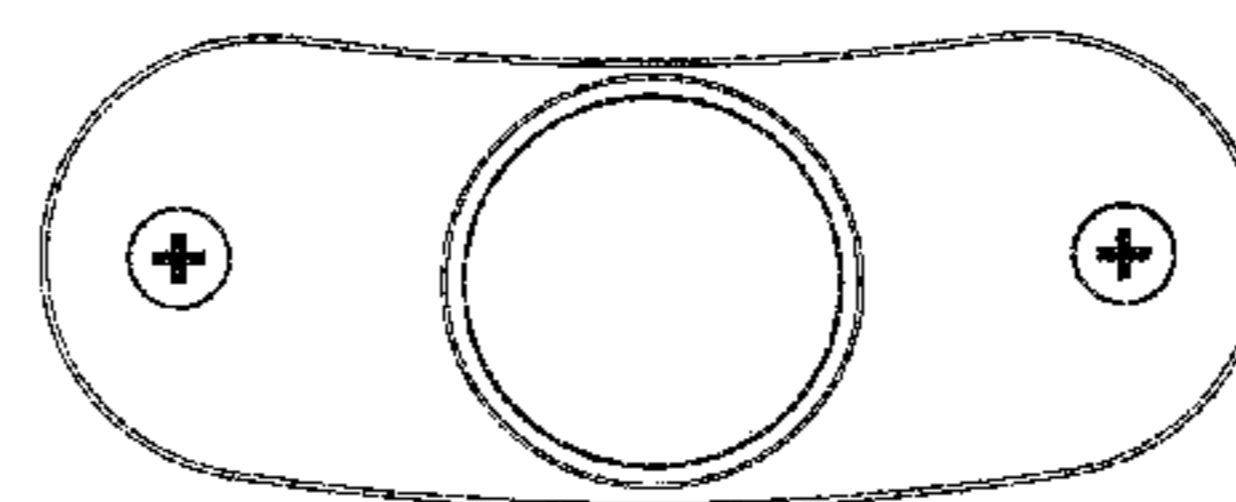
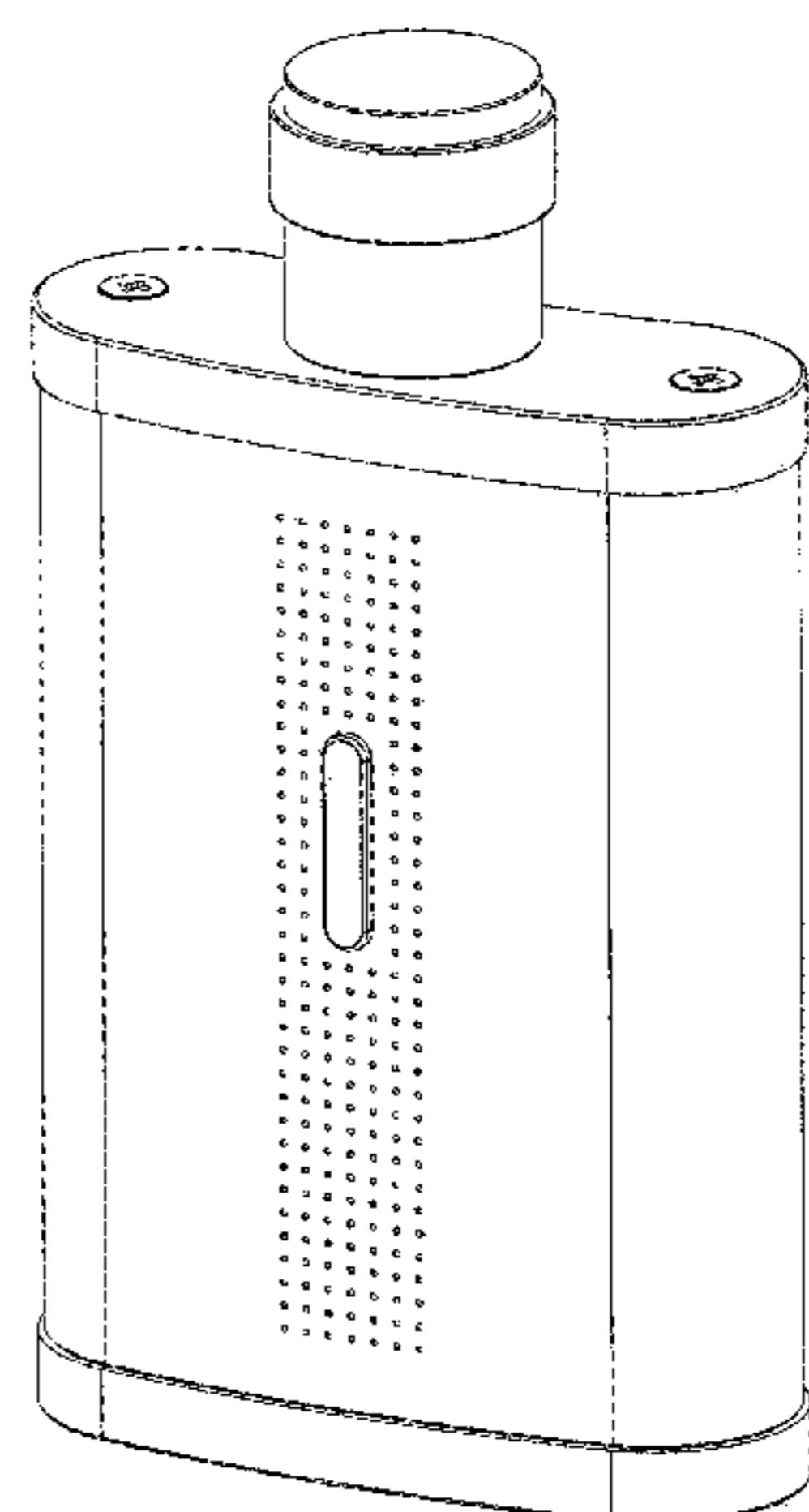
(57) **CLAIM**

The ornamental design for an electronic cigarette, as shown and described.

**DESCRIPTION**

FIG. 1 is the perspective view of the electronic cigarette showing my new design;

 FIG. 4 is the top plan view thereof;  
 FIG. 5 is the bottom plan view thereof;

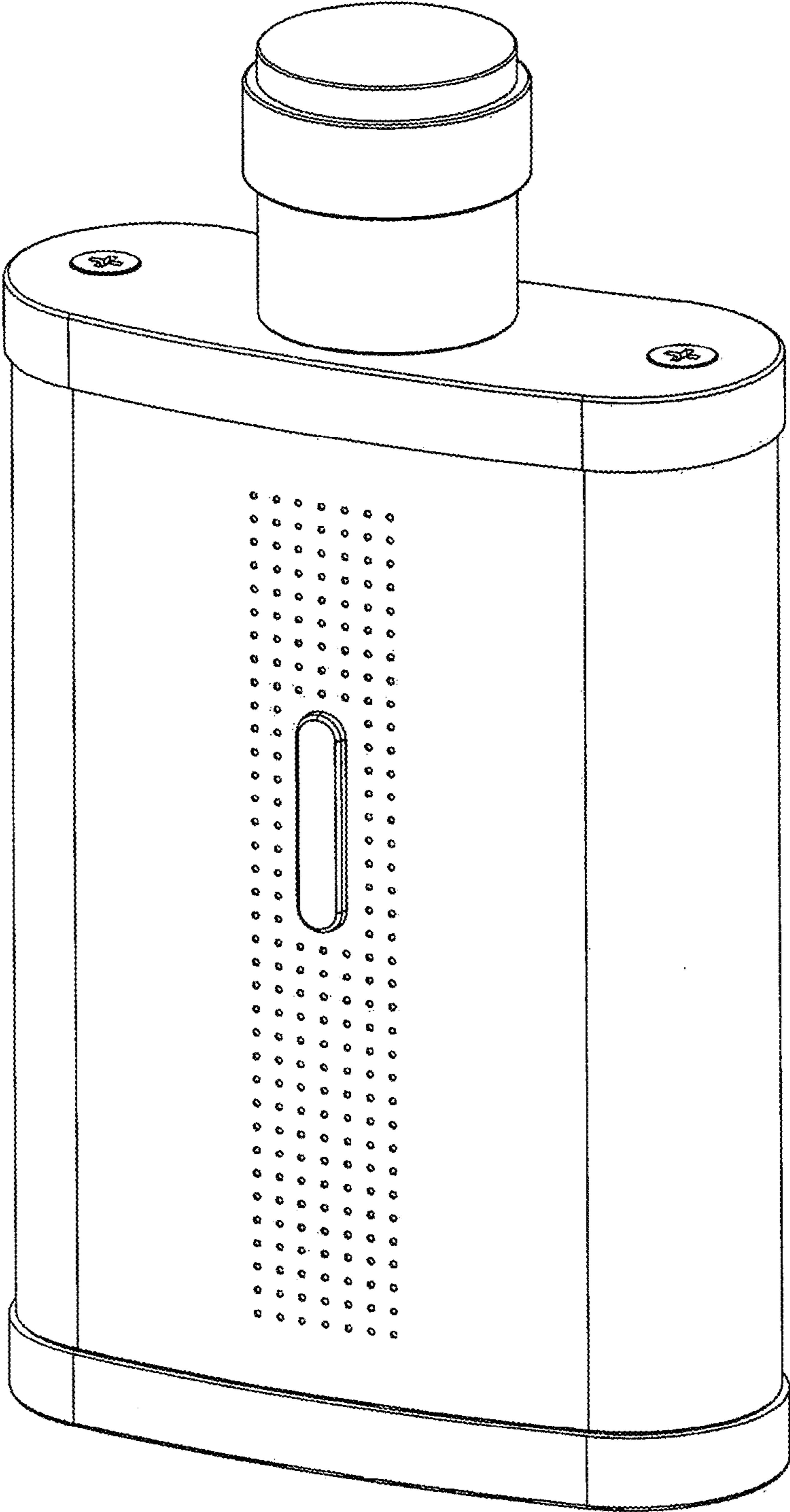

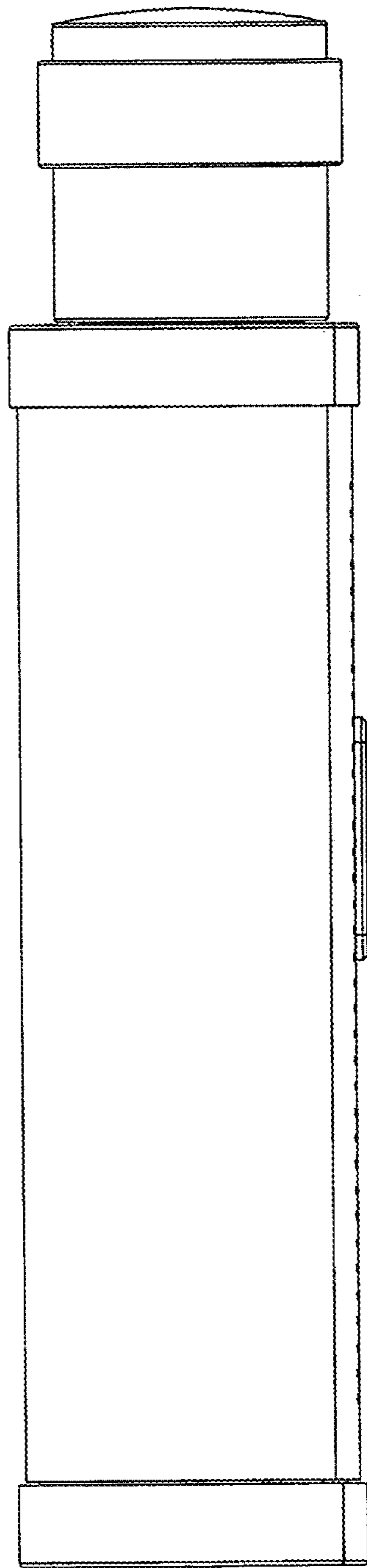

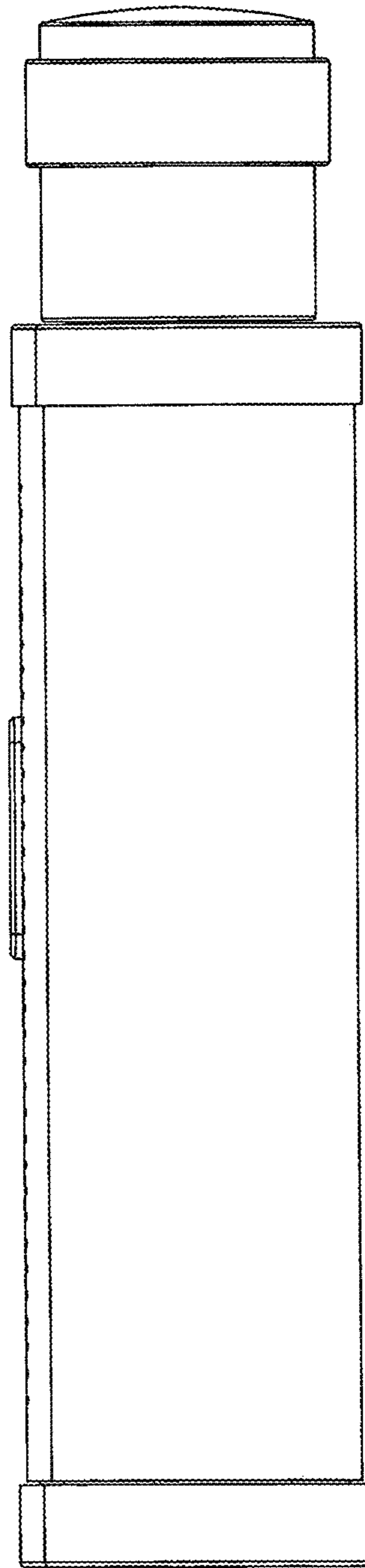

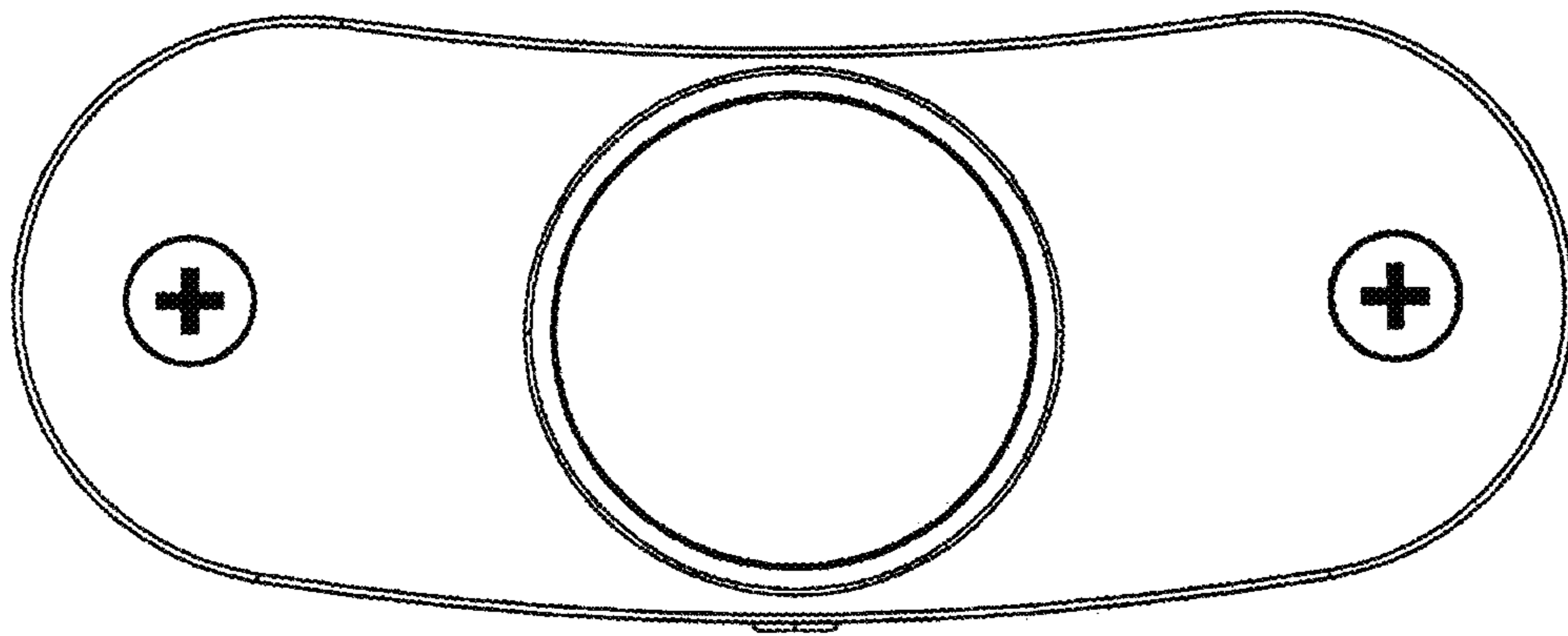

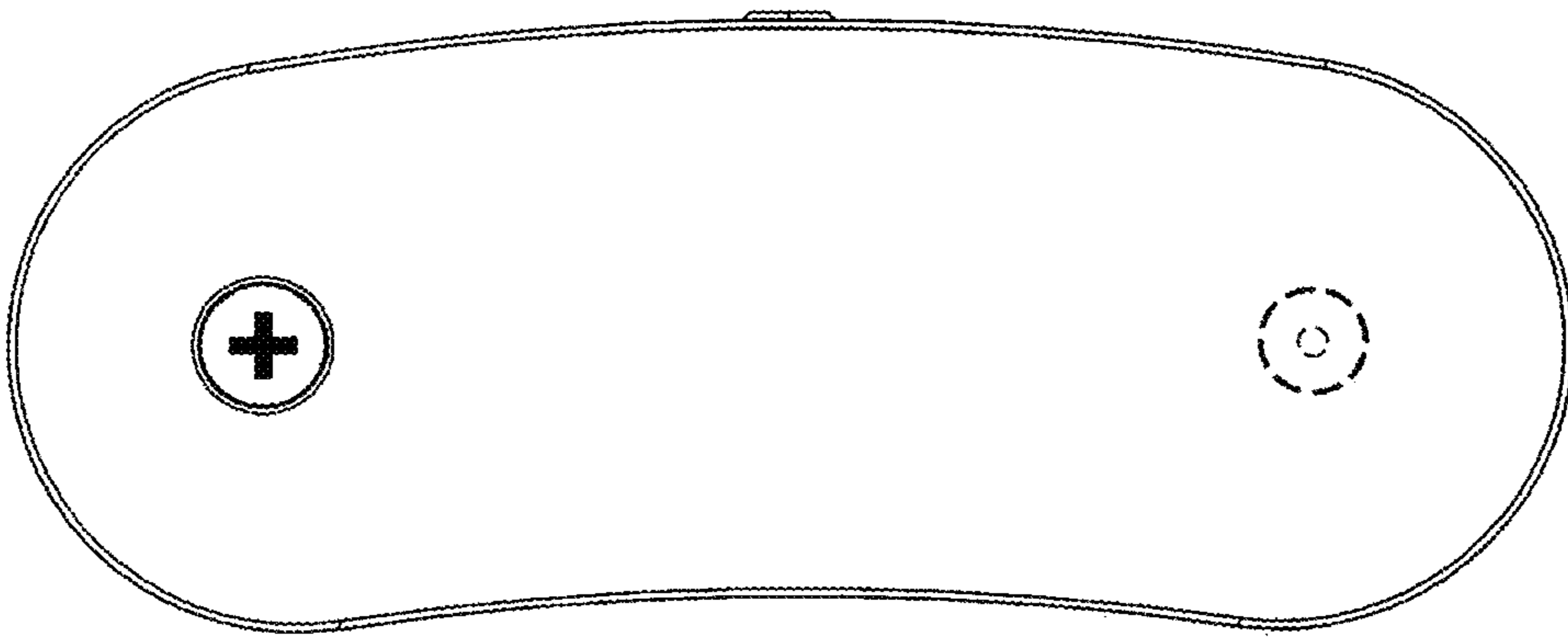

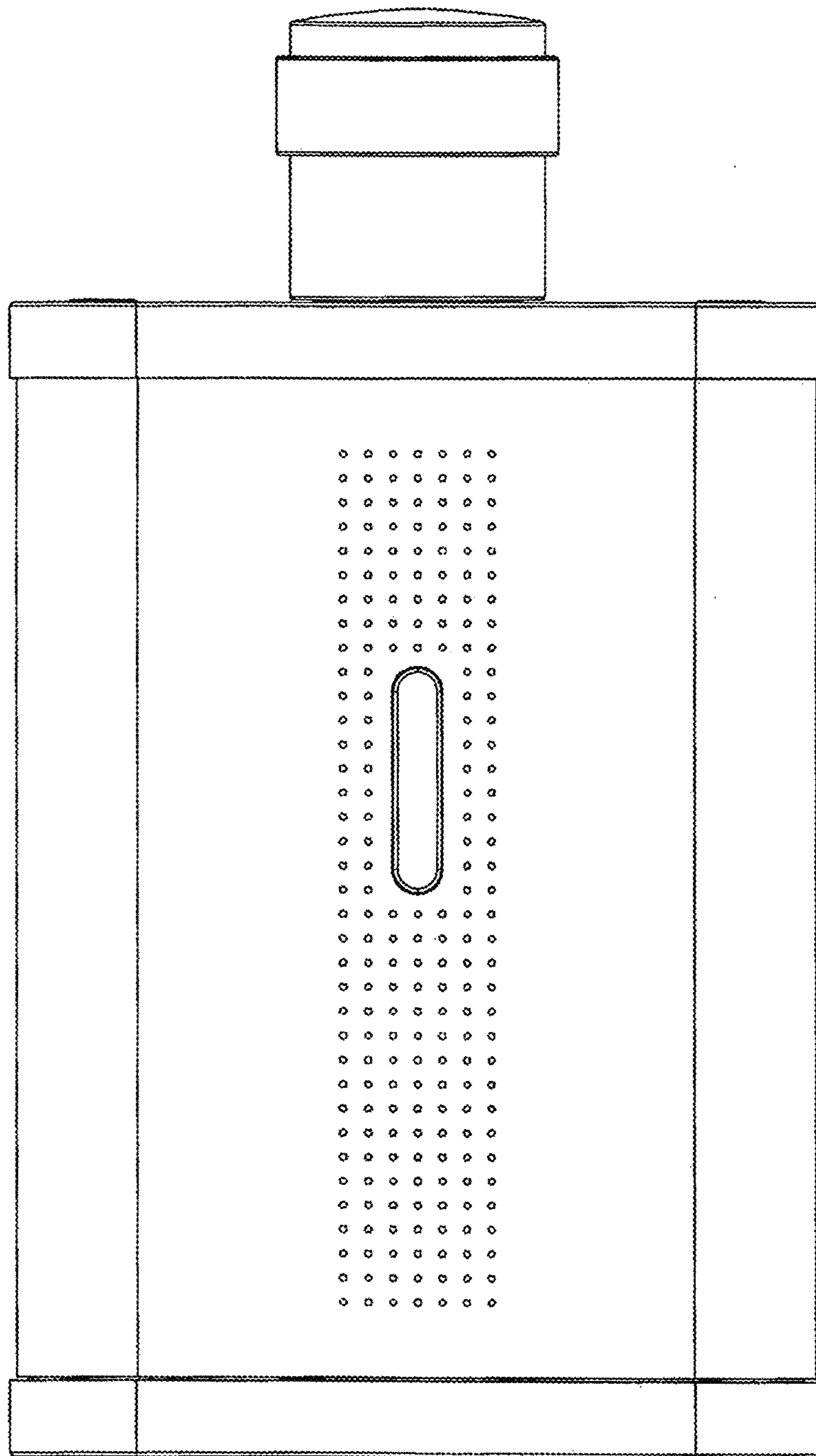

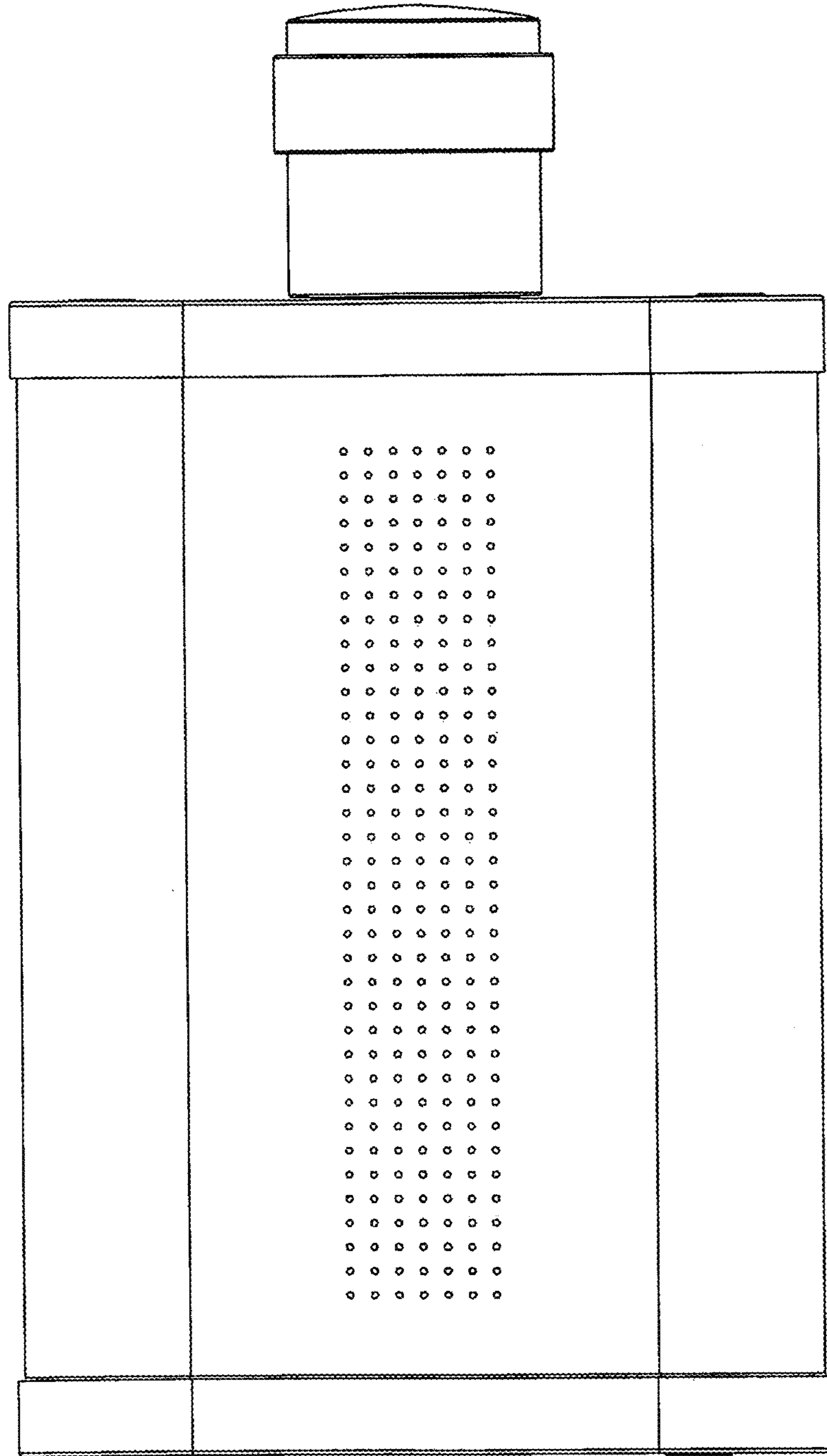
