(57) **CLAIM**

The ornamental design for a pet harness, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a pet harness, showing our new design with the connecting straps fastened; FIG. 2 is a rear elevation view thereof; FIG. 3 is an exterior plan view showing the connecting straps unfastened for clarity of disclosure; FIG. 4 is an interior plan view showing the connecting straps unfastened for clarity of disclosure; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; and, FIG. 7 is a front elevation view thereof.
