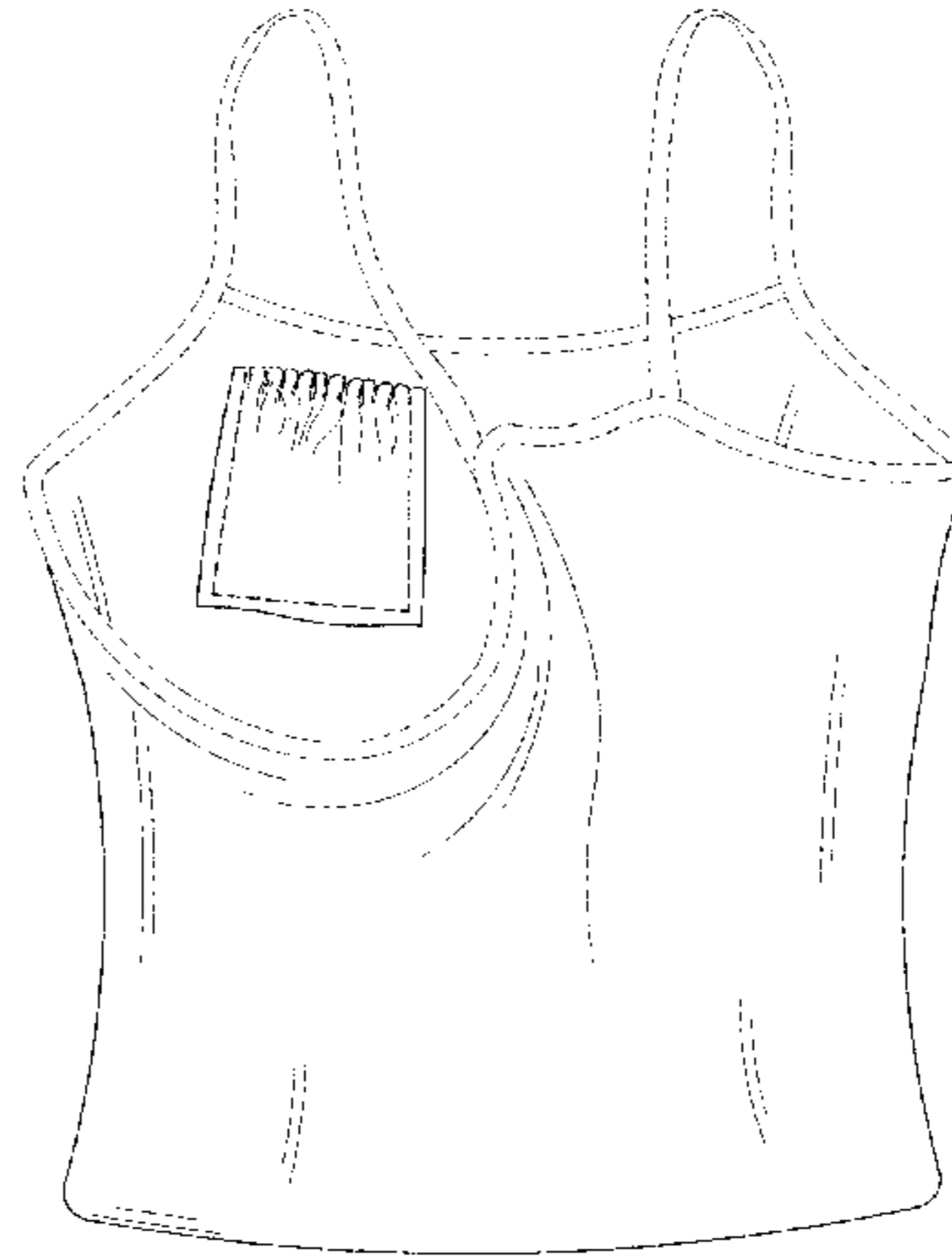
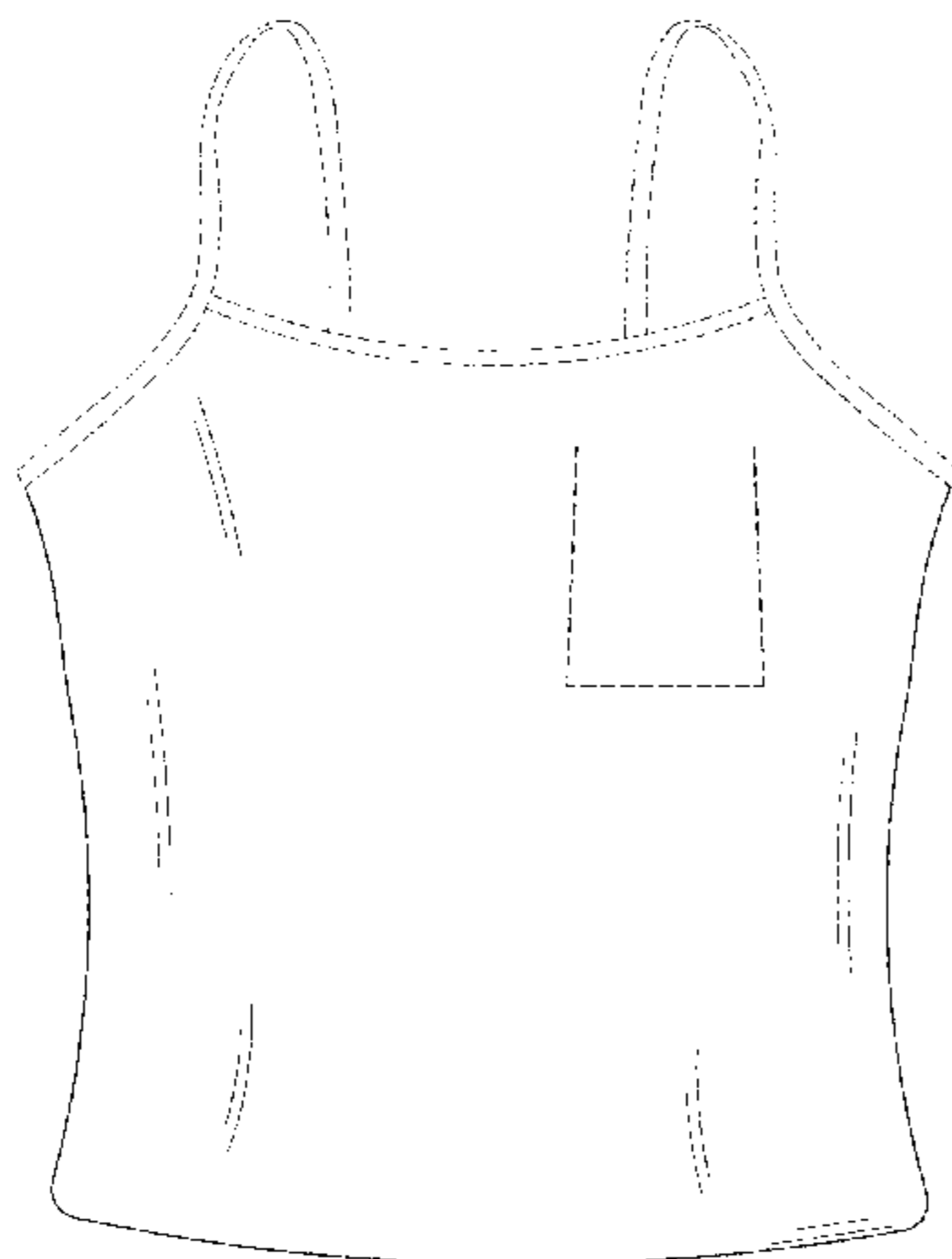
(57) **CLAIM**

The ornamental design for a shirt with pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the shirt with pocket showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is another rear elevational view thereof;
FIG. 6 is a rear perspective view thereof
FIG. 7 is an enlarged top plan view thereof; and,
FIG. 8 is an enlarged bottom plan view thereof.
The broken lines shown in FIGS. 1-8, including the broken line stitching lines, represent portions of the shirt with pocket that form no part of the claimed design.

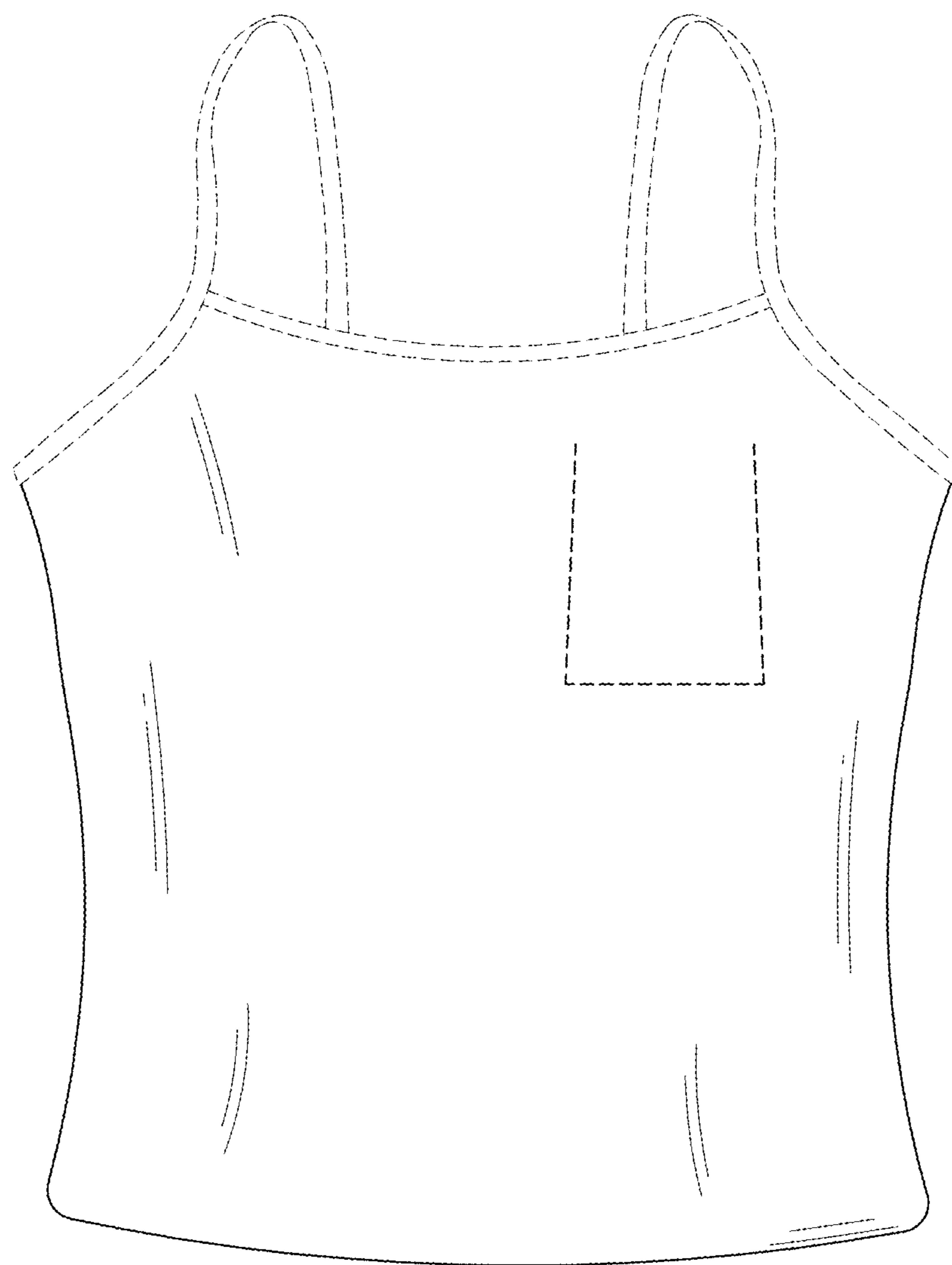

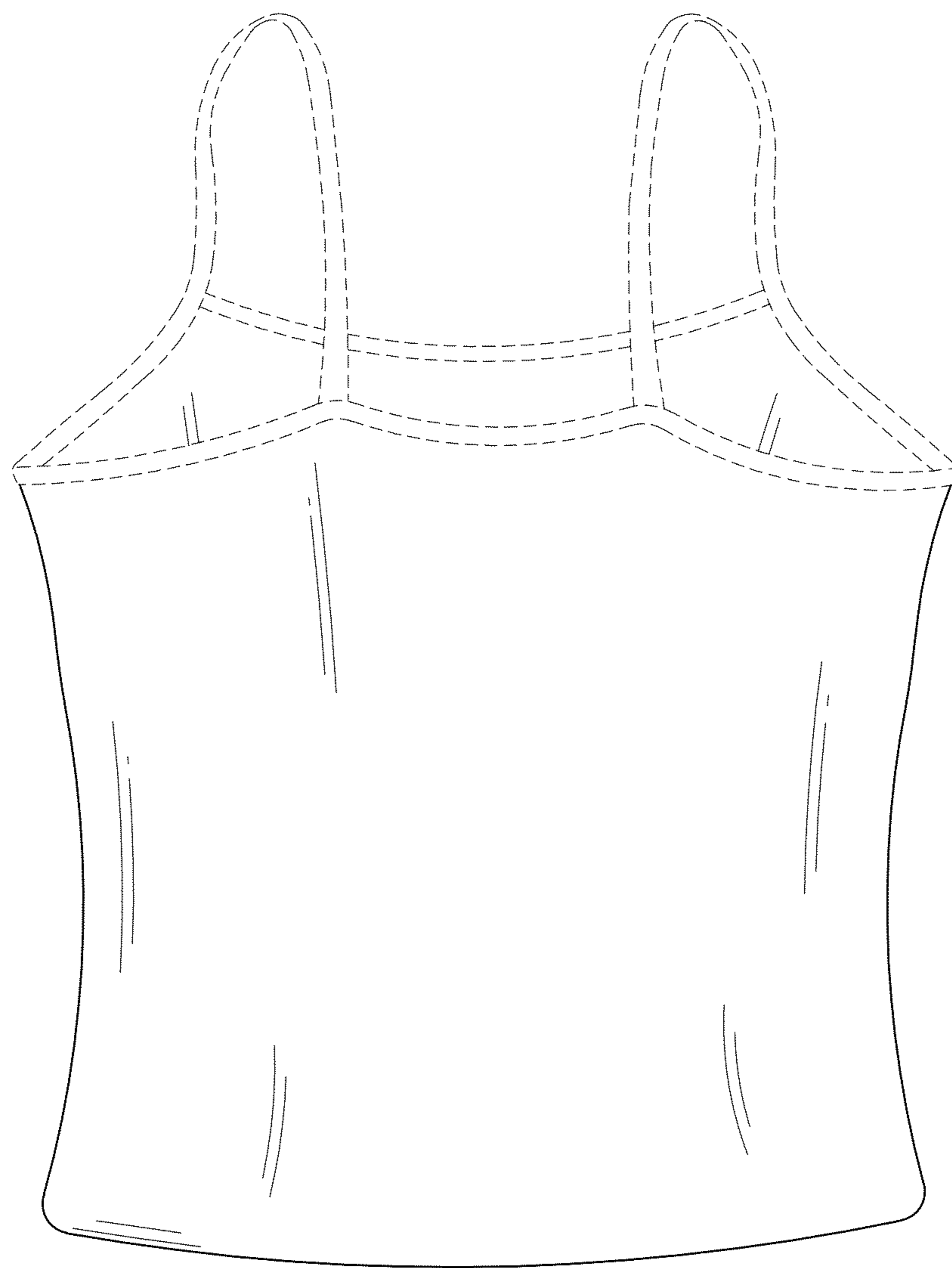

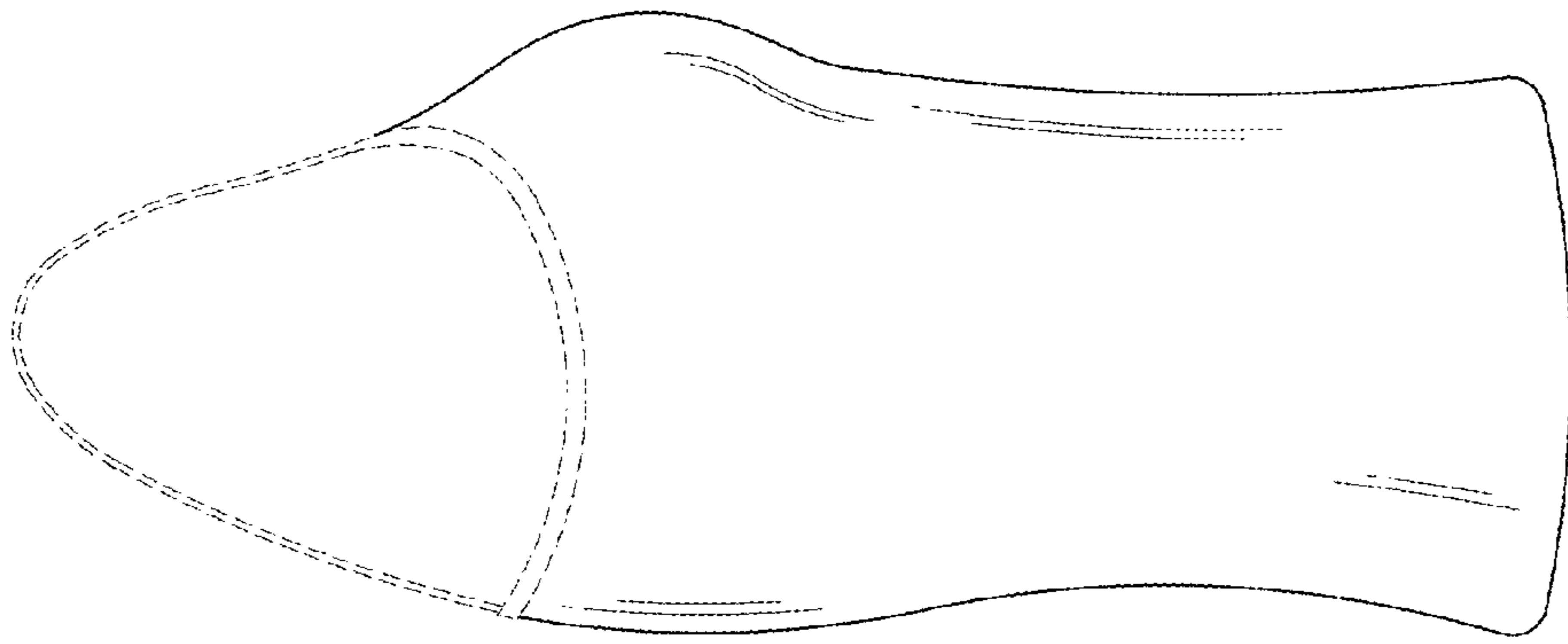

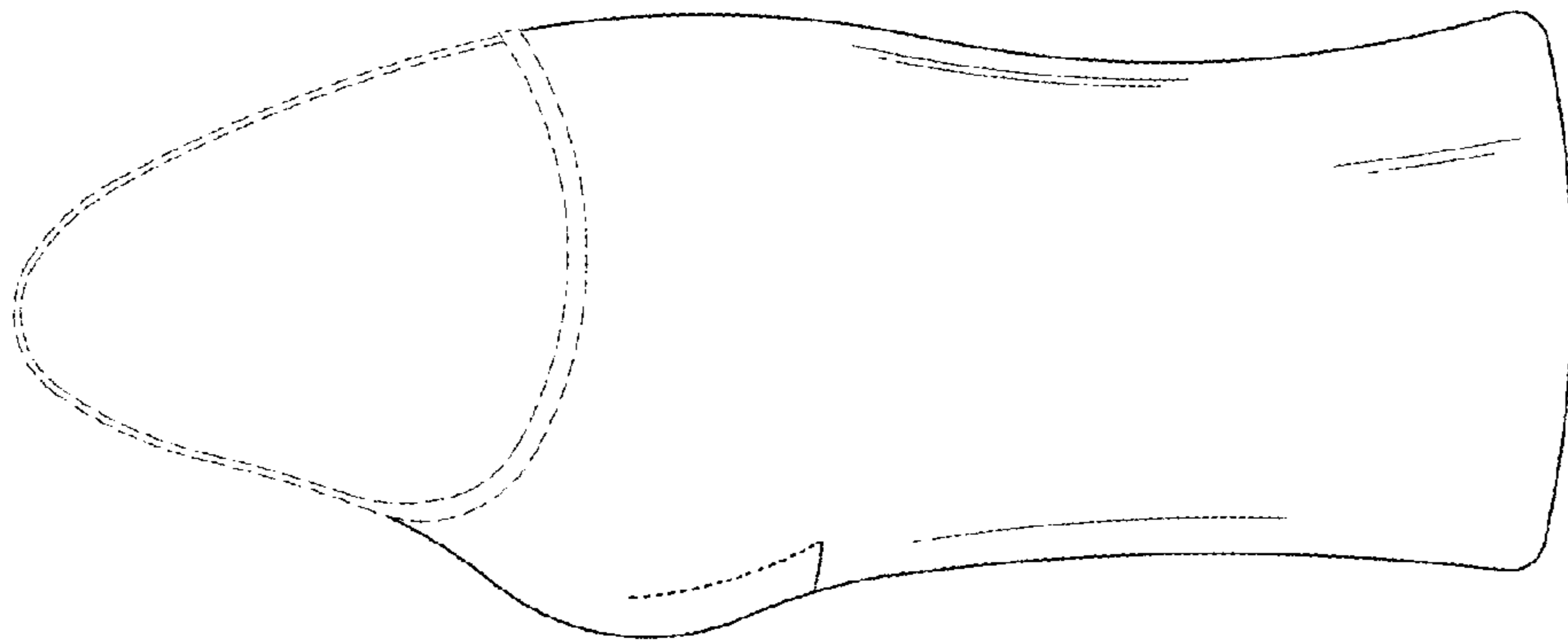

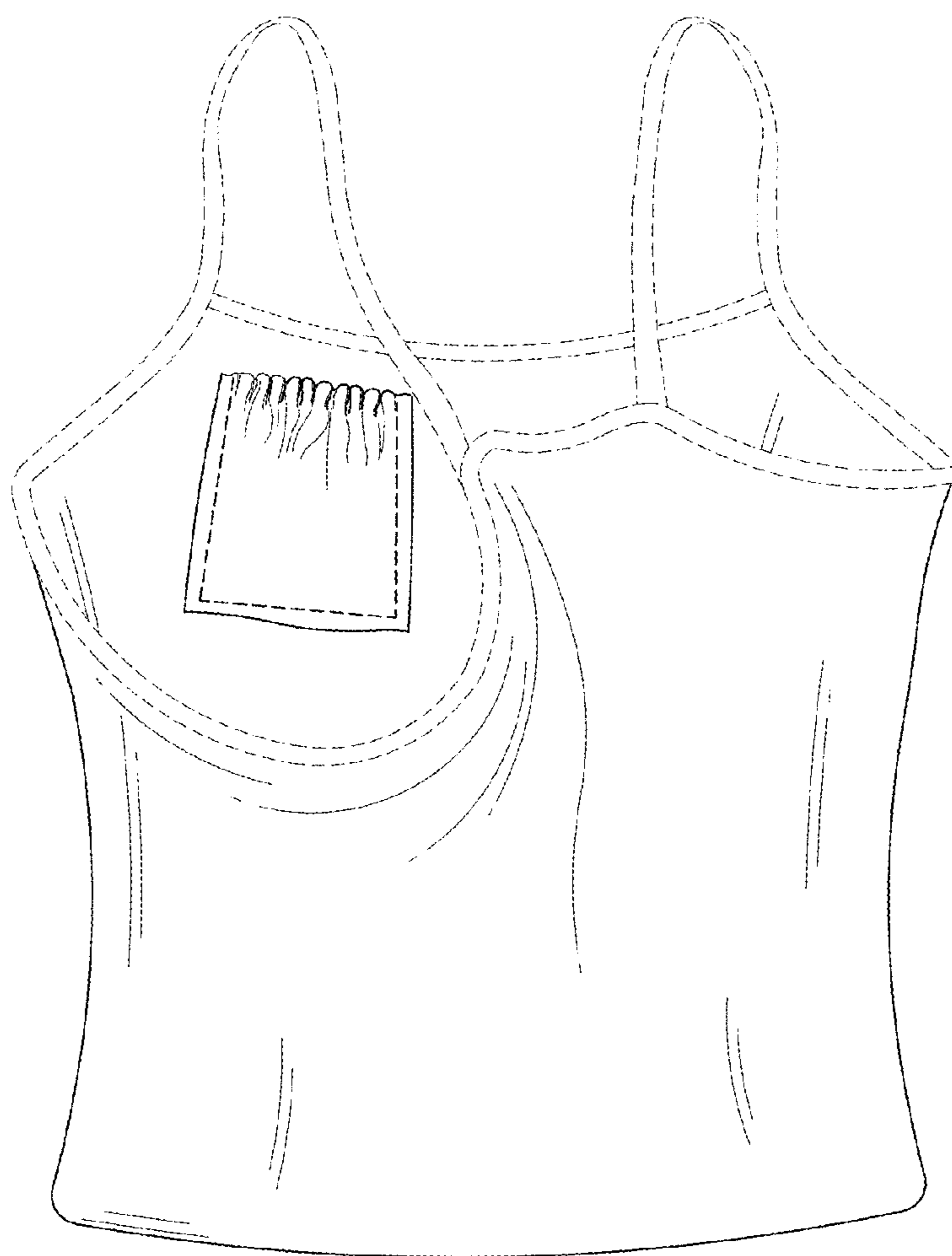

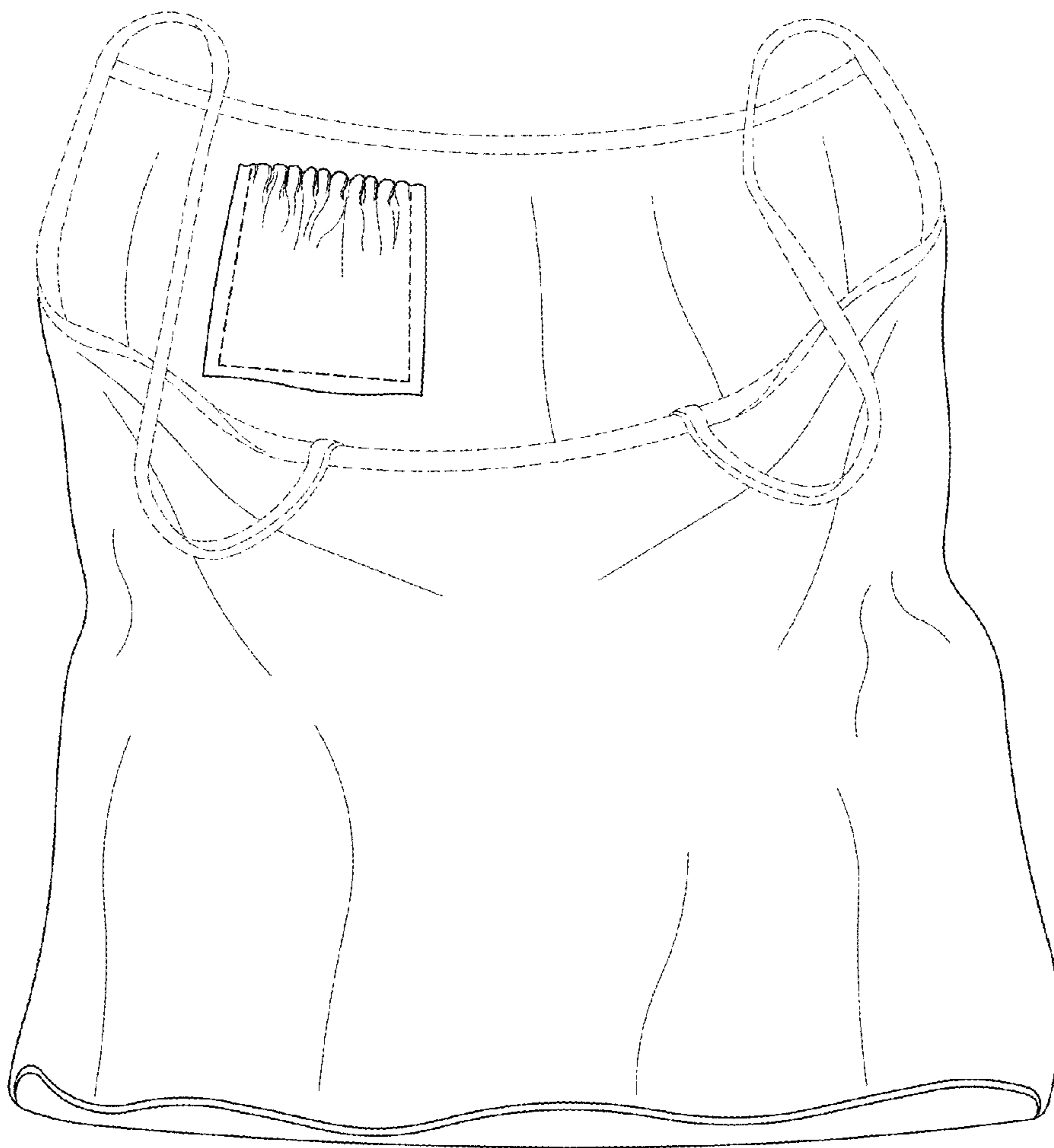

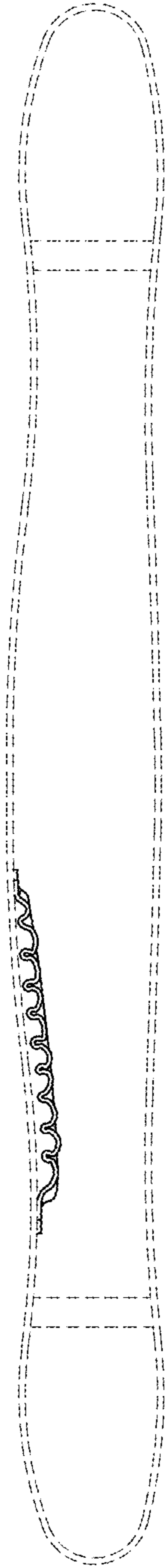

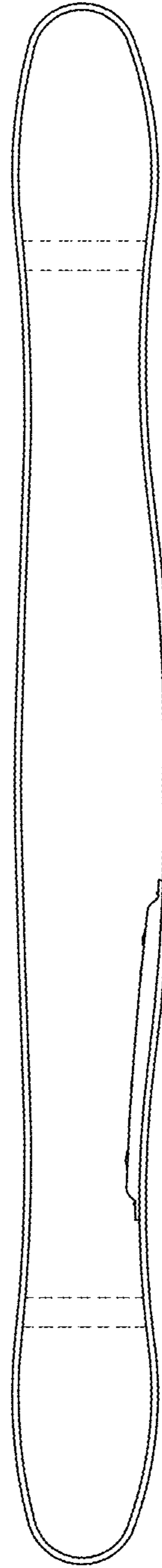
