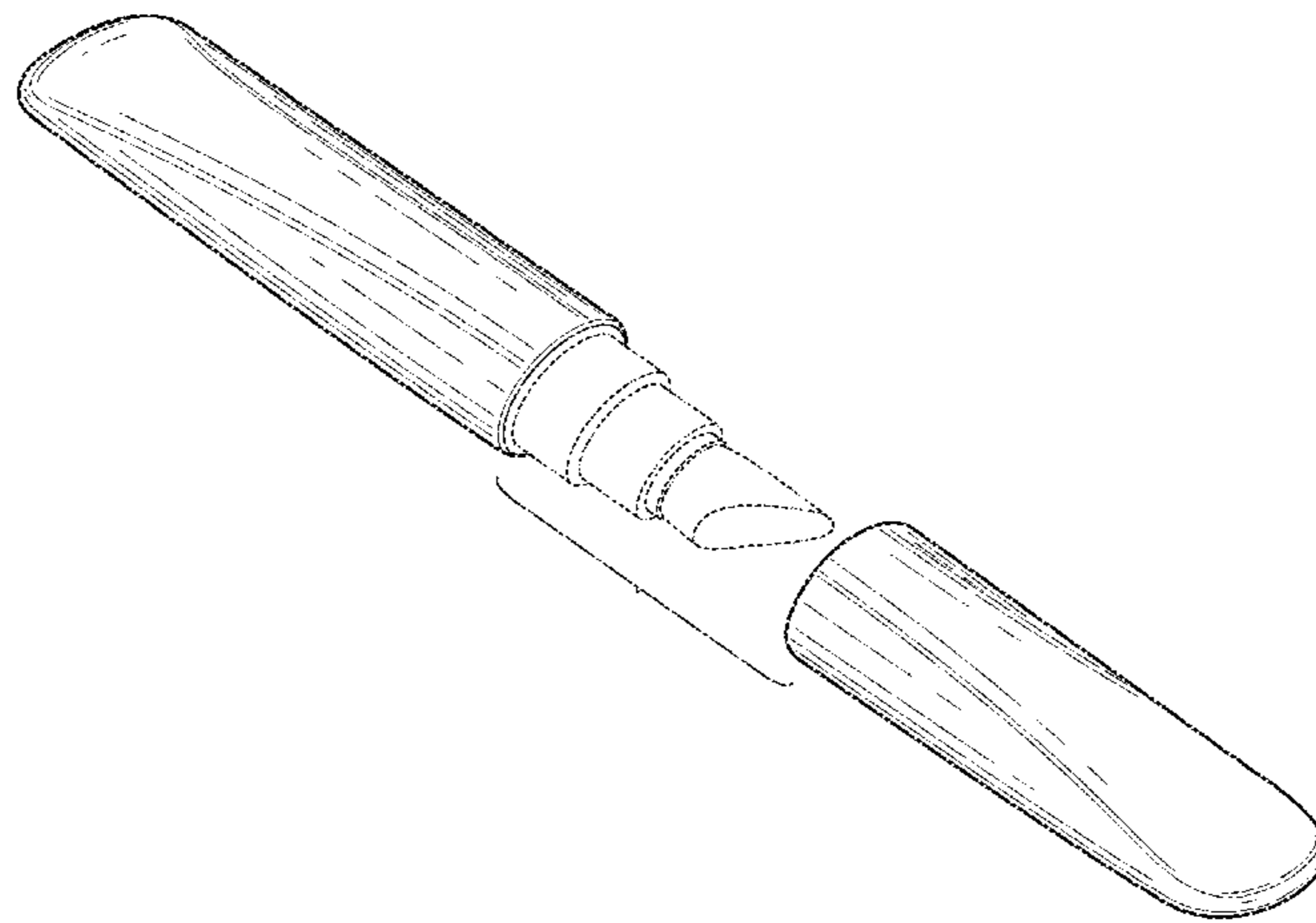

(57) **CLAIM**
The ornamental design for a cosmetic applicator, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cosmetic applicator showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a leading end view thereof; and,
FIG. 7 is a trailing end view thereof.
The broken lines in FIGS. 1 through 7 illustrate portions of the cosmetic applicator which form no part of the claimed design.

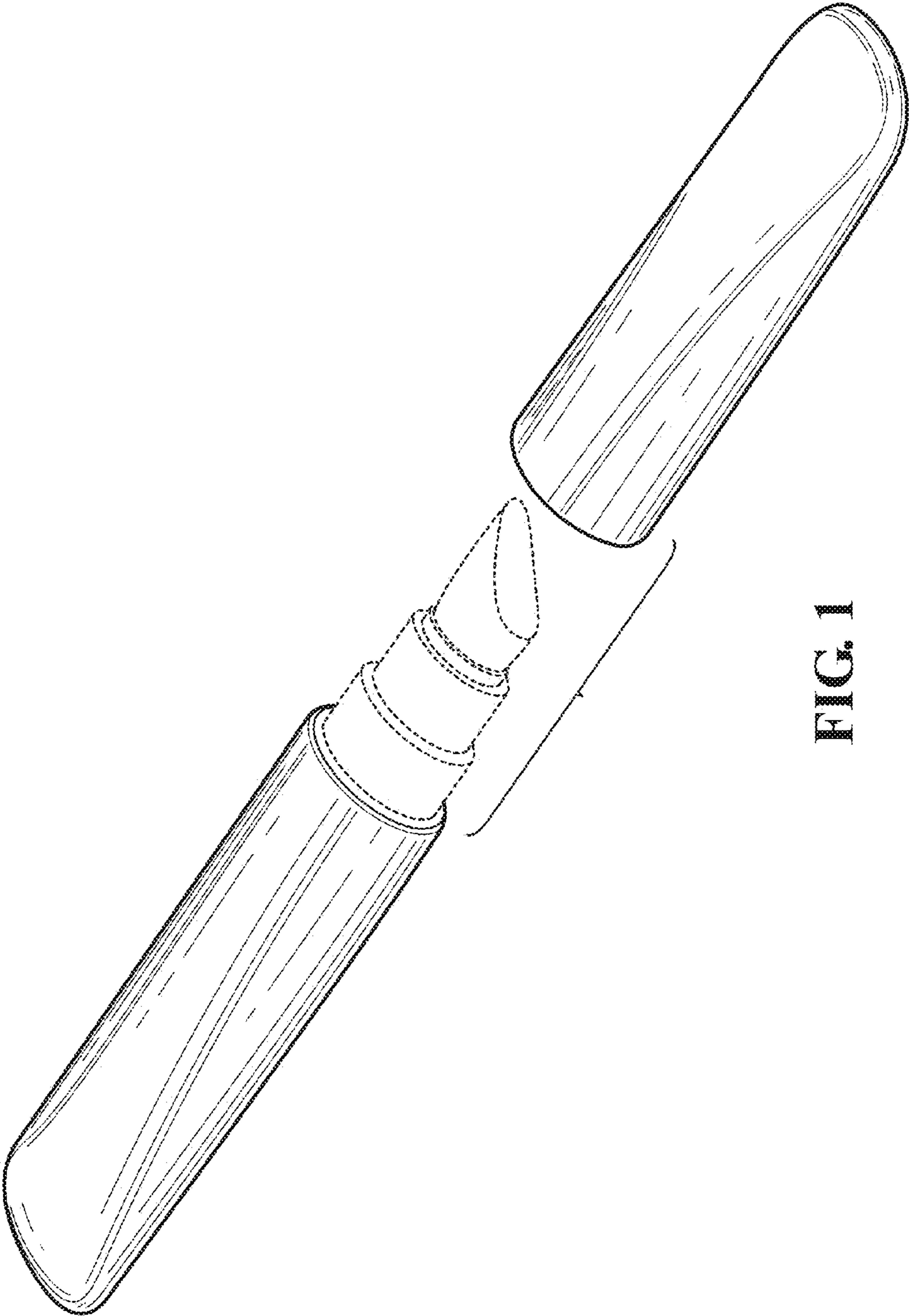

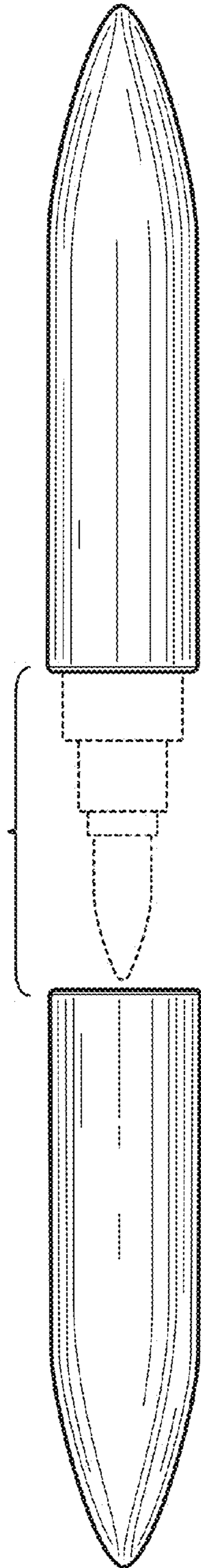

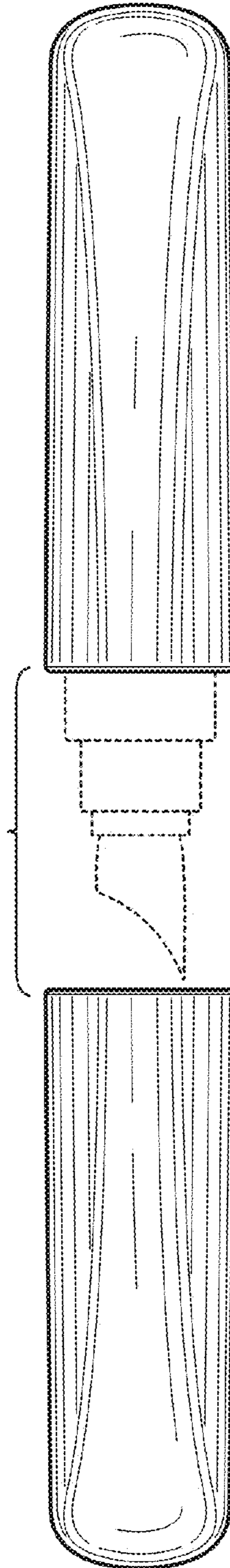

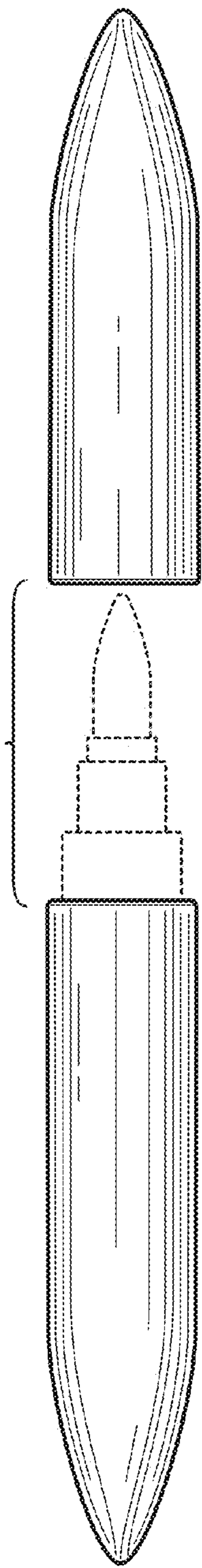

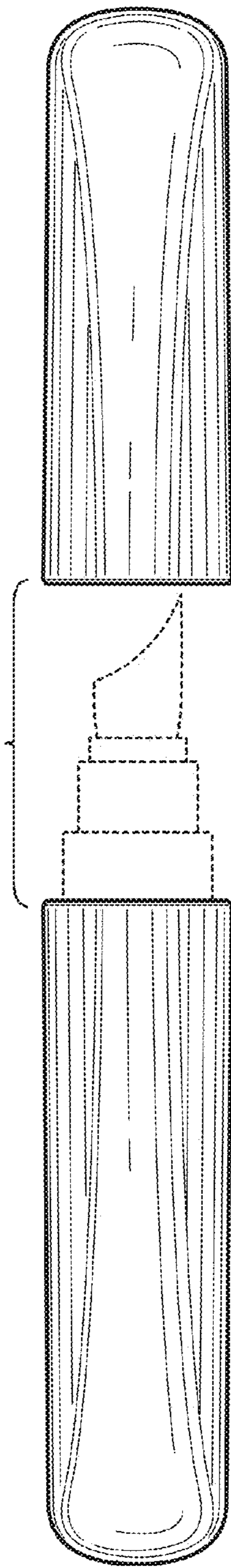

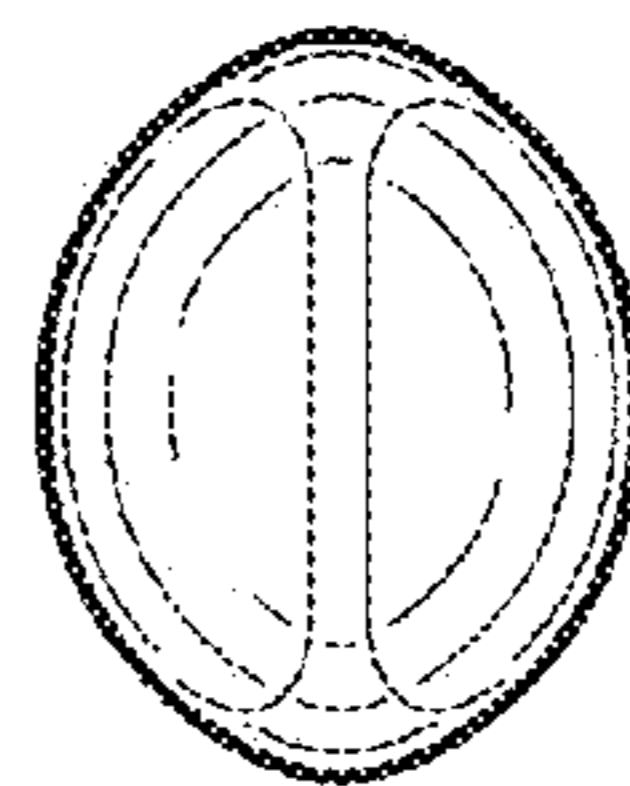

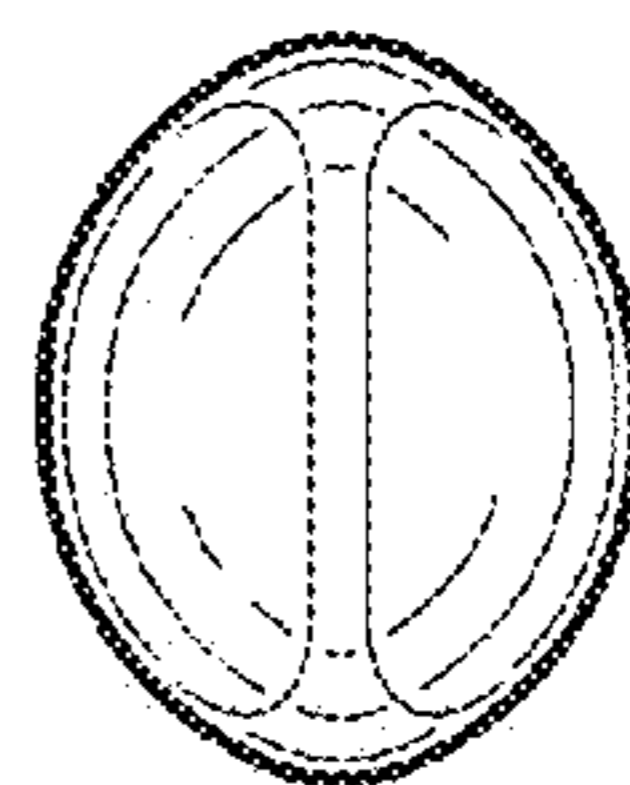
