FIG. 1 is an isometric view of a urinal mat; and, FIG. 2 is a front view thereof.

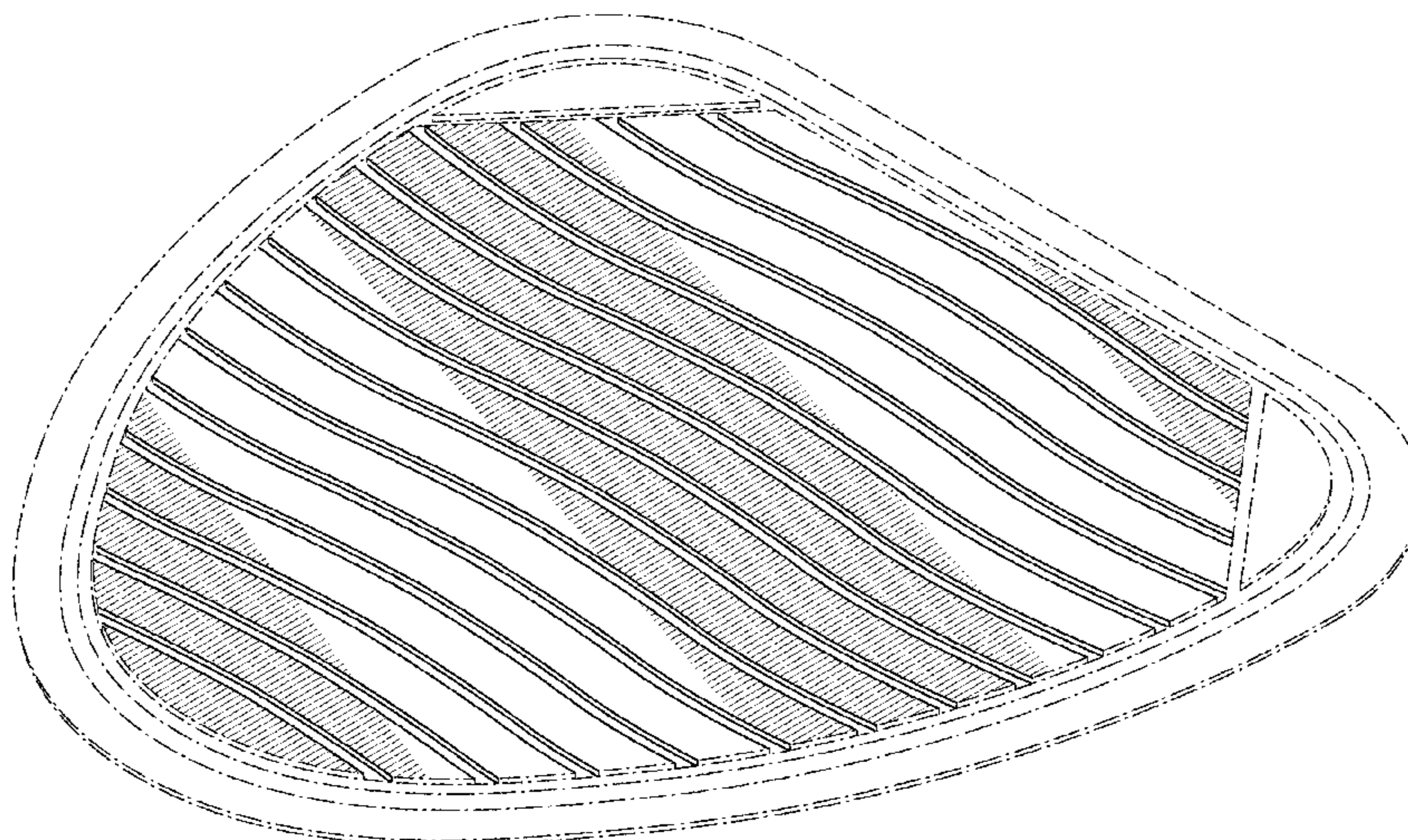

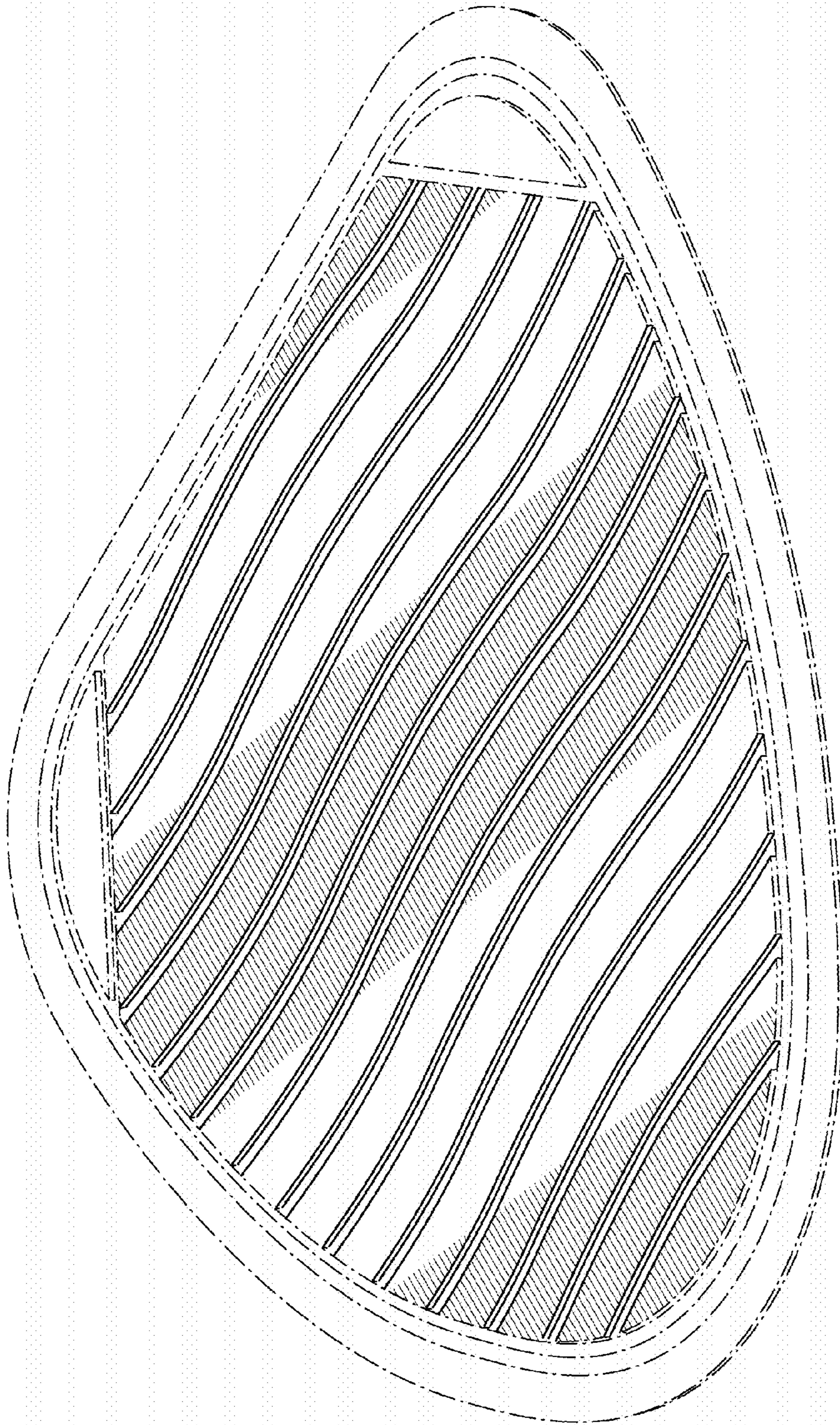

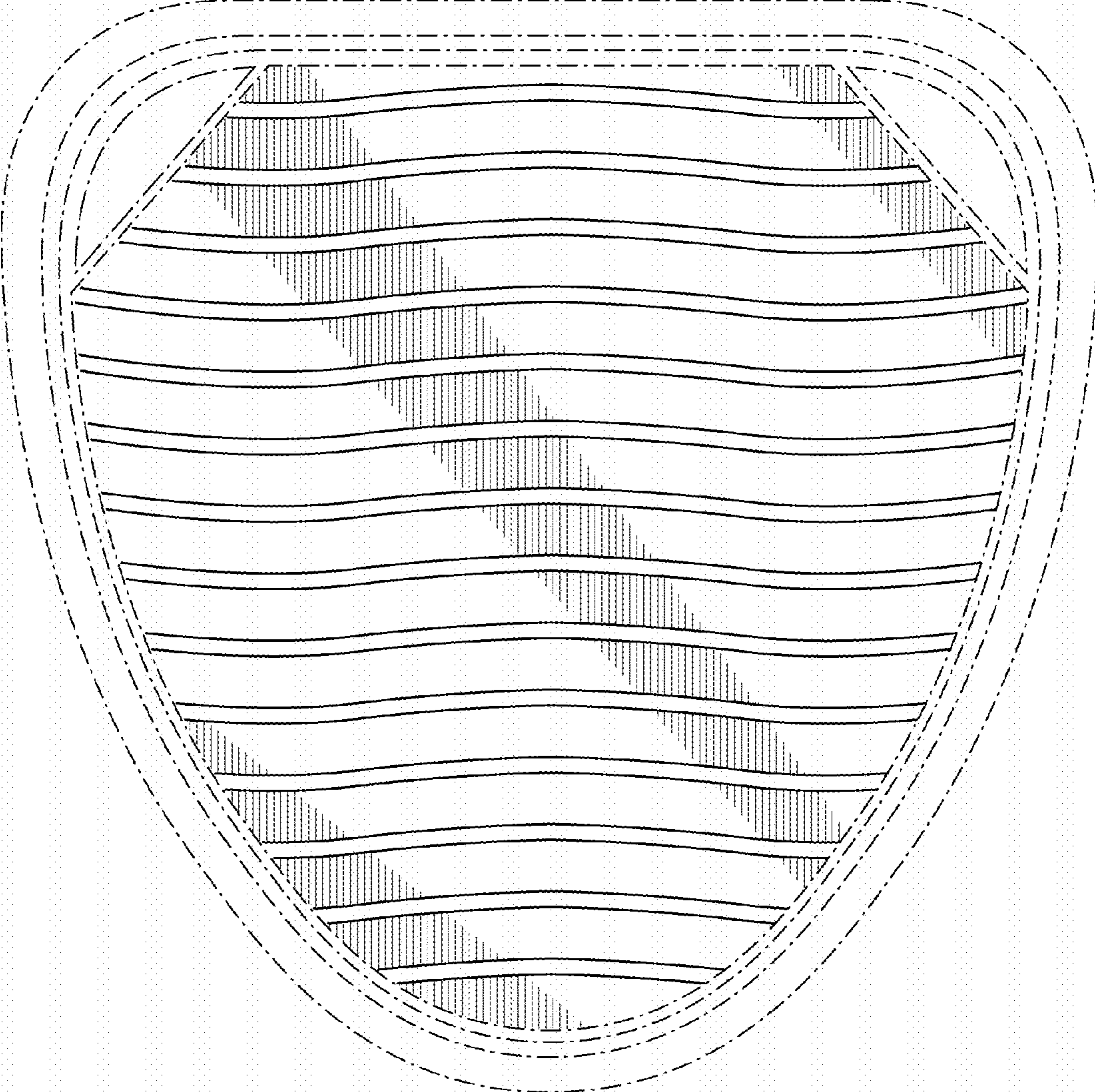
