The ornamental design of a drawer assembly with narrow upper shelf, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a drawer assembly with narrow upper shelf in accordance with my design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a side elevational view thereof as viewed from the right side of FIG. 2; and,

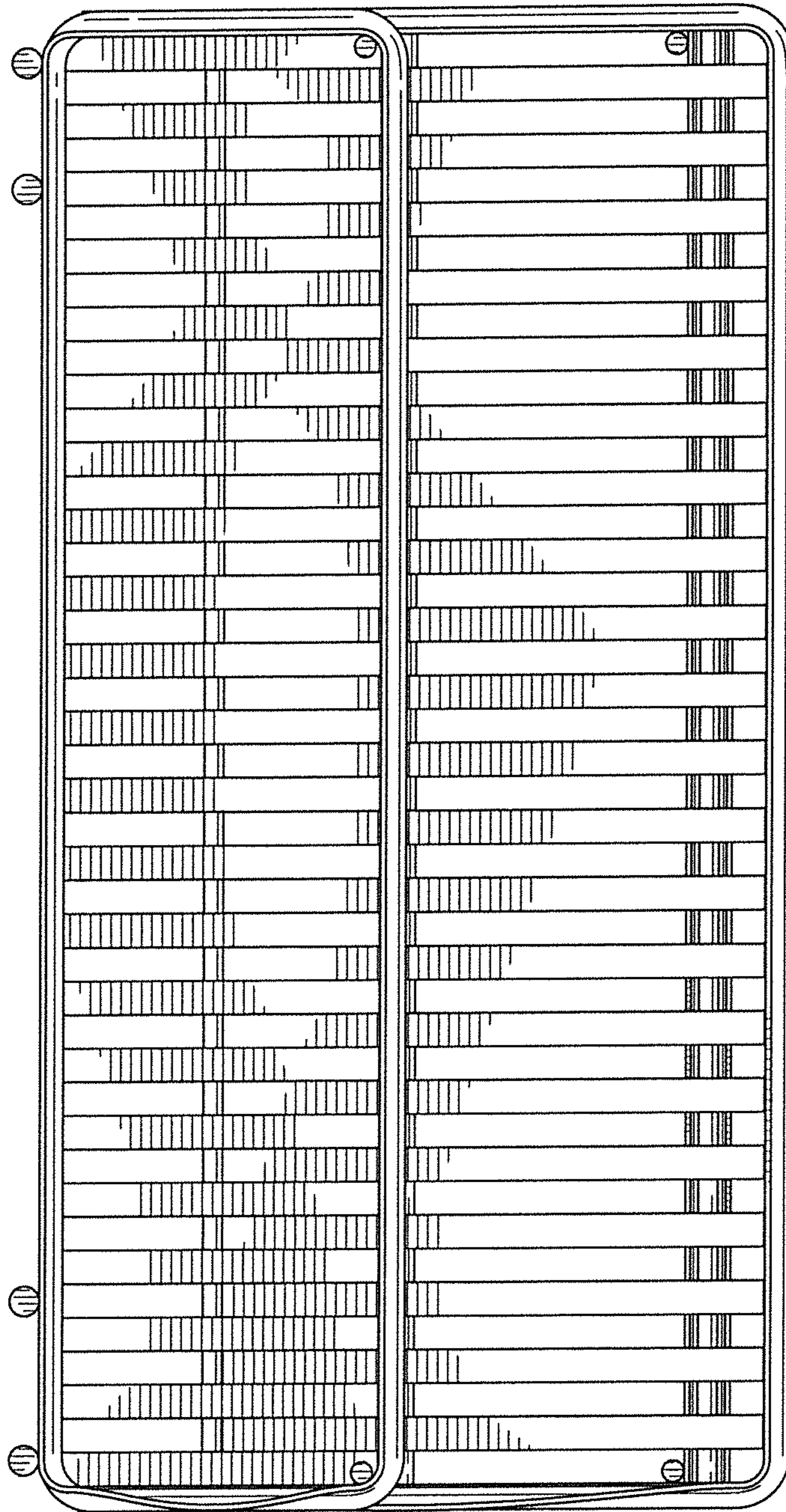

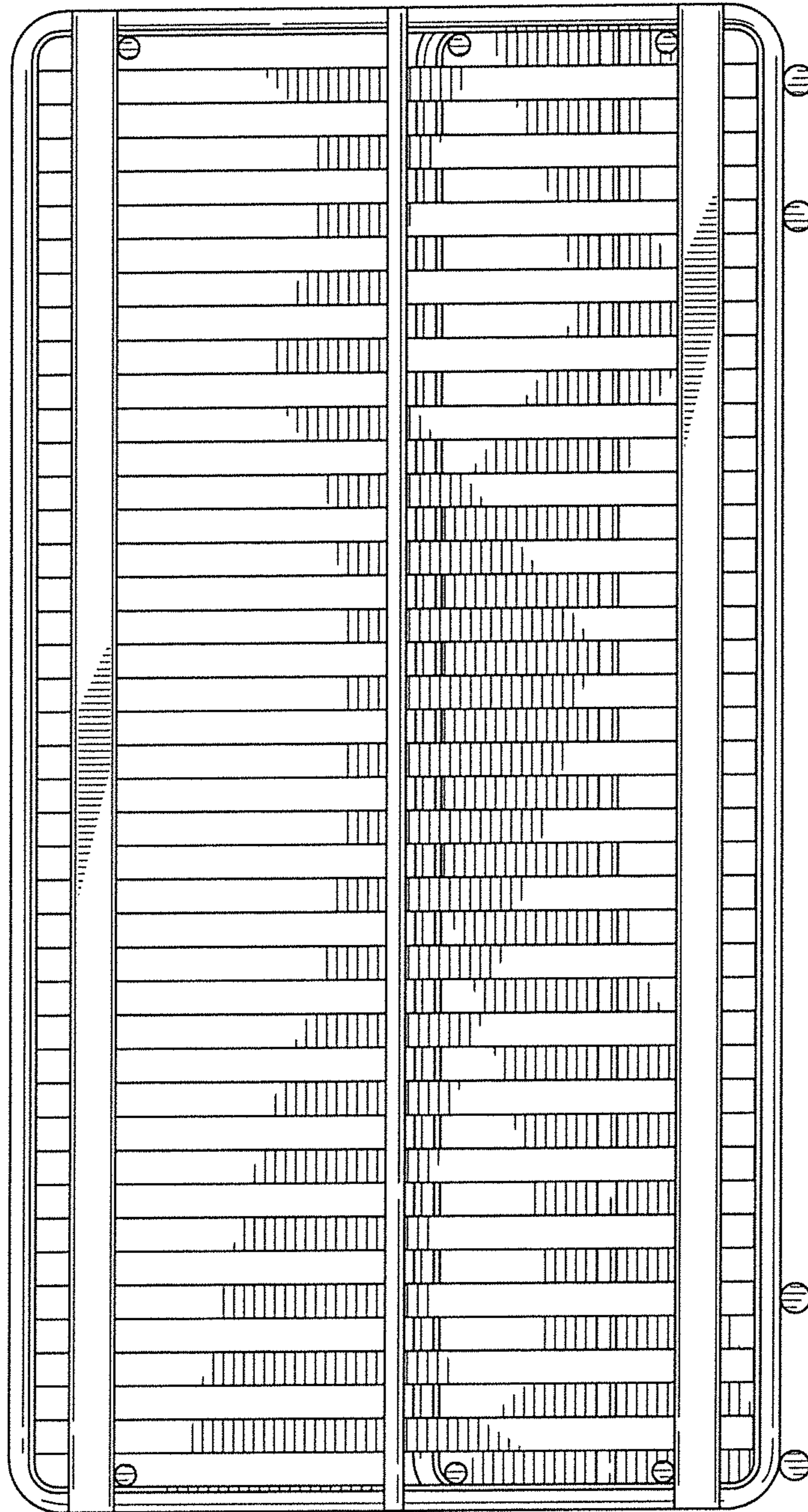

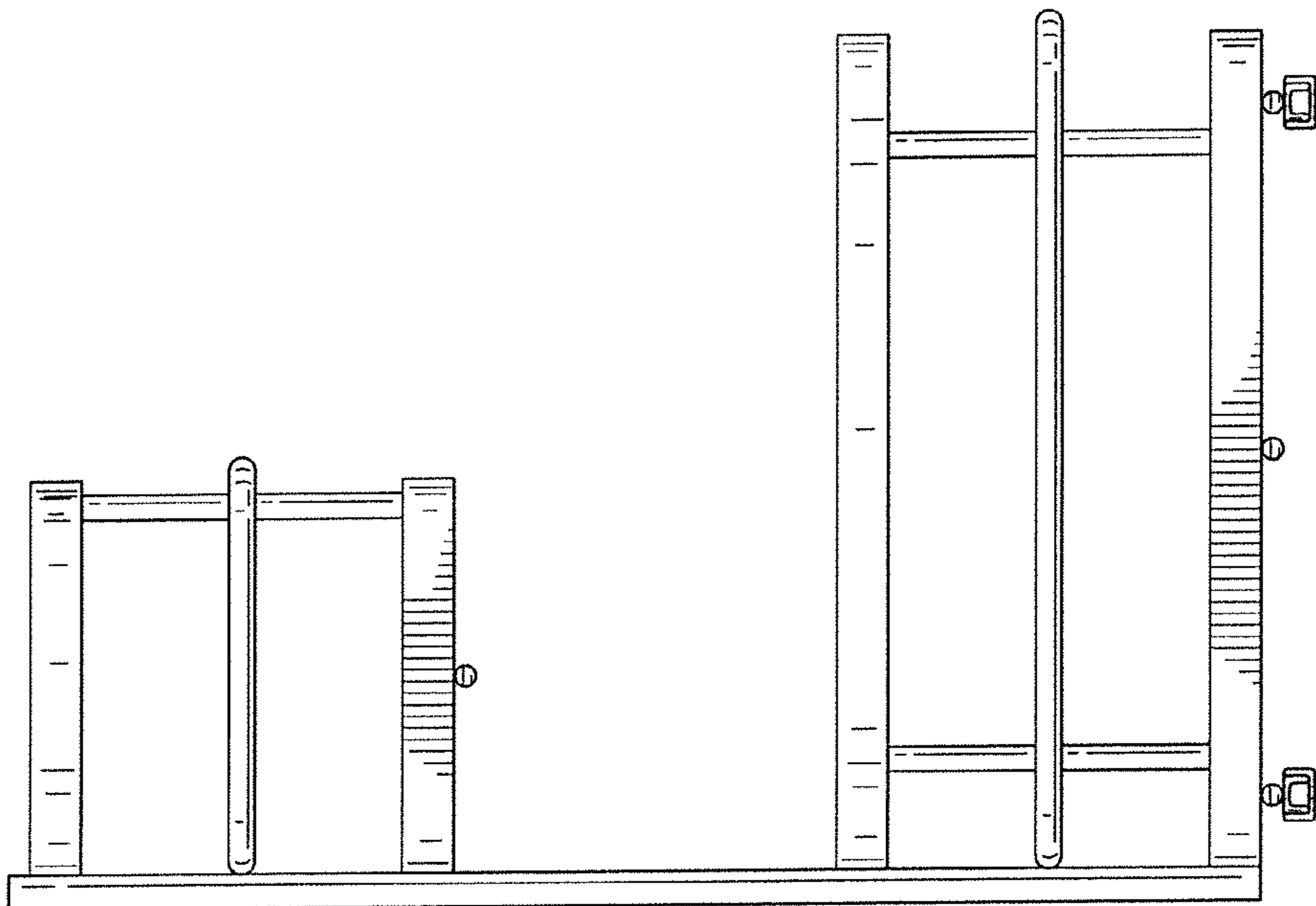

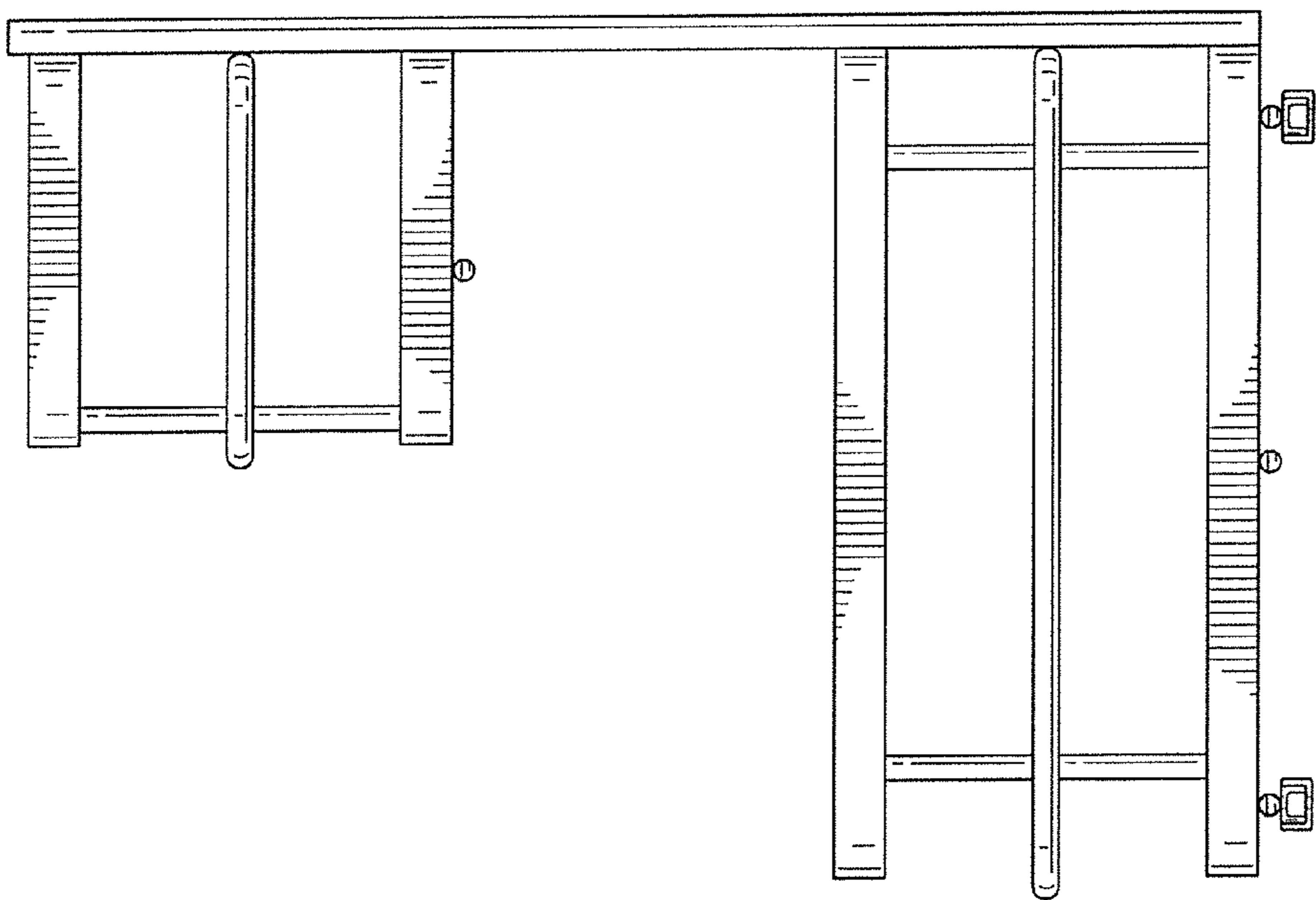

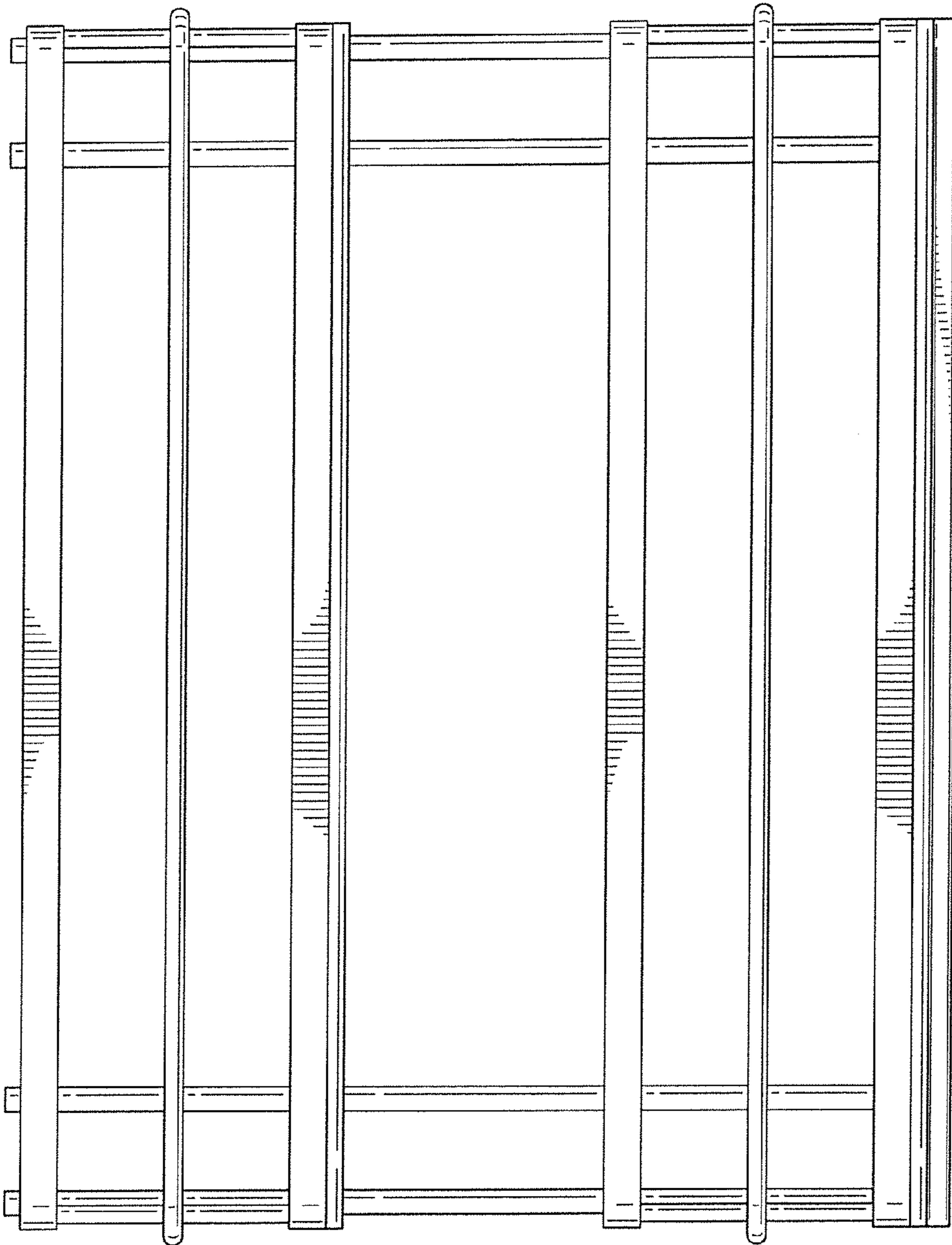

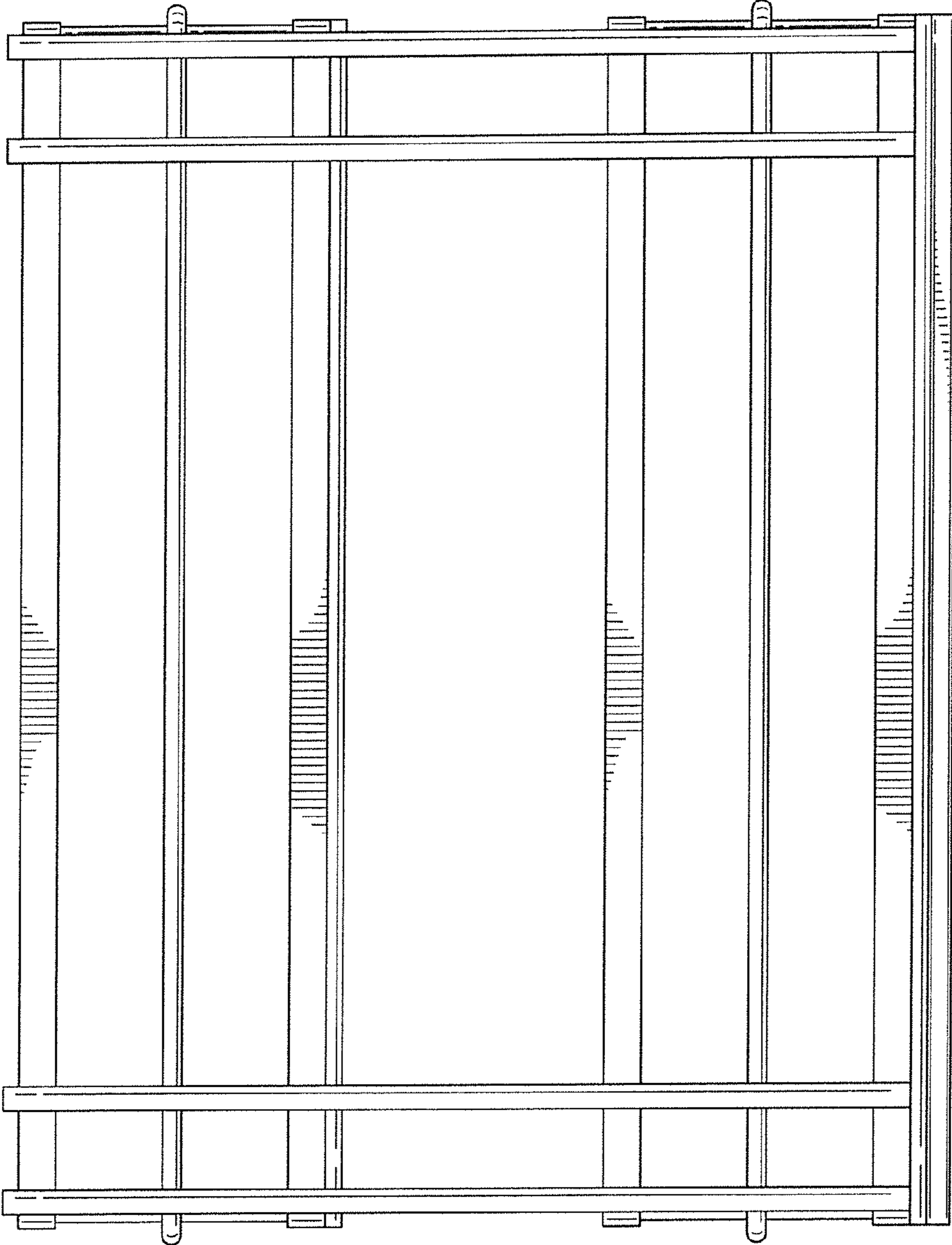
