FIG. 2 is another perspective view of the canister of FIG. 1;


FIG. 3 is a side view of the canister of FIG. 1;


FIG. 4 is a bottom plan view of the canister of FIG. 1; and,

FIG. 5 is a top plan view of the canister of FIG. 1.


All side views are mirror images of that shown in FIG. 3.









