(57) **CLAIM**

I claim the ornamental design of an interlocking utensil, as shown and described.

DESCRIPTION

FIG. 24 is a bottom view thereof;

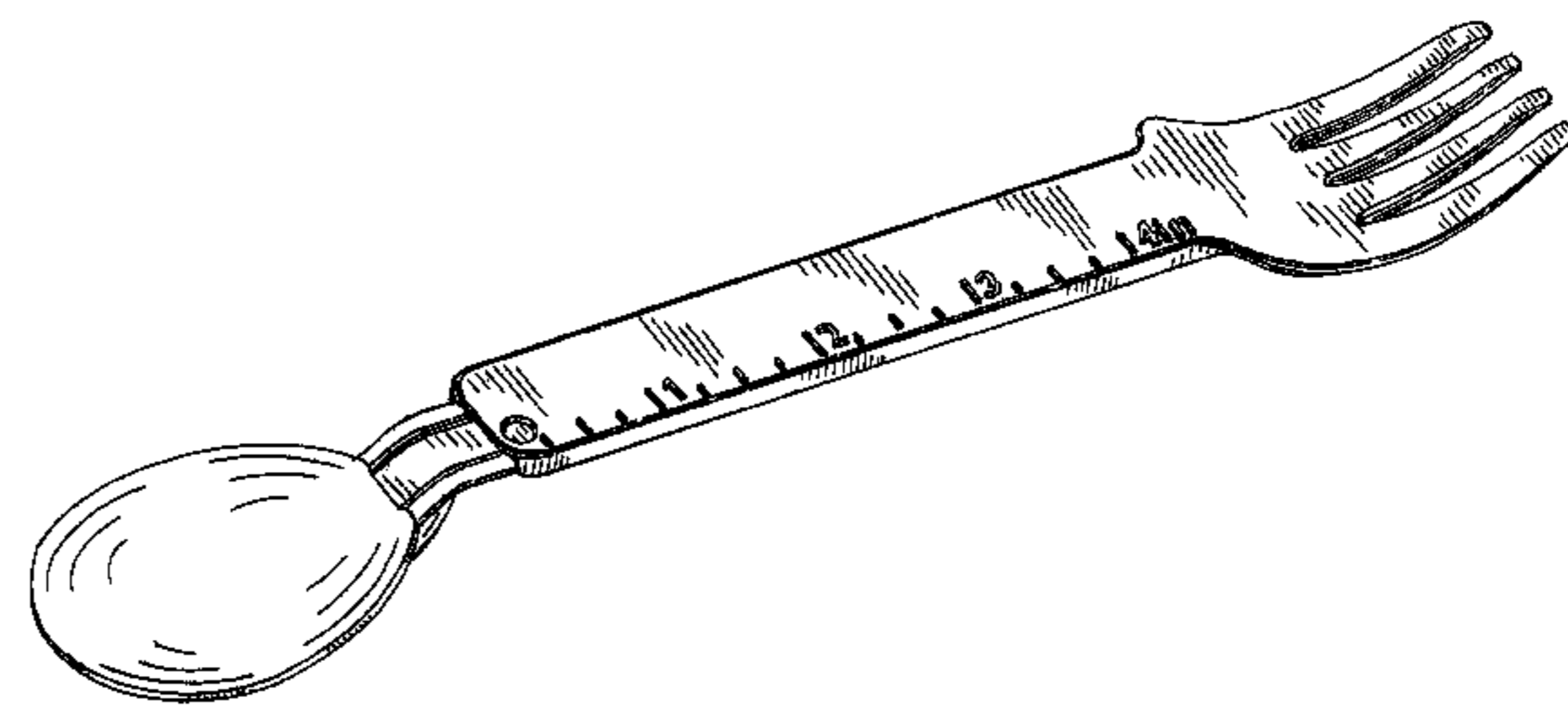
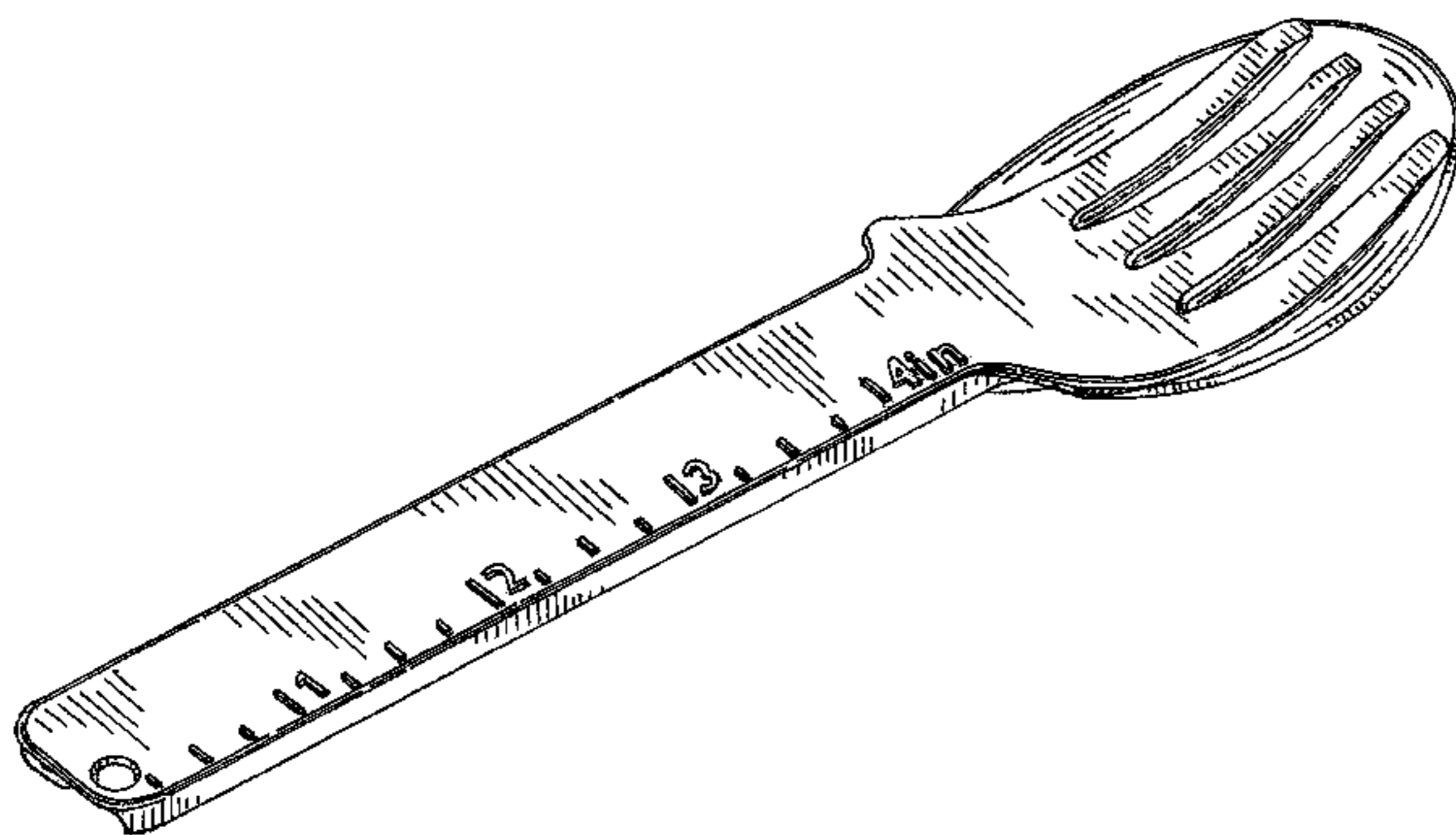
FIG. 25 is a right side view thereof;

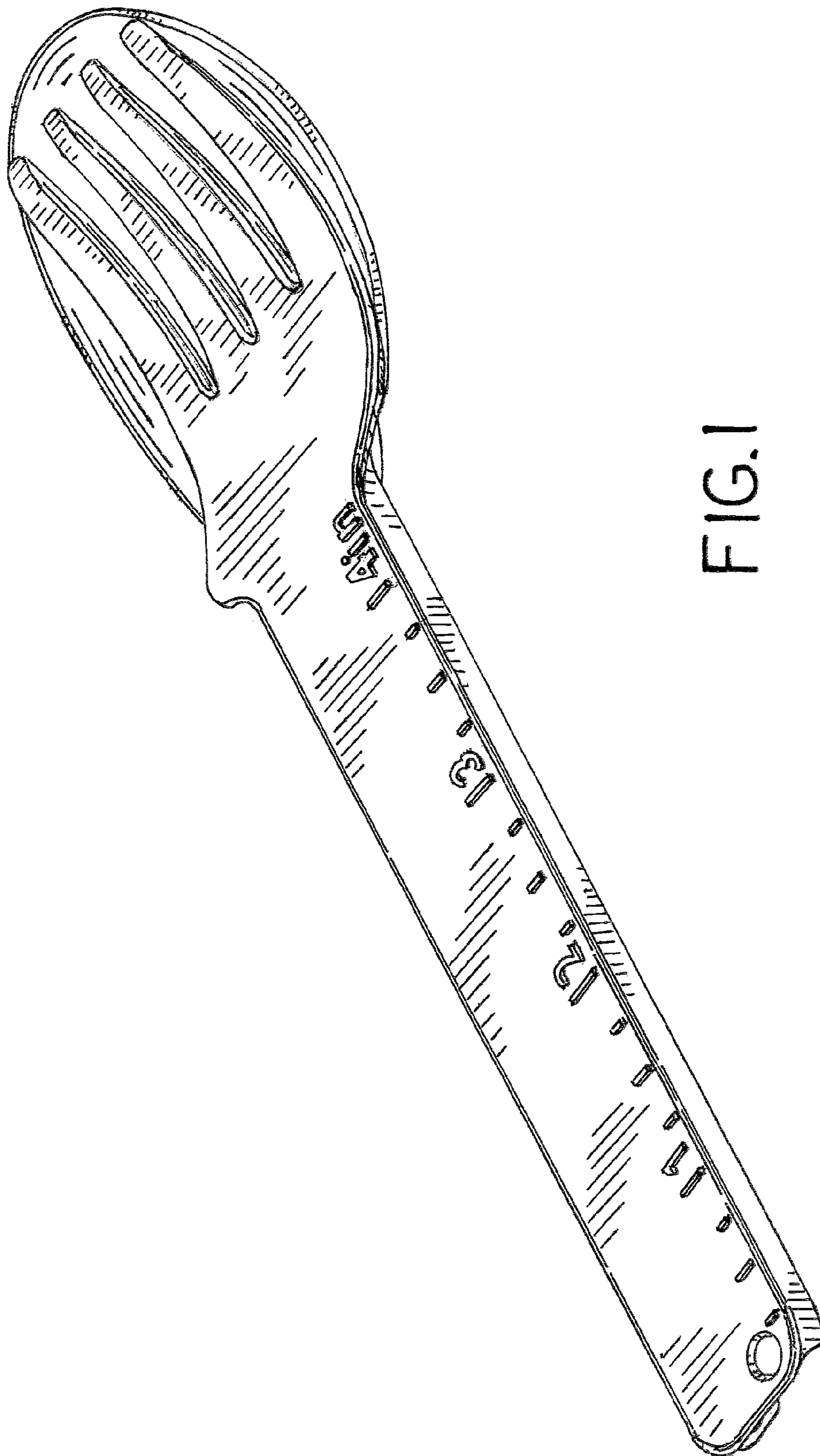

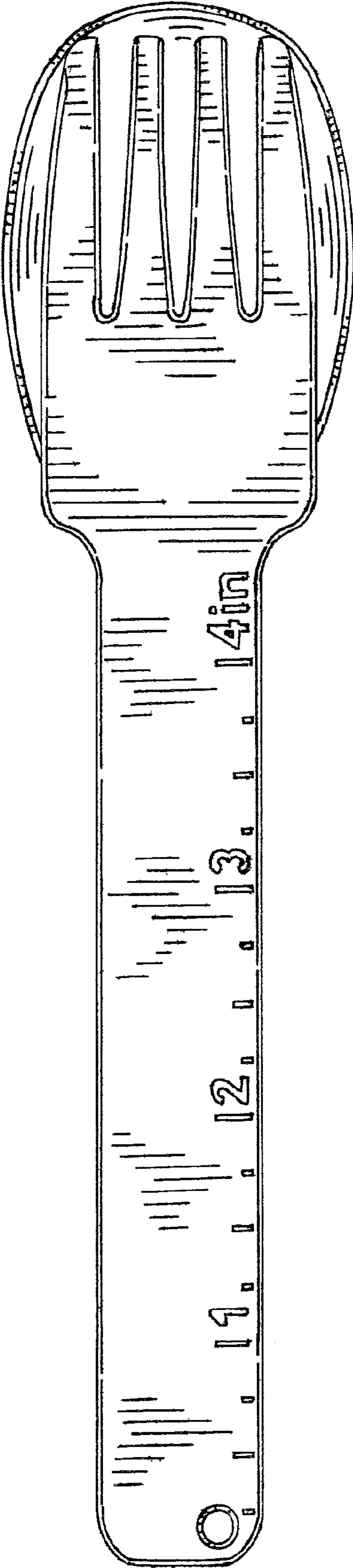

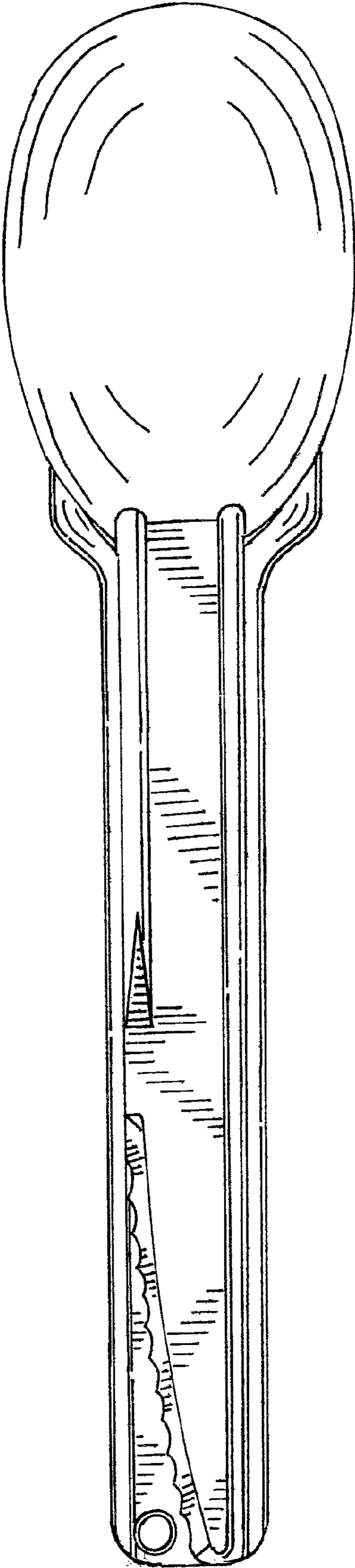

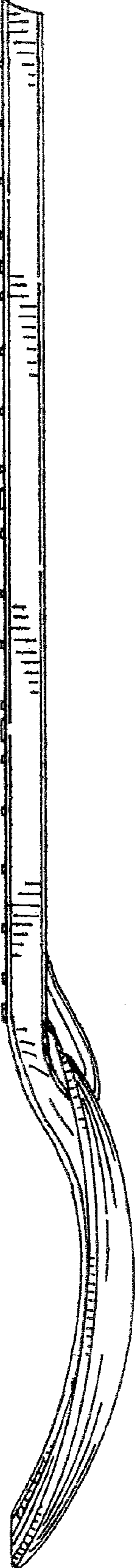

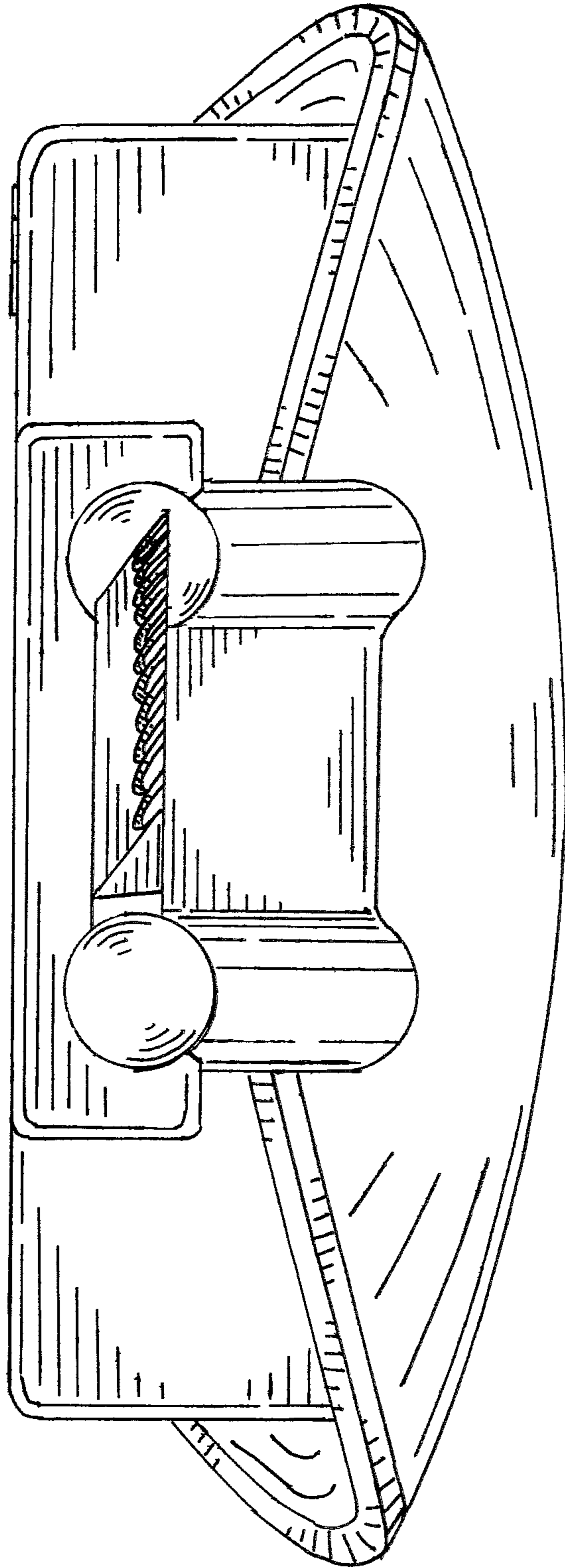

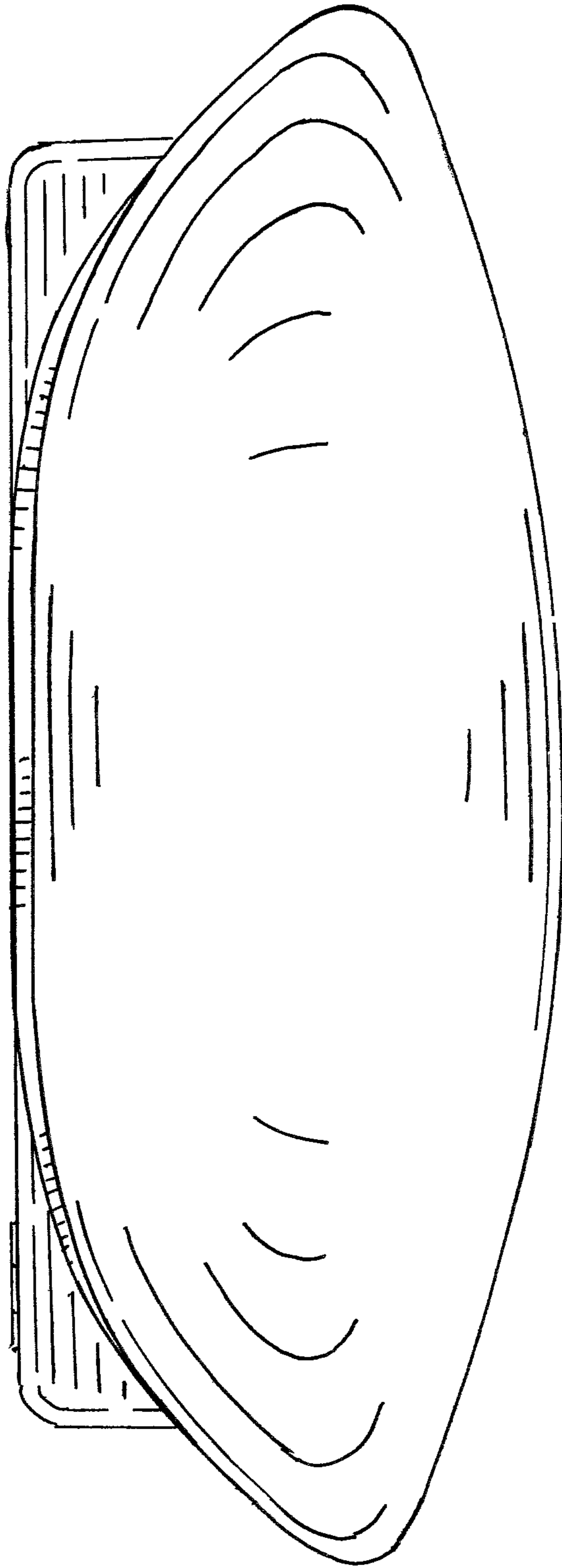

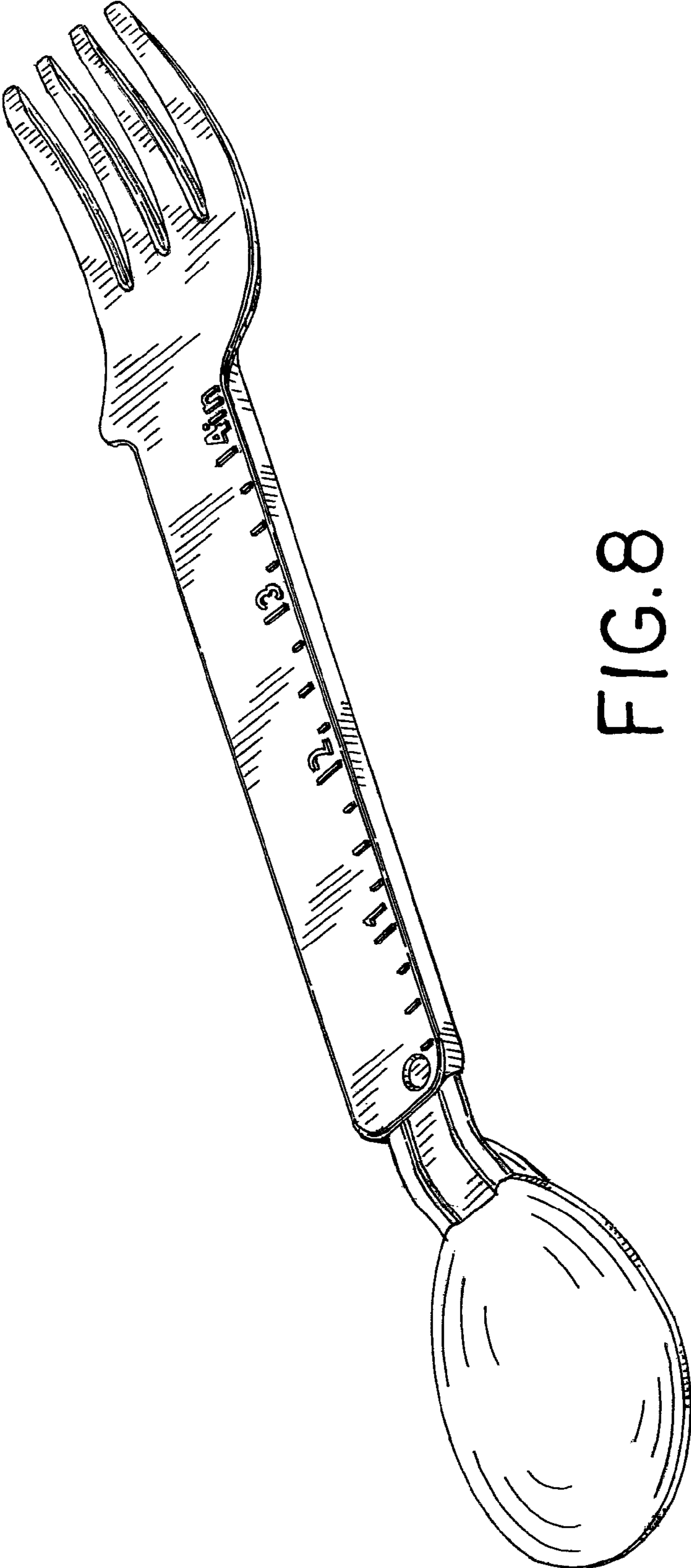

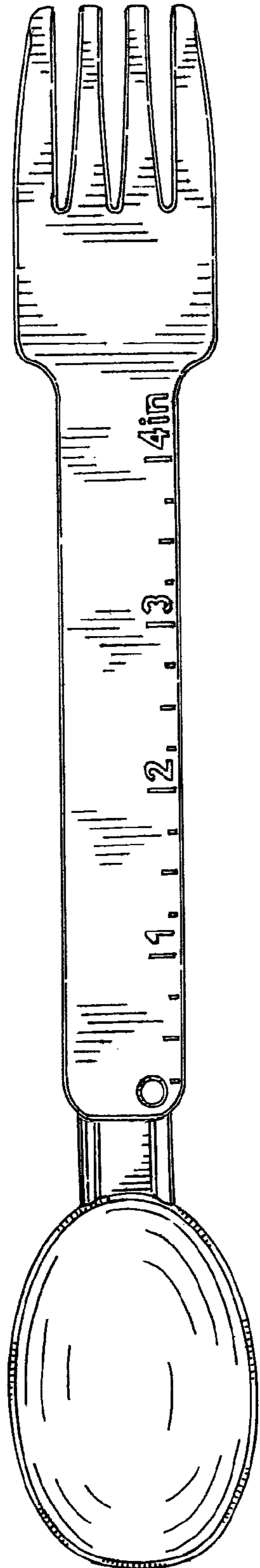

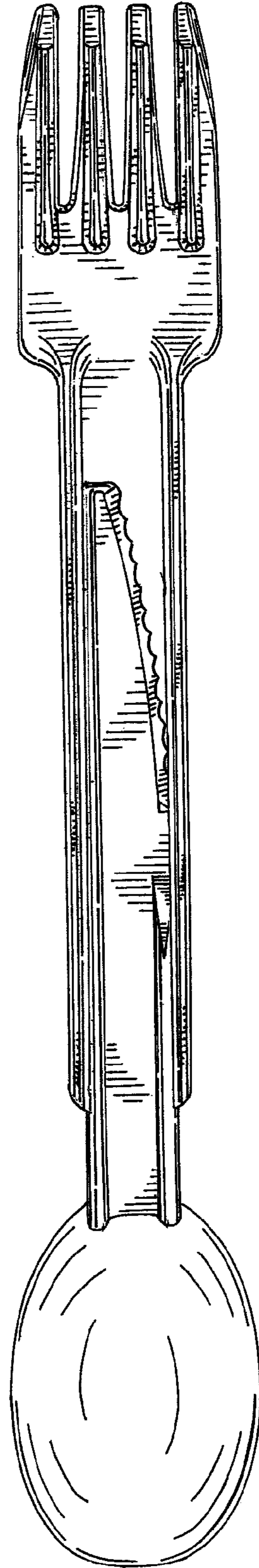

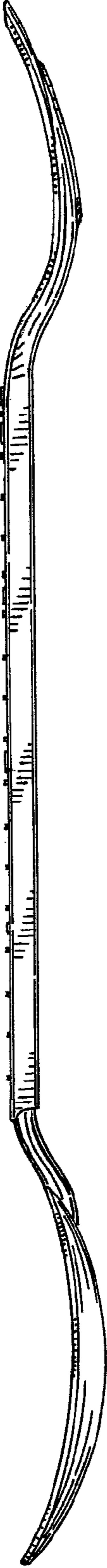

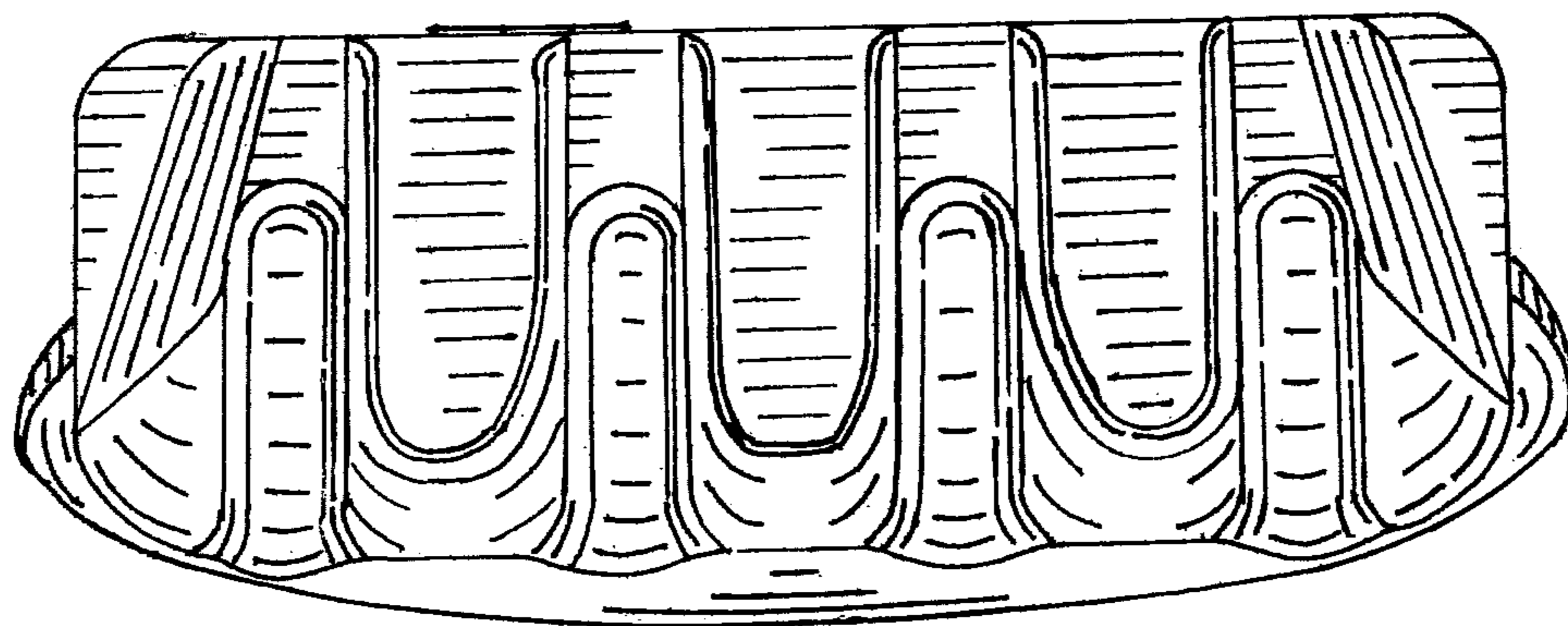

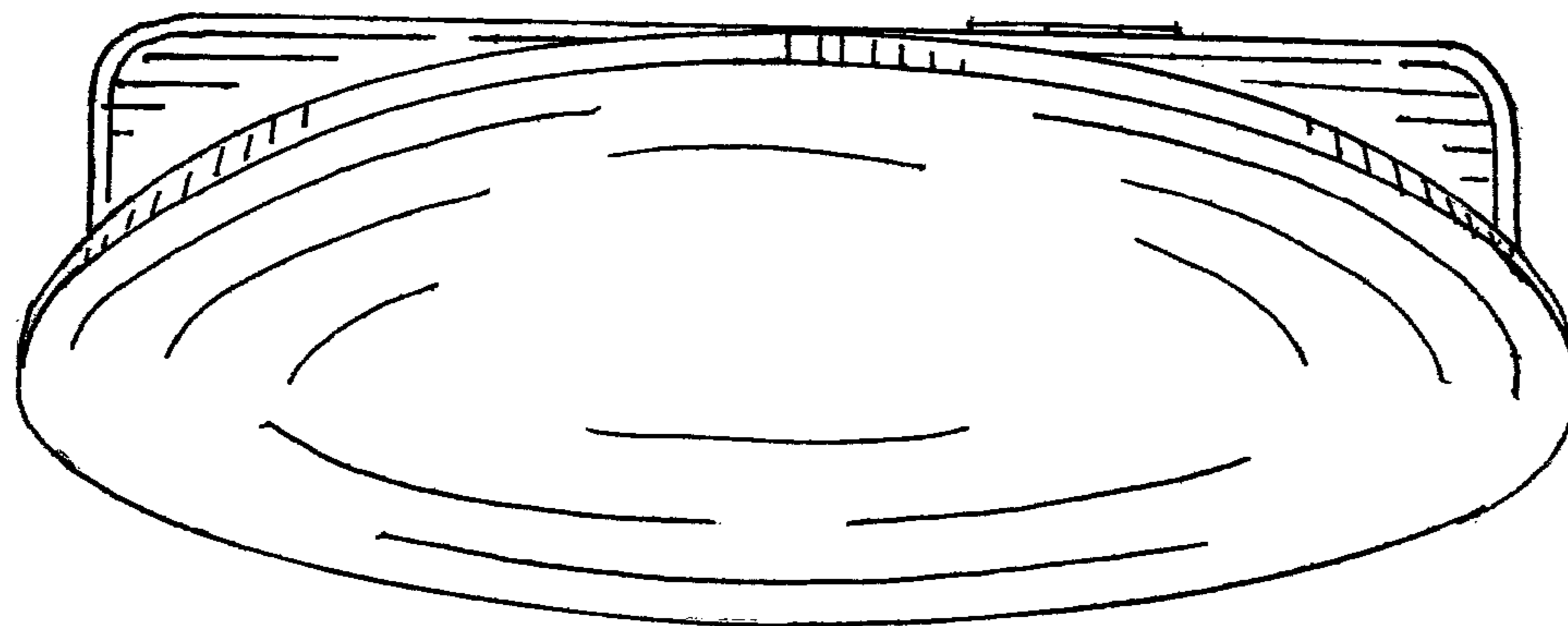

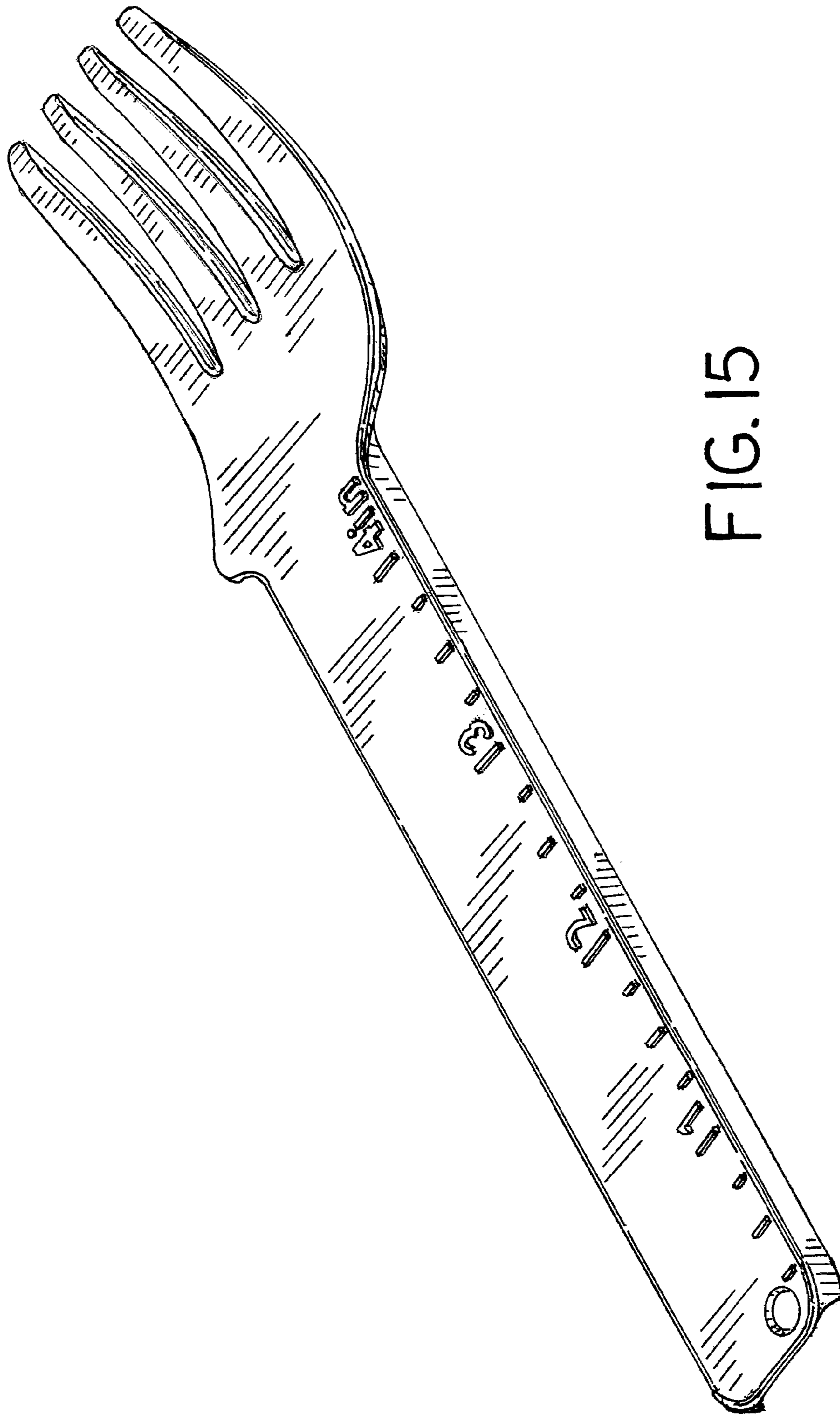

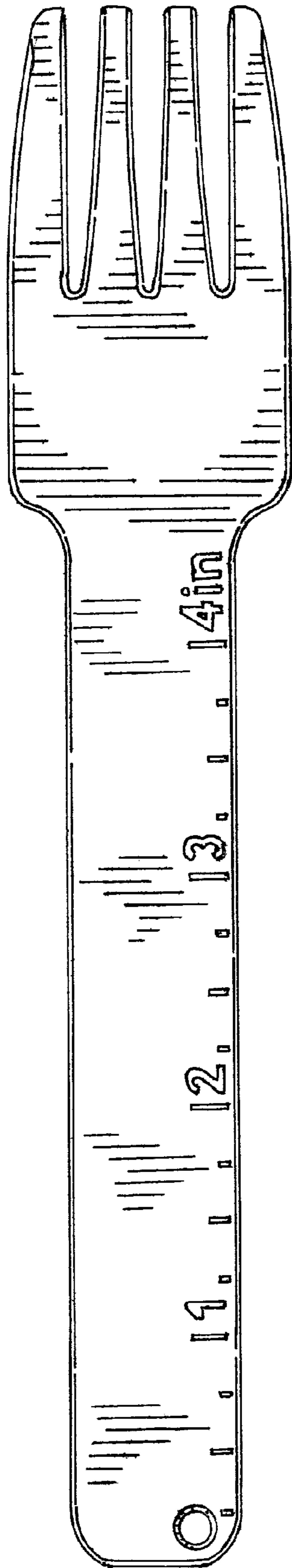

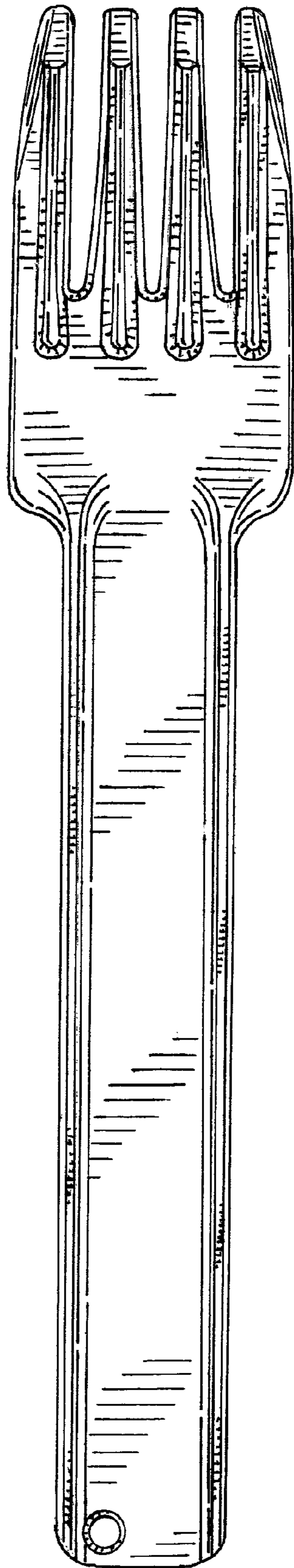

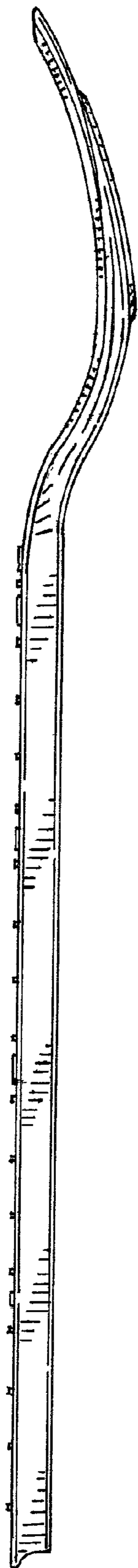

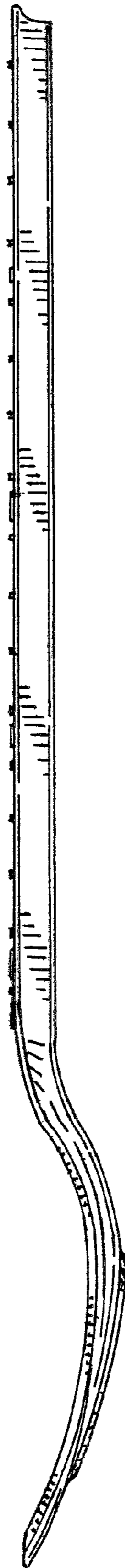

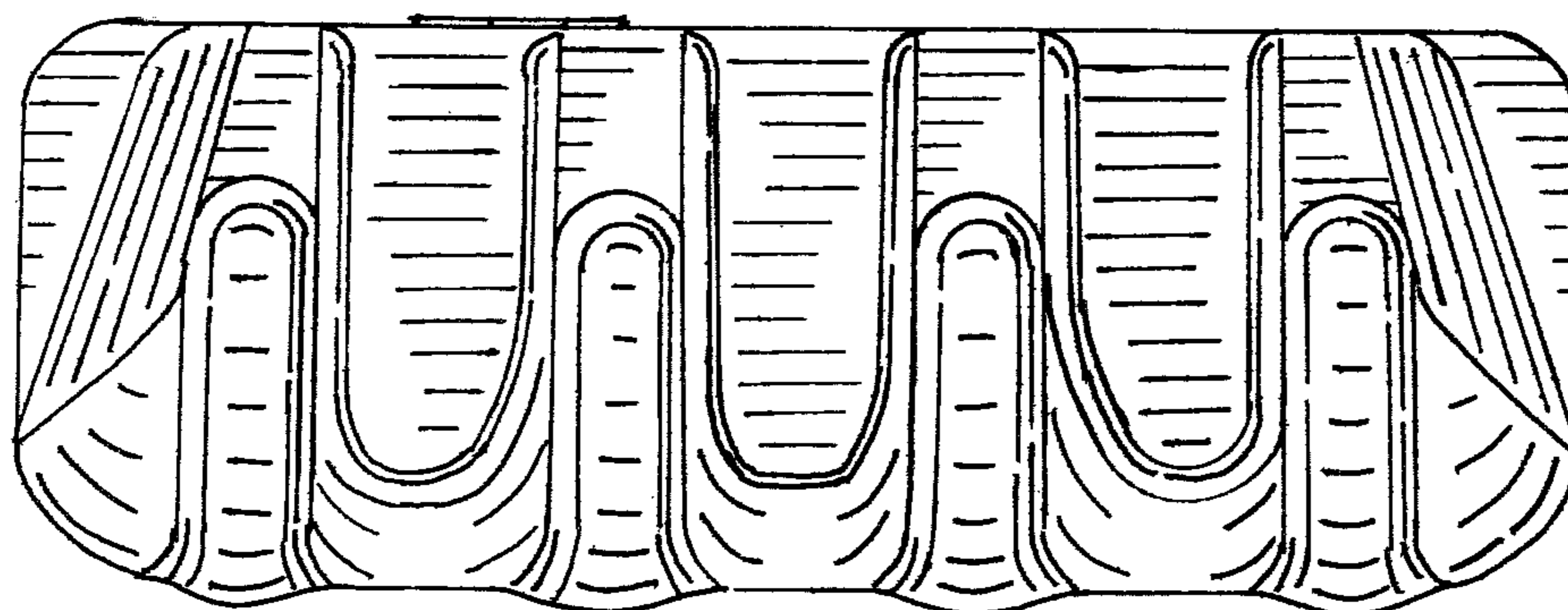

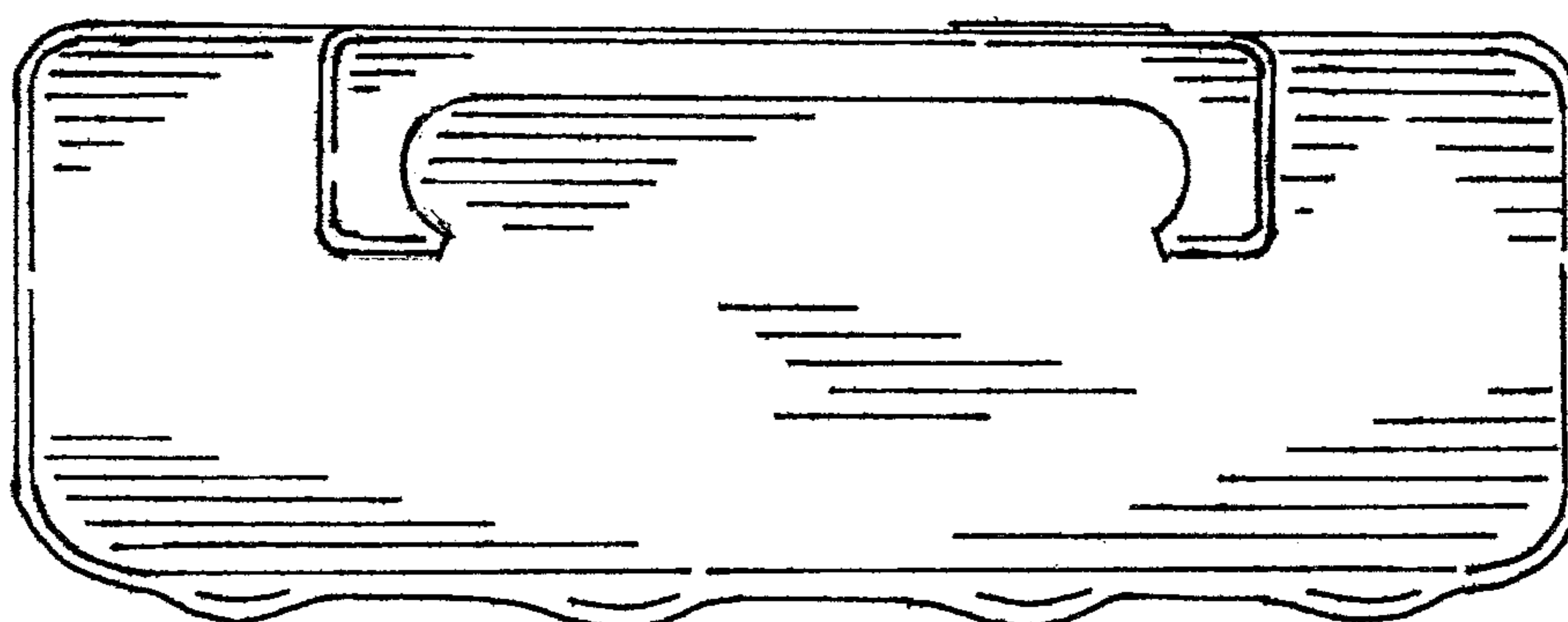

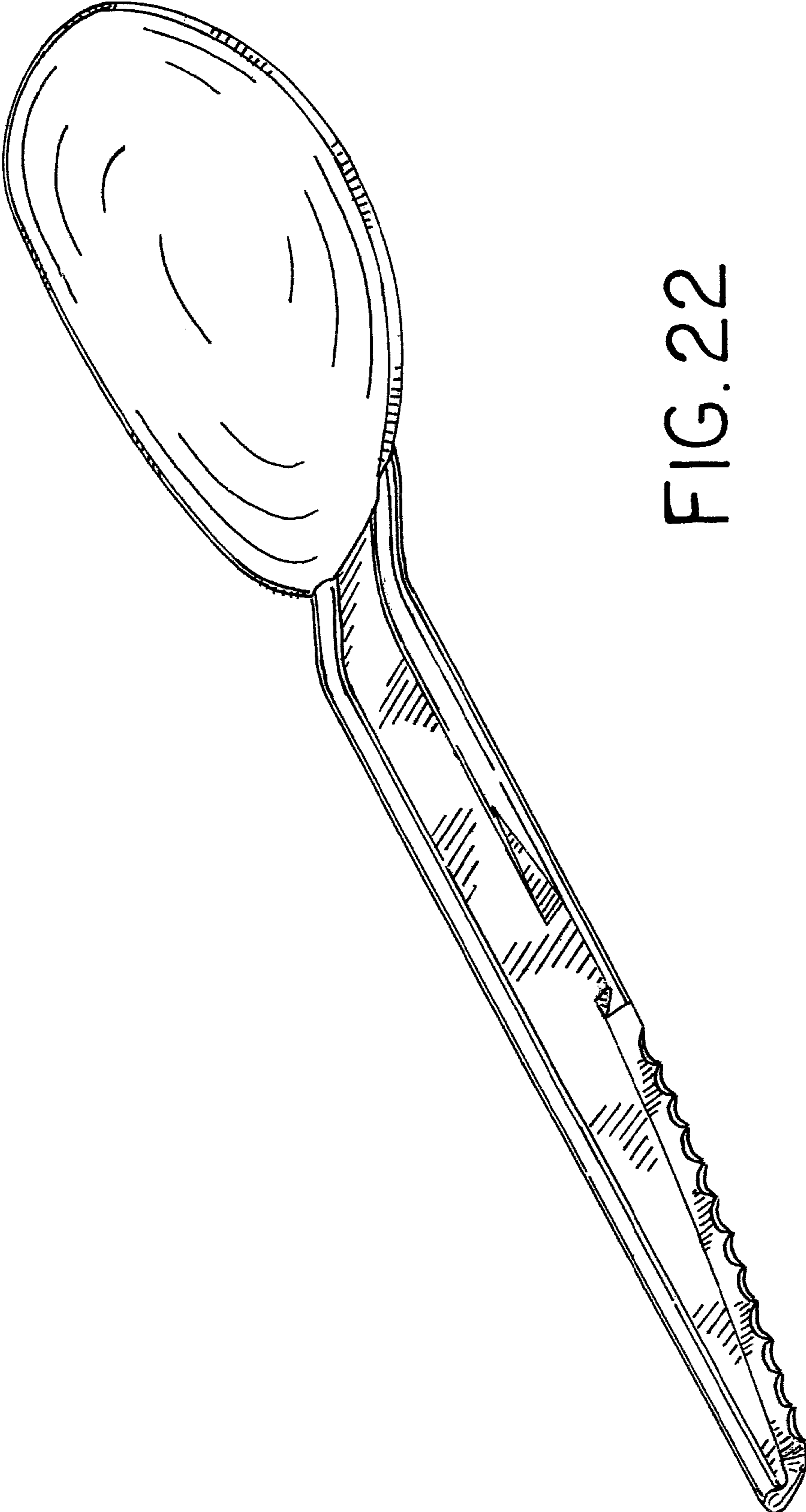

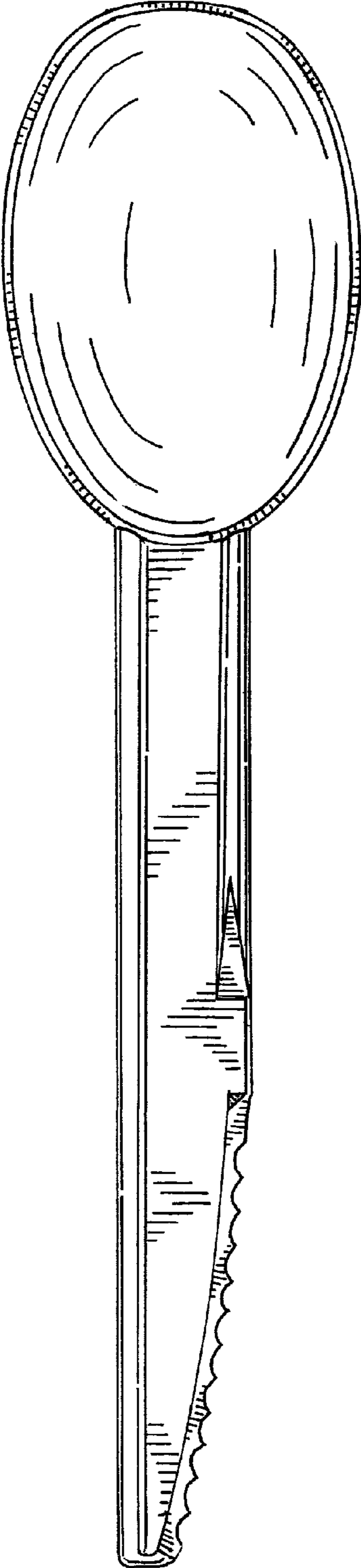

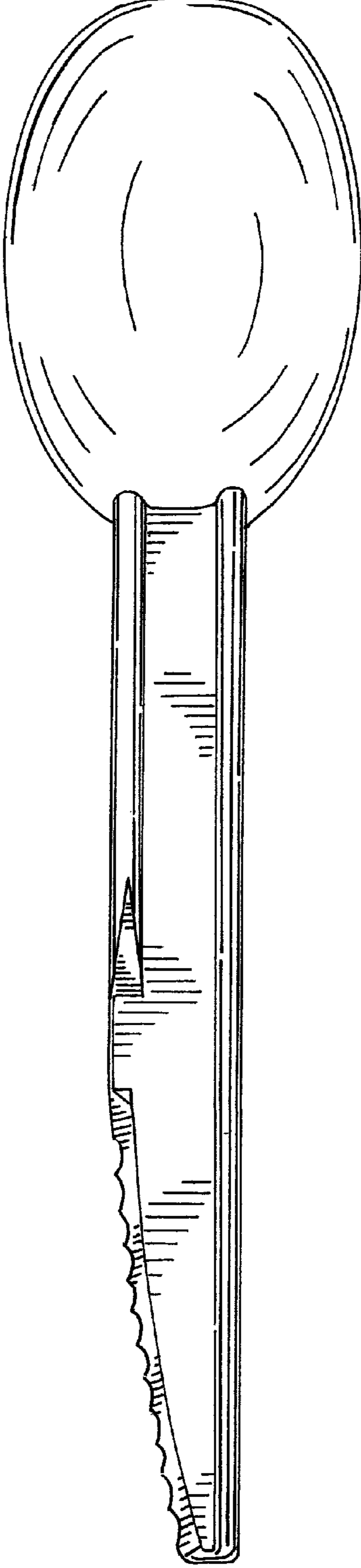

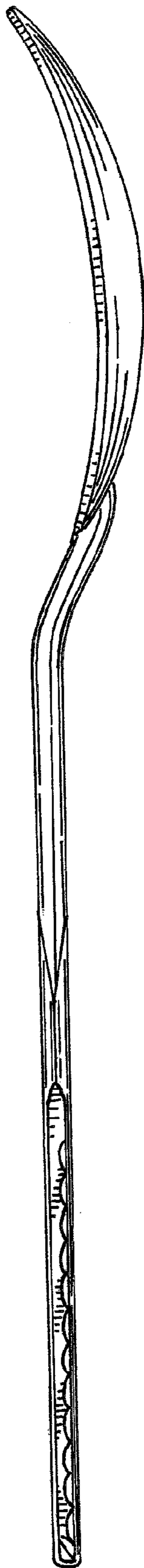

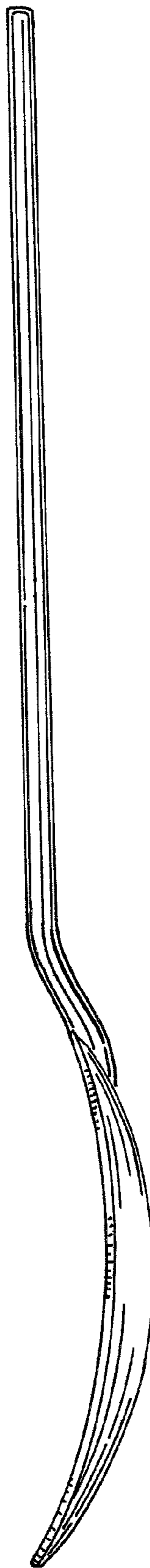

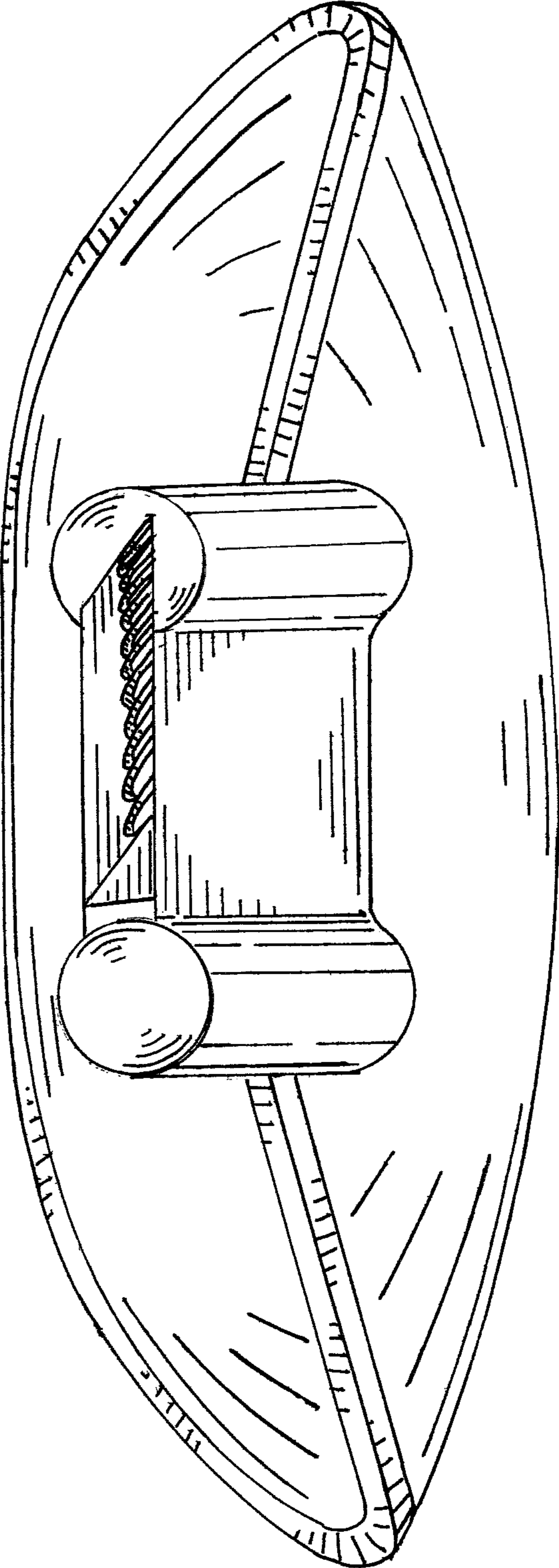

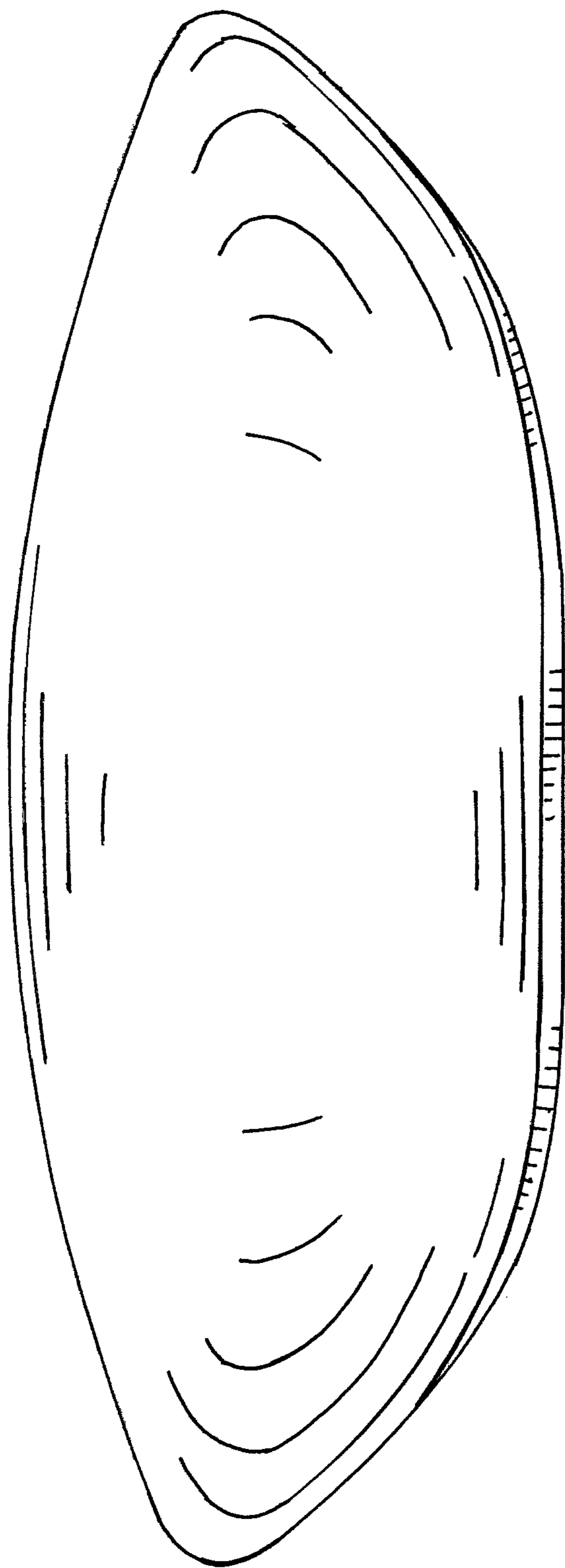
