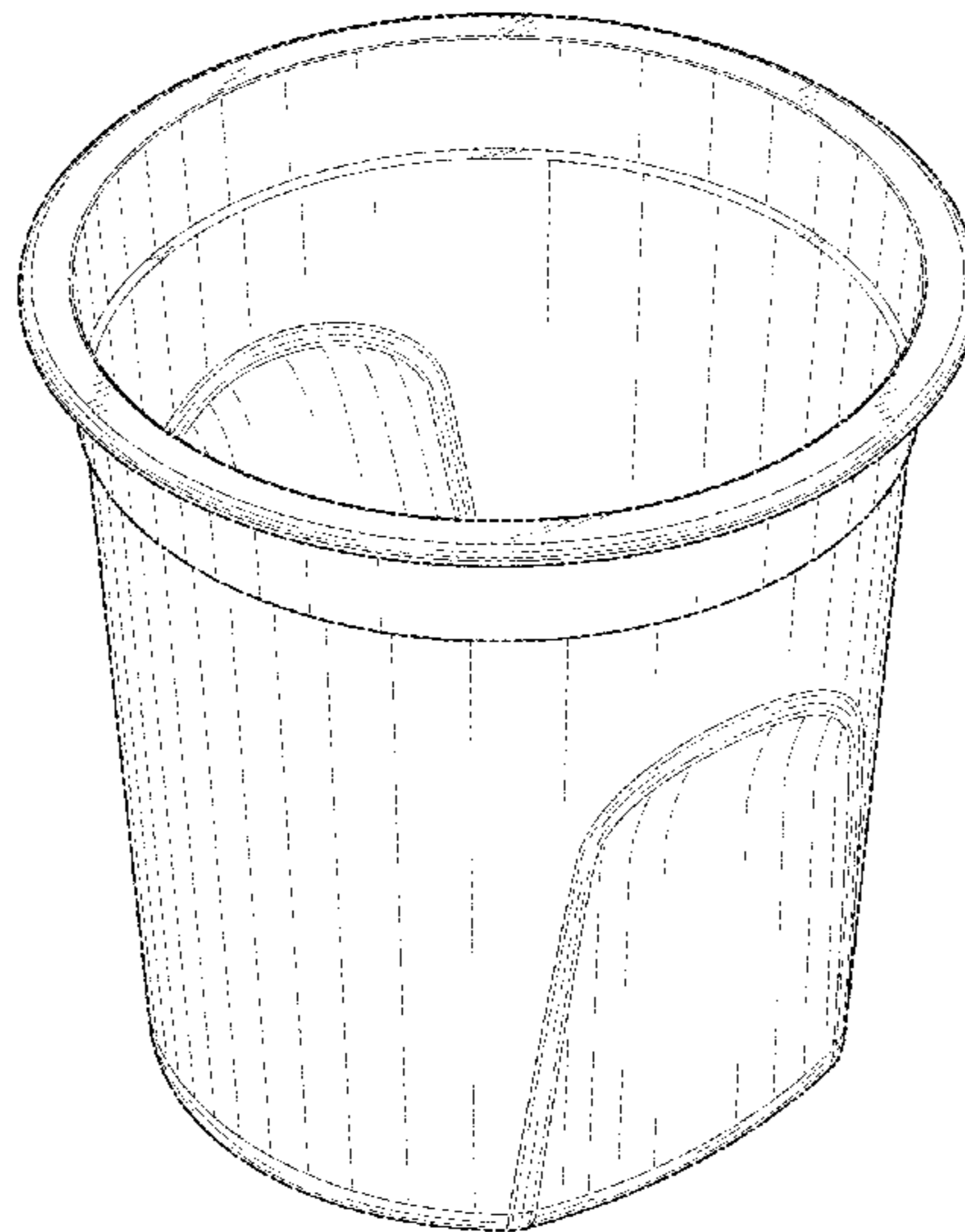

(57) **CLAIM**
 We claim the ornamental design for a tub, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a tub showing the new design;
 FIG. 2 is a front elevation view thereof, the rear elevation being a mirror image;
 FIG. 3 is a left side elevation view thereof, the right side elevation being a mirror image;
 FIG. 4 is a top view thereof; and,
 FIG. 5 is a bottom view thereof.
 The broken lines and the area within the broken line in FIG. 5 depict environmental subject matter that forms no part of the claimed design.

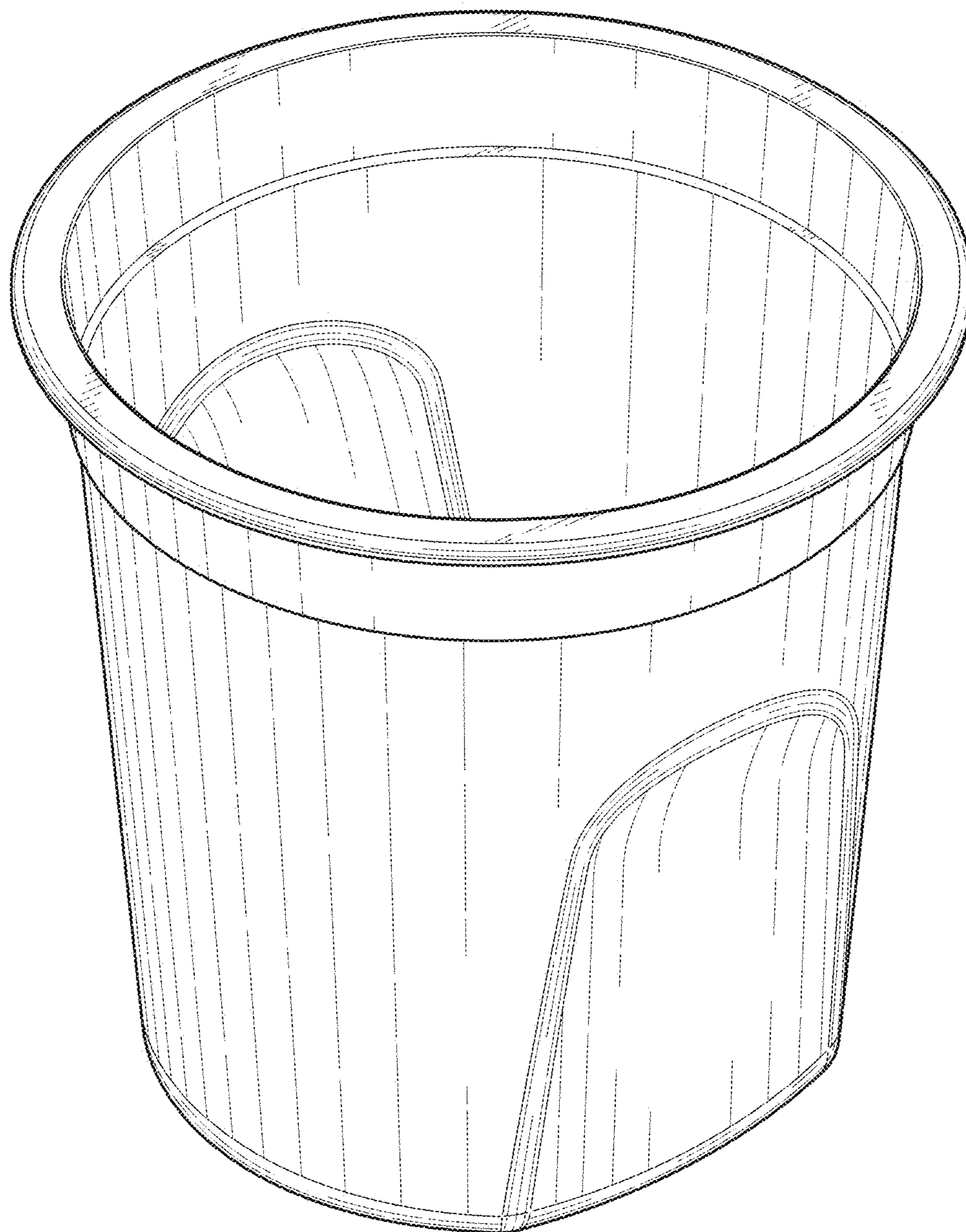

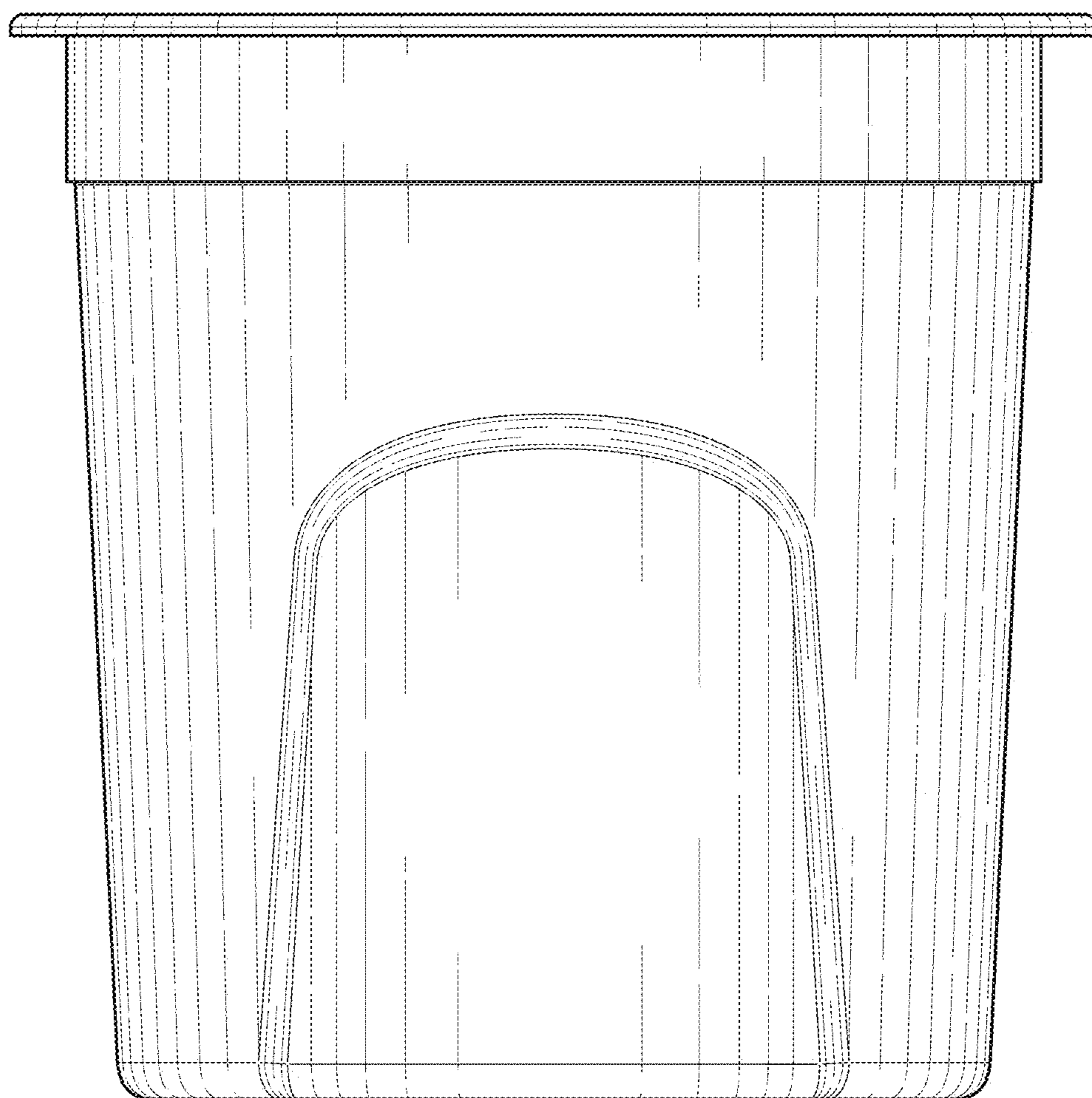

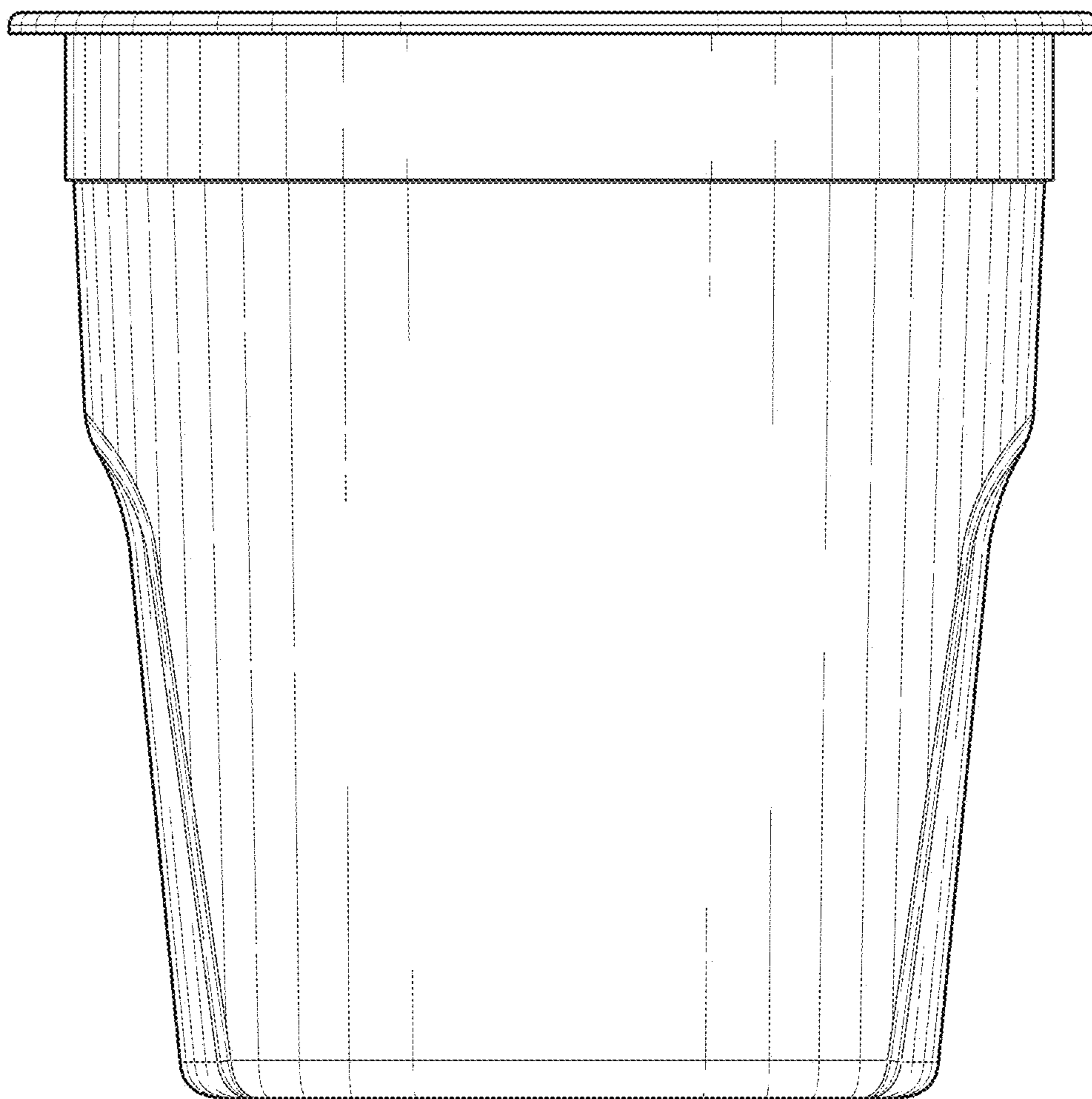

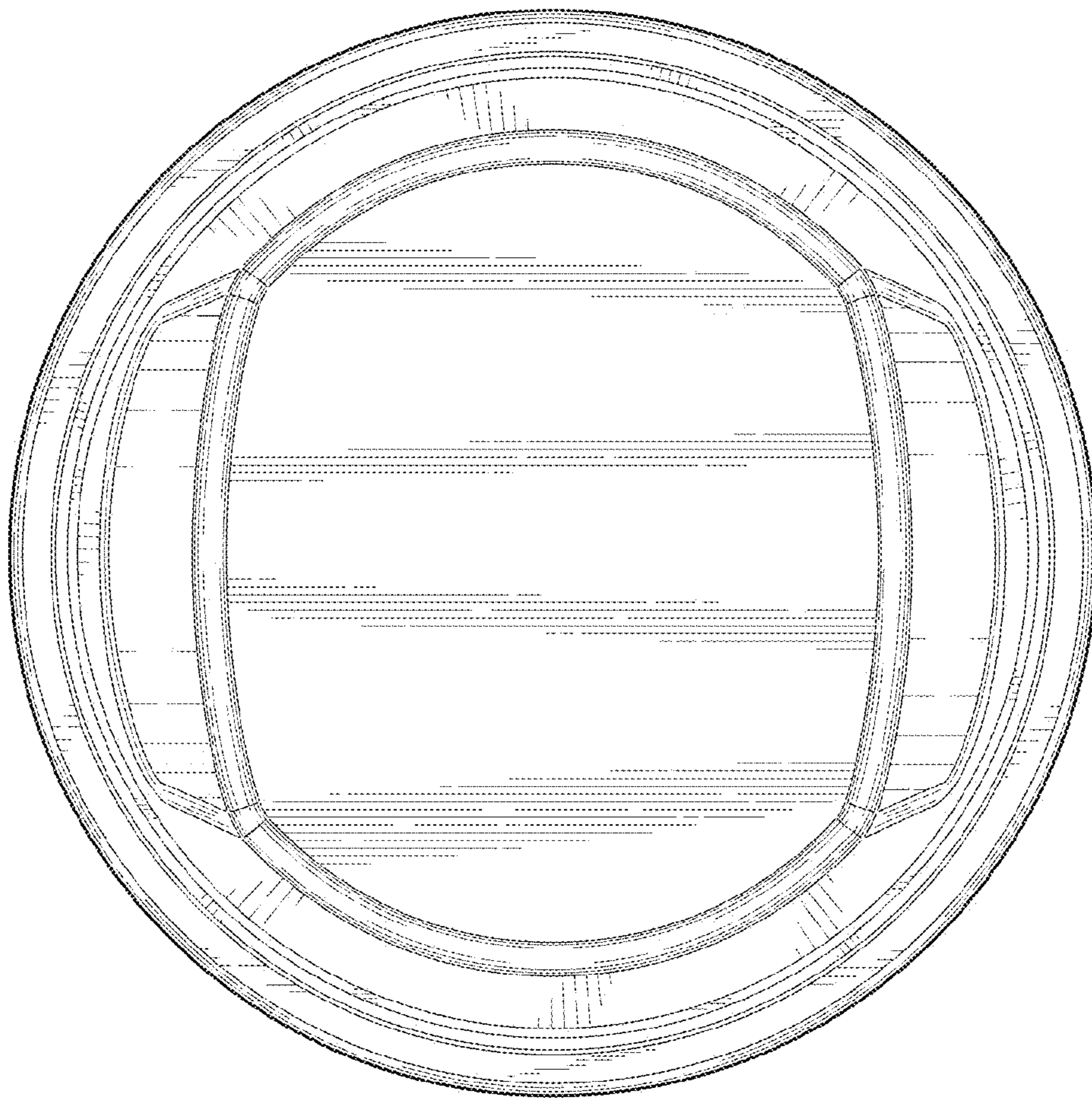

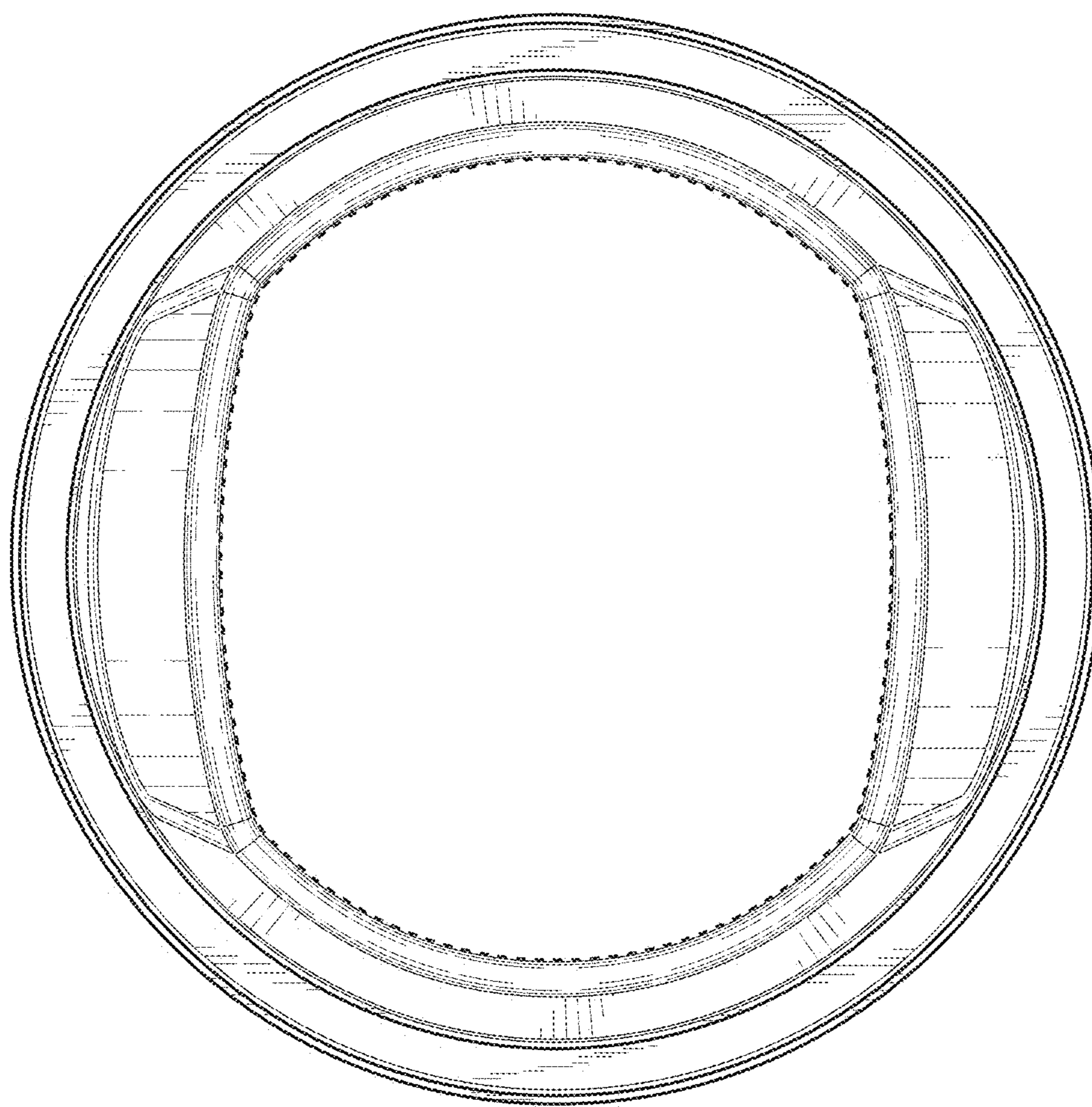
