FIG. 4 is a front view of the bottle of FIG. 1;

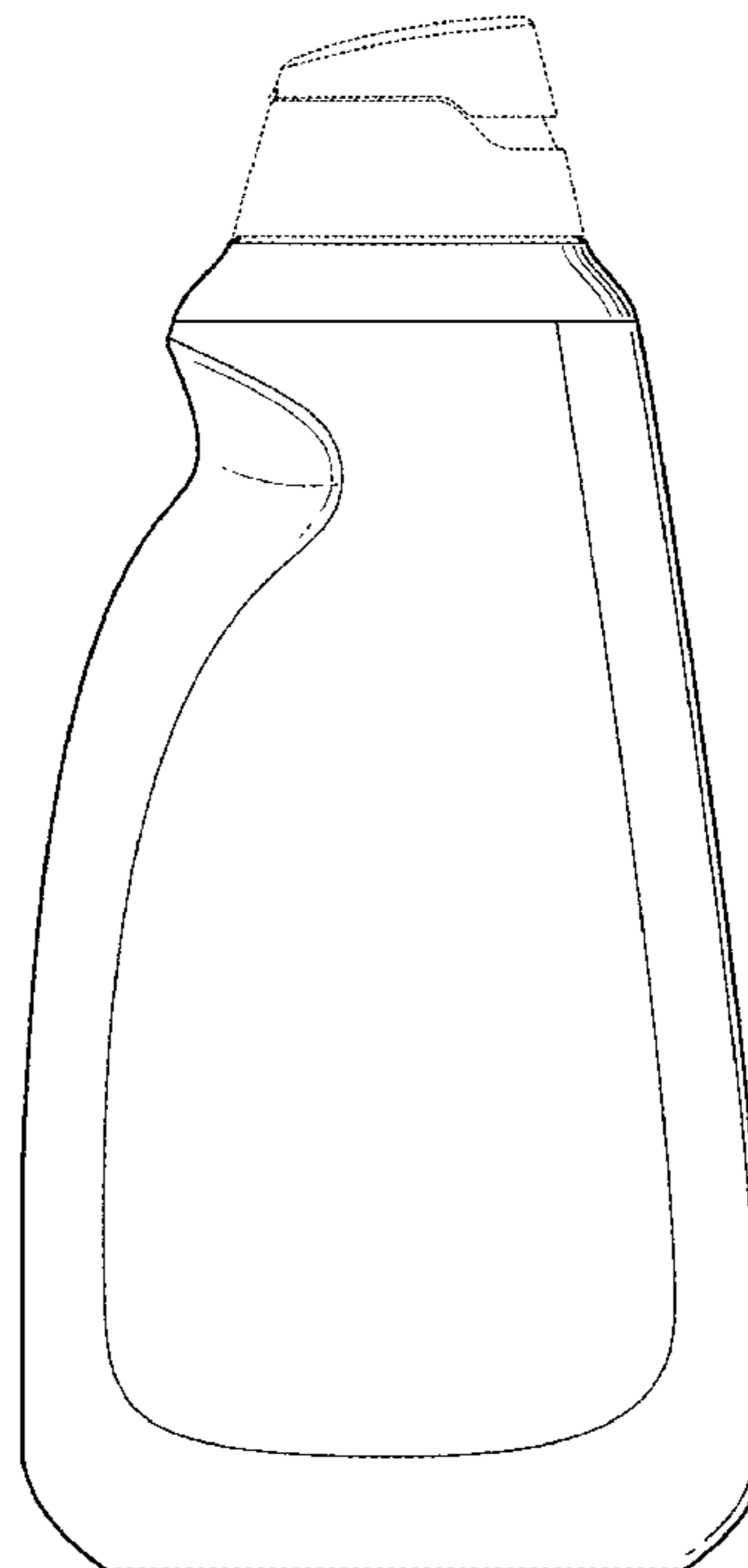
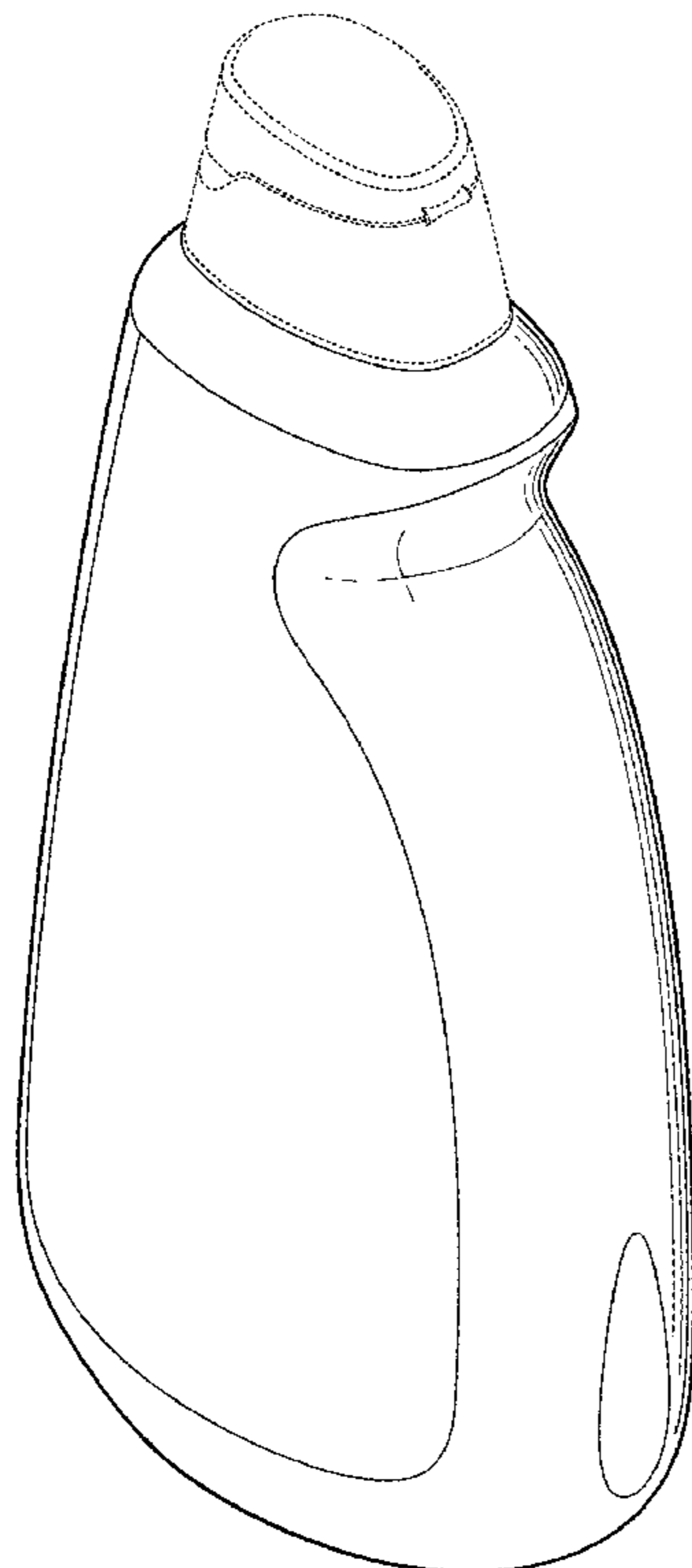
FIG. 5 is a back view of the bottle of FIG. 1;

FIG. 7 is a bottom plan view of the bottle of FIG. 1.

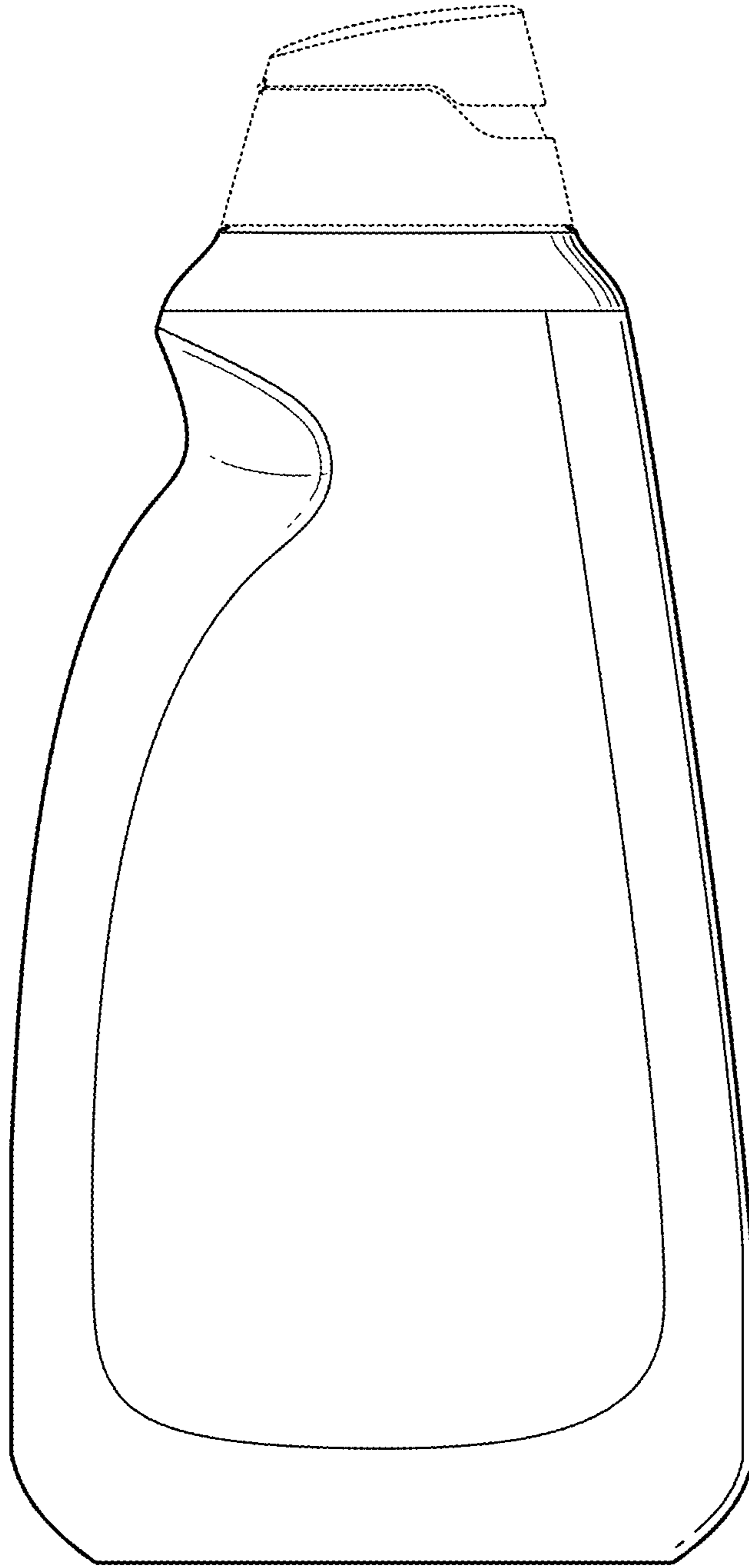

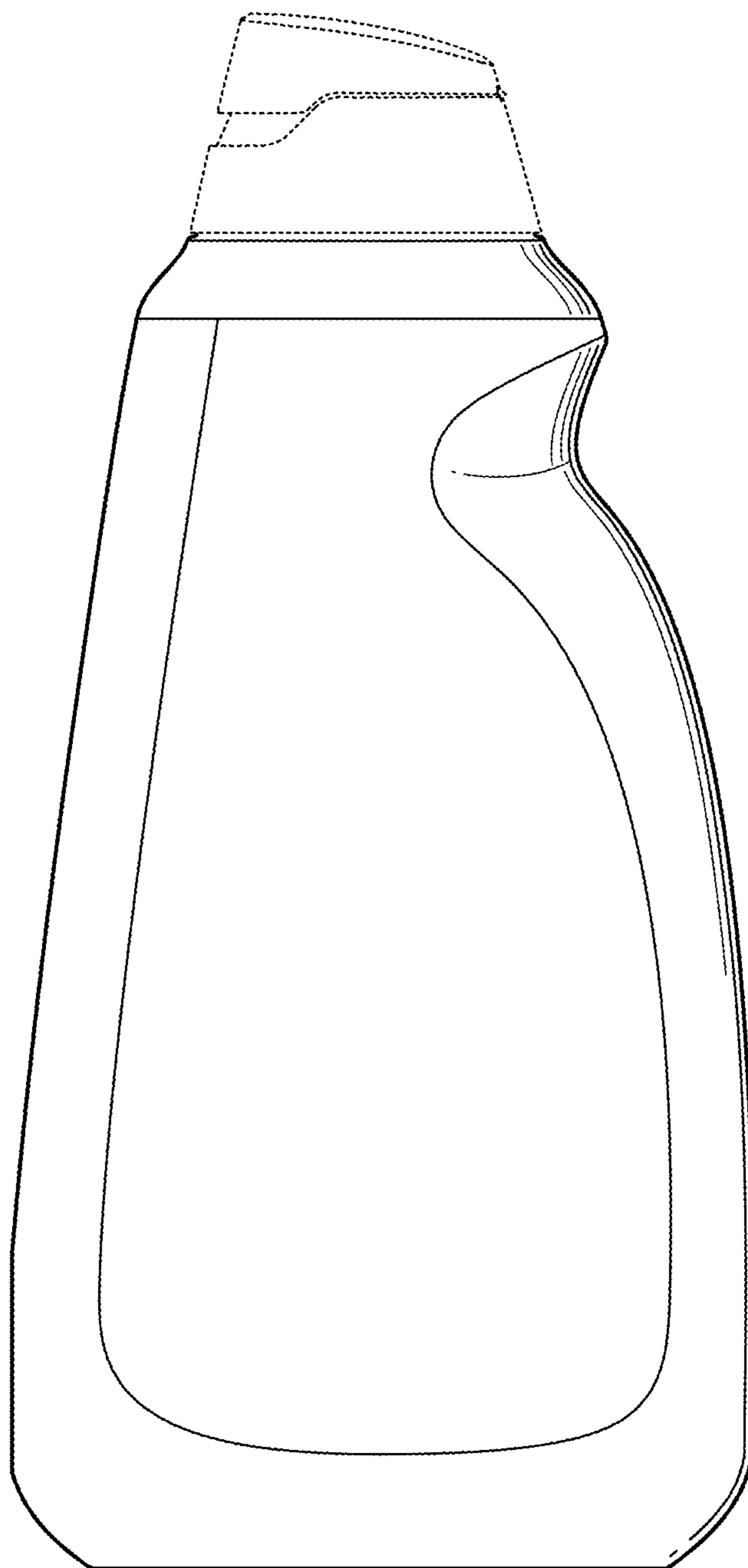




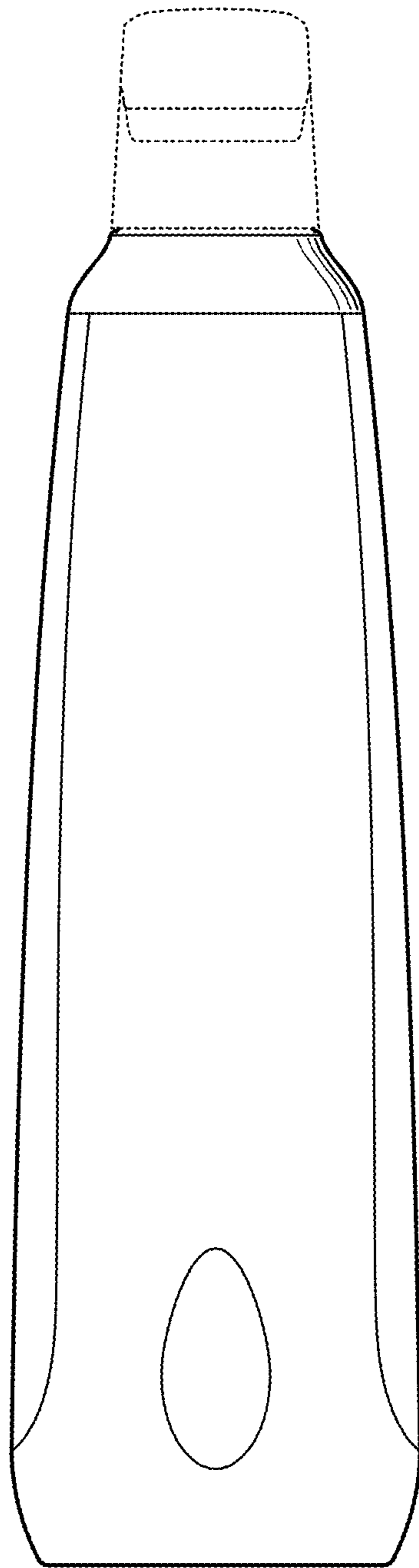

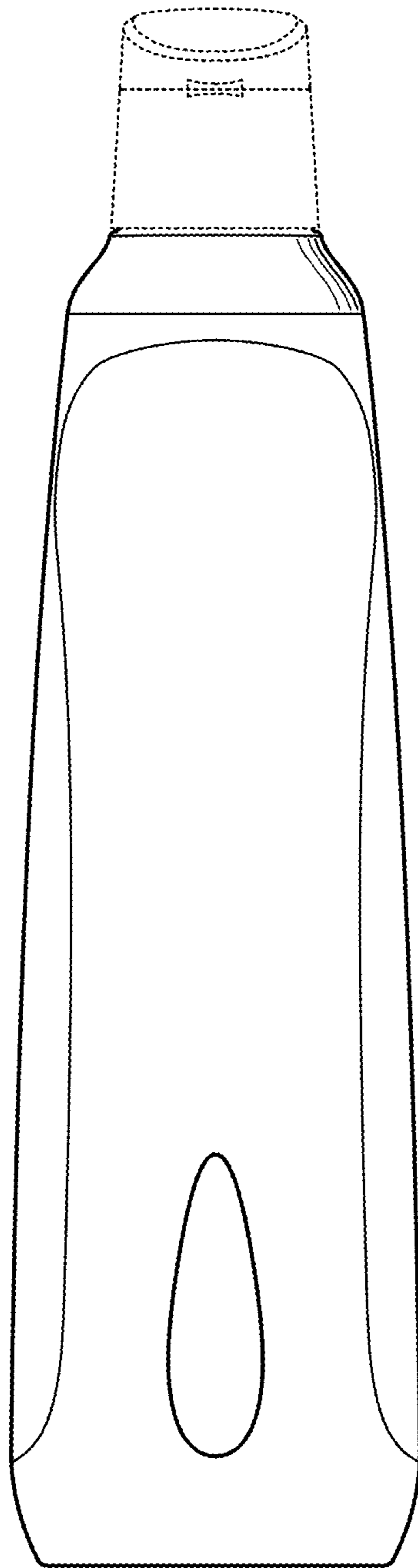

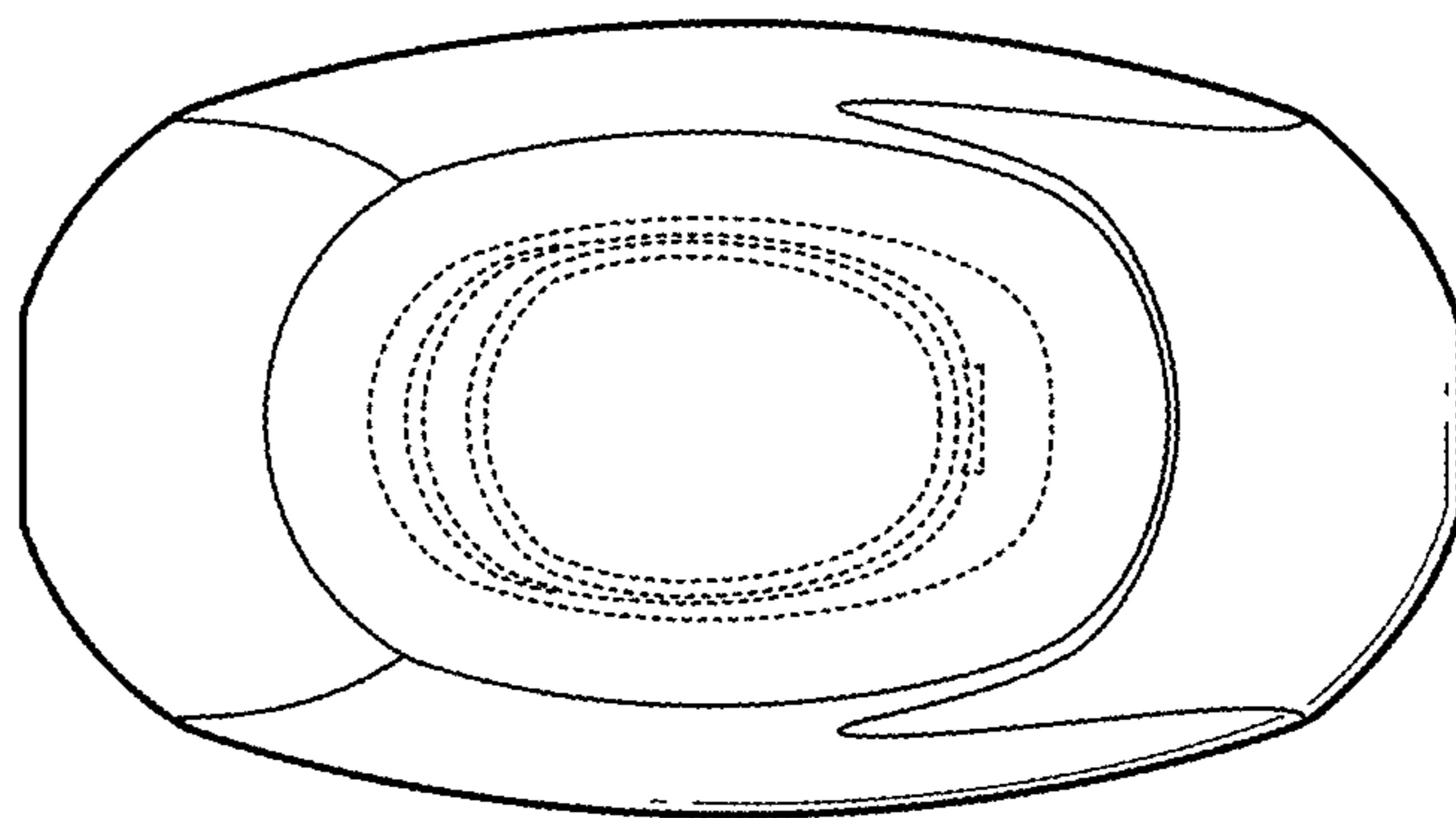

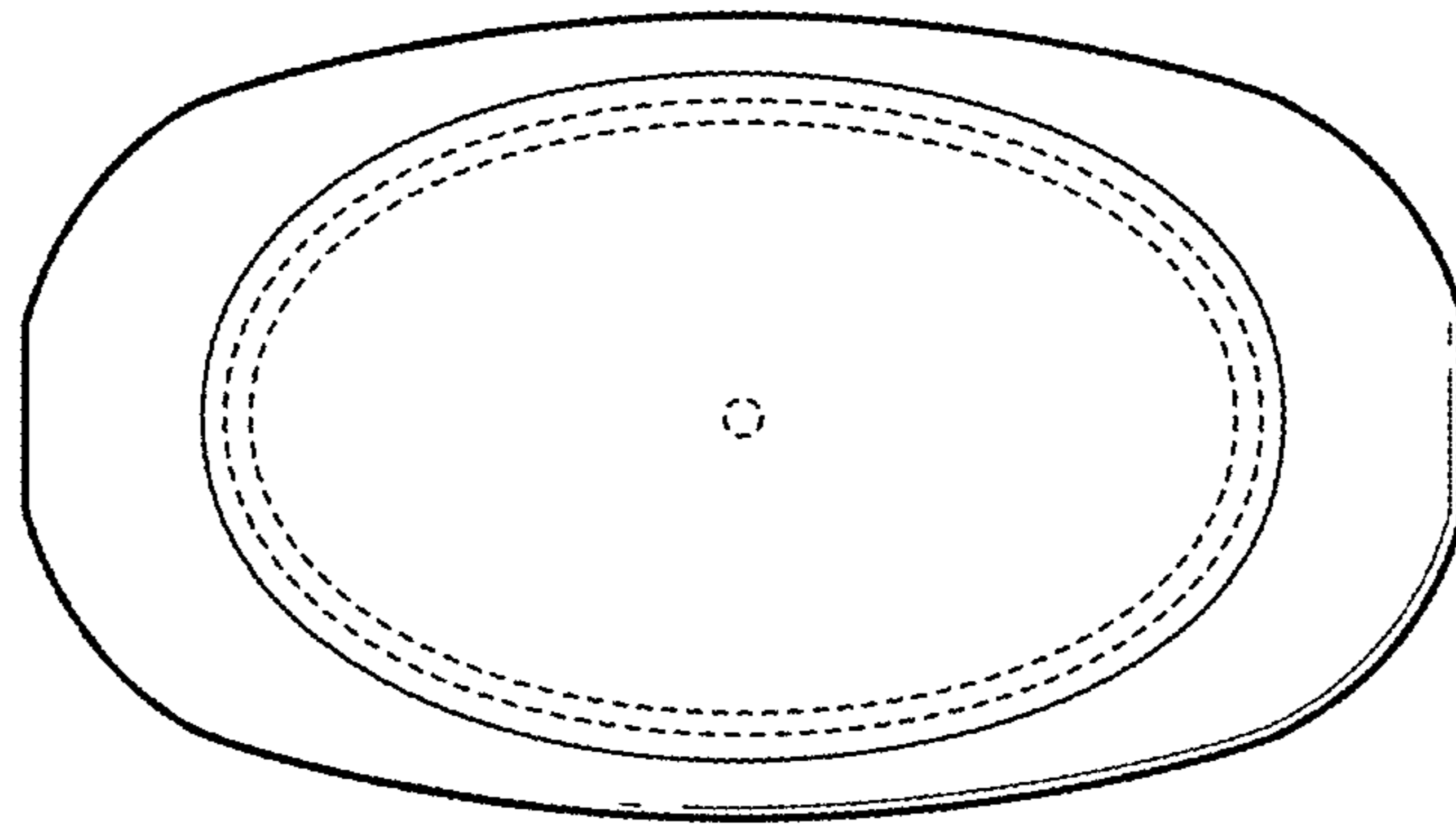
