**DESCRIPTION**

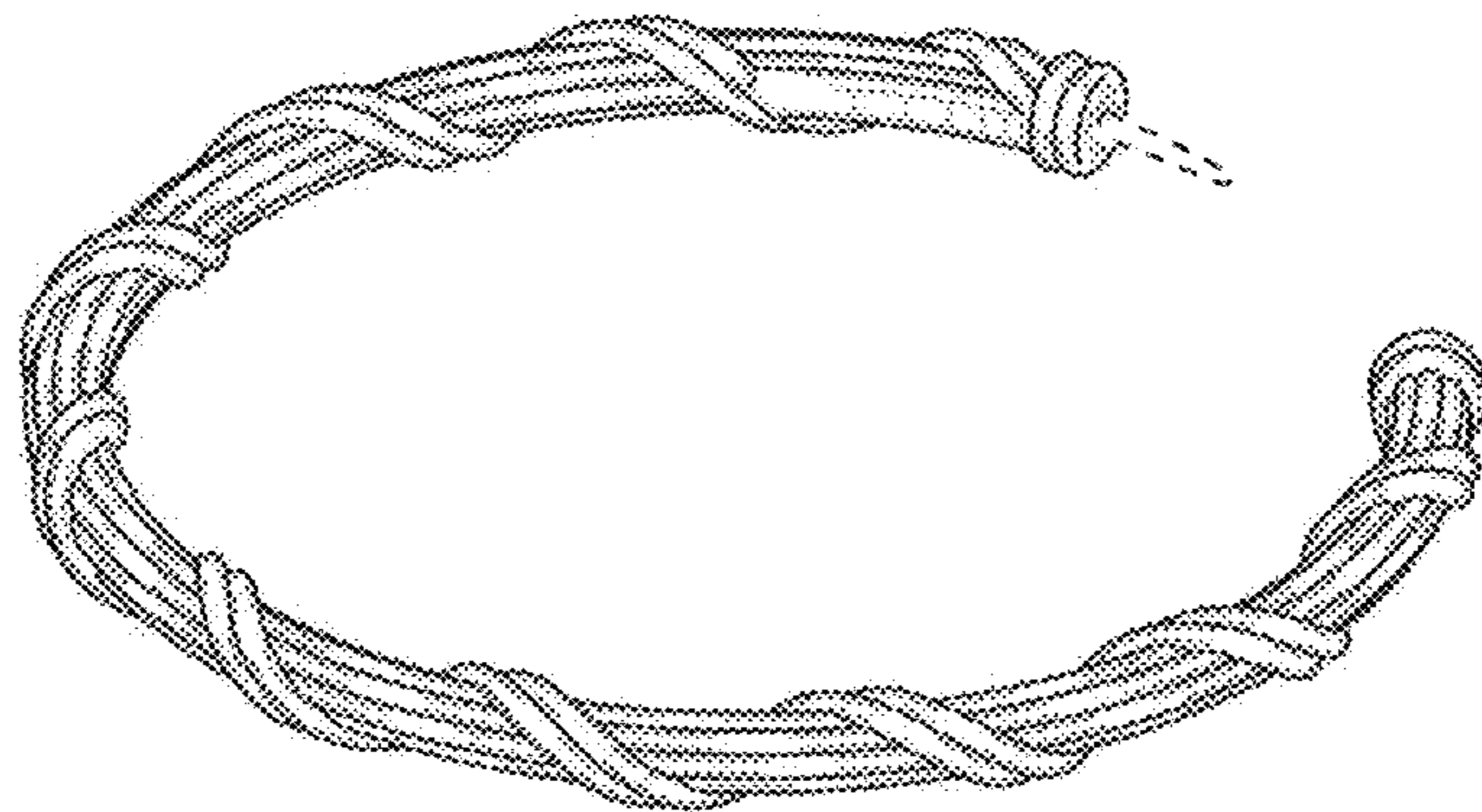
FIG. 1 is a front and right side perspective view of a hoop earring, in accordance with the invention;

FIG. 6 is a left elevational view thereof; and,

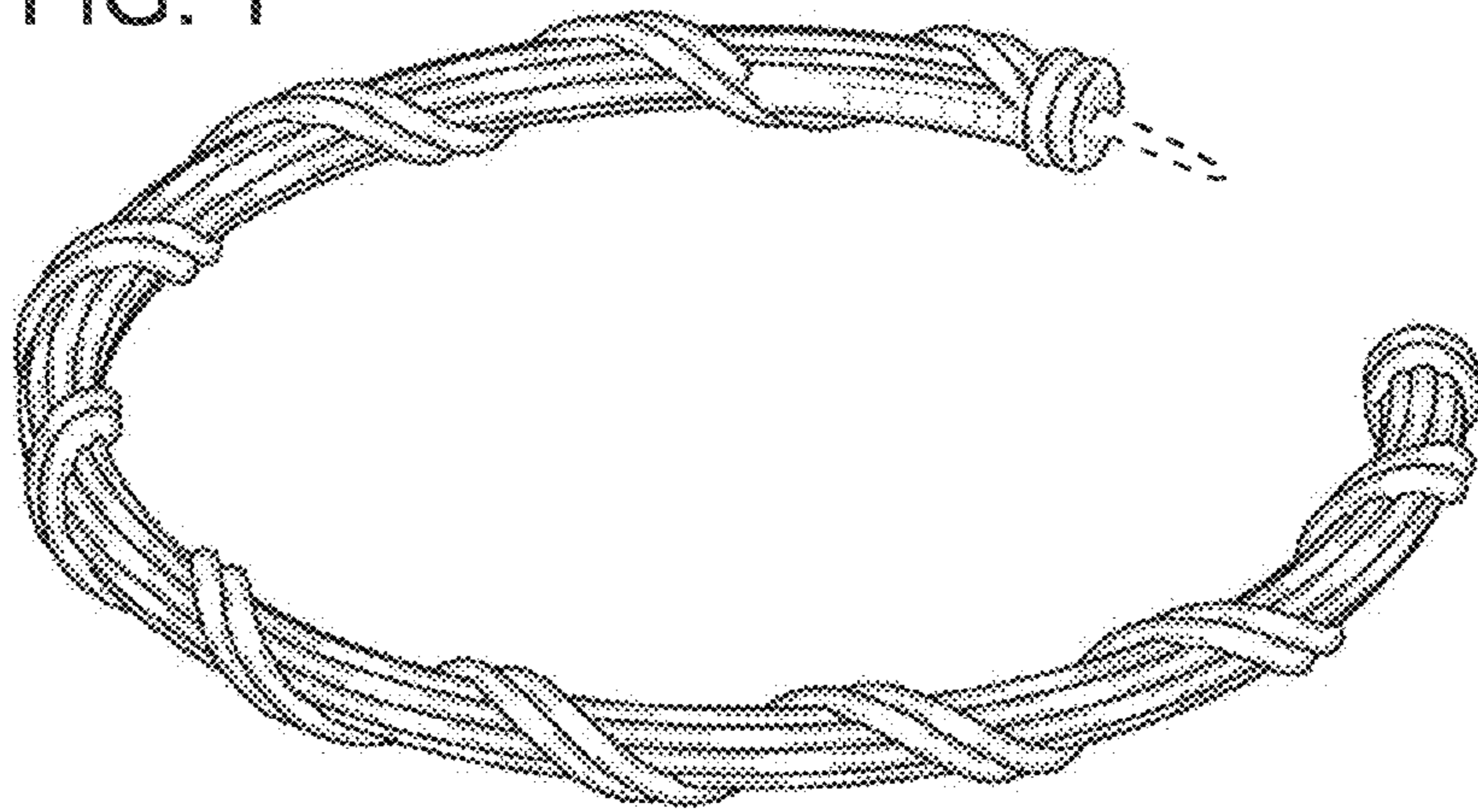
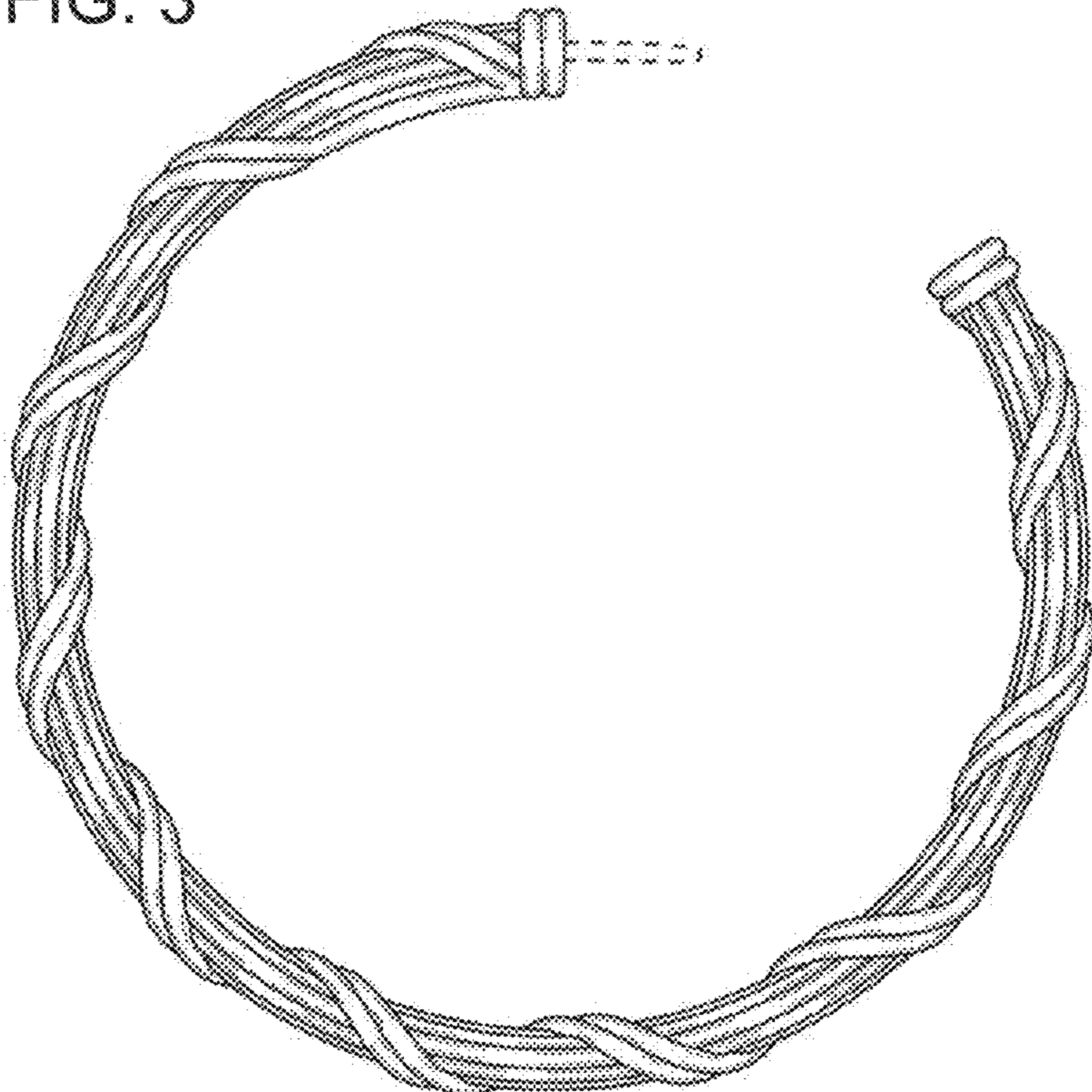

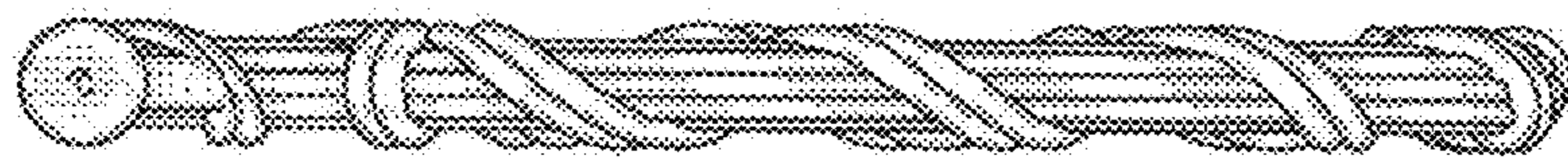

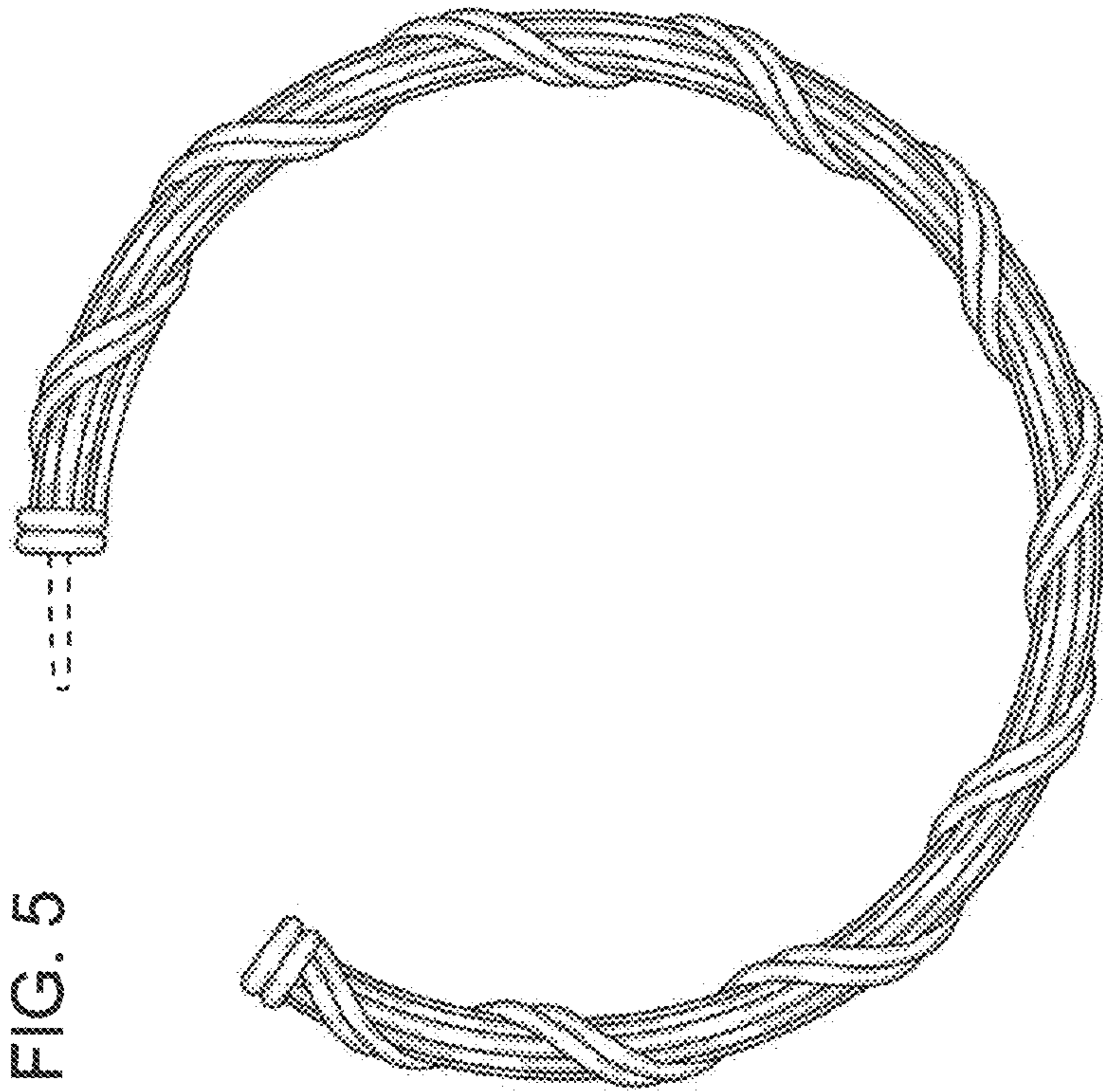

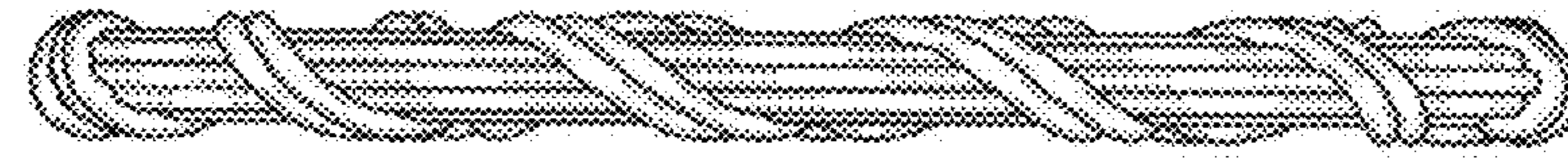
