**DESCRIPTION**

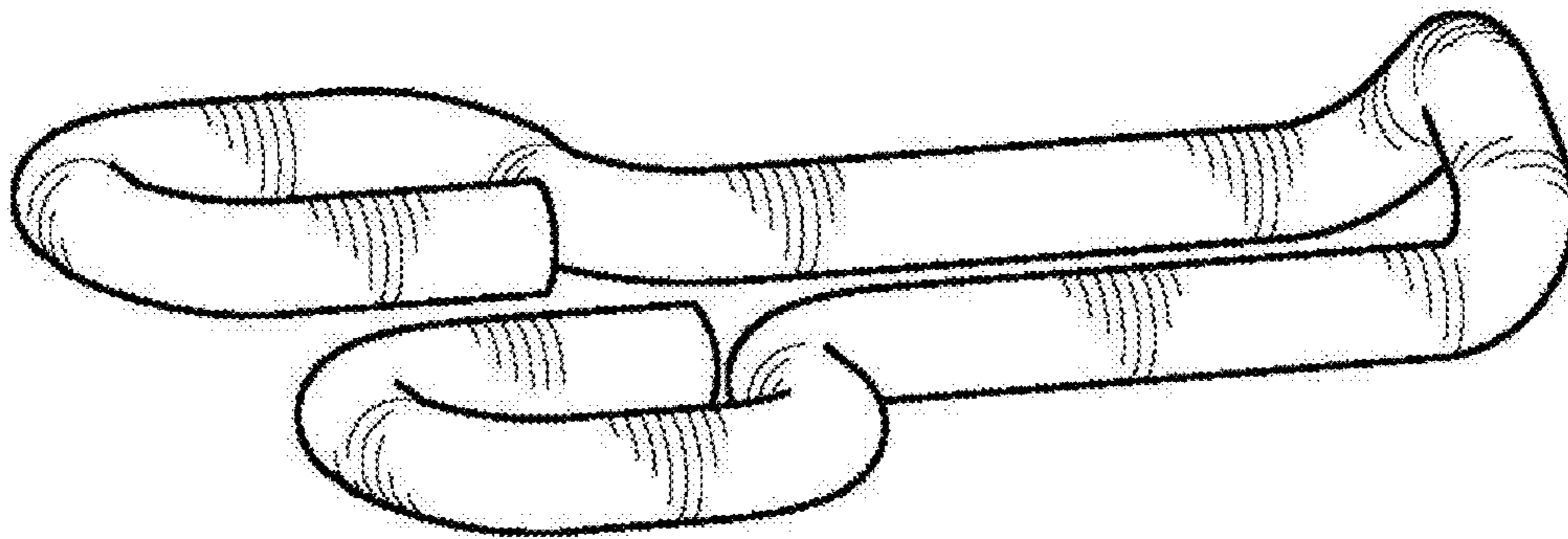
FIG. 1 is a front perspective view of an eyelet for fastening showing my new design;

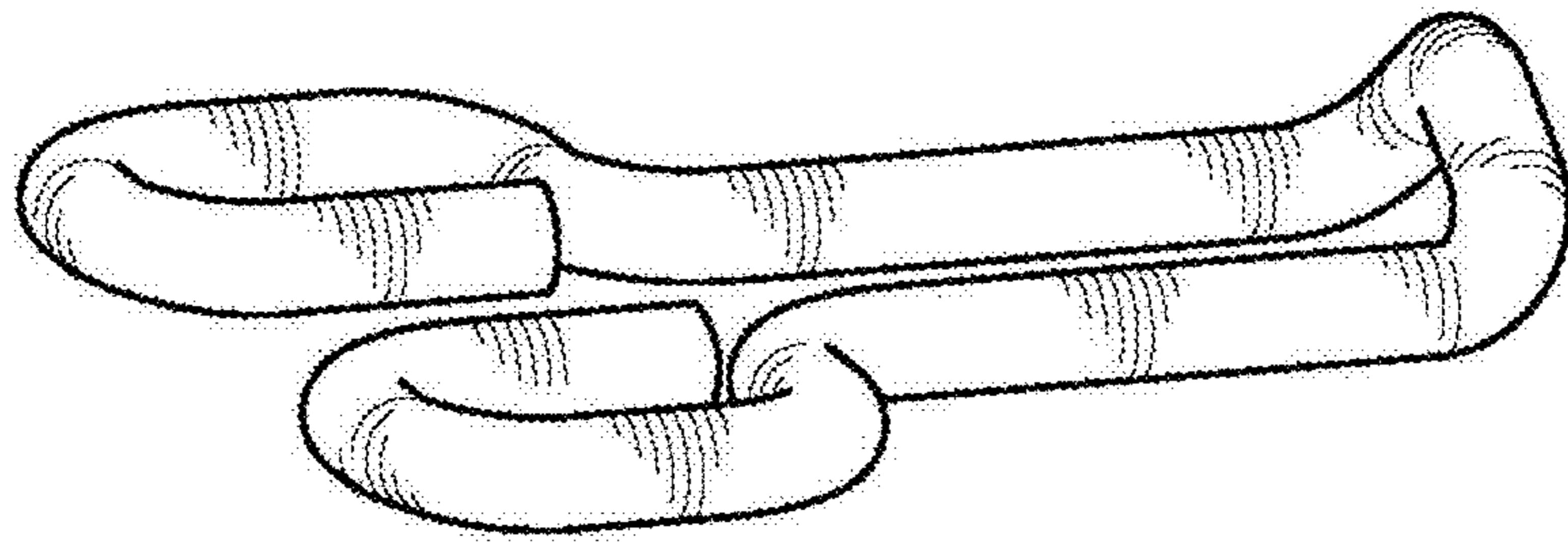

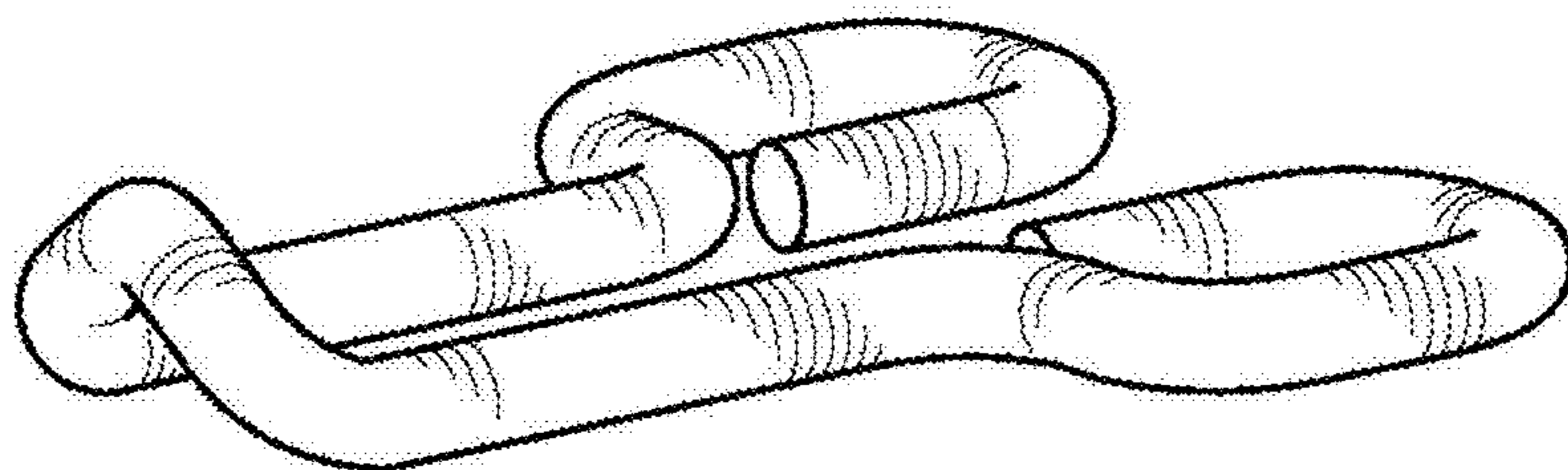

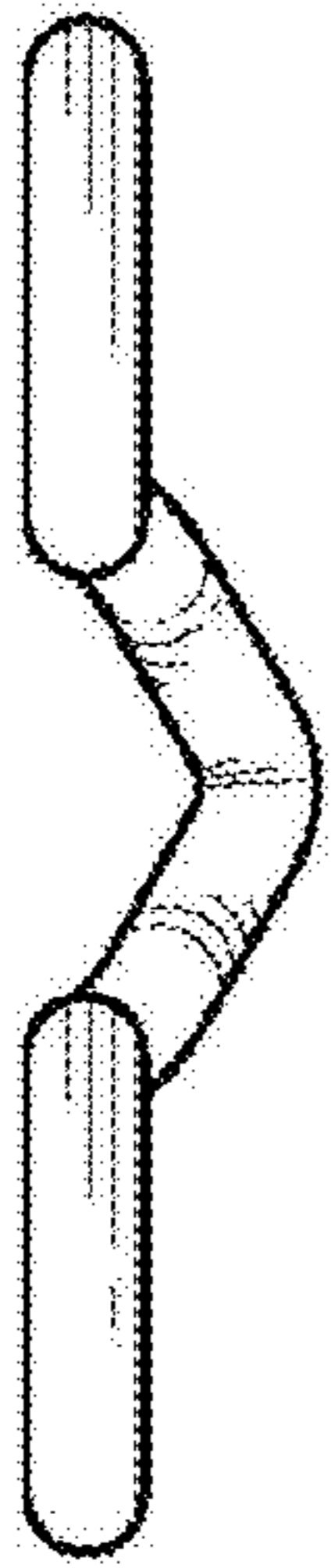

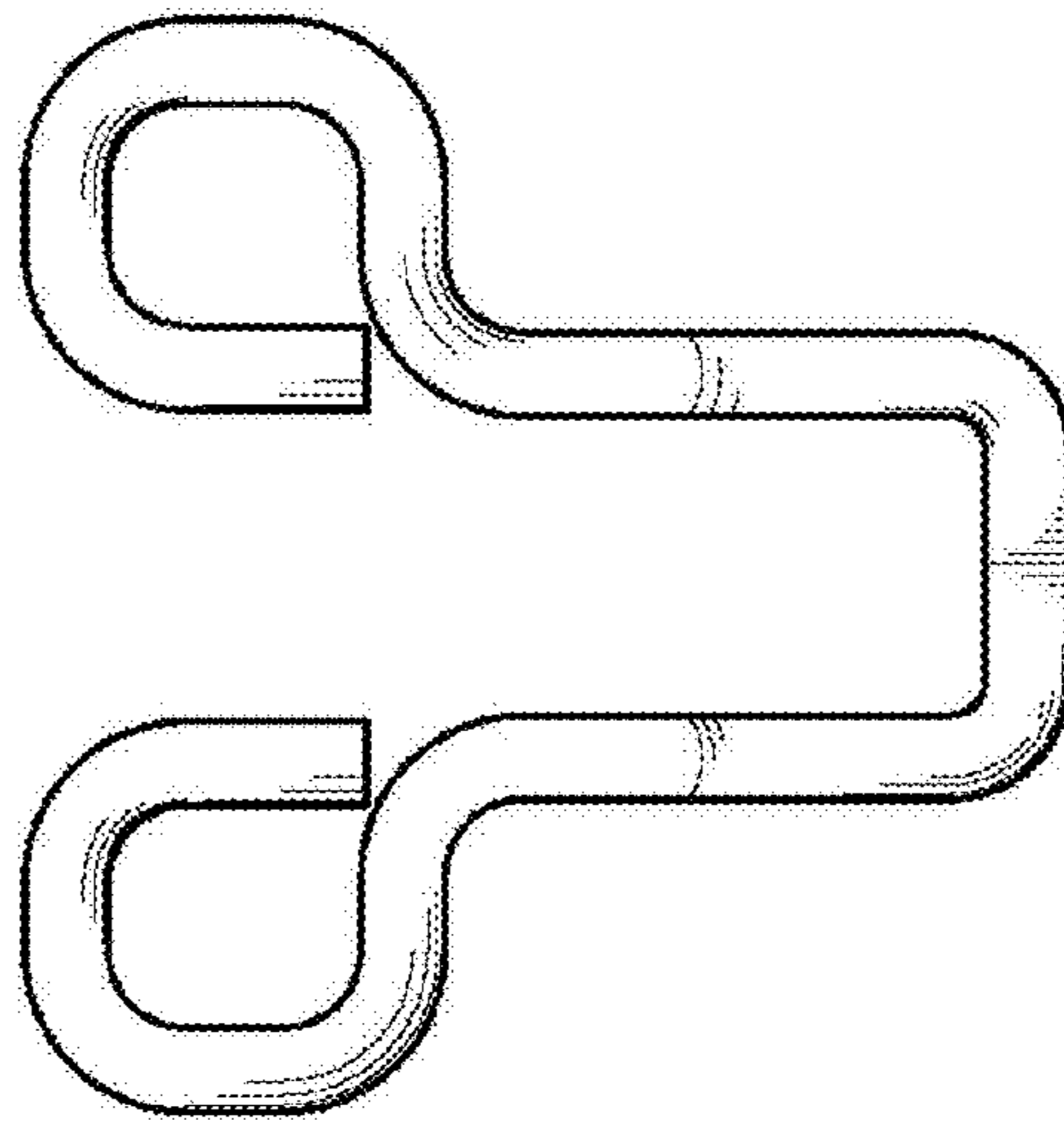

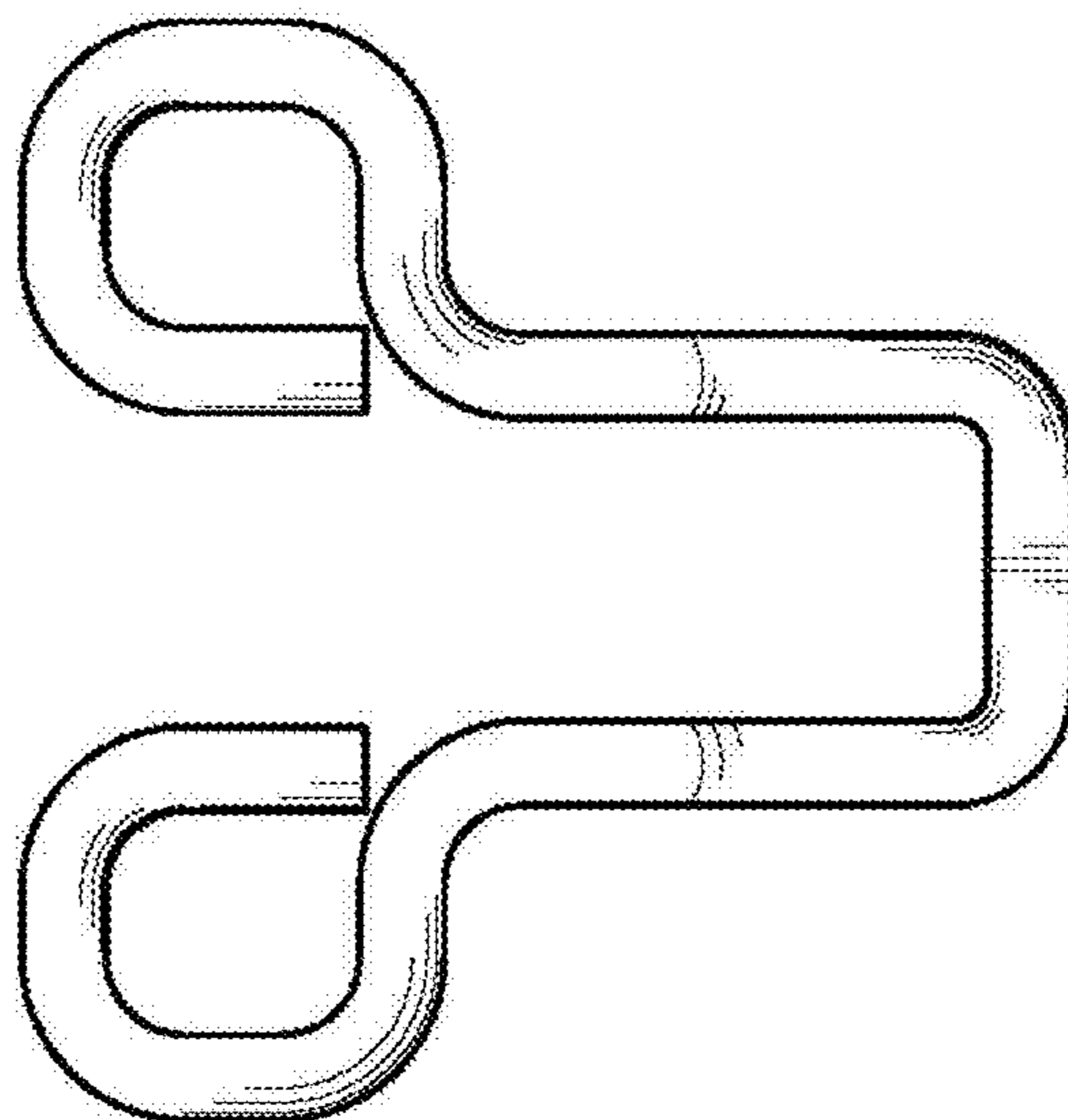

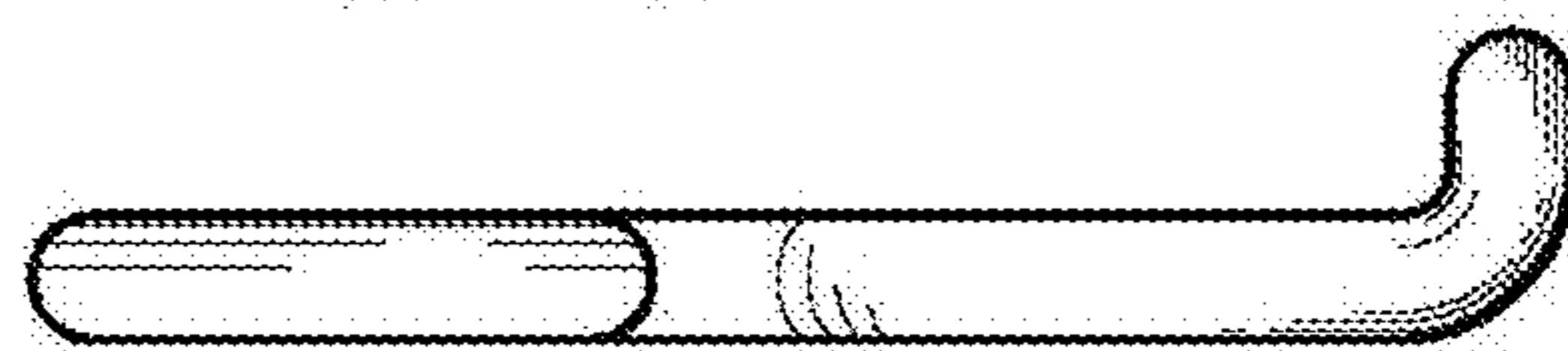

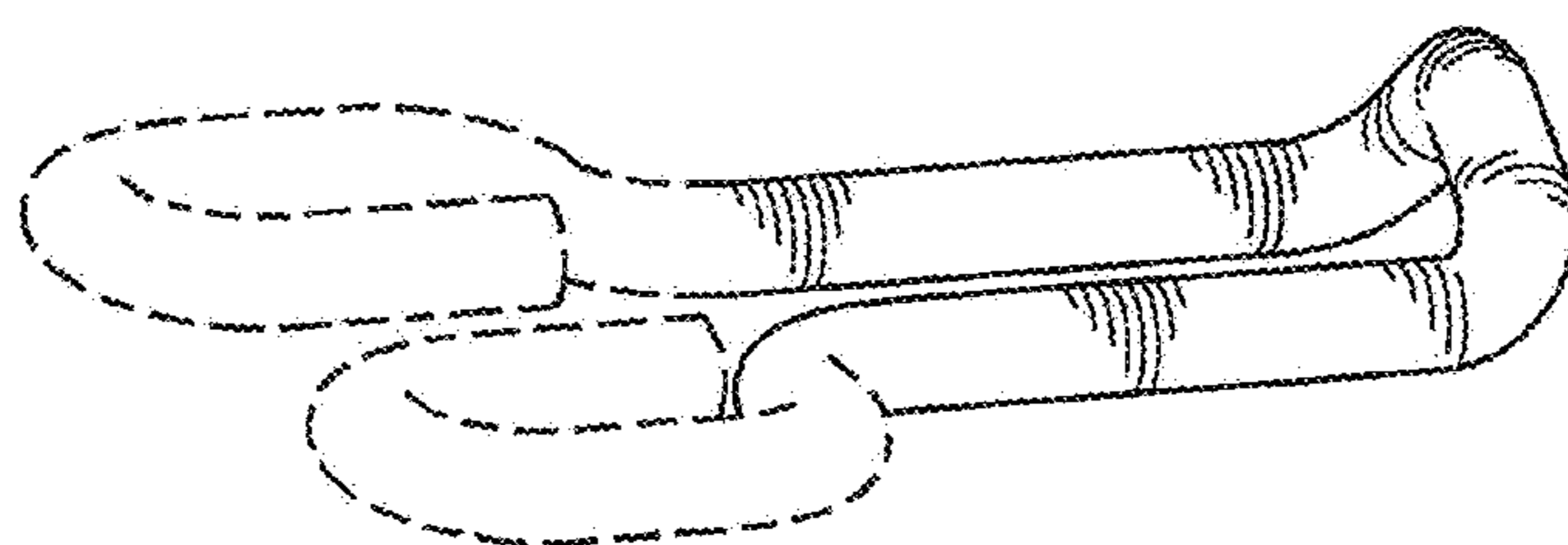

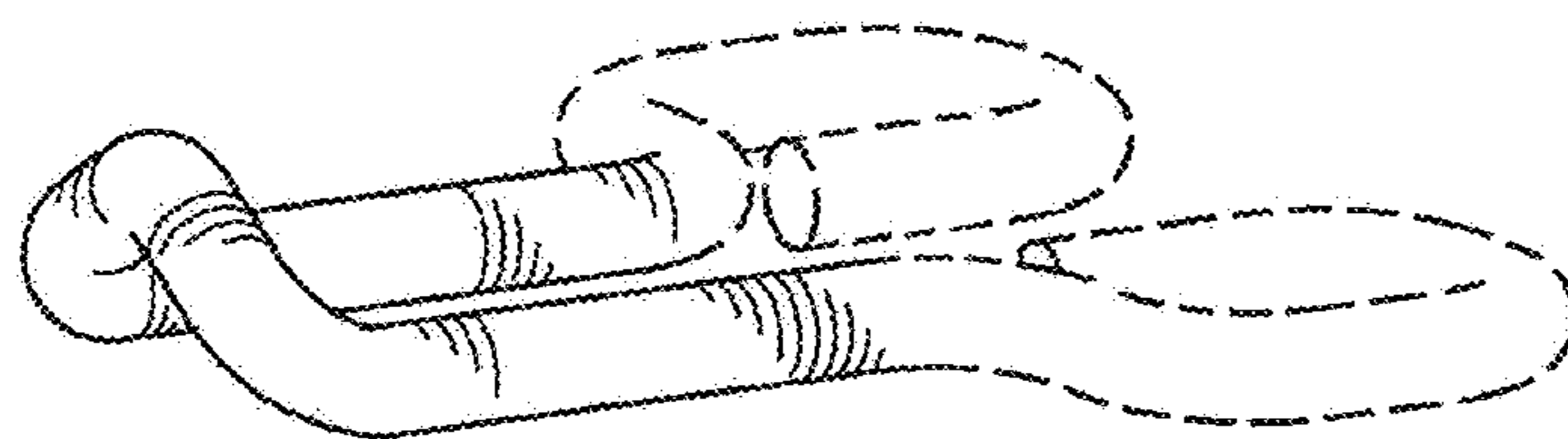

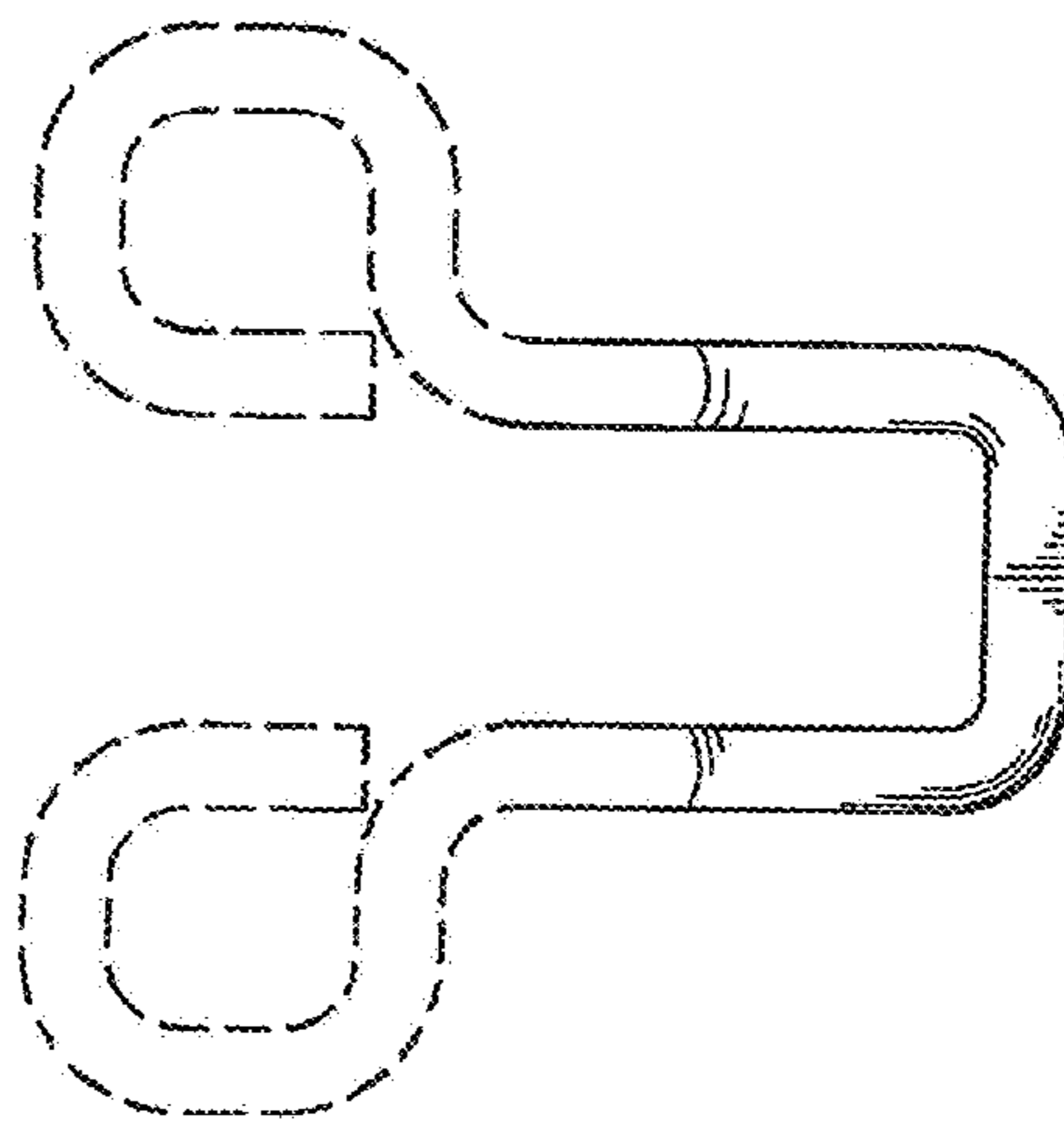

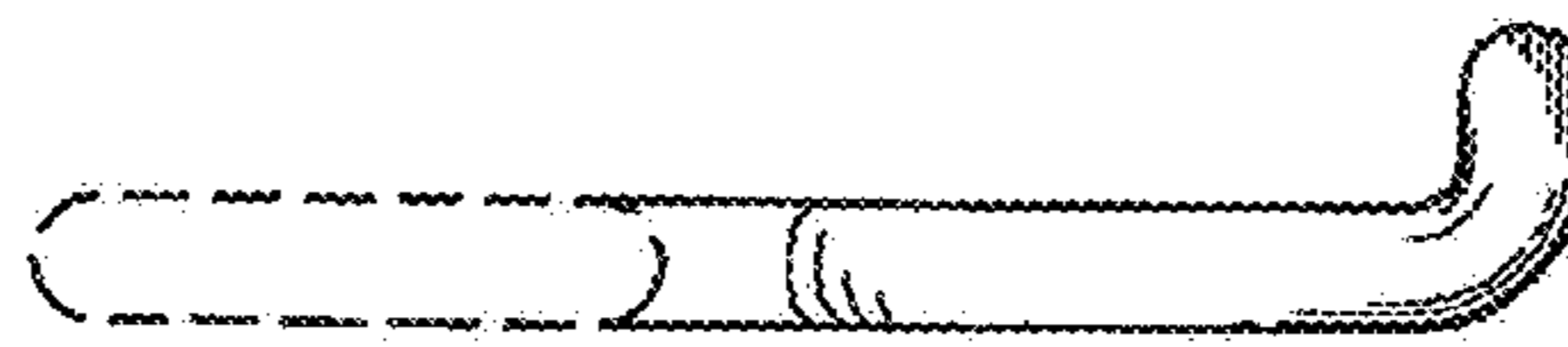

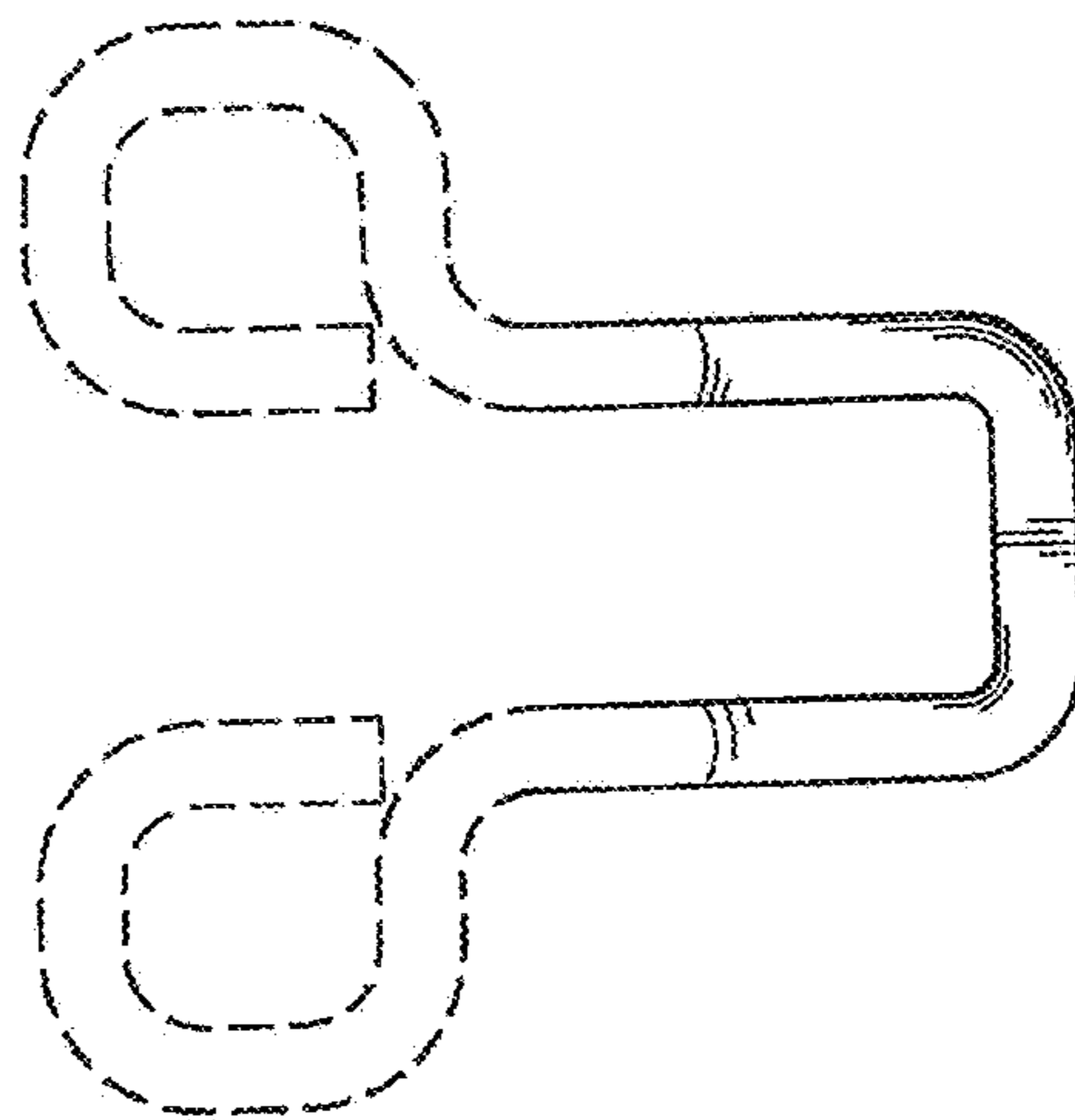

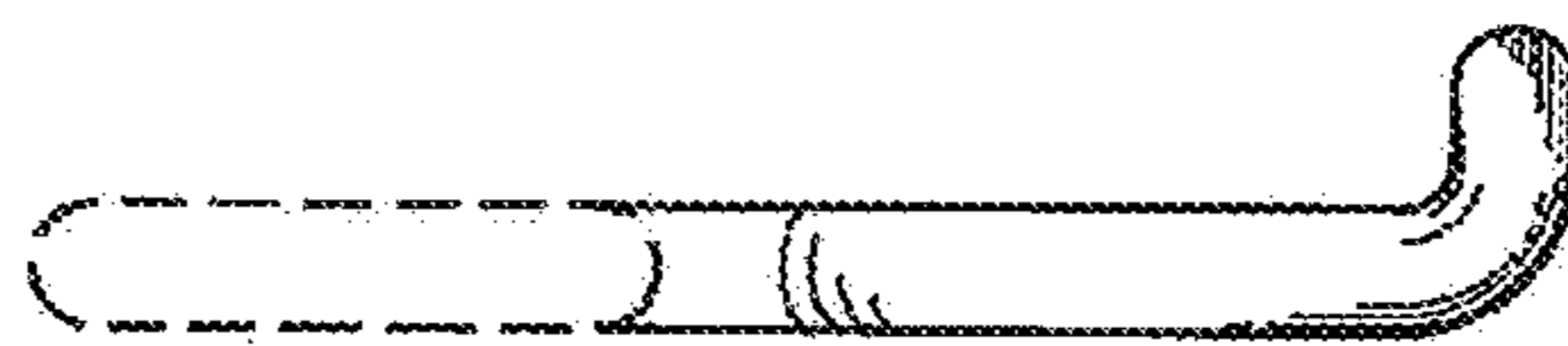
