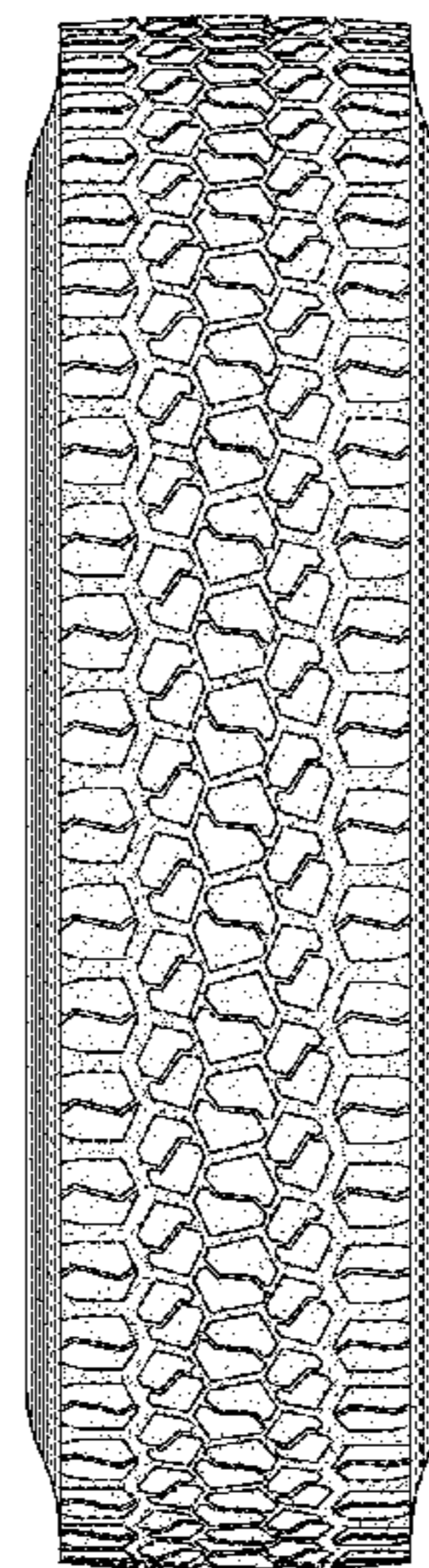
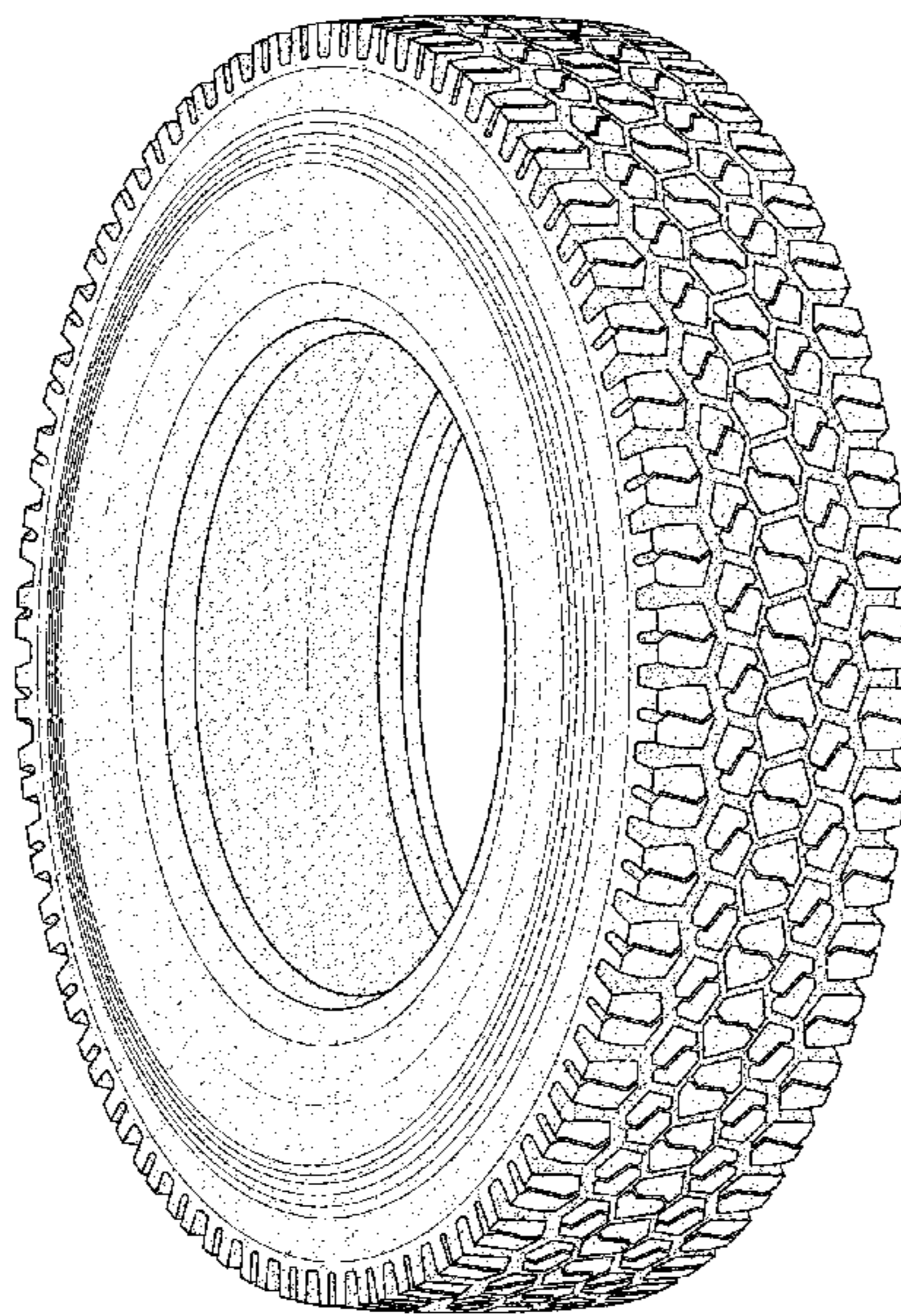
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, left perspective view of a tire for automobile showing my new design;

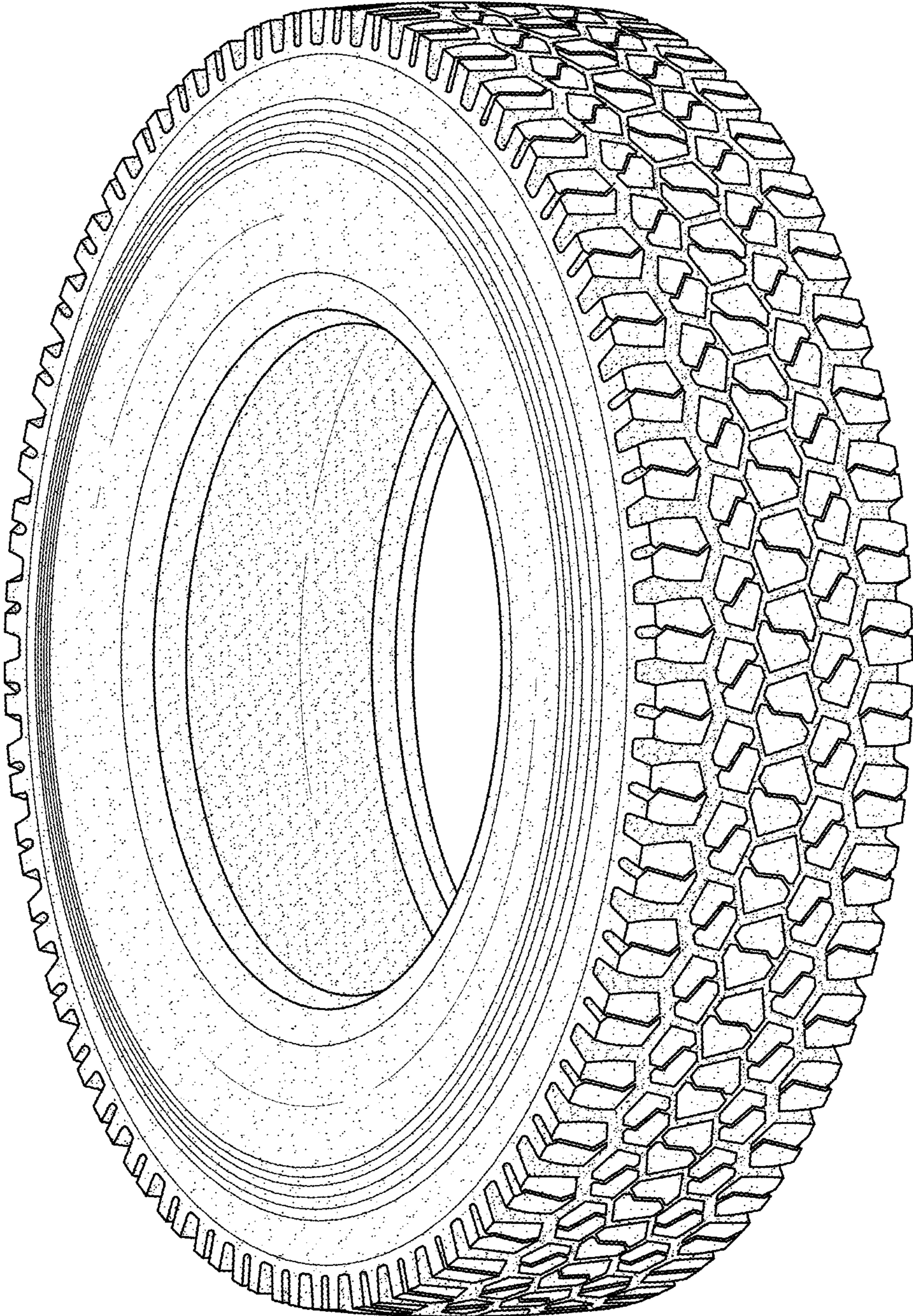

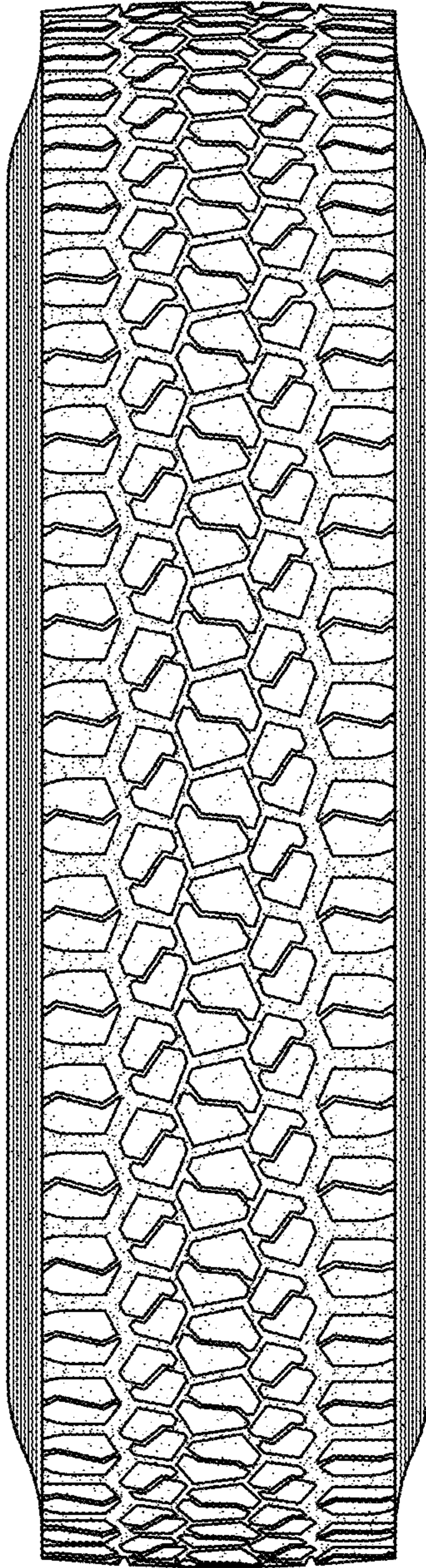

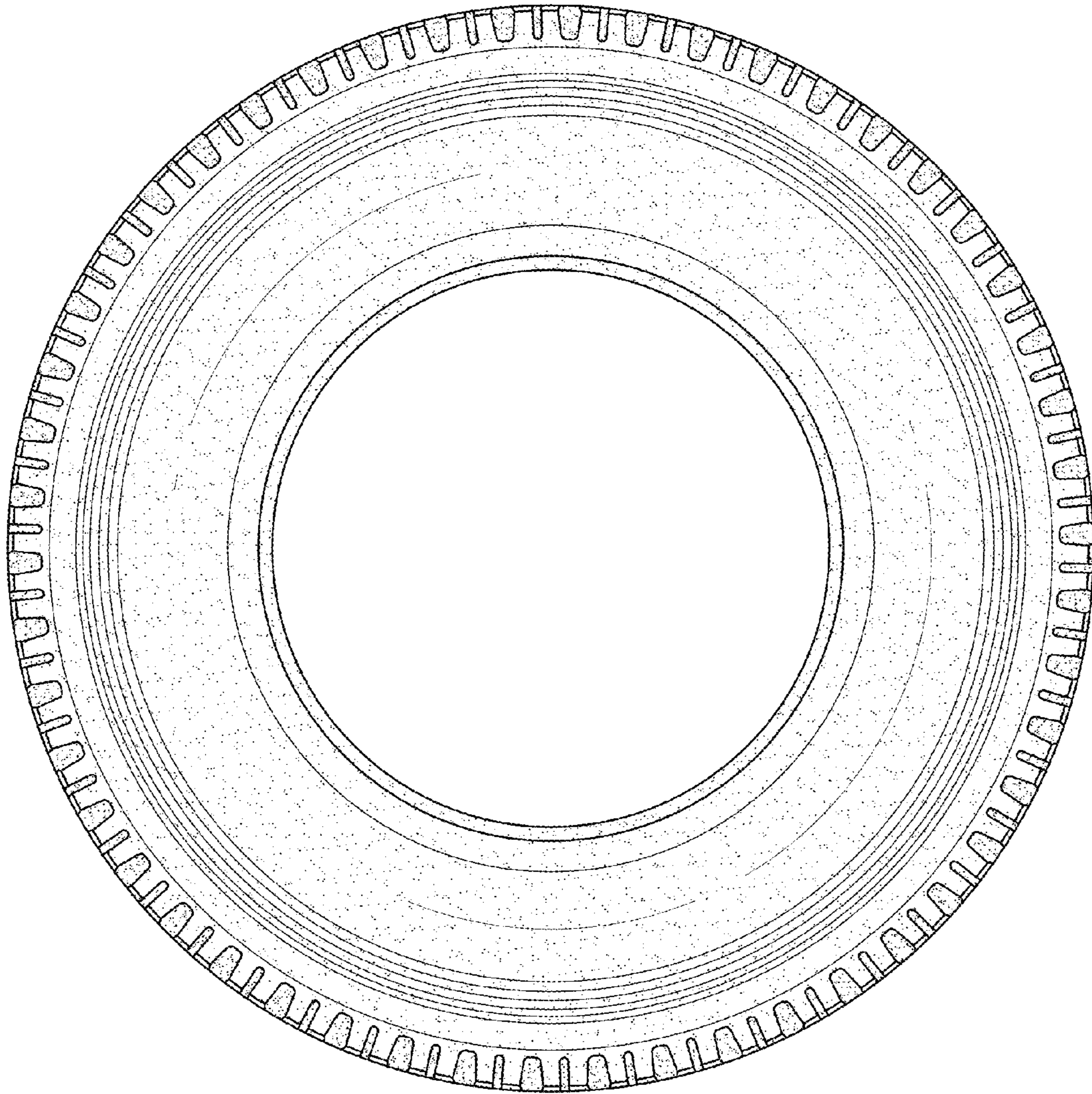

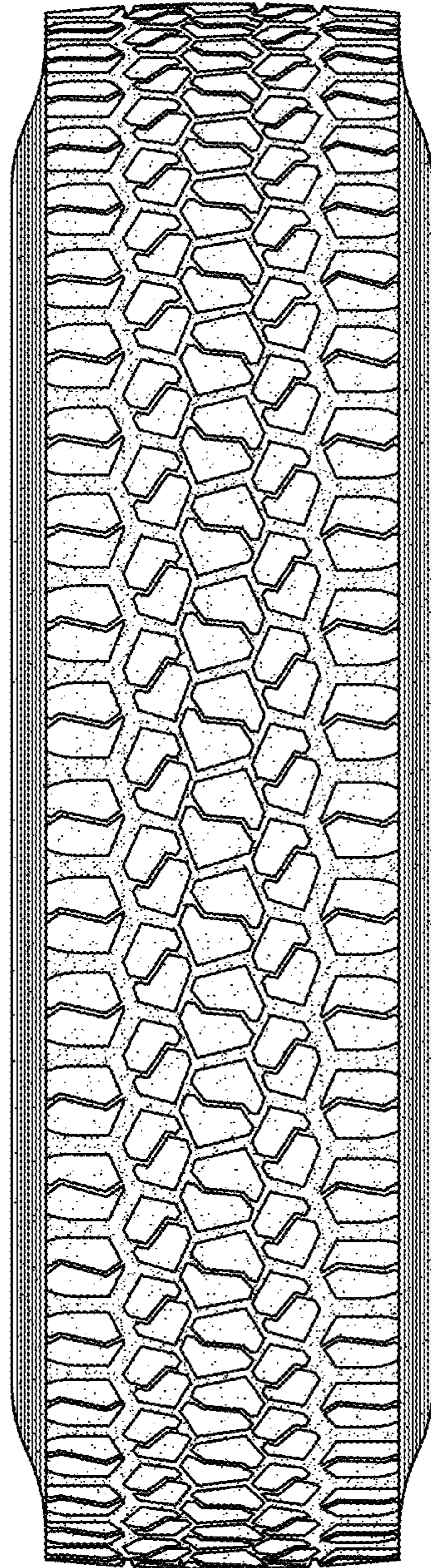

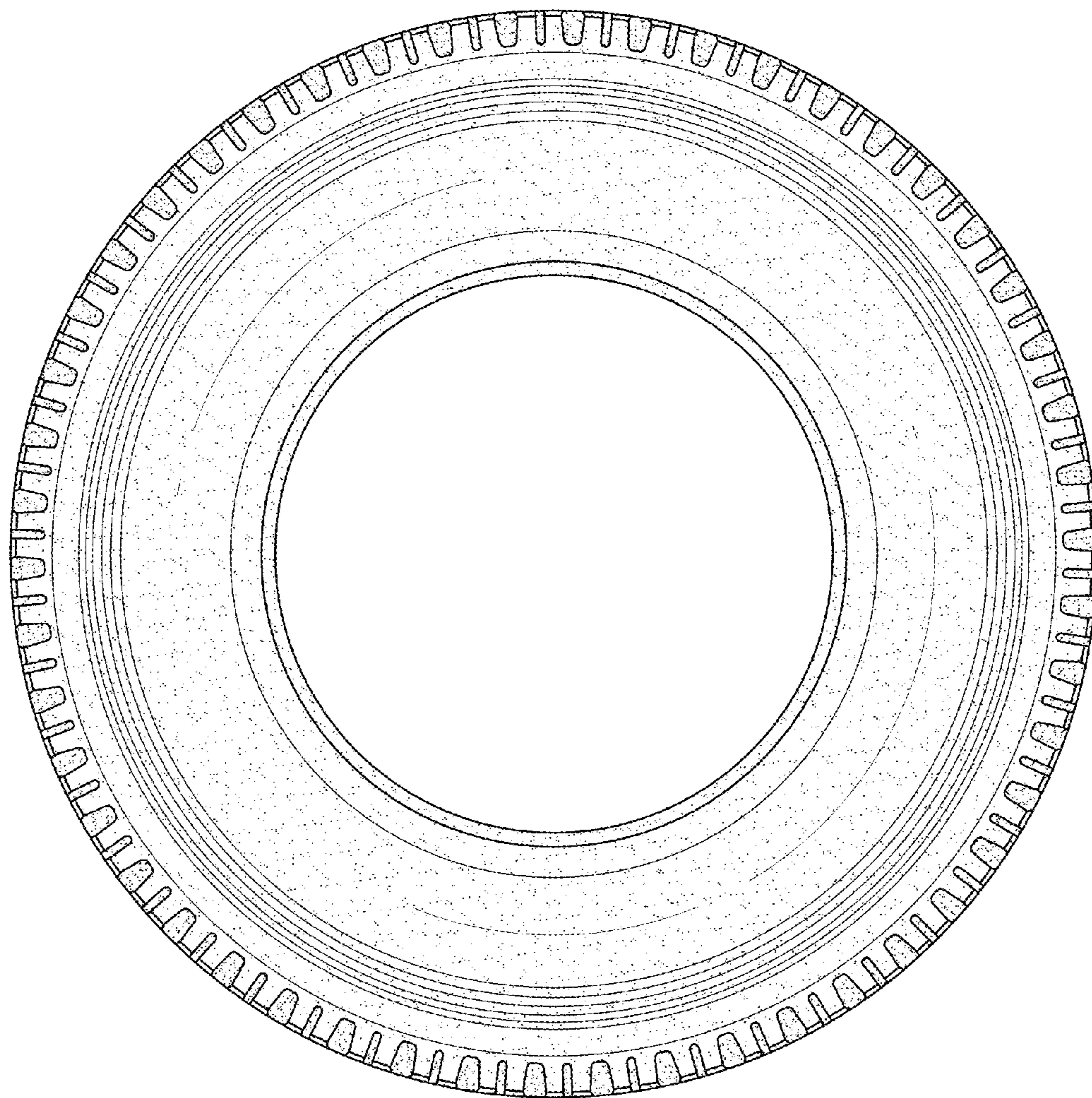

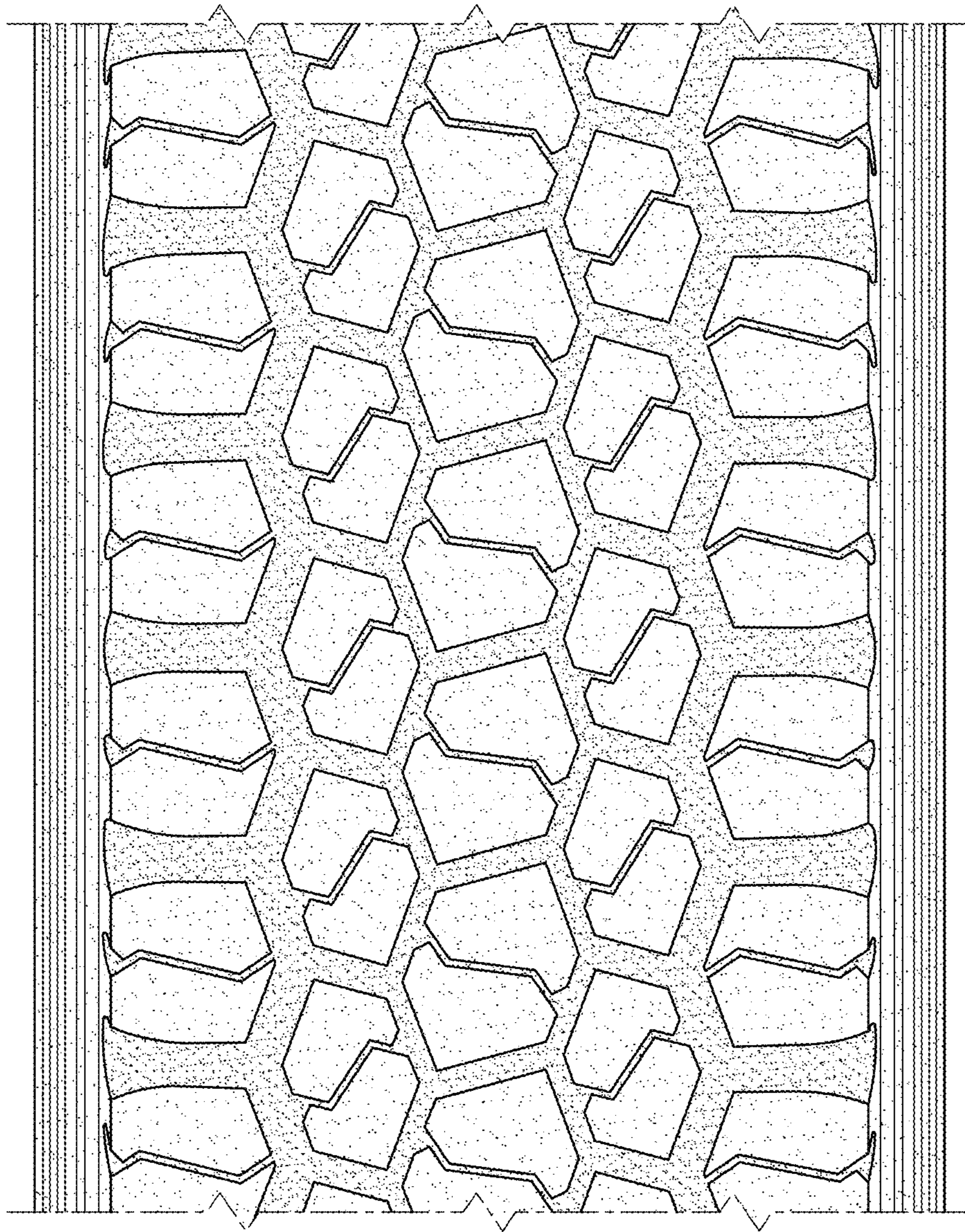
