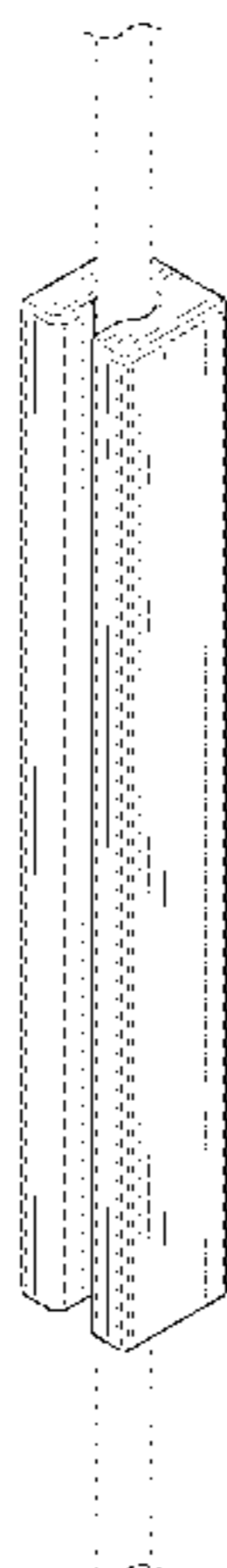
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a cable protector;
FIG. 2 is an isometric view thereof shown in environmental use;

FIG. 5 is a left side view thereof;

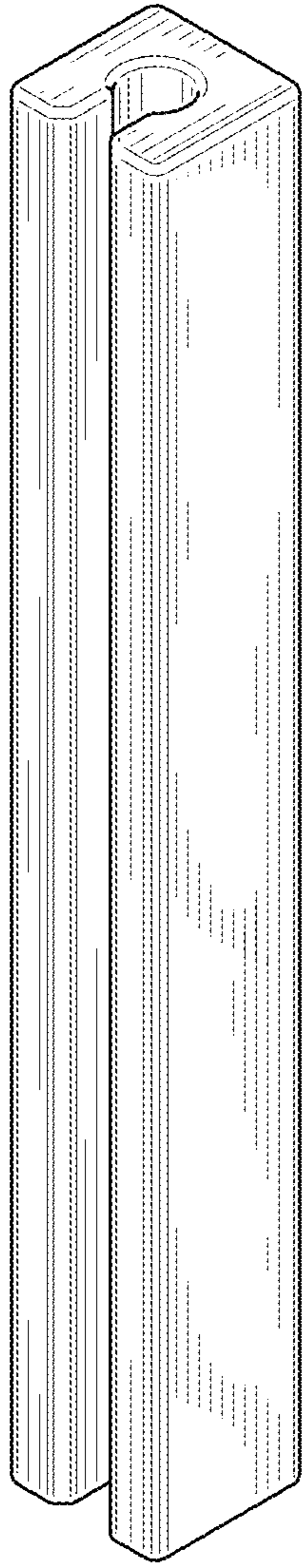

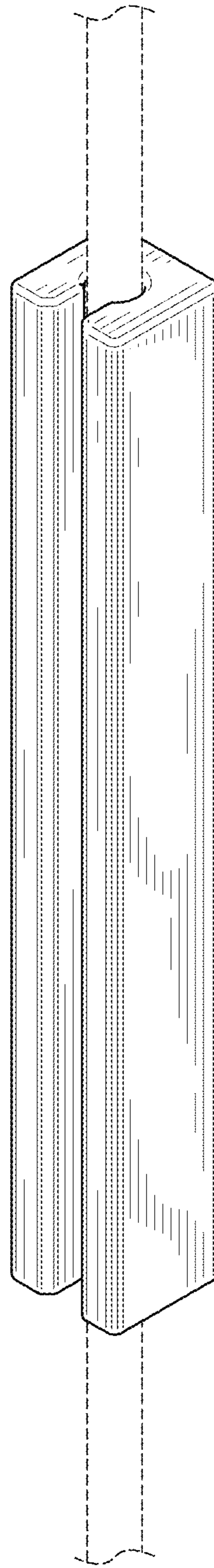

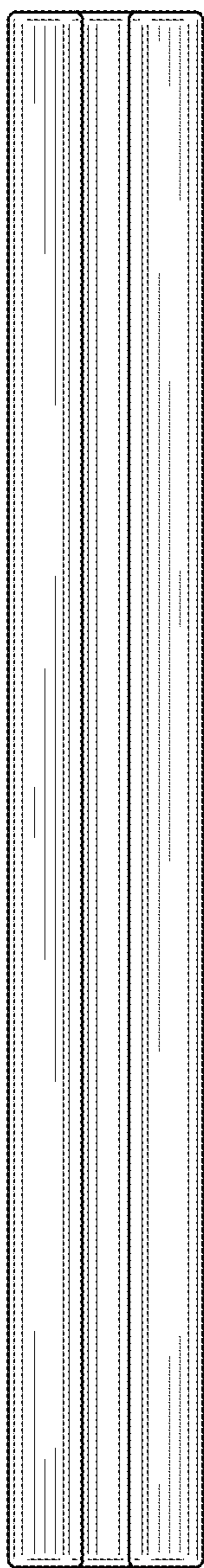

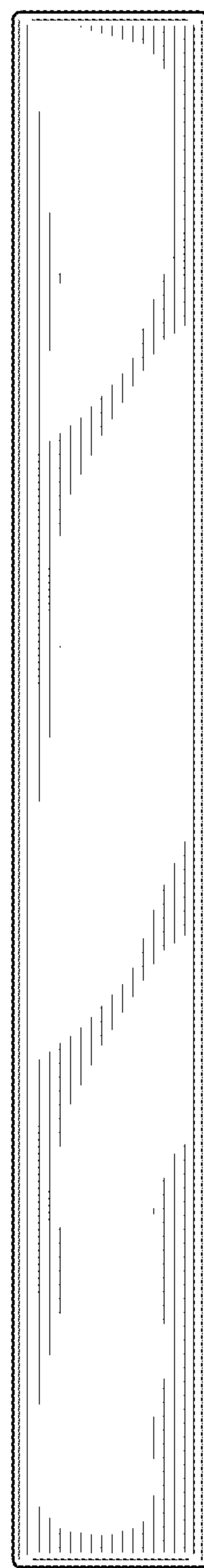

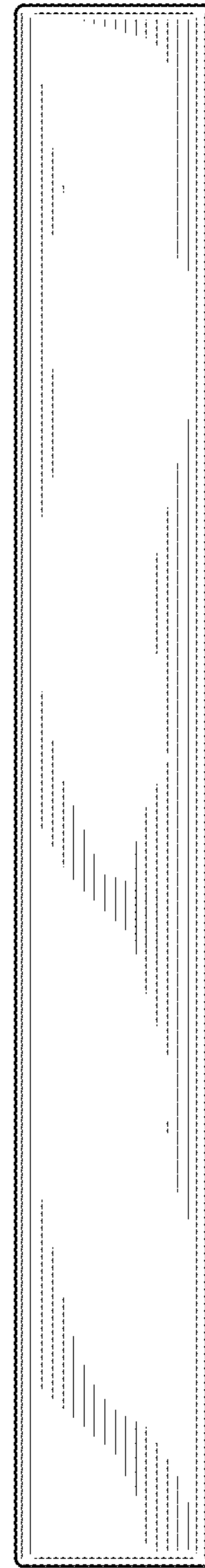

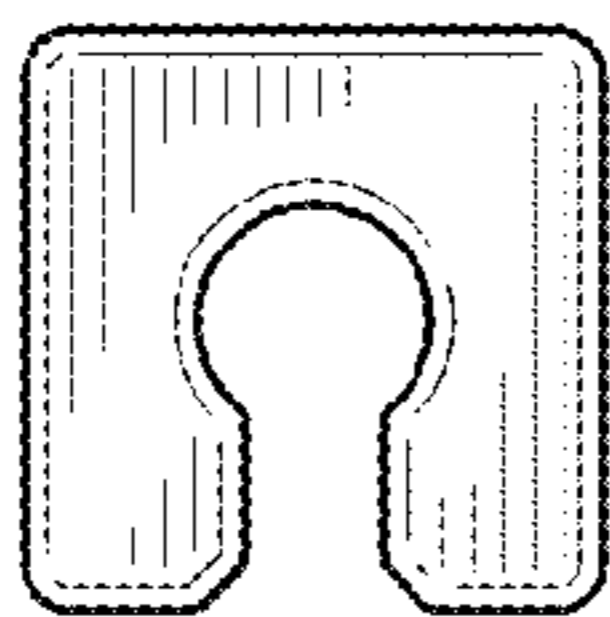

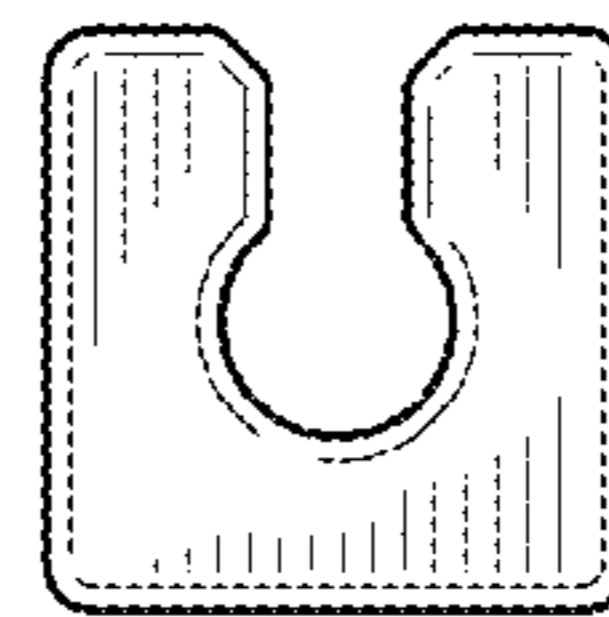
