(57) **CLAIM**

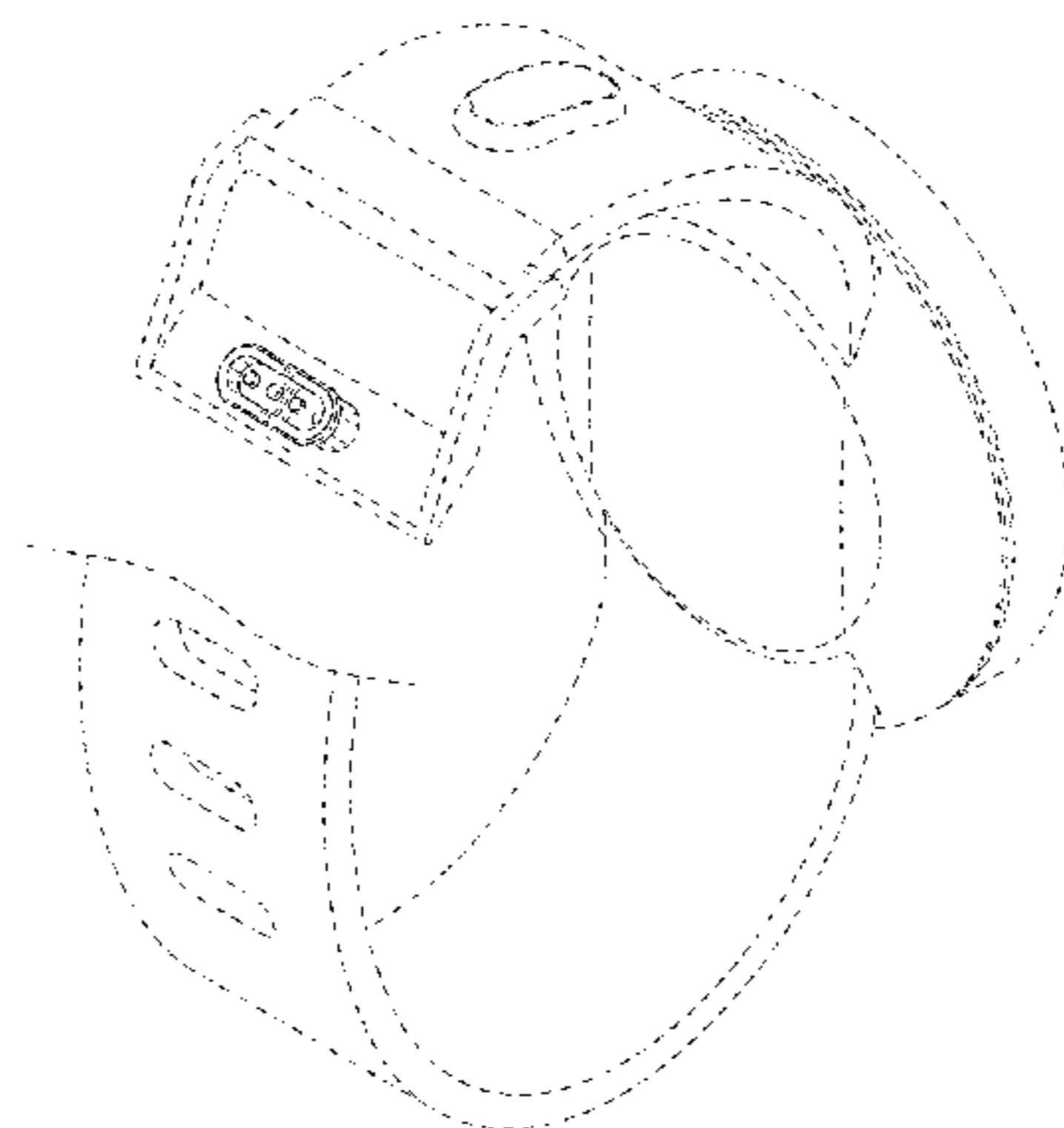
The ornamental design for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a first embodiment of an electronic device showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a top rear perspective view thereof with the electronic device shown with a portion of the band partially truncated.

The broken lines shown in the drawings represent portions of the electronic device that form no part of the claimed design.

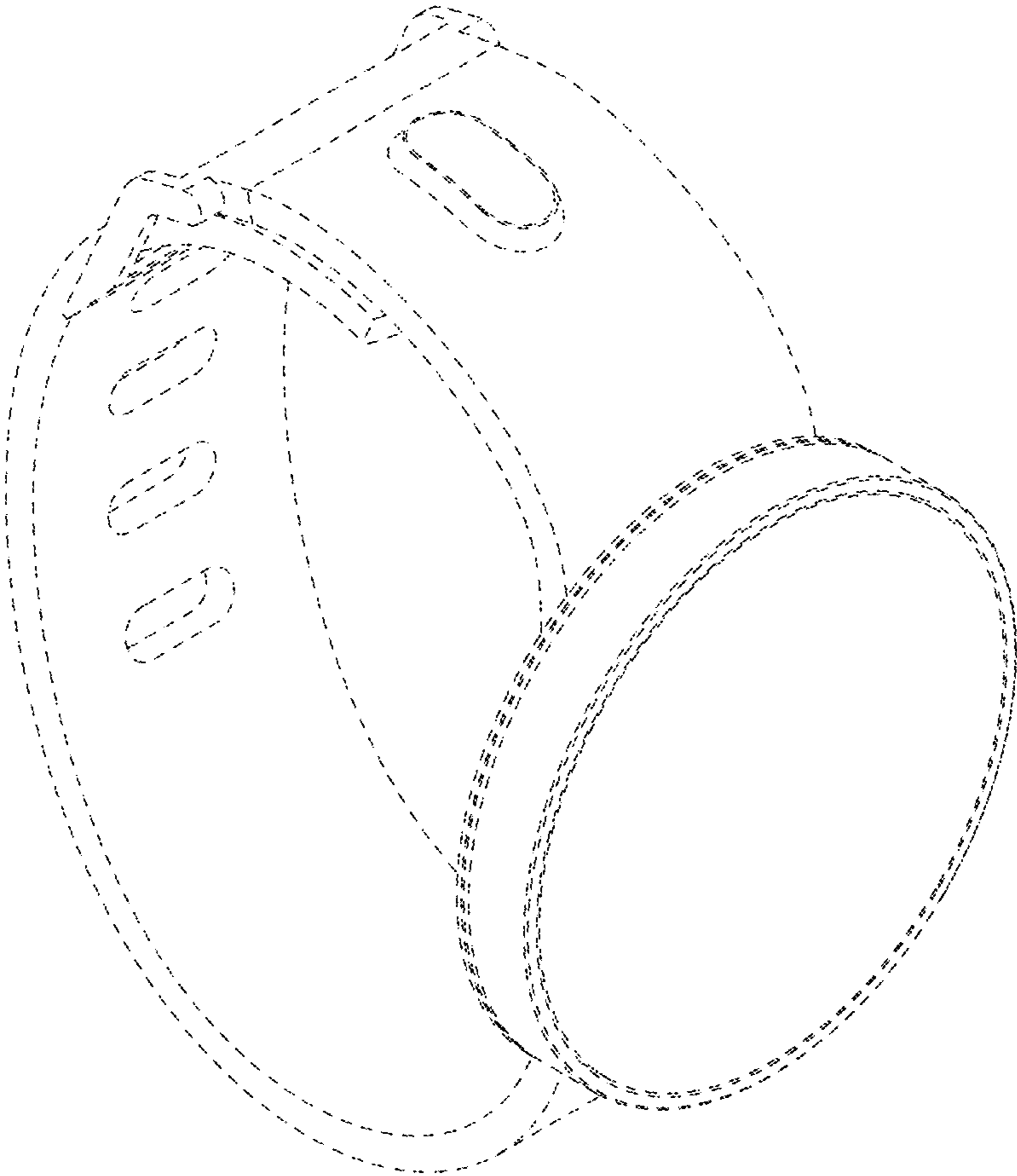

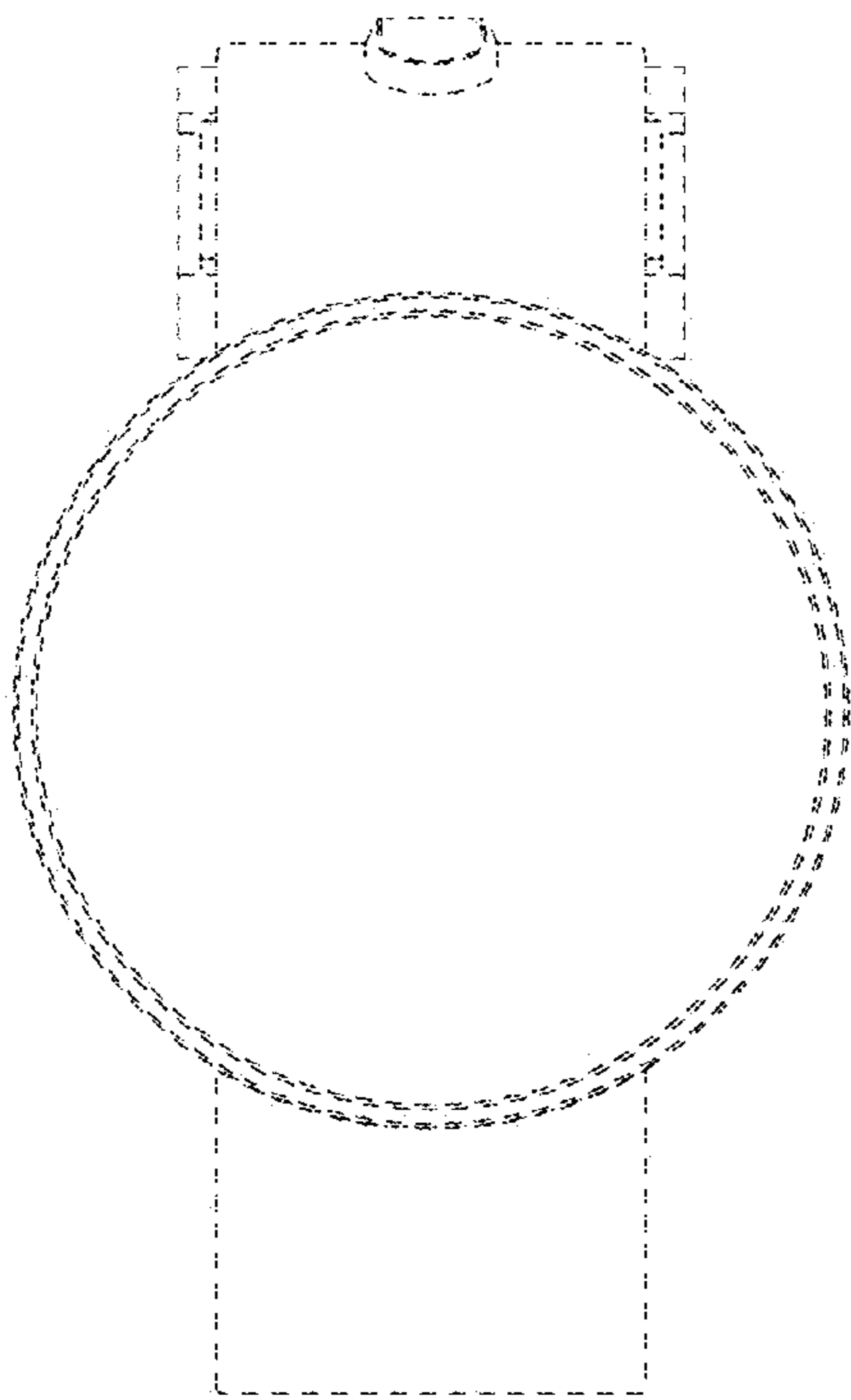

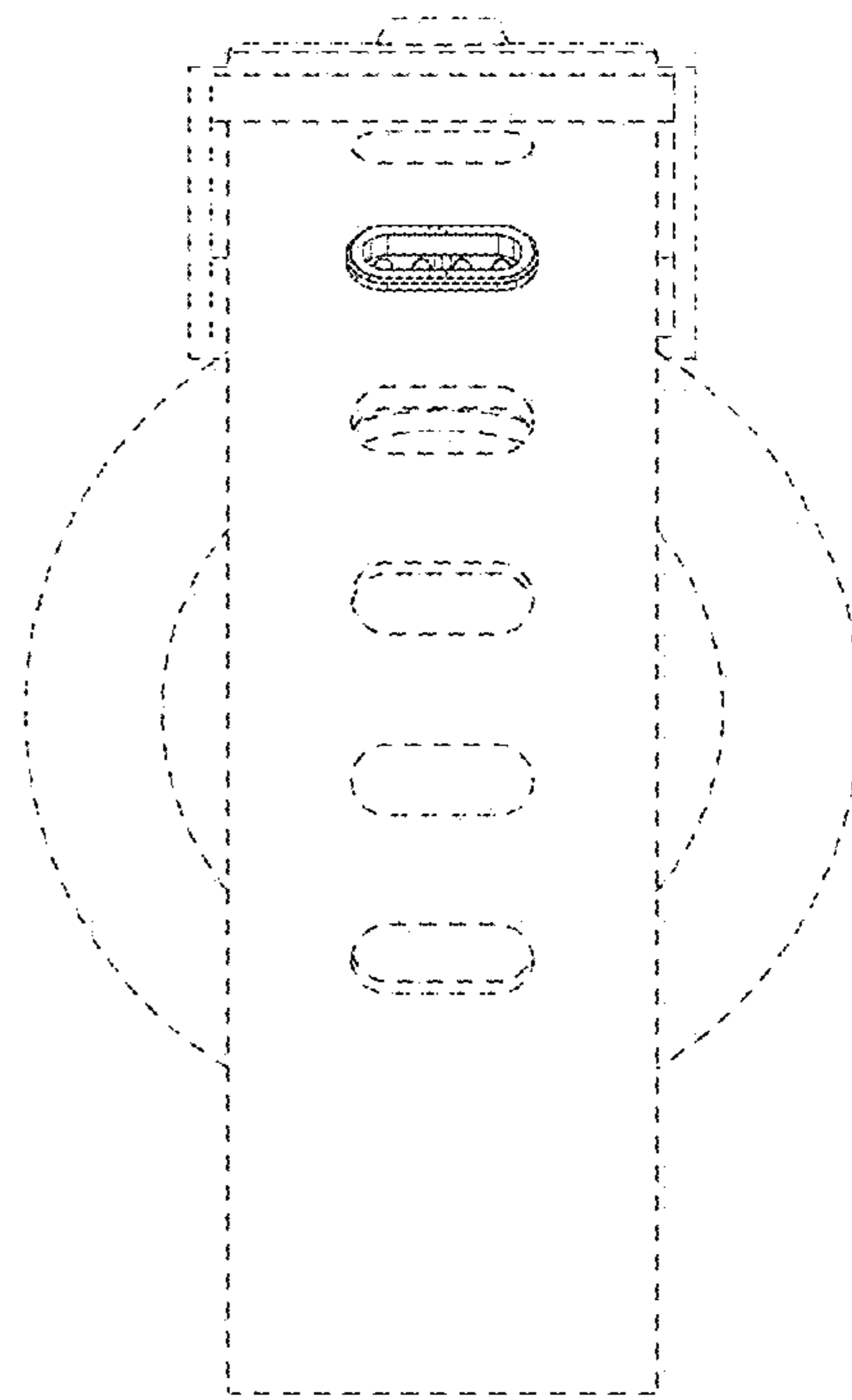

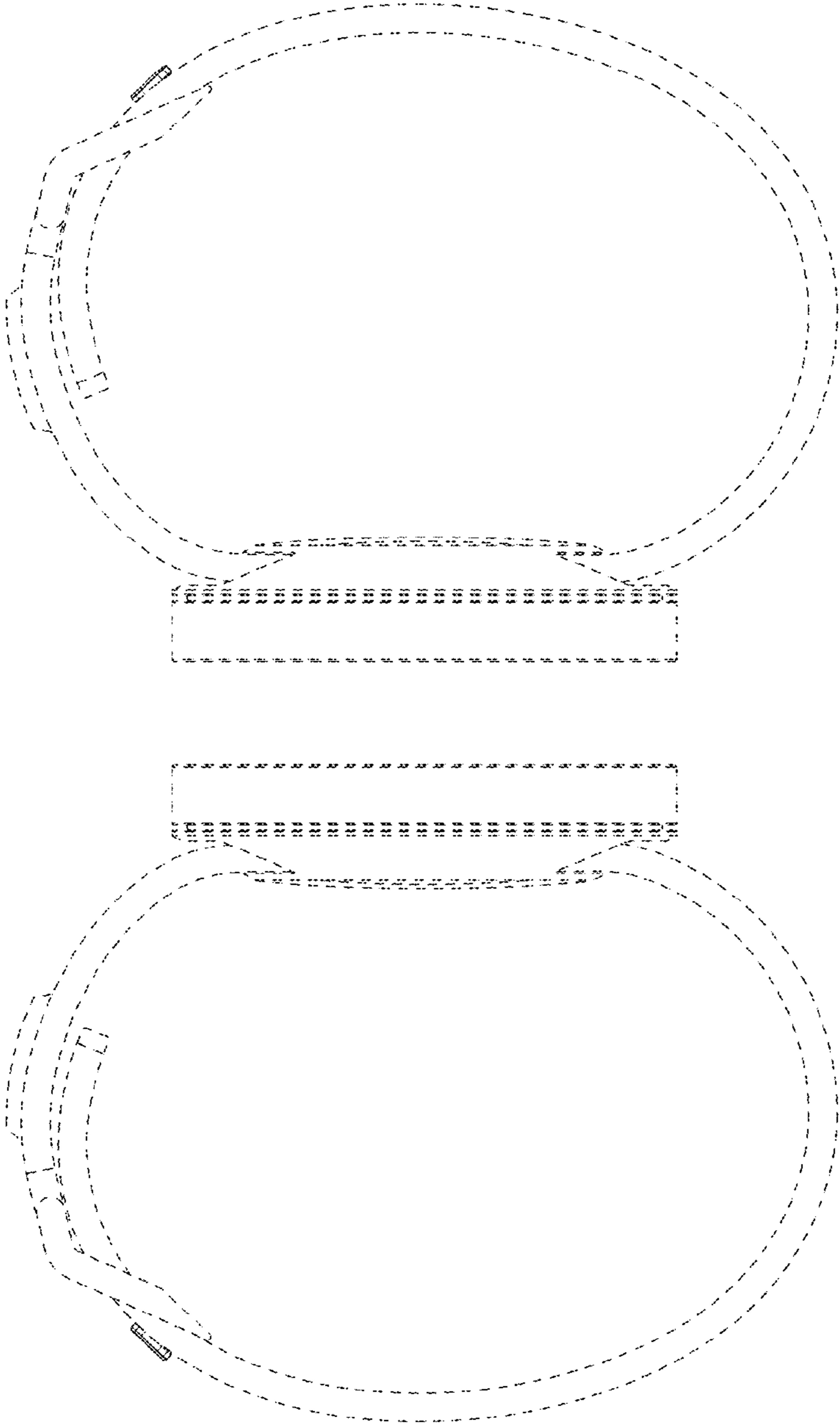

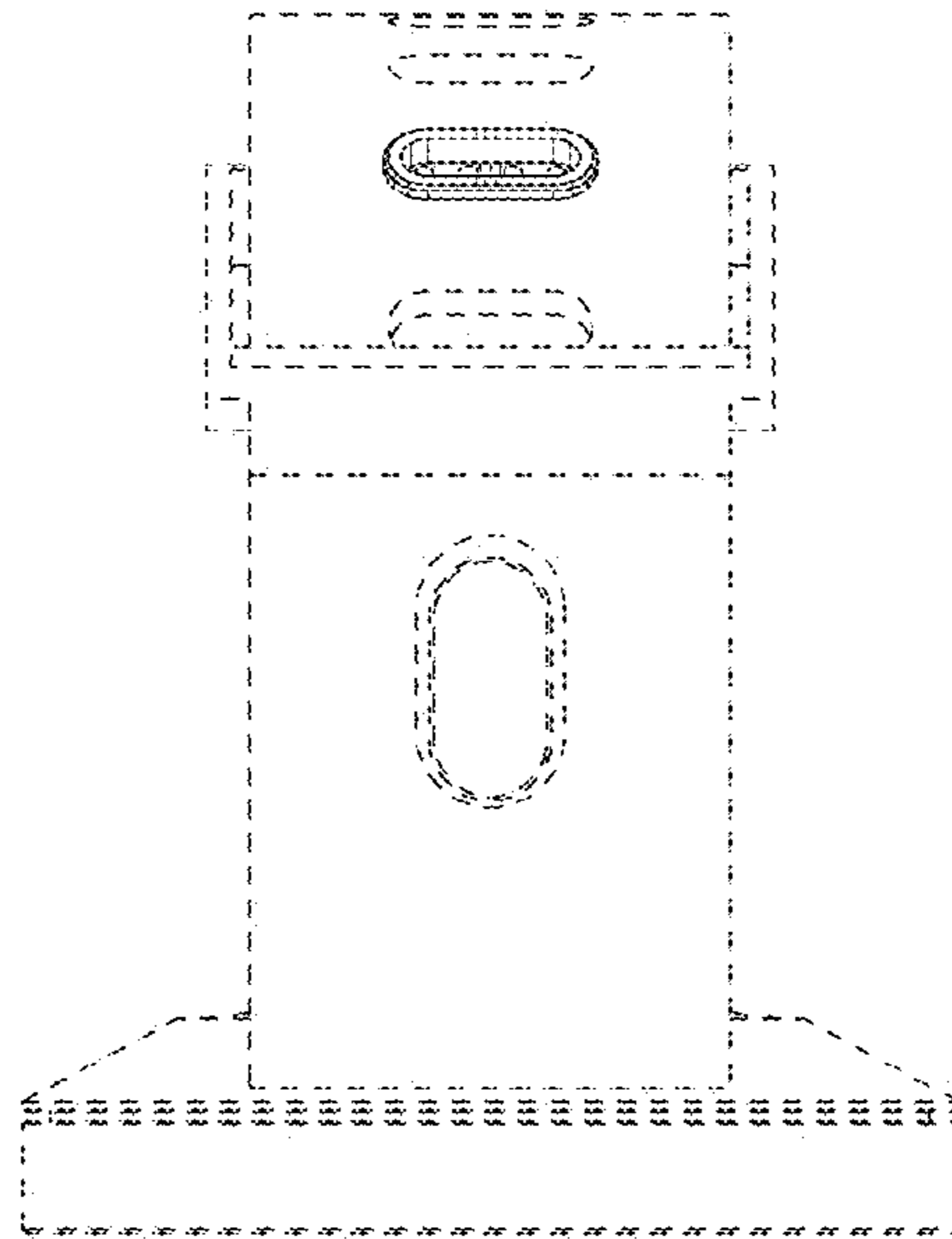

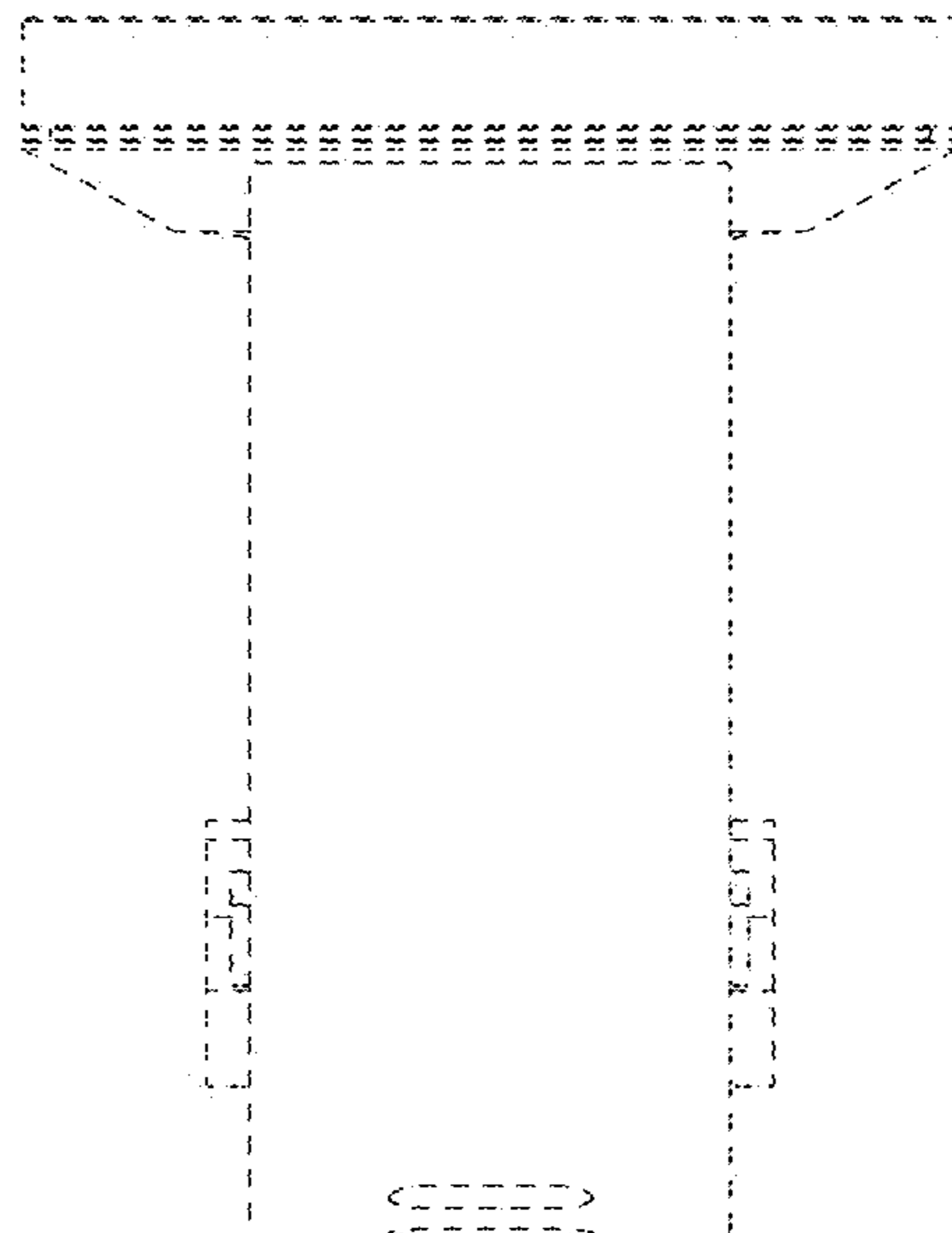

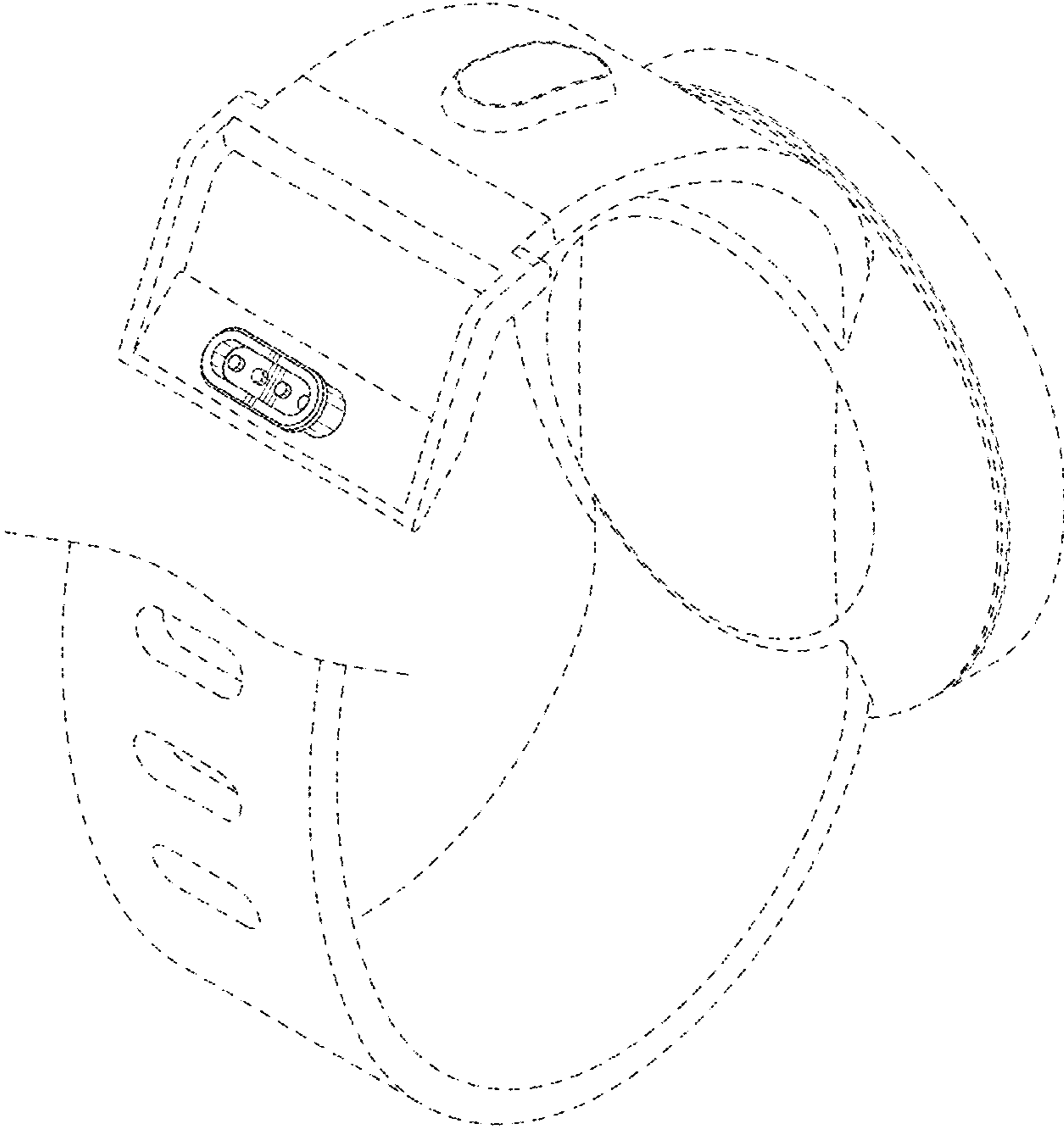
