(57) **CLAIM**



The ornamental design for an oven display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an oven display screen with graphical user interface according to our new ornamental design, shown with the upper button in the first column activated to enable a plurality of sub-menu selections that include vertical lines; and,

FIG. 2 is a front view of a second embodiment of FIG. 1, shown with the middle button in the first column activated to enable a plurality of sub-menu selections that include horizontal lines.

The dash-dot broken line showing of a vertical line forms no part of the claimed design. The dash-dash broken line showing of the remainder of the graphical user interface and of a display screen forms no part of the claimed design.




