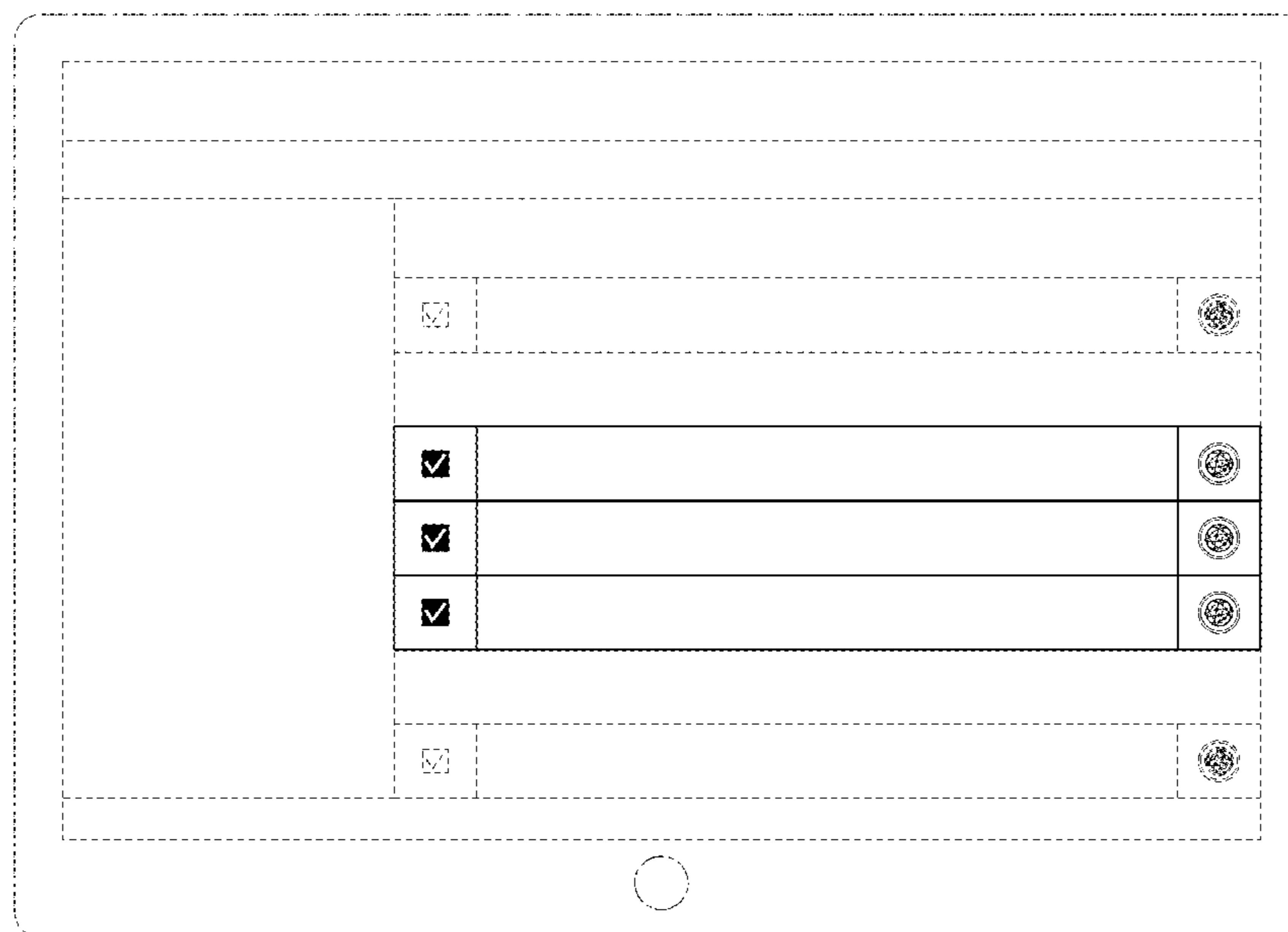

The dashed broken line showing in FIGS. 1-4 of the remainder of the graphical user interface forms no part of the claimed design.

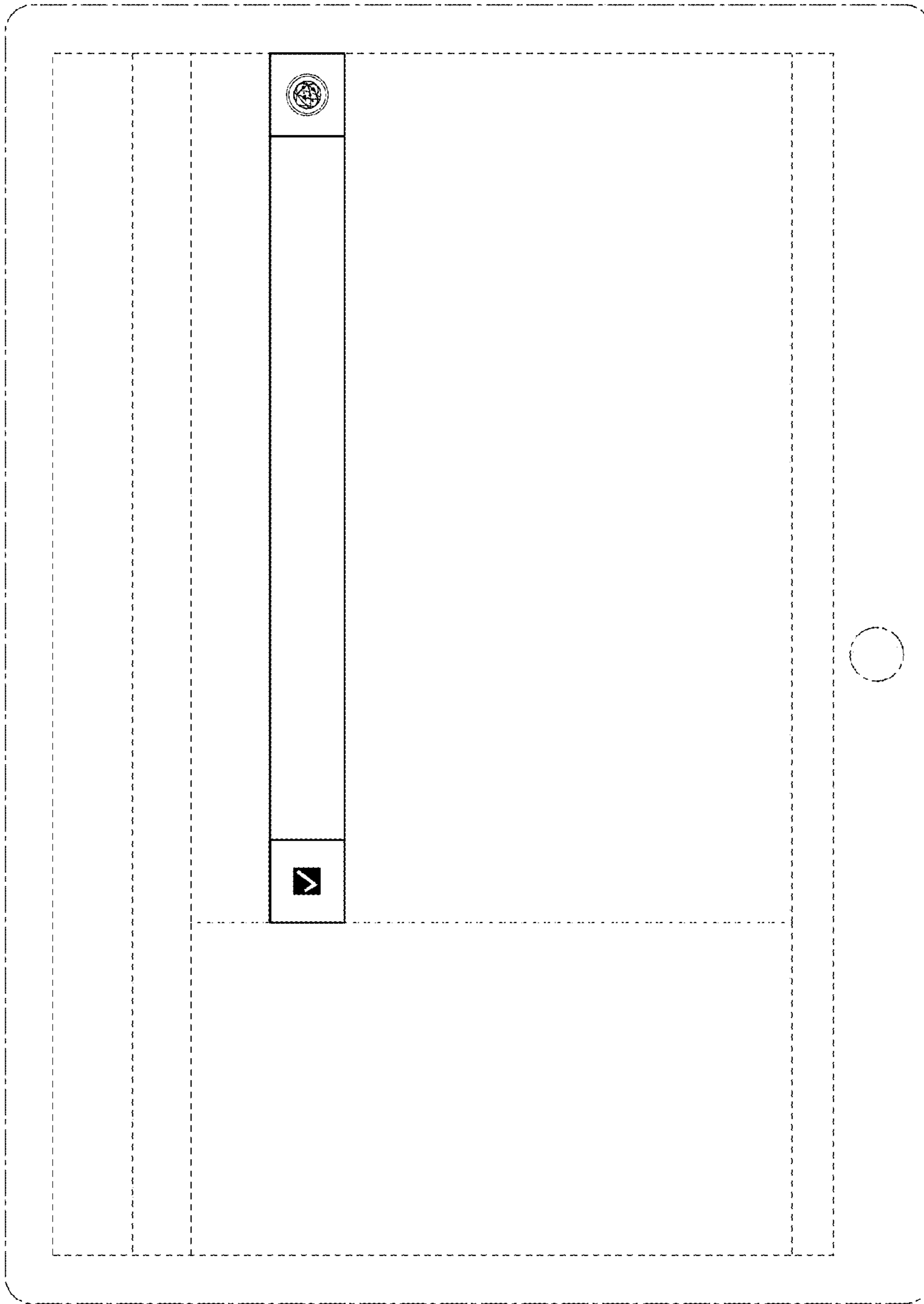

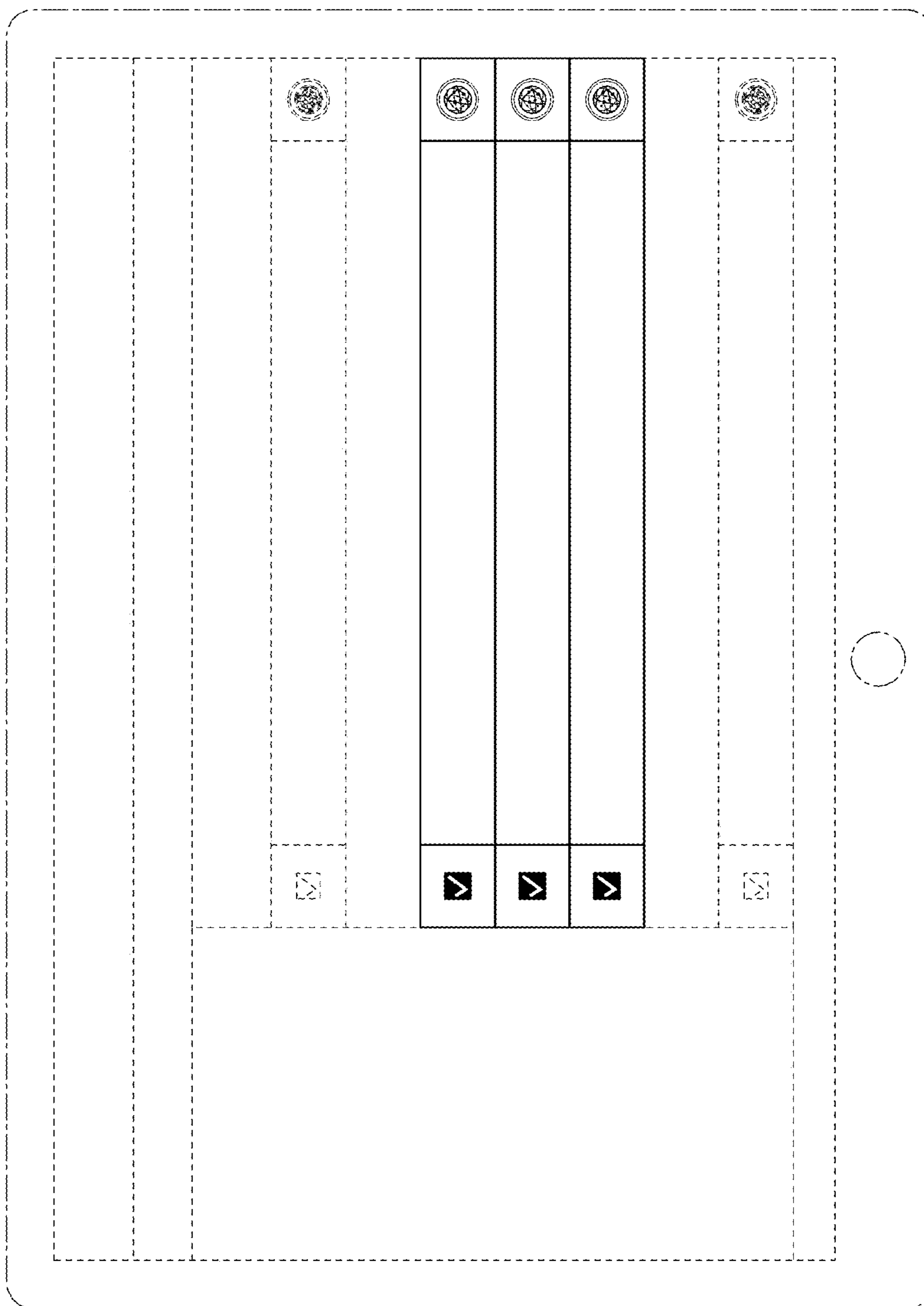

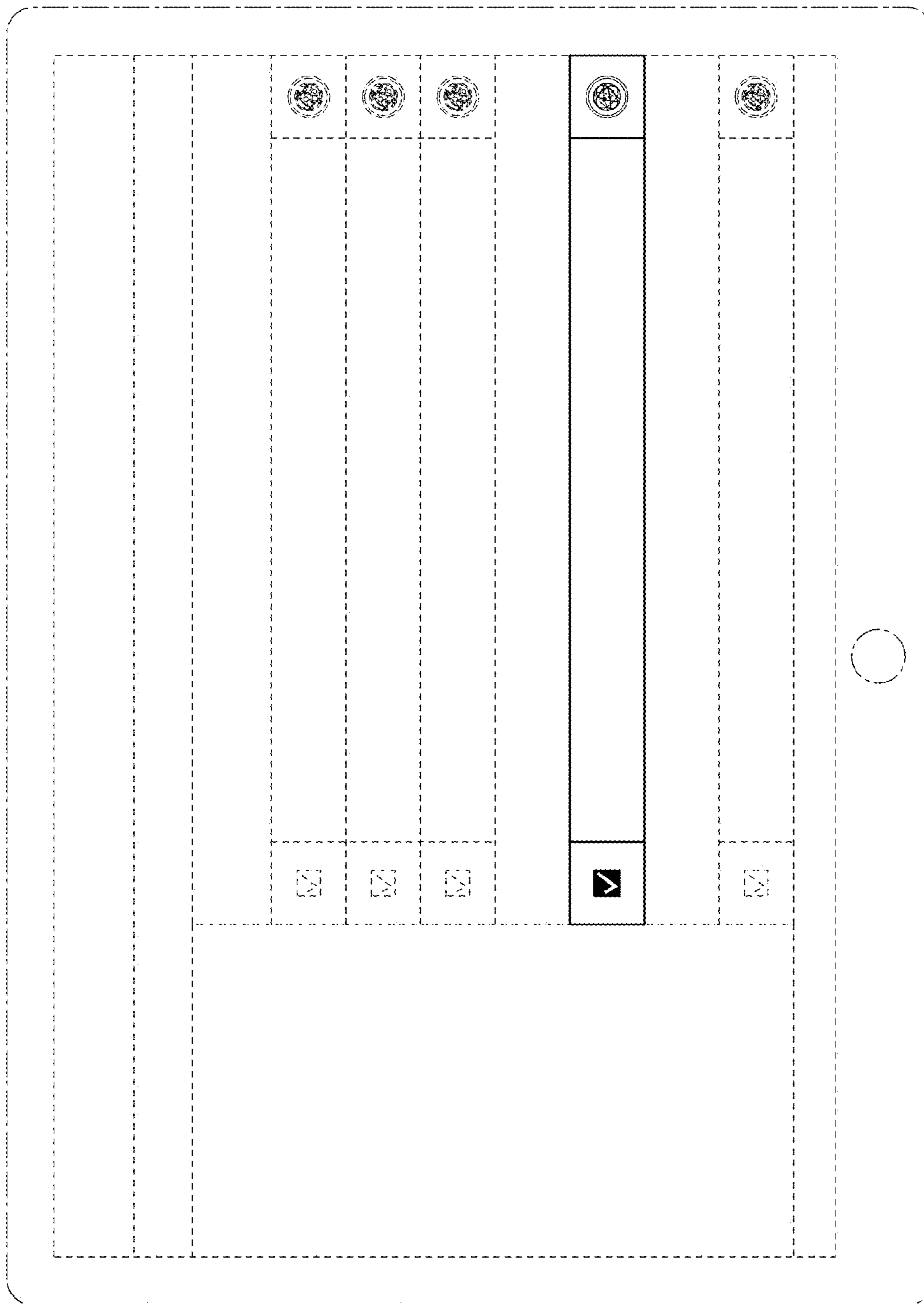

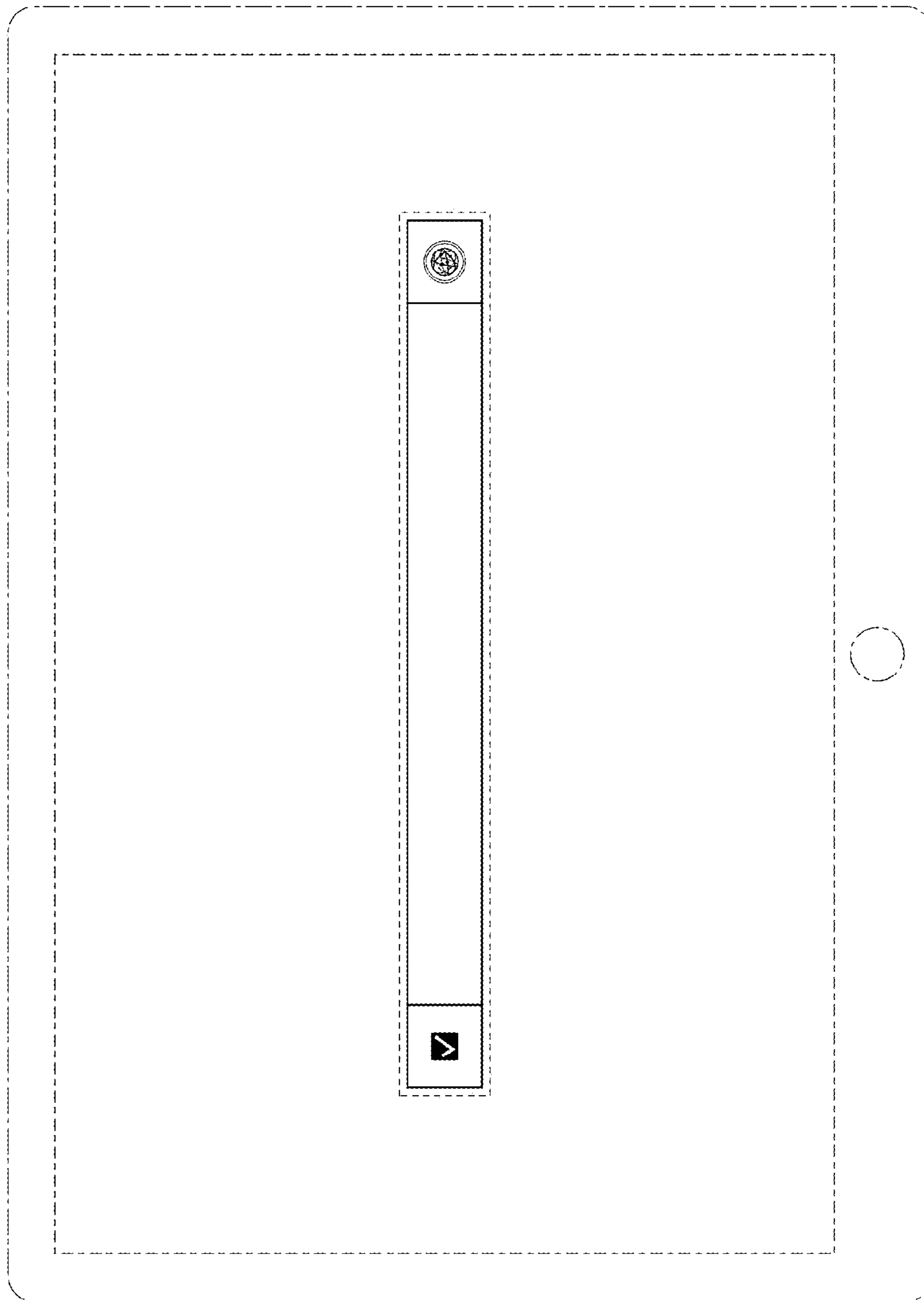
