(57) **CLAIM**

The ornamental design for a display panel or screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence of a display panel or screen with animated graphical user interface showing our new design; and, FIG. 2 is a second image thereof.

The broken lines in the figures represent portions of the display panel or screen with animated graphical user interface that form no part of the claimed design.

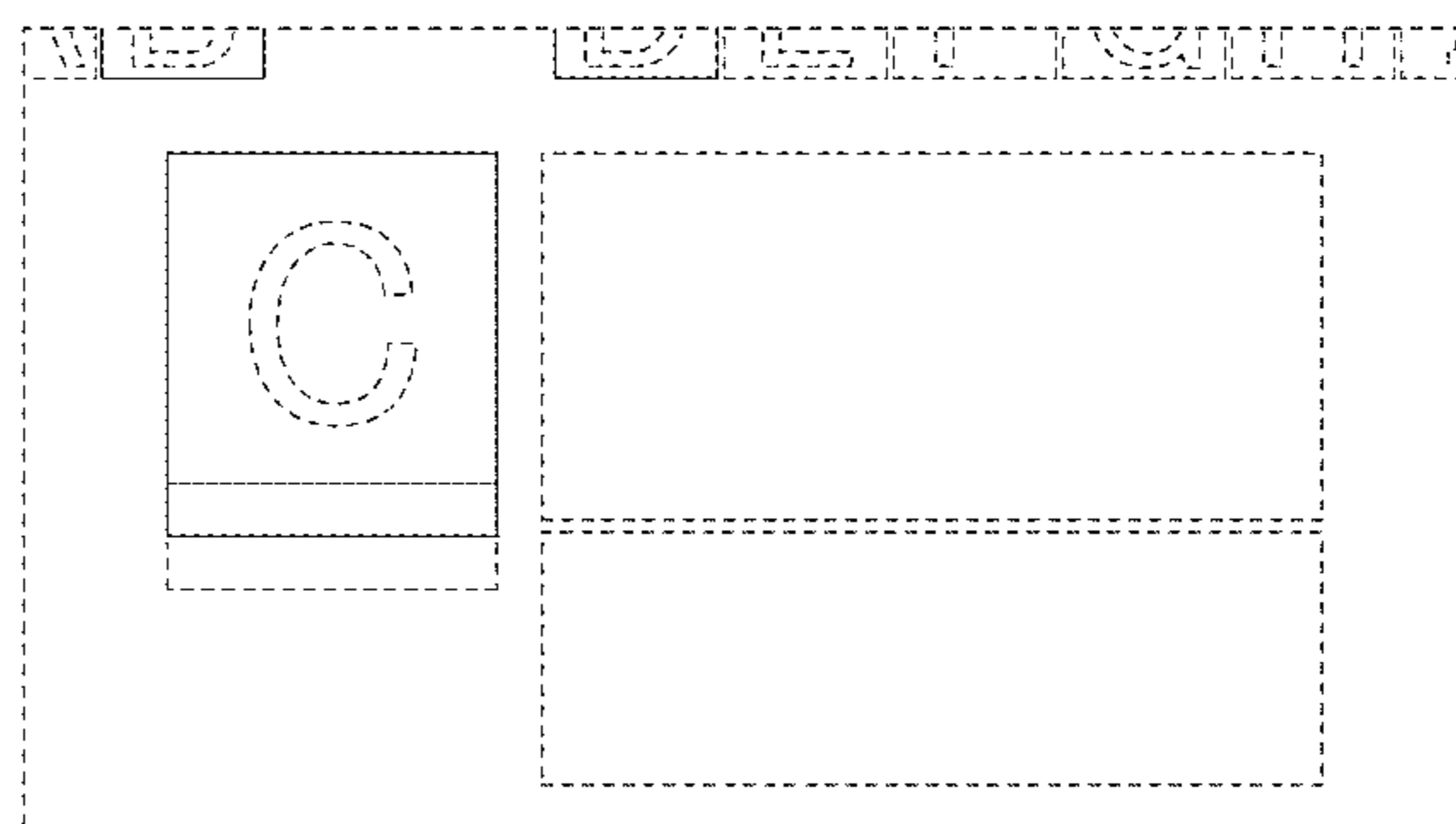
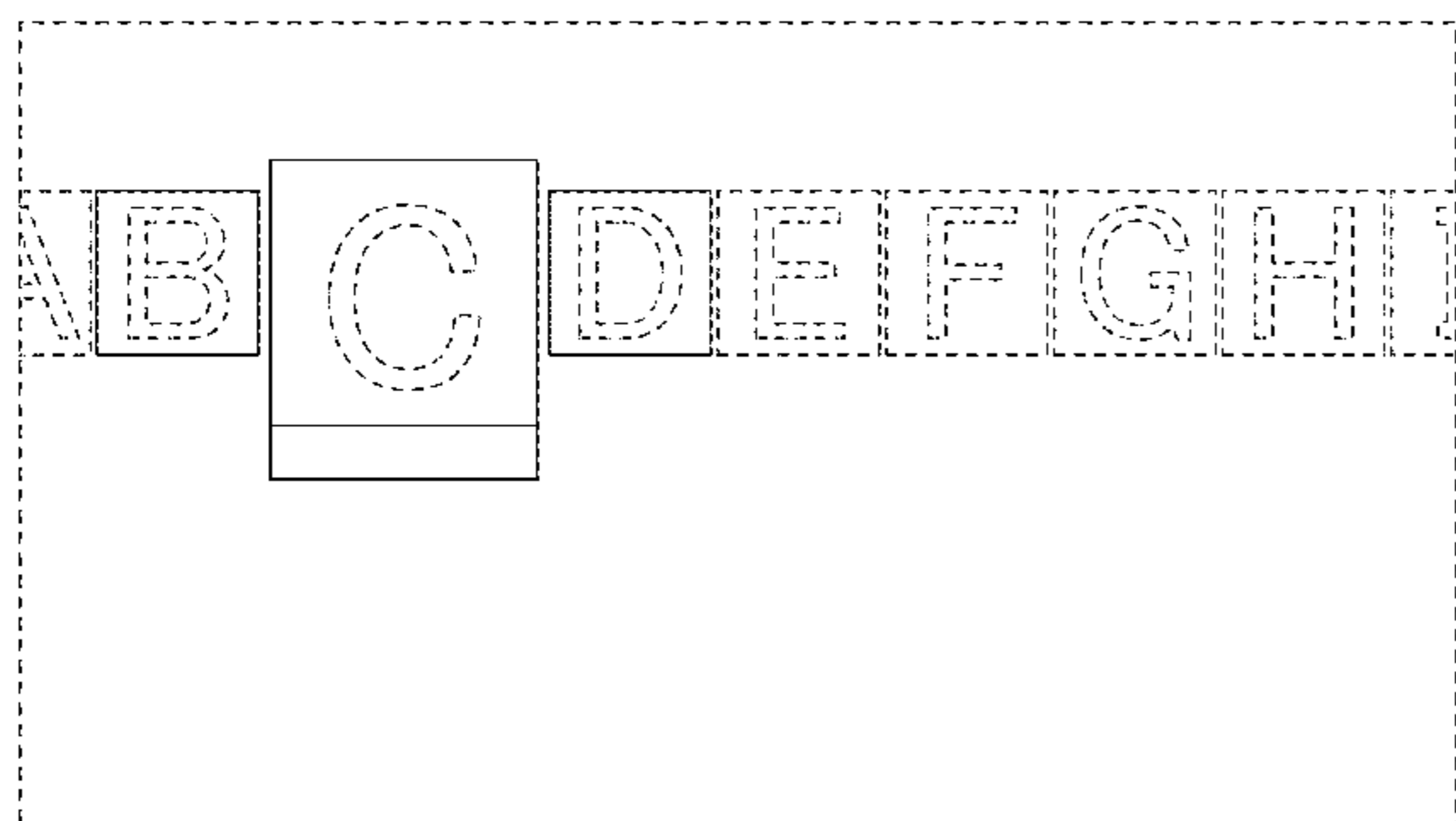

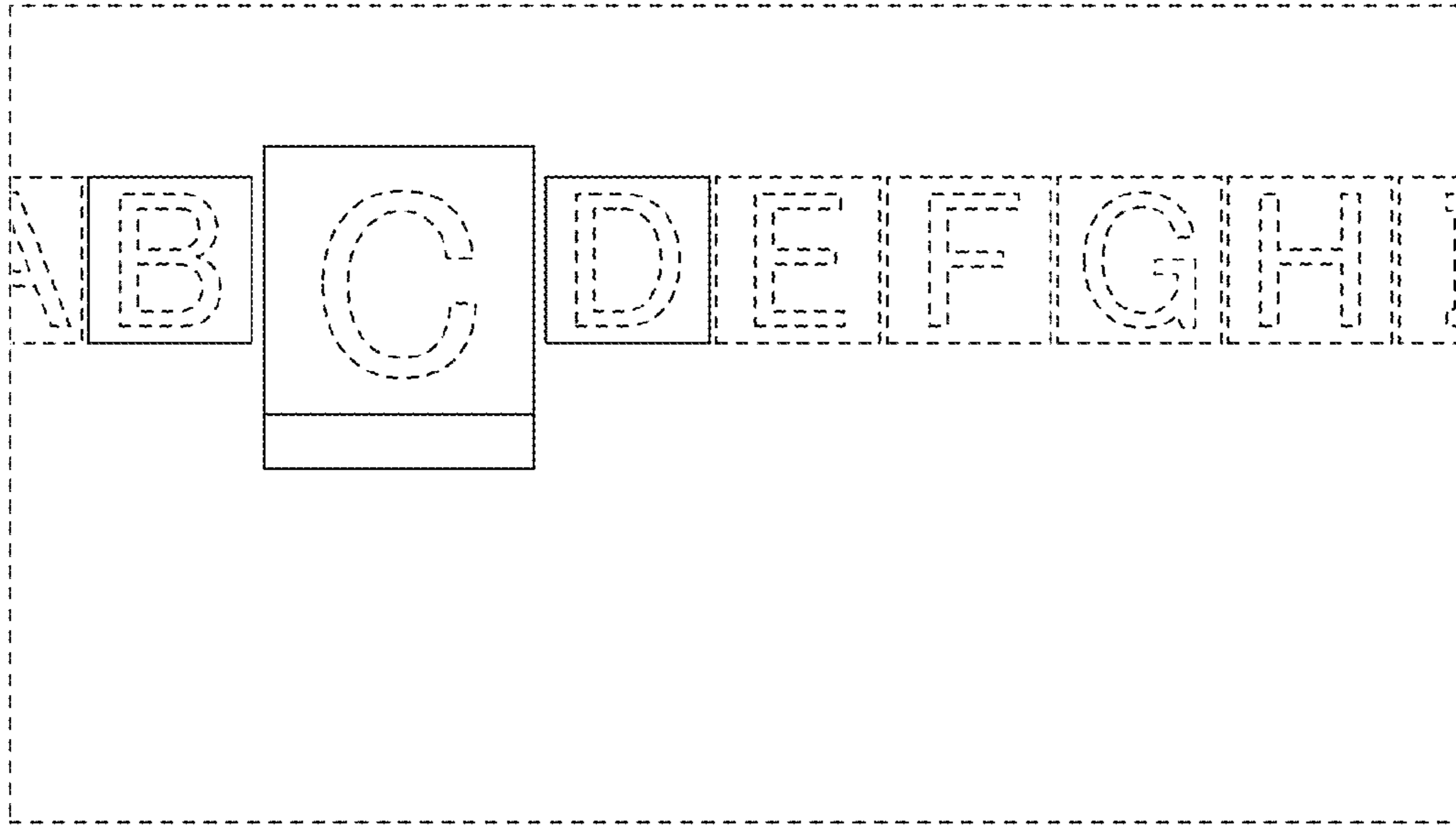
