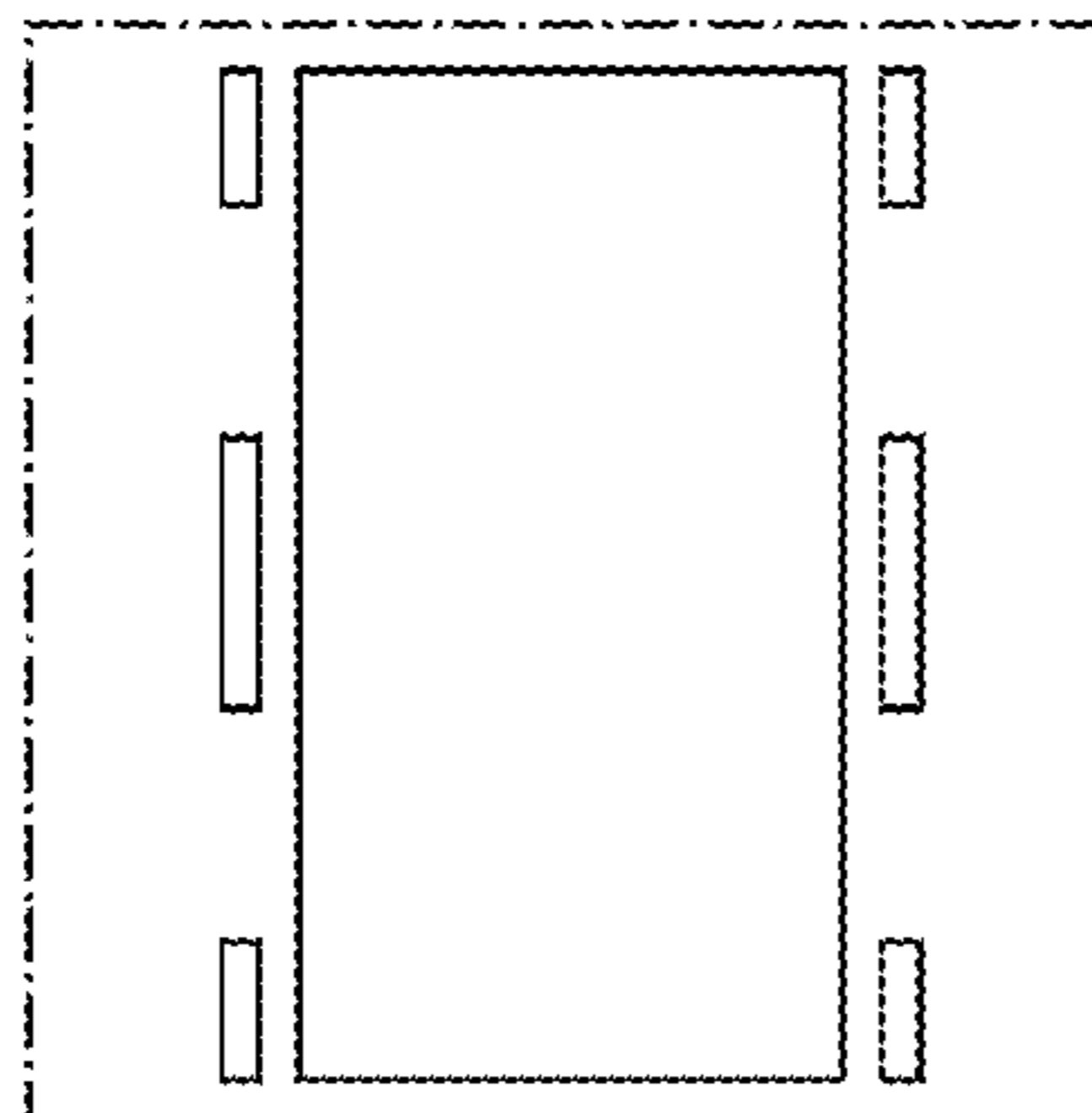
(57) **CLAIM**

FIG. 1 a front view of a display screen portion with icon according to a first embodiment of our design; and, FIG. 2 is a front view of a display screen portion with icon according to a second embodiment of our design. The broken line showings of a portion of a display screen in the figures are environmental only and form no part of the claimed design. 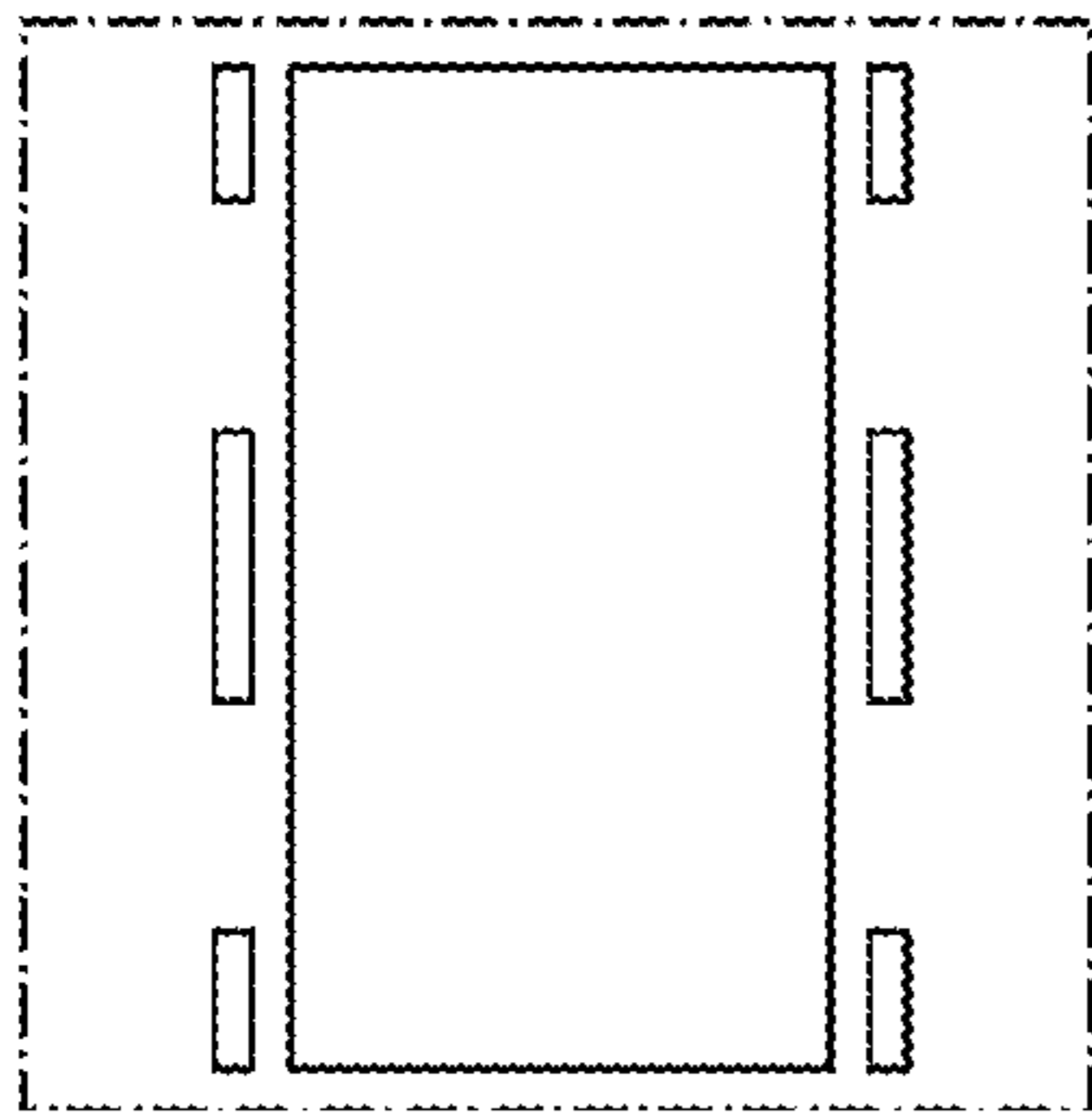

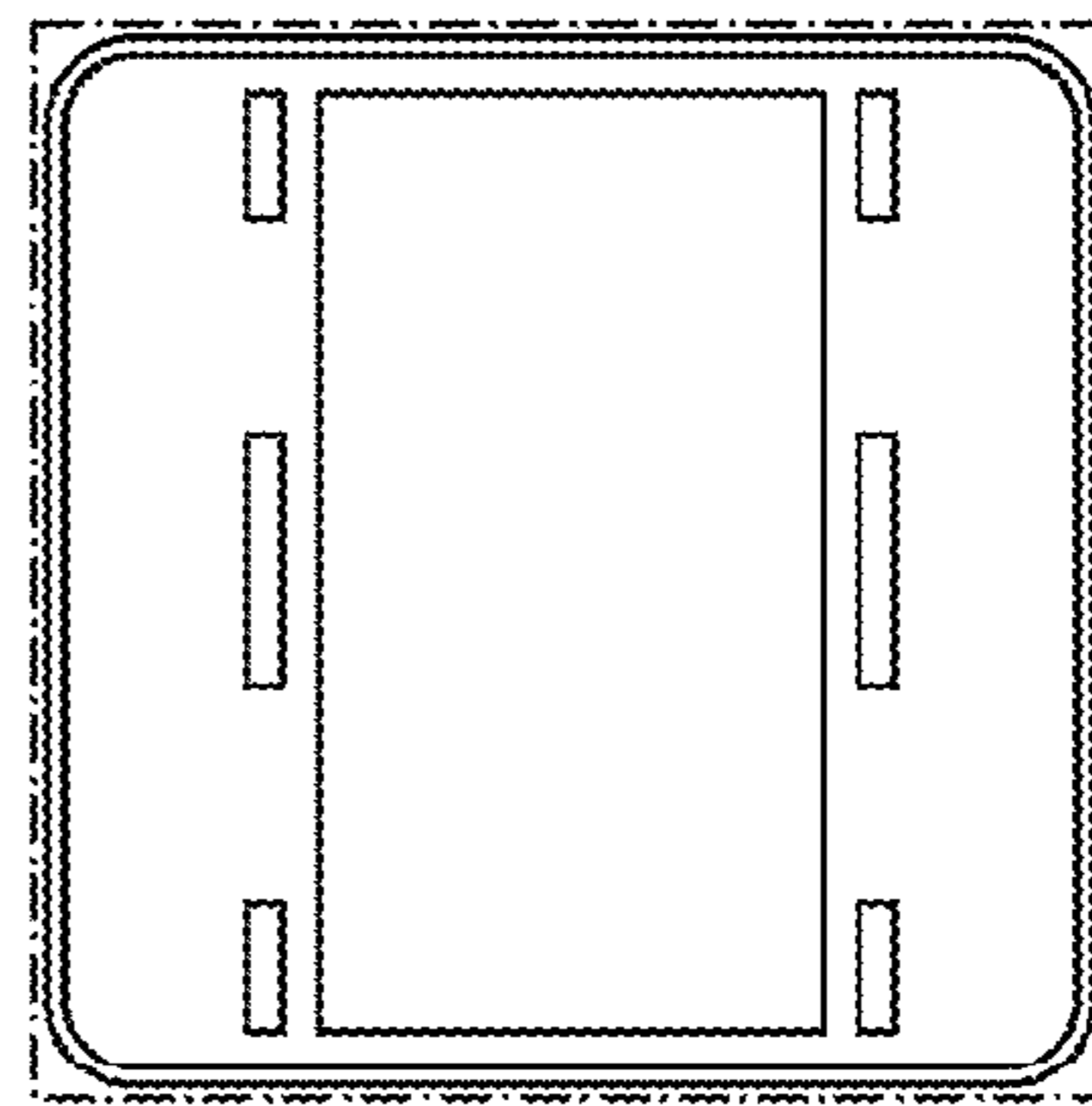
