The ornamental design for a cutting tool, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a cutting tool showing our new design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a left side view thereof;
 FIG. 7 is a front perspective view thereof;
 FIG. 8 is a rear perspective view thereof;
 FIG. 9 is a top perspective view thereof;
 FIG. 10 is a sectional view taken along line 10-10 of FIG. 5 thereof; and,
 FIG. 11 is a sectional view taken along line 11-11 of FIG. 5 thereof.

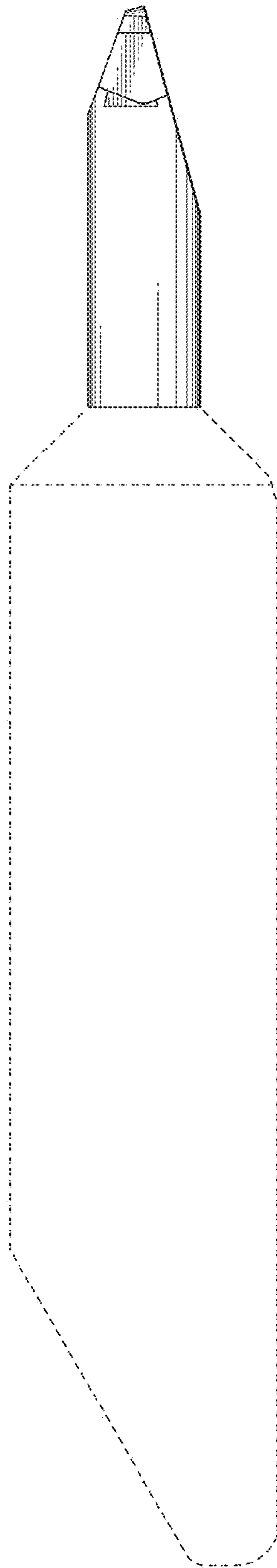

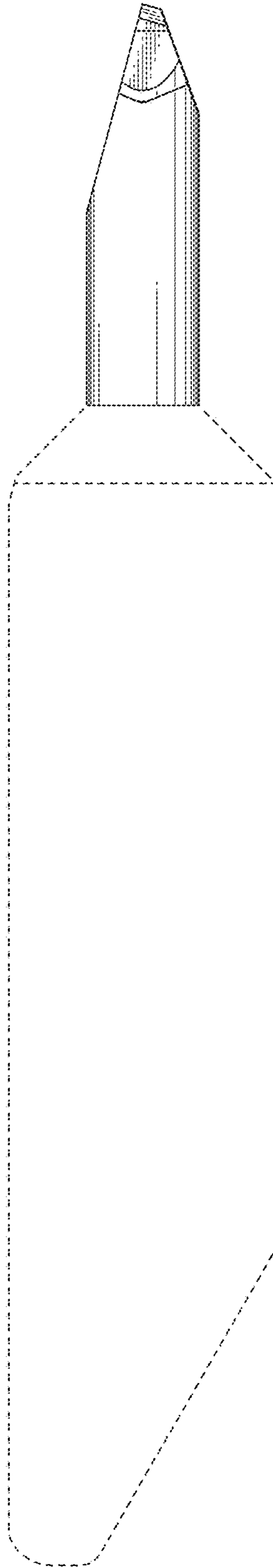

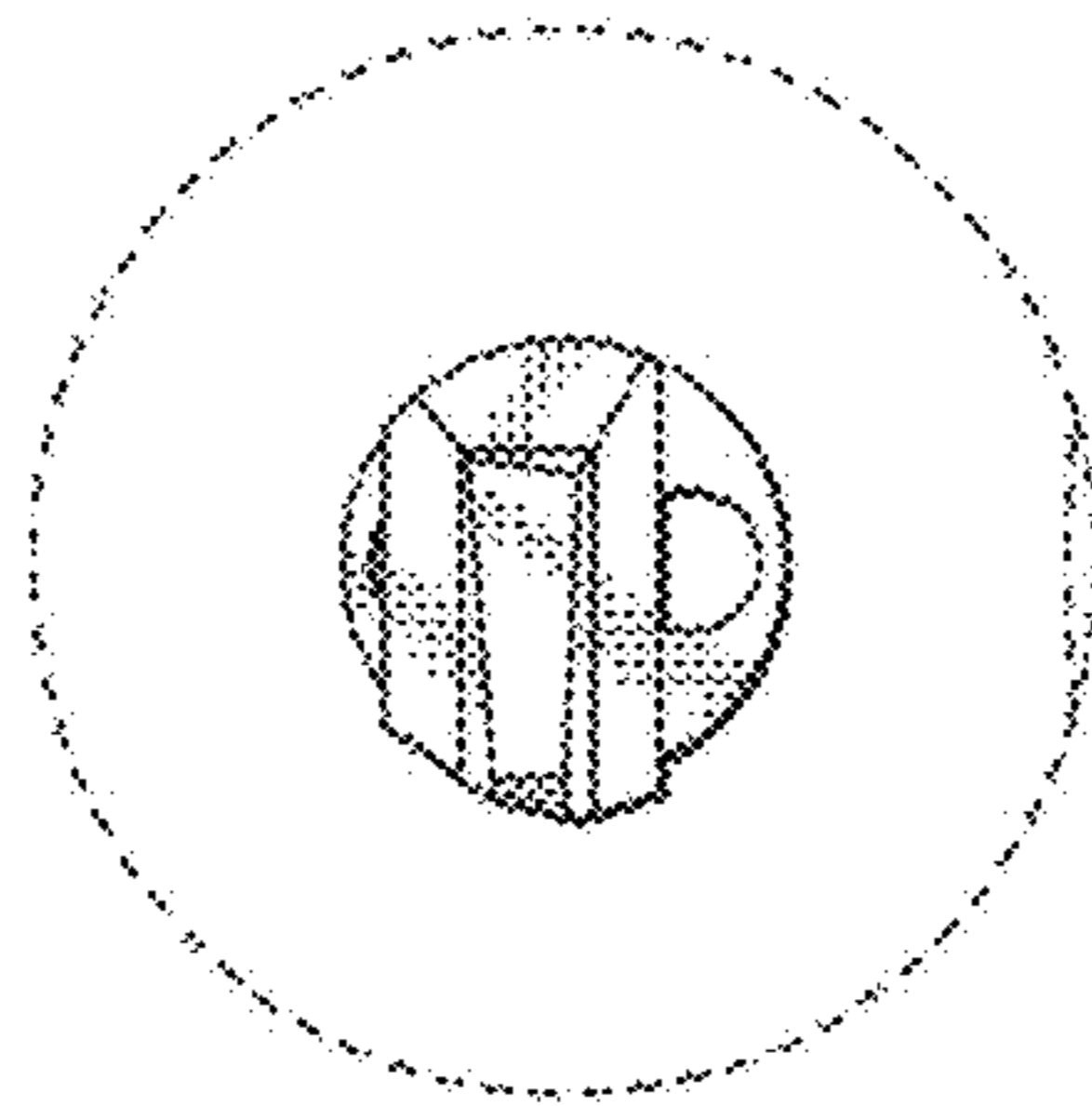

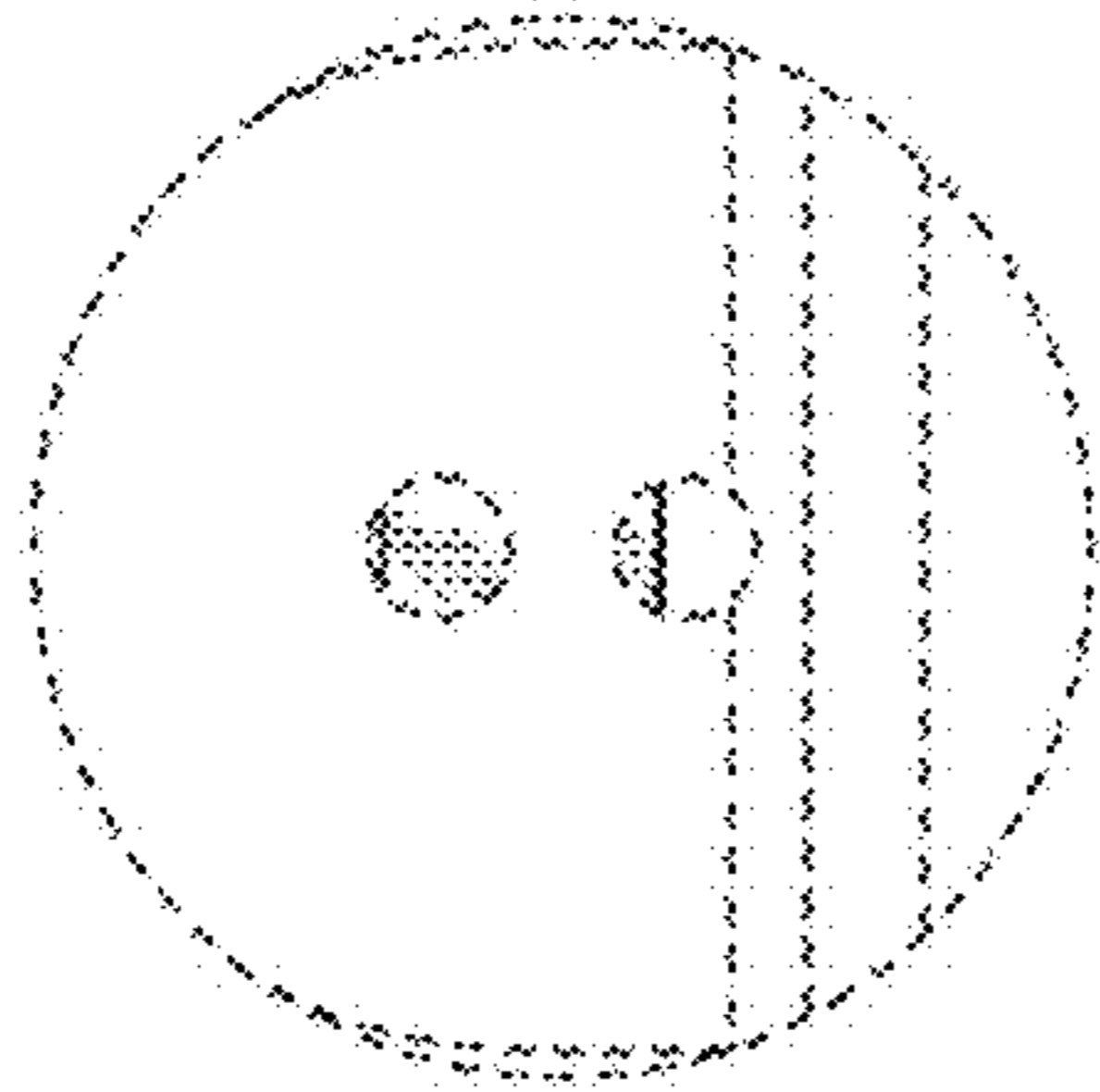

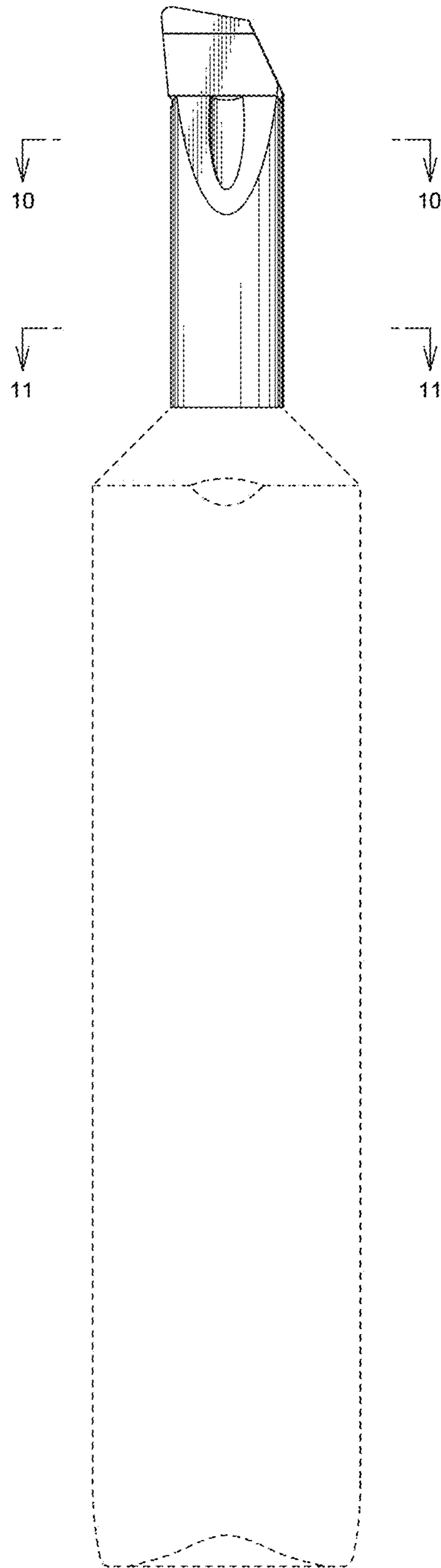

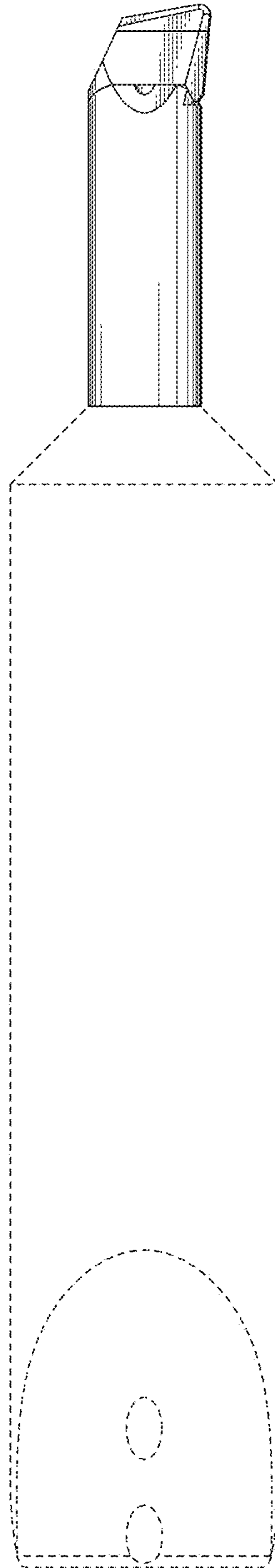

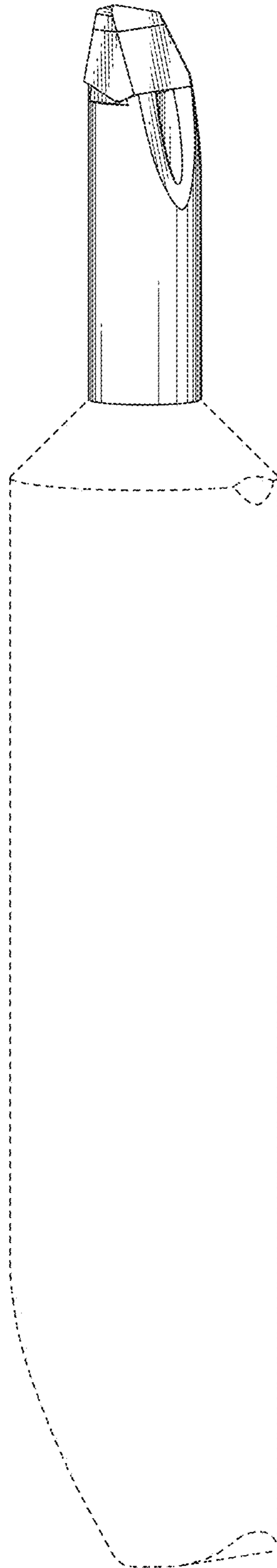

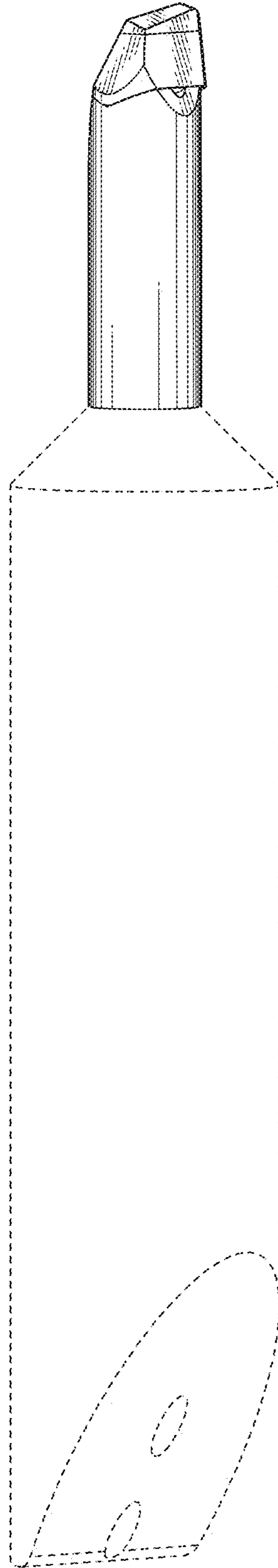

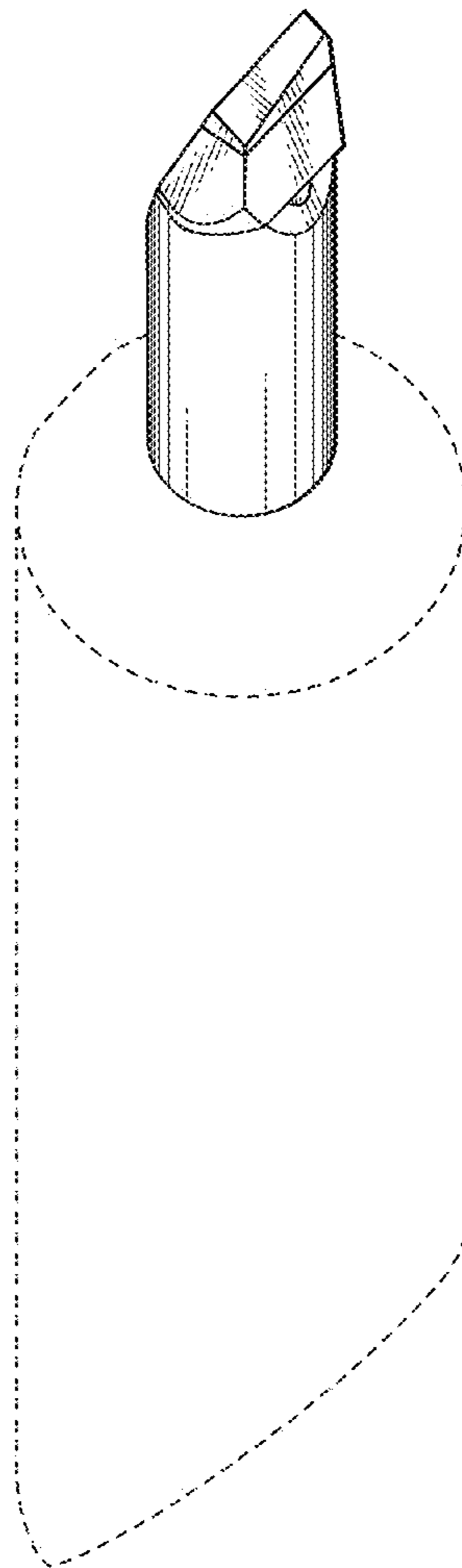

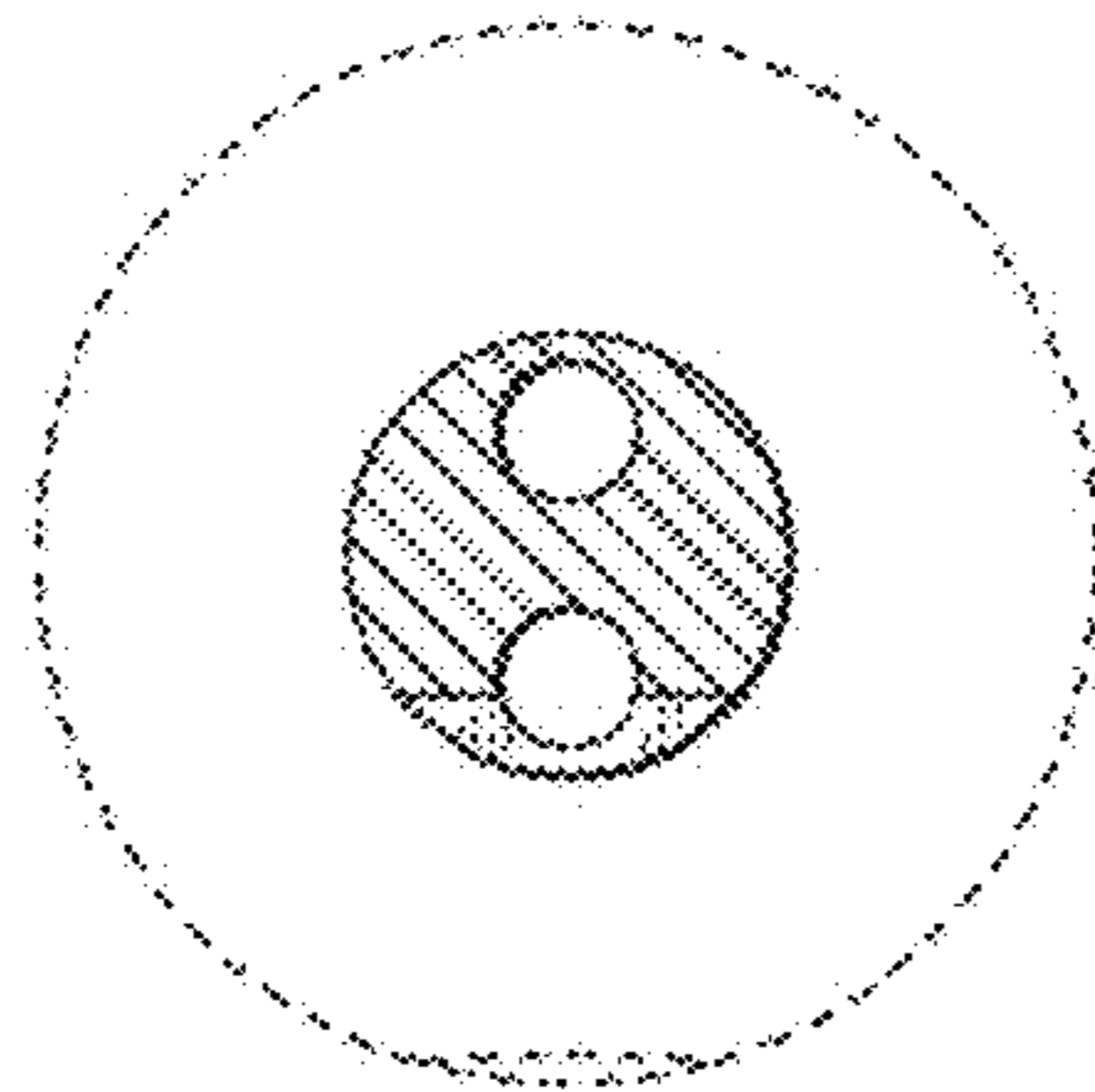
