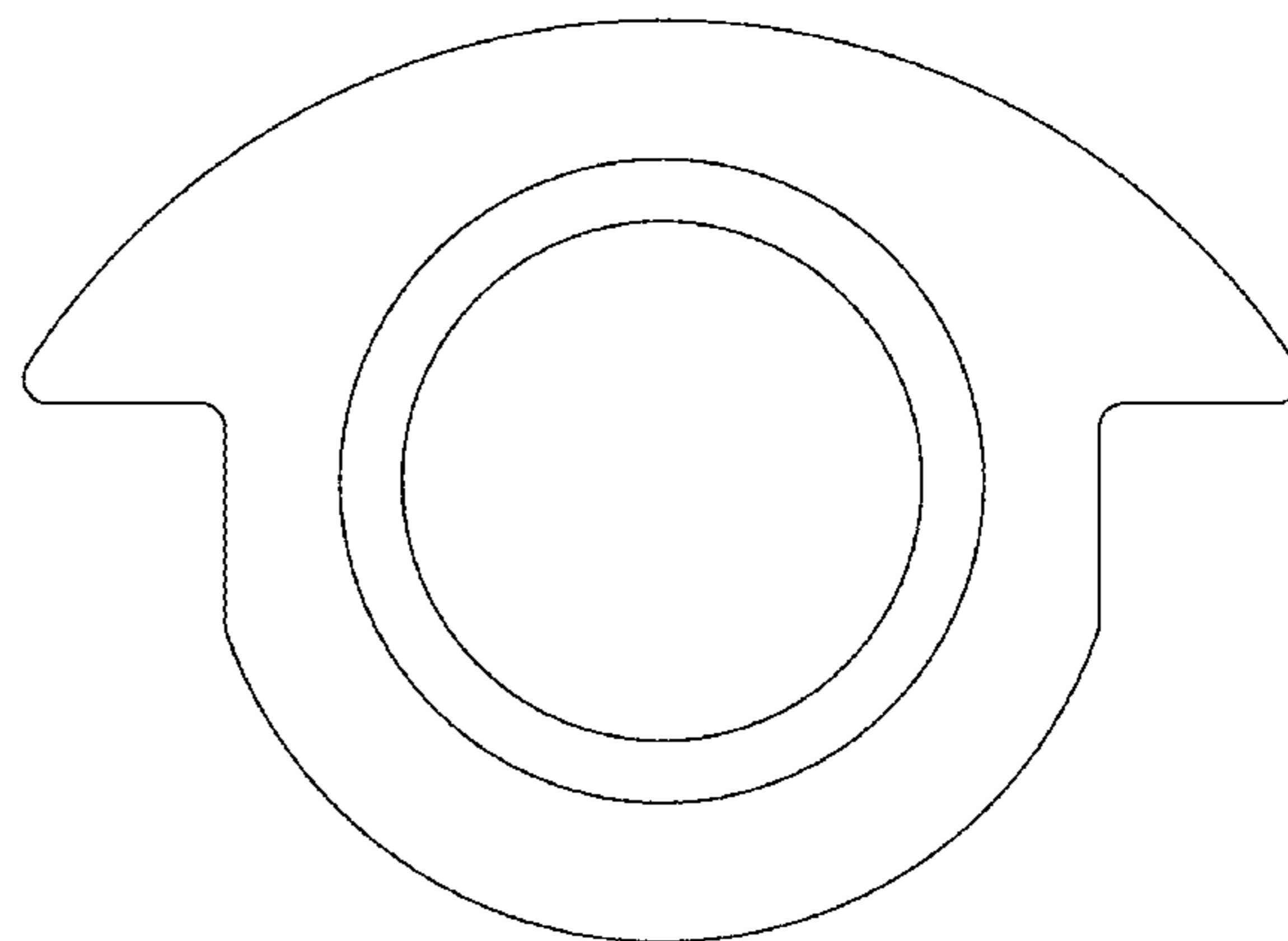
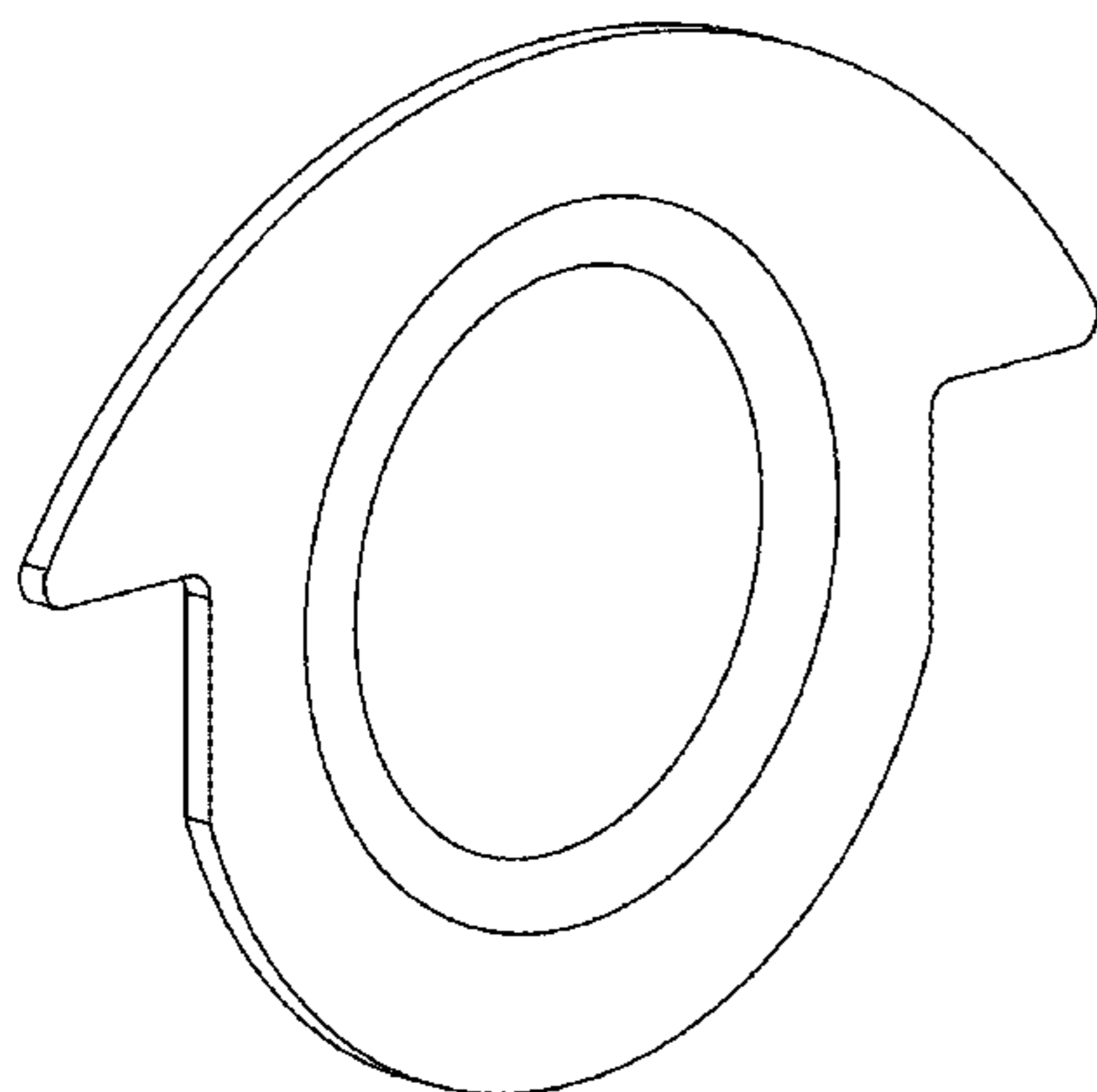
(57) **CLAIM**

I claim the ornamental design for a pipe joint replacement seal with annular reinforcement ridge, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a pipe joint replacement seal with annular reinforcement ridge showing my new design;
FIG. 2 is a front elevation view thereof, the rear view being a mirror image thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof; and,
FIG. 5 is a left side elevation view thereof, the right side view being a mirror image thereof.
The annular reinforcement ridge encircles the central opening of the pipe joint replacement seal.

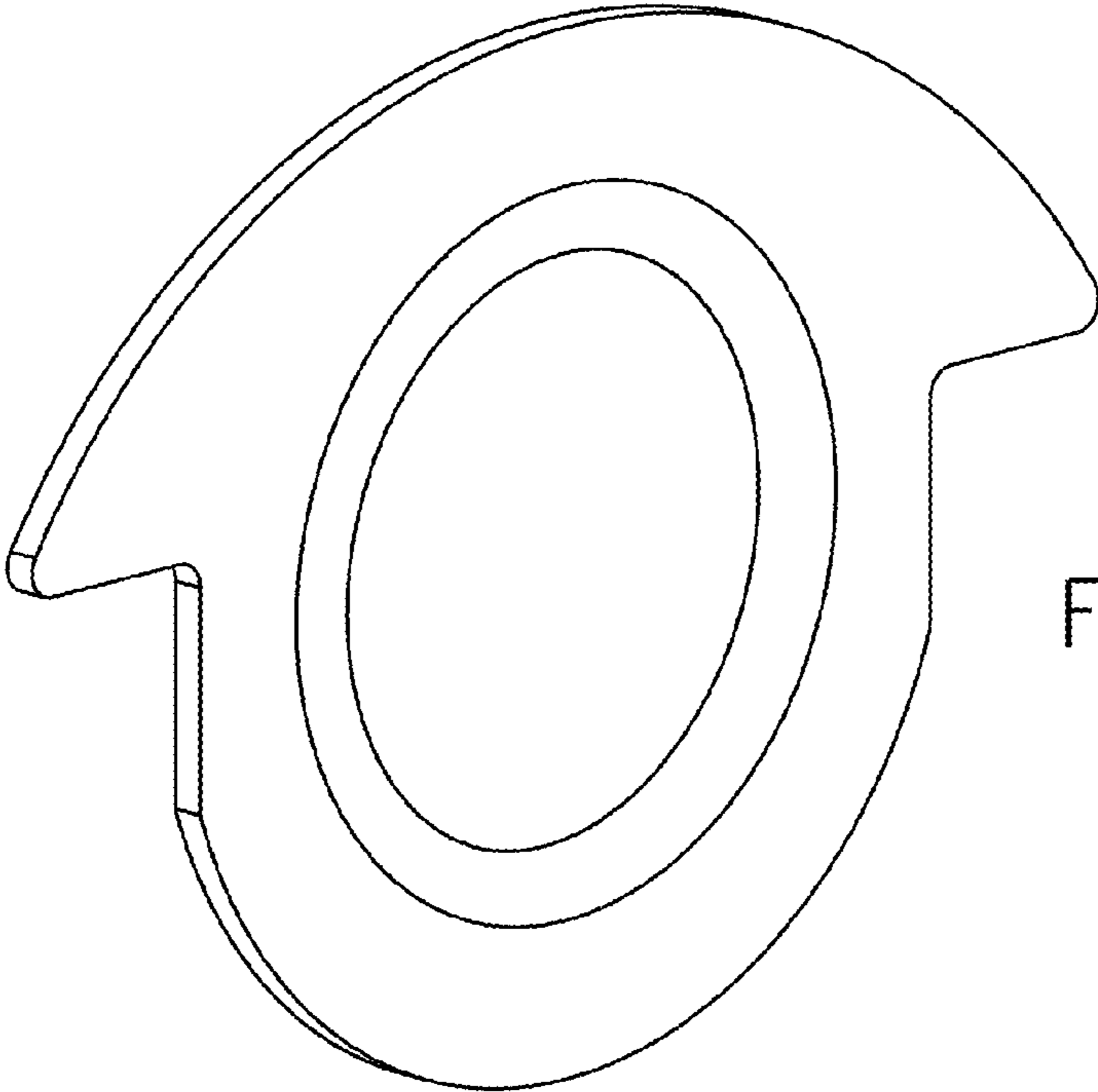

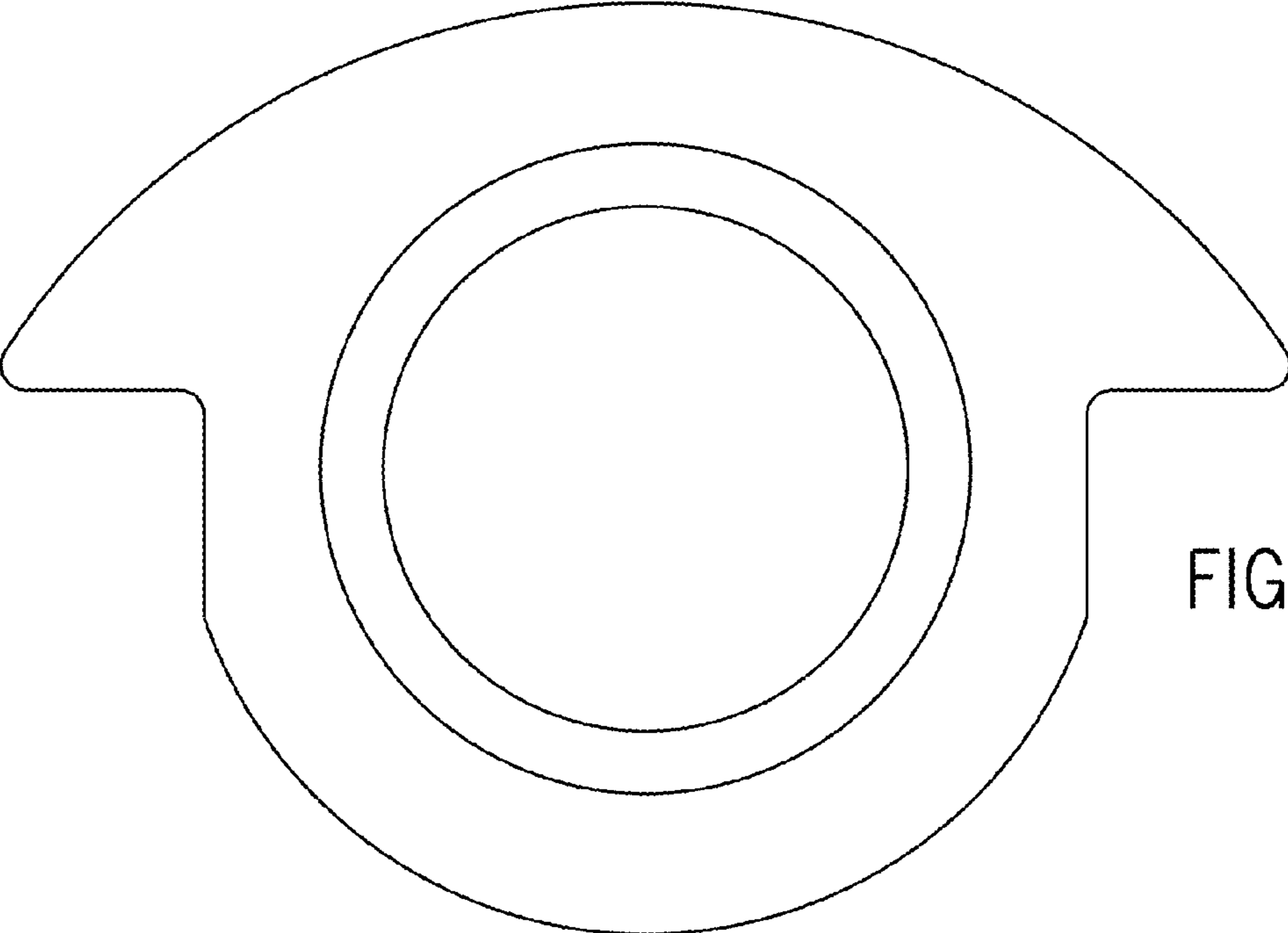

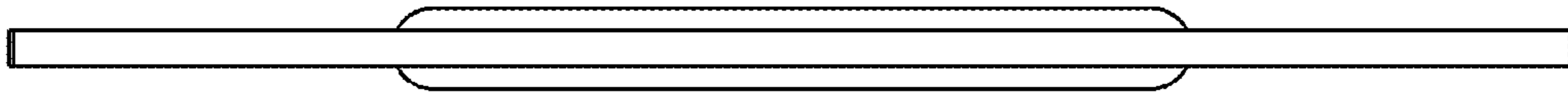

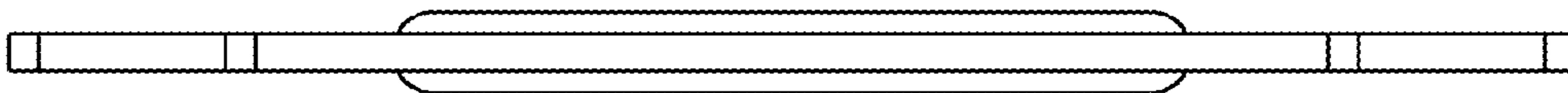

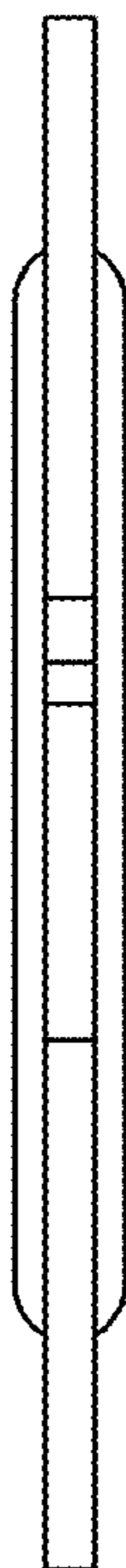
