(57) **CLAIM**

The ornamental design for a helmet-mounted light, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the helmet-mounted light; FIG. 2 is a top plan view thereof; FIG. 3 is a right-side elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a front, bottom perspective view thereof; and, FIG. 8 is a reference view showing the helmet-mounted light attached to a helmet.

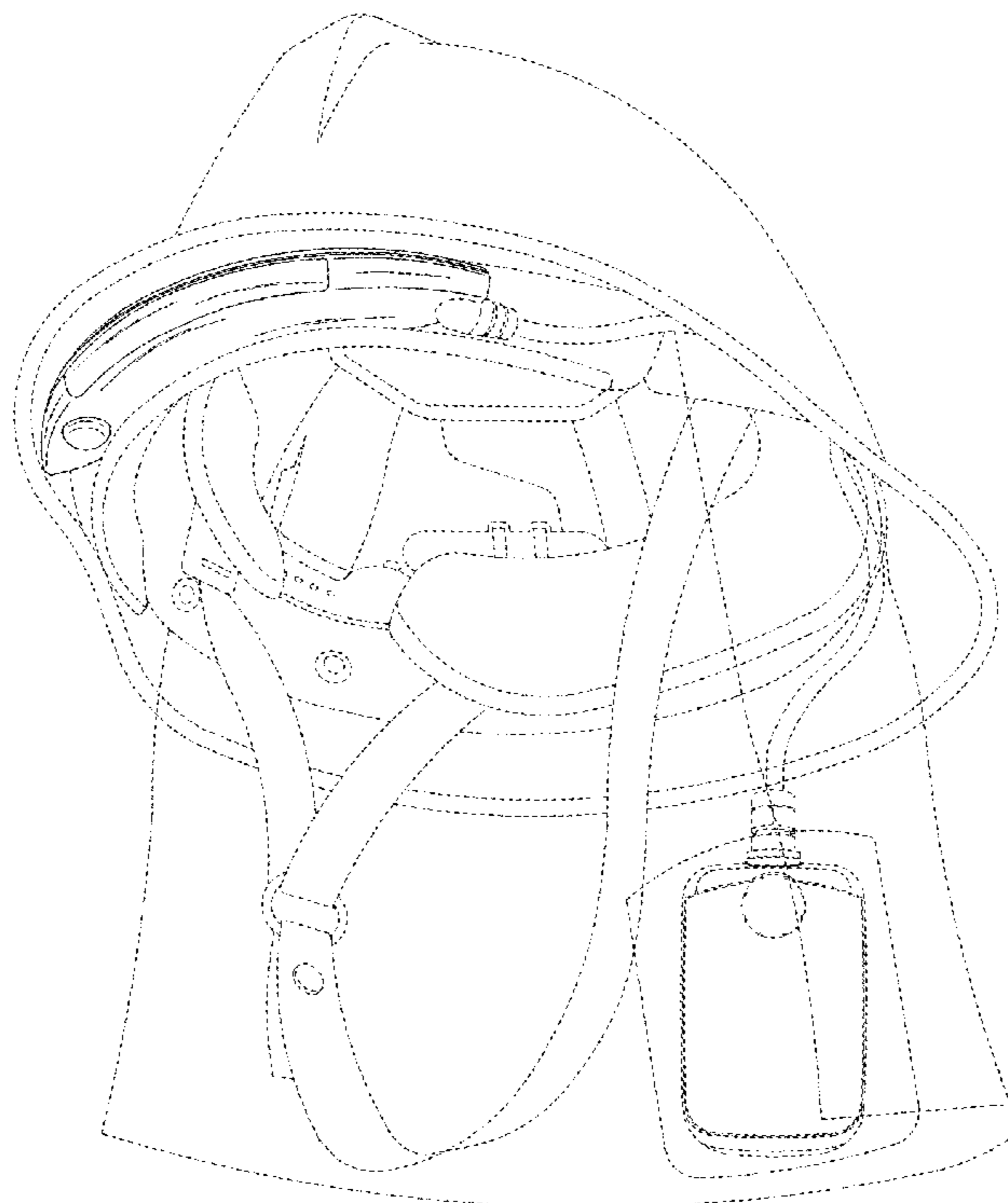

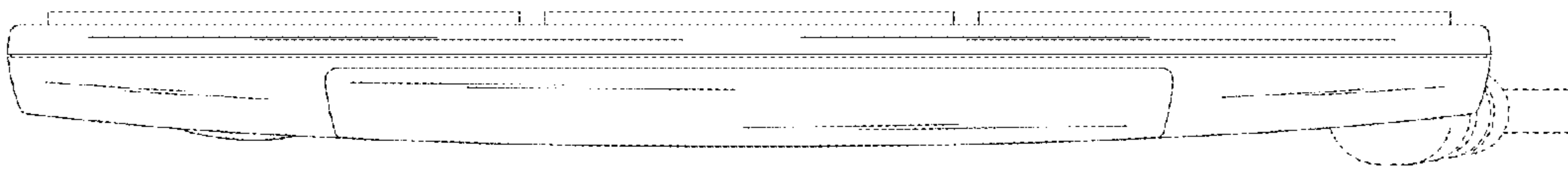

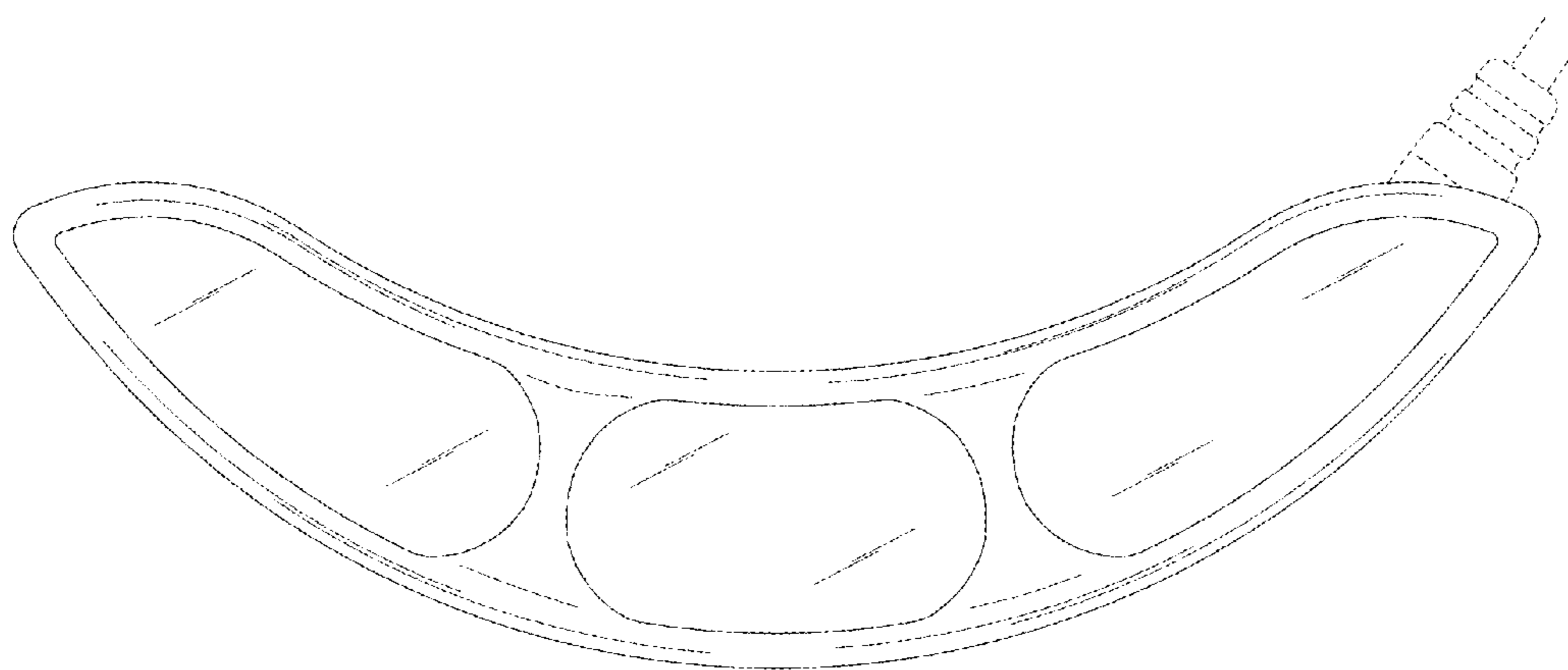

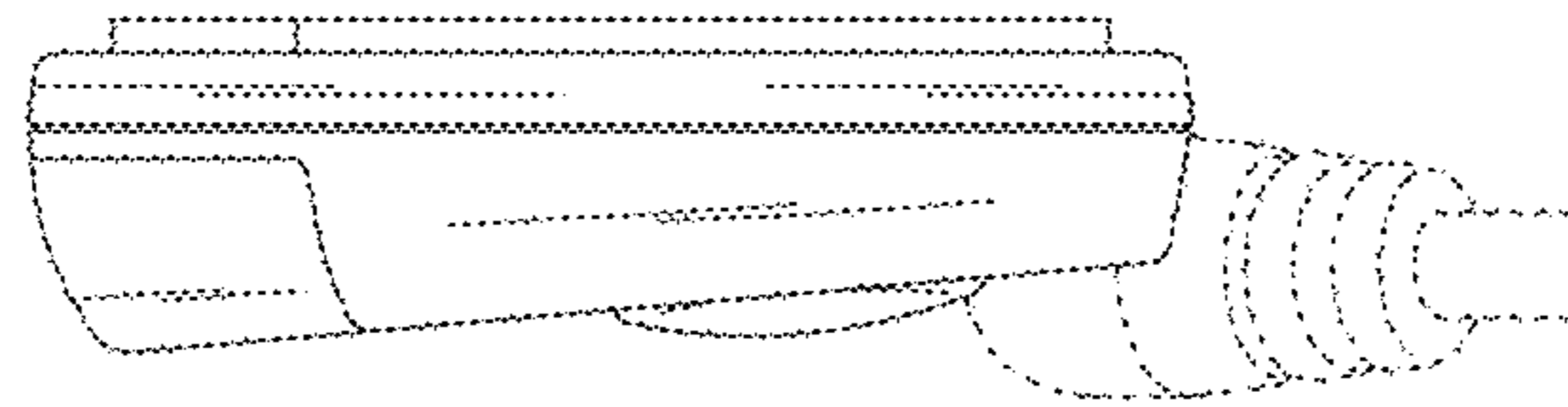

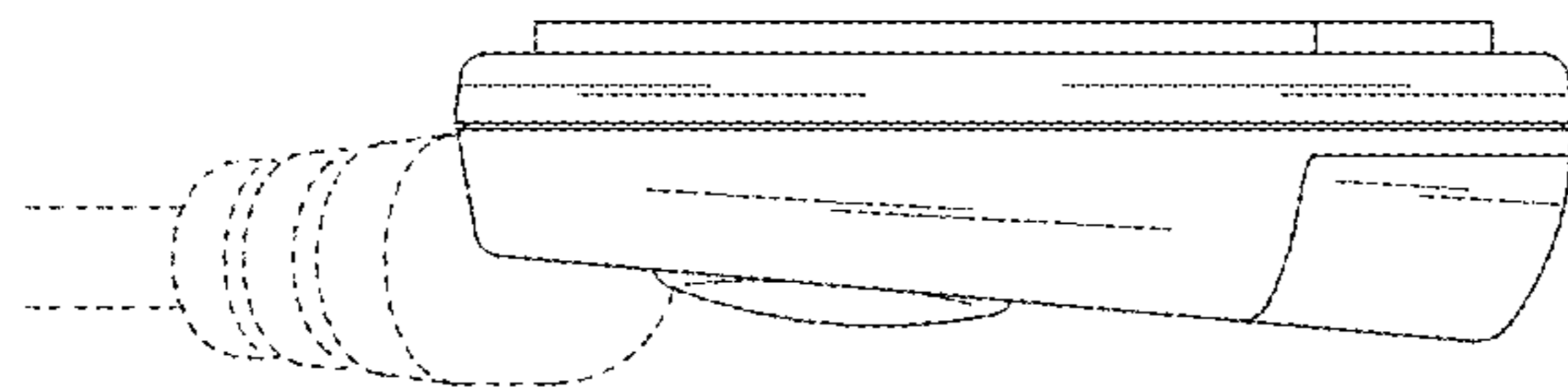

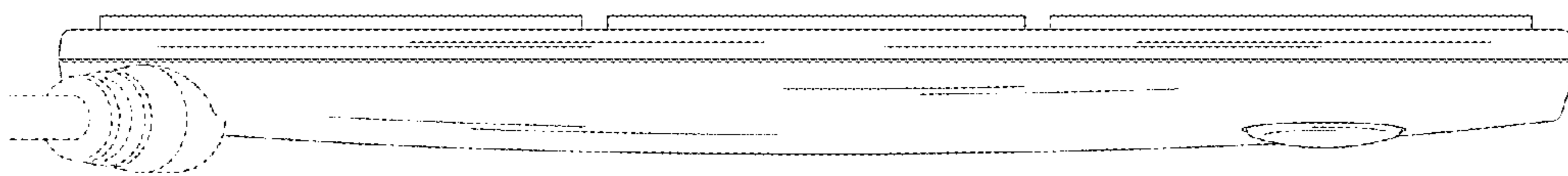

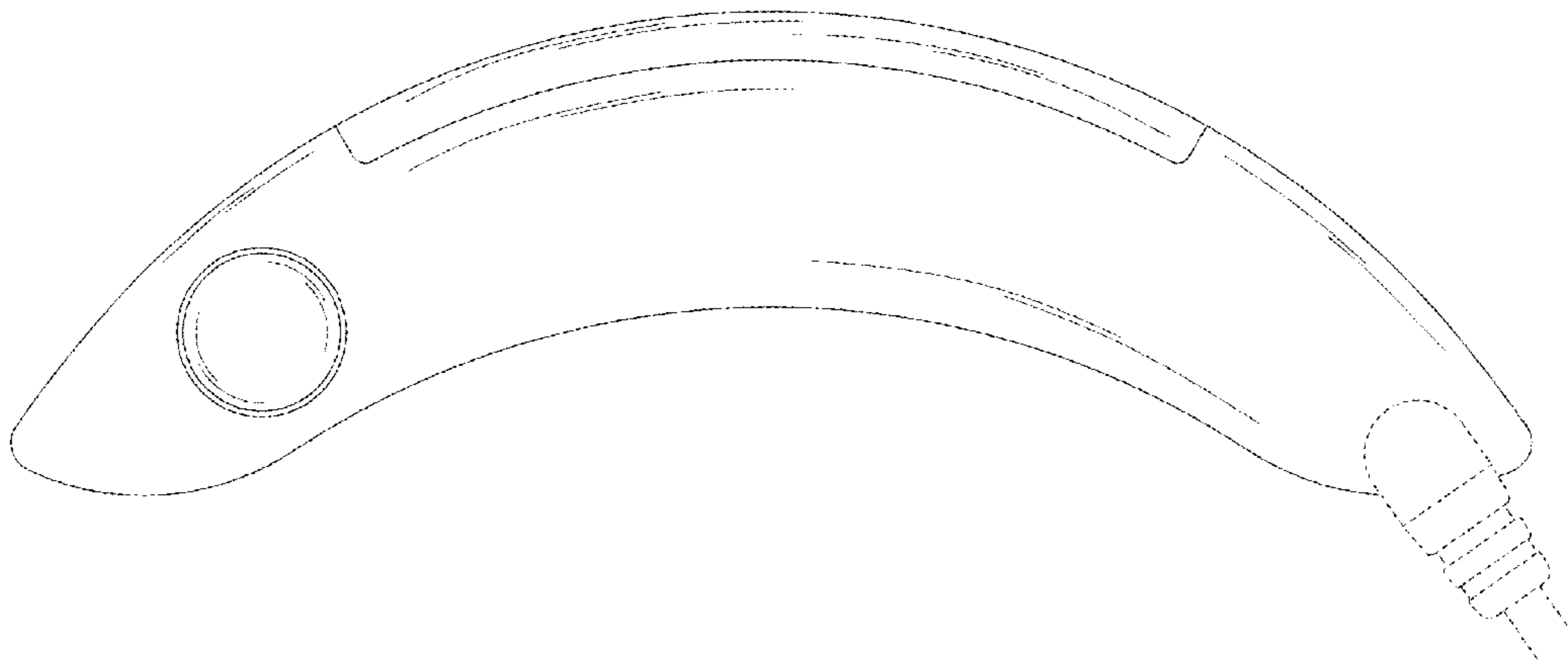

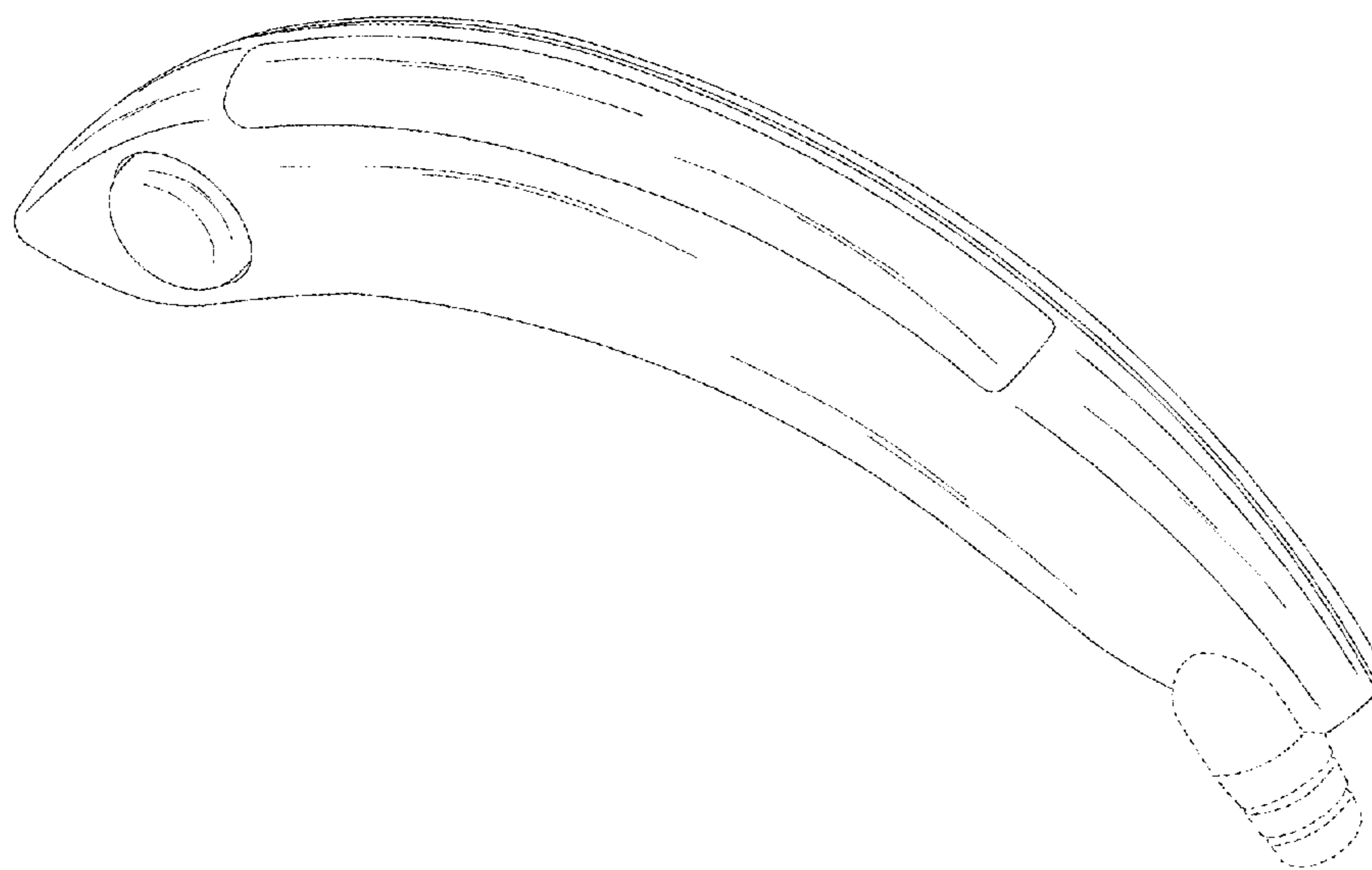
