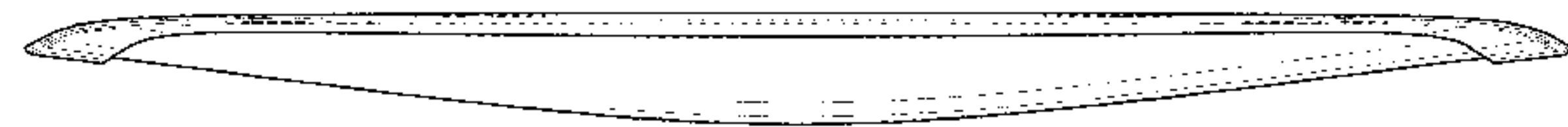
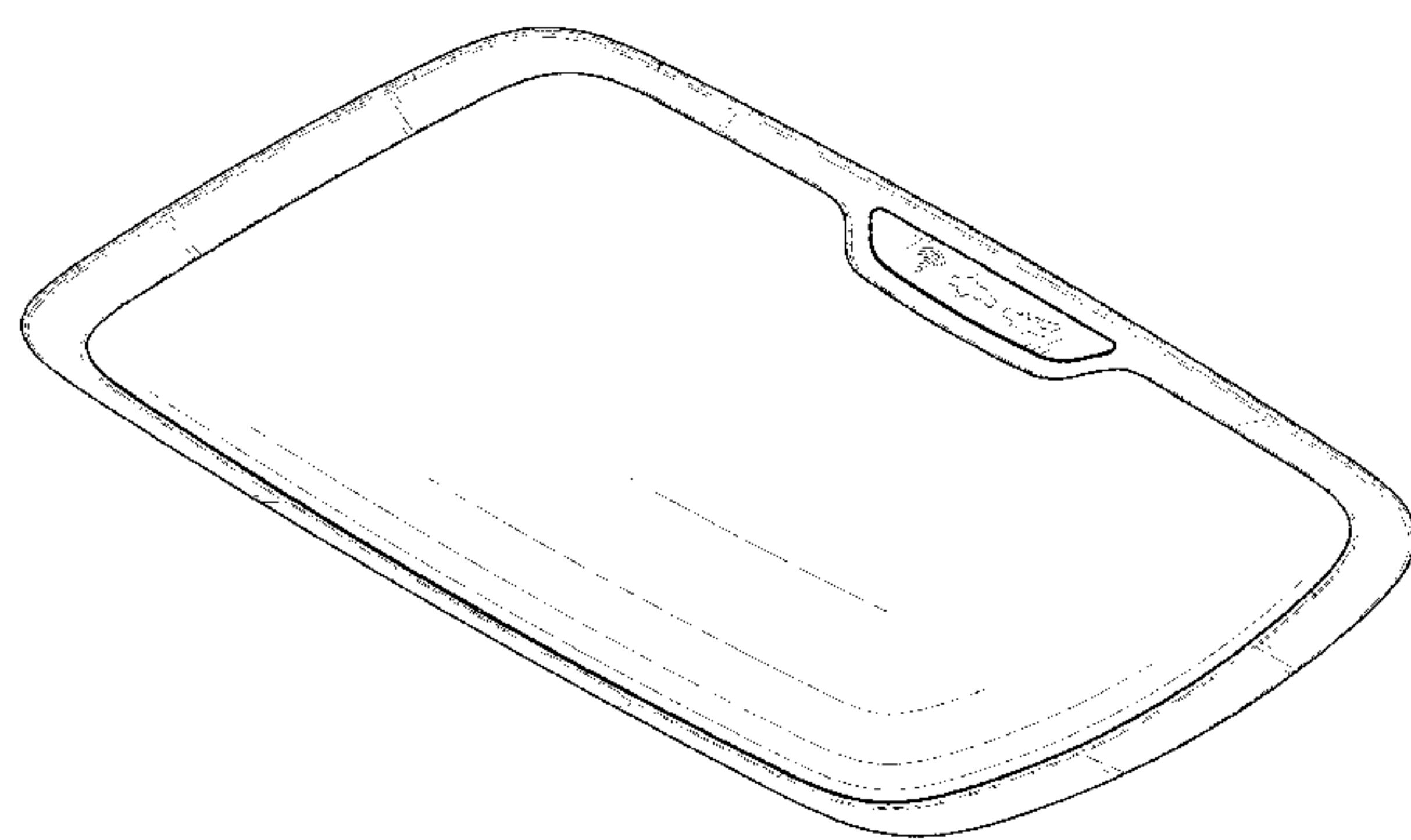
(57) **CLAIM**

The ornamental design for a light cover, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the light cover;
FIG. 2 is a front elevation view of the present invention shown in FIG. 1;
FIG. 3 is a rear elevation view of the present invention shown in FIG. 1;
FIG. 4 is a left side elevation view of the present invention shown in FIG. 1, the right side being a mirror image thereof; and,
FIG. 5 is a bottom plan view of the present invention shown in FIG. 1.
The broken lines depicted in FIGS. 1, 2 and 5 illustrate surface environment of the light cover that forms no part of the claimed design.

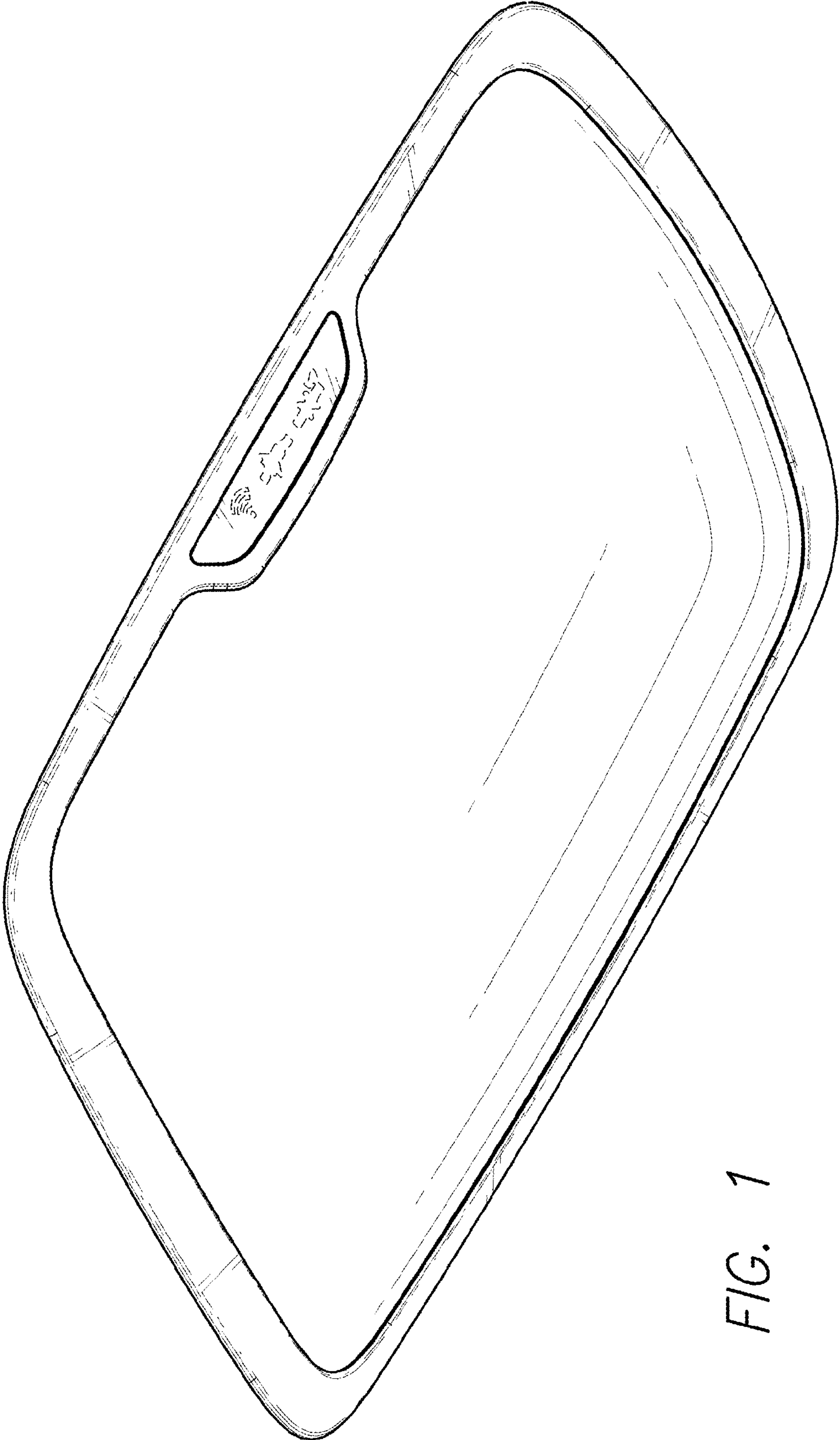

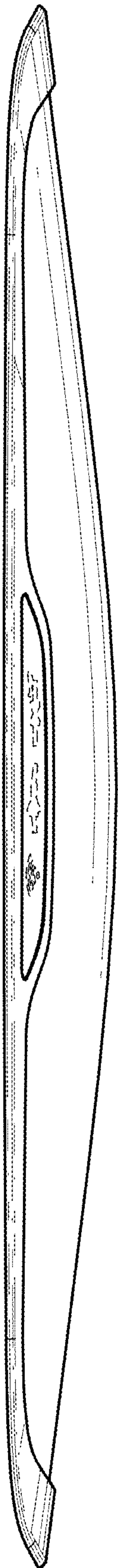

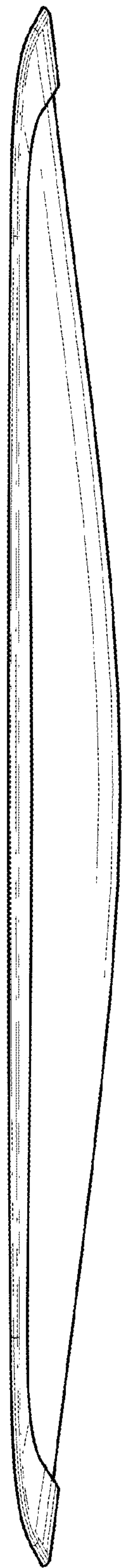

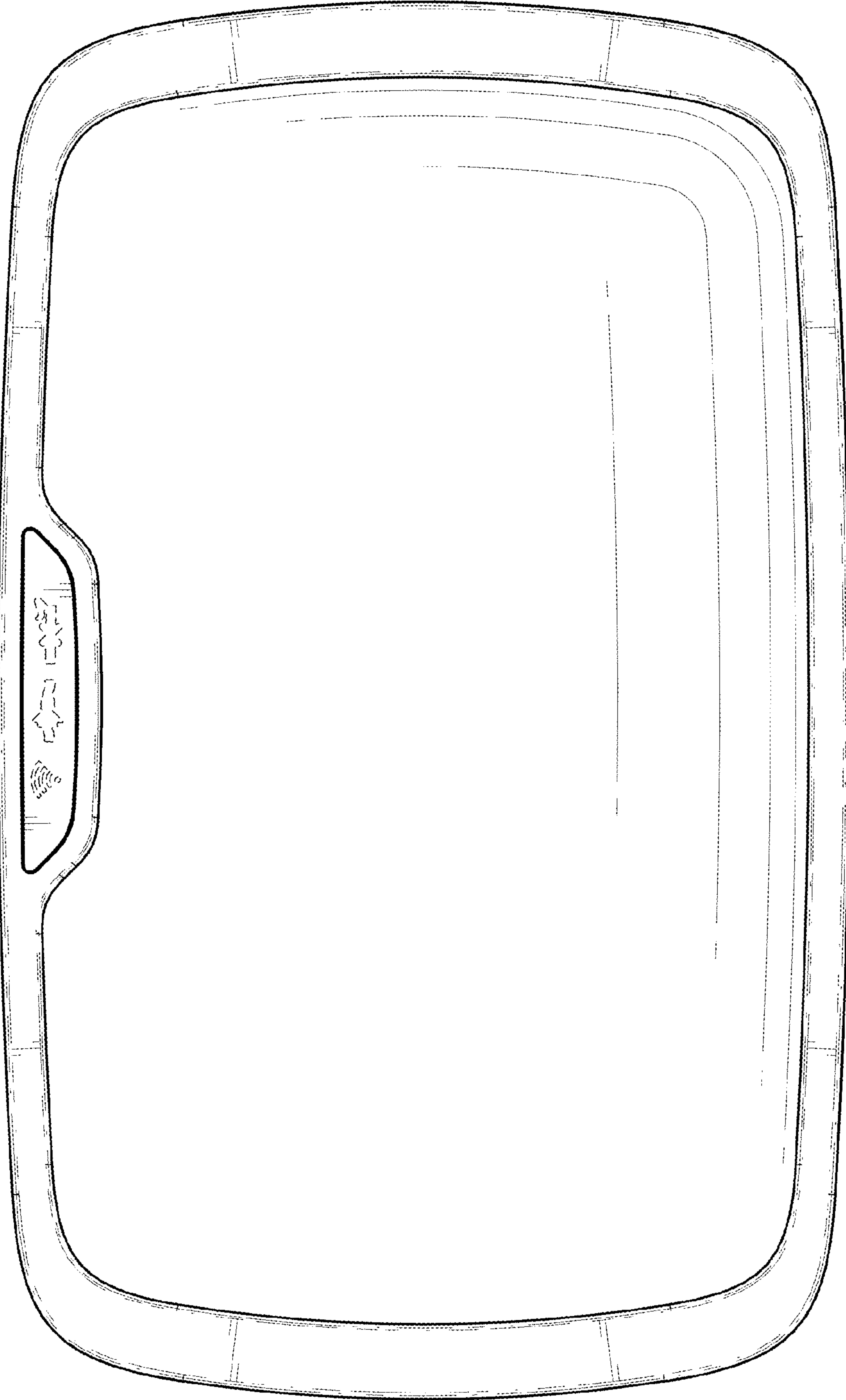
