DESCRIPTION

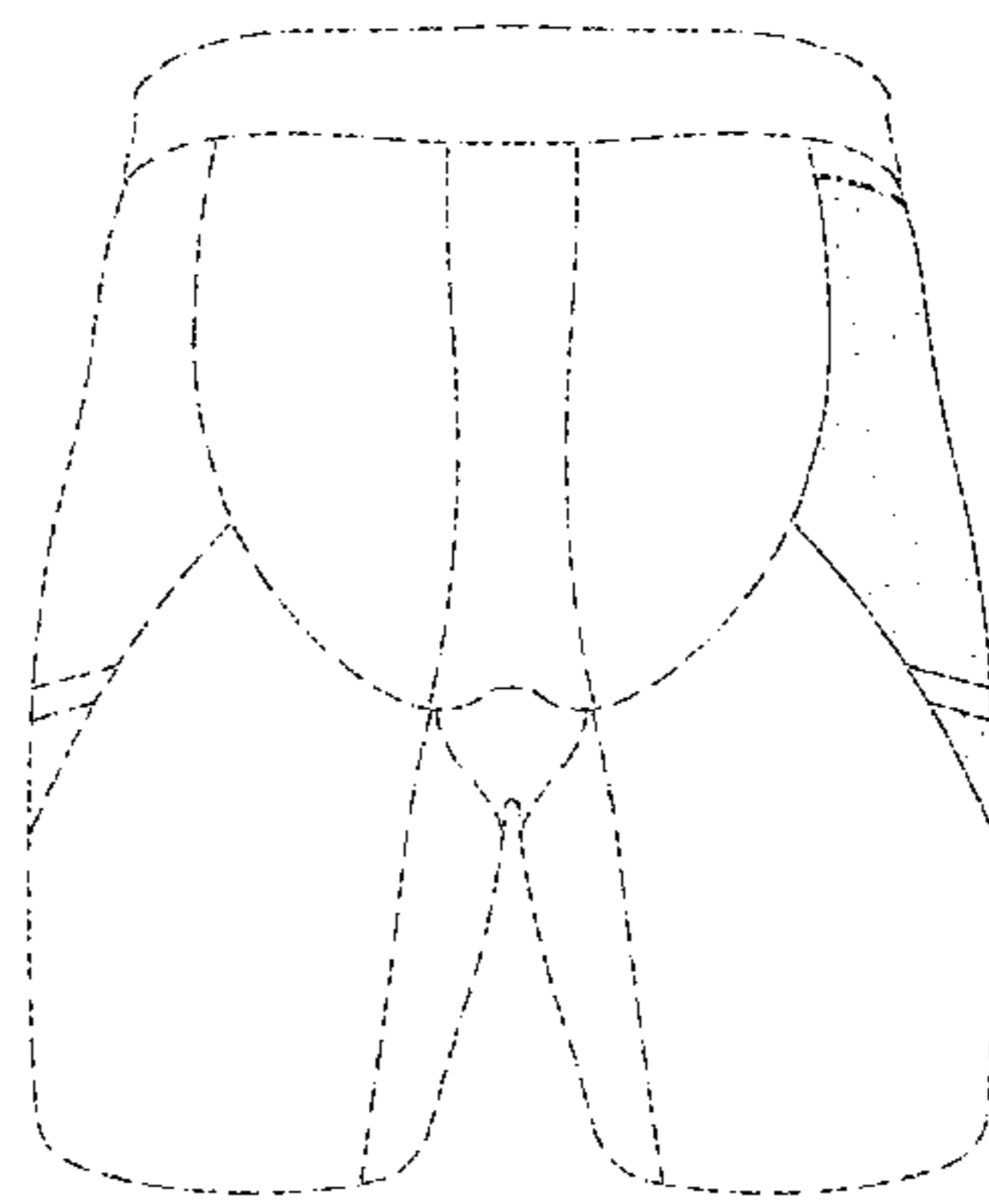
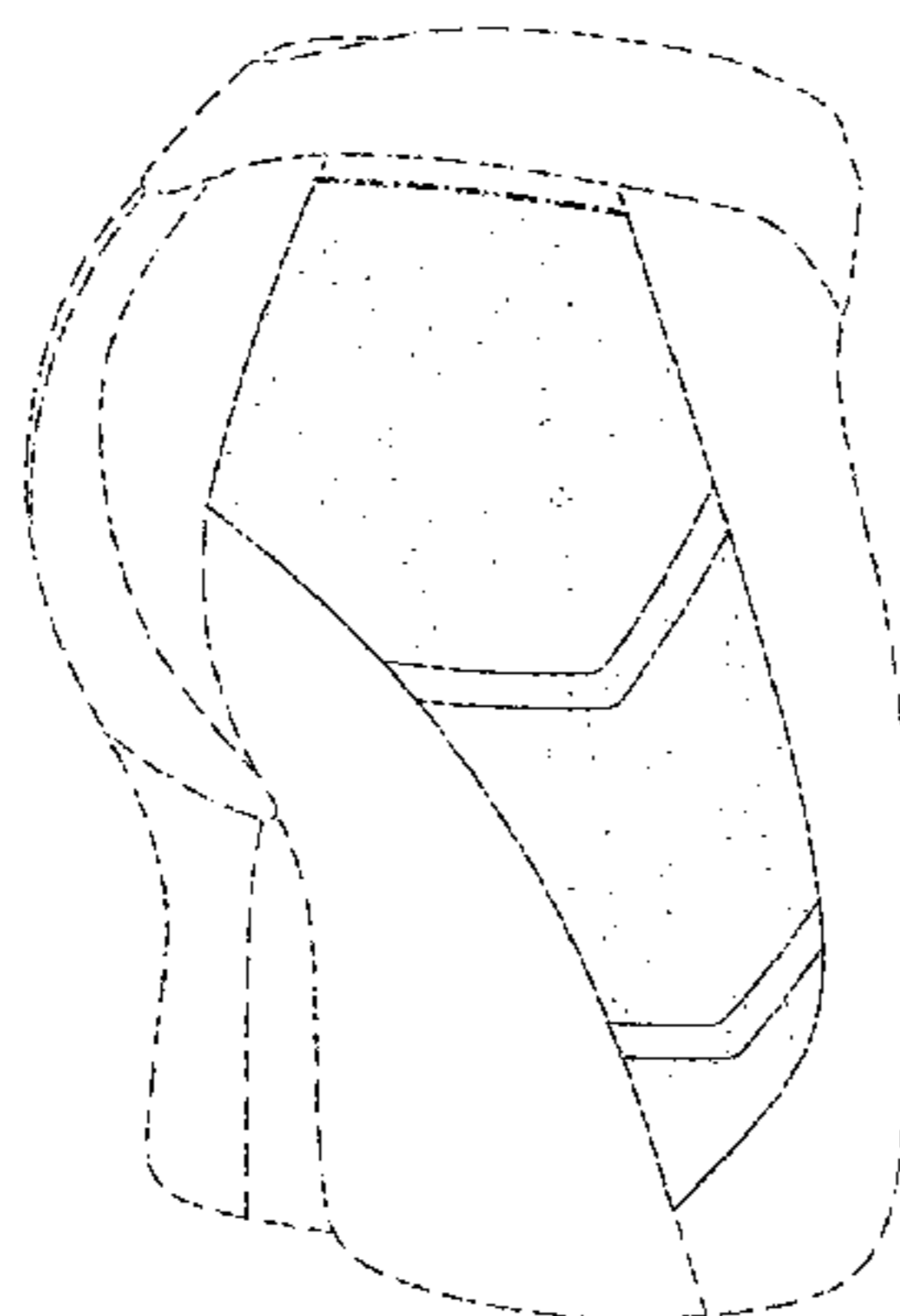
FIG. 1 is a back, right perspective view of an exercise short according to the present design;

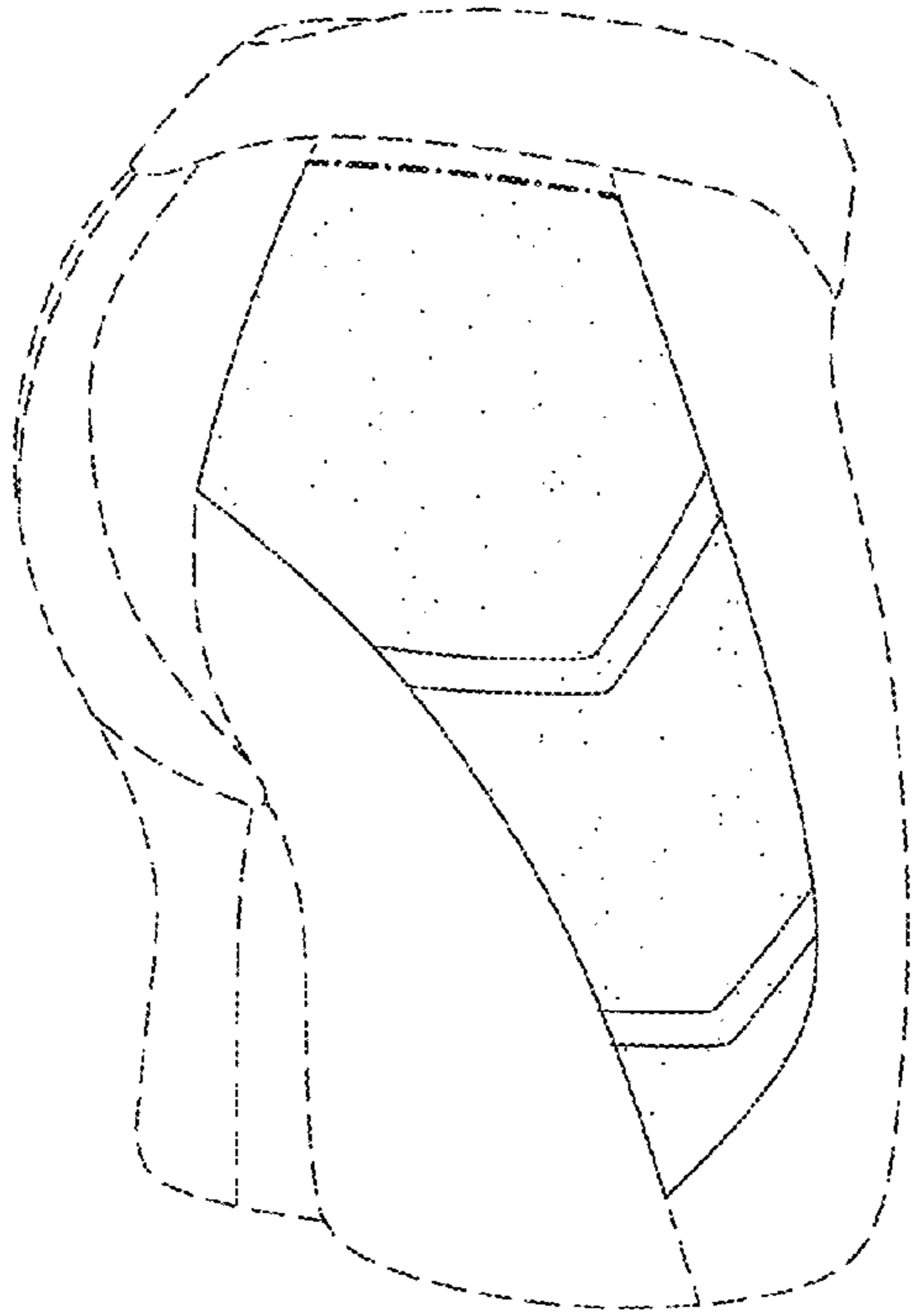

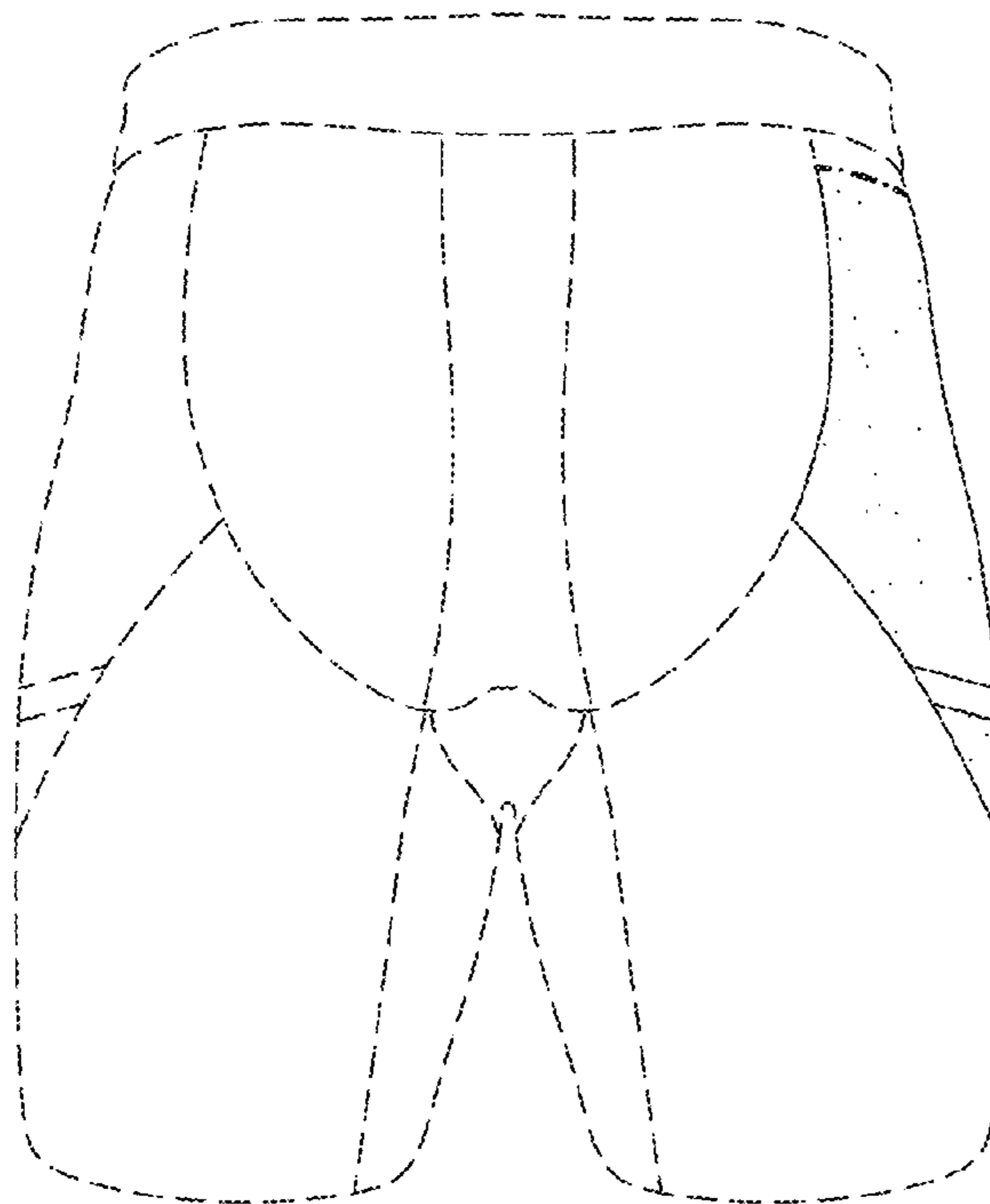

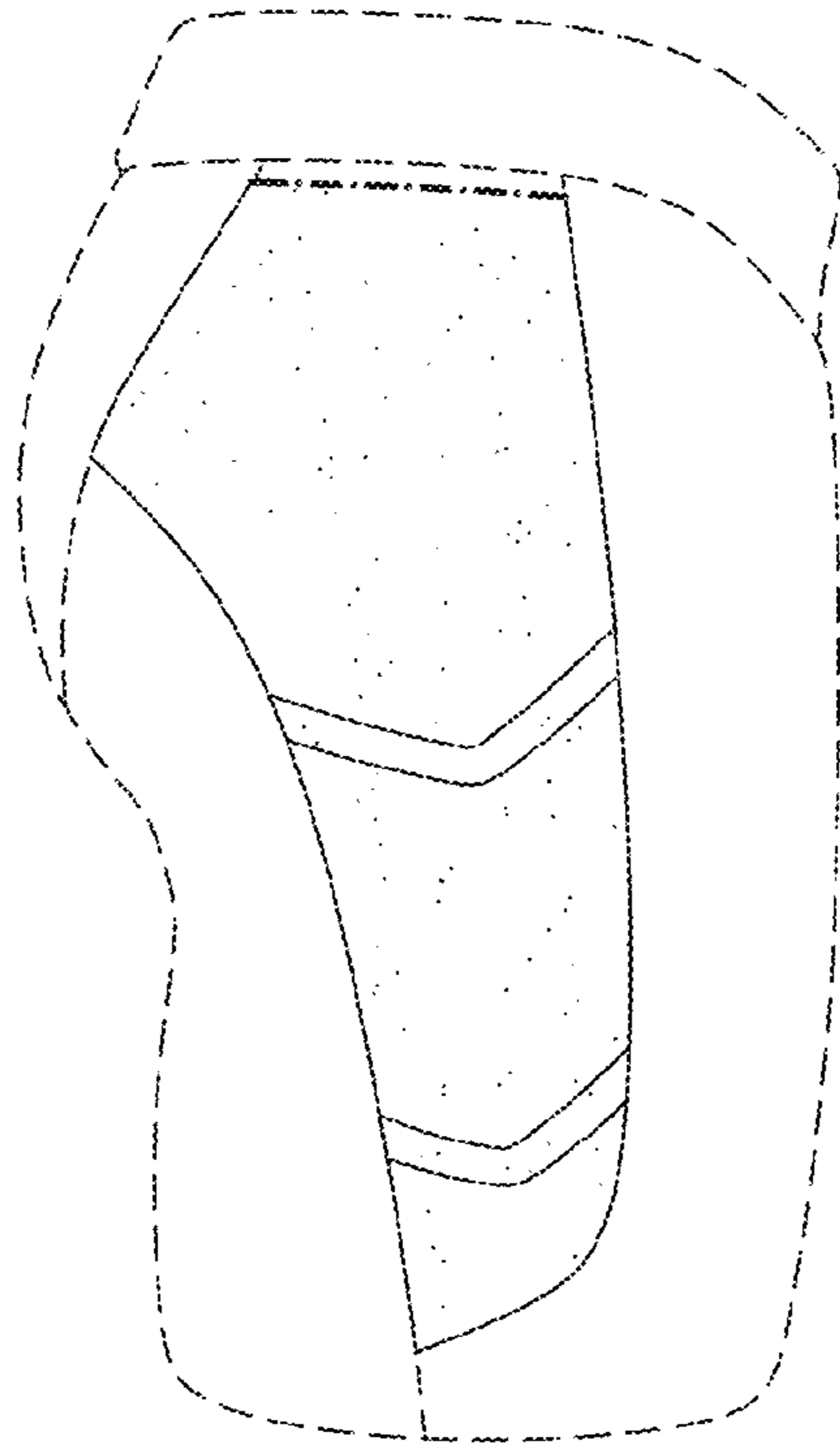

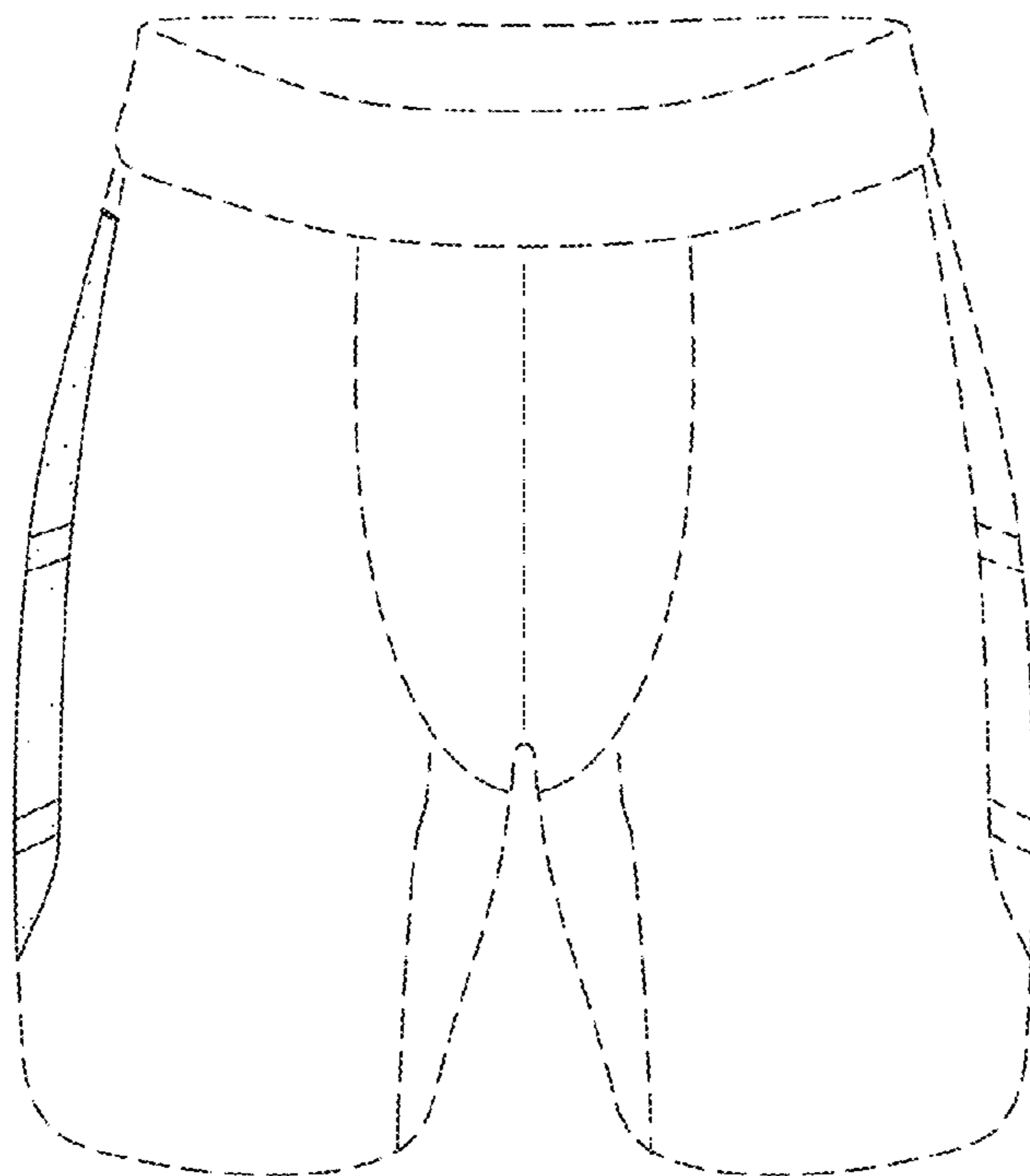
