FIG. 9 is a right side view thereof;

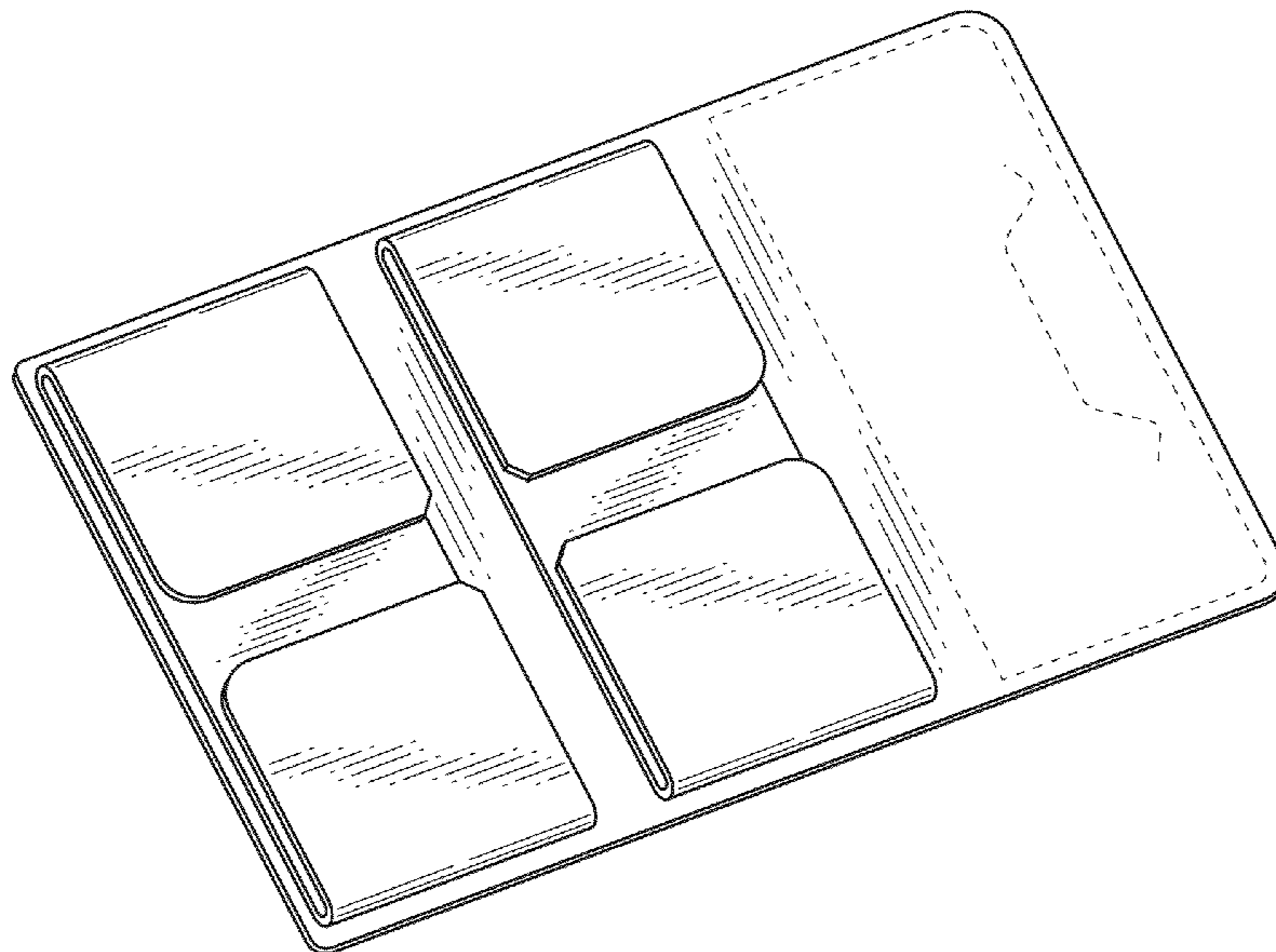
FIG. 10 is a top view thereof;

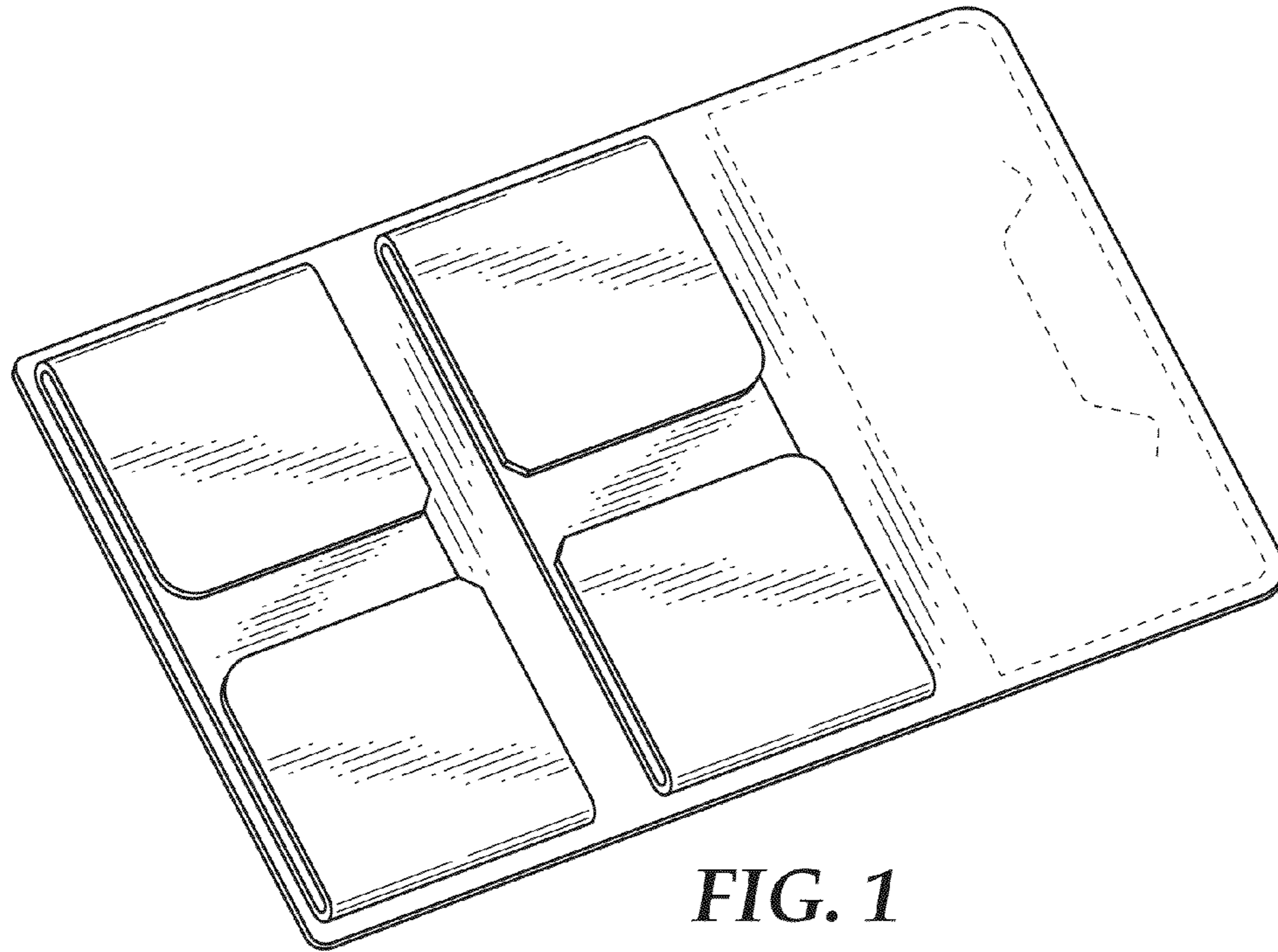

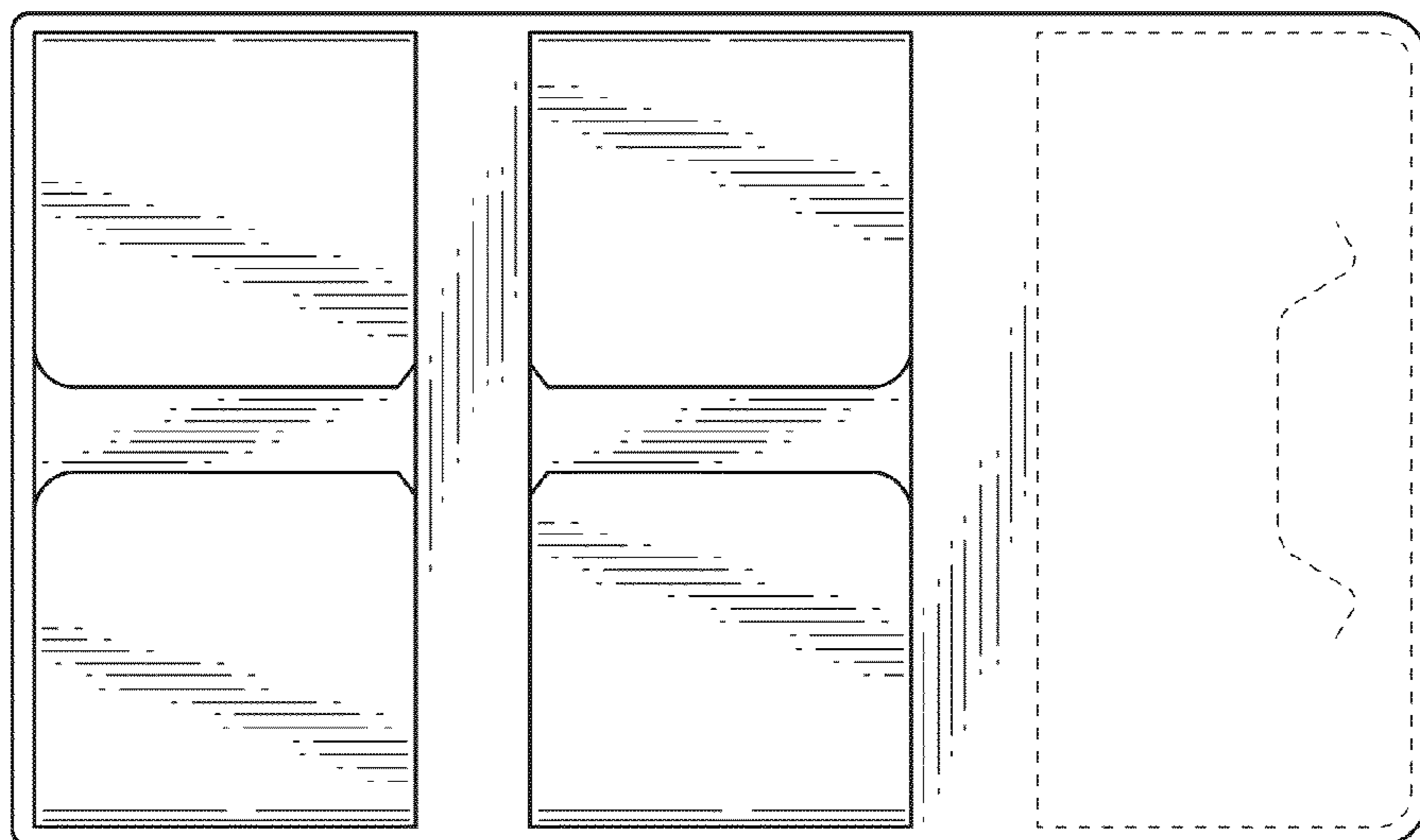

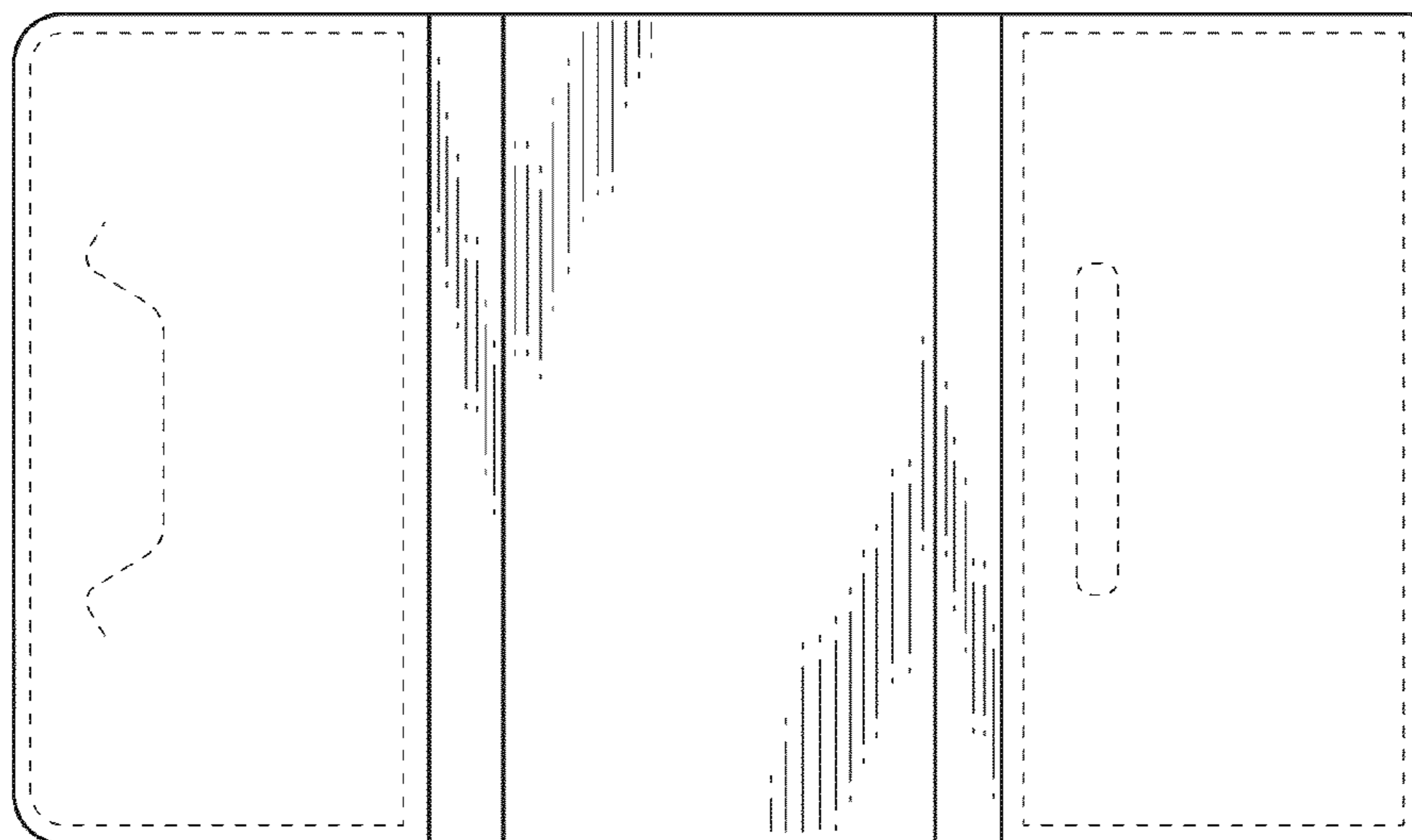

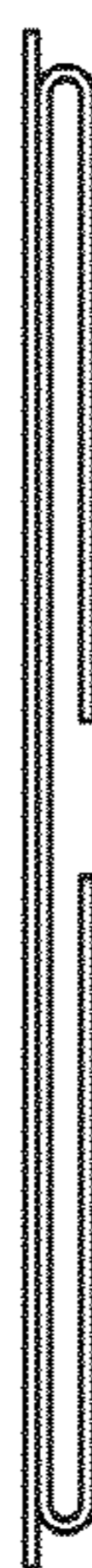

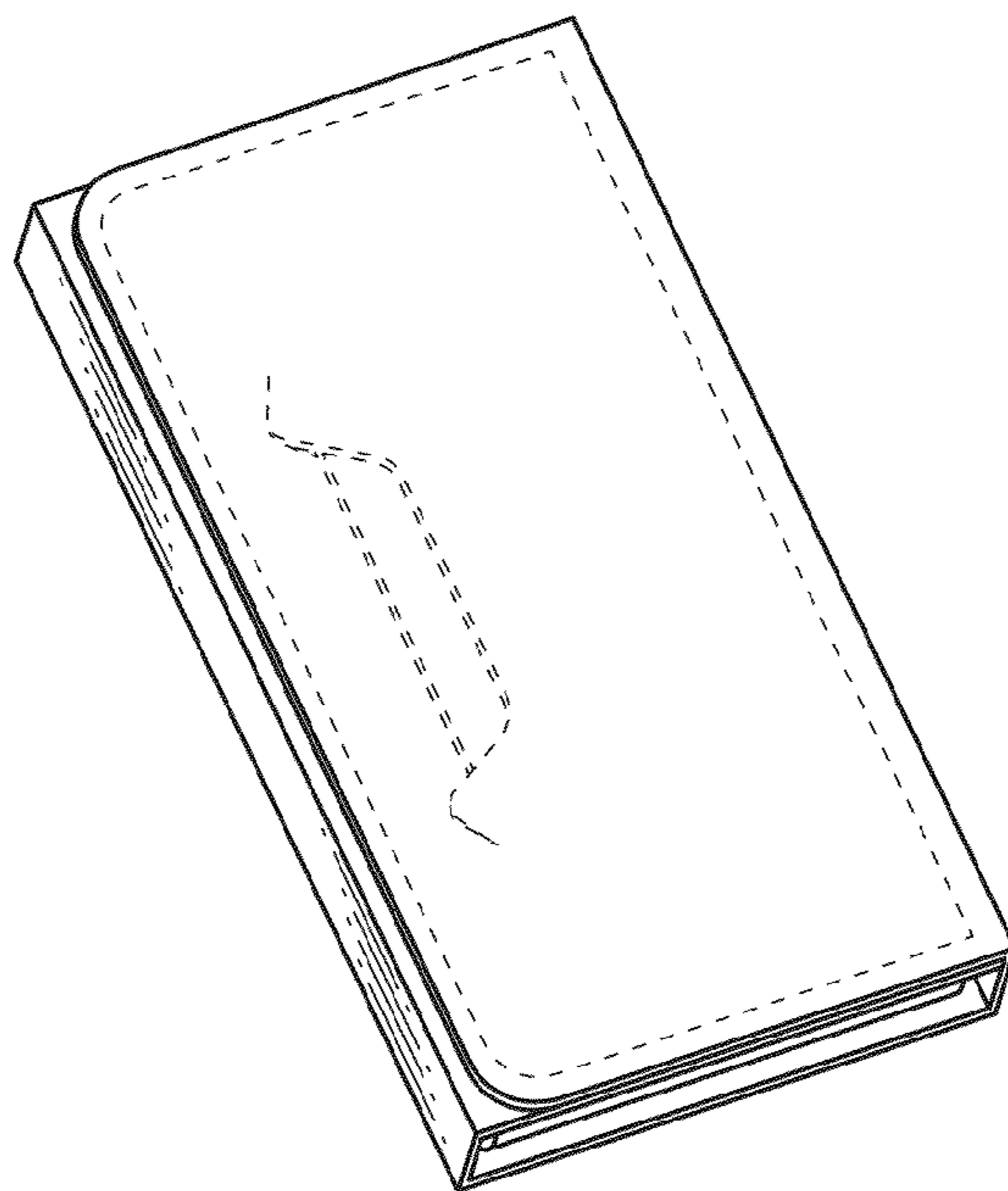

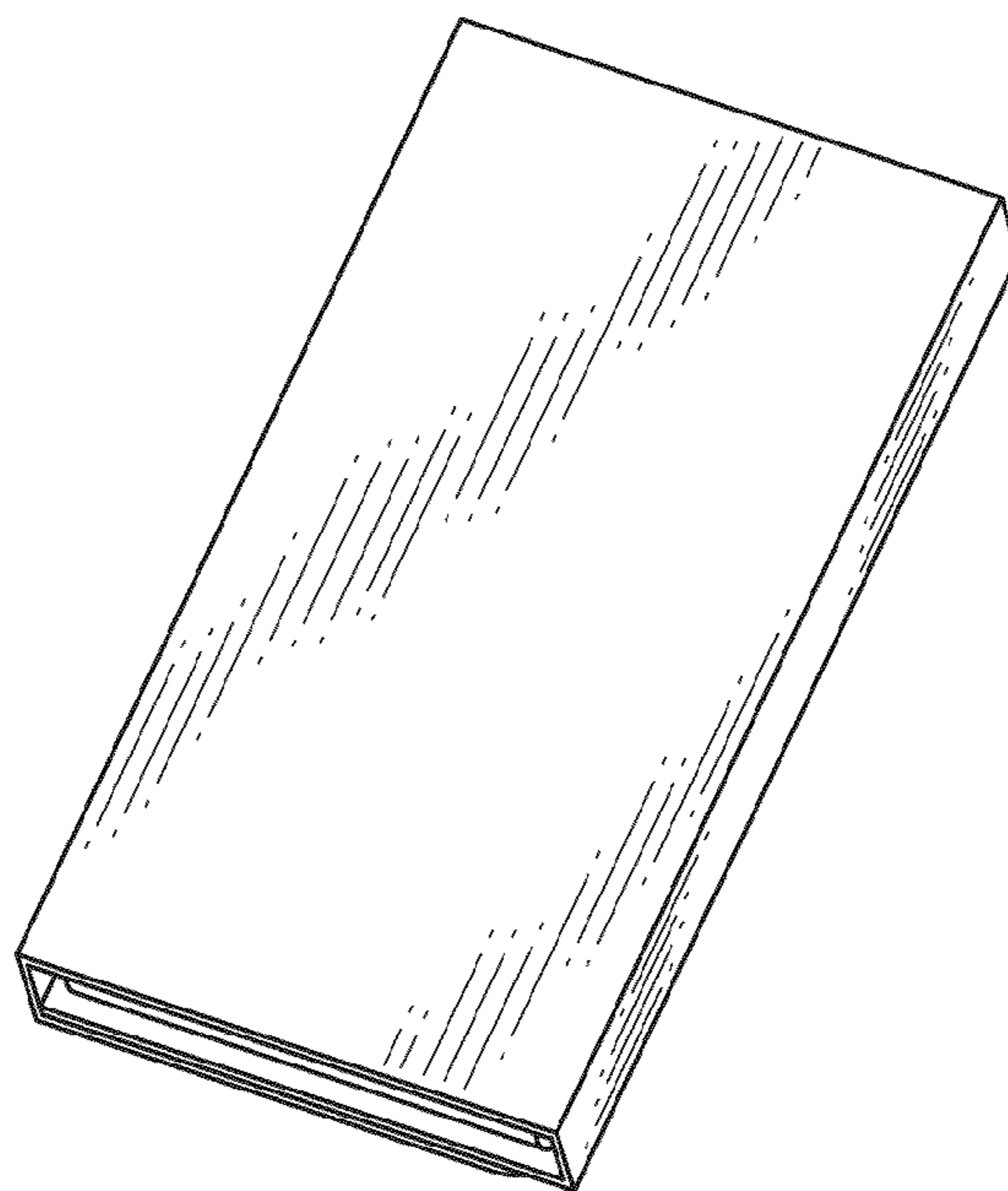

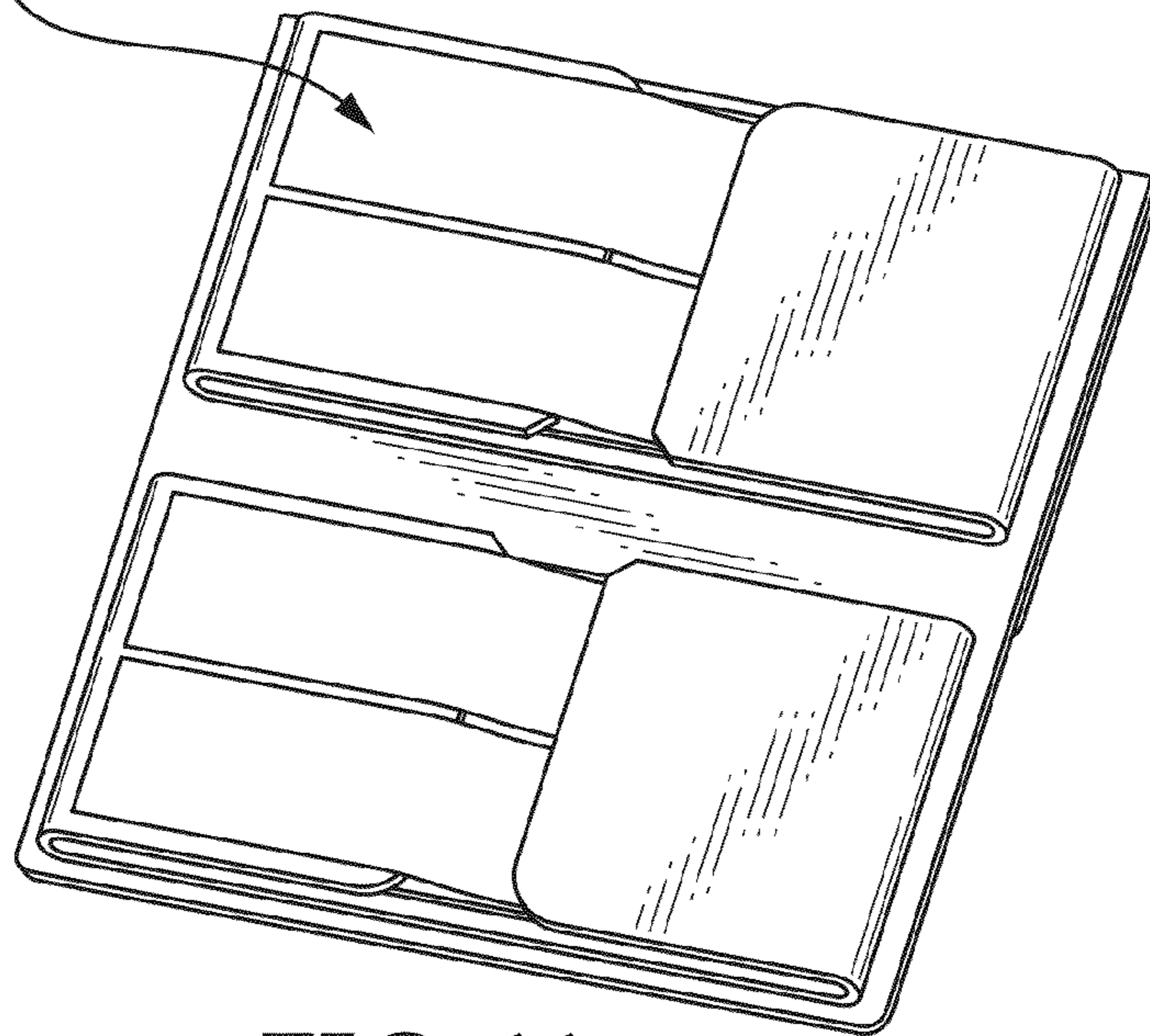

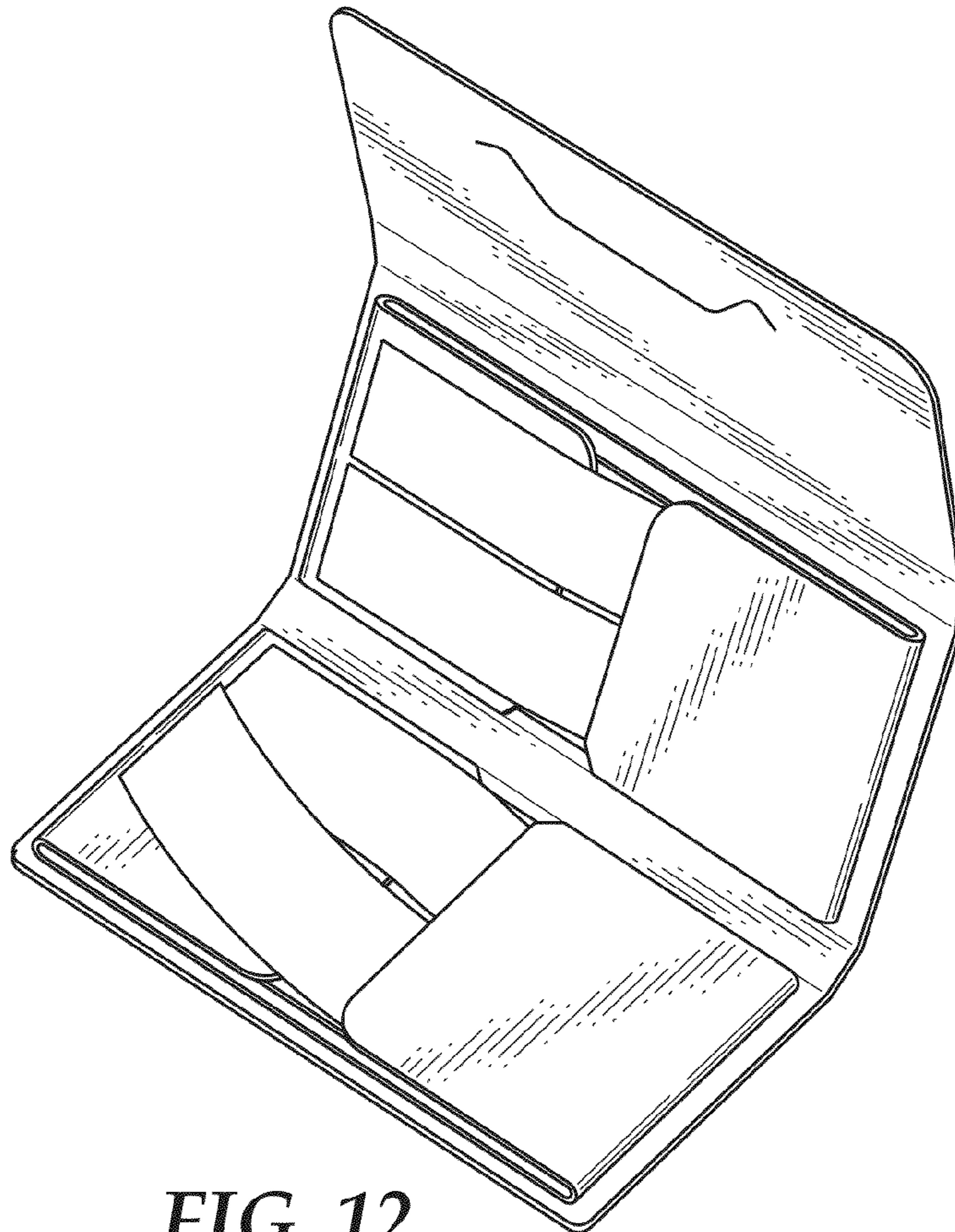
