(57) **CLAIM**

We claim the ornamental design for a bed, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bed according to a first embodiment of the present design;
FIG. 2 is a front view of the bed of FIG. 1, the rear view being a mirror image thereof;
FIG. 3 is a left side view of the bed of FIG. 1, the right side view being a mirror image thereof;
FIG. 4 is a top view of the bed of FIG. 1;
FIG. 5 is a bottom view of the bed of FIG. 1;
FIG. 6 is a perspective view of a bed according to a second embodiment of the present design;
FIG. 7 is a front view of the bed of FIG. 6, the rear view being a mirror image thereof;
FIG. 8 is a left side view of the bed of FIG. 6, the right side view being a mirror image thereof;
FIG. 9 is a top view of the bed of FIG. 6; and,
FIG. 10 is a bottom view of the bed of FIG. 6.

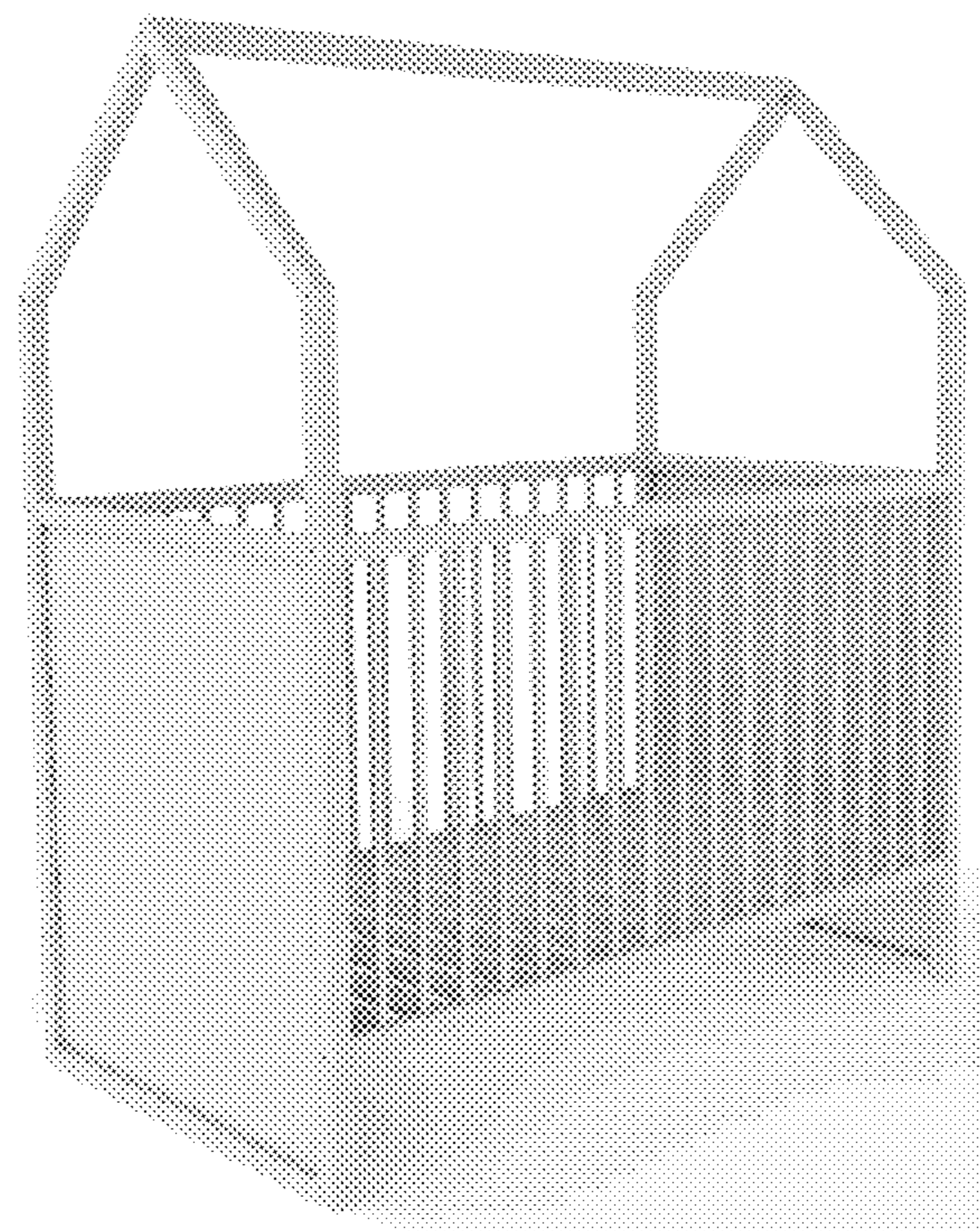

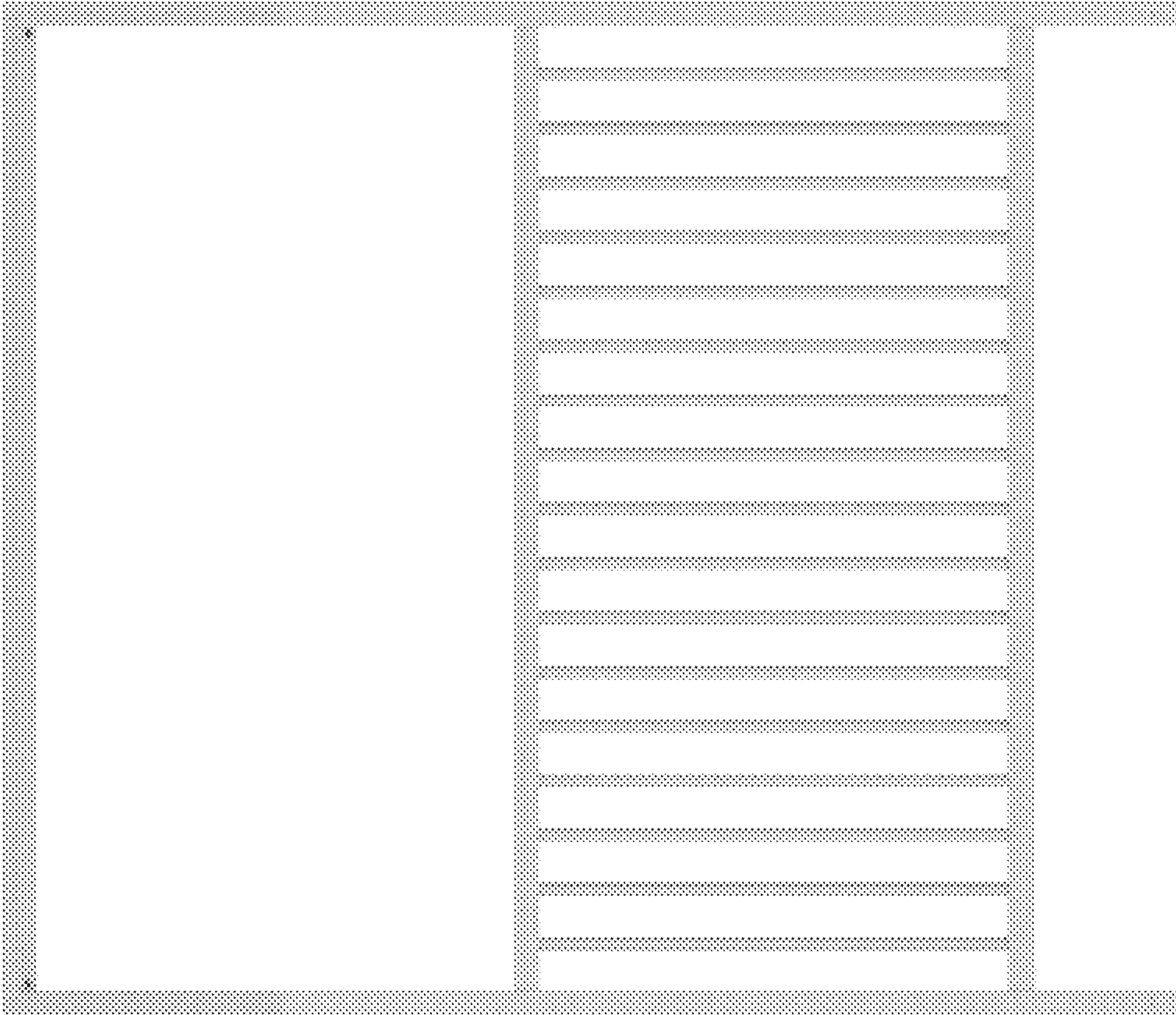

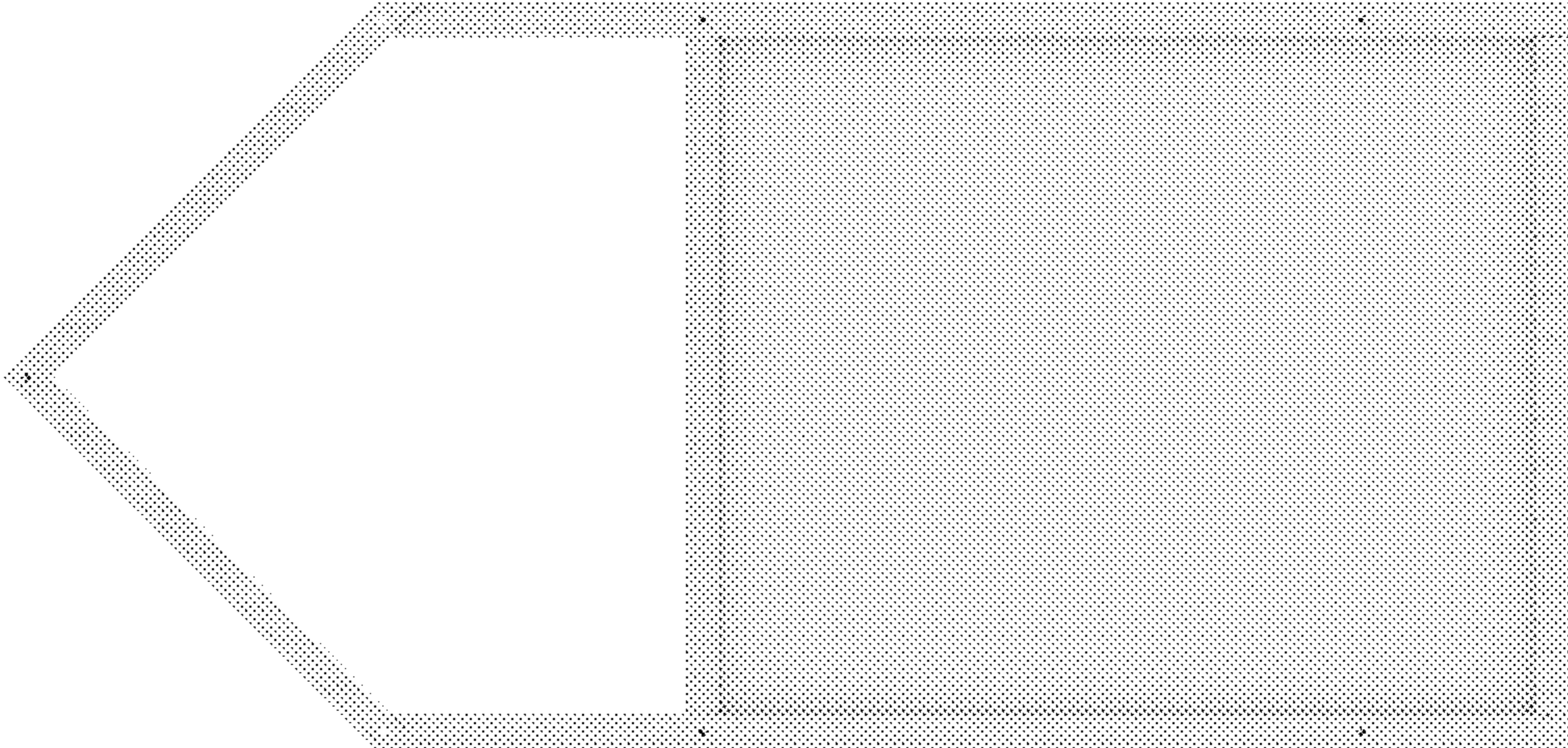

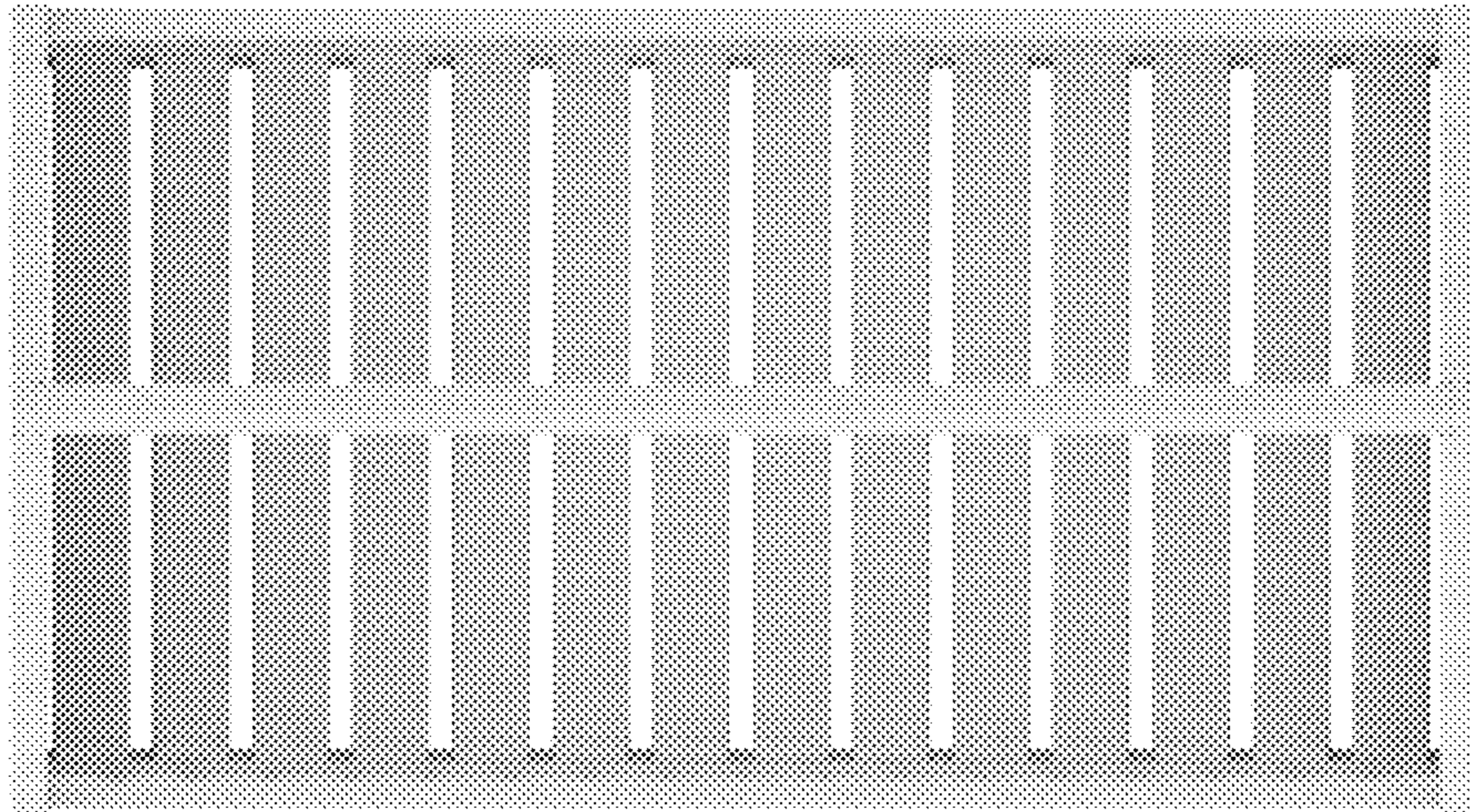

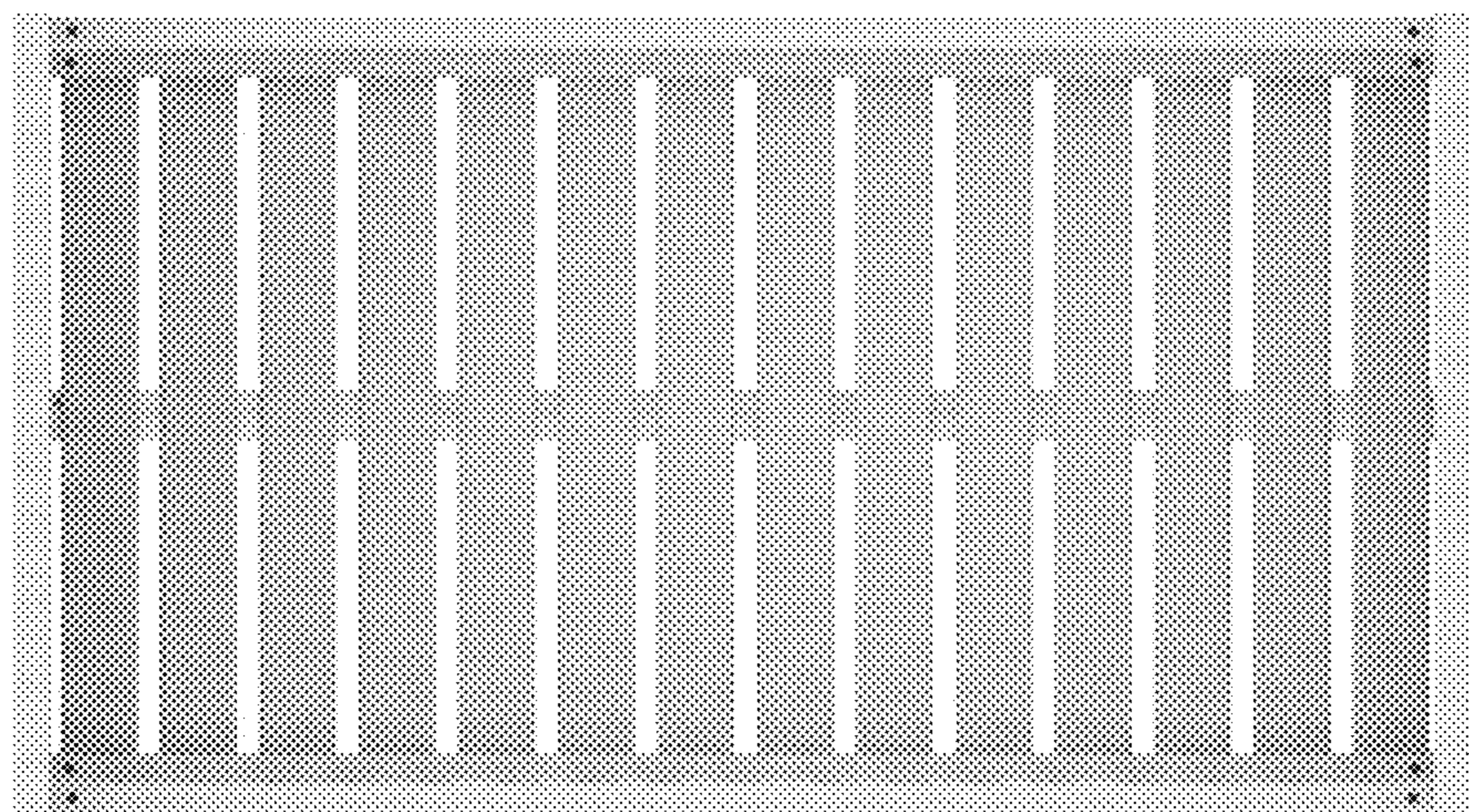

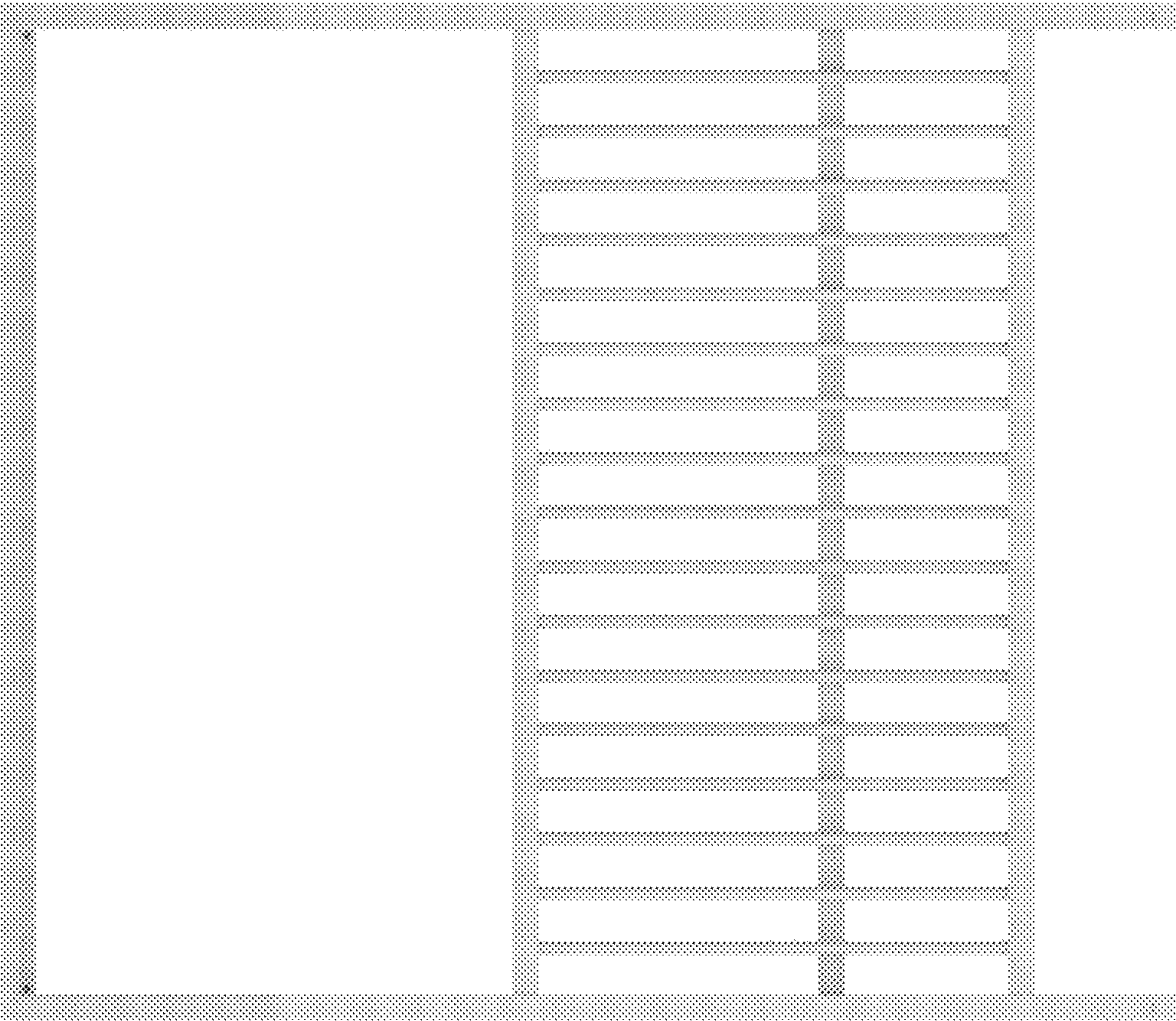

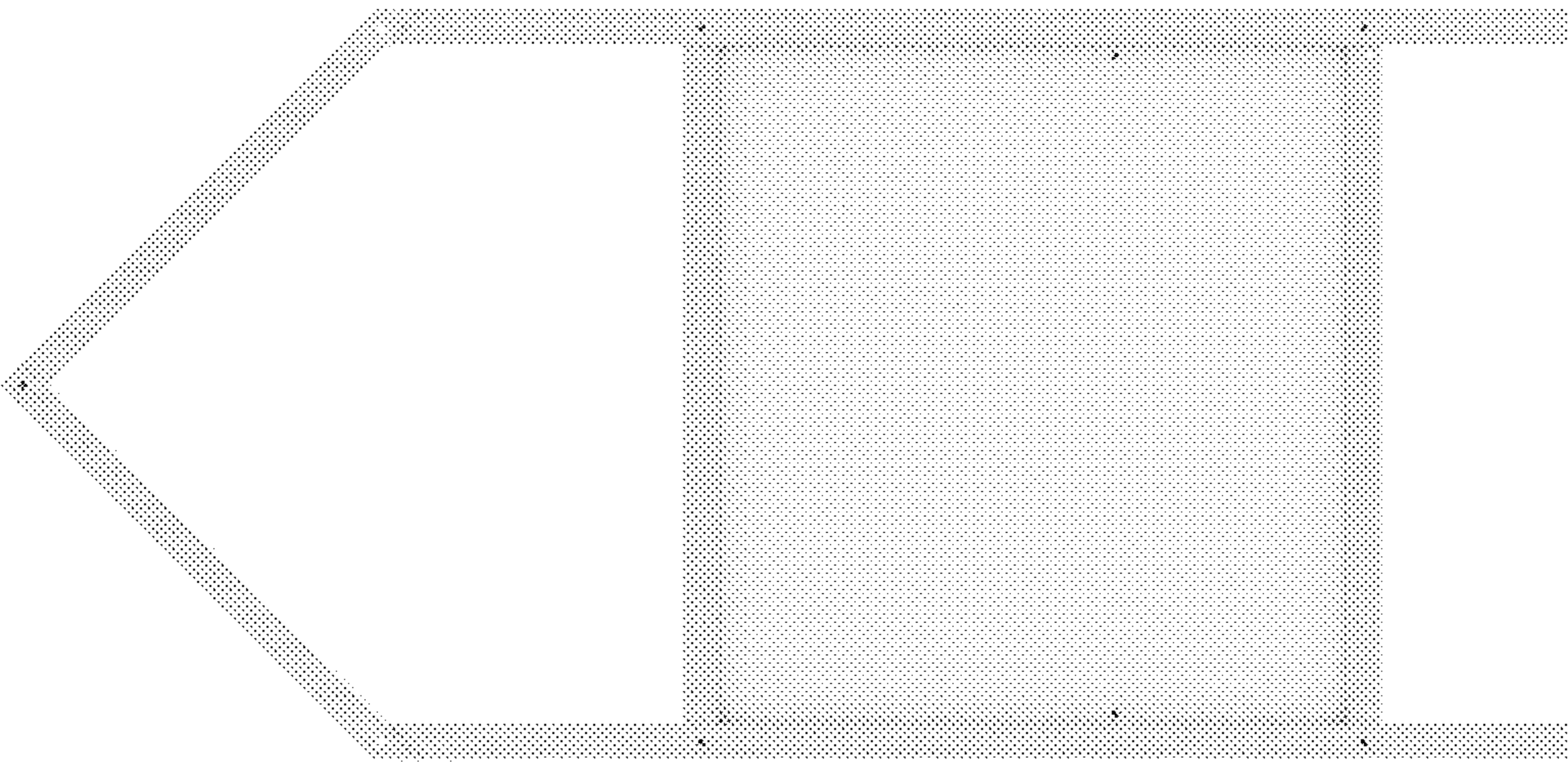

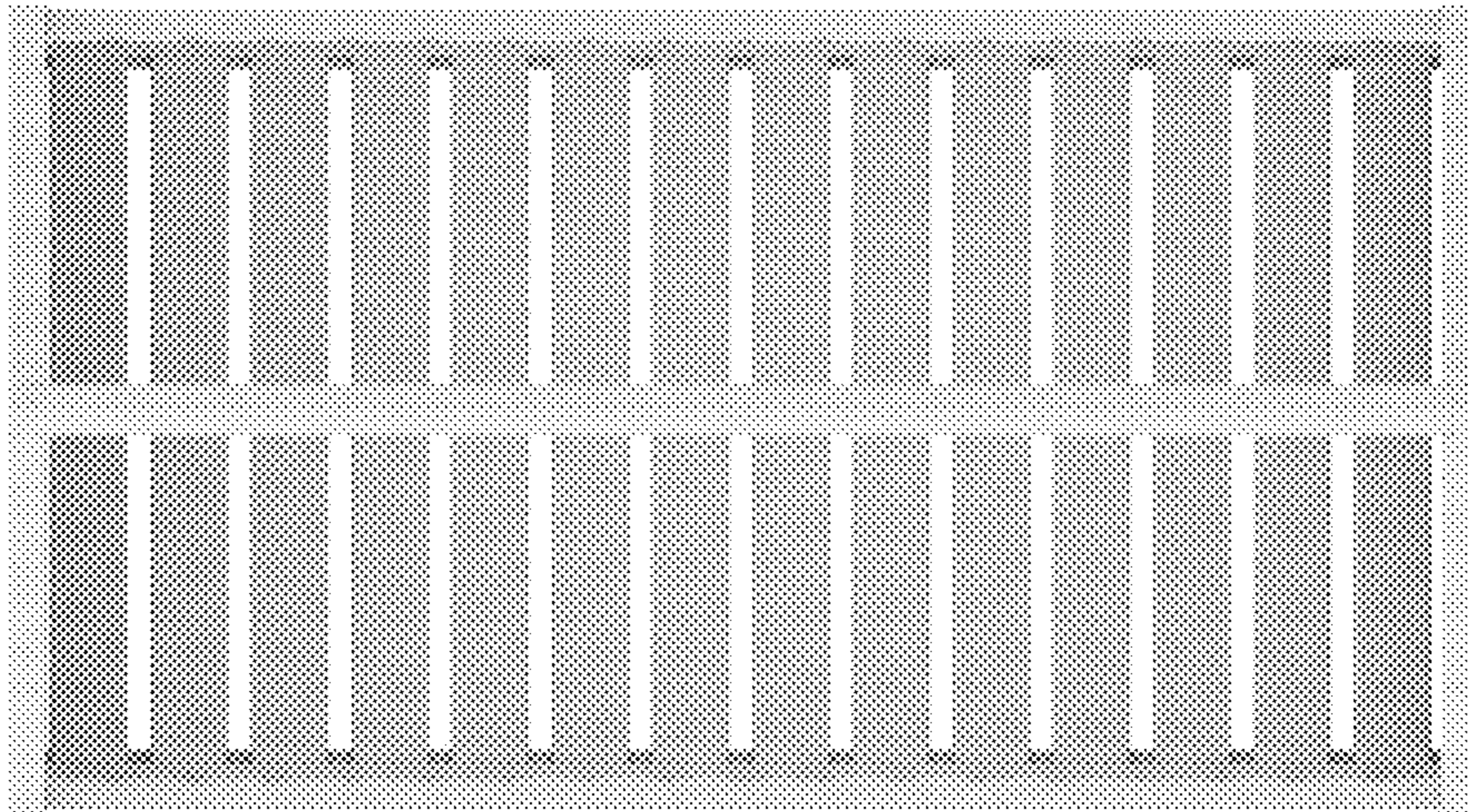
