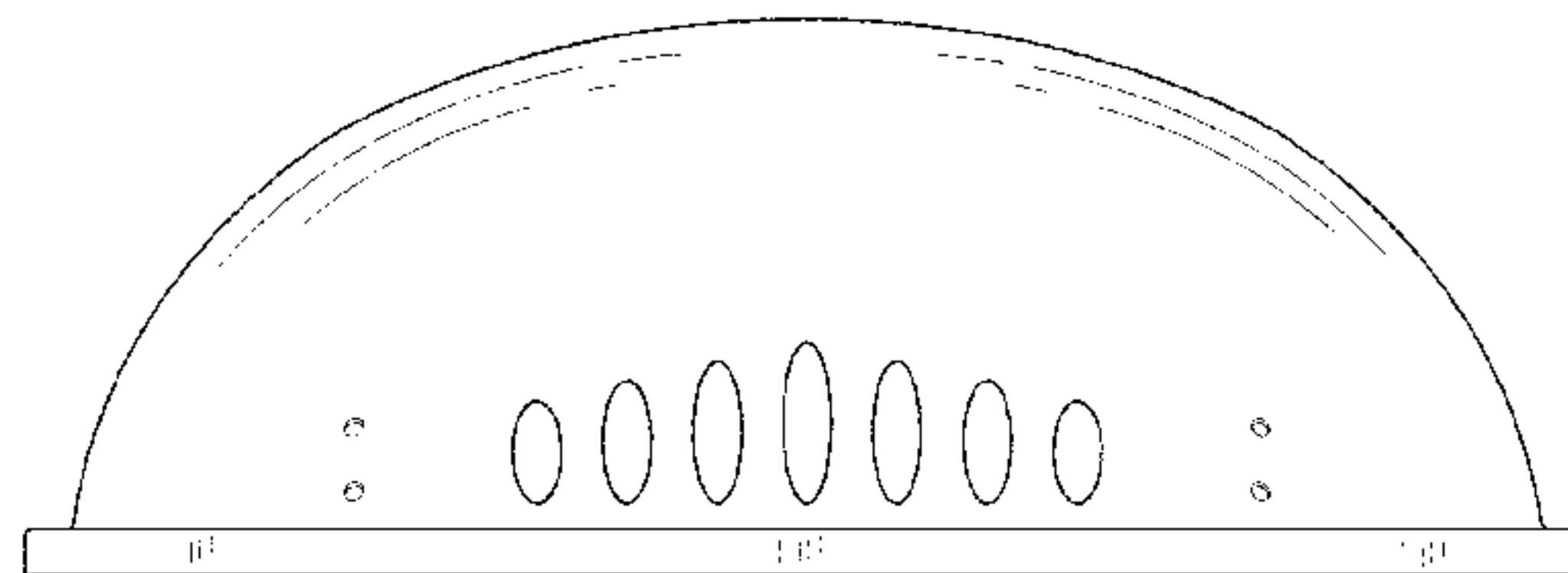
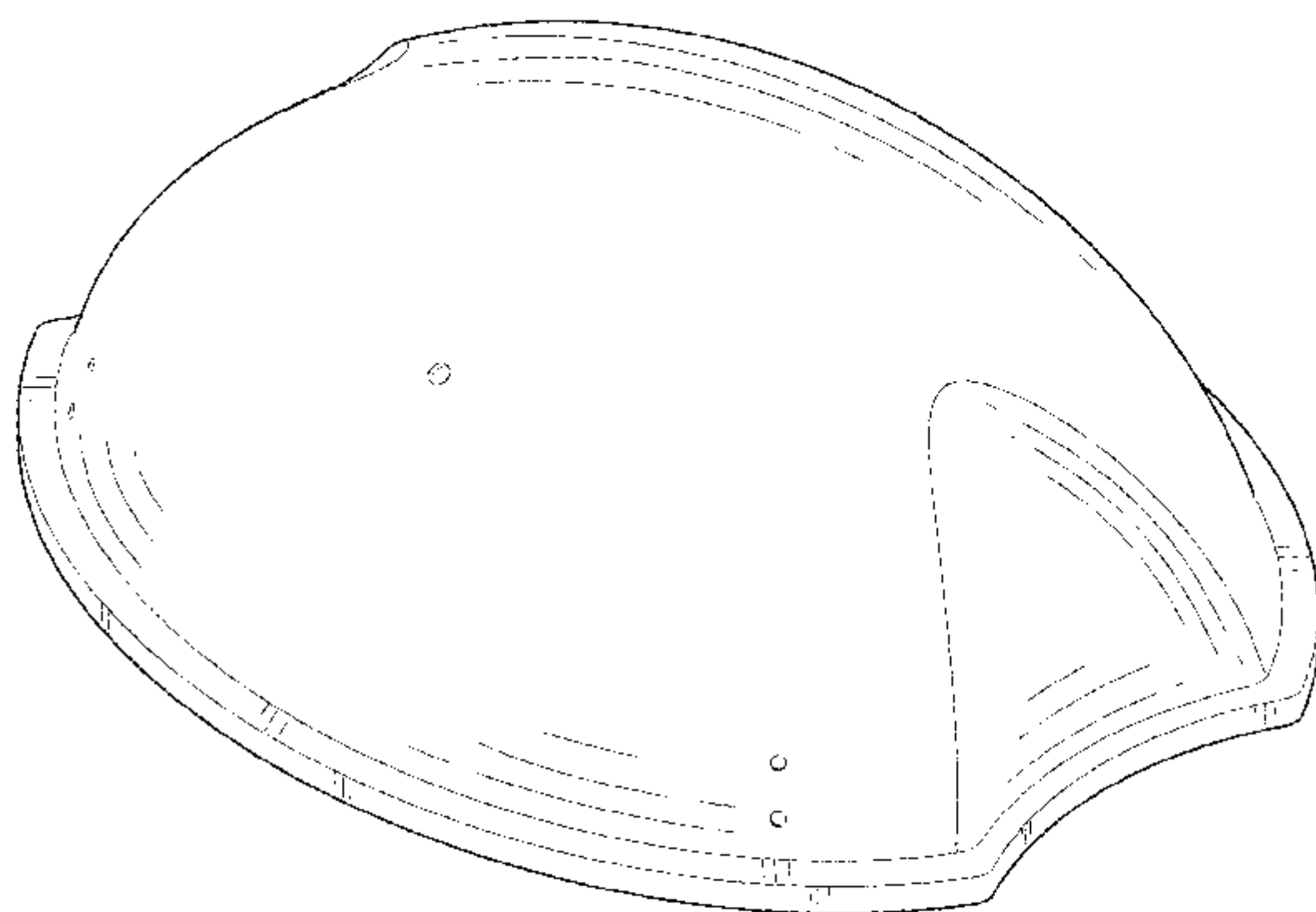
(57) **CLAIM**

The ornamental design for a barbecue grill lid, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of a barbecue grill lid showing my new design.

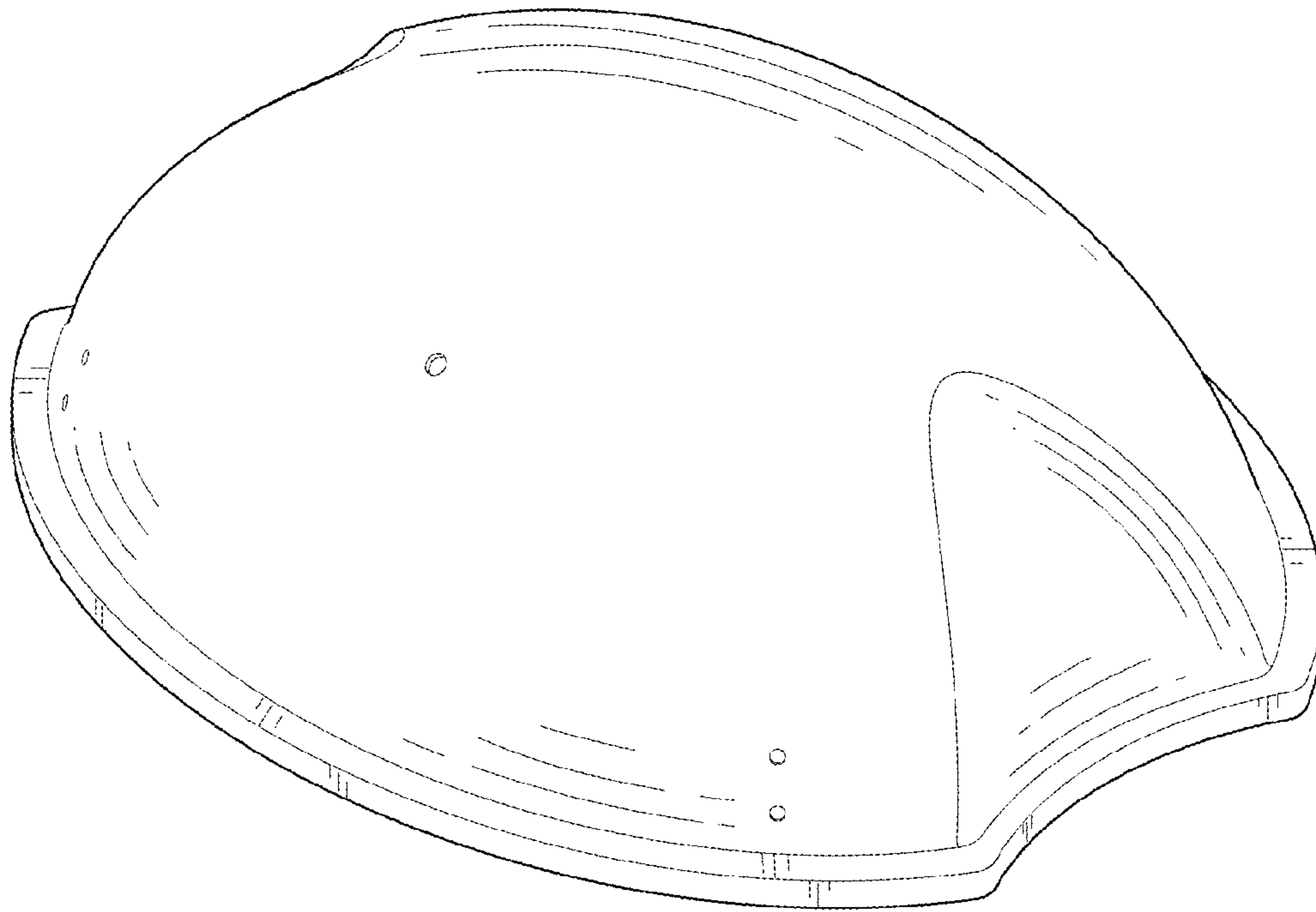

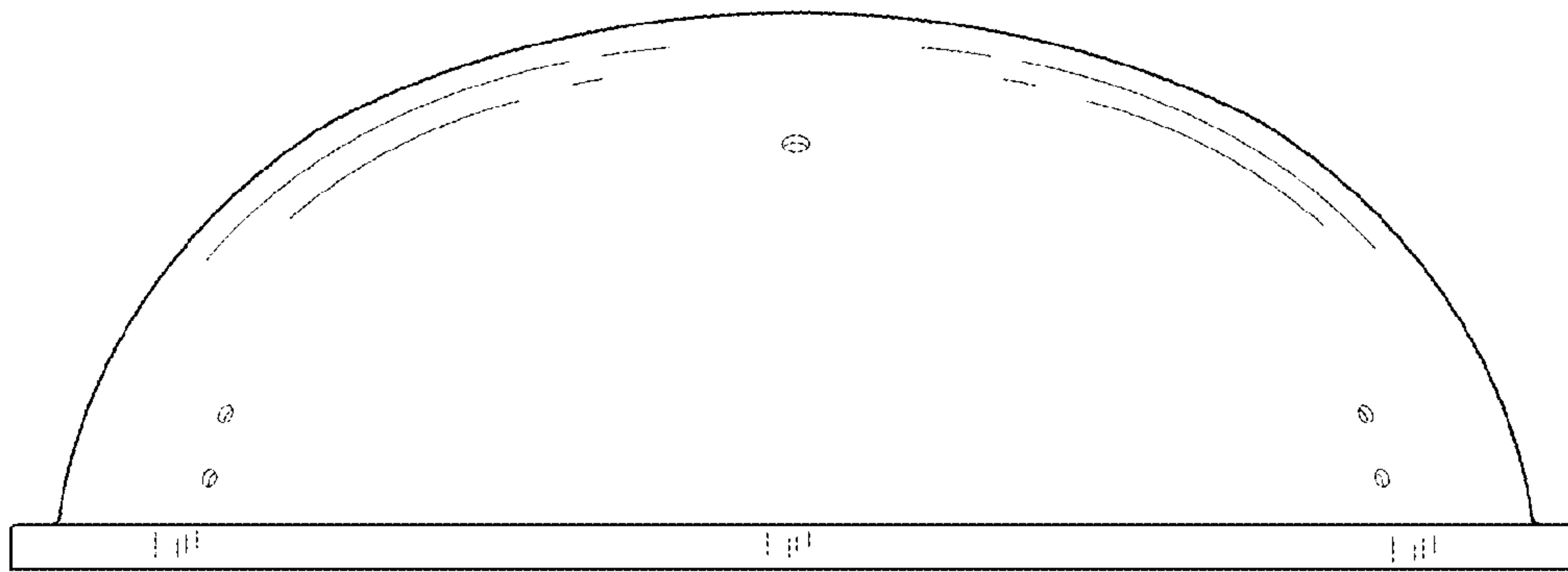

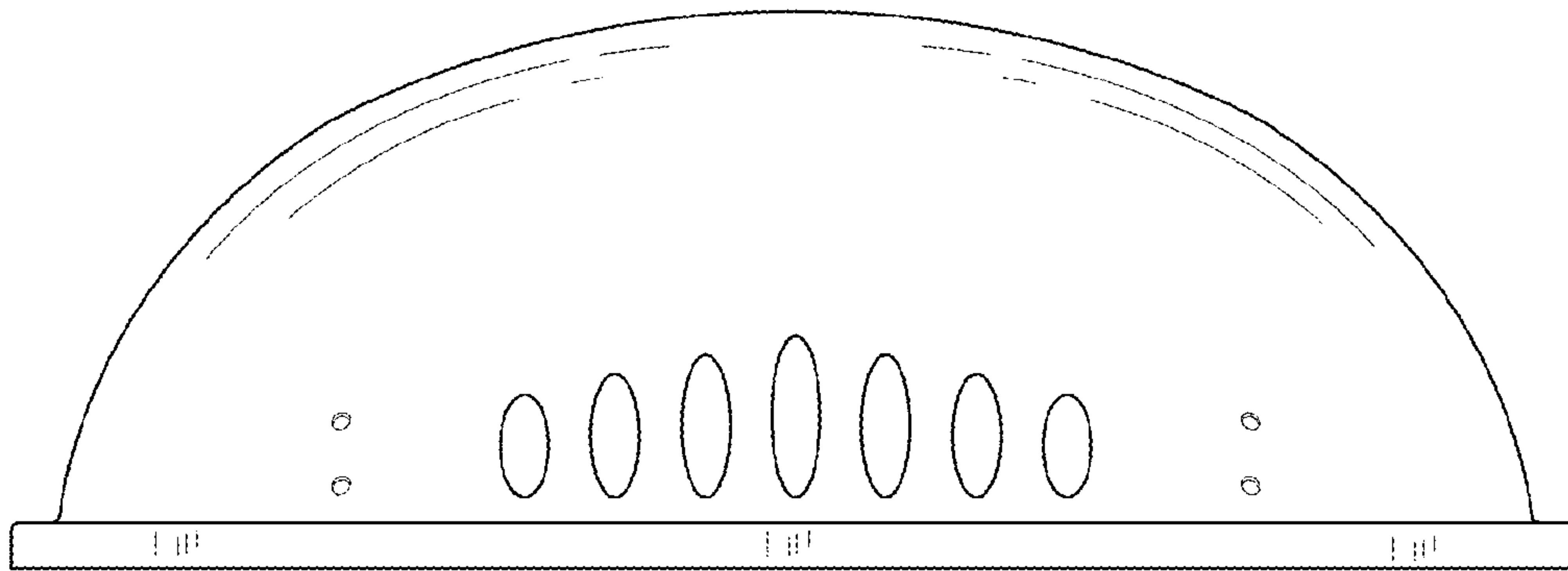

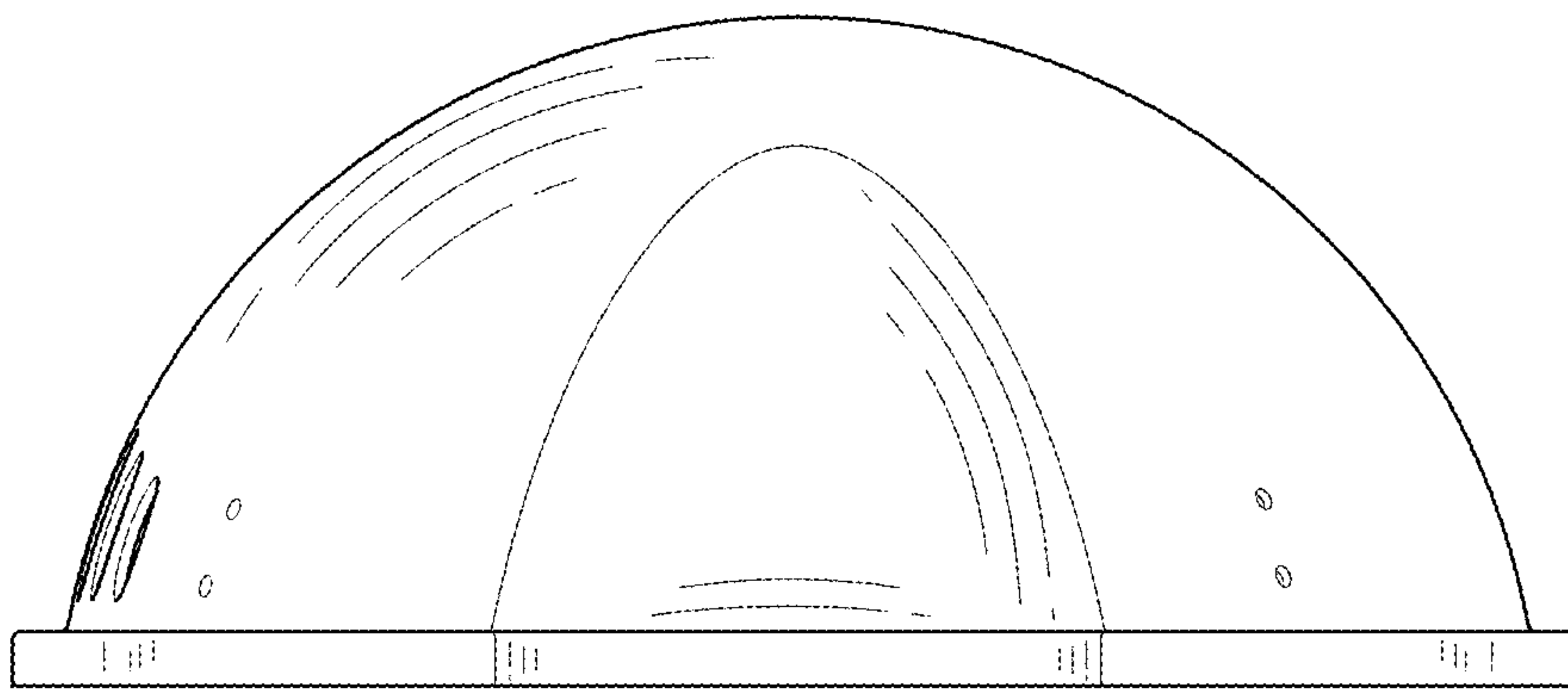

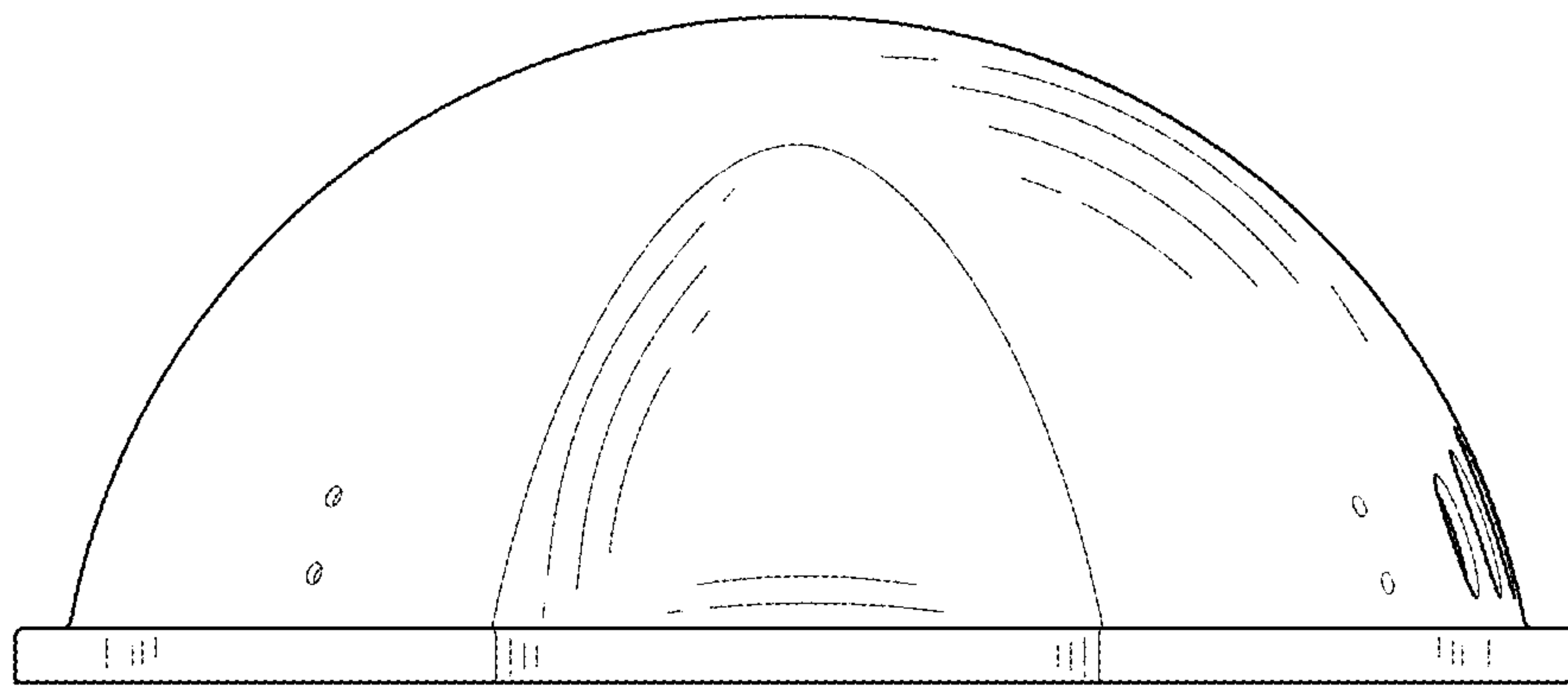

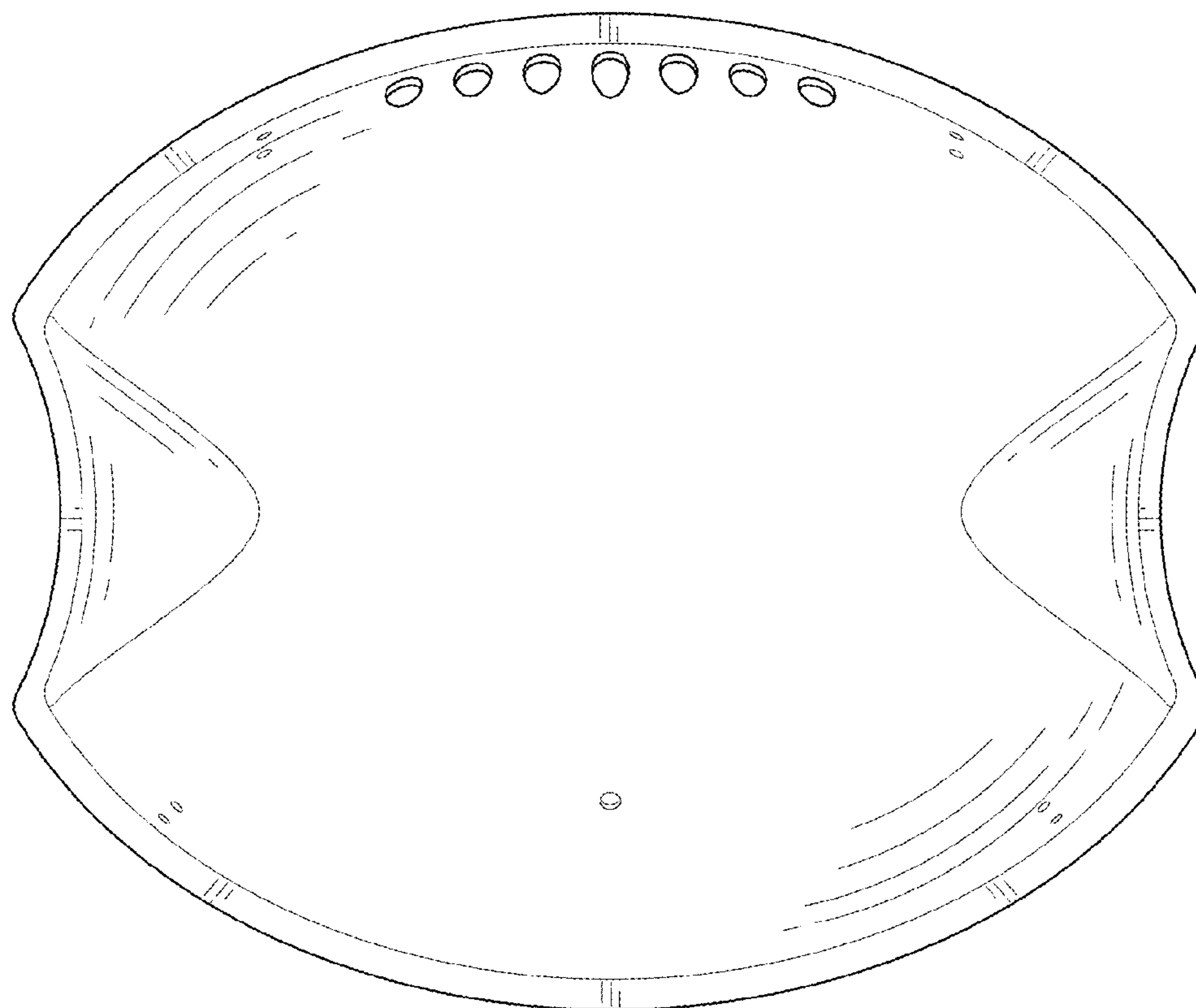

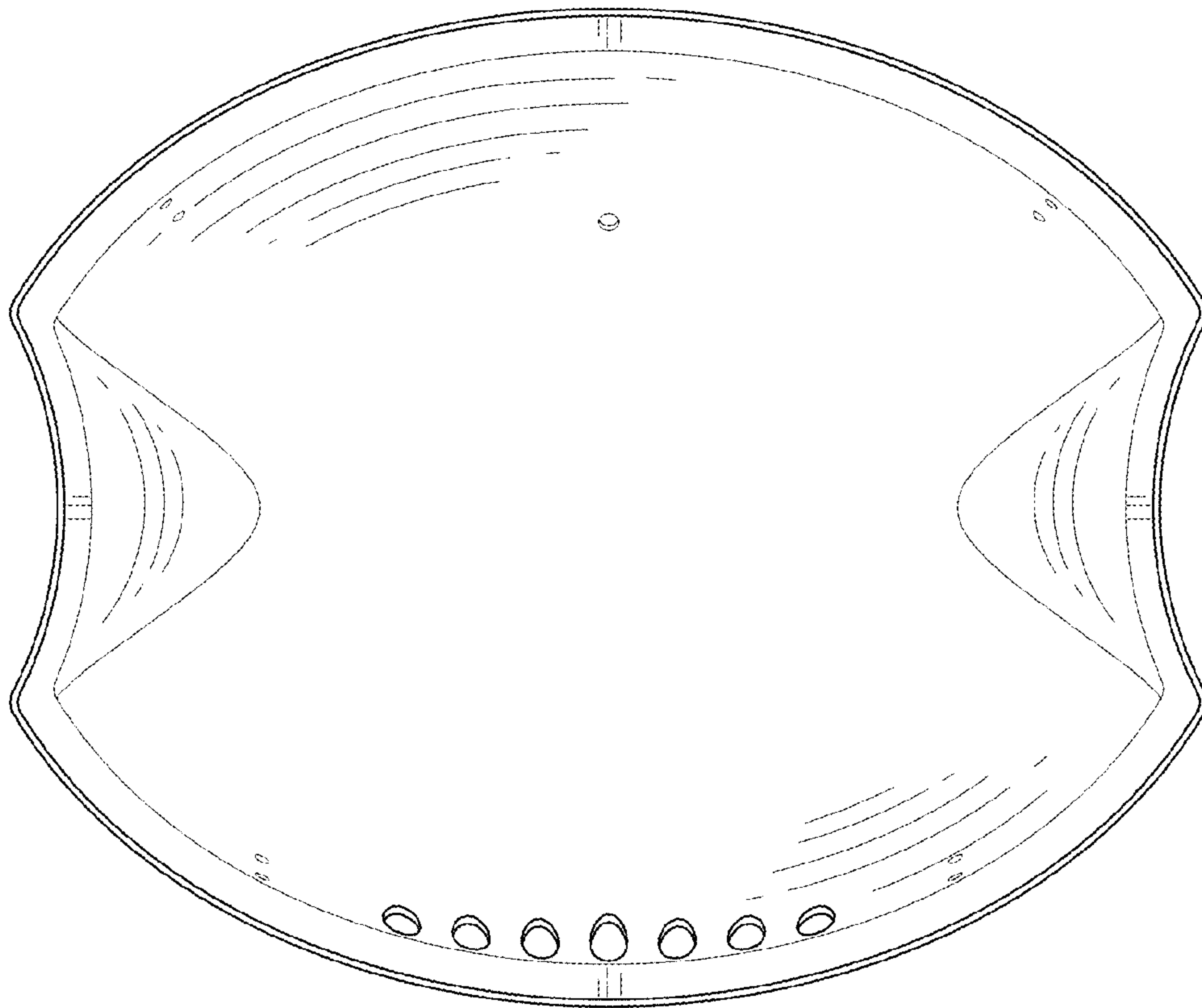

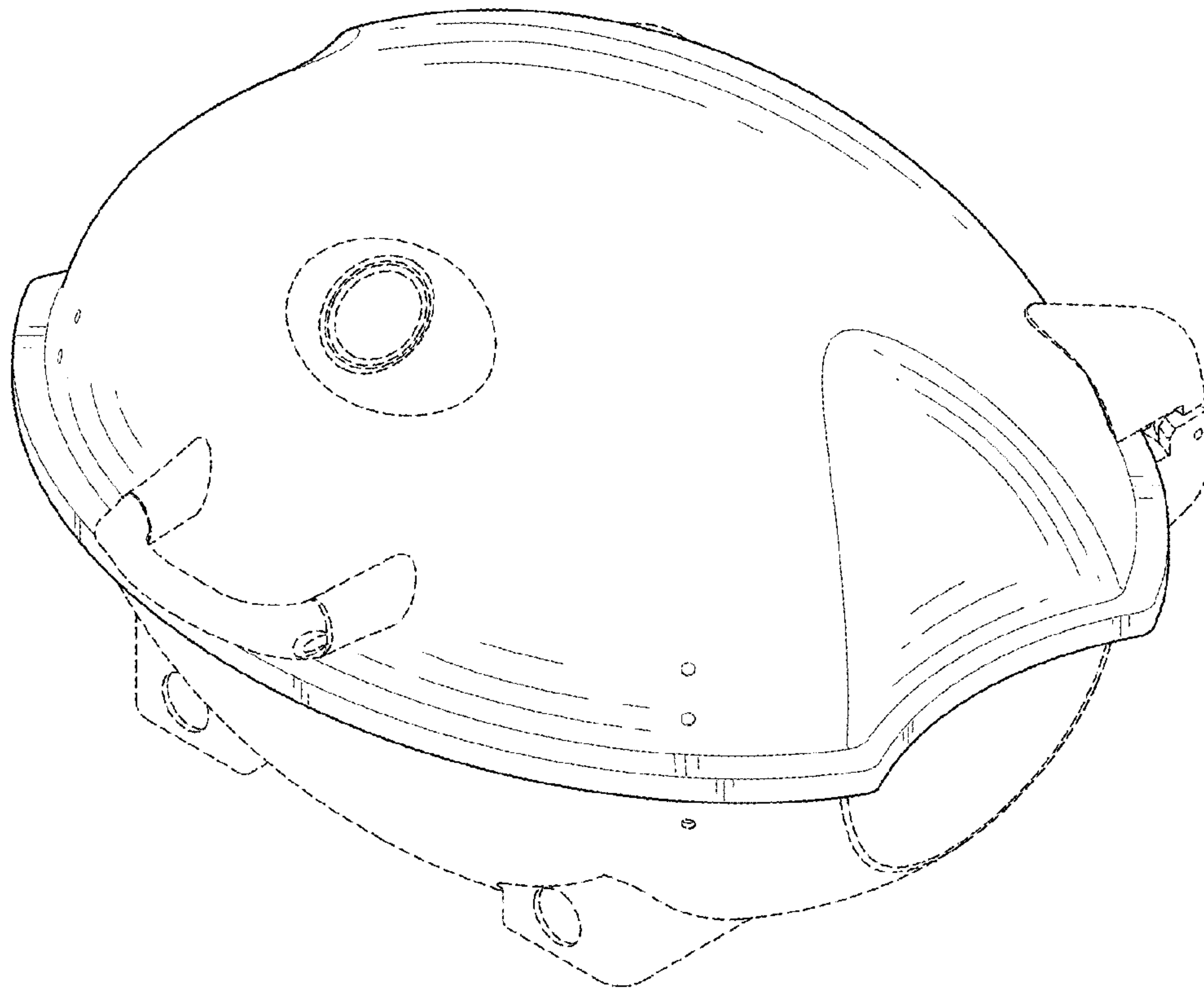
