The ornamental design for a shock absorber, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a shock absorber;
FIG. 2 is a front and right side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;

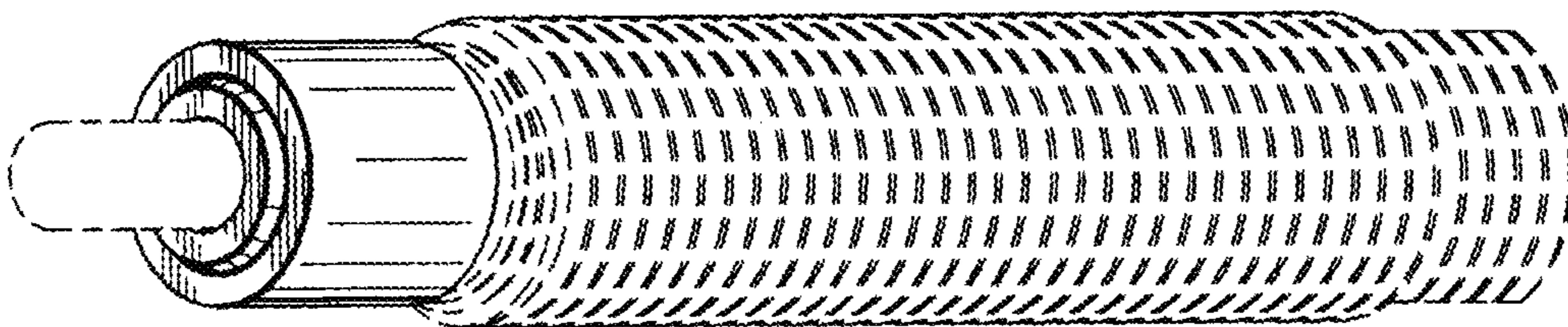

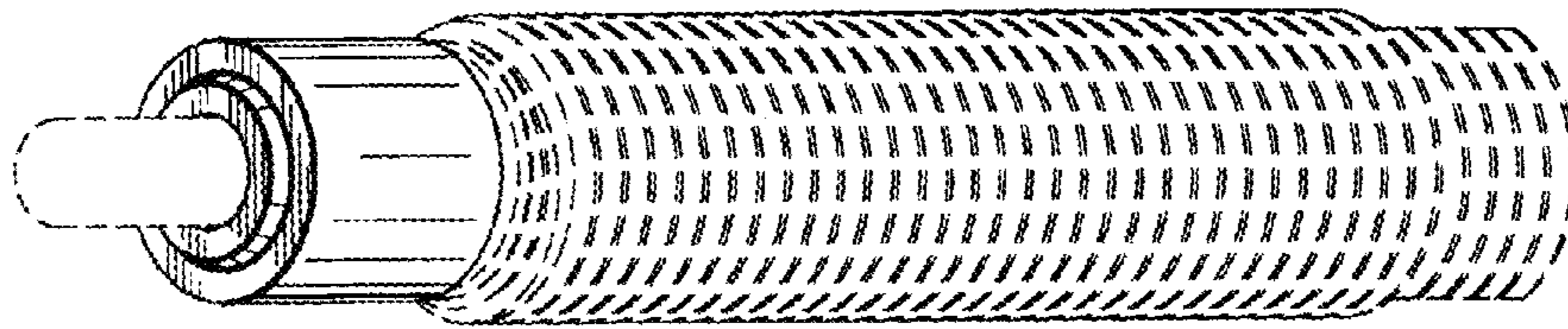

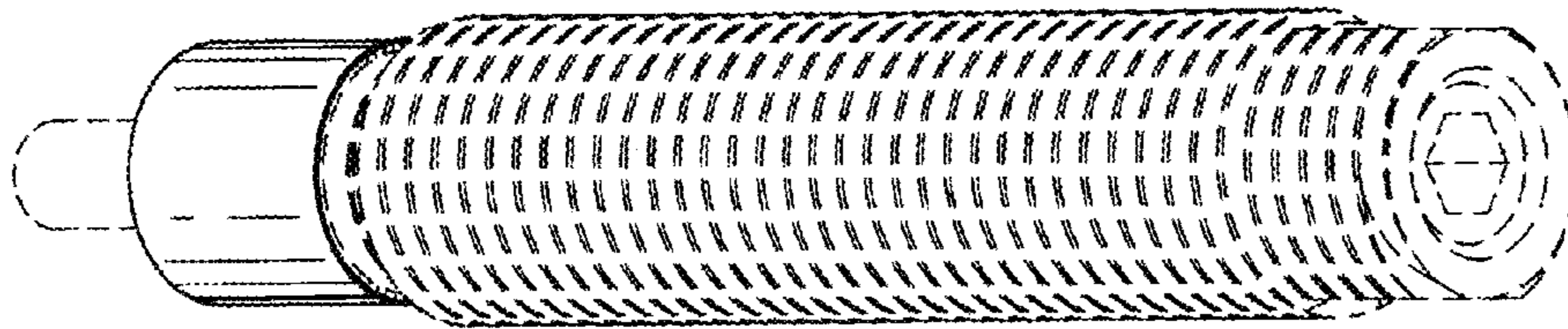

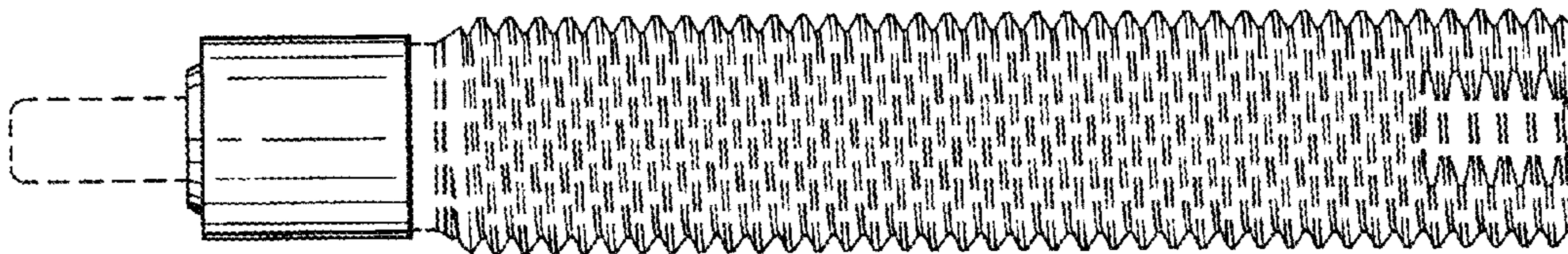

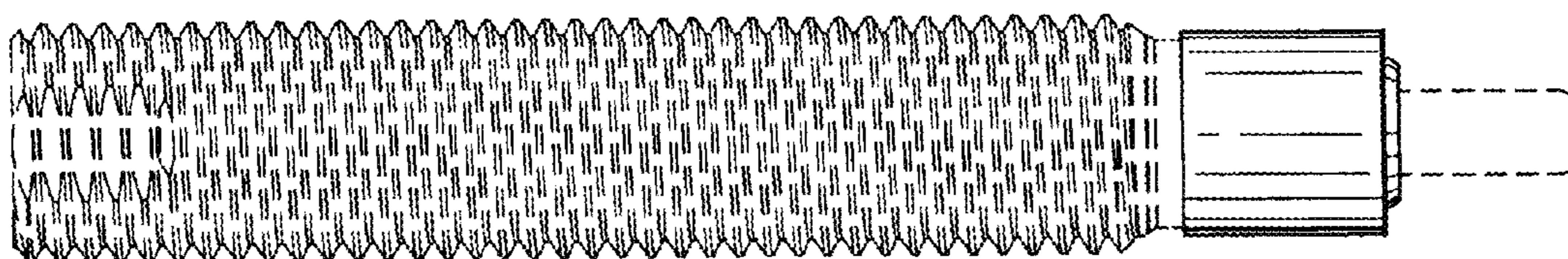

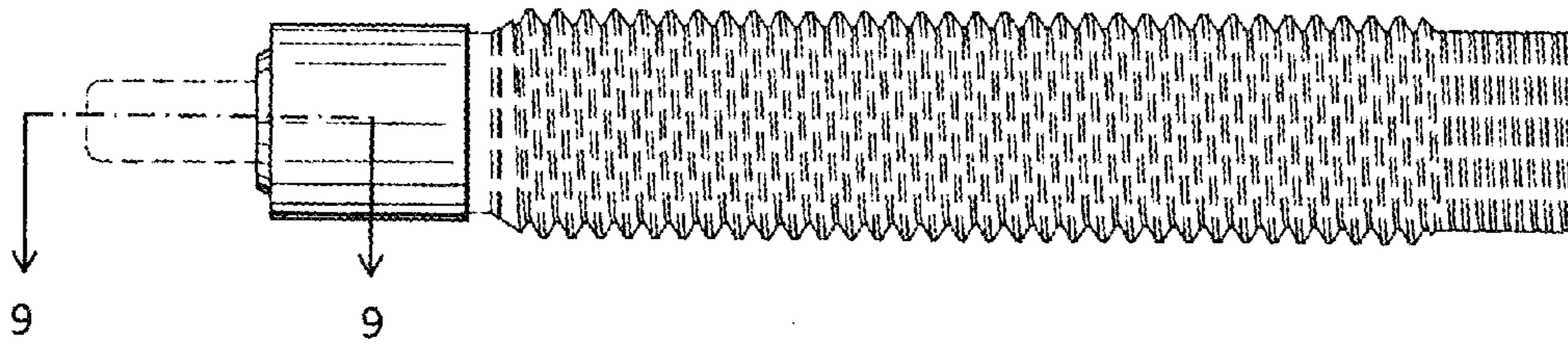

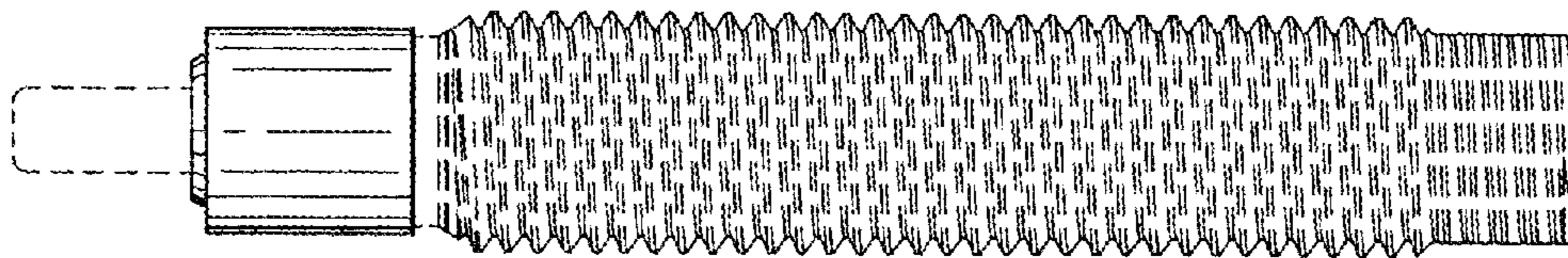

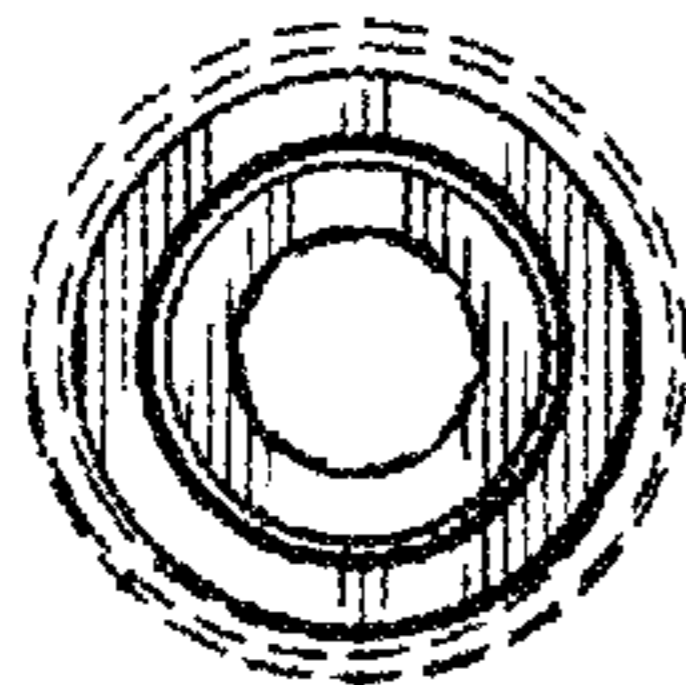

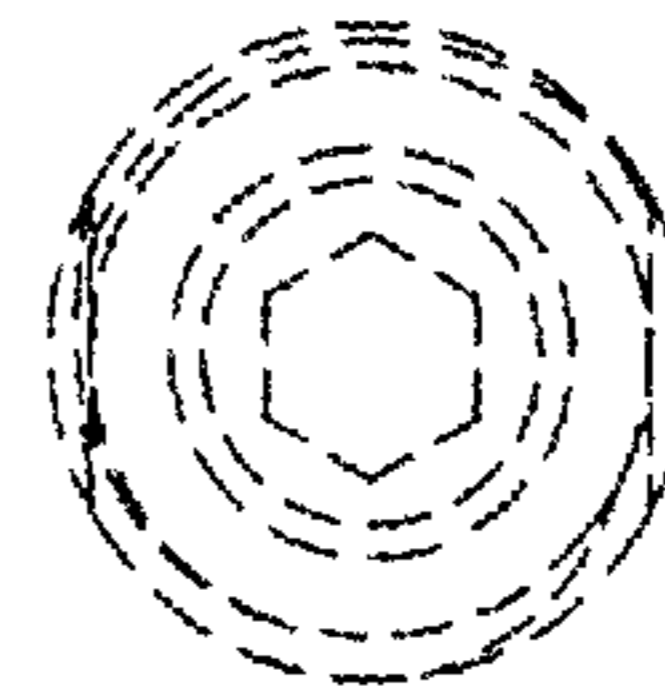
