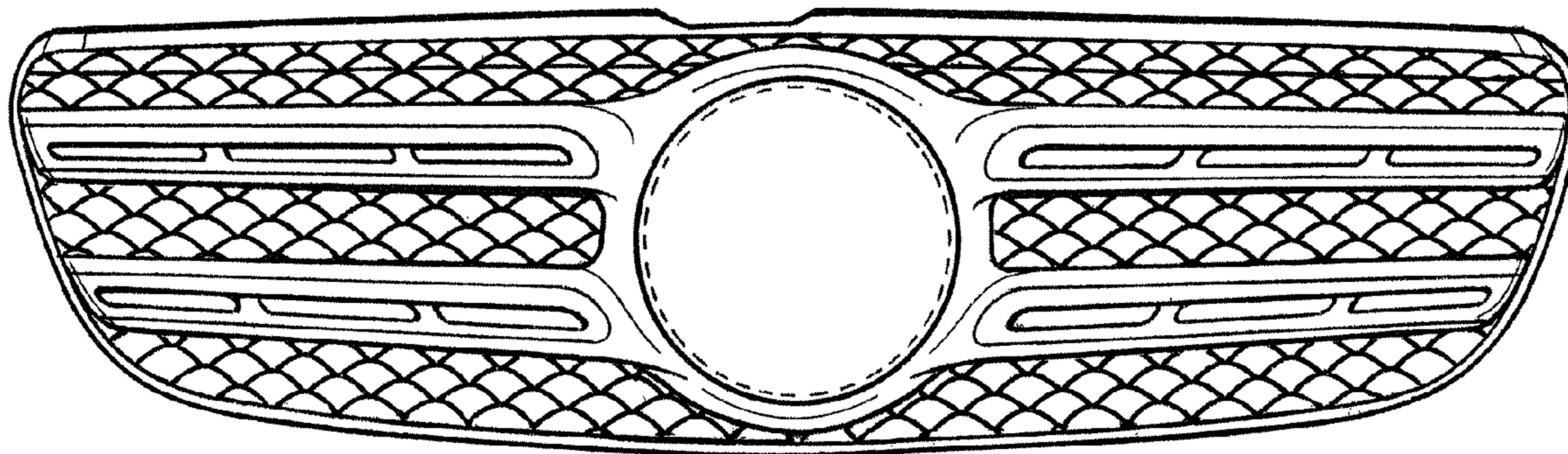
(57) **CLAIM**

The ornamental design for a radiator grill for a vehicle, as shown and described.

**DESCRIPTION**

This application contains subject matter related to the following co-pending U.S. design patent applications: application Ser. No. 29/507,829, filed herewith and entitled “Vehicle, Toy, and/or Replicas thereof”; and, application Ser. No. 29/507,830, filed herewith and entitled “Front Portion of a Vehicle, Toy, and/or Replicas thereof”. FIG. 1 is a left, front perspective view of a radiator grill for a vehicle according to the design; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; and, FIG. 4 is a right side view thereof. The broken lines are for illustrative purposes only and form no part of the claimed design.

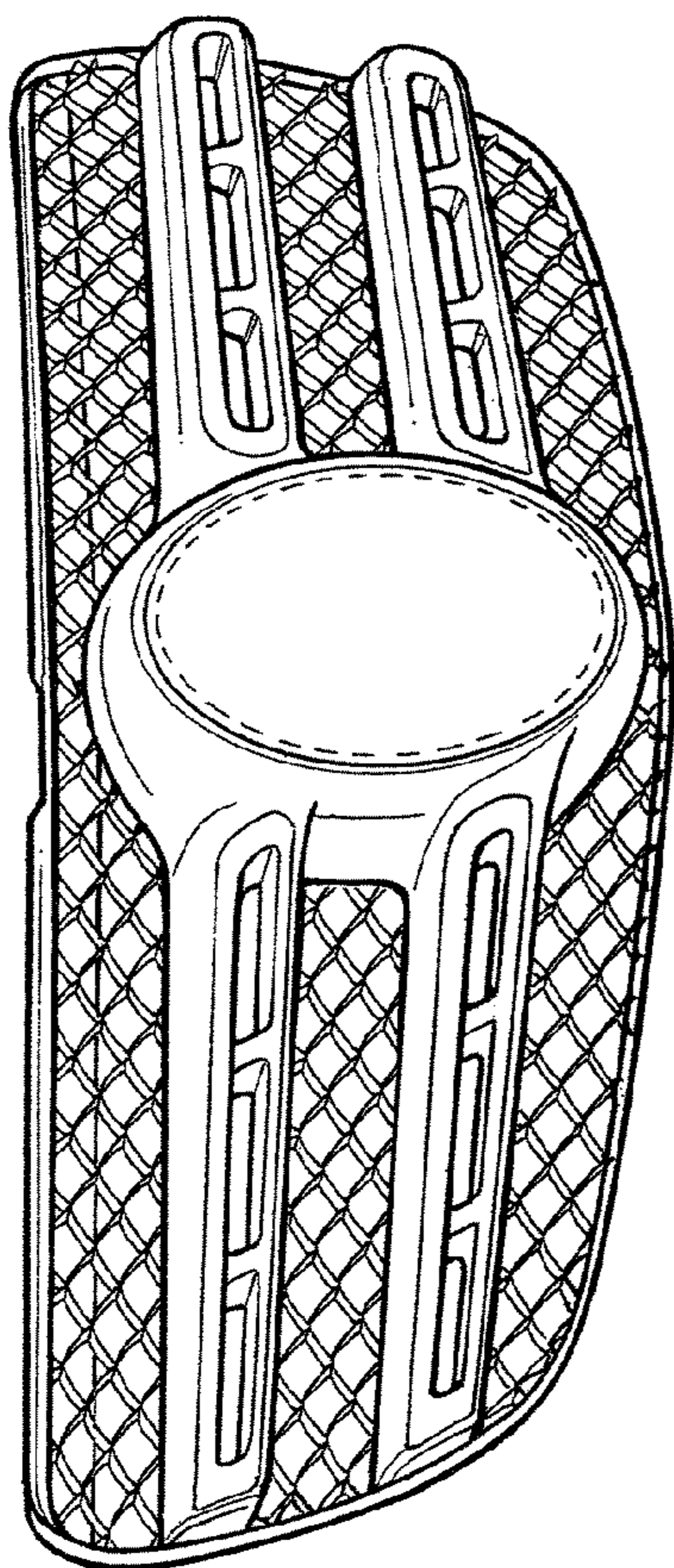

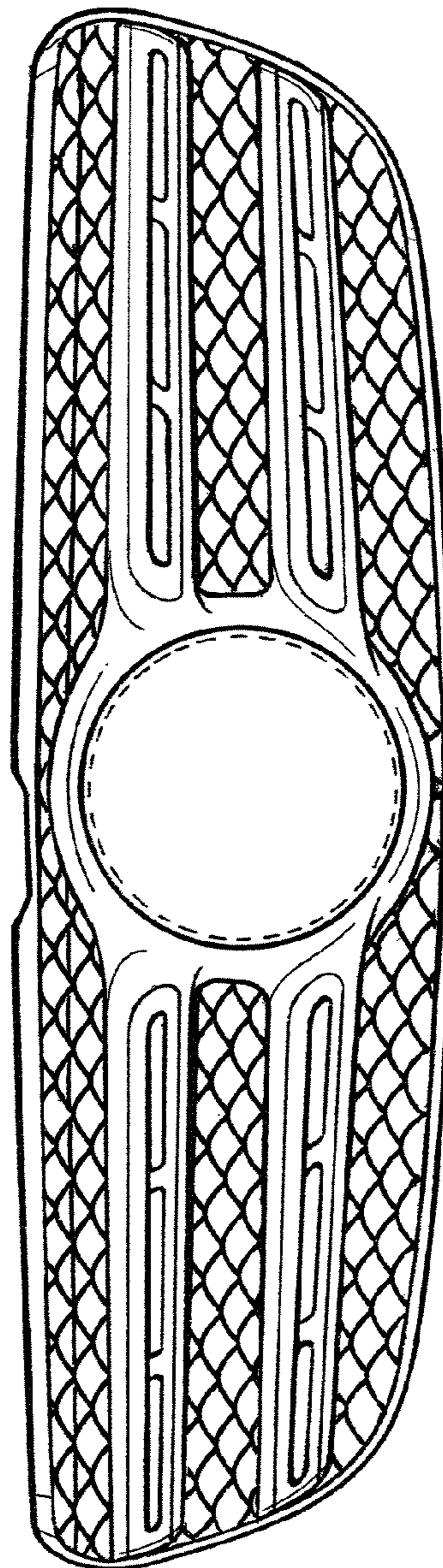

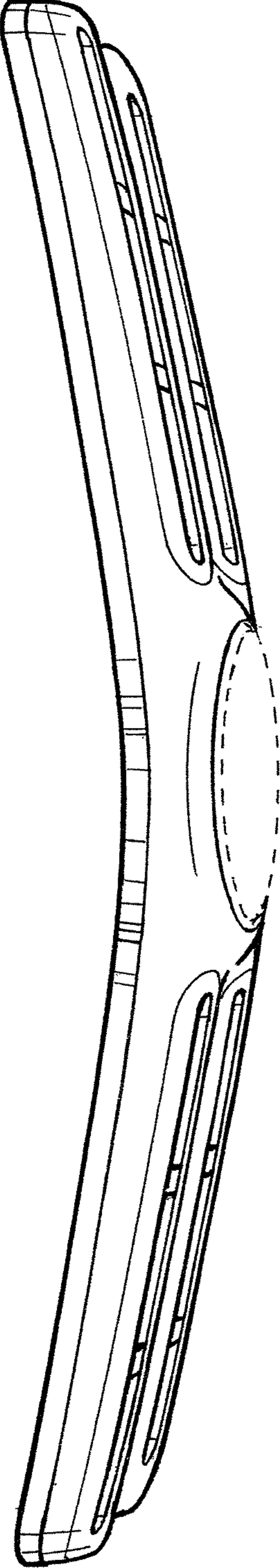

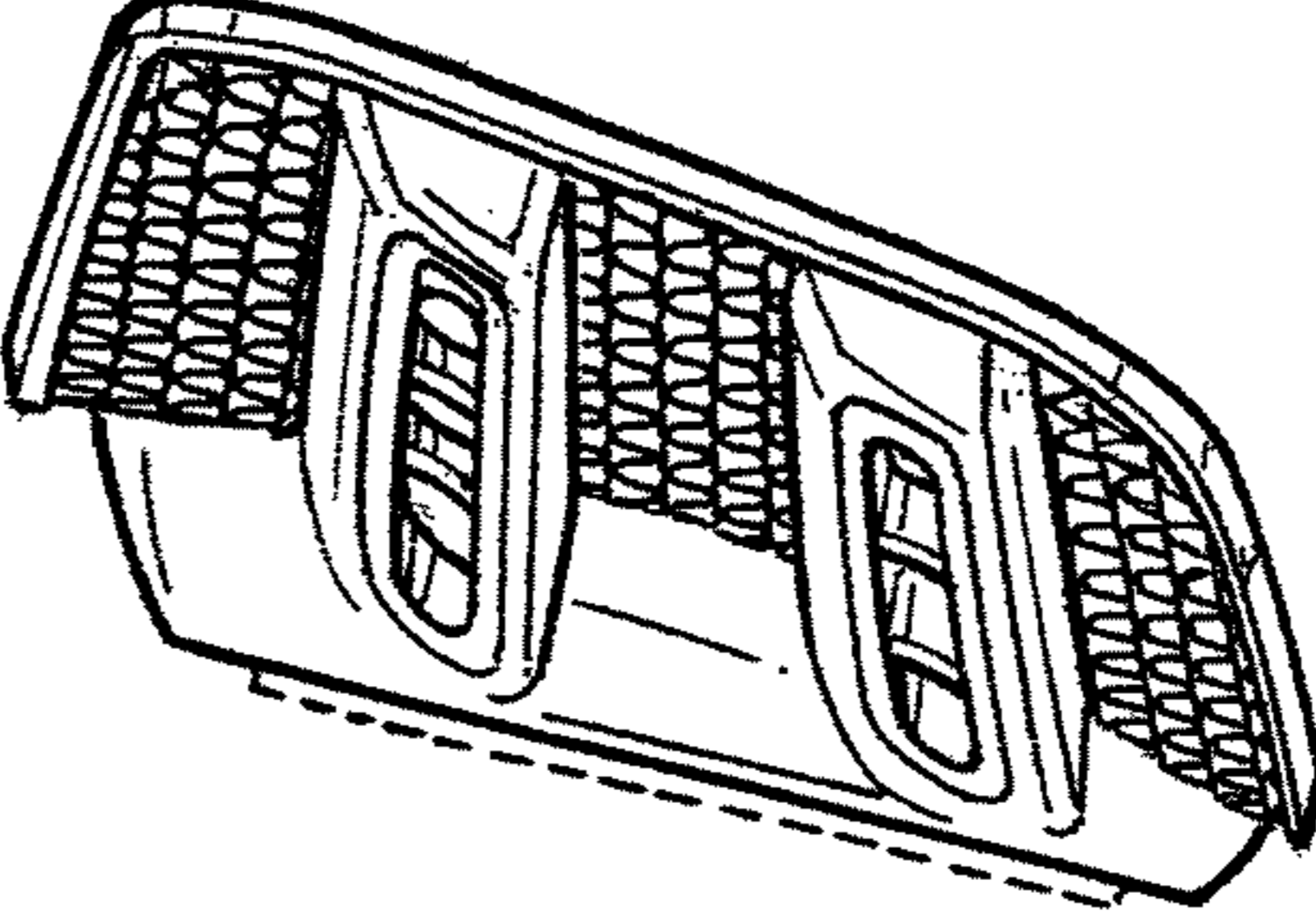
