(57) **CLAIM**

The ornamental design for a wing root leading edge extension, as shown and described.

DESCRIPTION

FIG. 1 is a front left side isometric view of a wing root leading edge extension for a left wing of an aircraft showing my new design;

FIG. 2 is a top plan view of the wing root leading edge extension of FIG. 1;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a right side elevational view thereof; and

FIG. 8 is a front right side isometric view of a wing root leading edge extension for a right wing of an aircraft showing my new design;

FIG. 9 is a top plan view of the wing root leading edge extension of FIG. 8;

FIG. 10 is a bottom plan view of FIG. 8;

FIG. 11 is a front elevational view of FIG. 8;

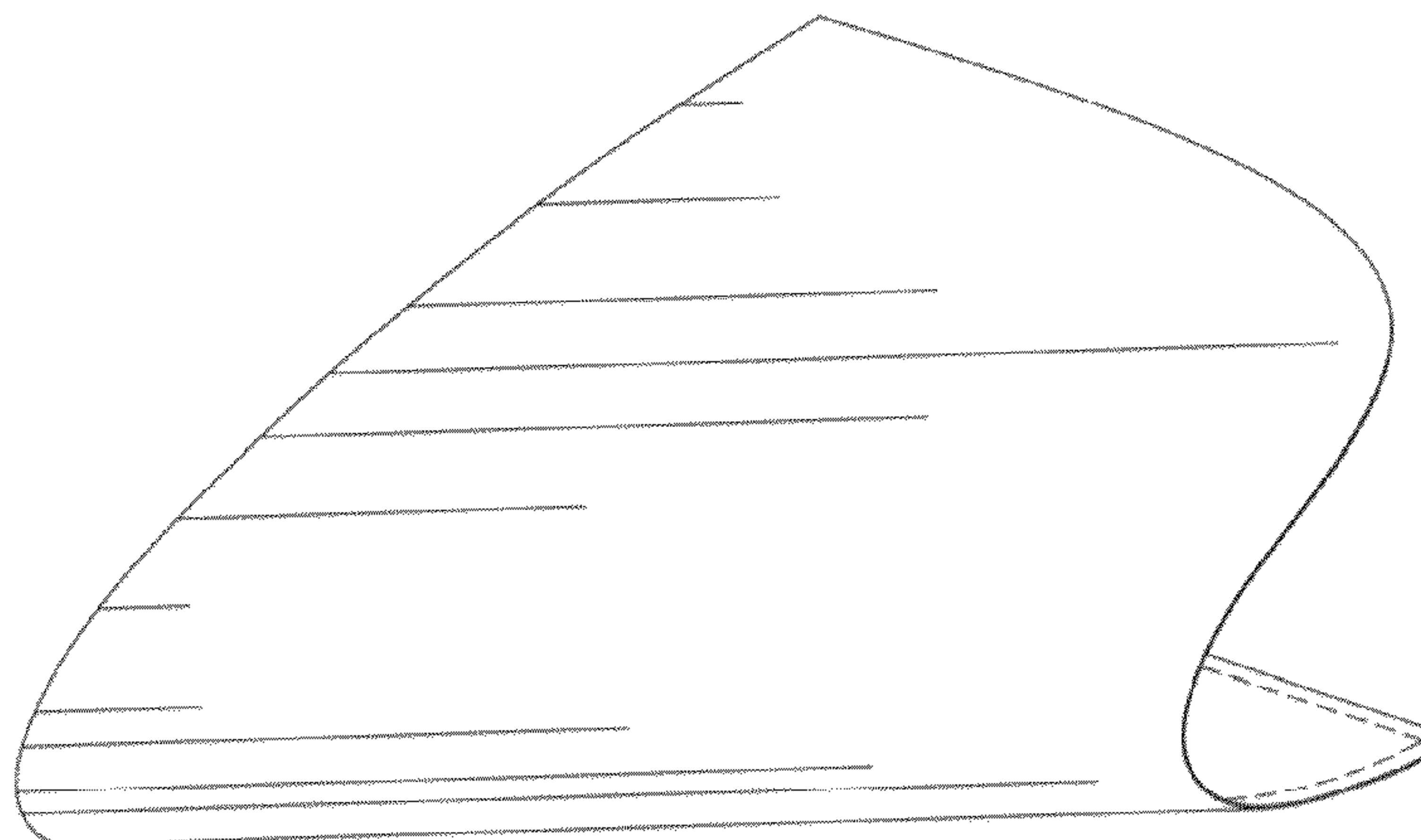
FIG. 12 is a rear elevational view of FIG. 8;

FIG. 13 is a right side elevational view of FIG. 8; and,

FIG. 14 is a left side elevational view of FIG. 8.

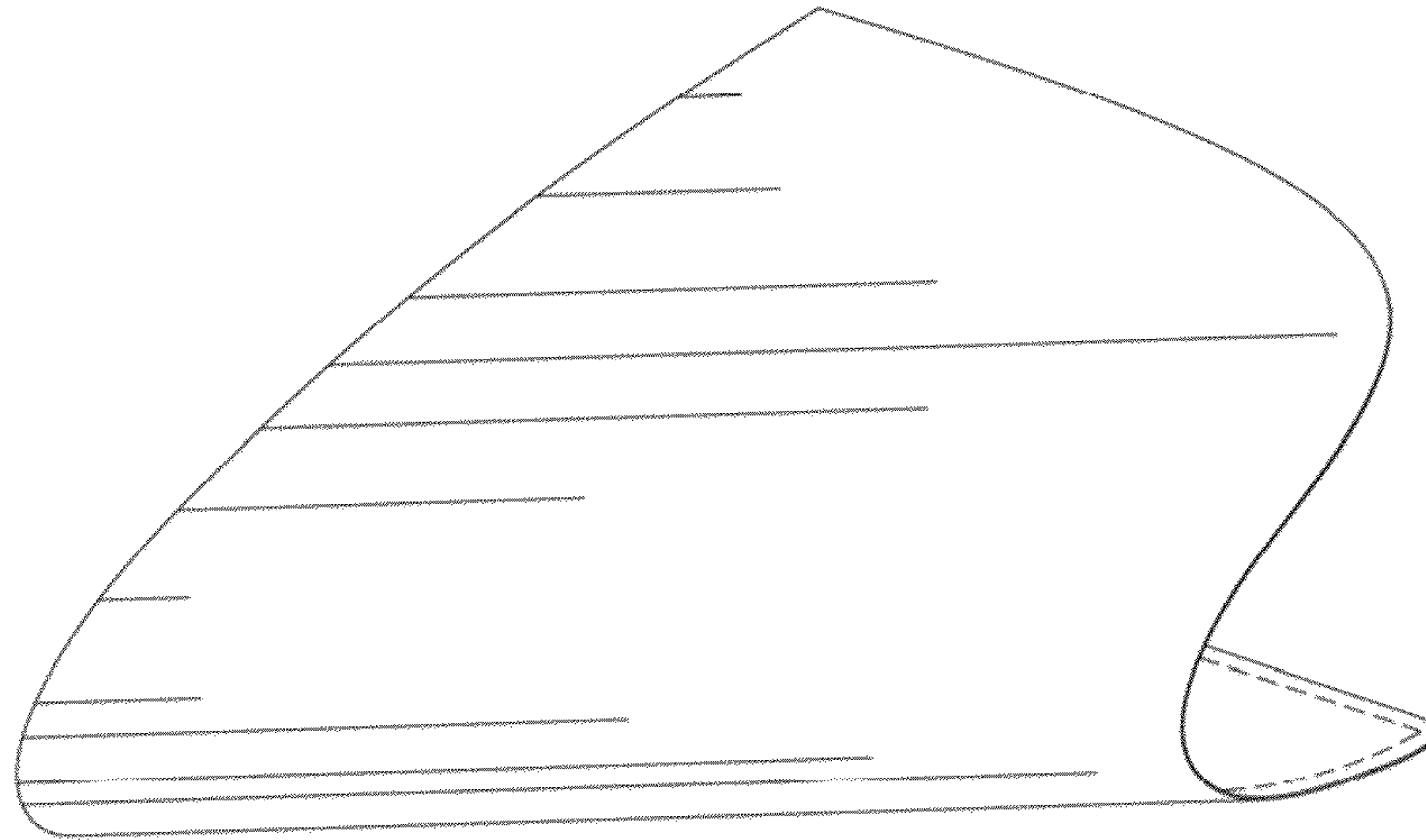

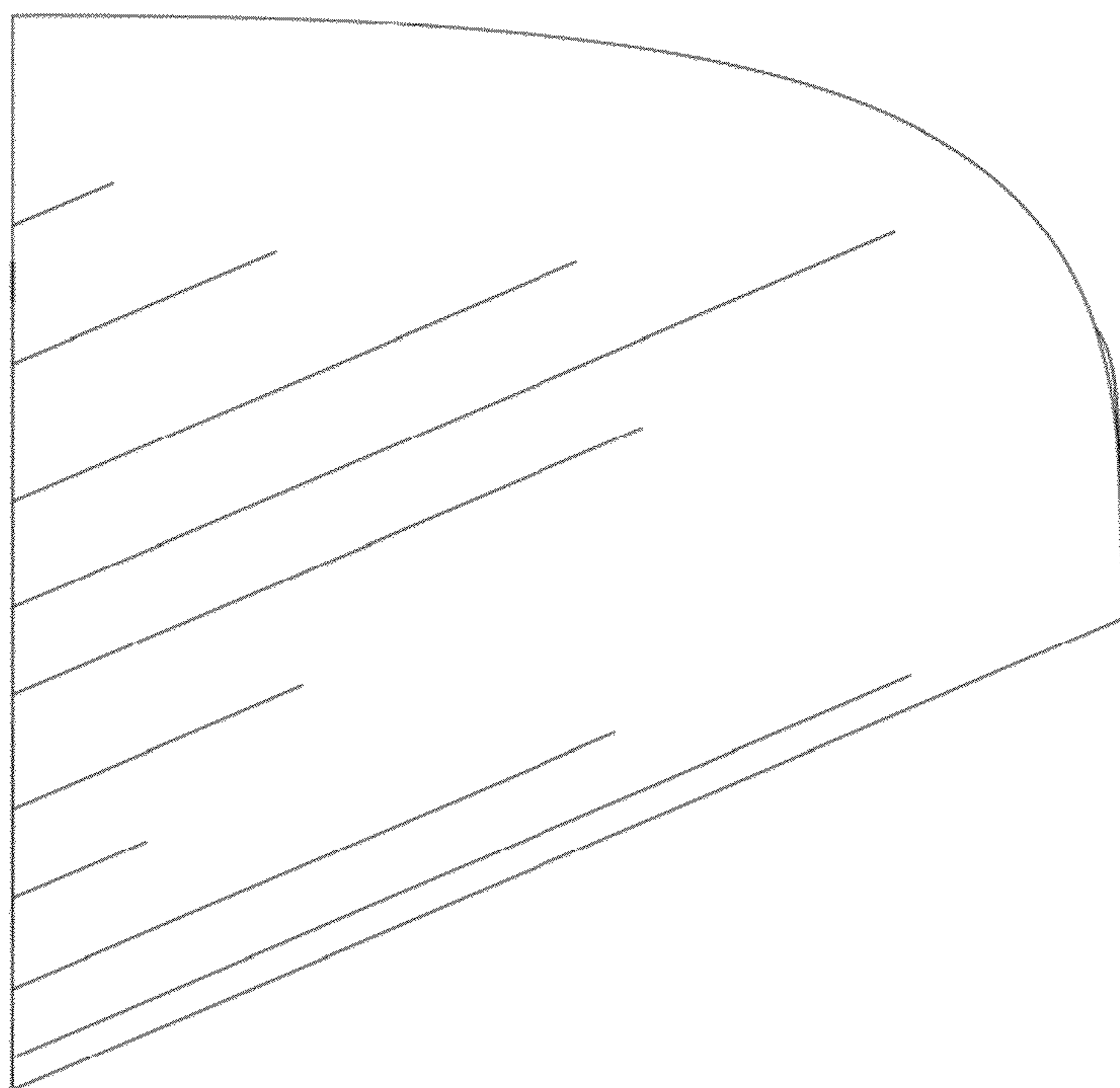

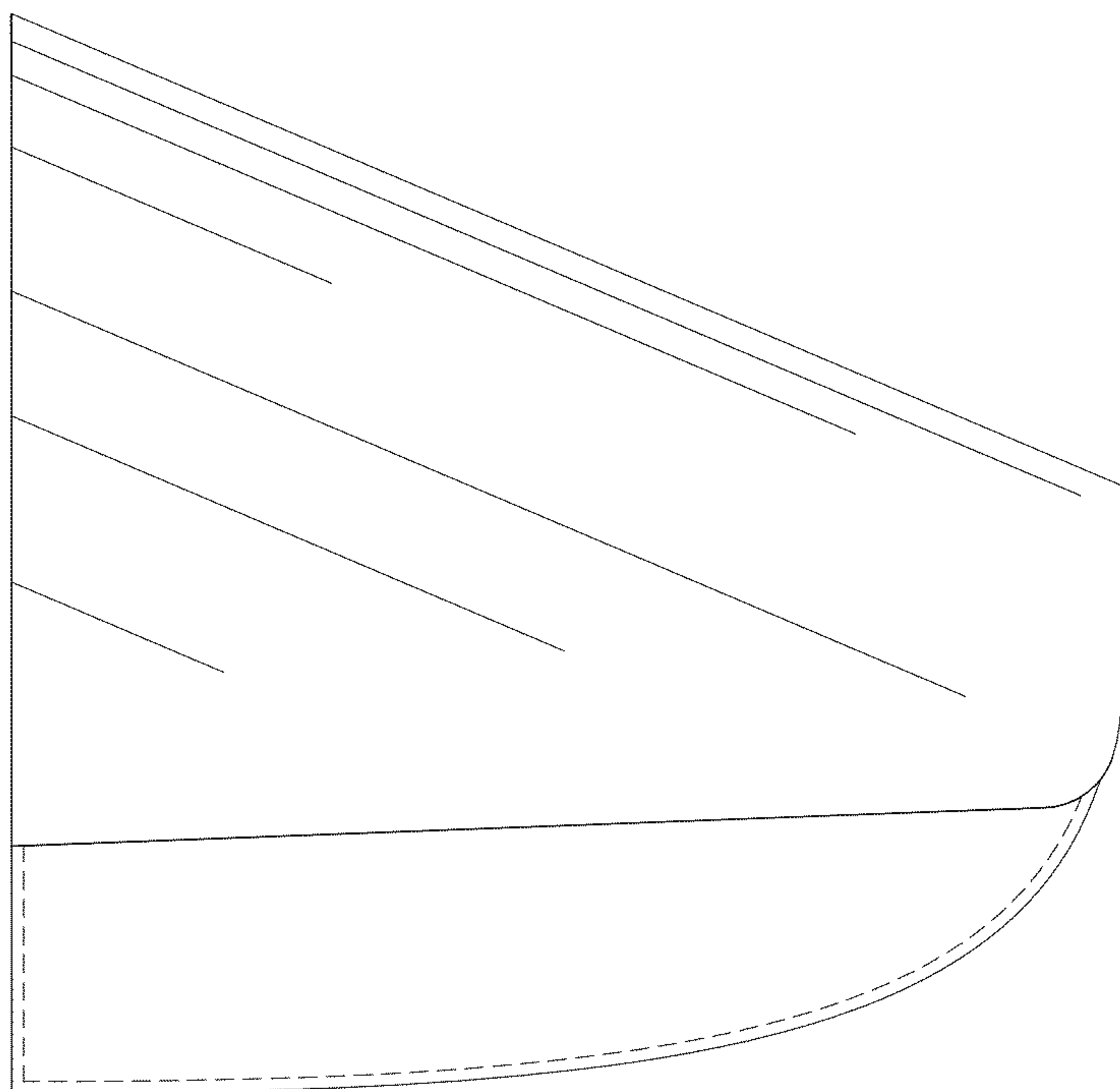

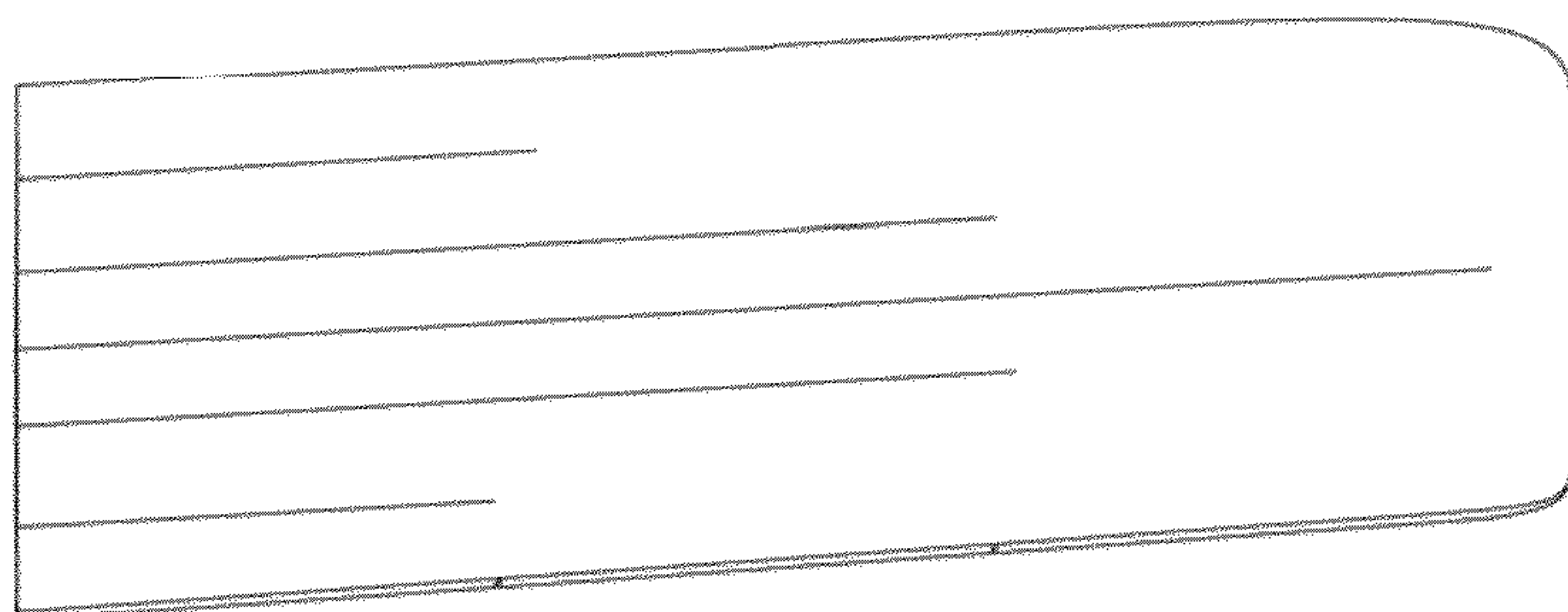

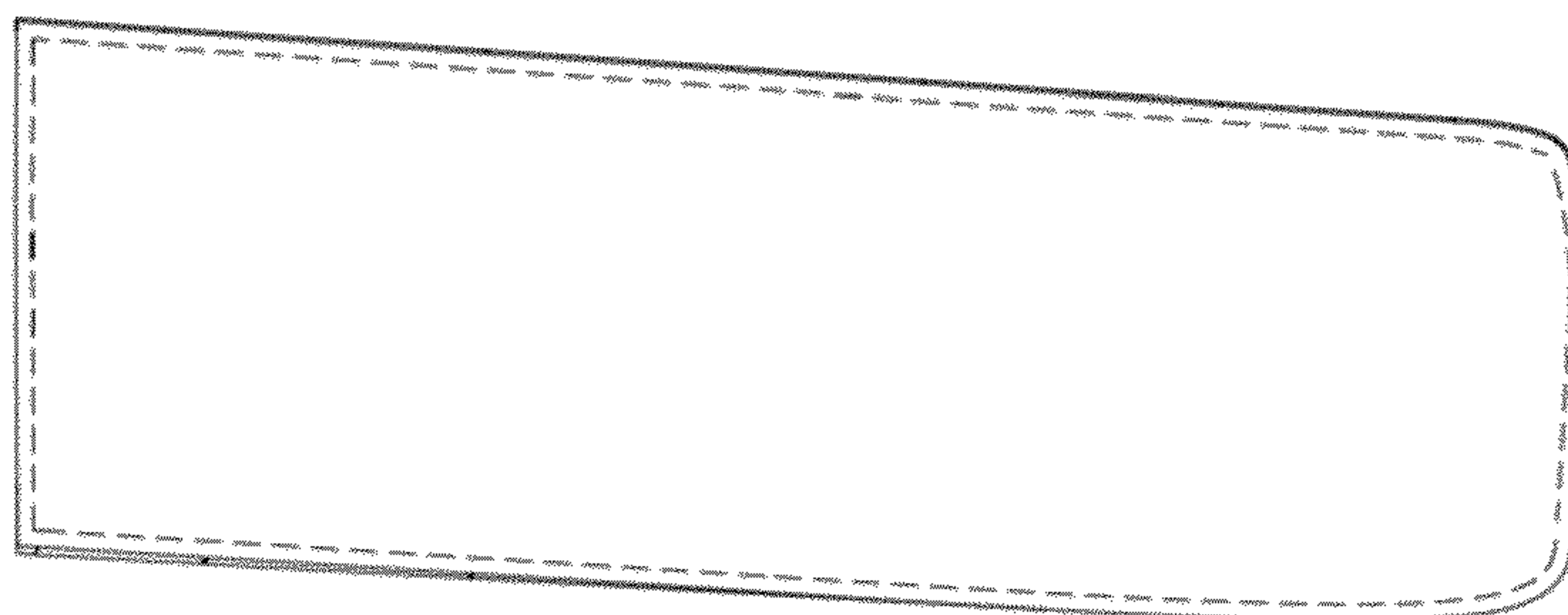

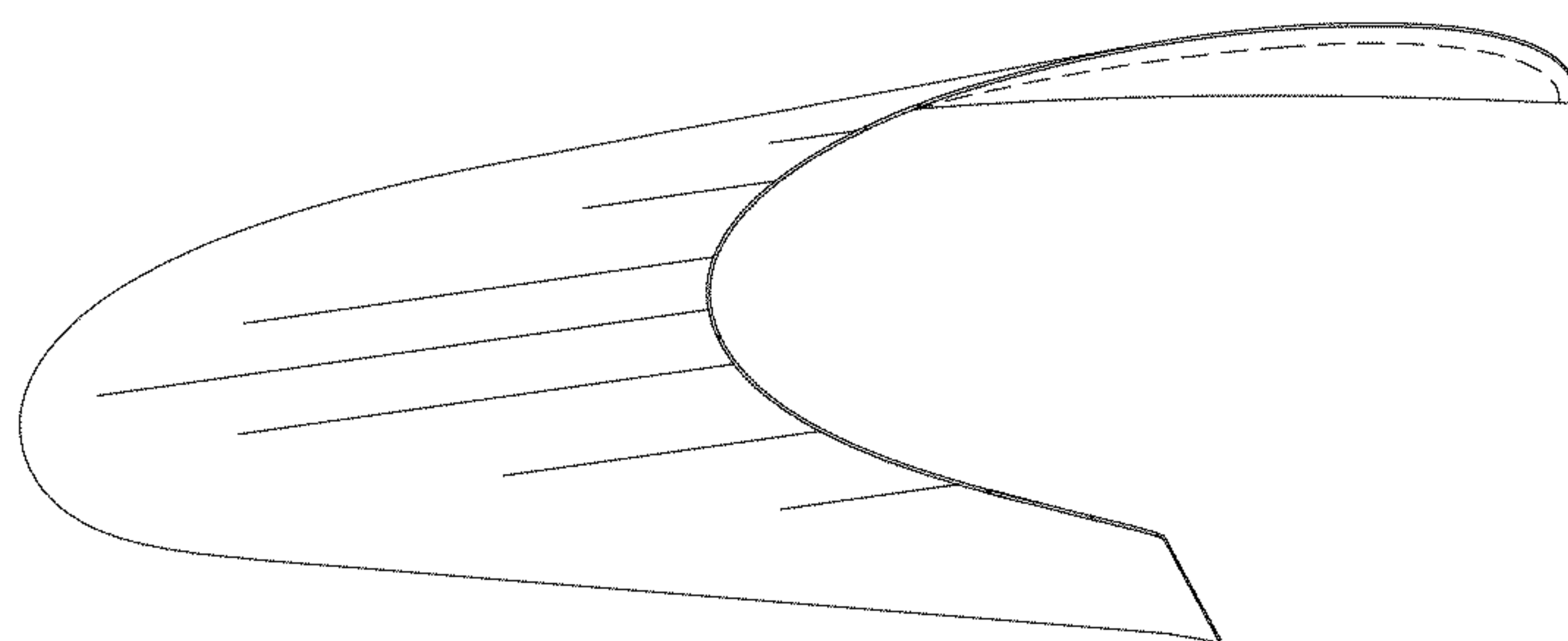

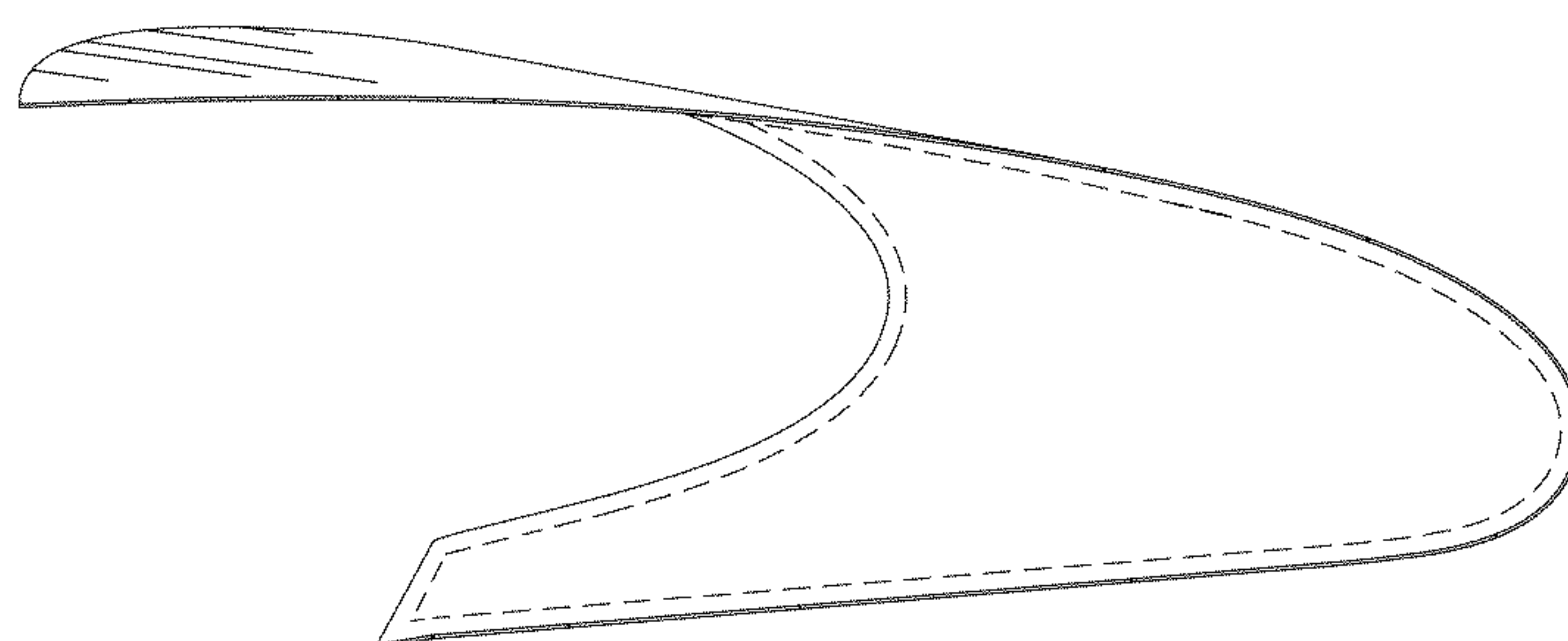

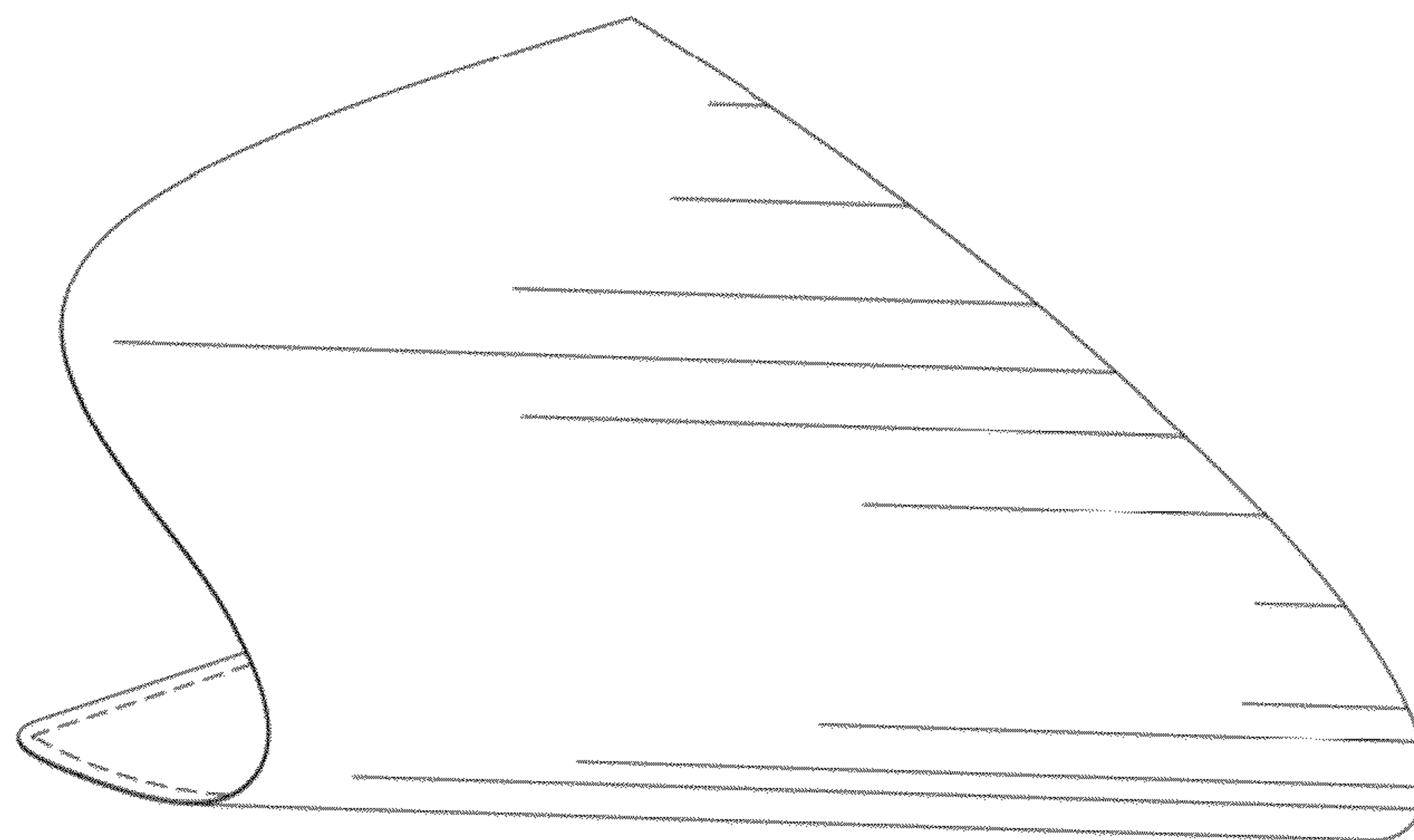

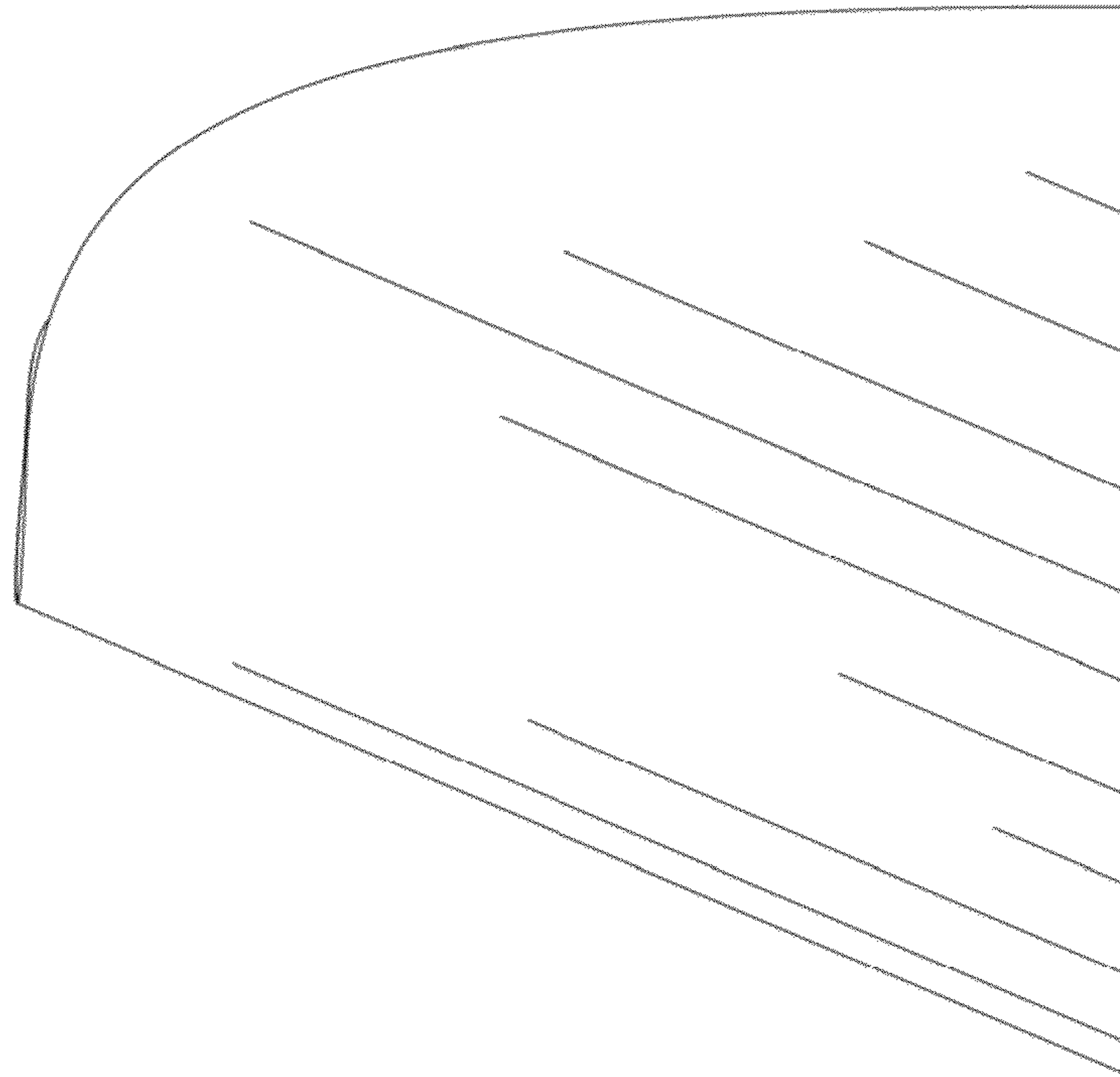

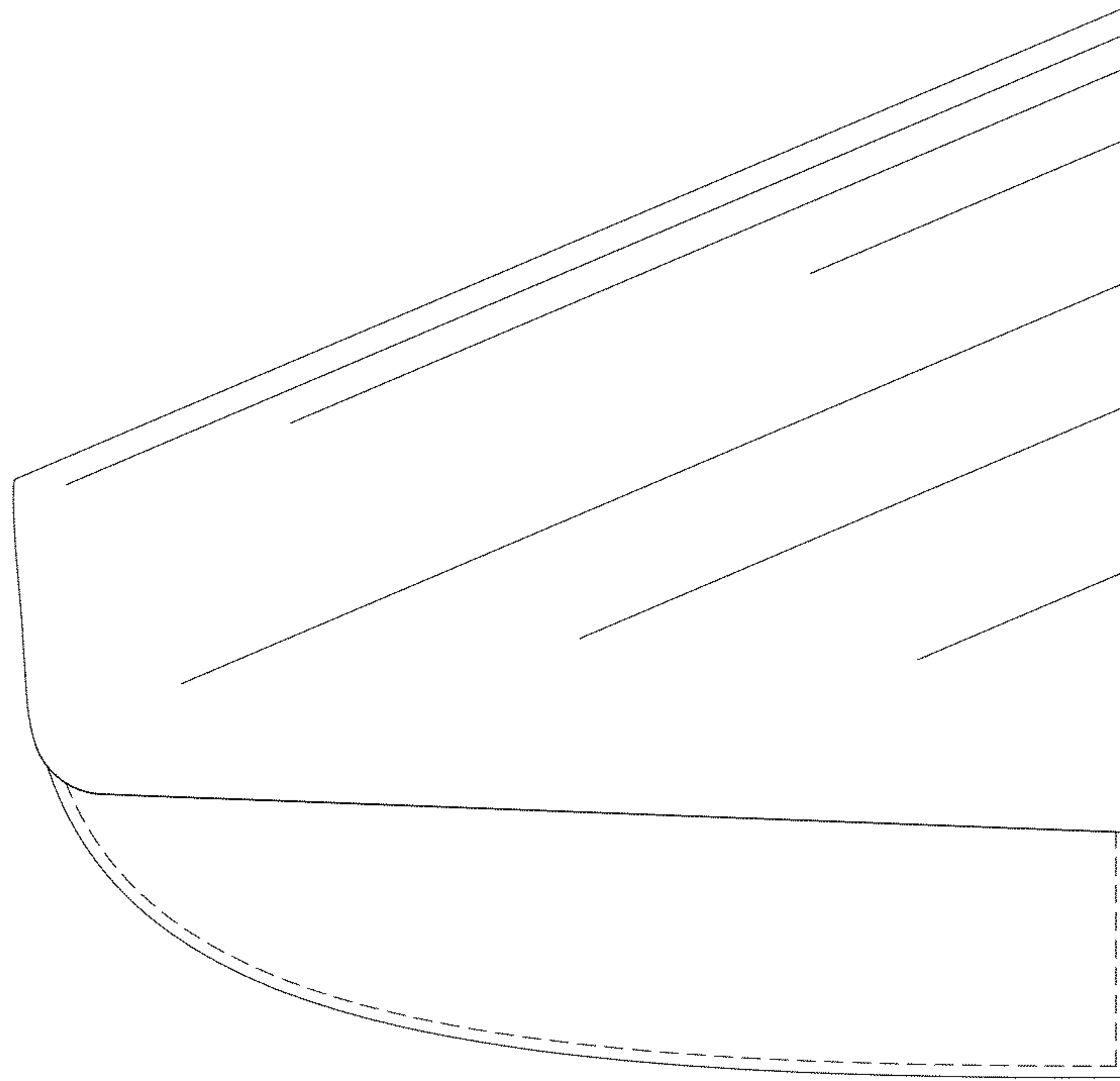

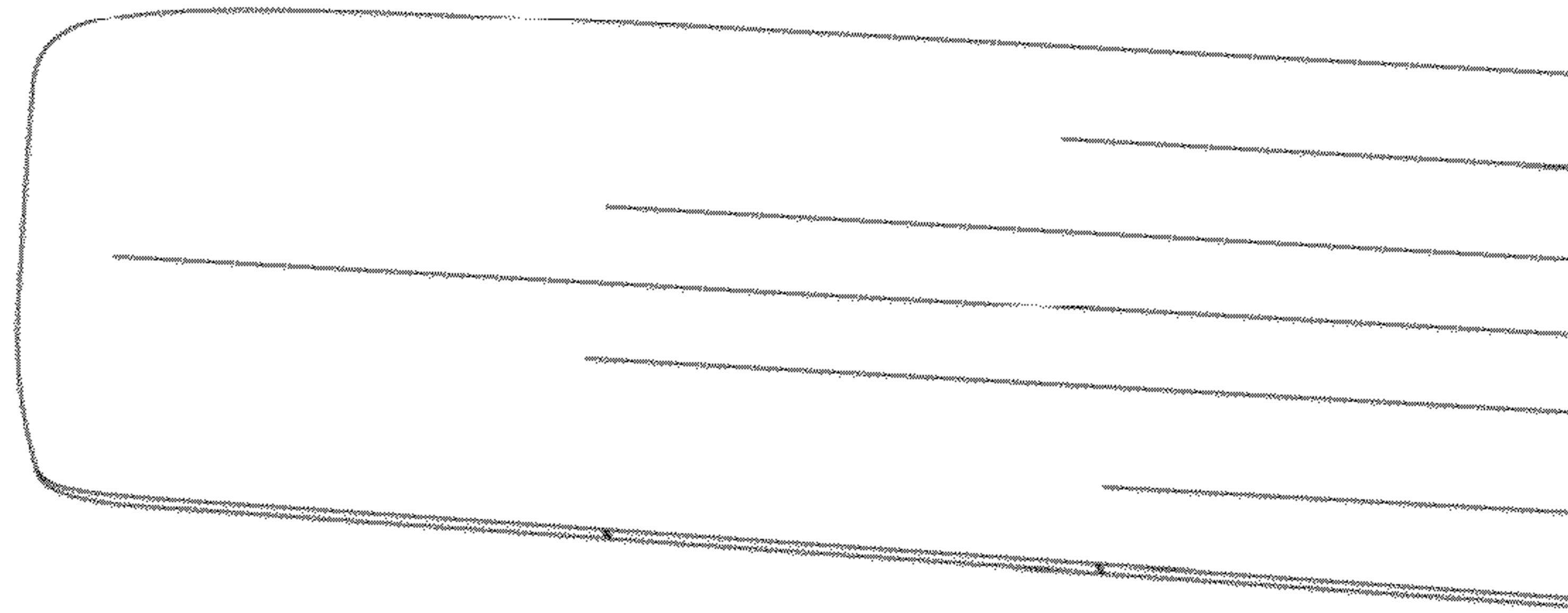

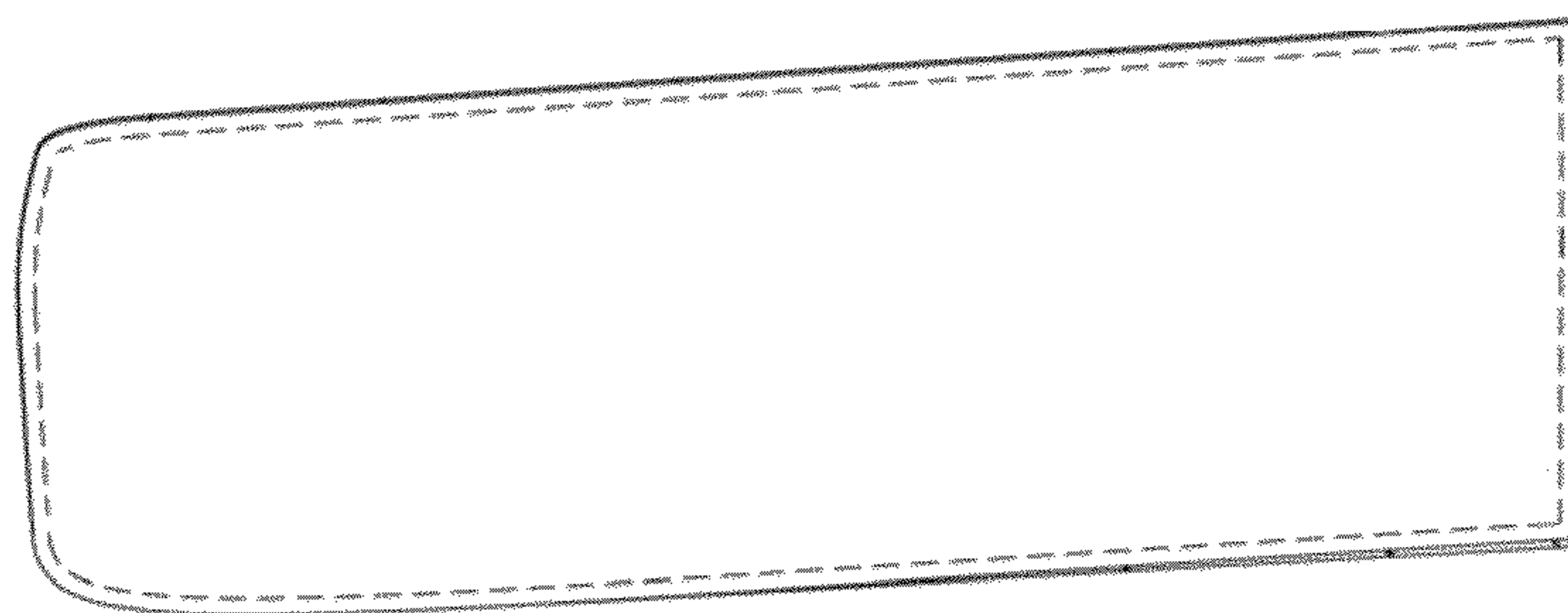

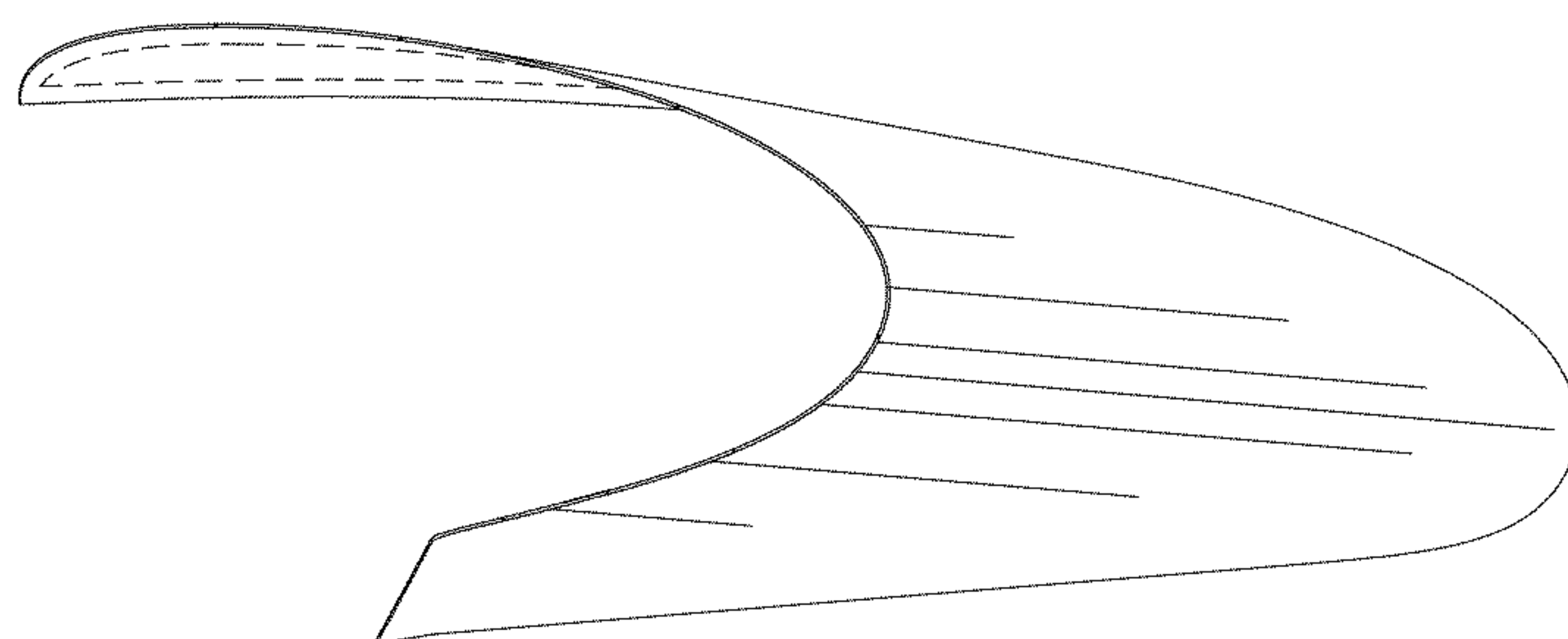

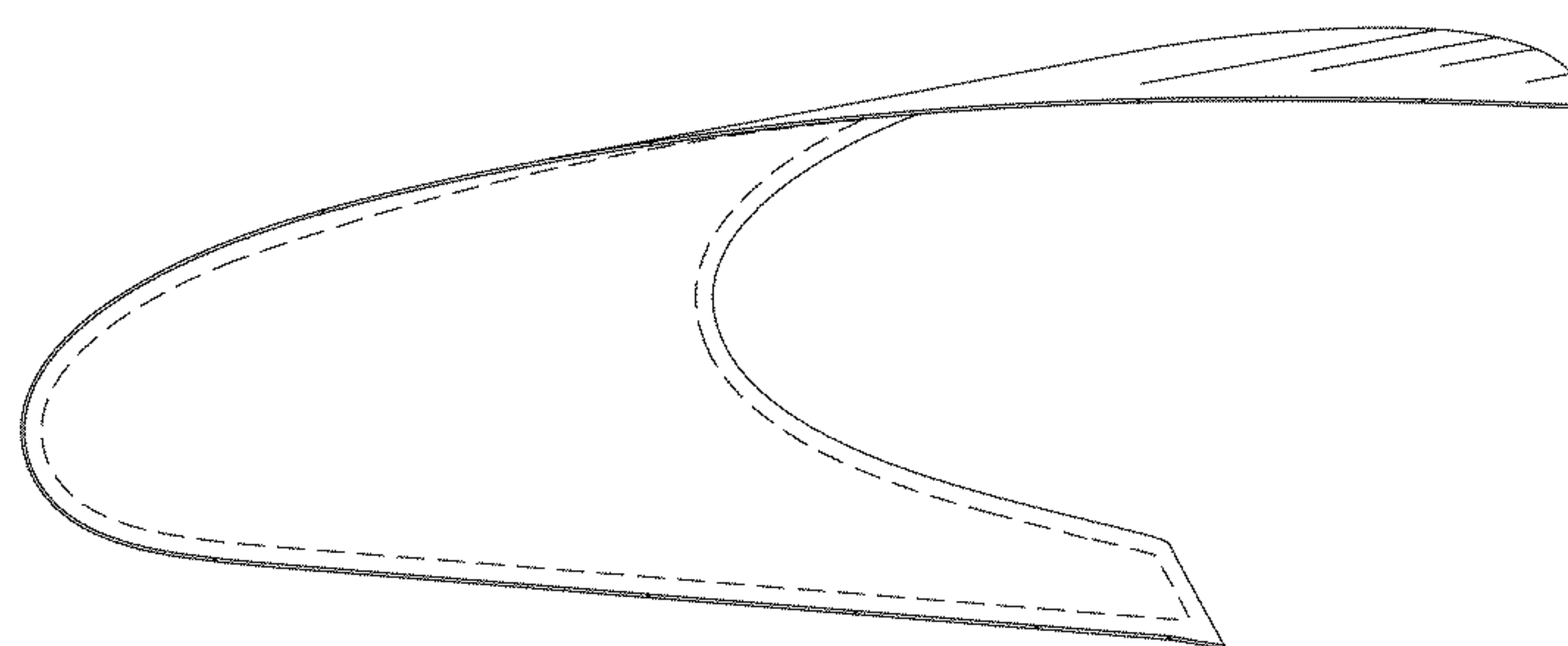
