(57) **CLAIM**
The ornamental design for a television with sliding speakers, as shown and described.

DESCRIPTION

FIG. 1 is a first front, side, and top perspective view of a television with sliding speakers in a first position showing my design;

FIG. 2 is a first rear, side, and top perspective view of FIG. 1;

FIG. 3 is a first front elevation view of FIG. 1;

FIG. 4 is a first rear elevation view of FIG. 1;

FIG. 5 is a first right side elevation view of FIG. 1, wherein a first left side elevation view is a mirror image thereof;

FIG. 6 is a first top plan view of FIG. 1;

FIG. 7 is a first bottom plan view of FIG. 1;

FIG. 8 is a second front, side, and top perspective view;

FIG. 9 is a second rear, side, and top perspective view;

FIG. 10 is a second front elevation view;

FIG. 11 is a second rear elevation view;

FIG. 12 is a second left side elevation view, wherein a second right side elevation view is a mirror image thereof;

FIG. 17 is a front elevation view of FIG. 15;

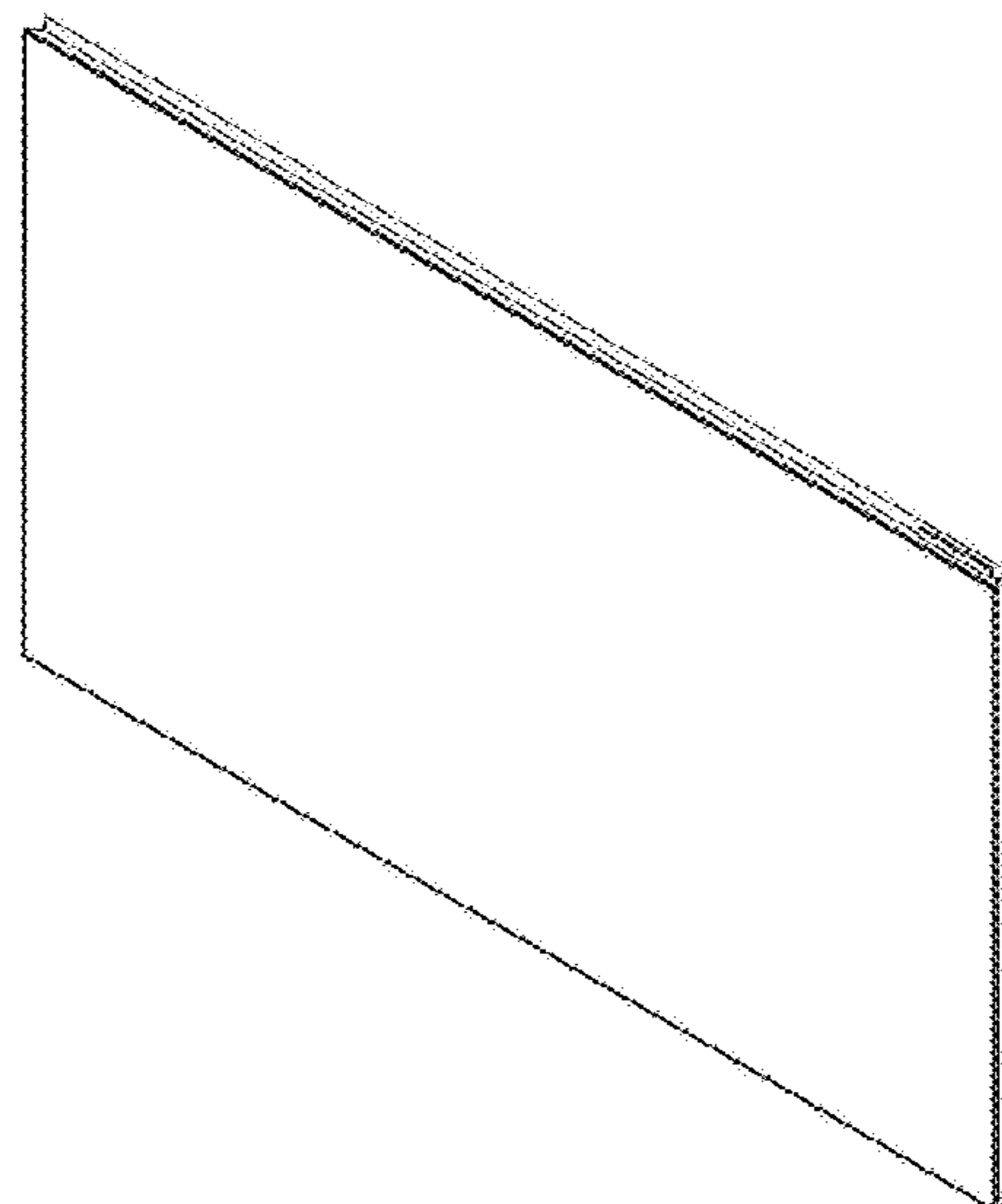
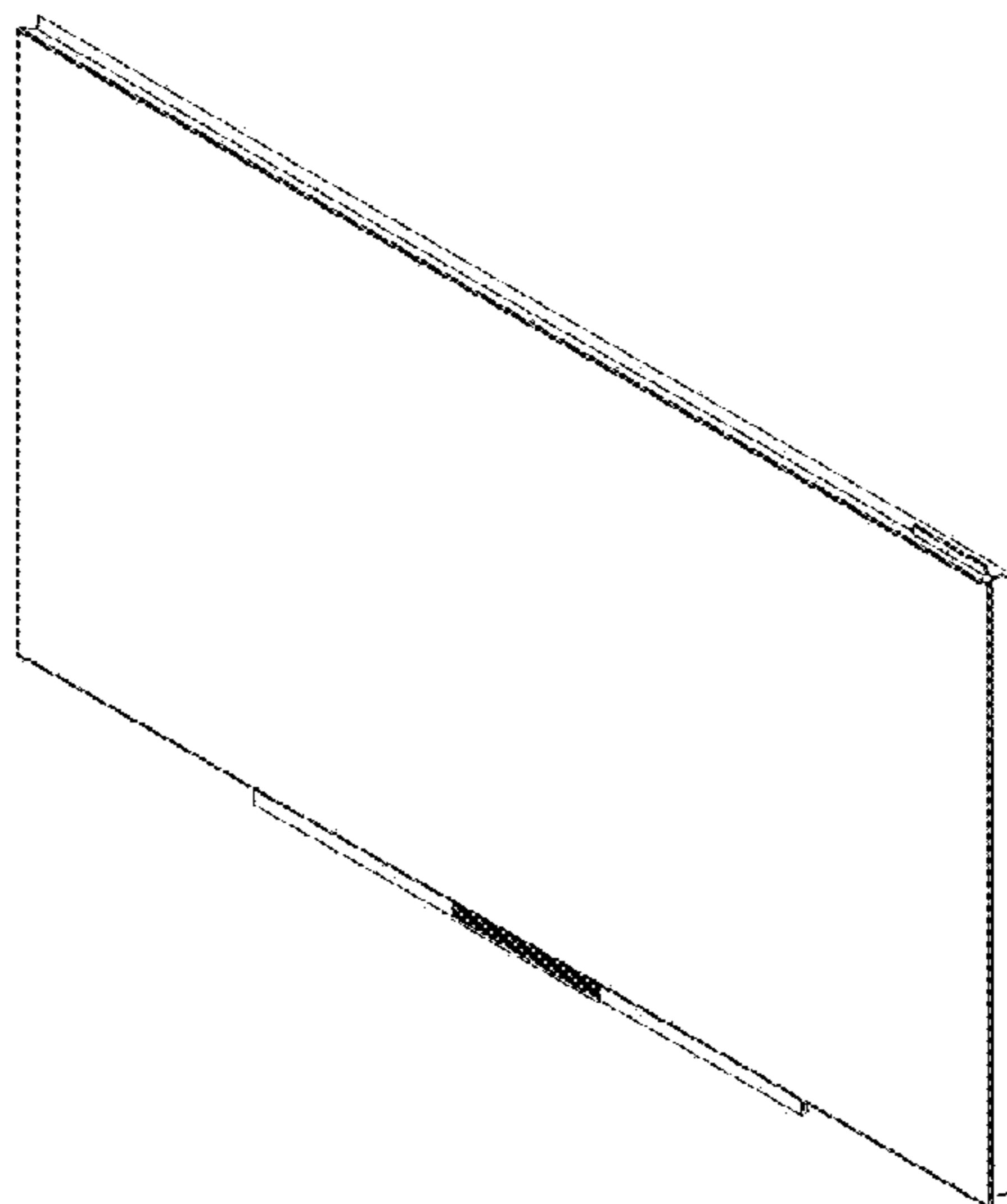
FIG. 18 is a rear elevation view of FIG. 15;

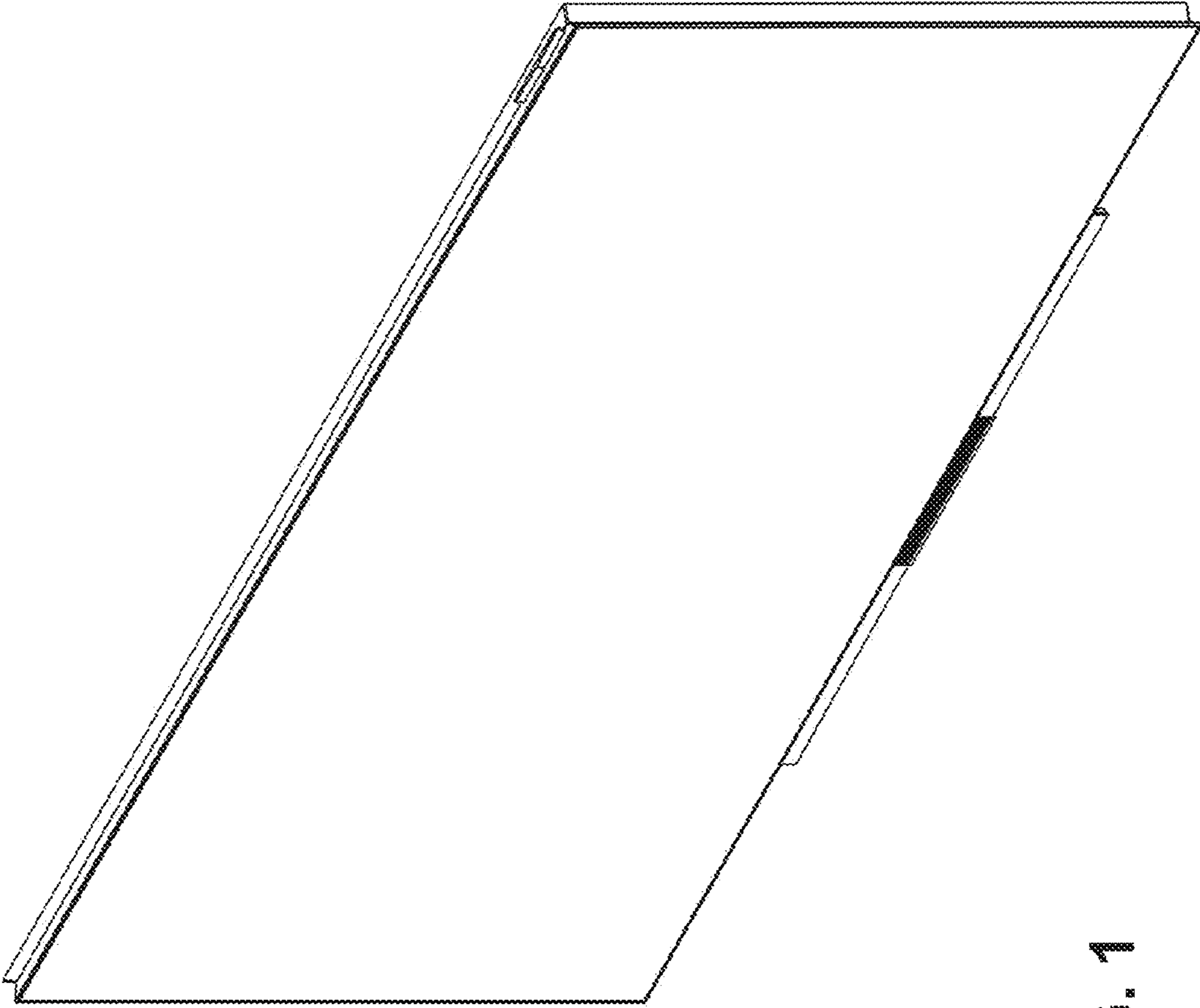

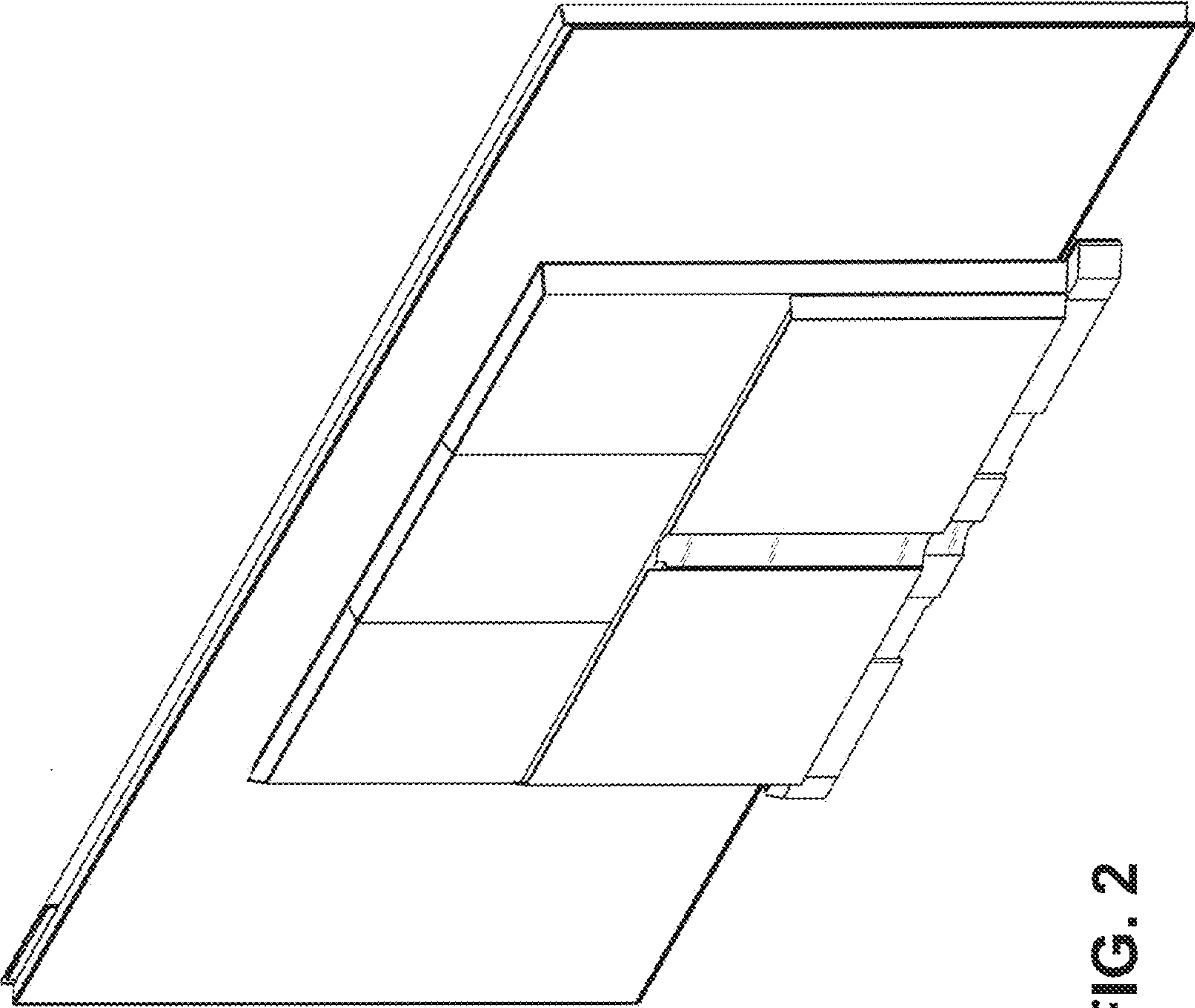

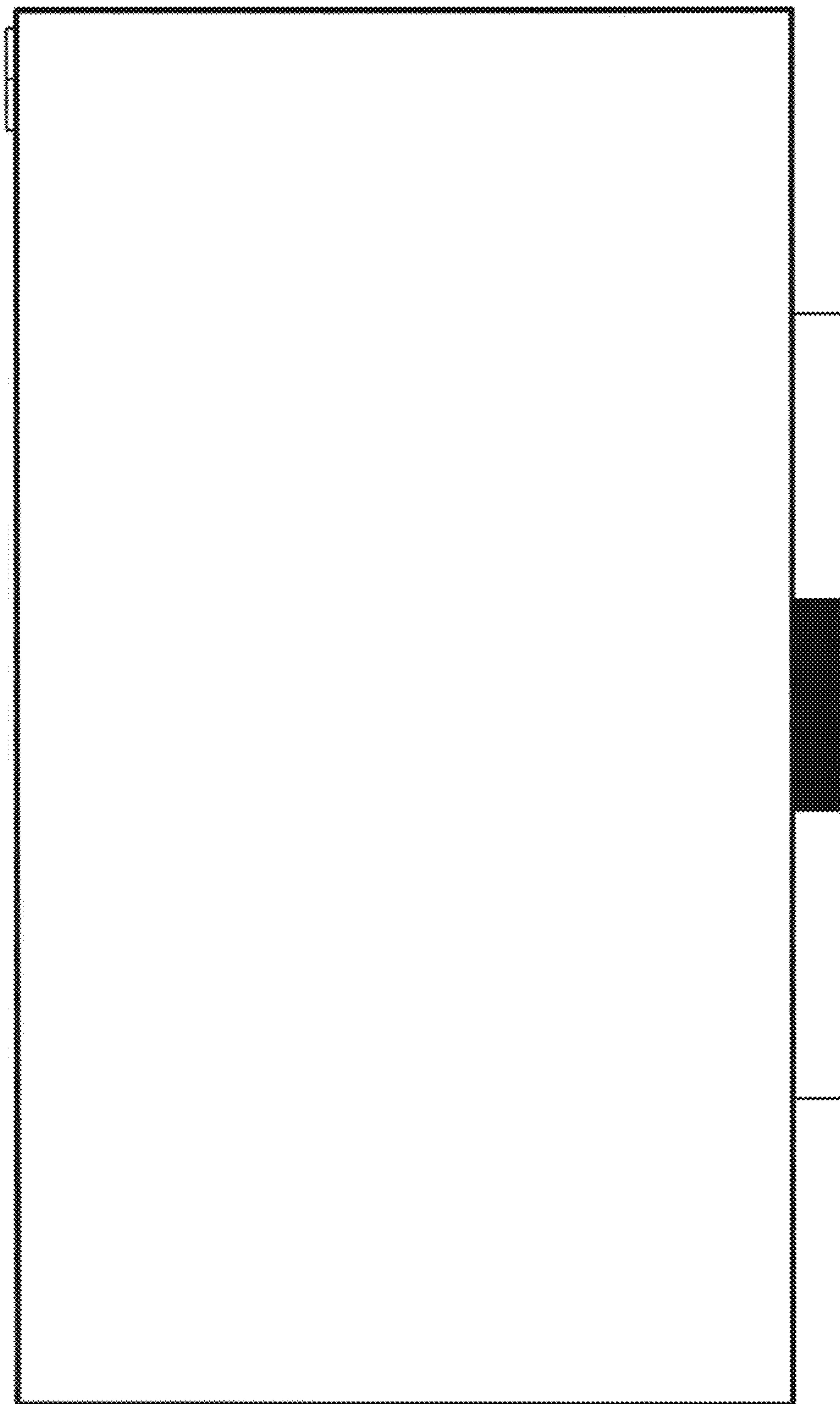

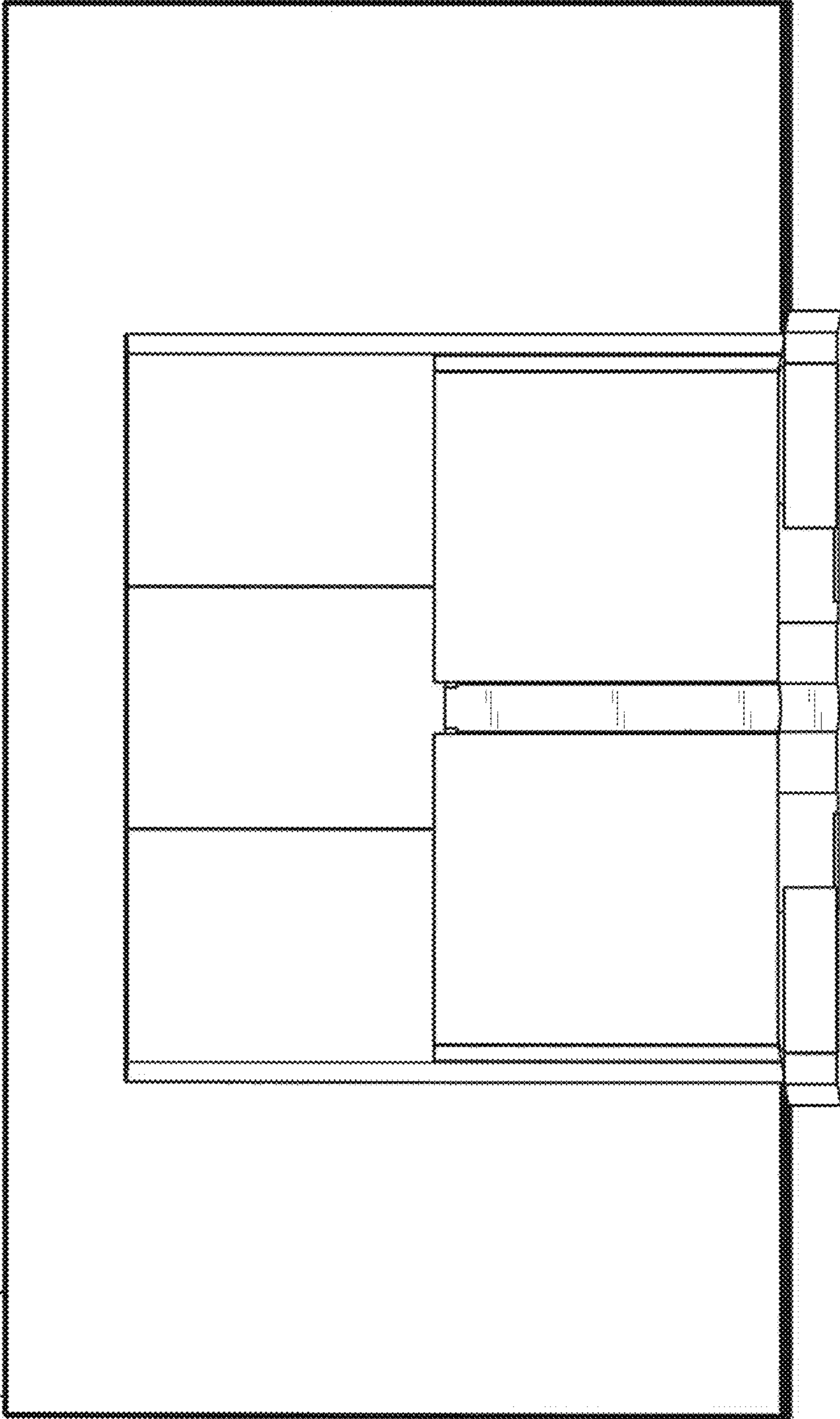

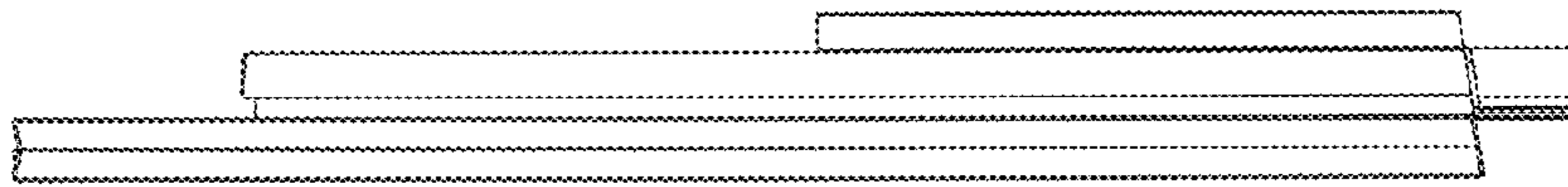

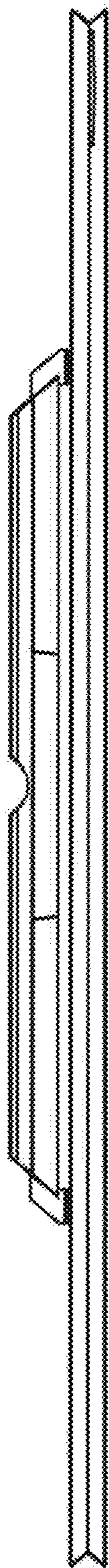

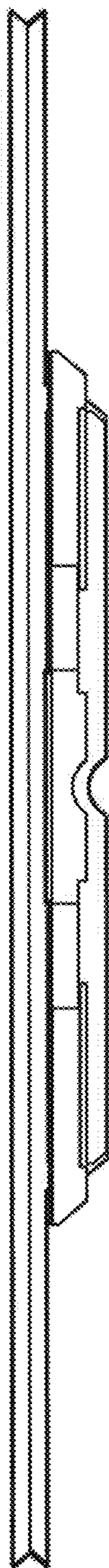

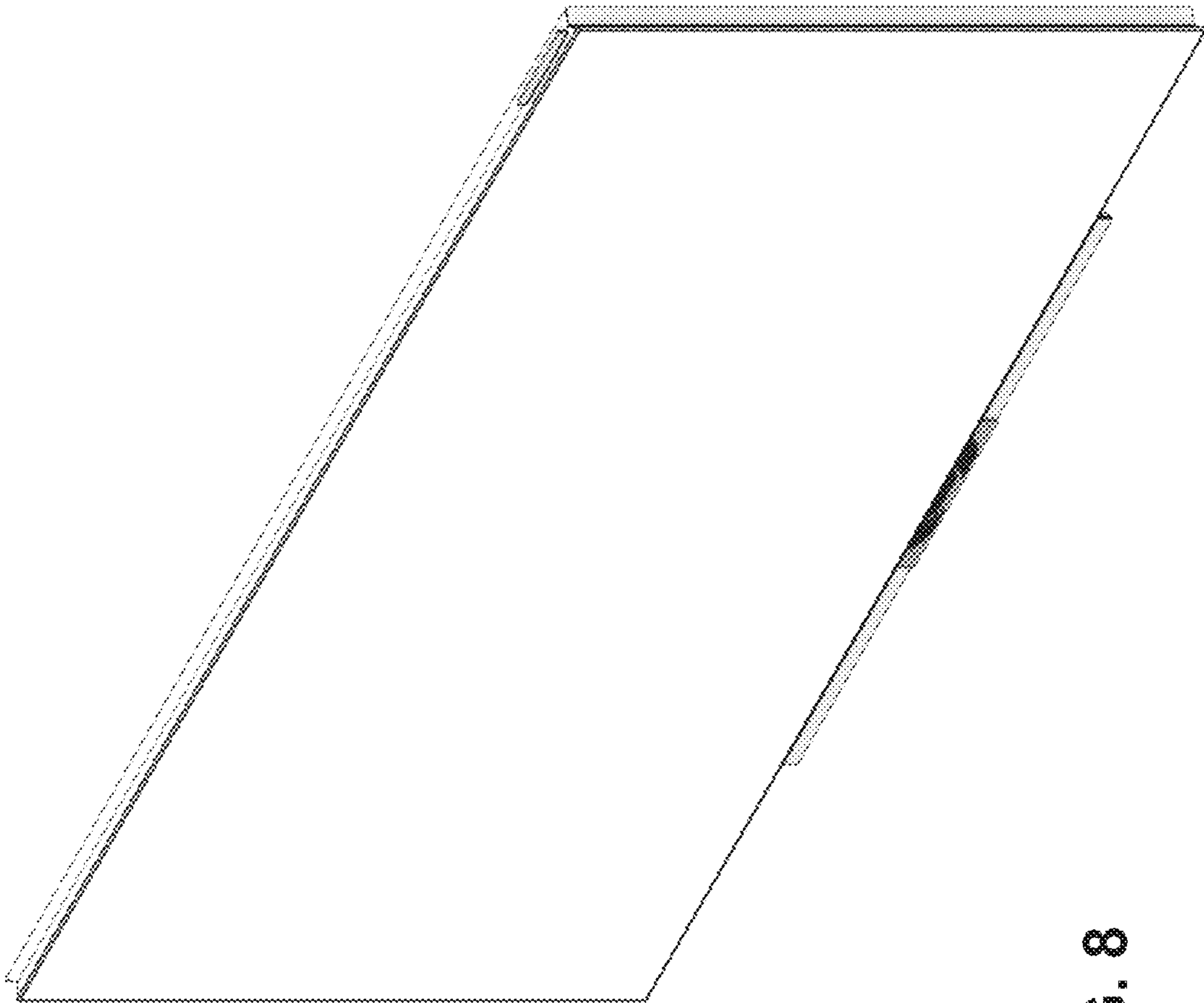

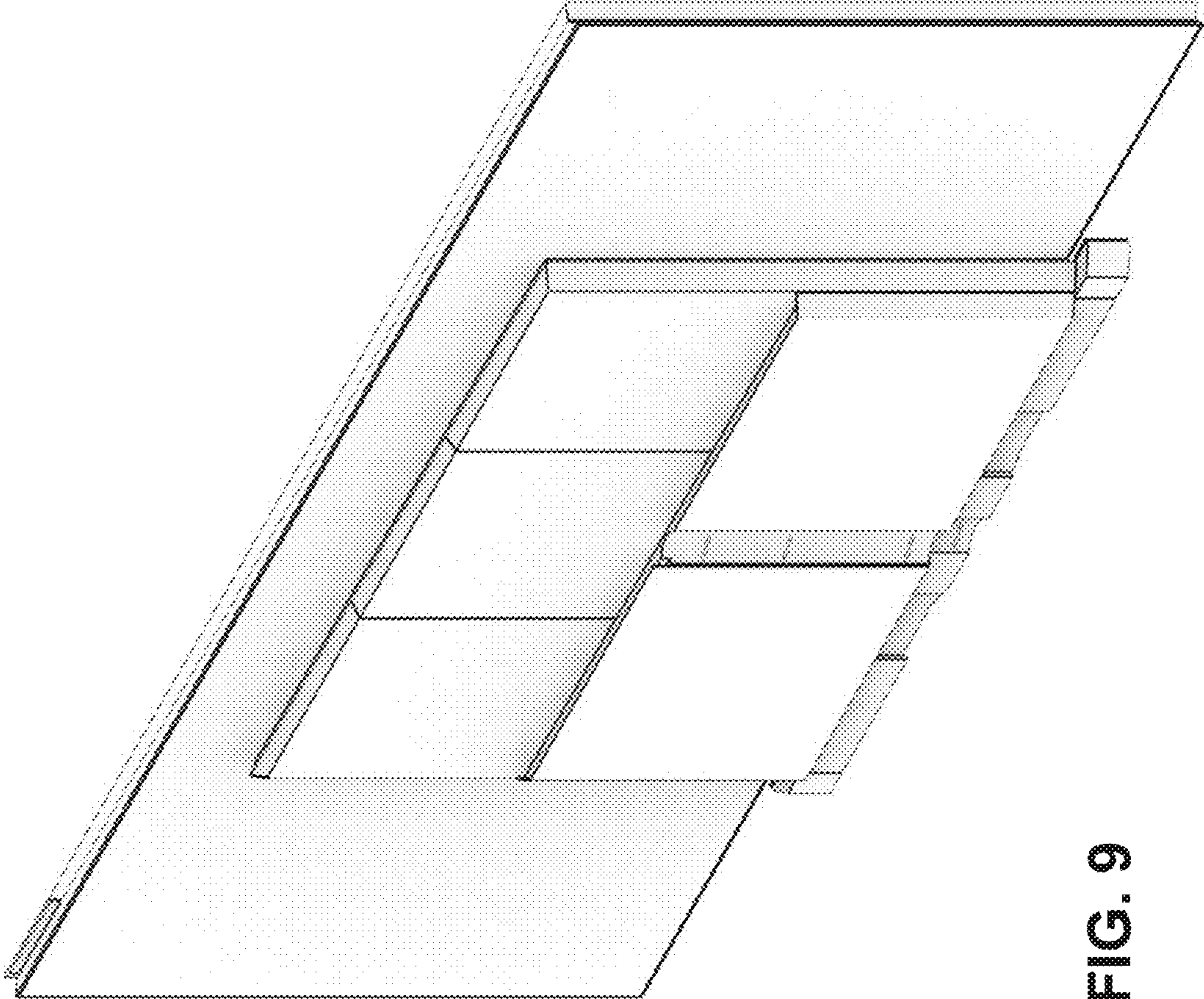

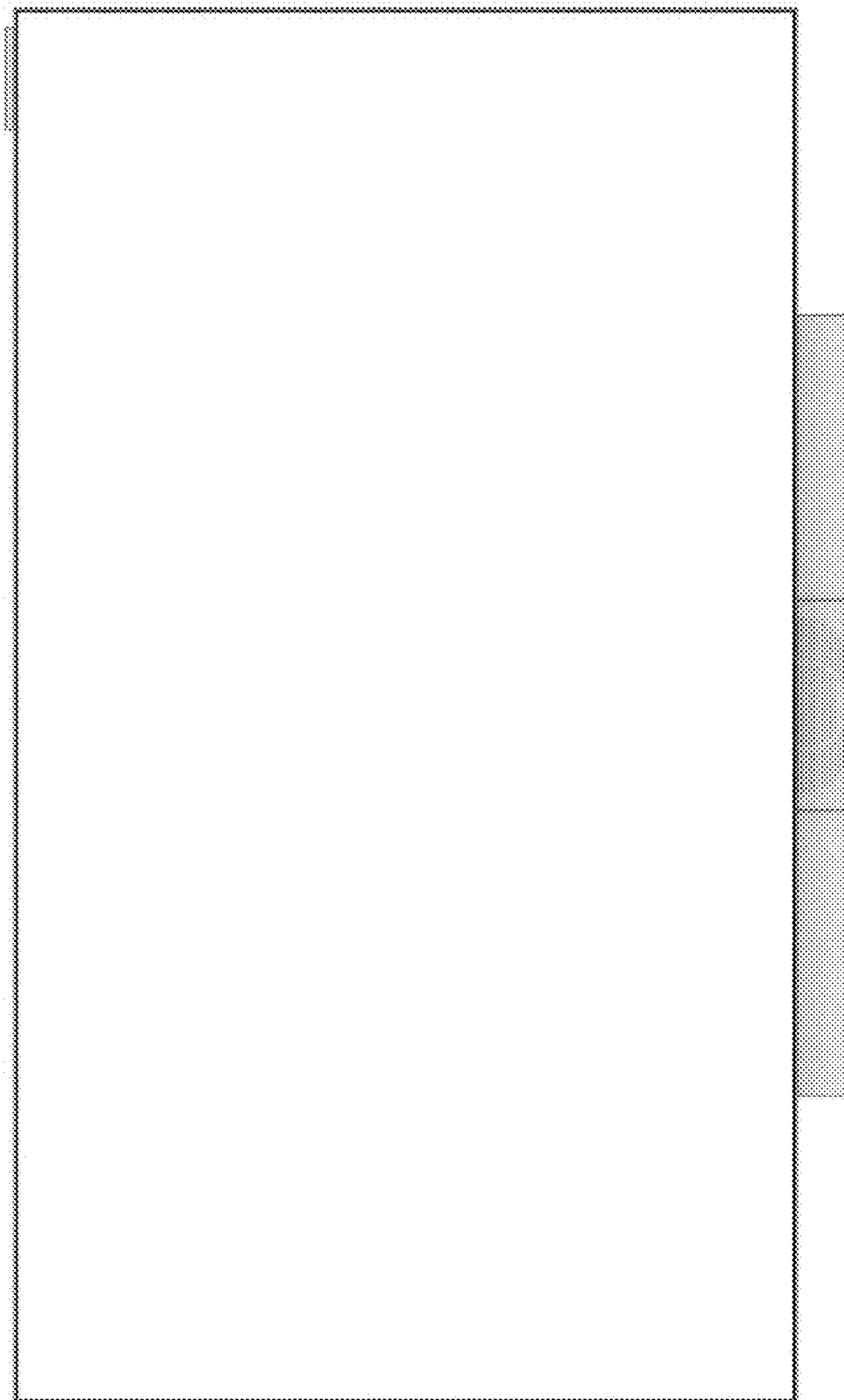

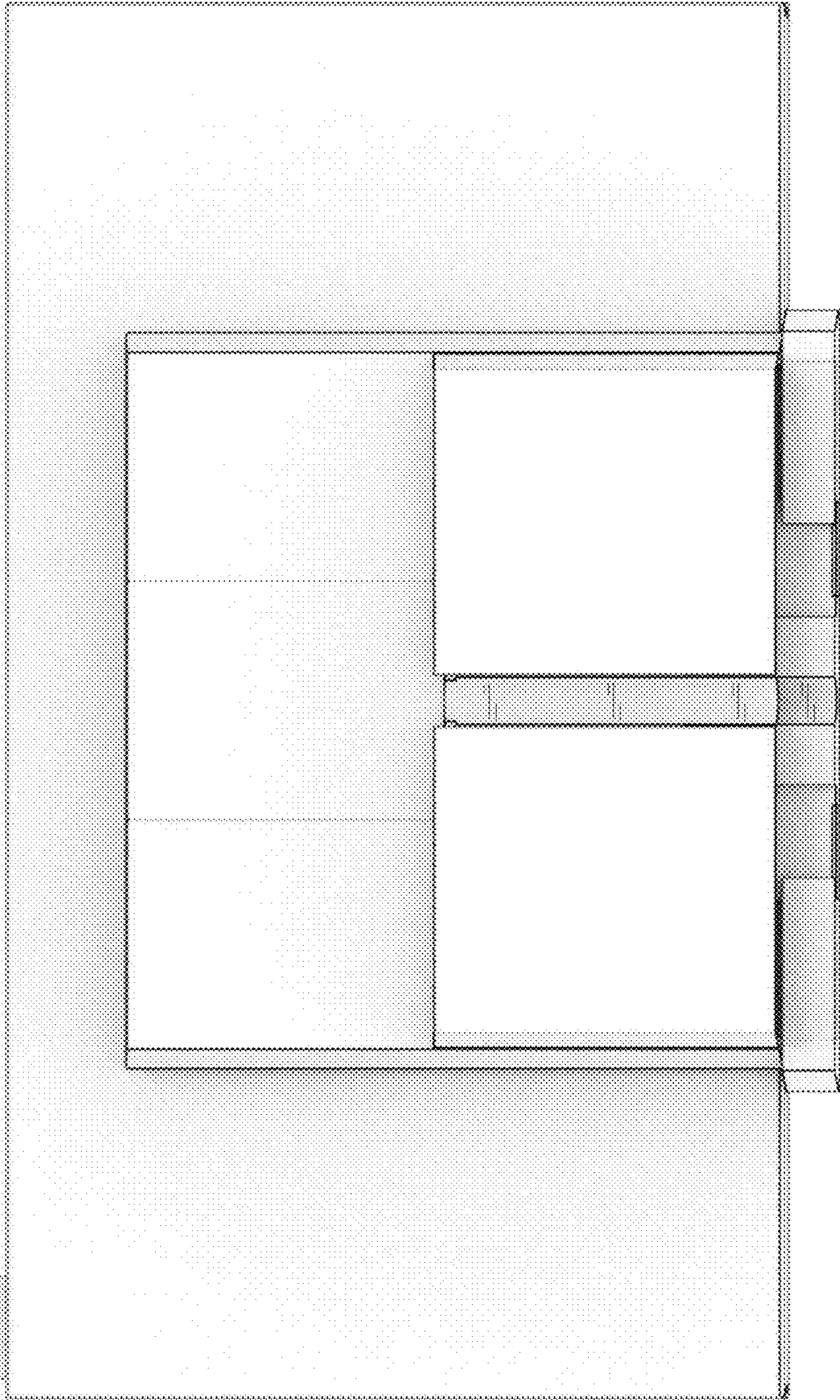

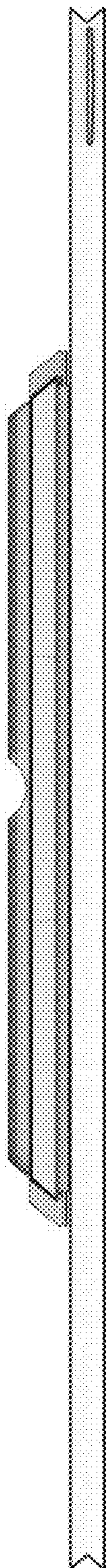

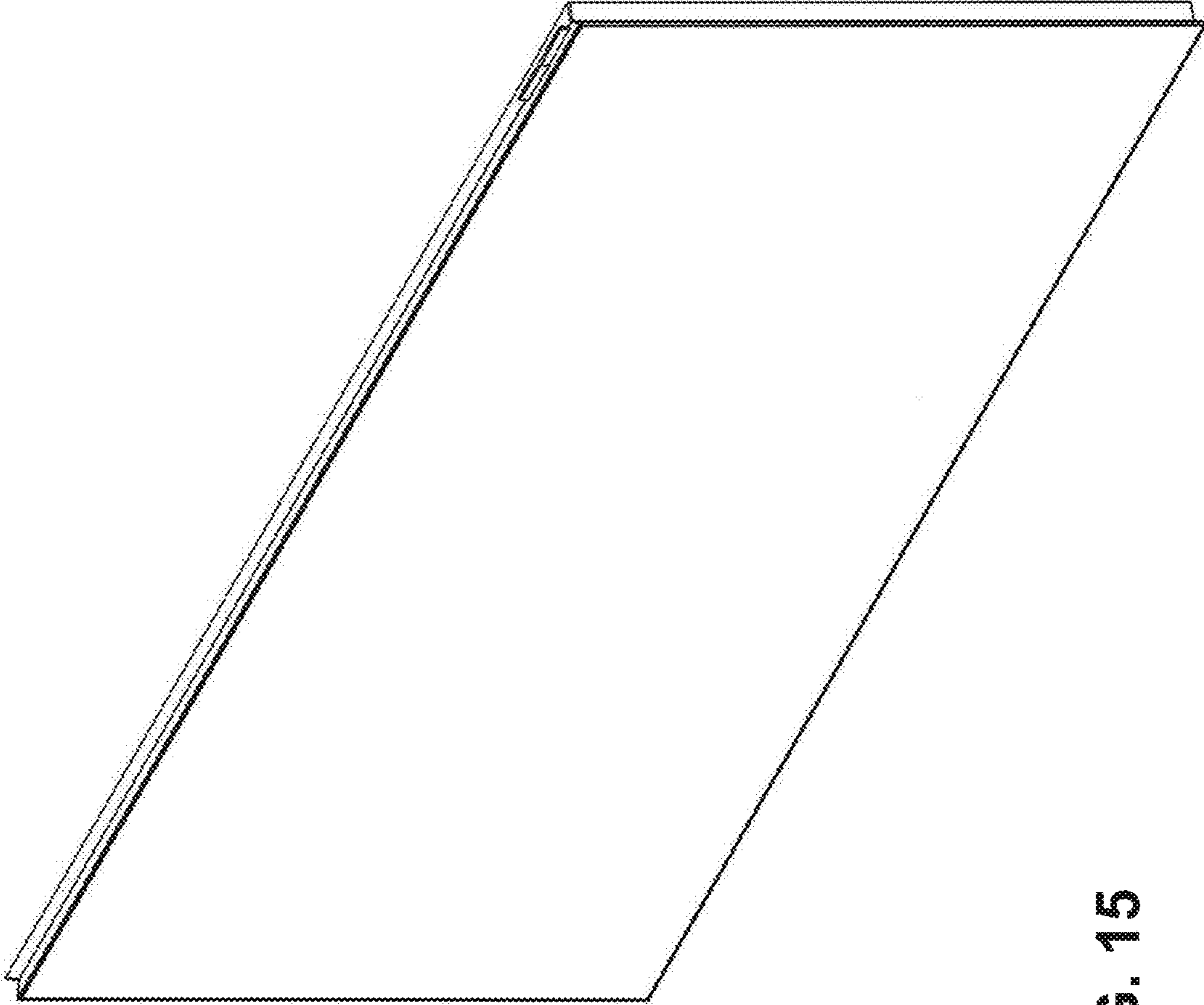

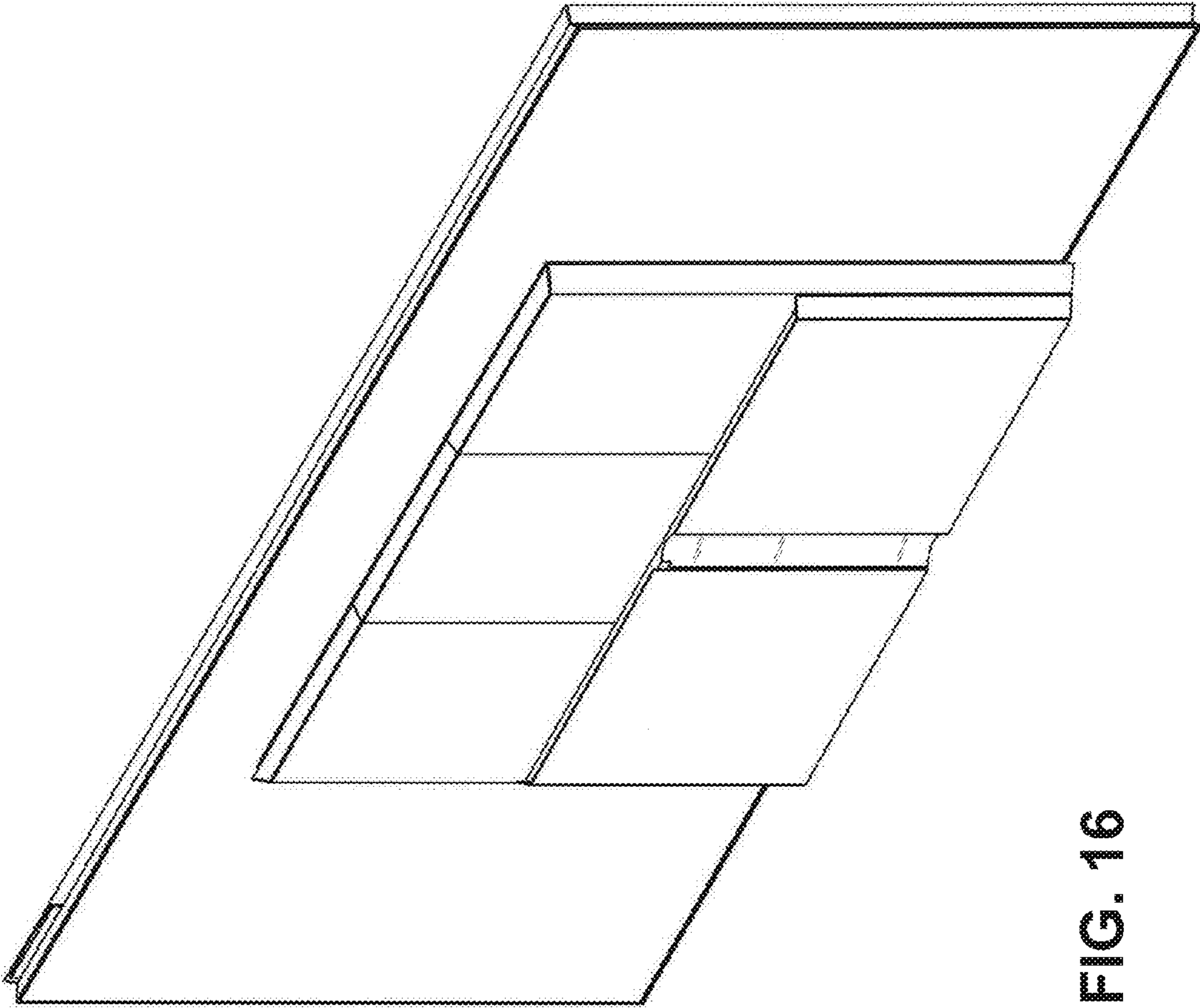

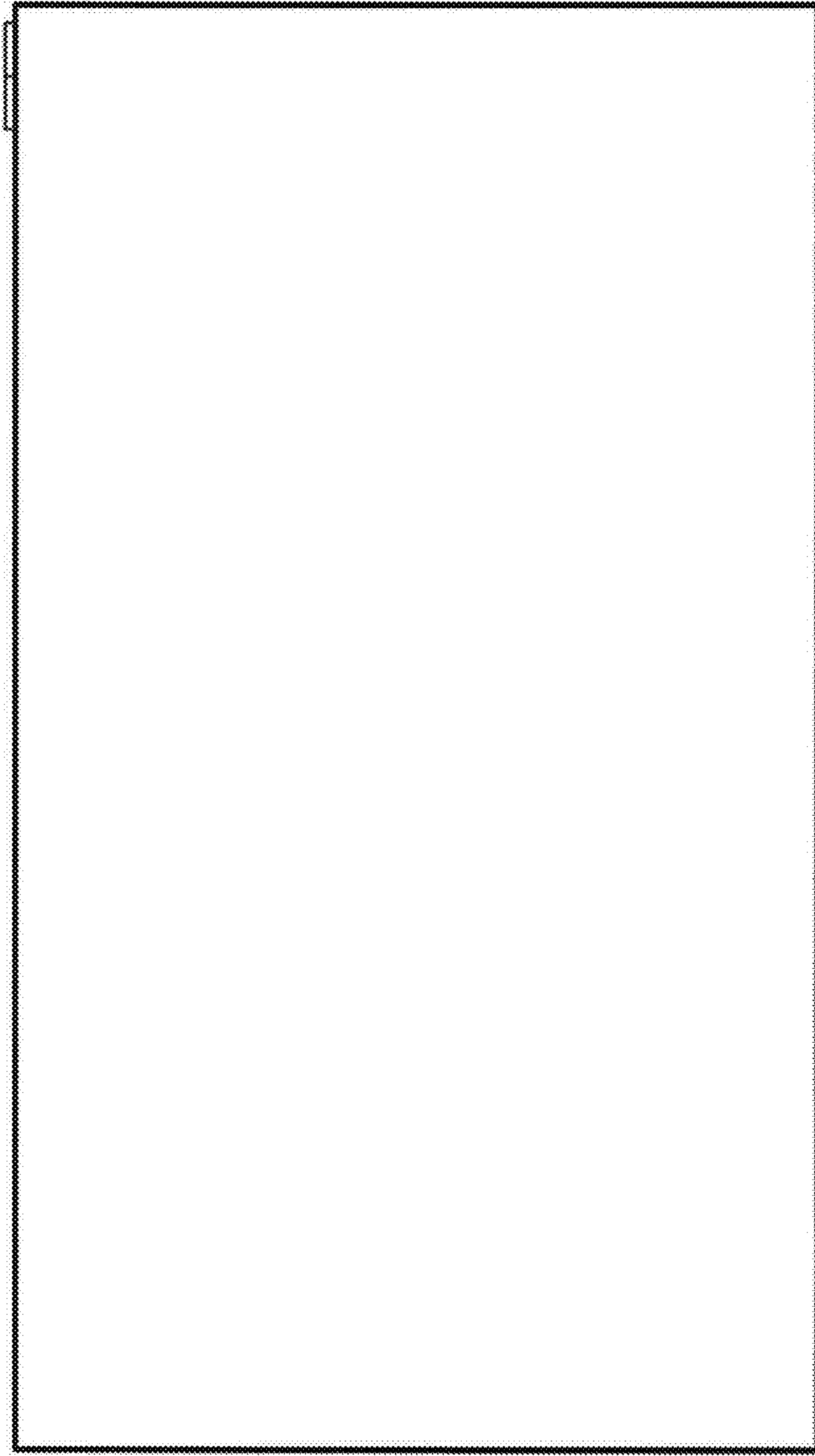

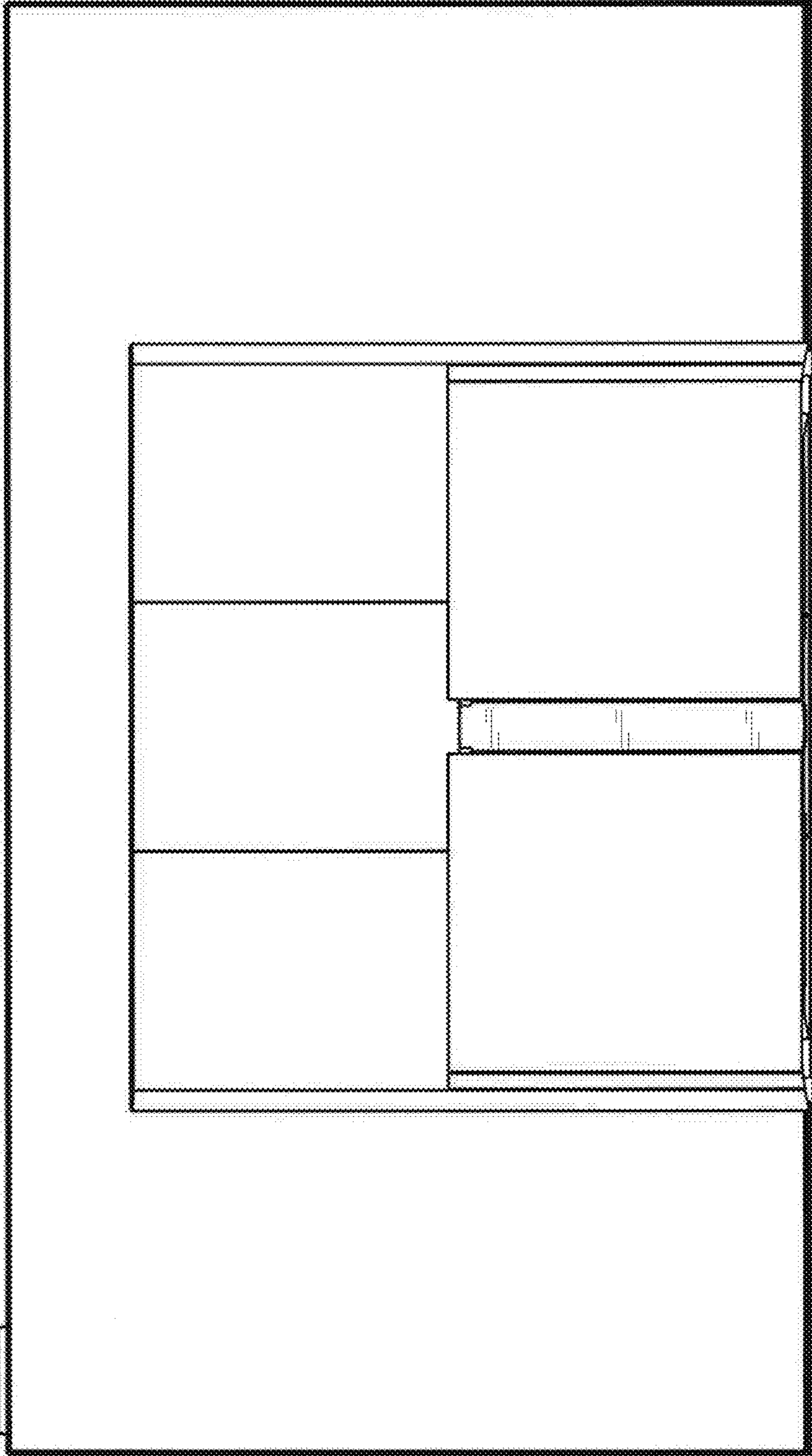

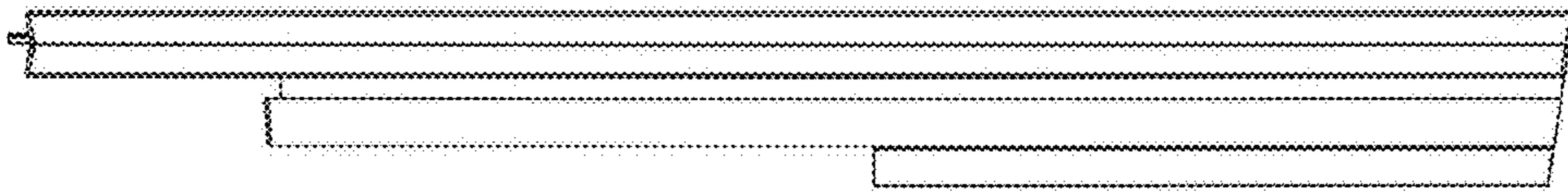

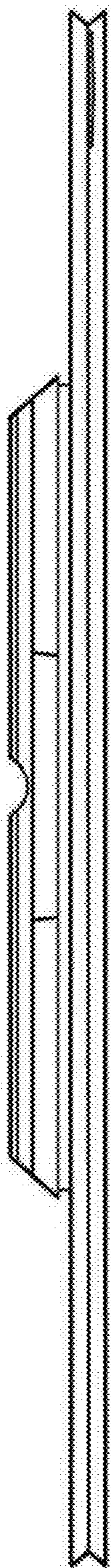

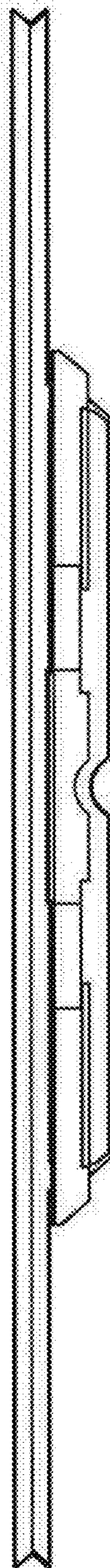
