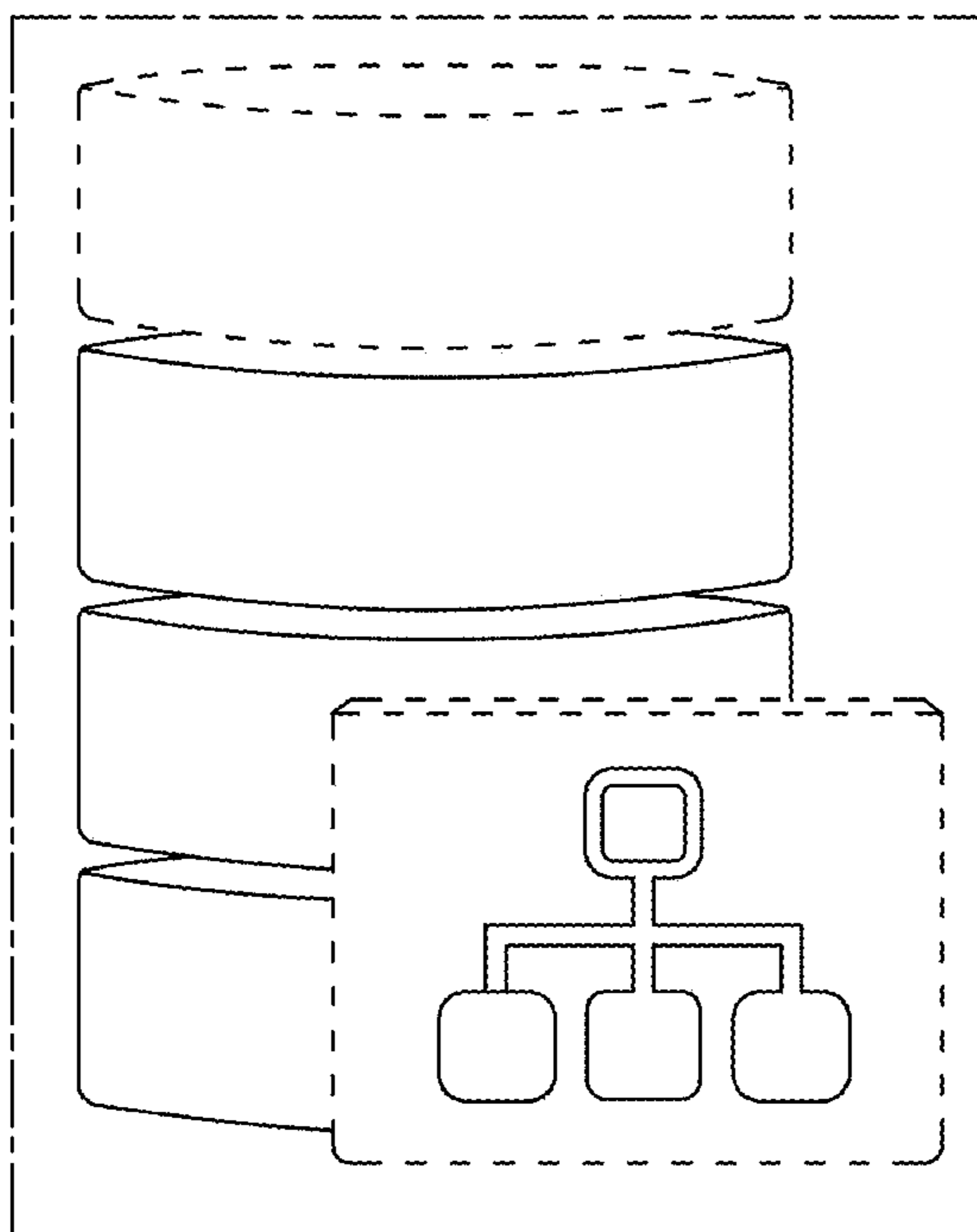
(57) **CLAIM**

The ornamental design for an display screen or portion thereof with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an icon for a portion of a display screen showing my new design; and, FIG. 2 is a front view of a second embodiment thereof. In the drawings, dot-dash broken lines show the boundaries of the claim. The evenly spaced dash-dash broken lines shows an display screen or portion thereof with icon that forms no part of the claimed design.

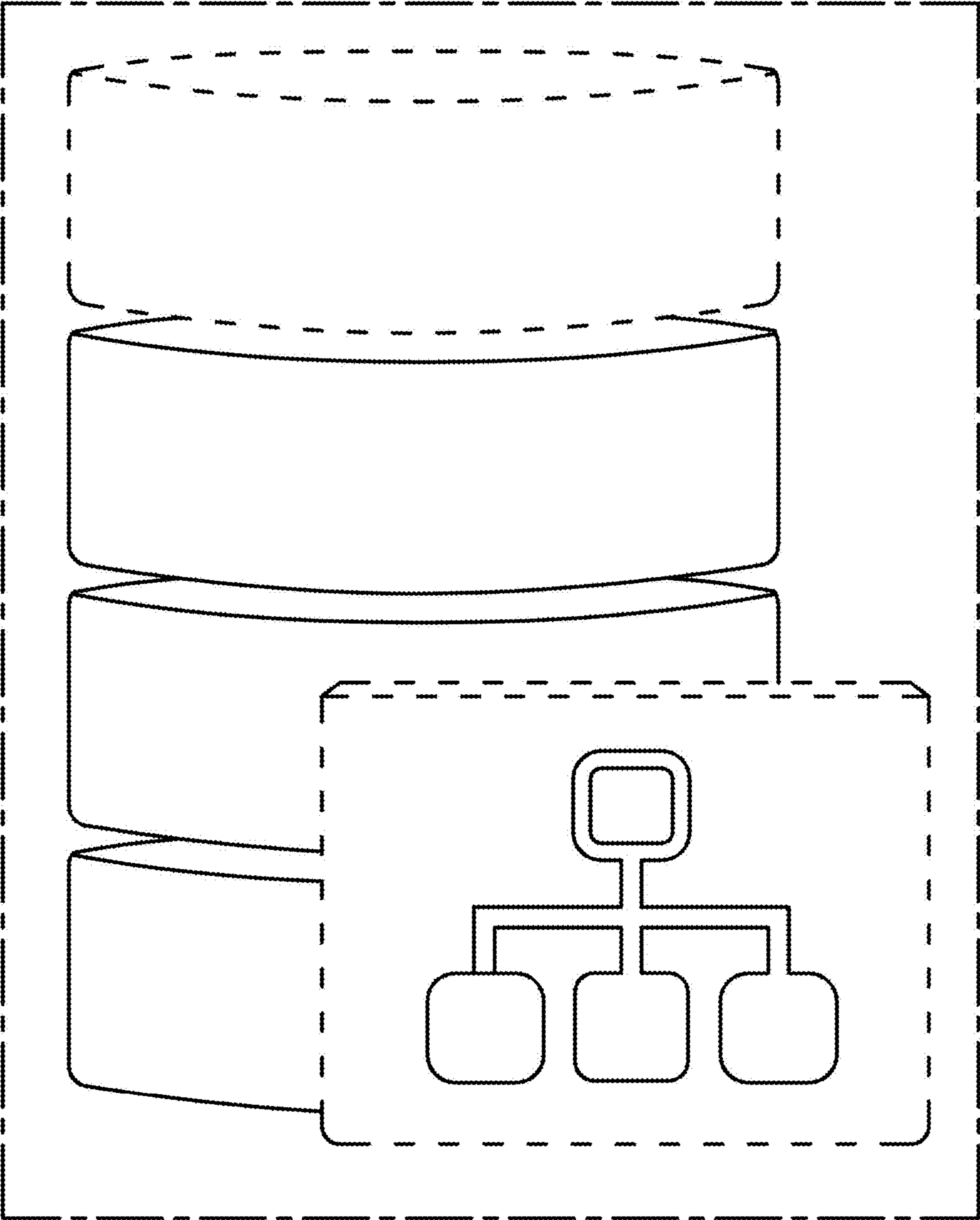

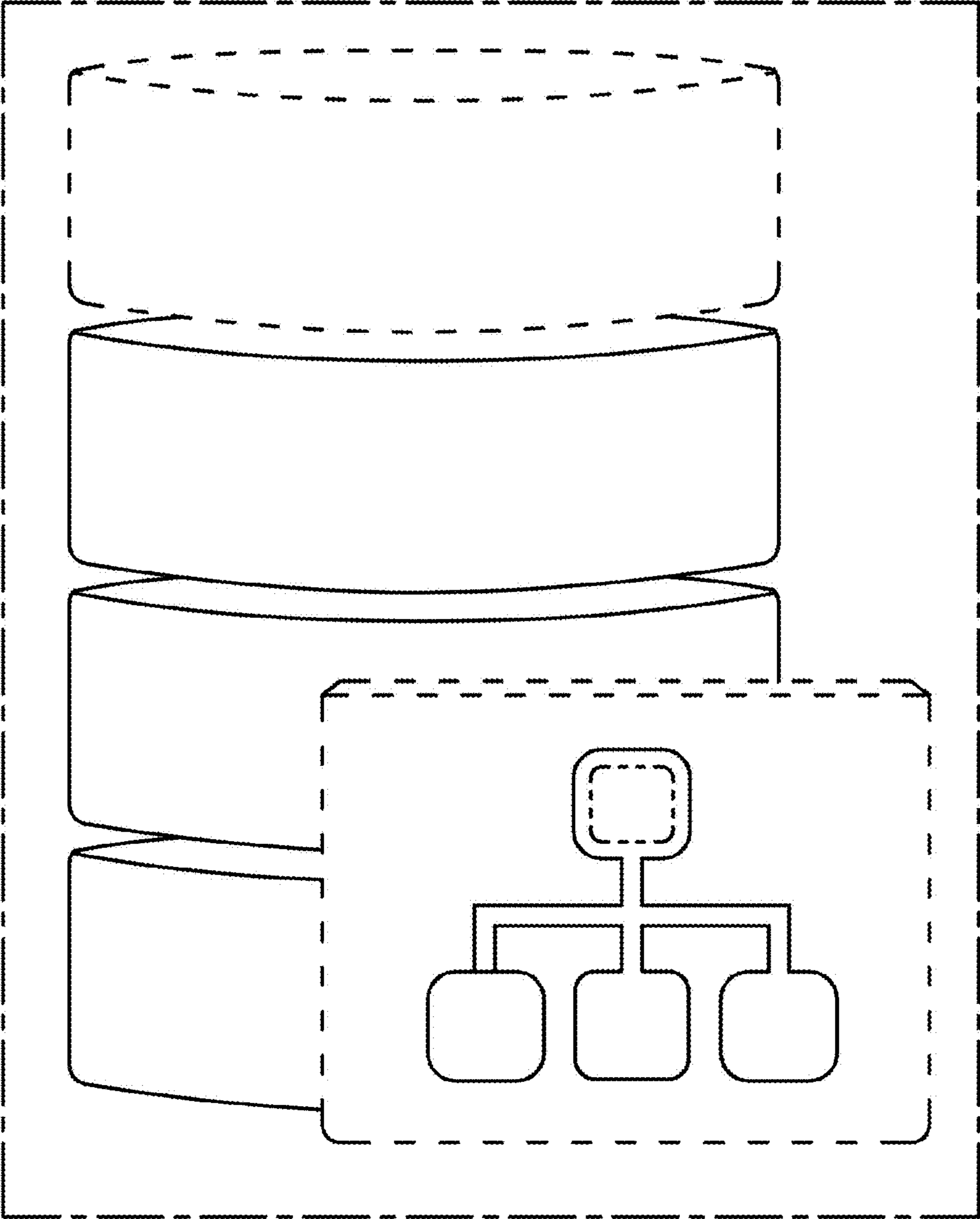
