The ornamental design for a display screen of a portion thereof with icon, as shown and described.

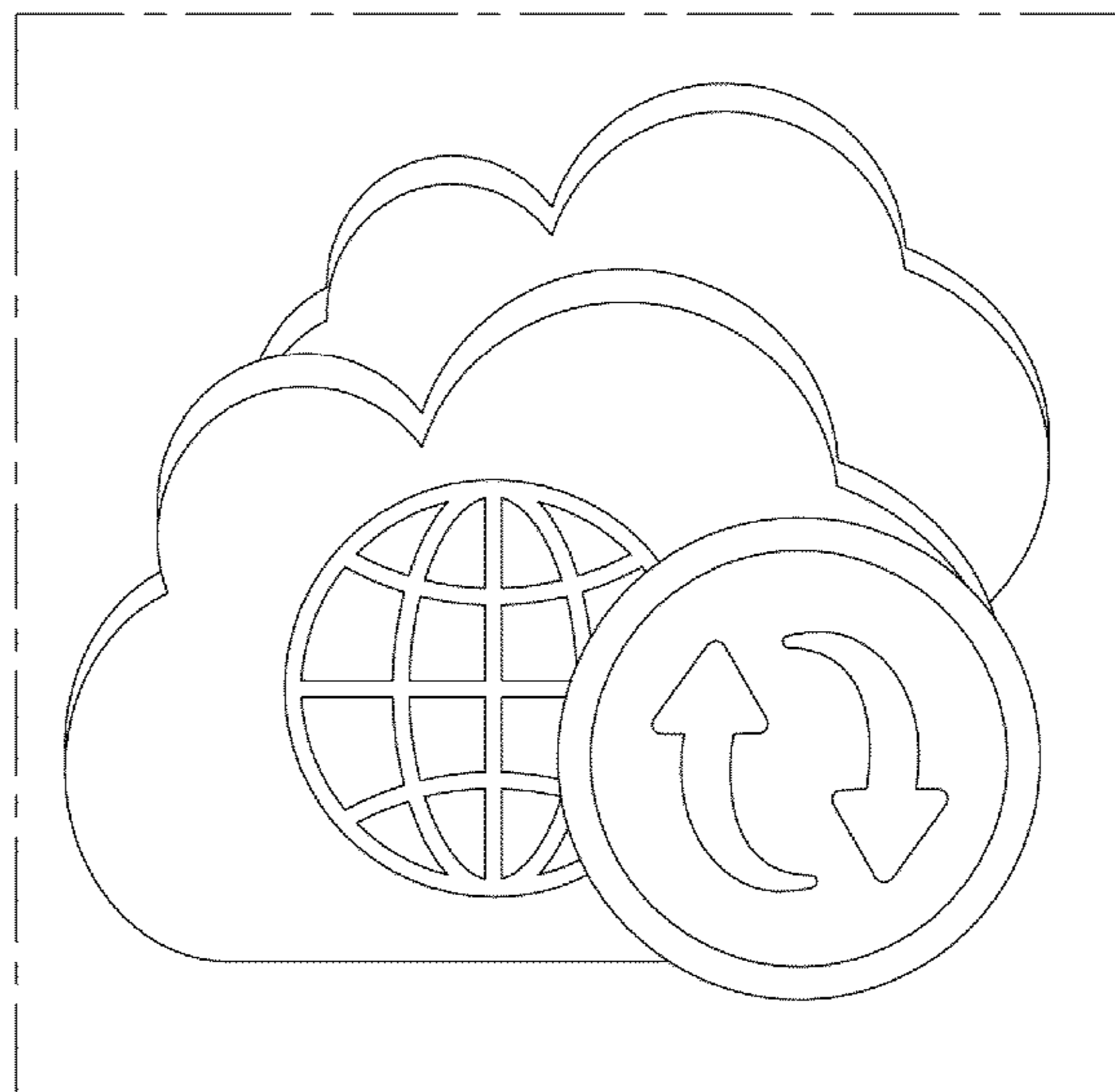
DESCRIPTION

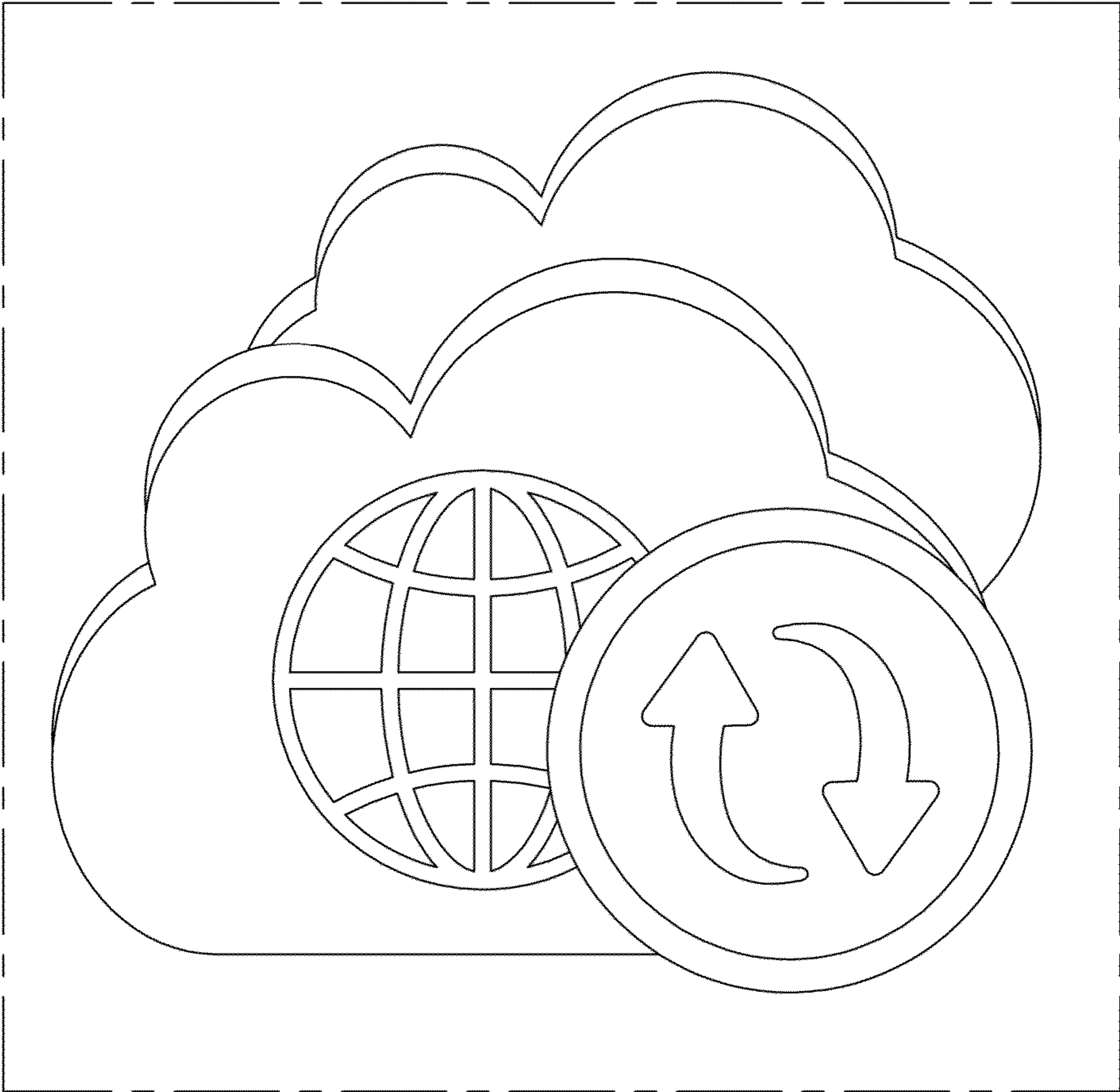

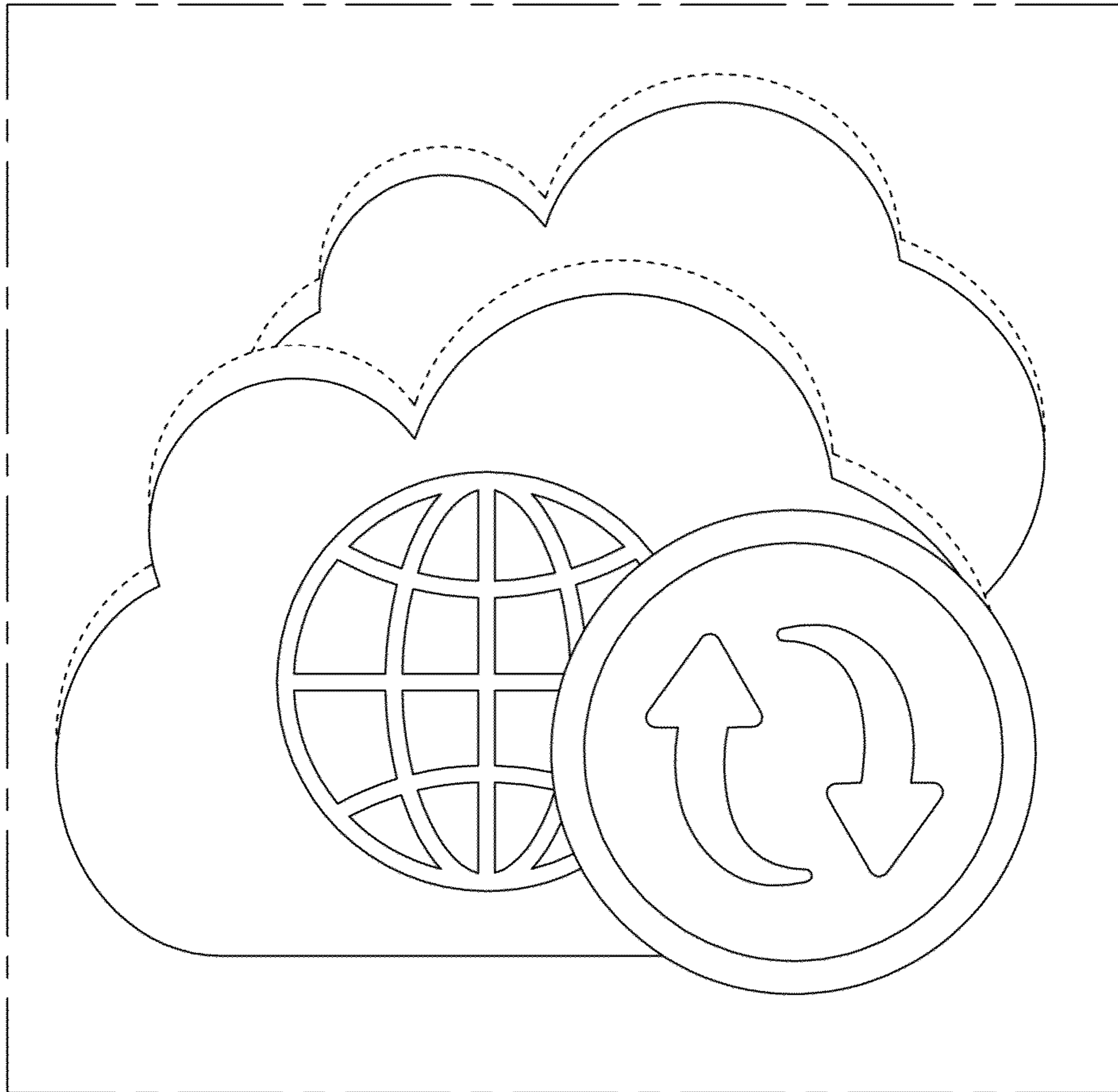
