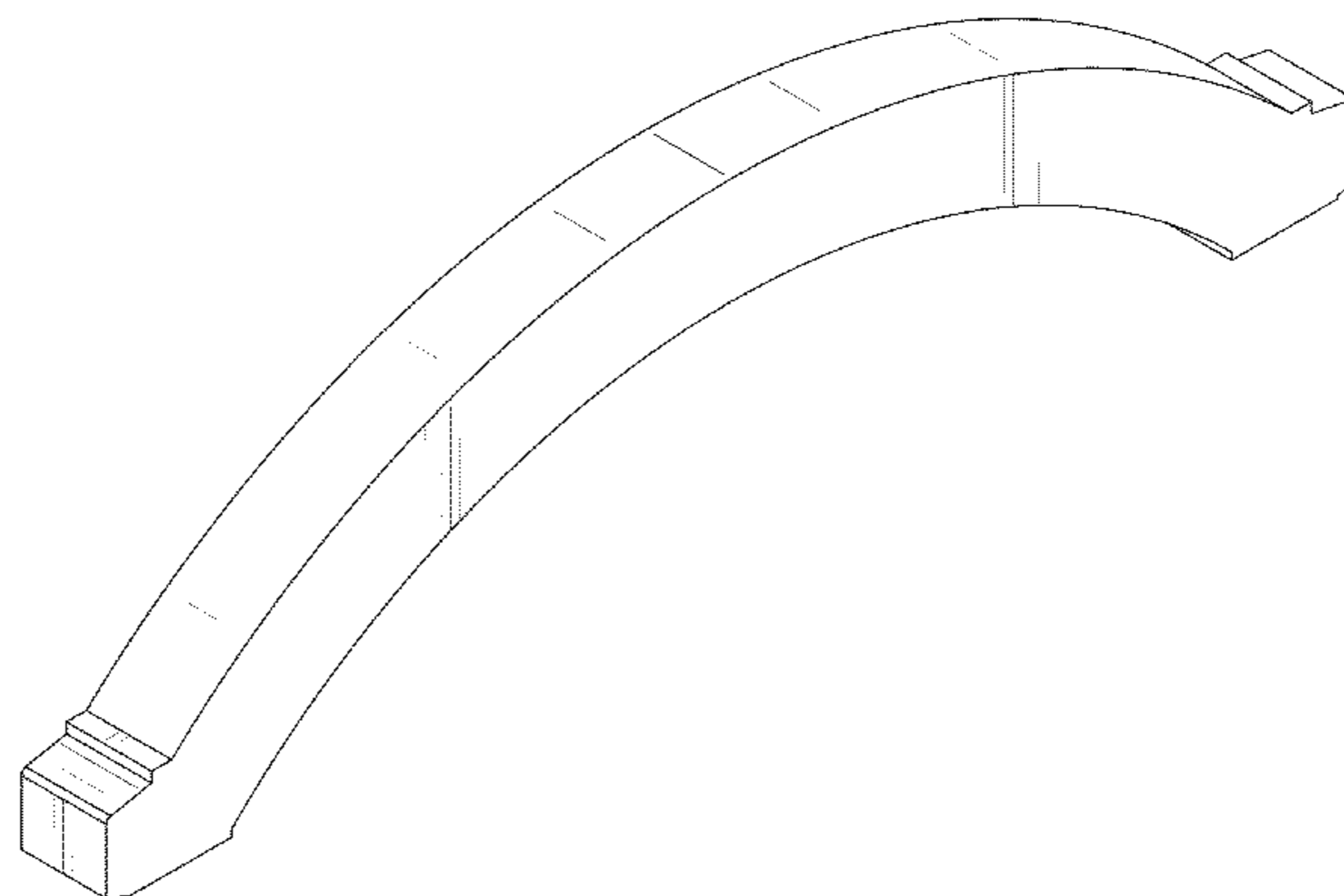
(57) **CLAIM**

The ornamental design for a “monolithic crown arch for glass furance regenerator,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a monolithic crown arch for glass furance regenerator which embodies our new and original design therefore;

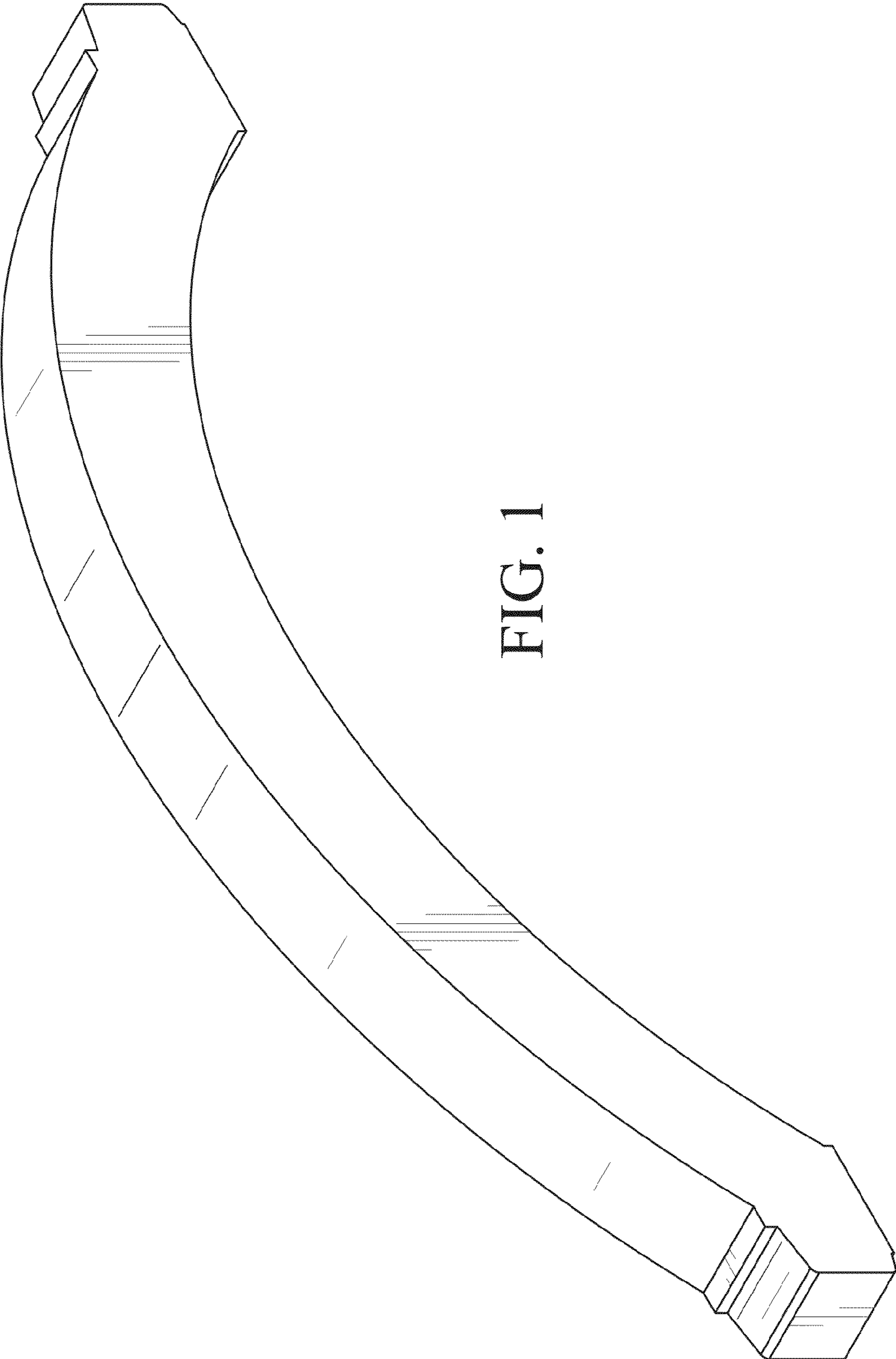

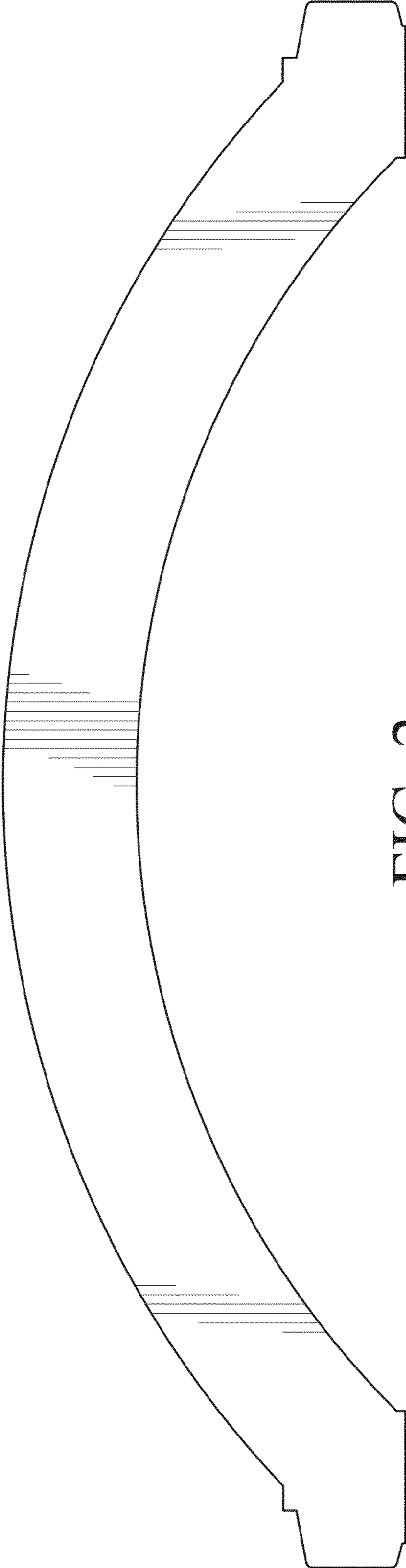

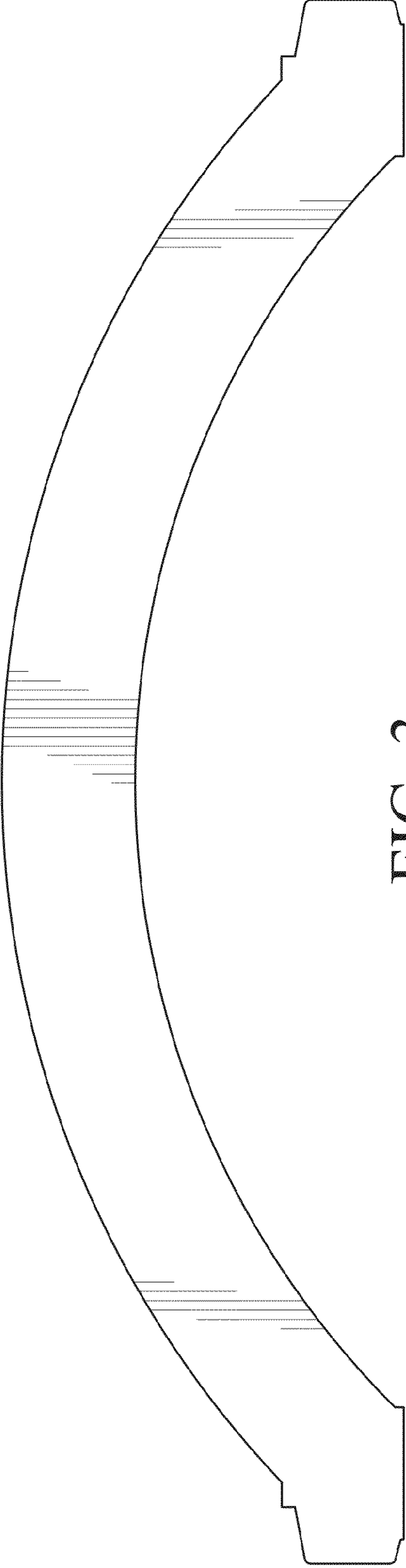

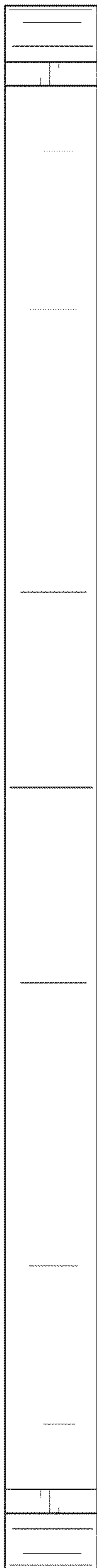

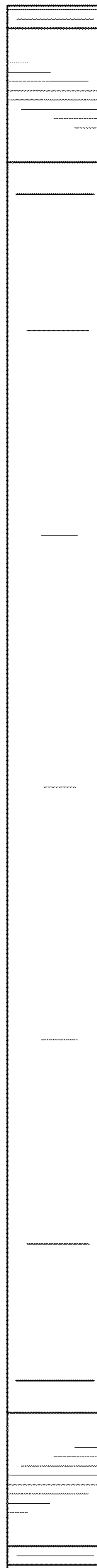

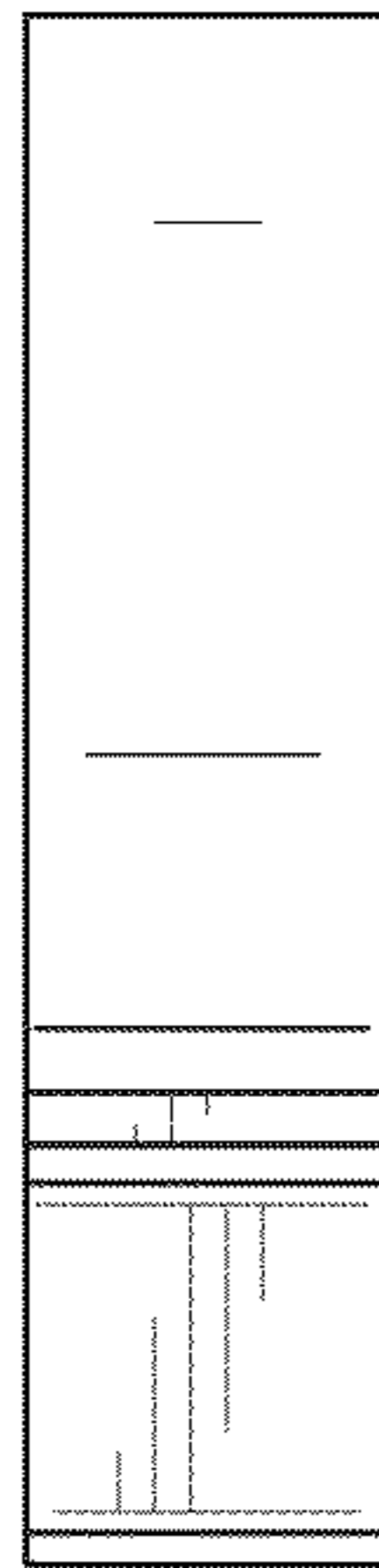

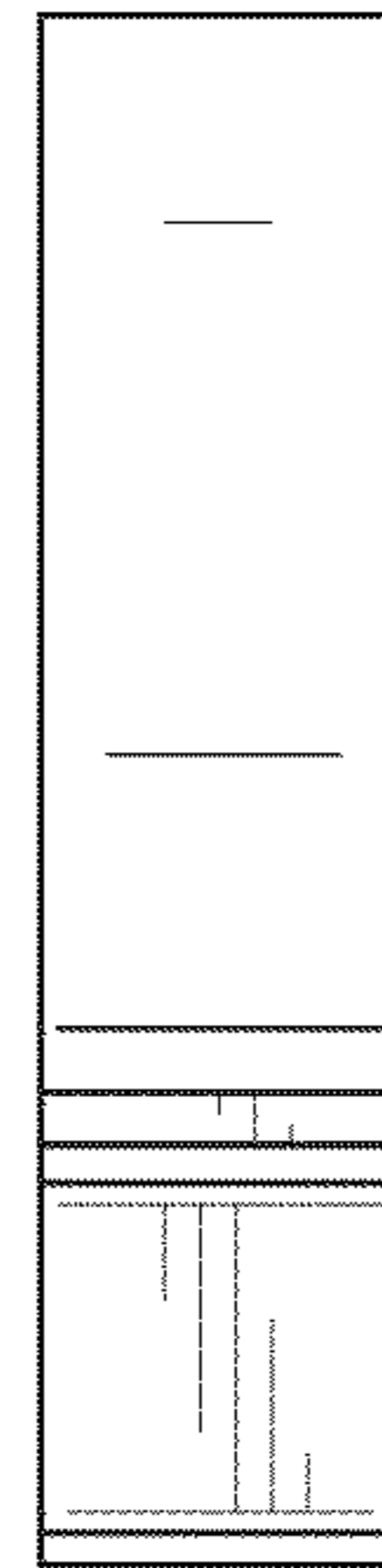
