FIG. 21 is a right side view of the claimed design of FIG. 17;

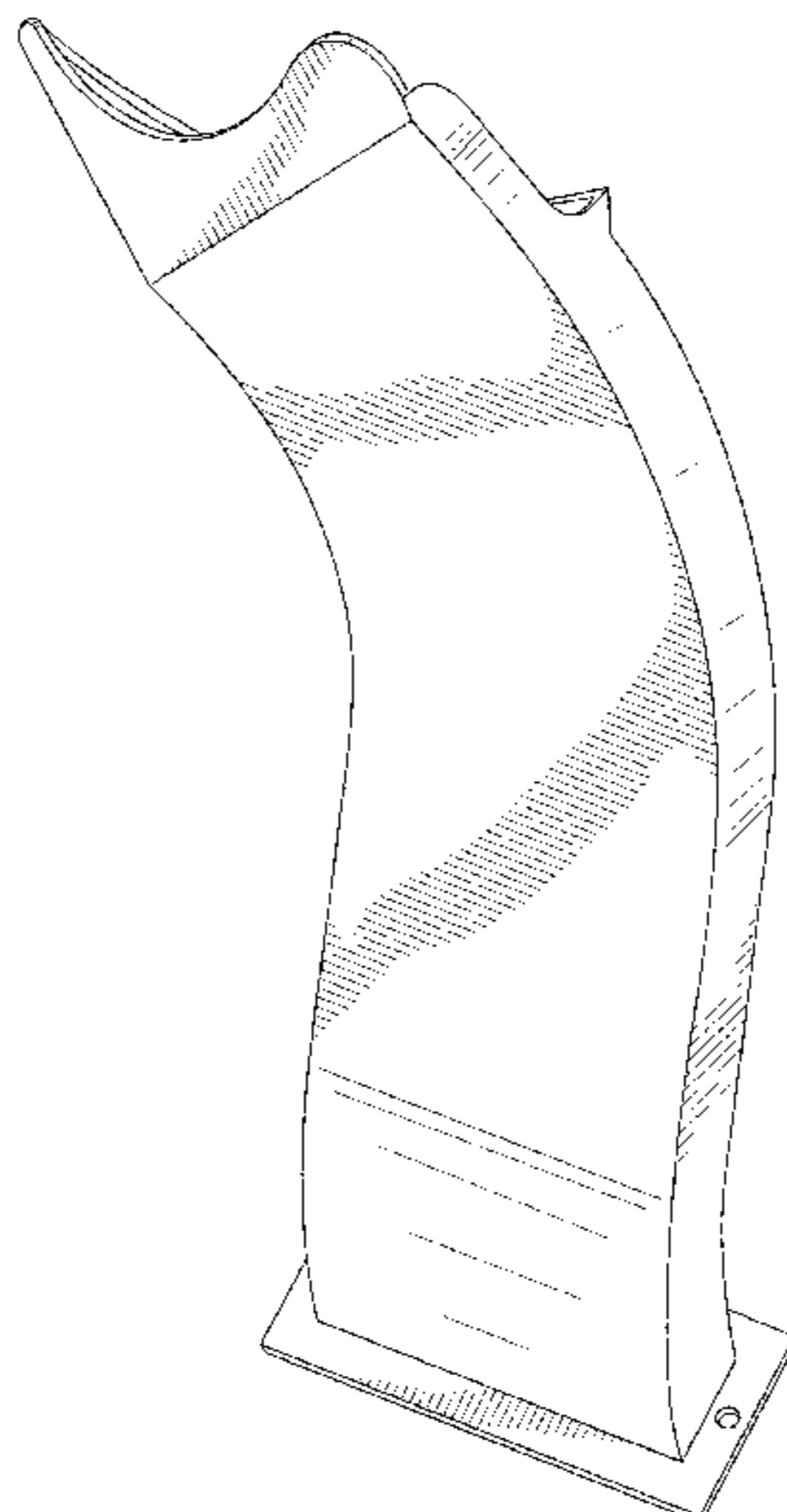
FIG. 22 is a left side view of the claimed design of FIG. 17;

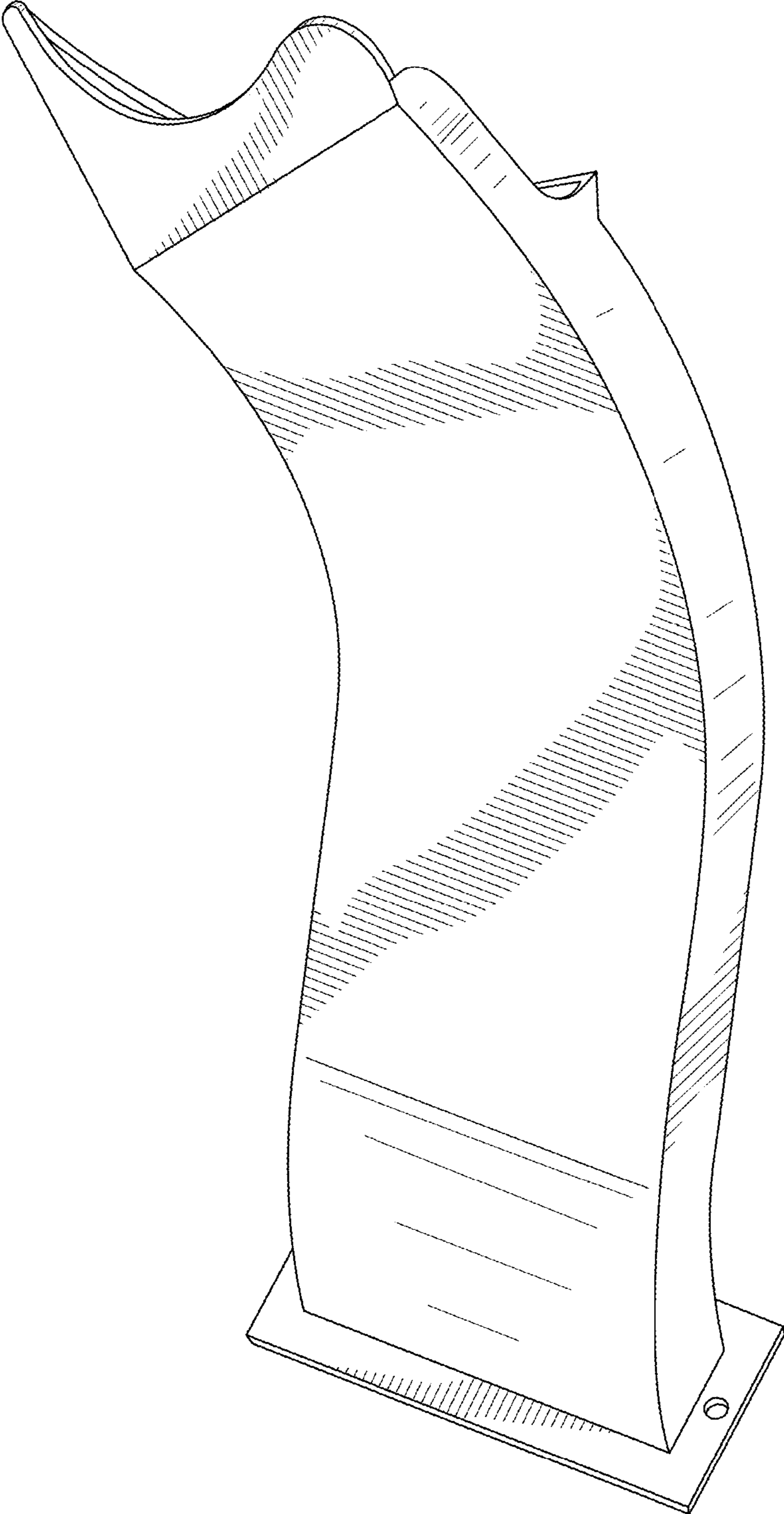

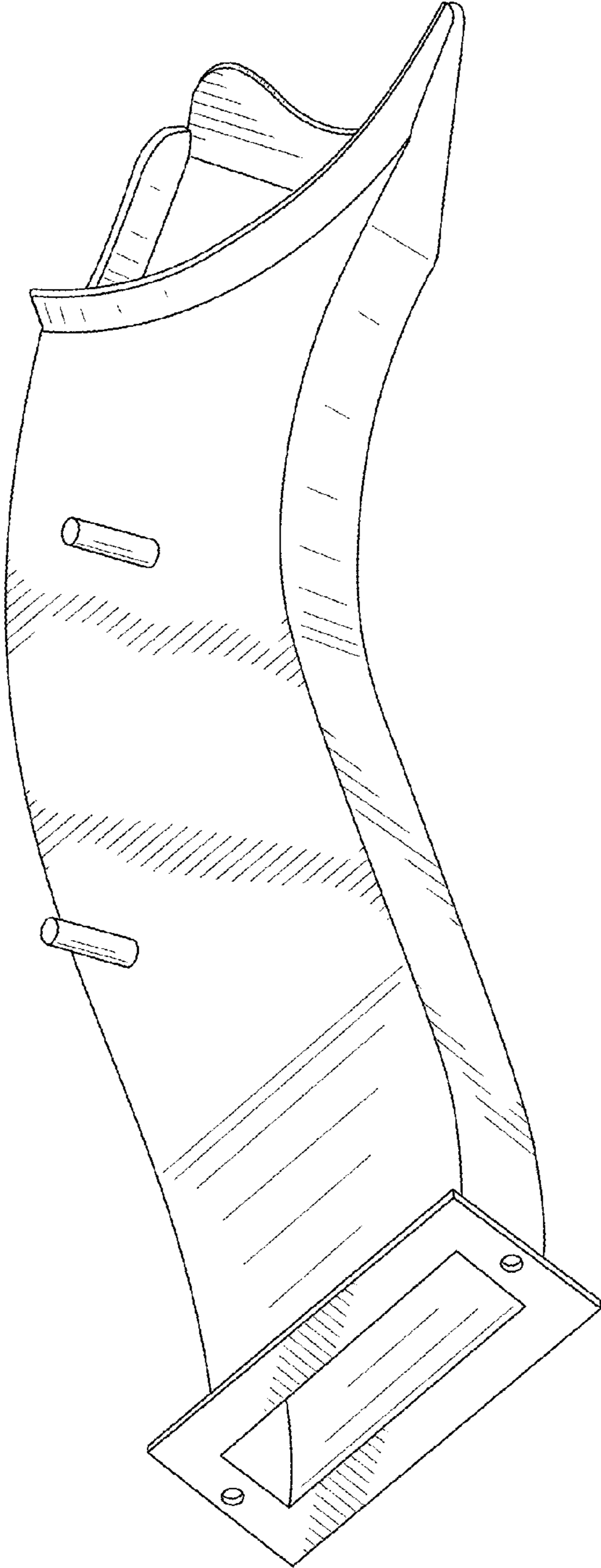

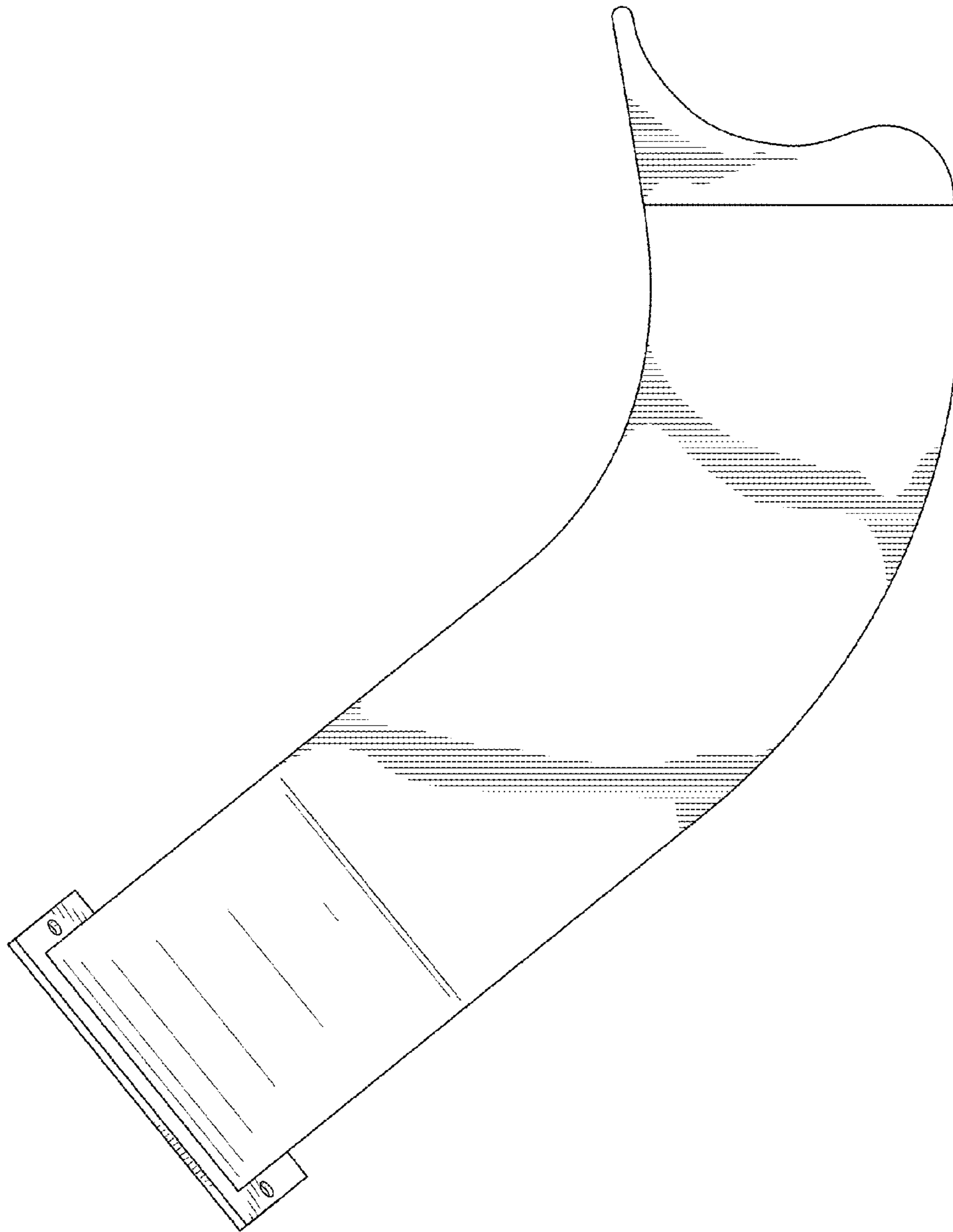

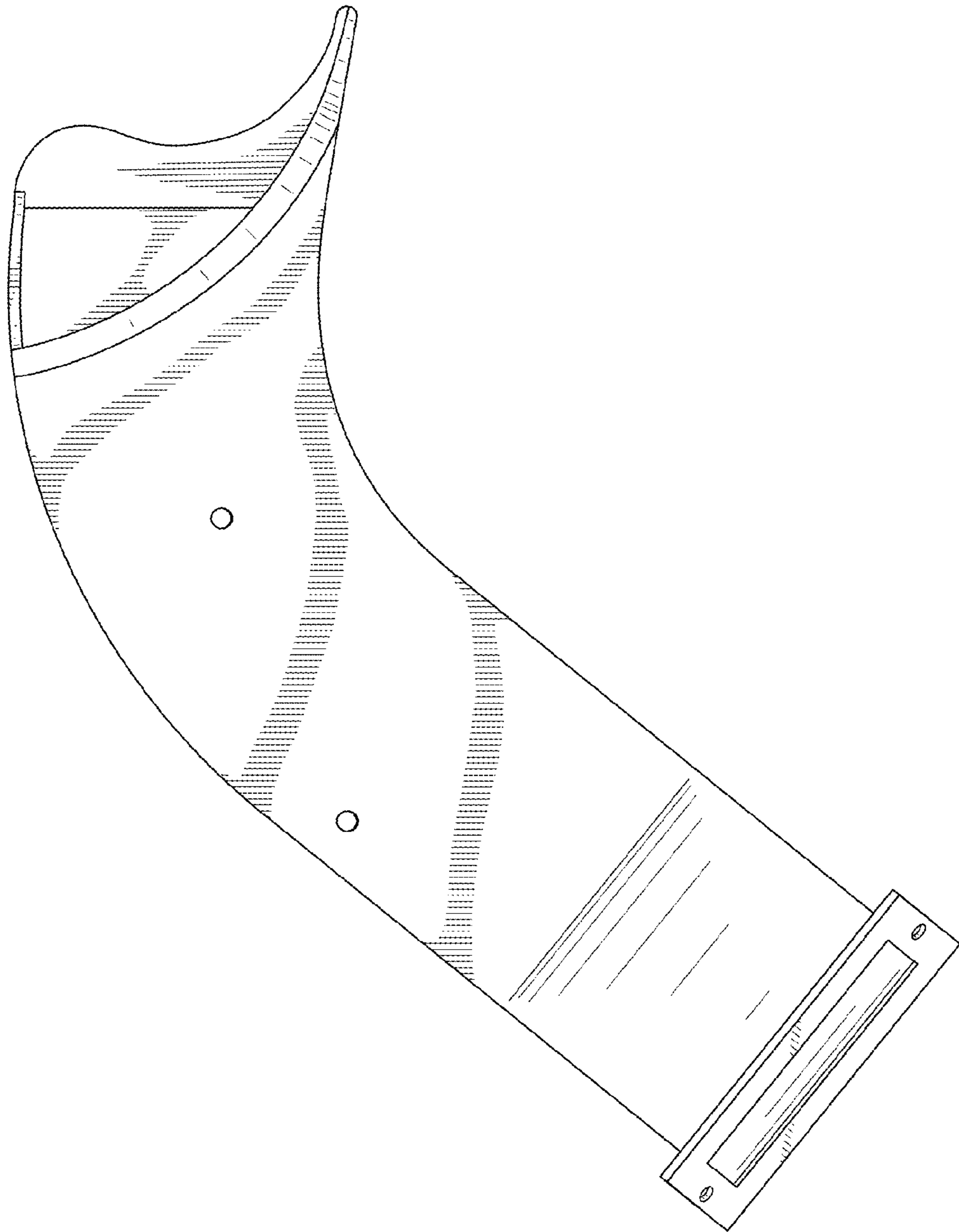

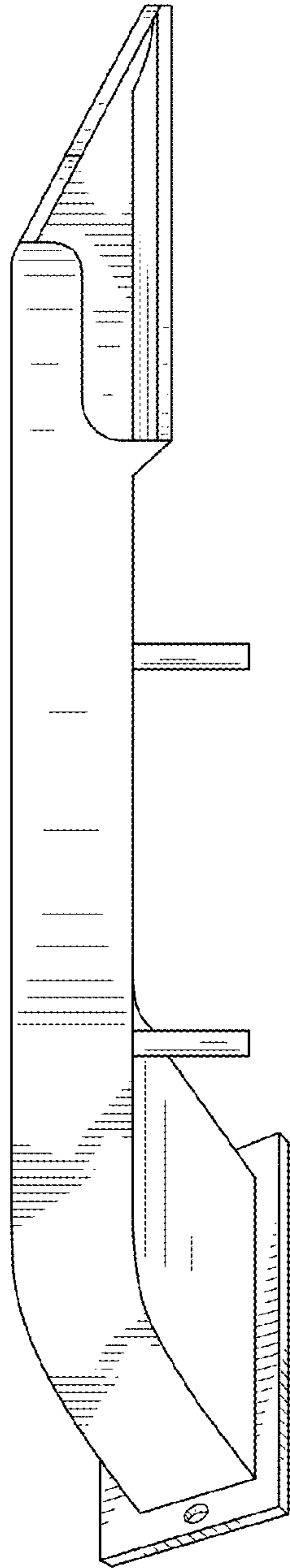

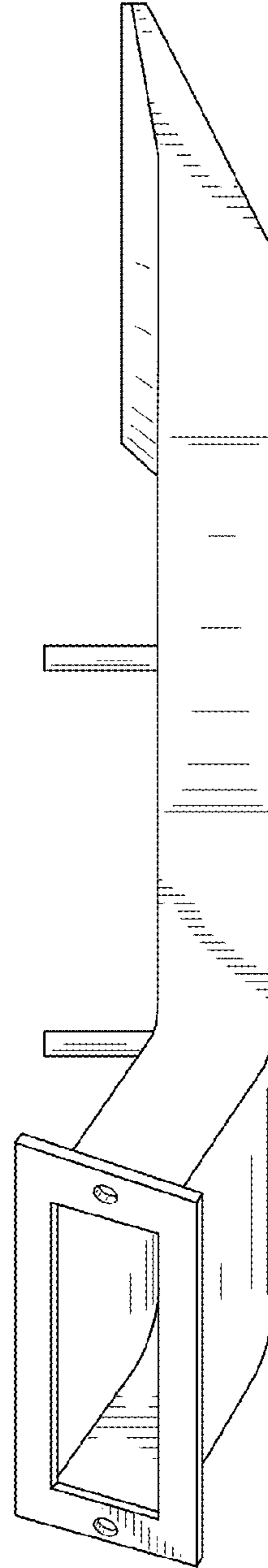

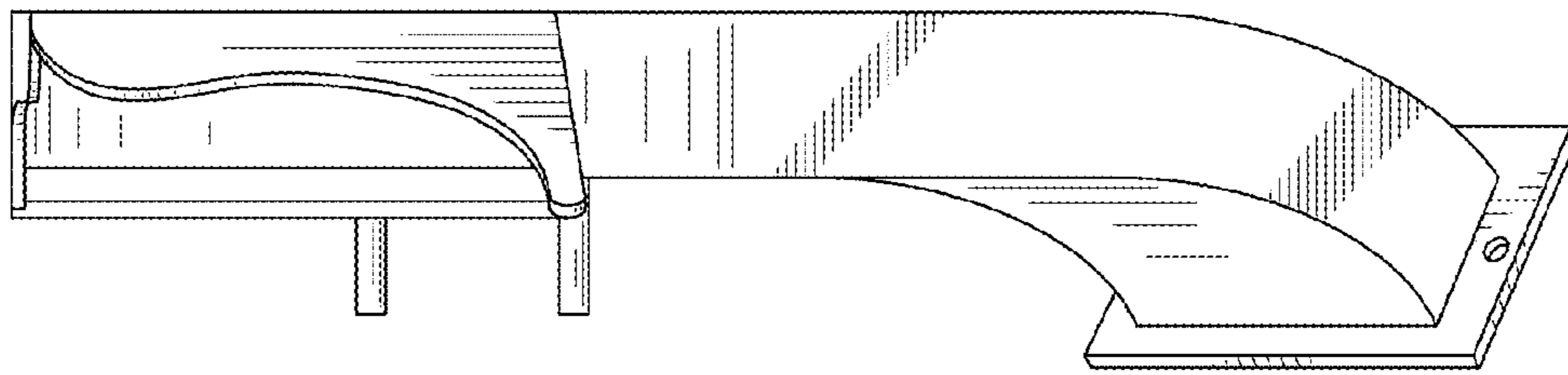

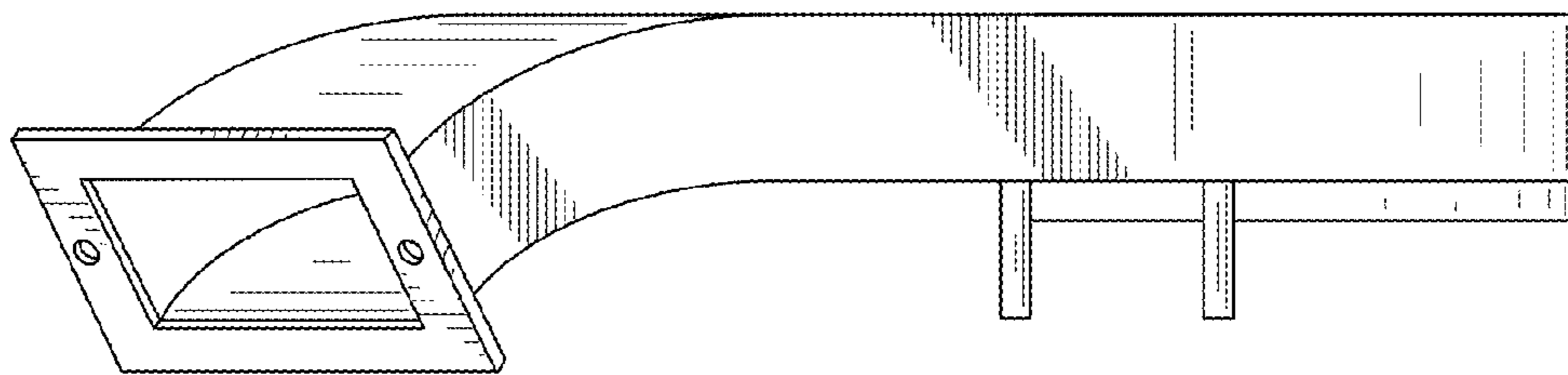

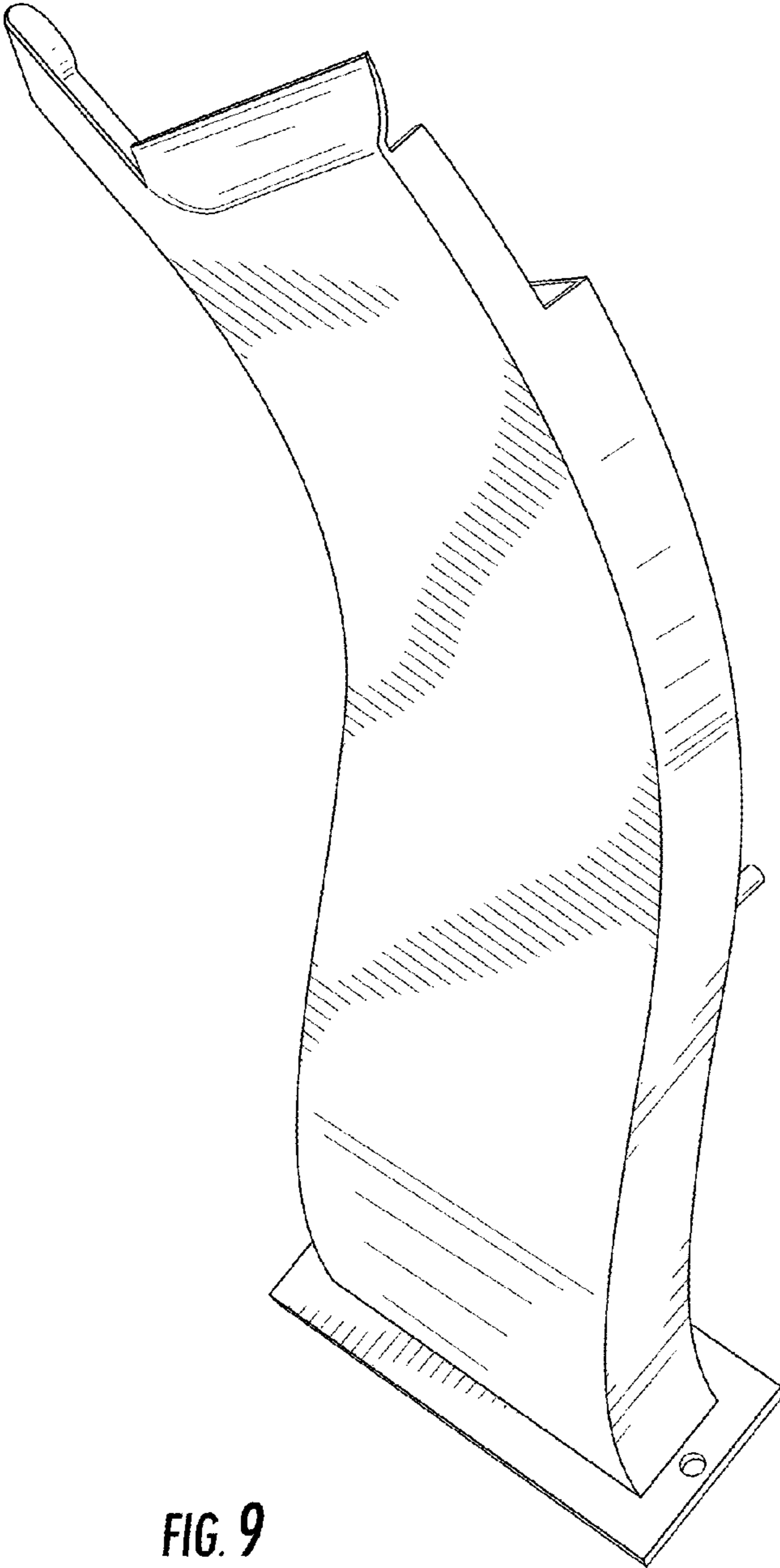

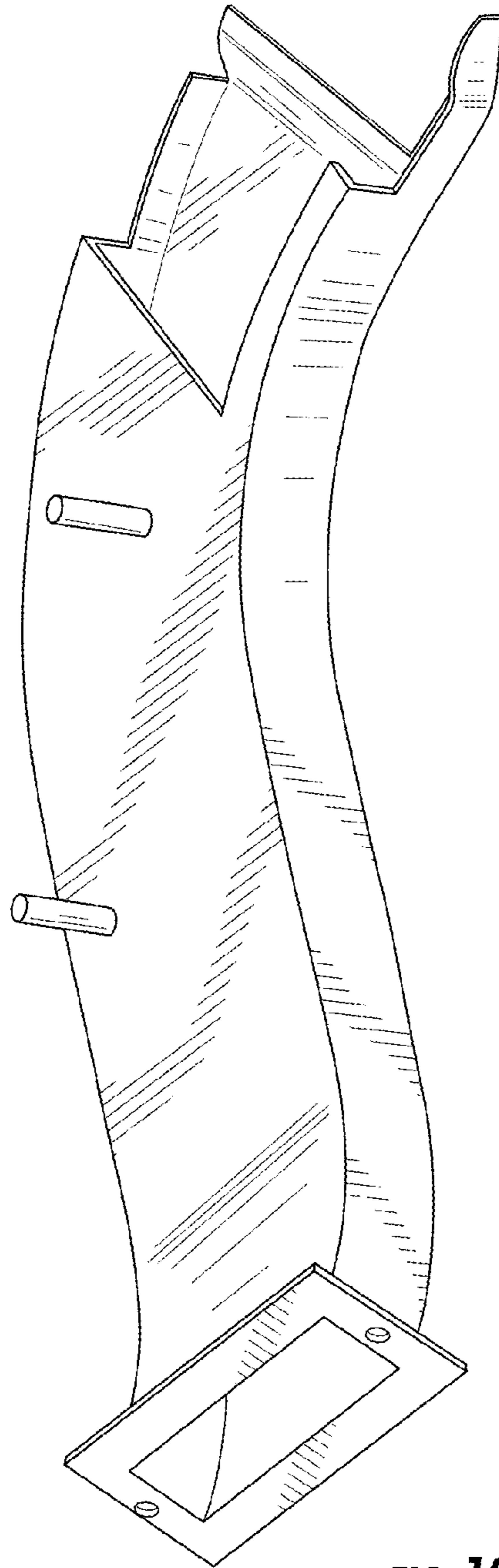
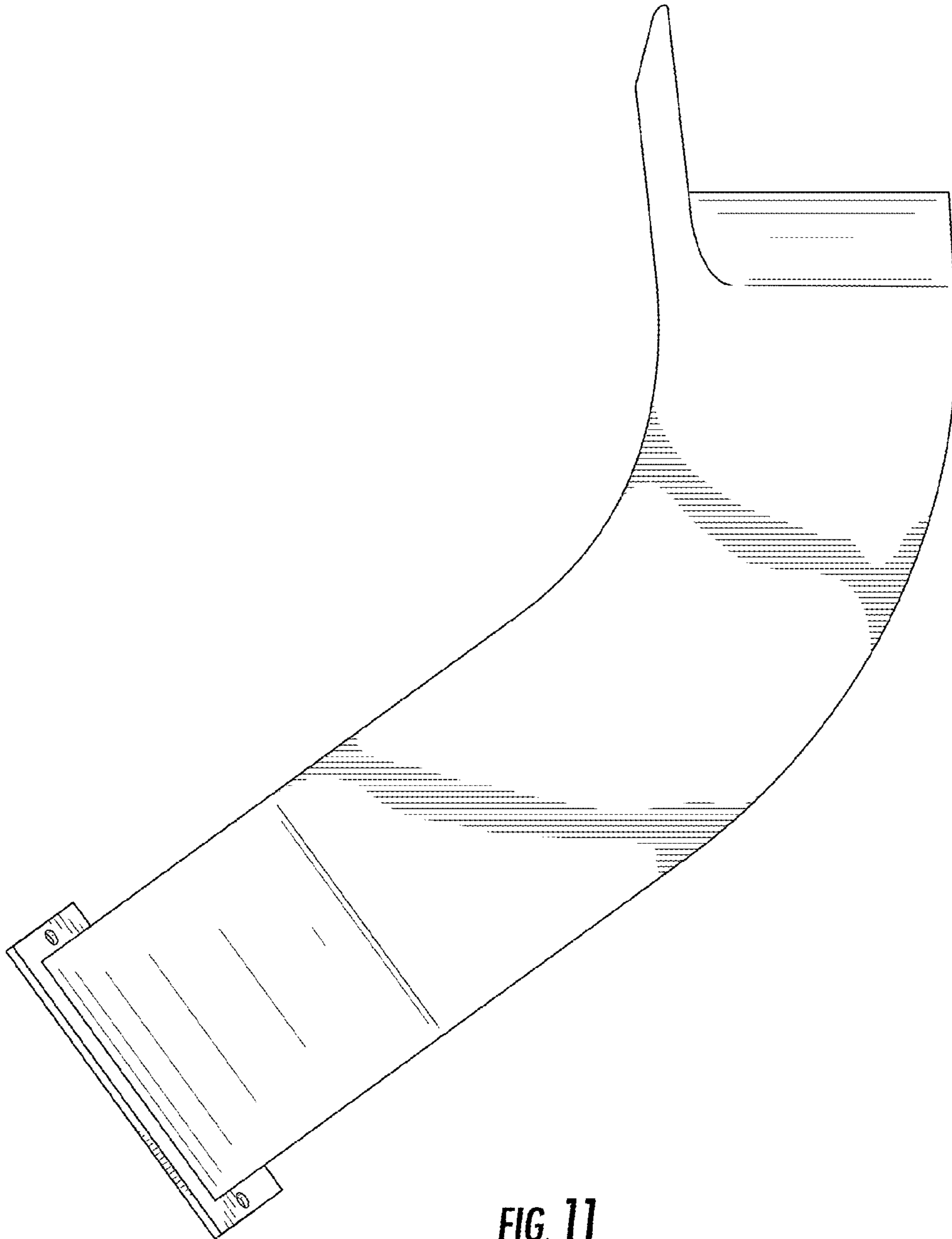

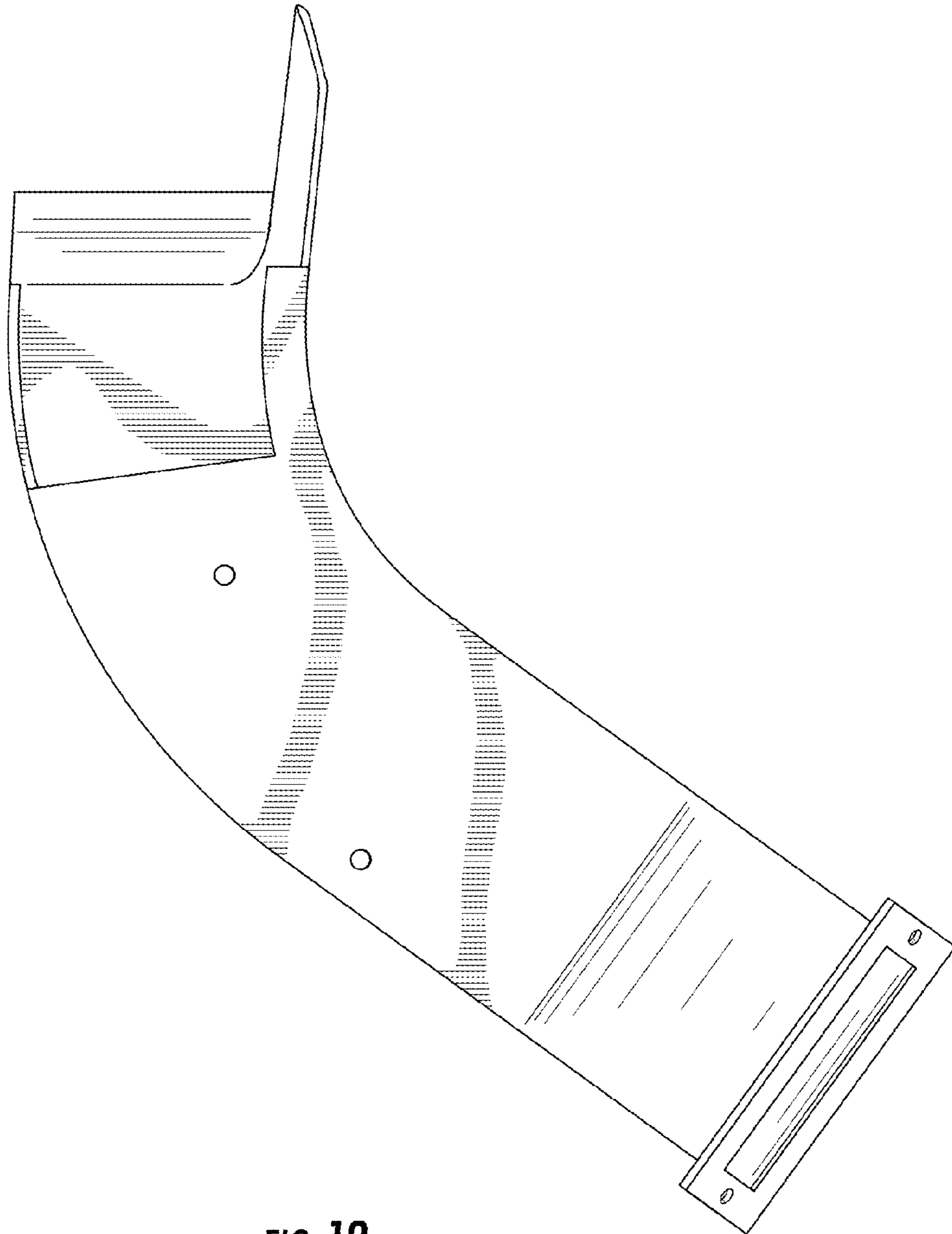

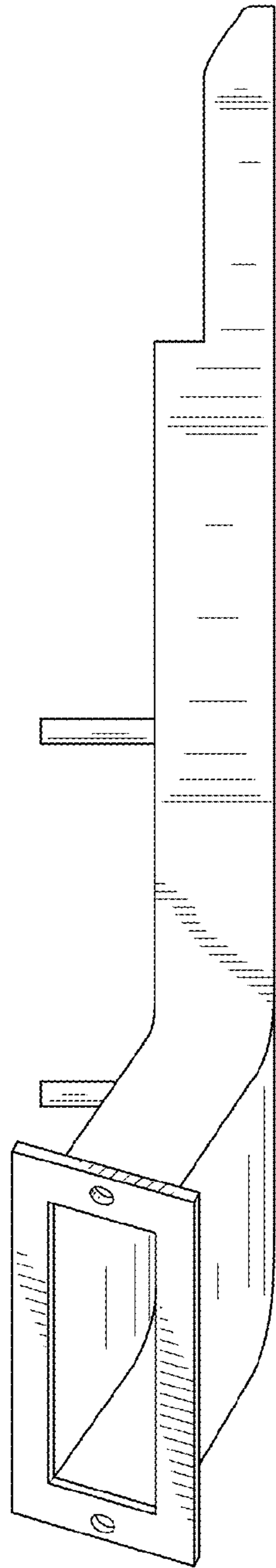

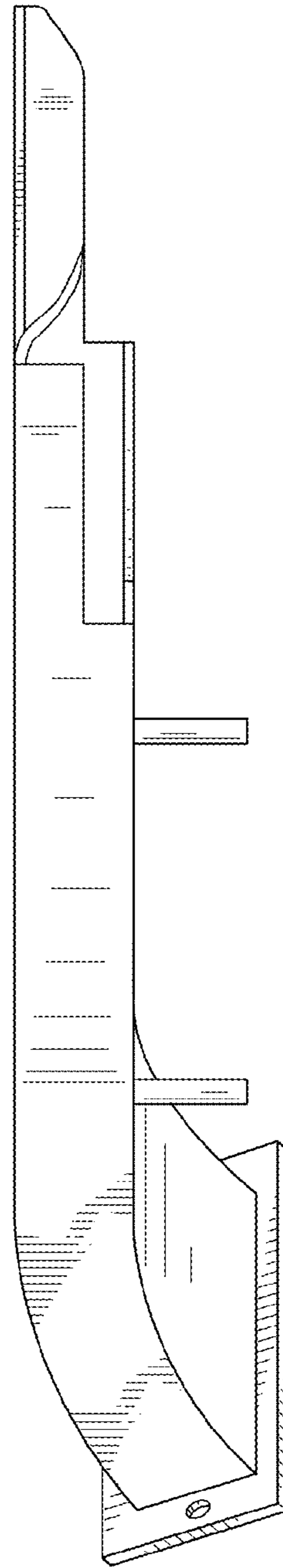

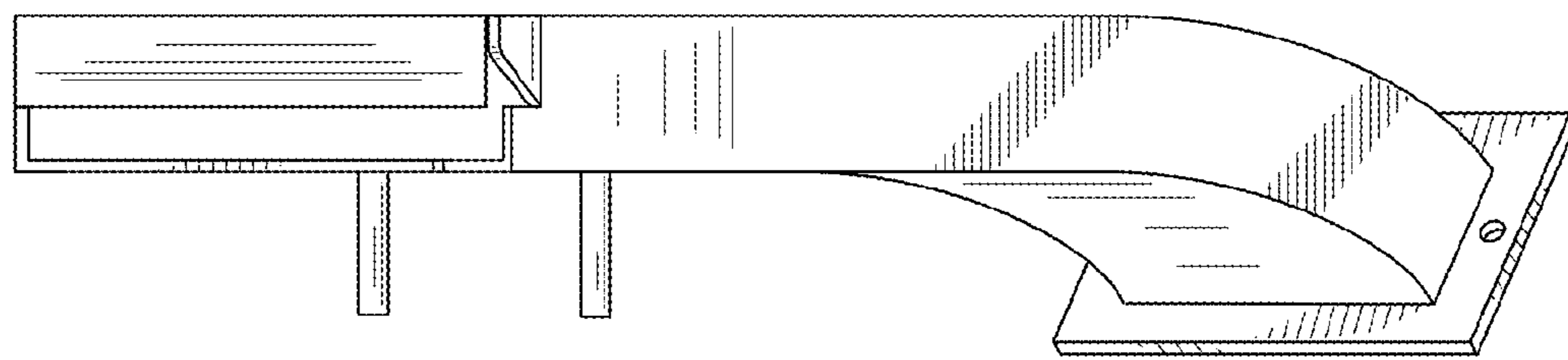

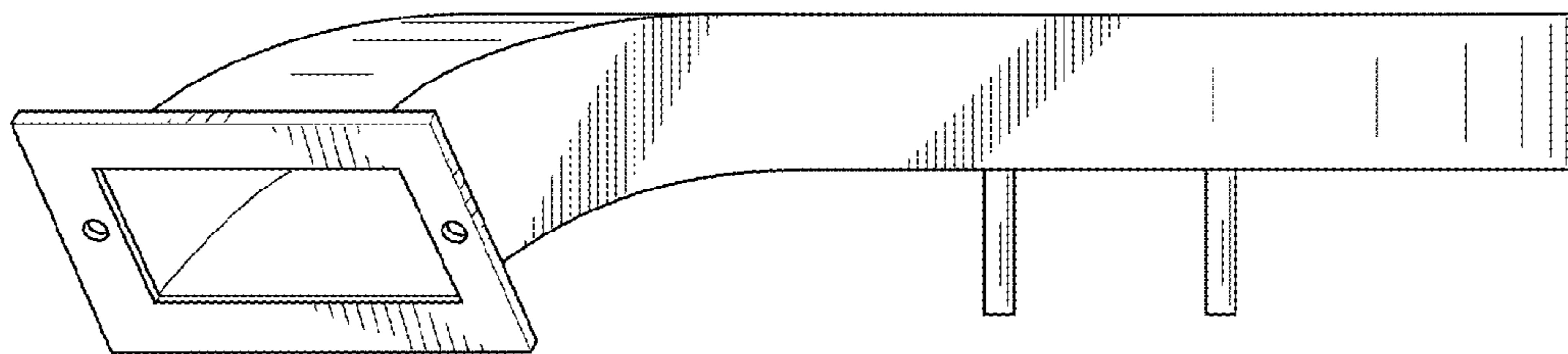

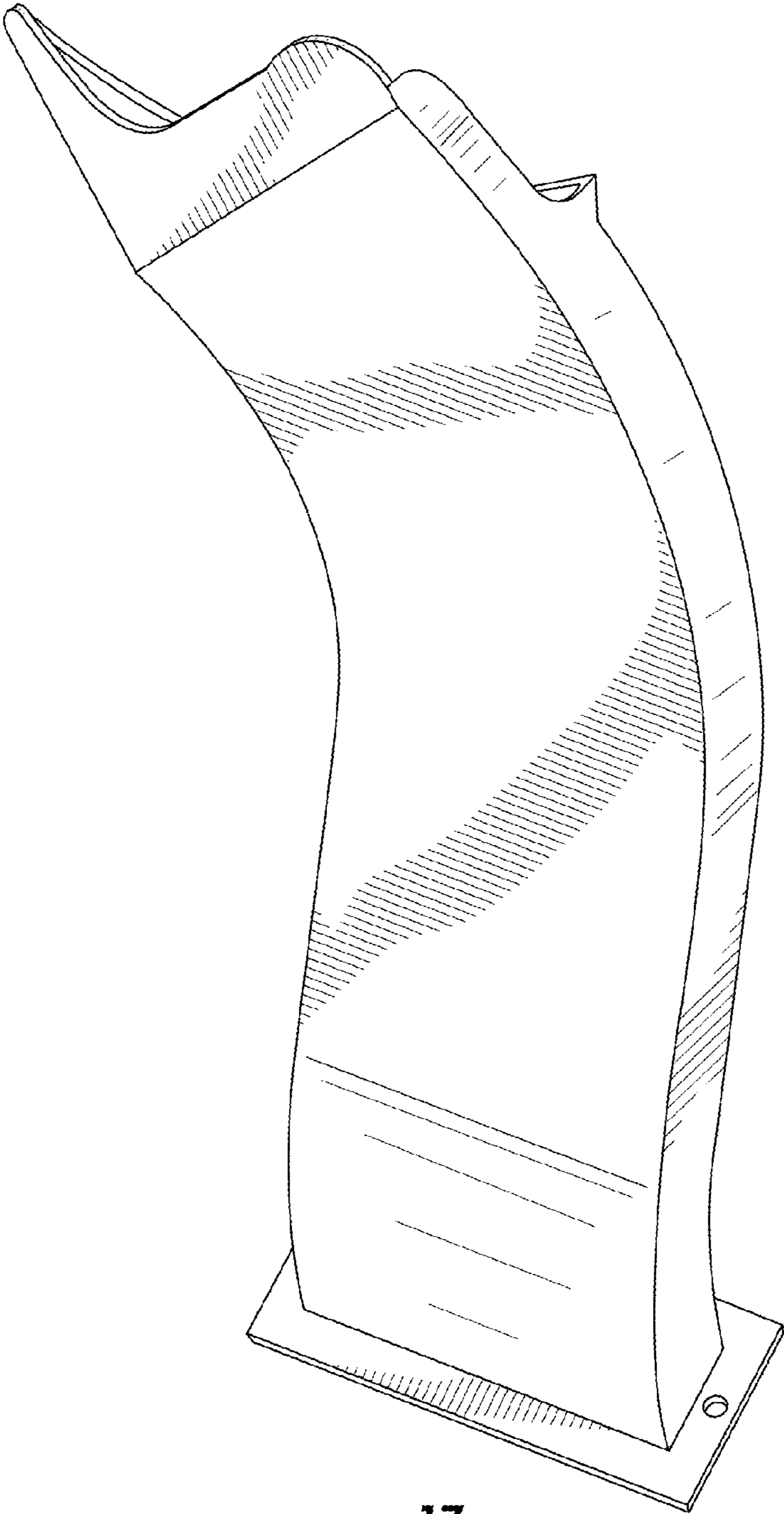

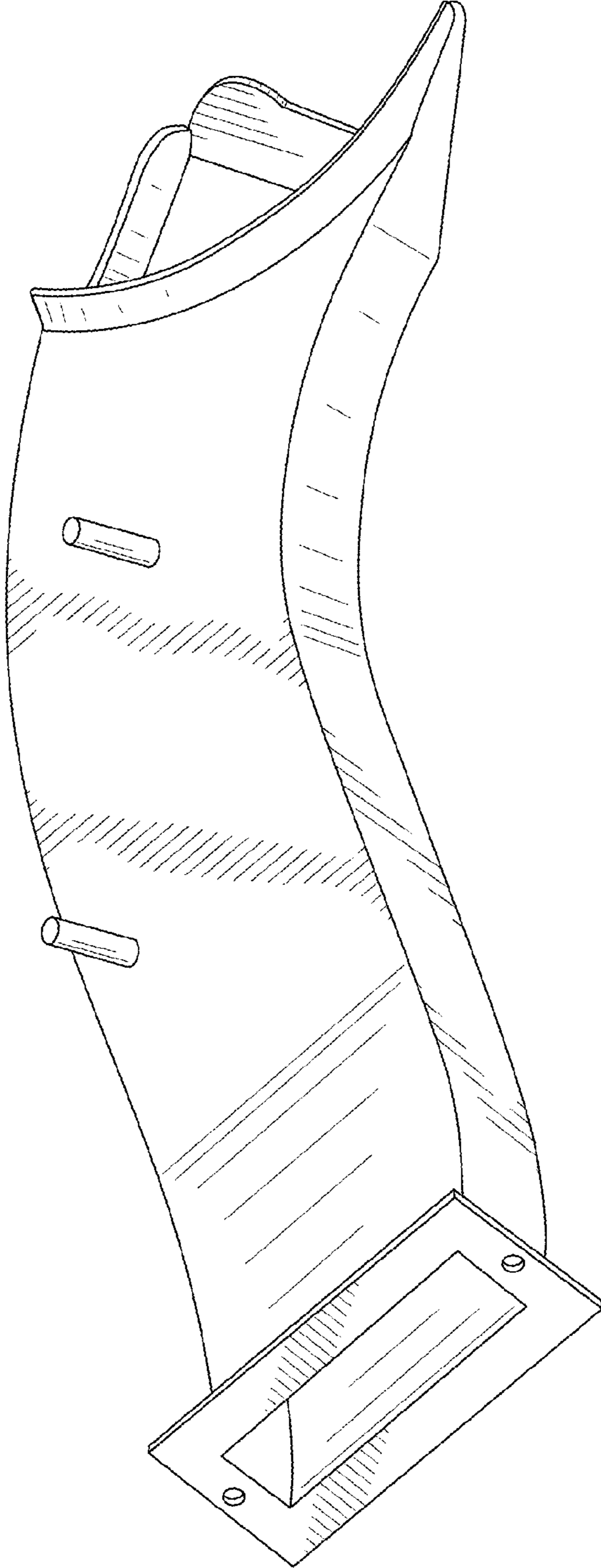

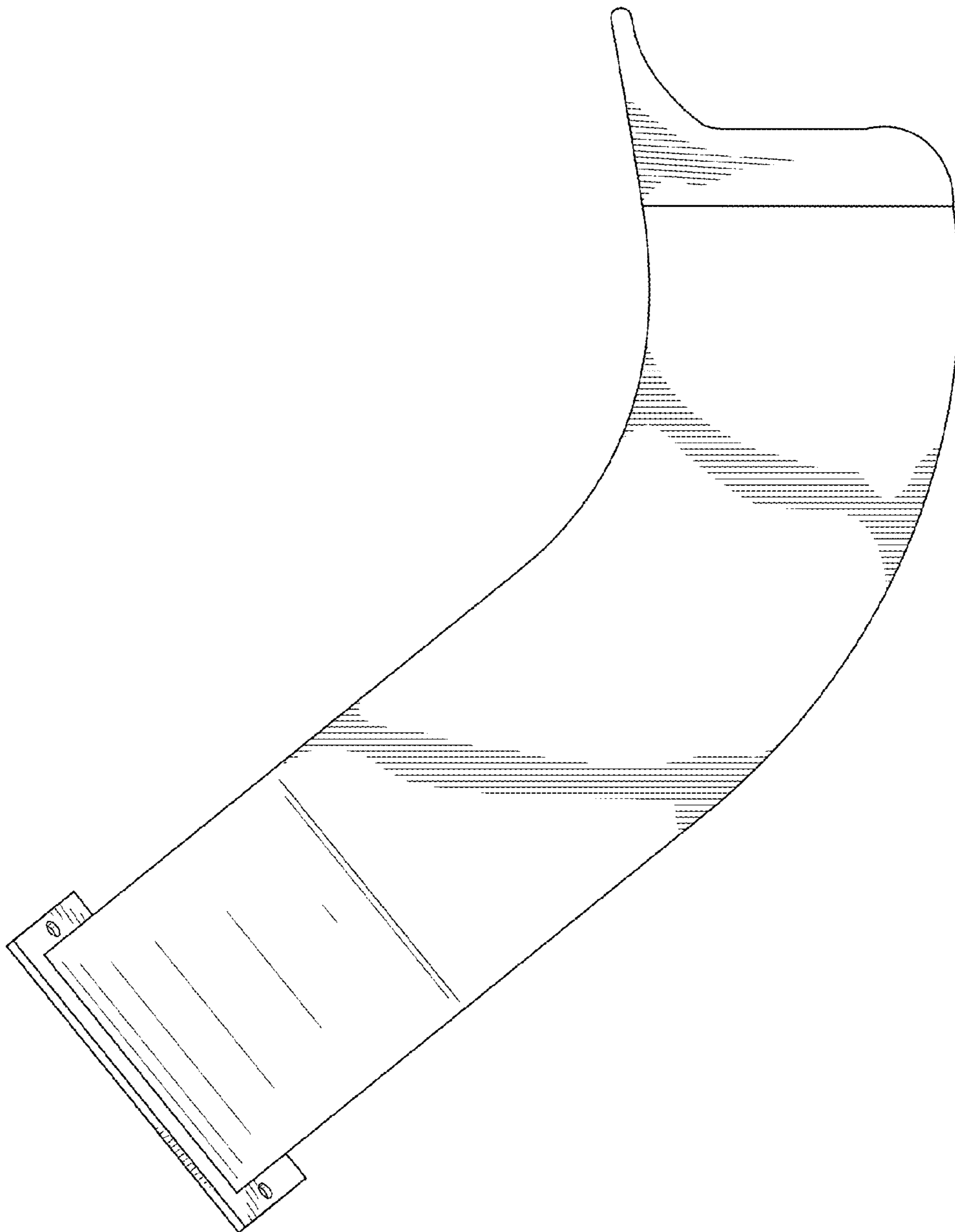

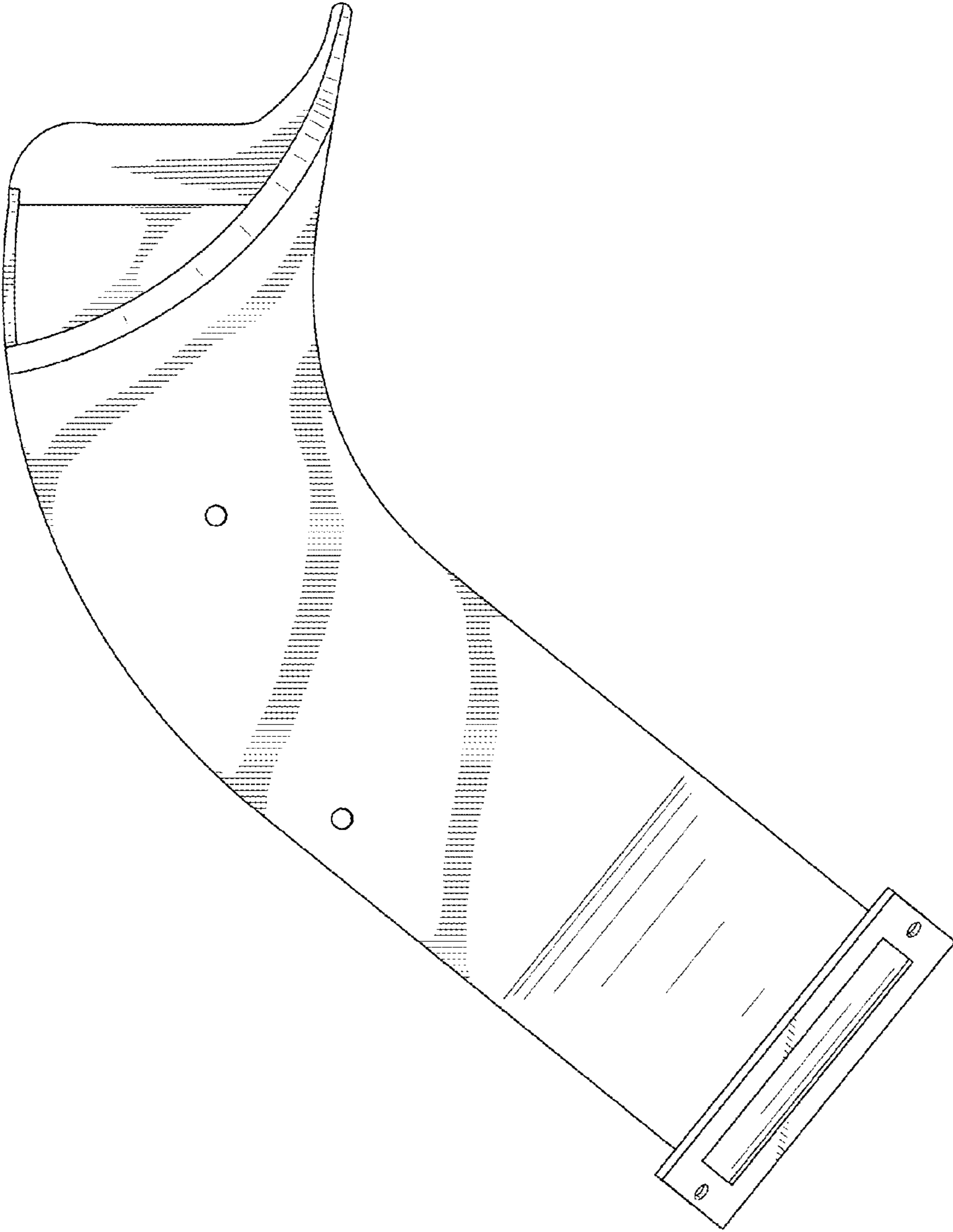

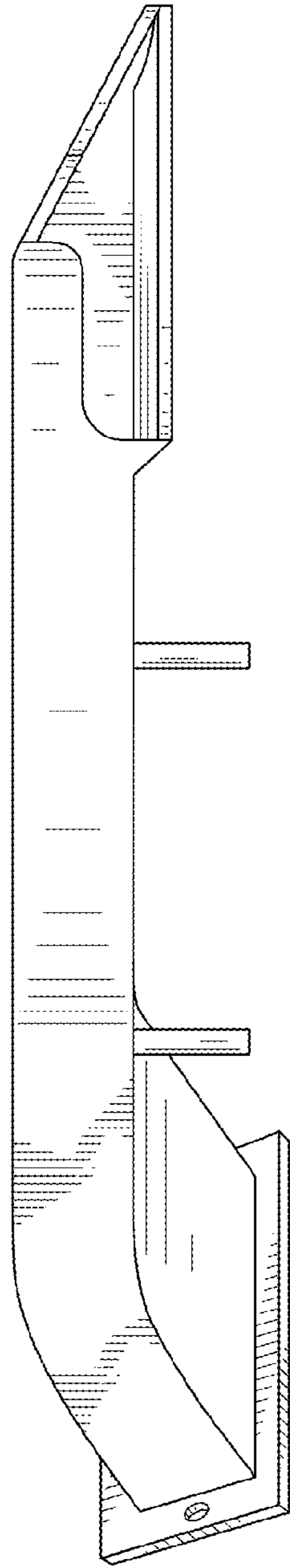

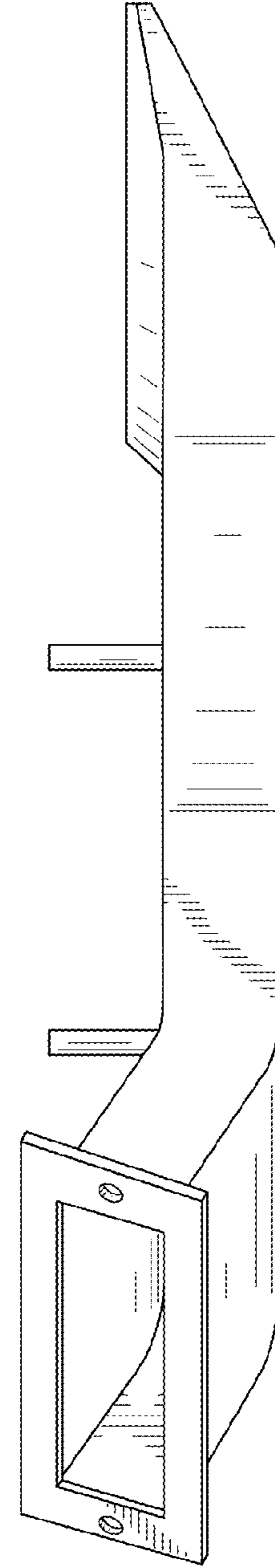

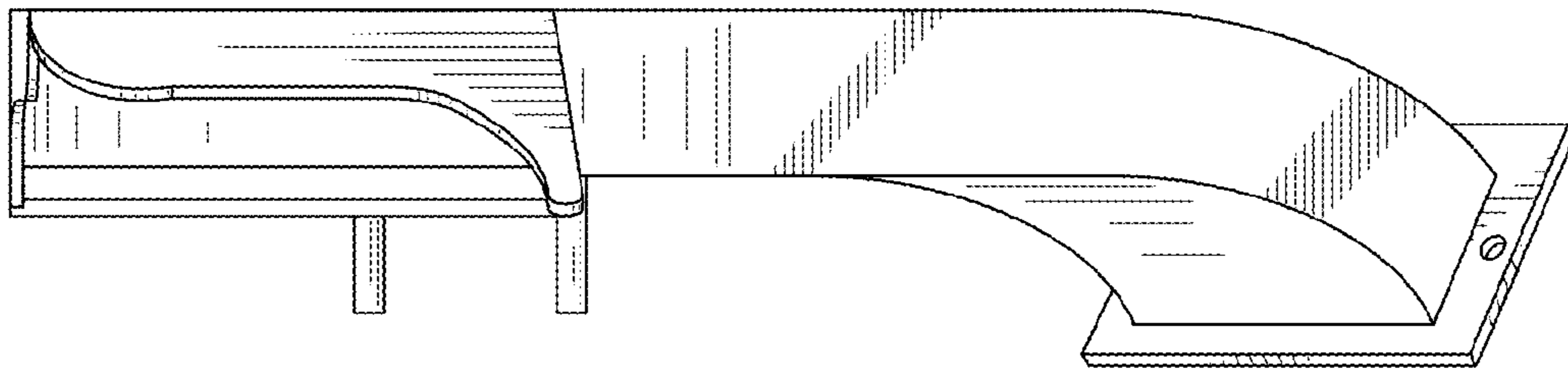

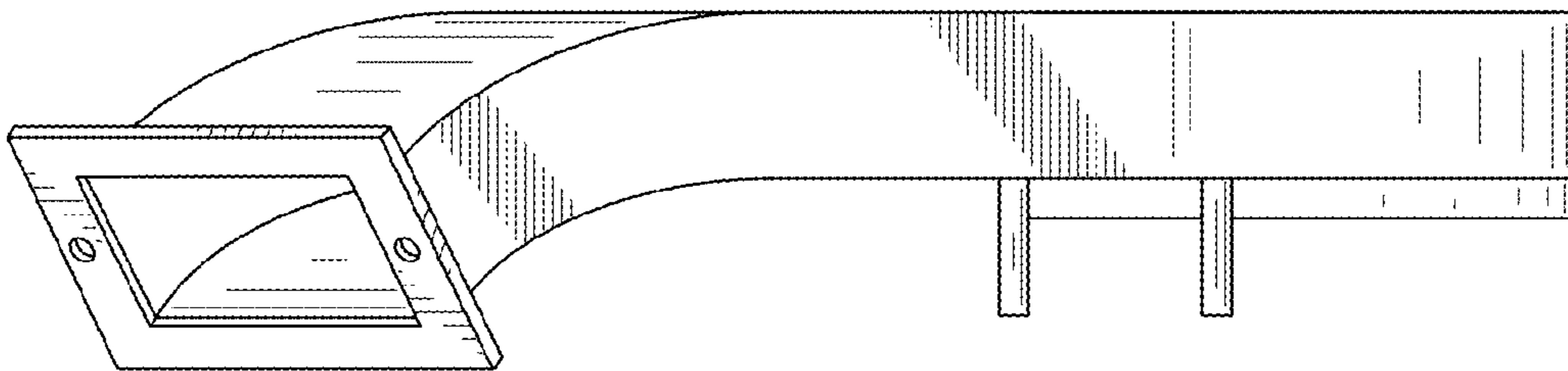
