DESCRIPTION

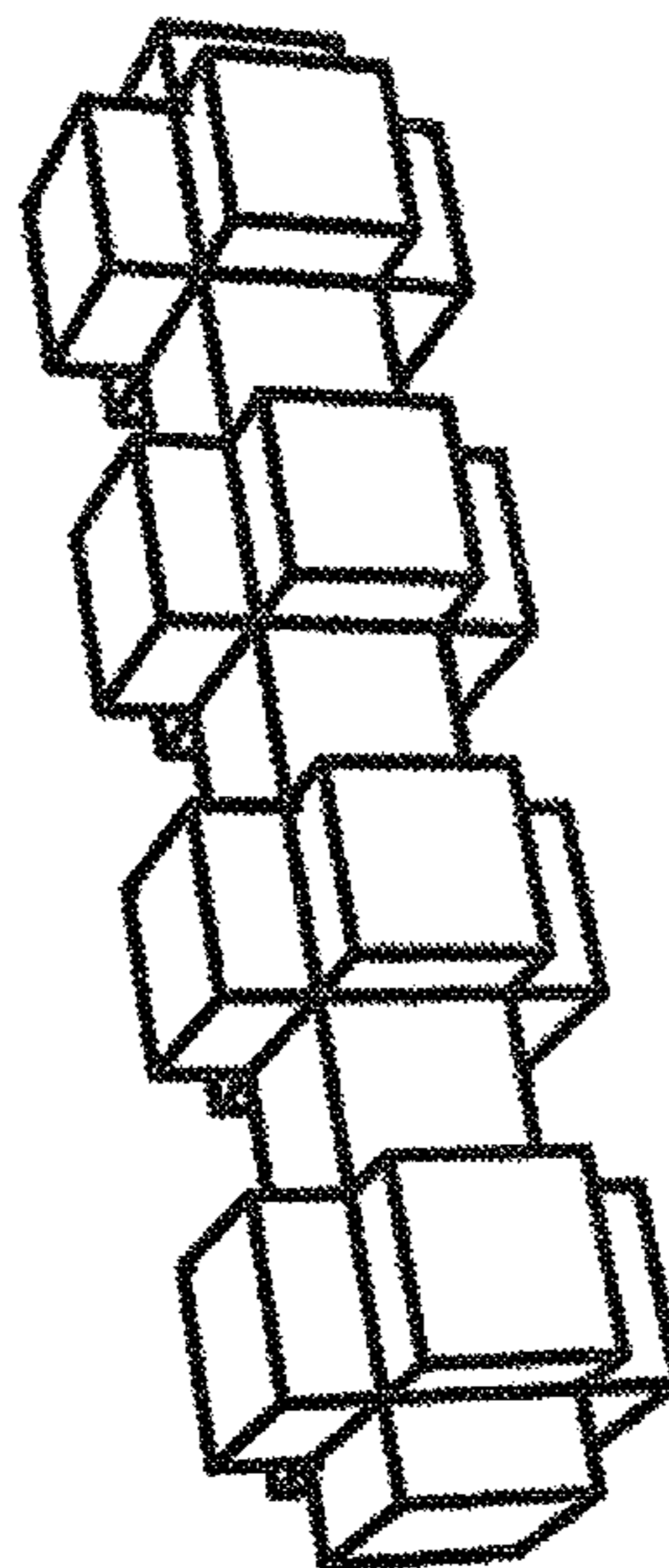
FIG. 1 is a top, front, right side perspective view of a building block according to my new design;

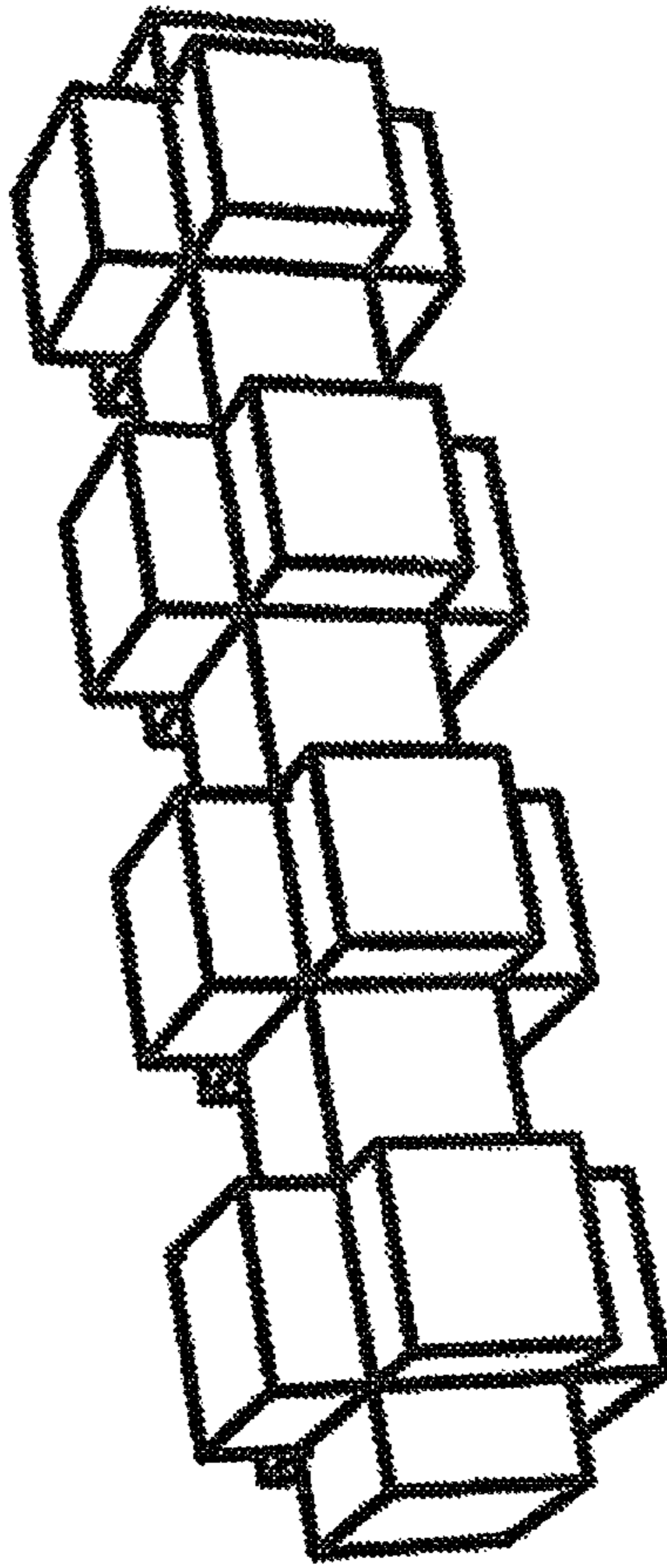

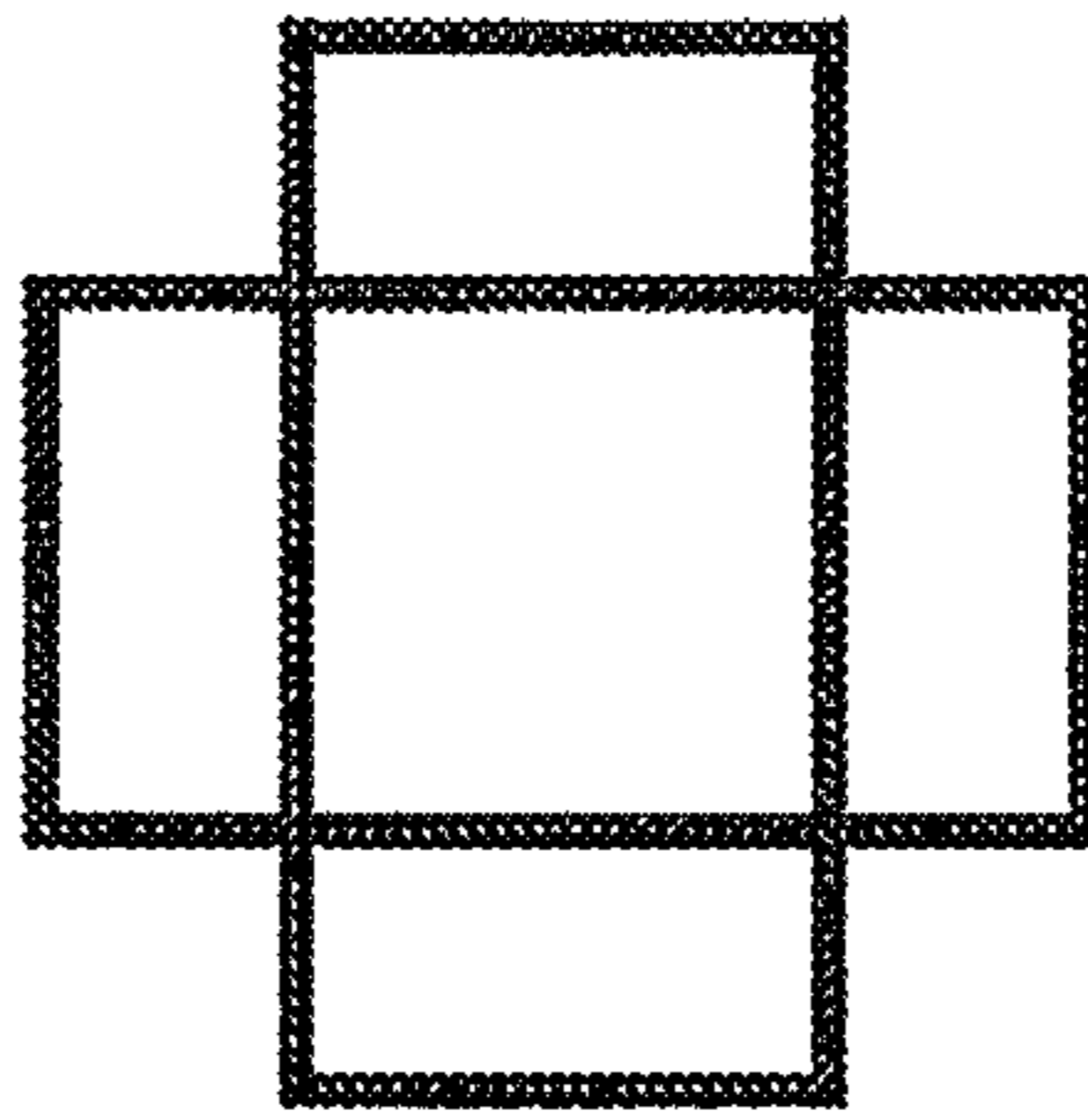

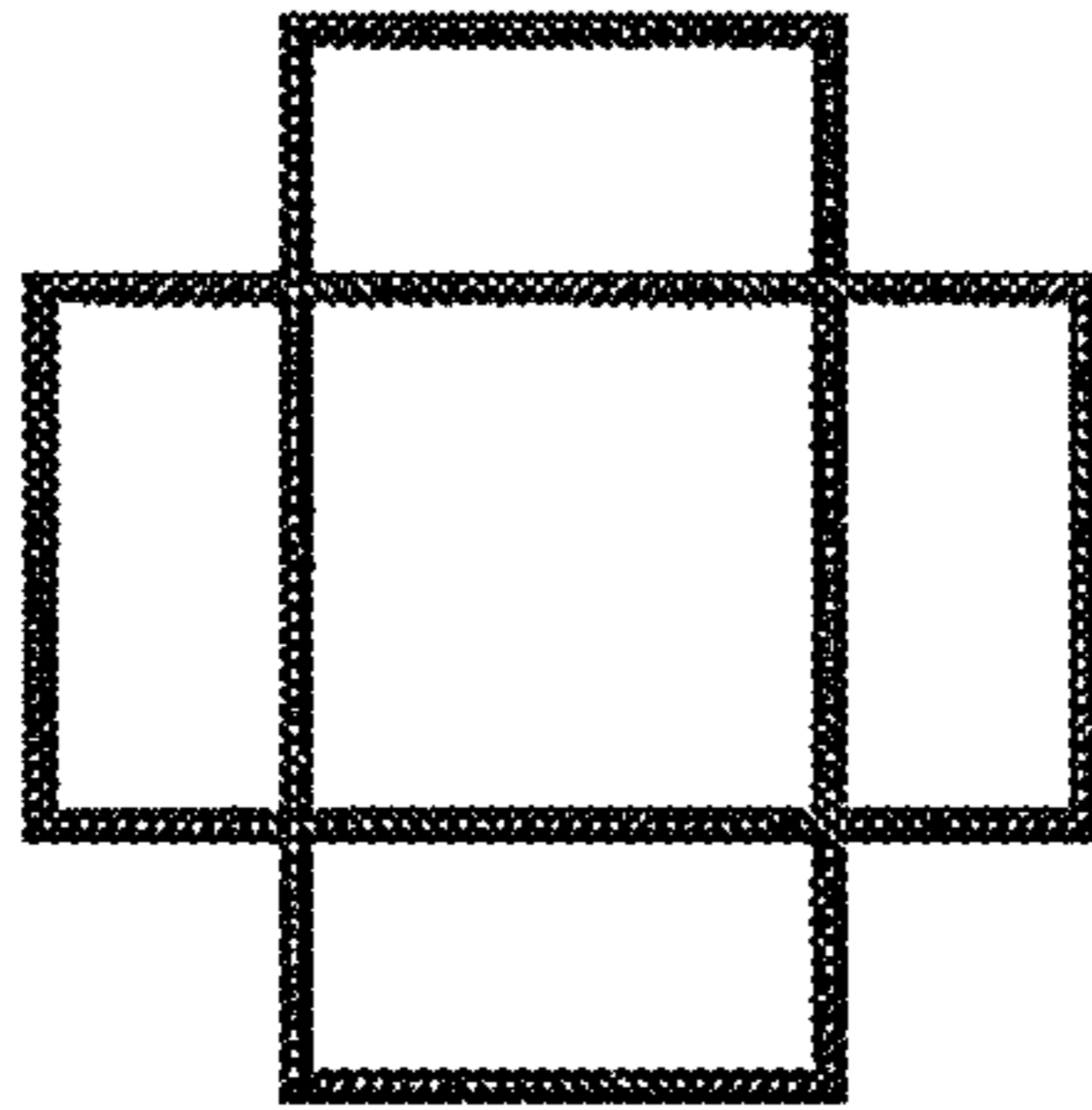

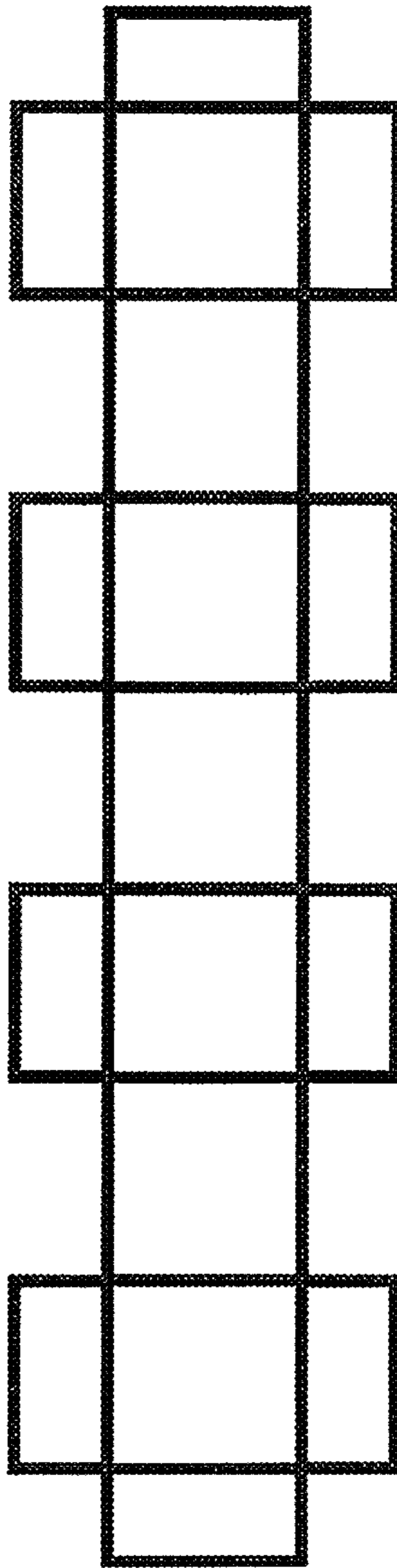

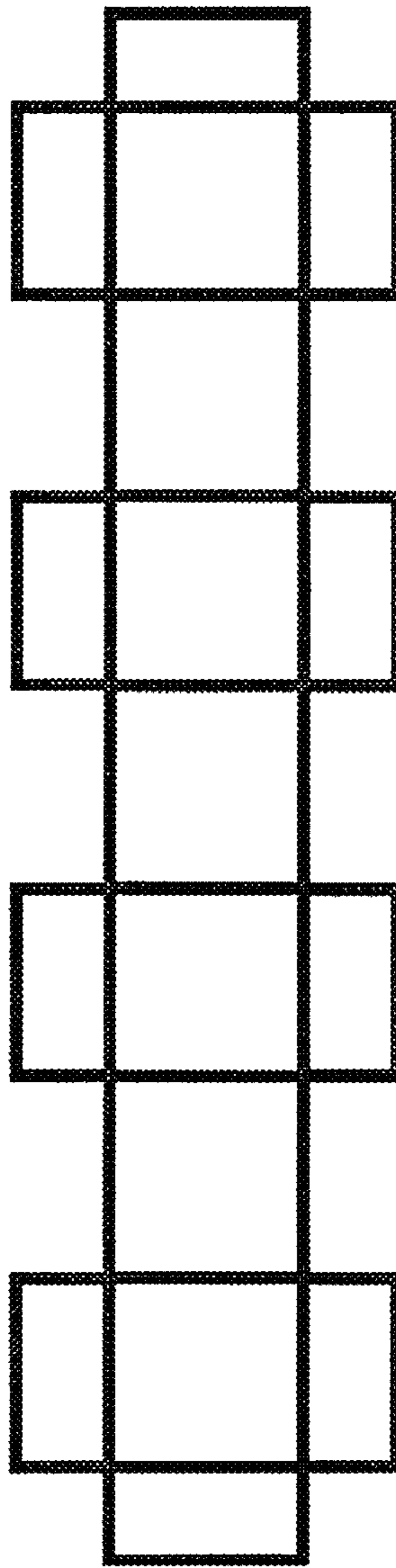

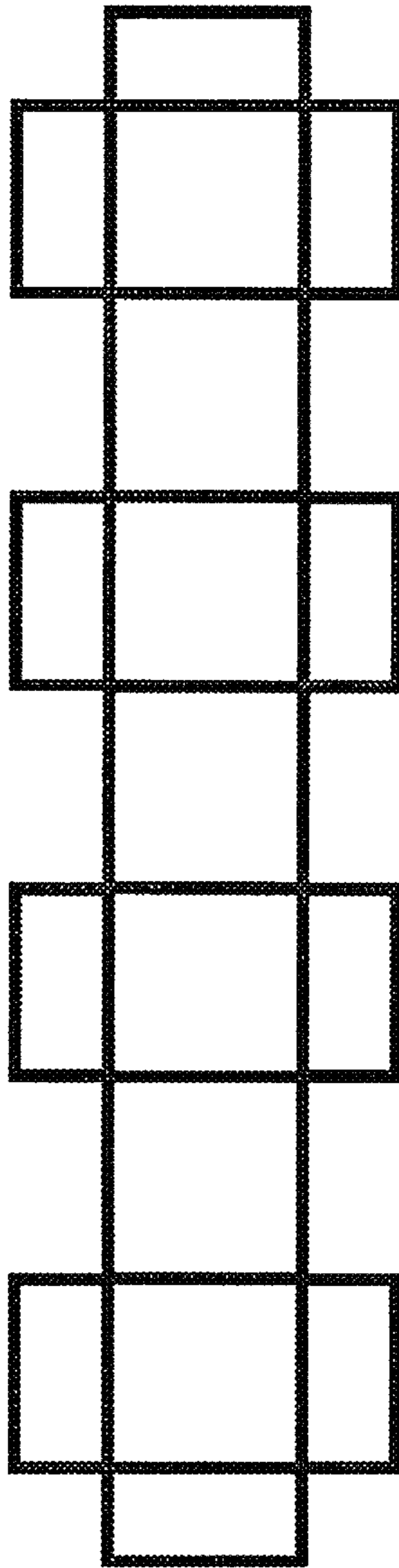

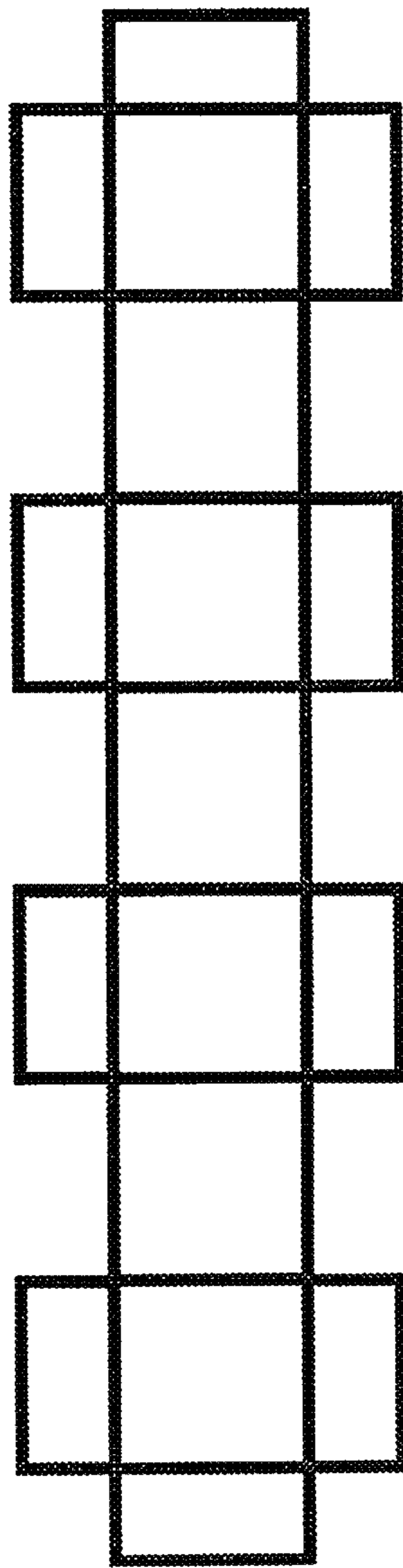
