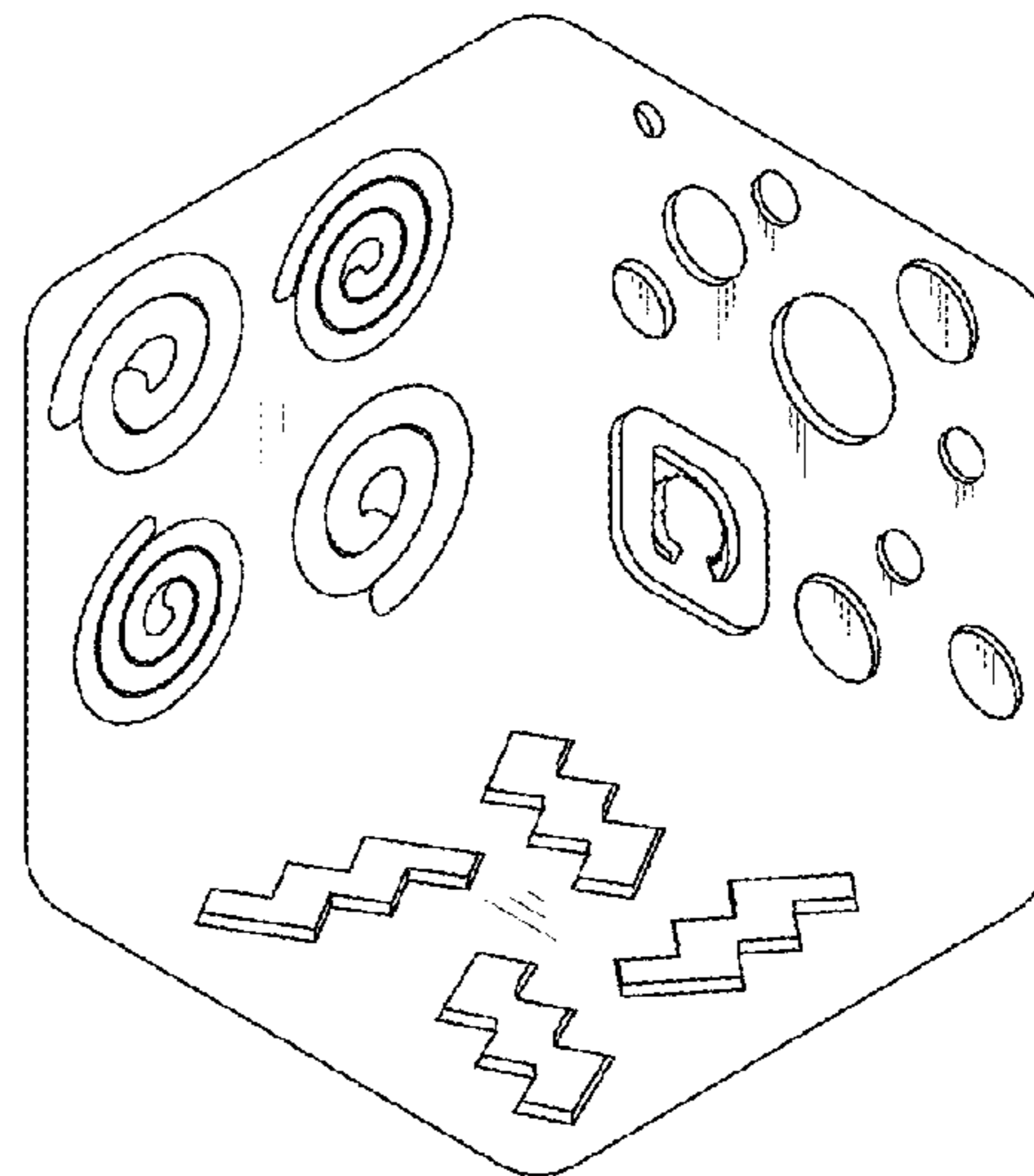
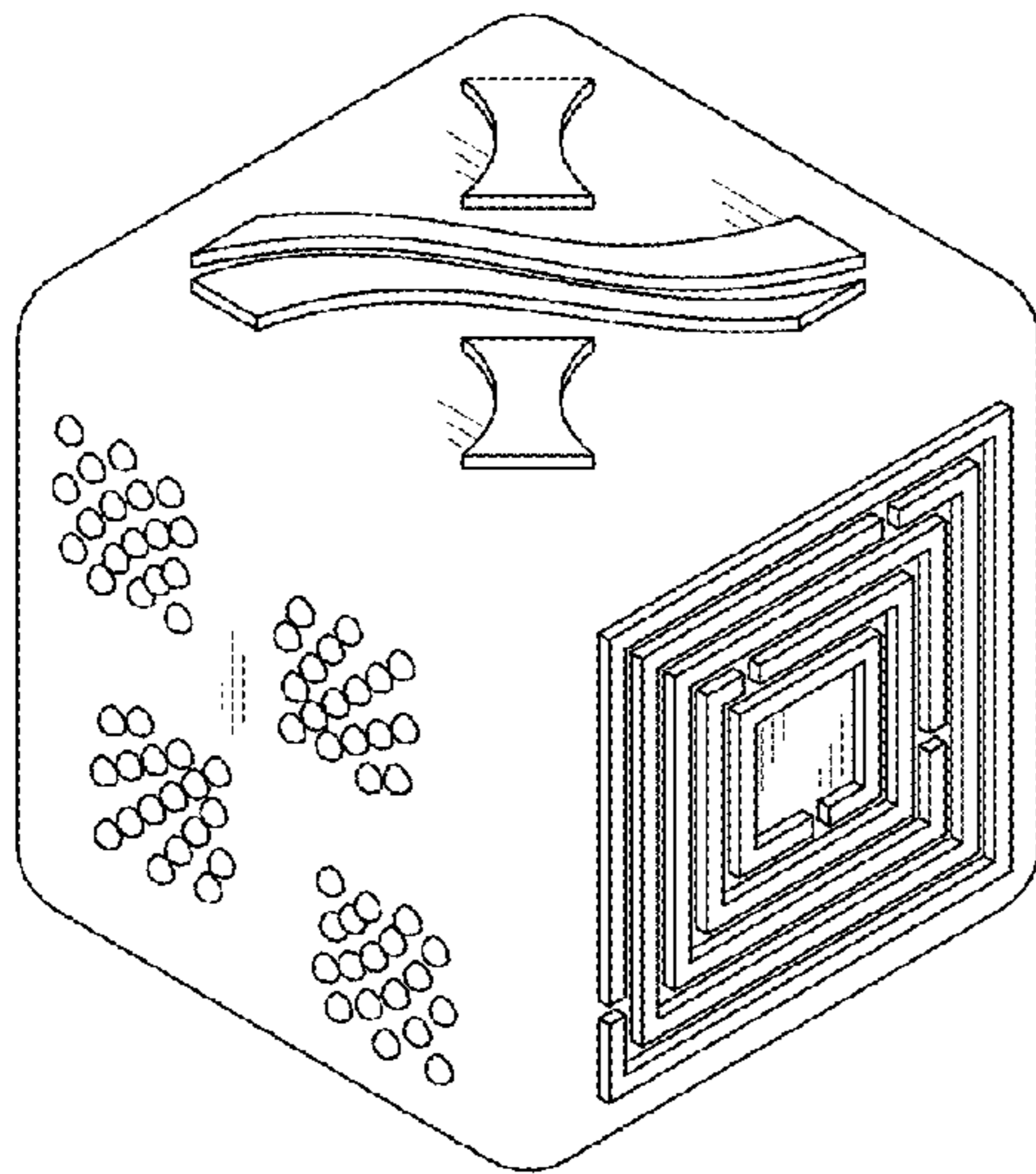
(57) **CLAIM**

The ornamental design for a toy block, as shown and described.

DESCRIPTION

FIG. 1 is a top front right isometric view of the toy block according to one embodiment of my new design; FIG. 2 is a top front left isometric view thereof; FIG. 3 is a bottom rear right isometric view thereof; FIG. 4 is a bottom rear left elevation view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a left elevation view thereof; FIG. 8 is a right elevation view thereof; FIG. 9 is a top plan view thereof; and, FIG. 10 is a bottom plan view thereof.

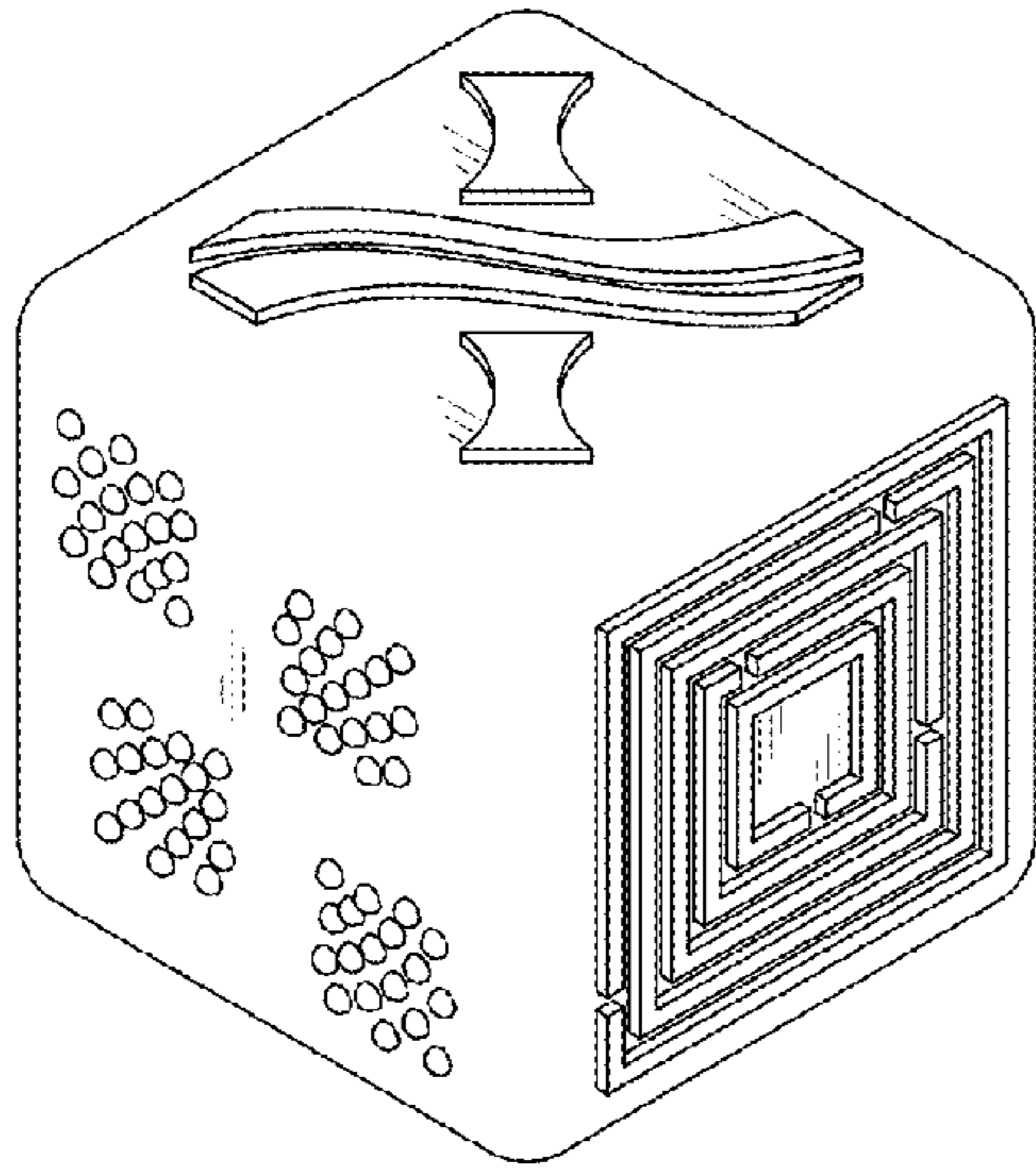

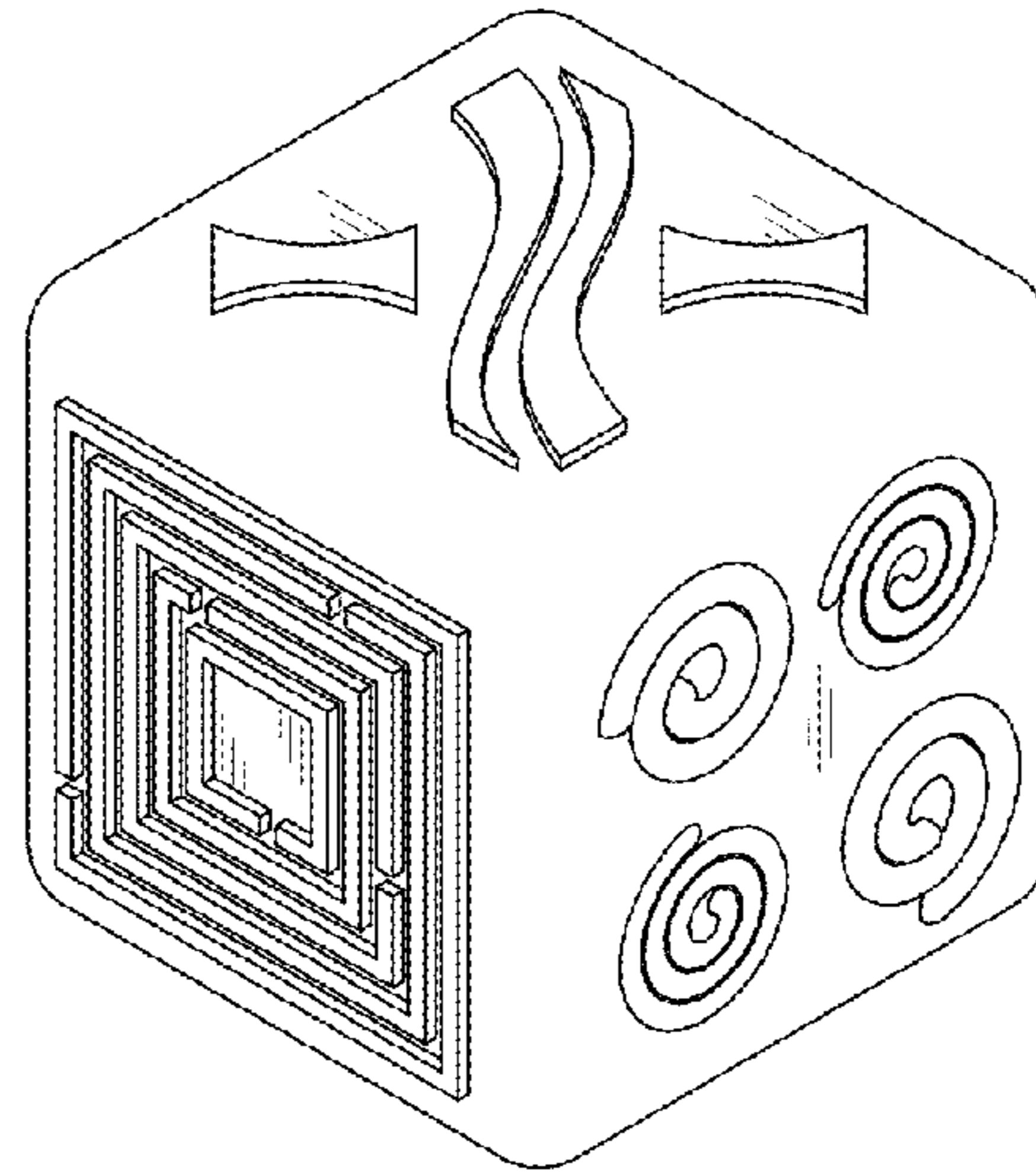

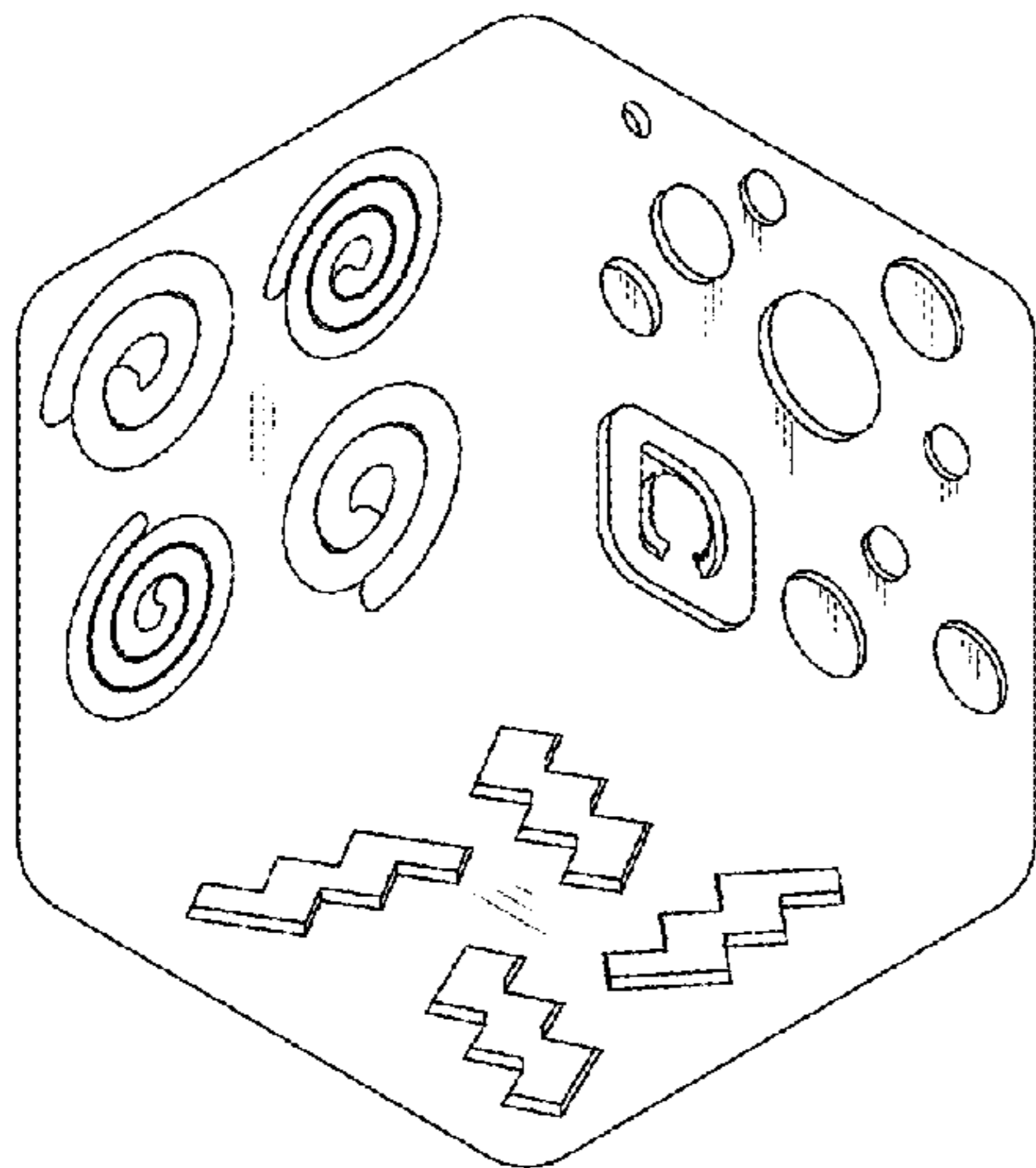

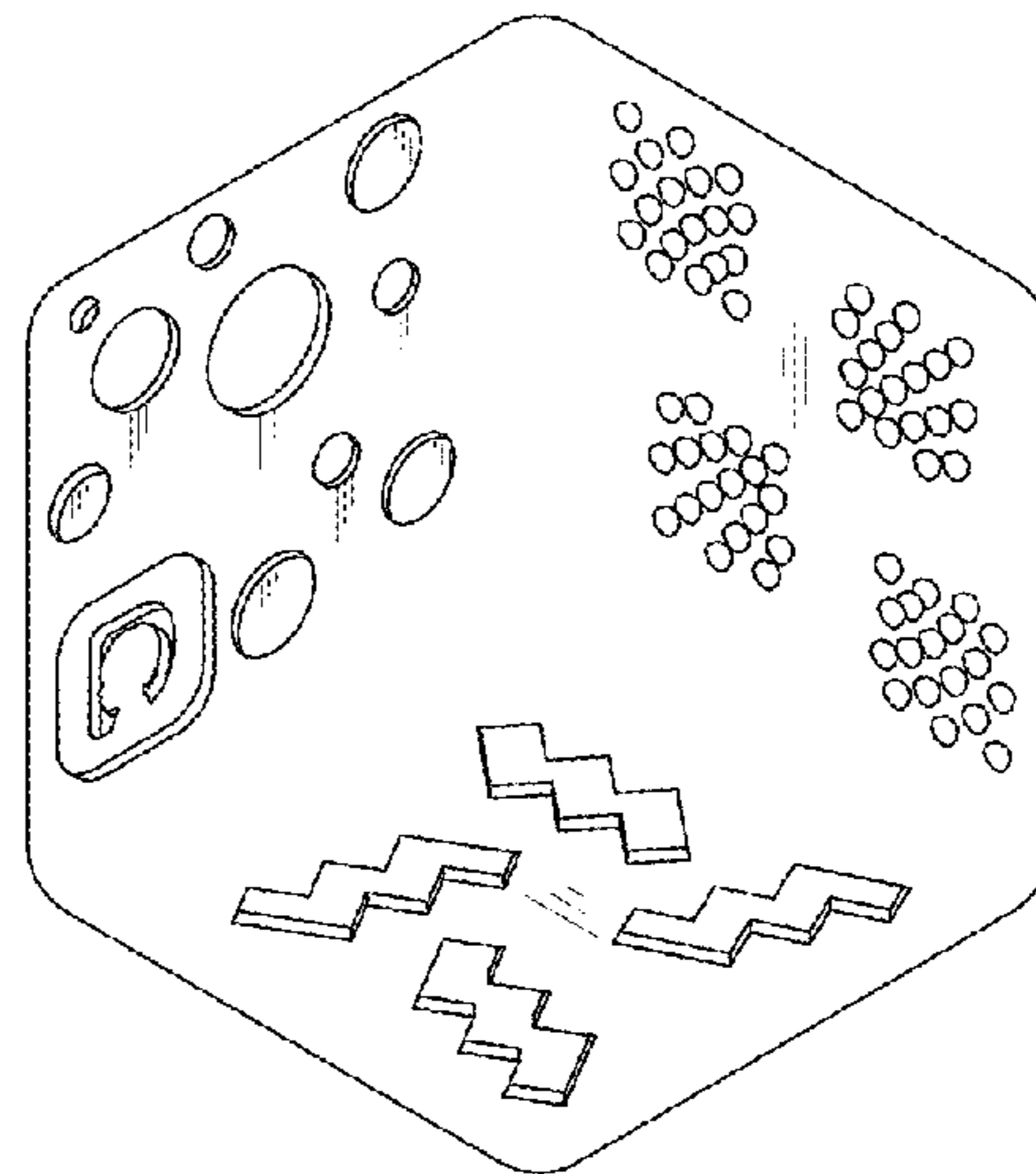

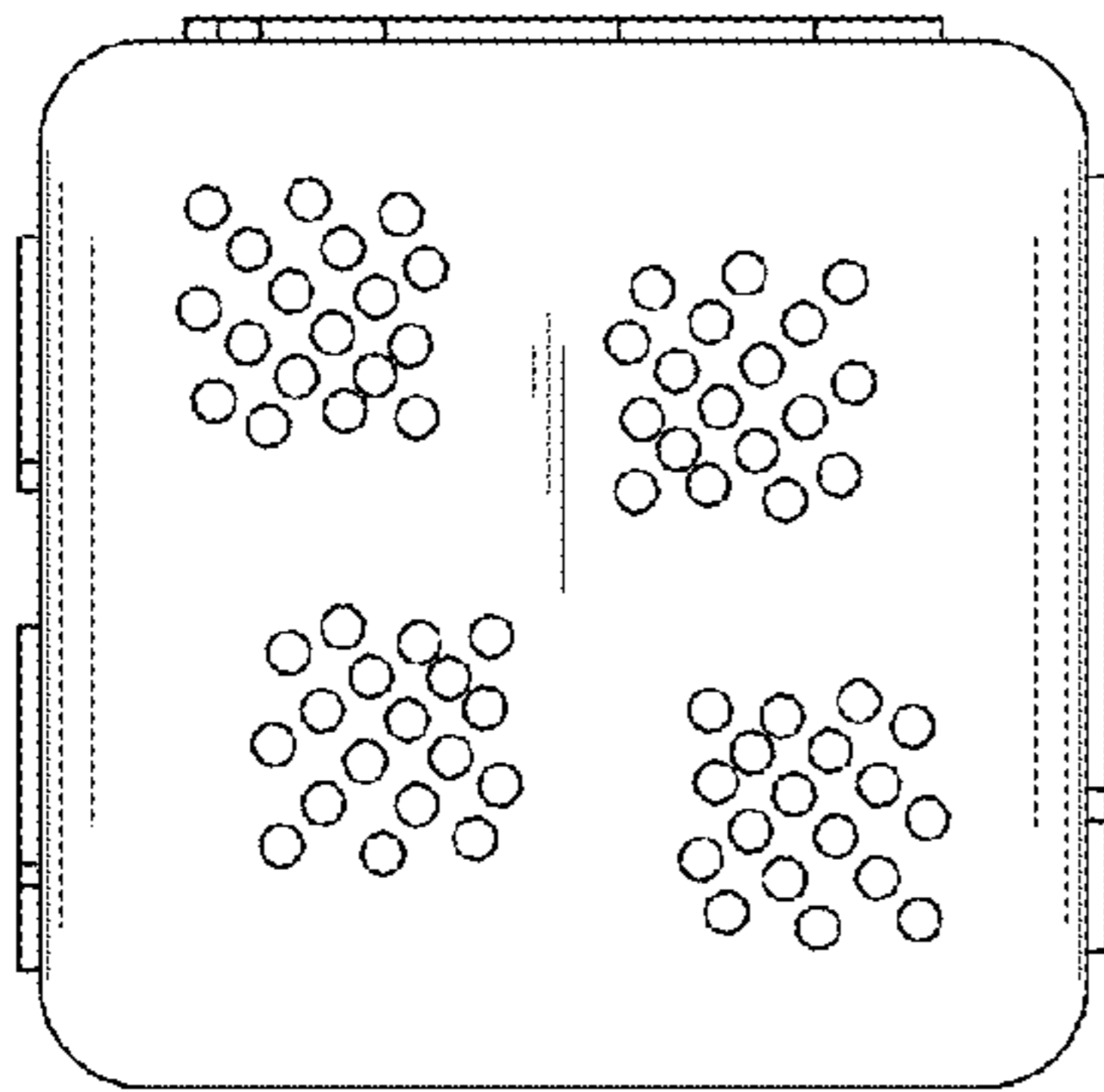

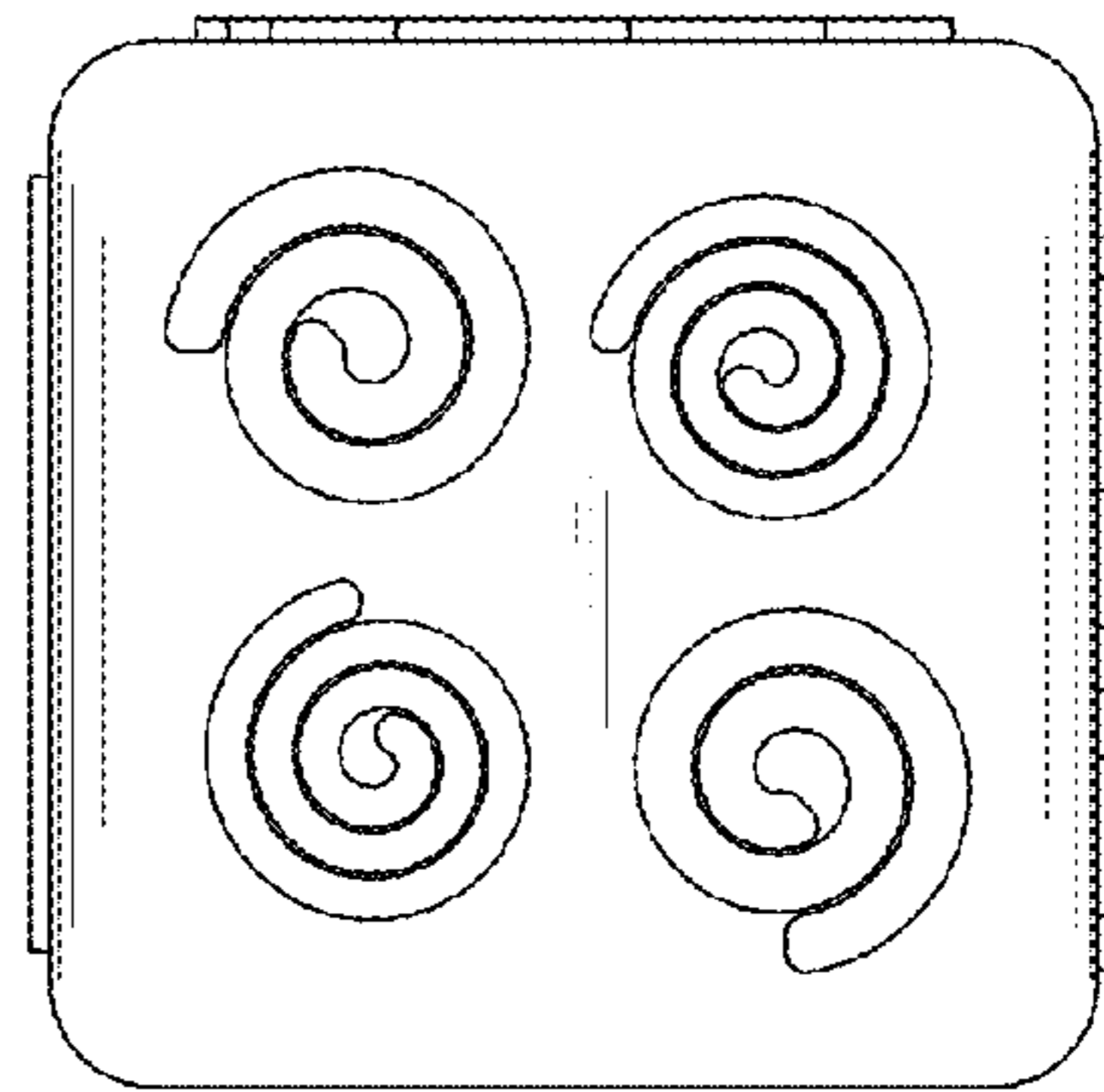

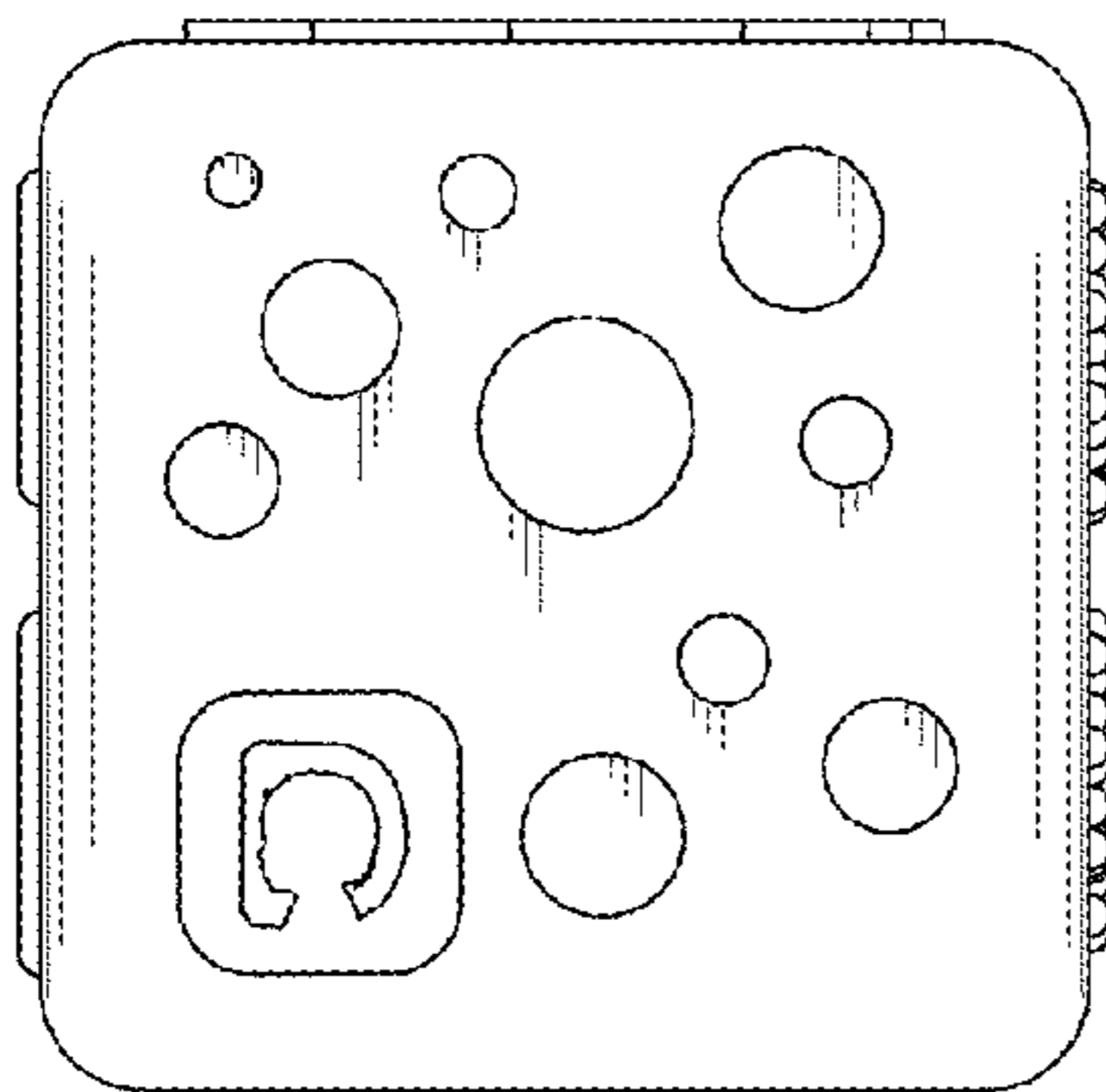

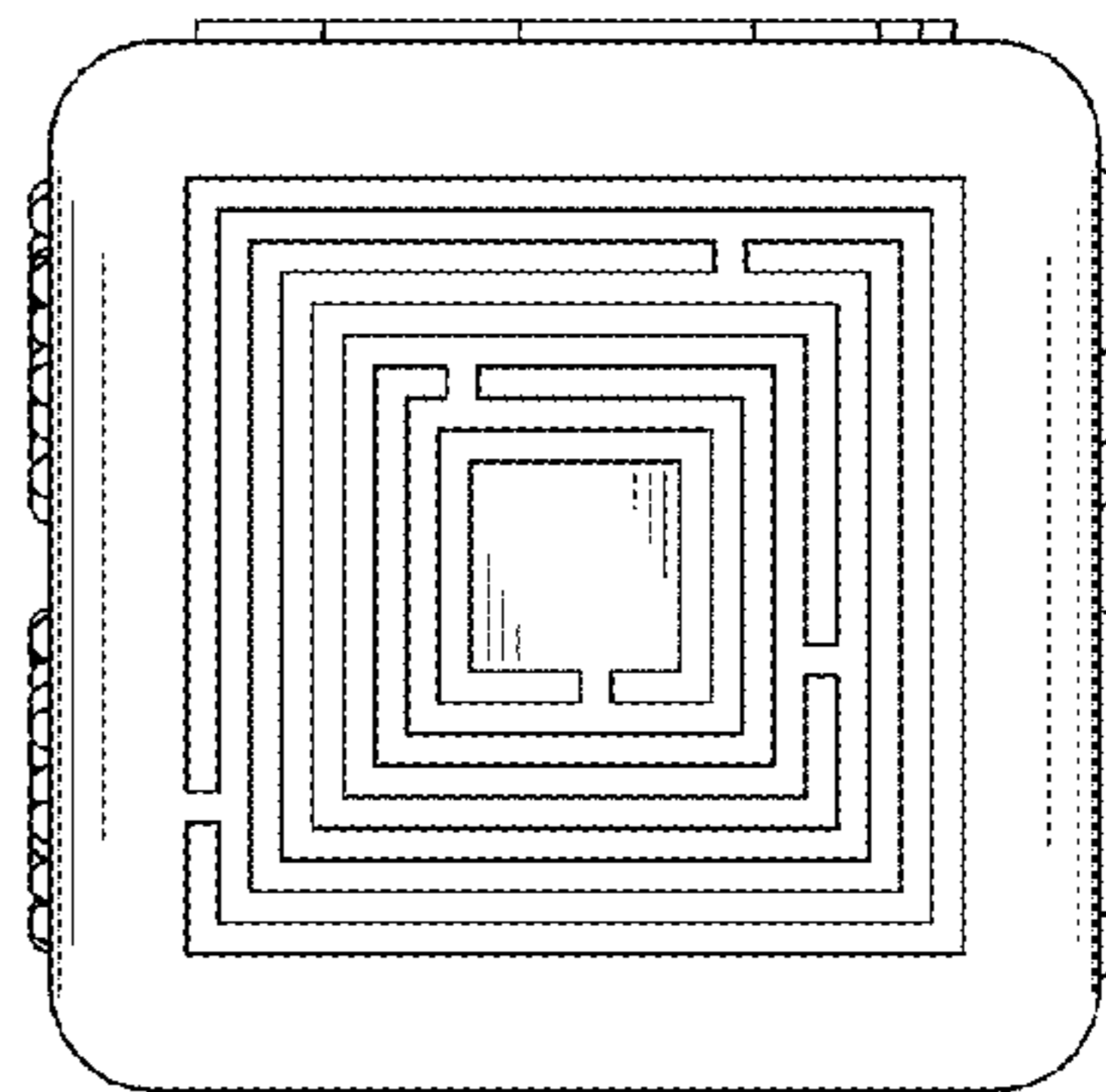

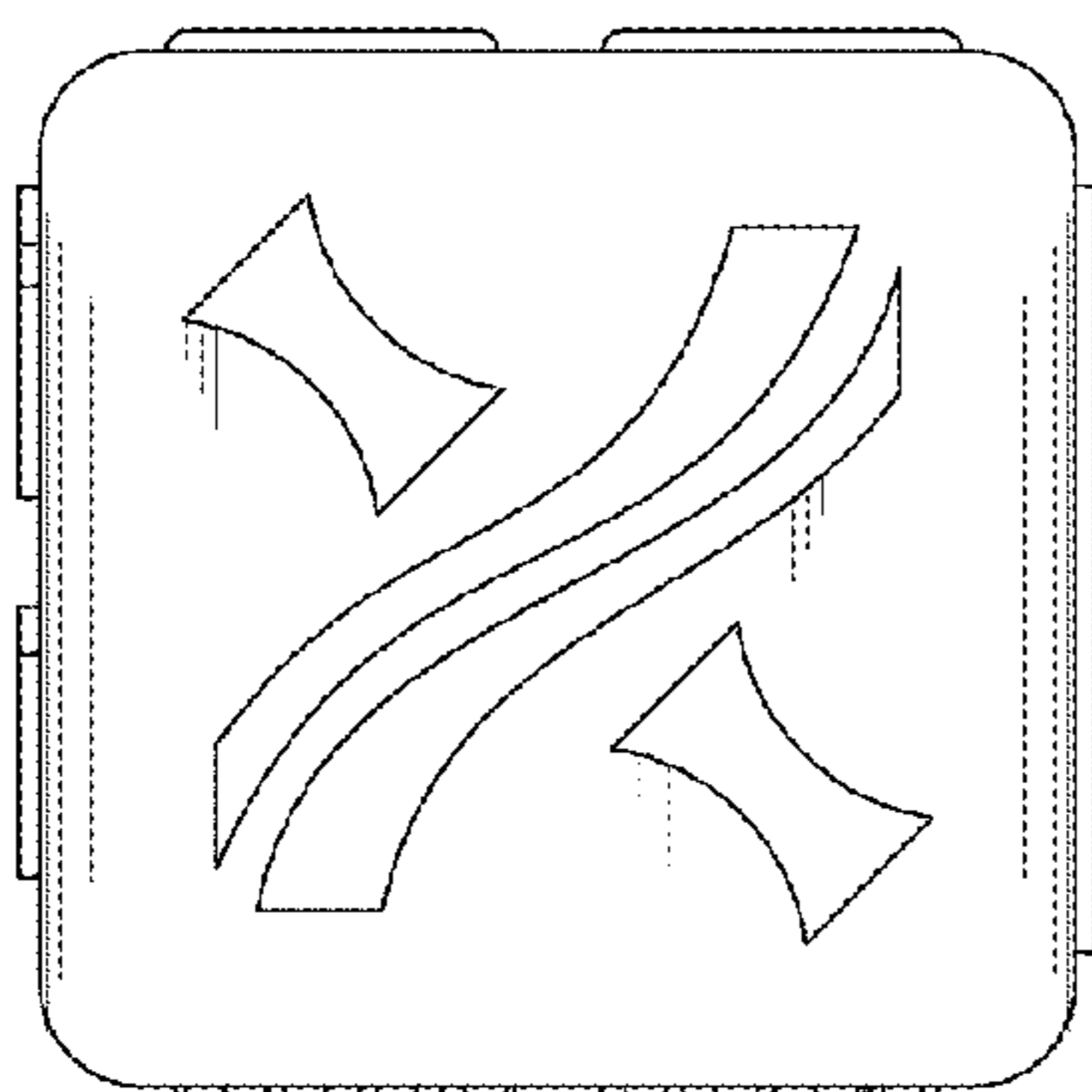

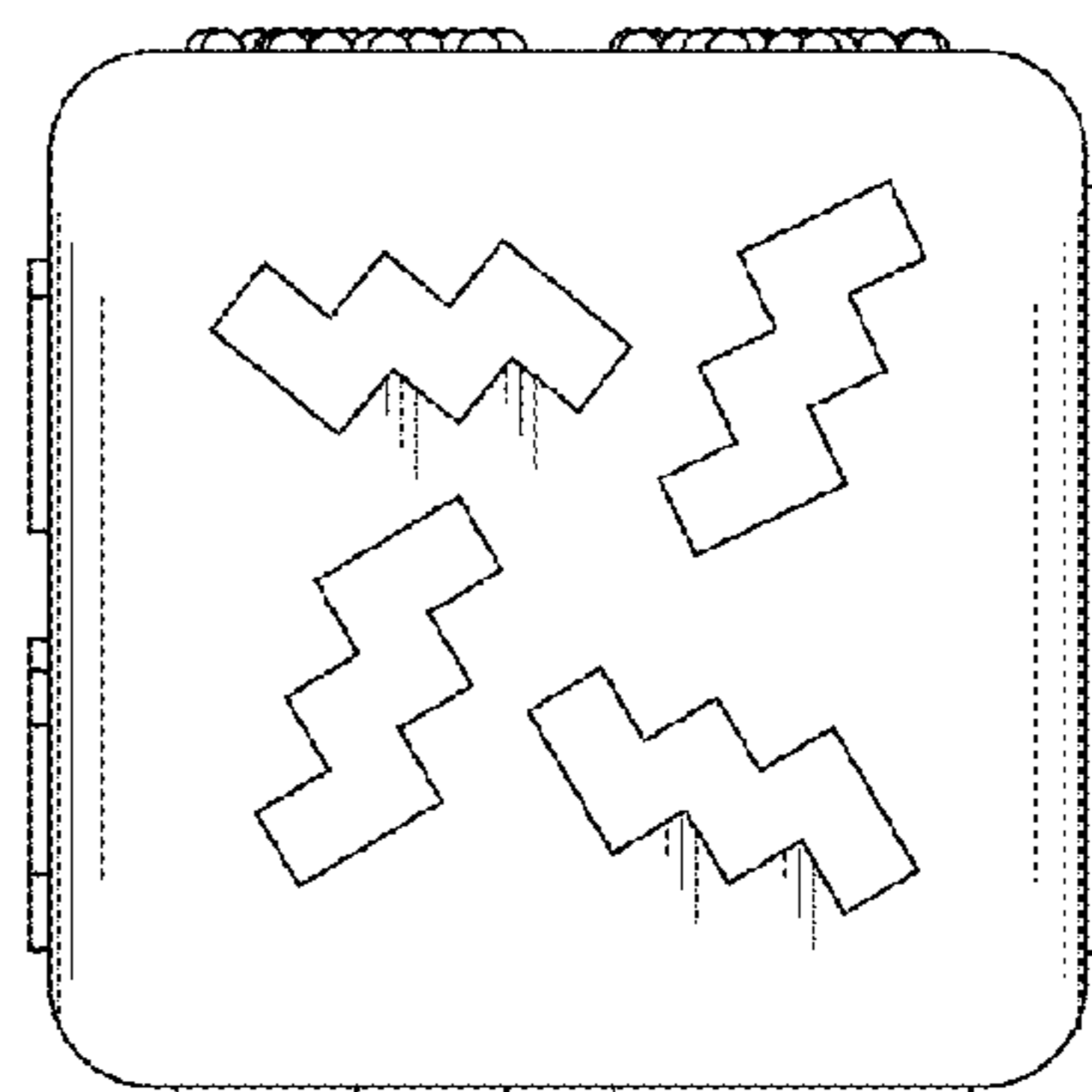
