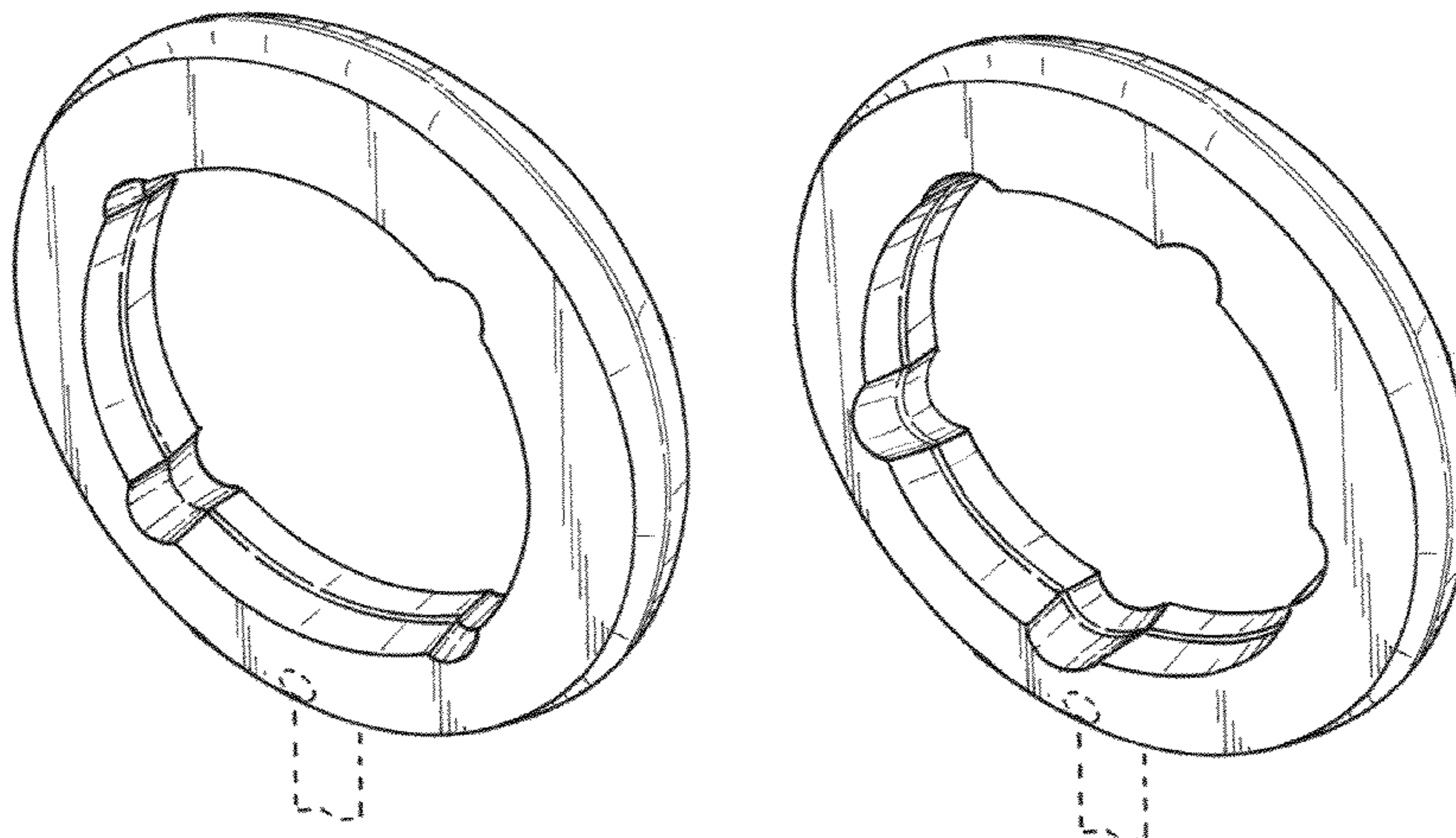
(57) **CLAIM**

The ornamental design for a golf ball retriever, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf ball retriever showing the new design;
 FIG. 2 is a front view, the back view being a mirror image;
 FIG. 3 is a top view;
 FIG. 4 is a bottom view;
 FIG. 5 is a left side view, the right side view being a mirror image;
 FIG. 6 is a perspective view of a first alternate embodiment;
 and,
 FIG. 7 is a perspective view of a second alternate embodiment.
 The broken lines are included for the purpose of illustrating portions of the golf ball retriever that form no part of the claimed design.

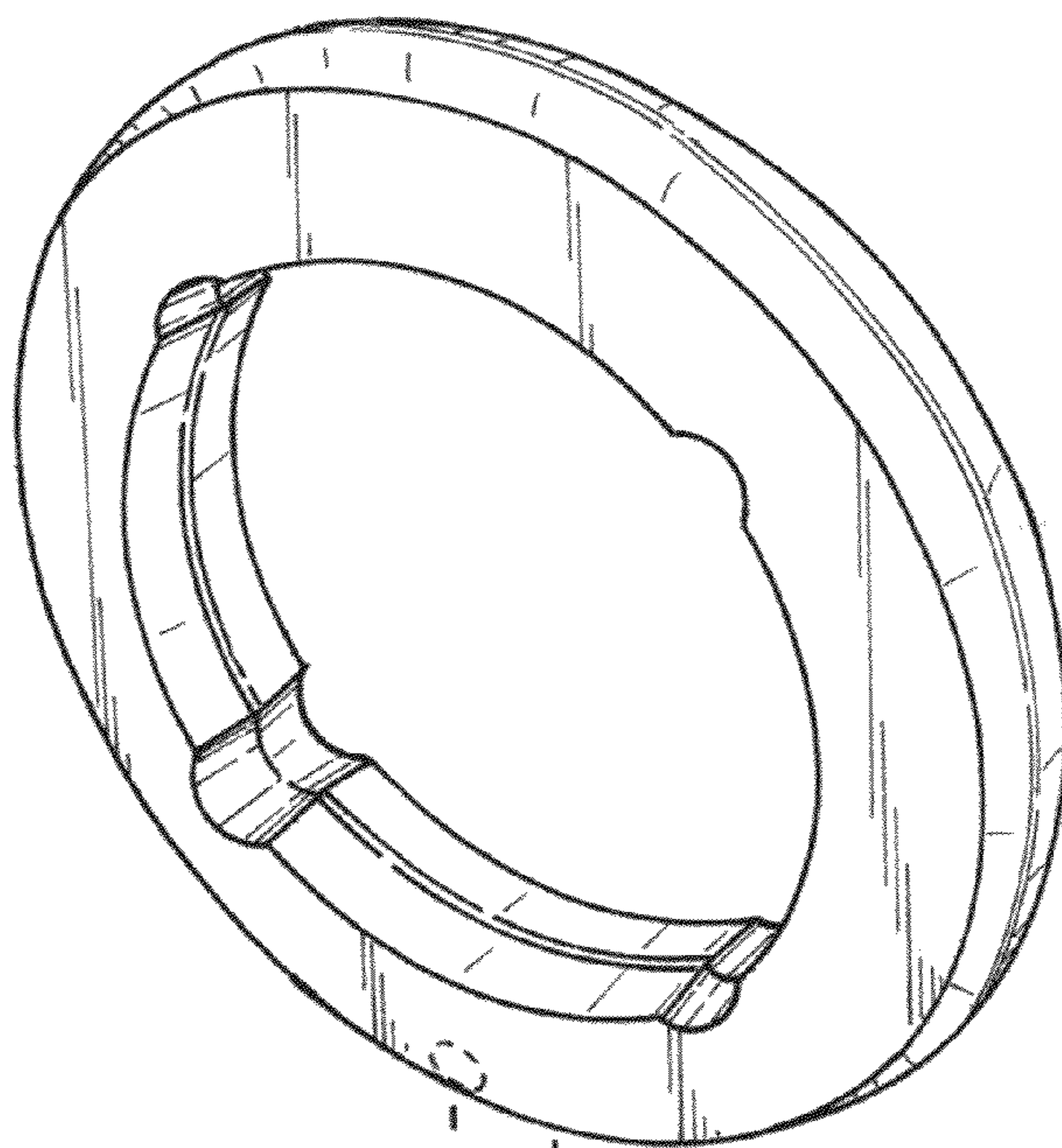

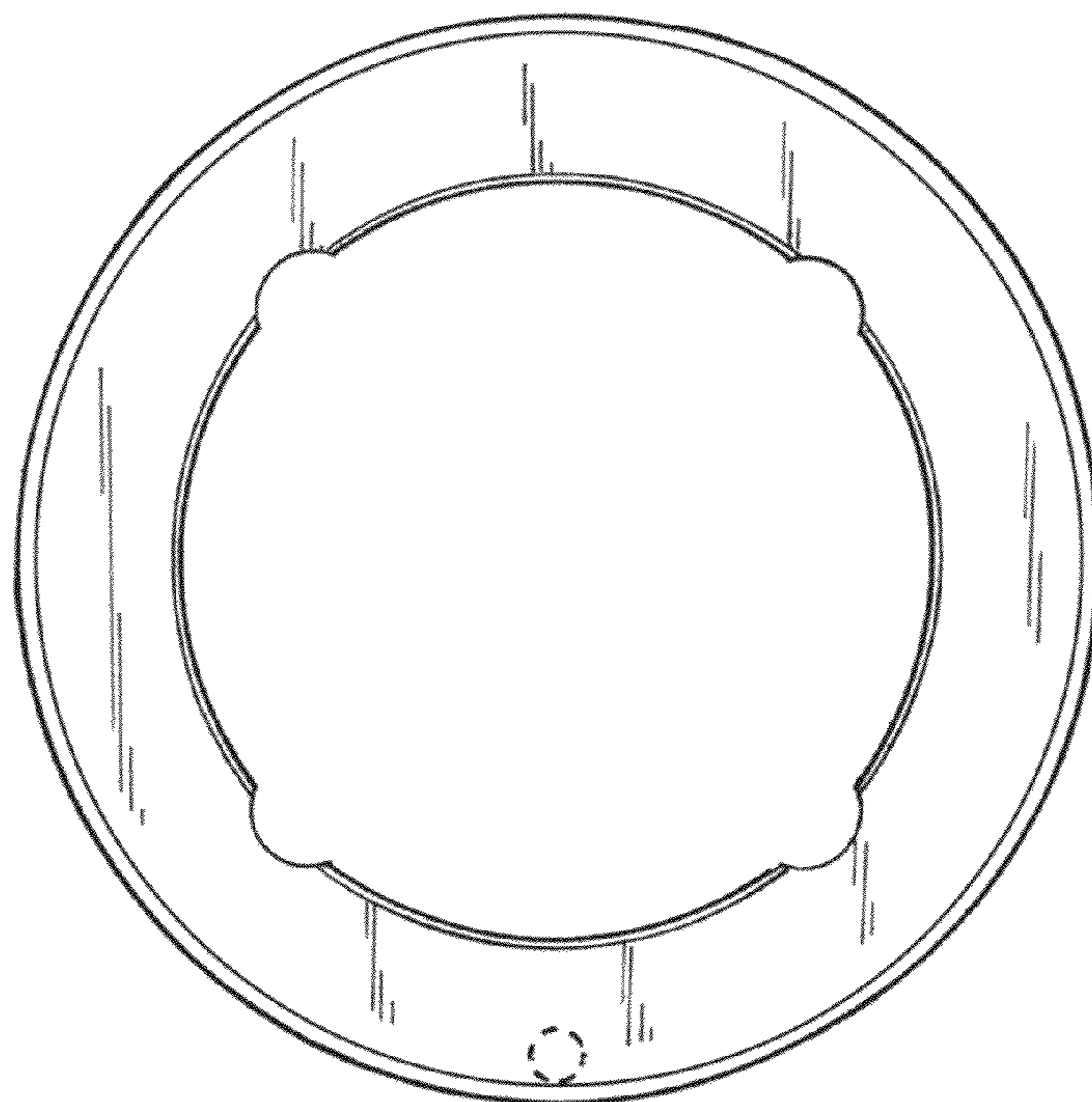

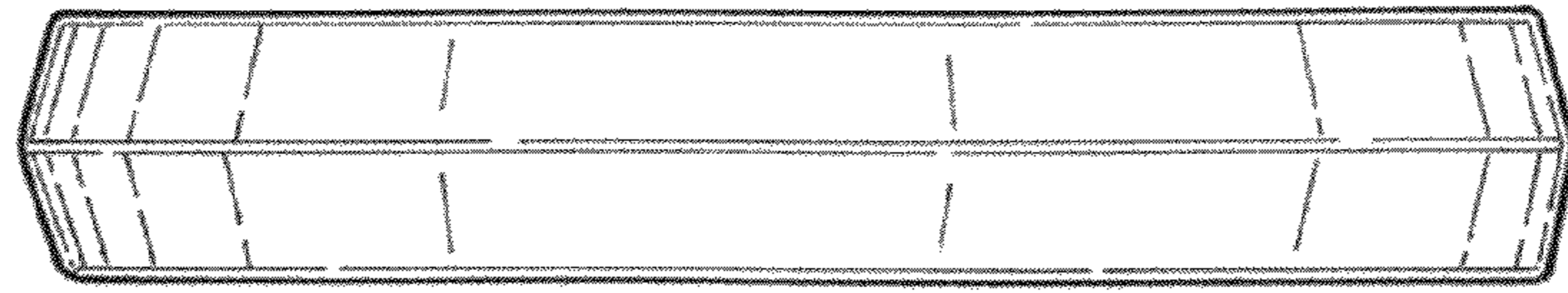

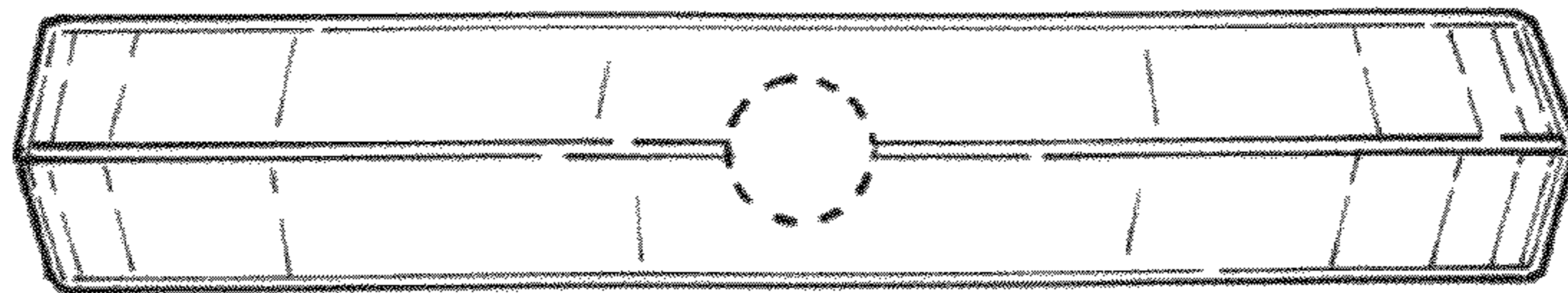

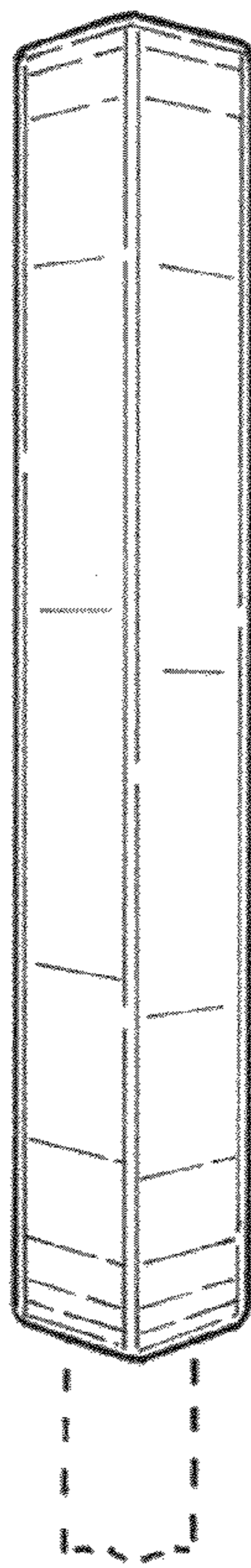

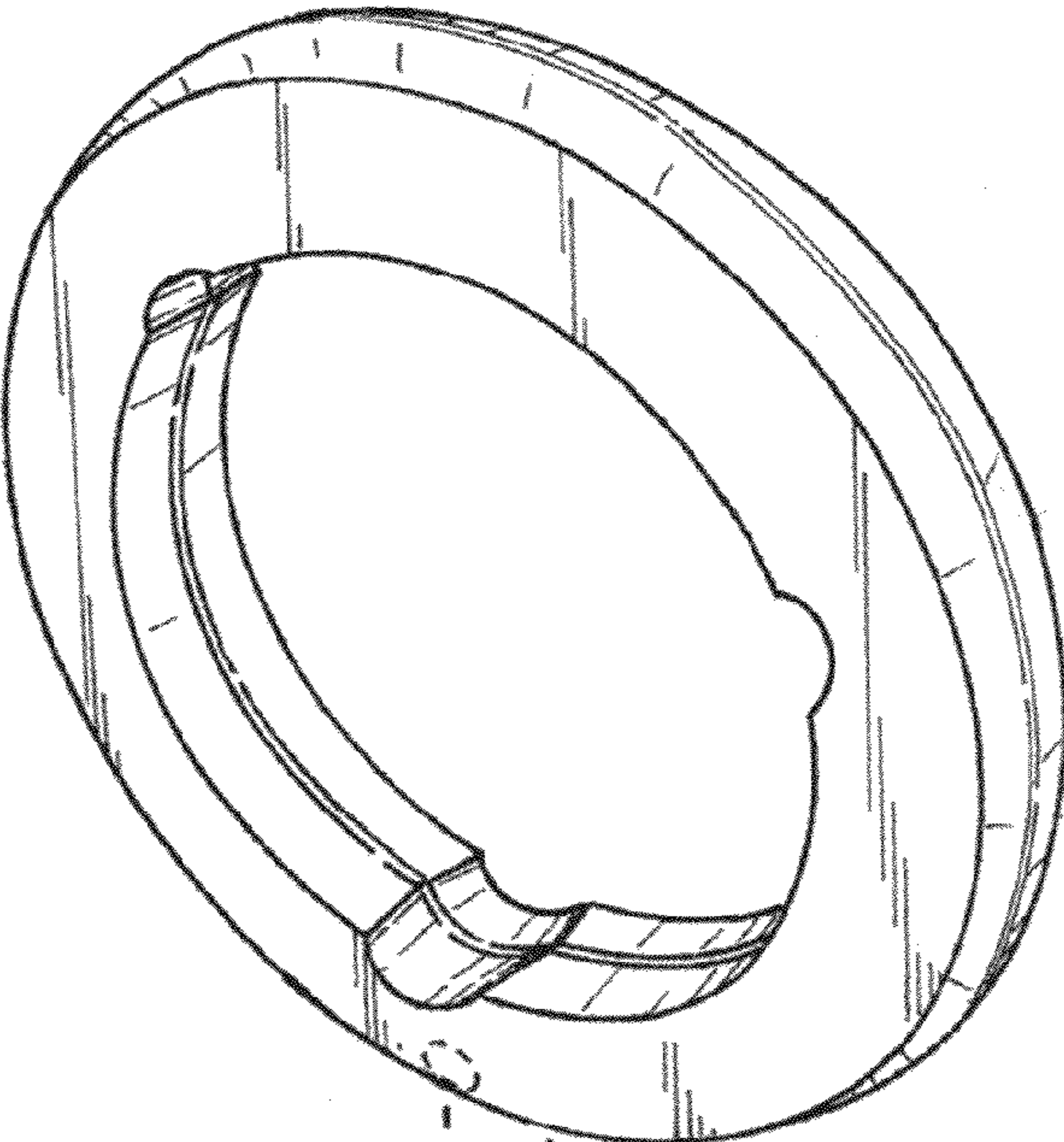

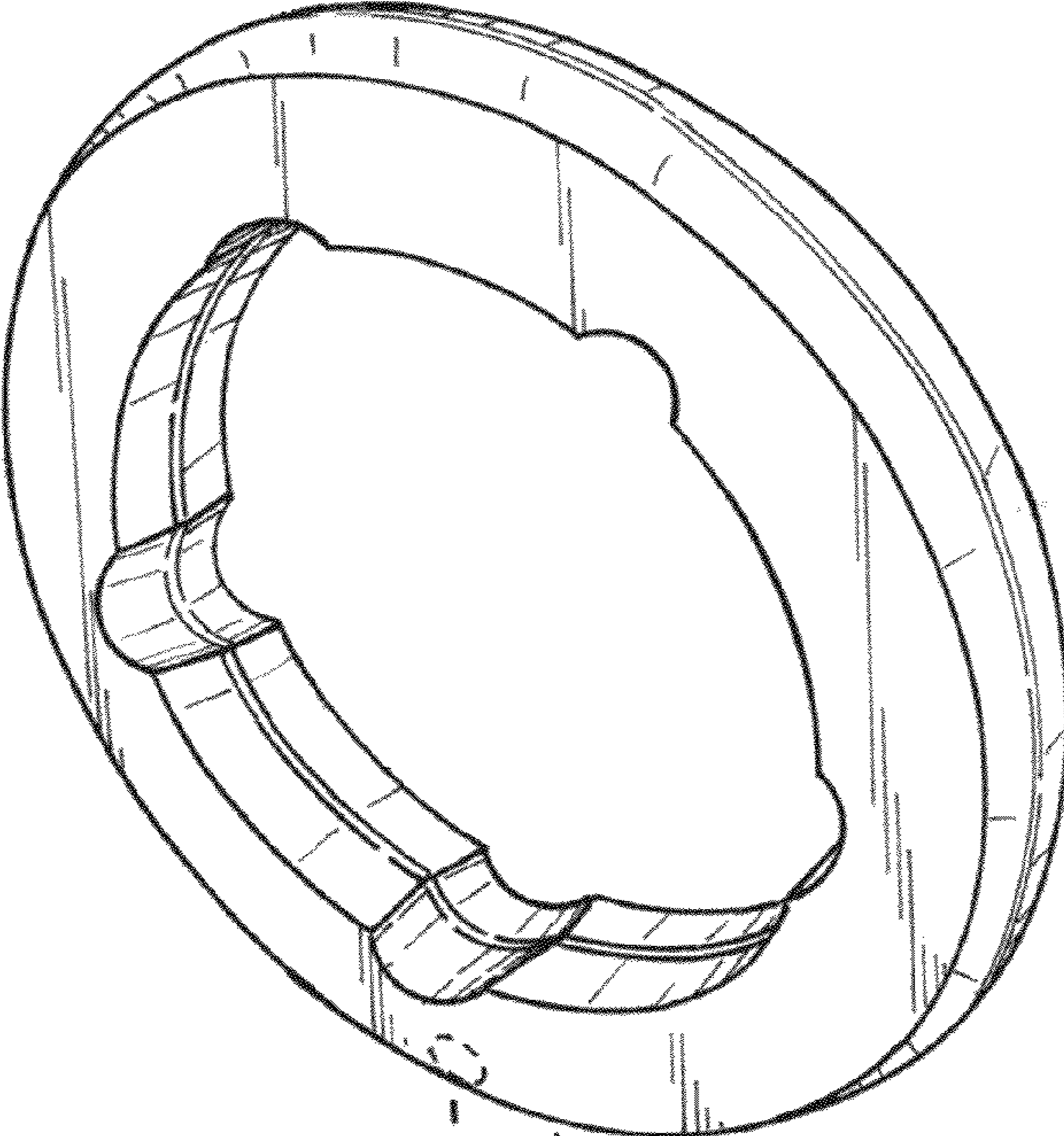
