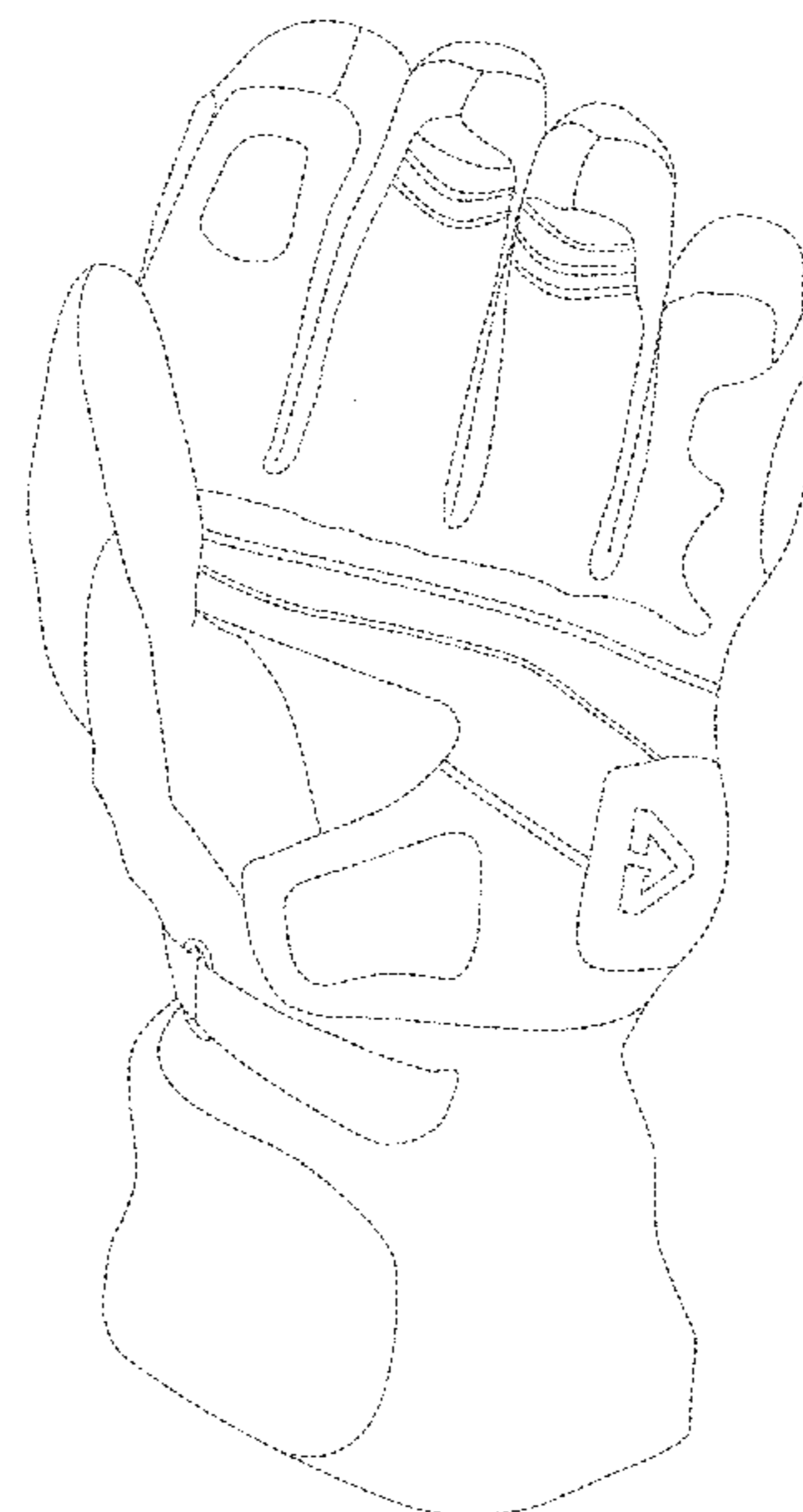
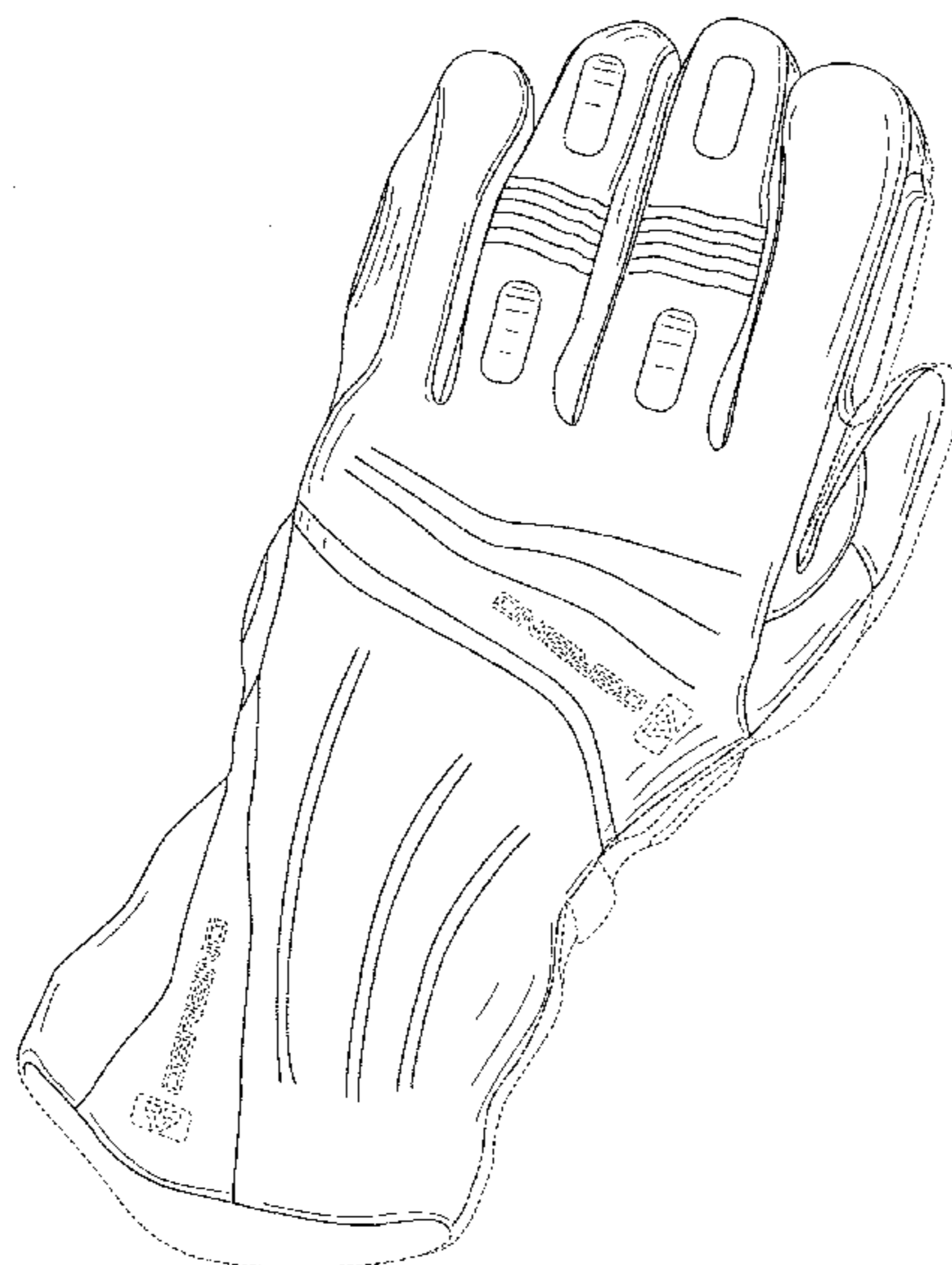
(57) **CLAIM**

The ornamental design for a glove, as shown in the accompanying drawings and described above.

DESCRIPTION

FIG. 1 is a perspective view of a glove of the present invention;
FIG. 2 is a top plan view of the glove of FIG. 1;
FIG. 3 is a bottom plan view of the glove of FIG. 1;
FIG. 4 is a left elevation view of the glove of FIG. 1;
FIG. 5 is a right elevation view of the glove of FIG. 1;
FIG. 6 is a front elevation view of the glove of FIG. 1; and,
FIG. 7 is a rear elevation view of the glove of FIG. 1.
The evenly-incremented broken lines shown in the drawings illustrate environmental structure. The short-dash-long-dash broken lines represent the bounds of the claimed design. None of the broken line elements form a part of the claimed design.

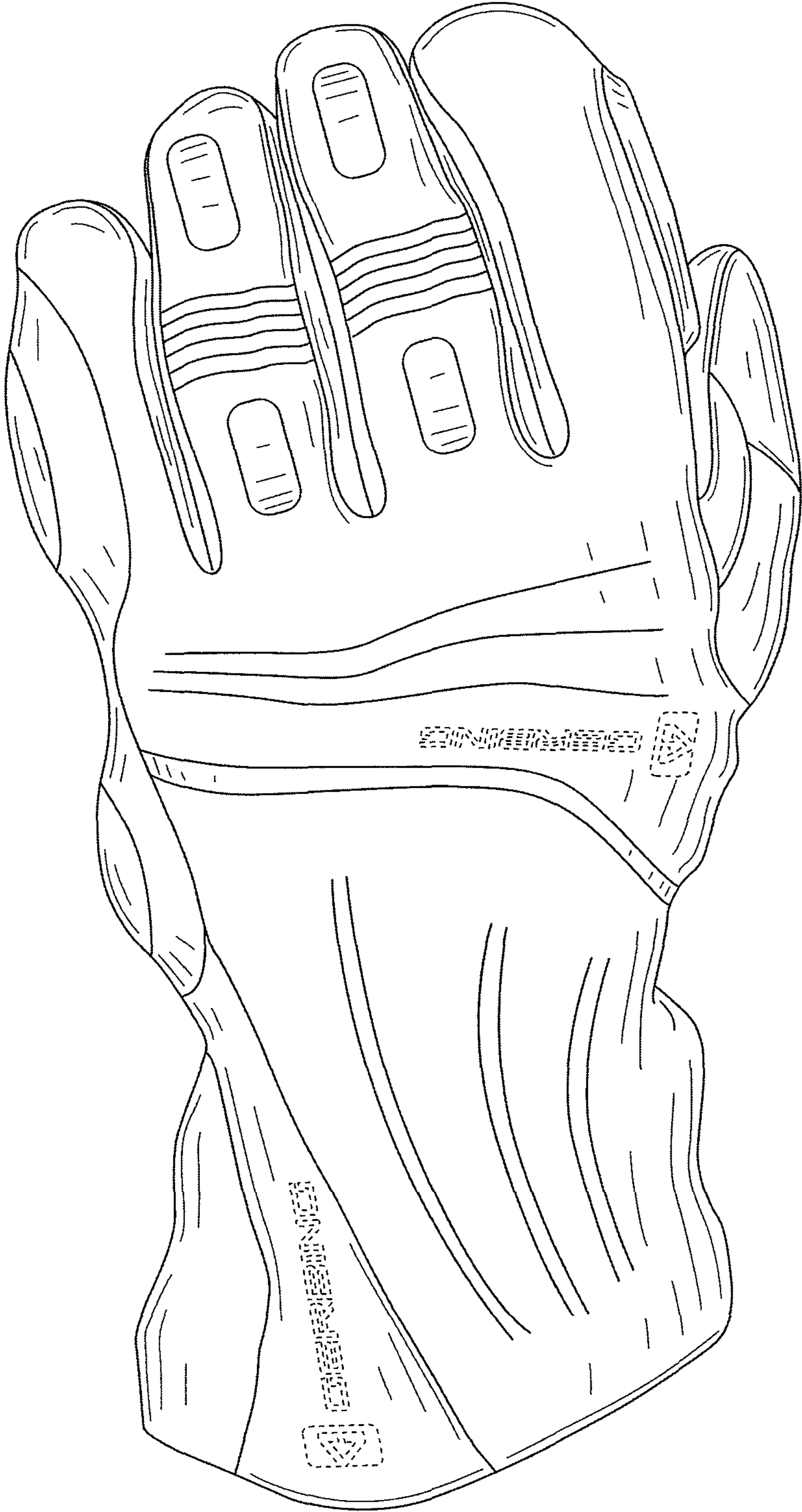

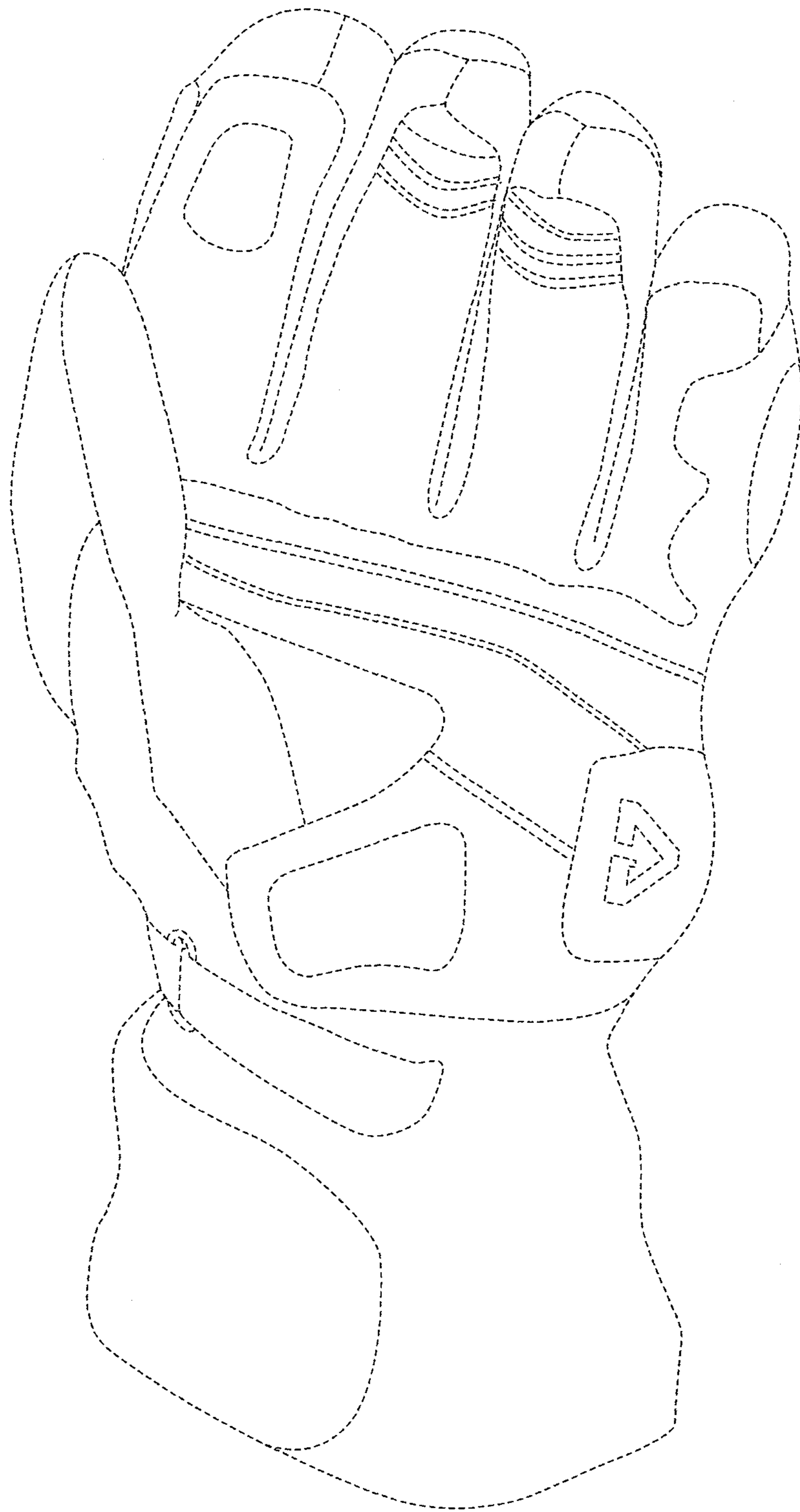

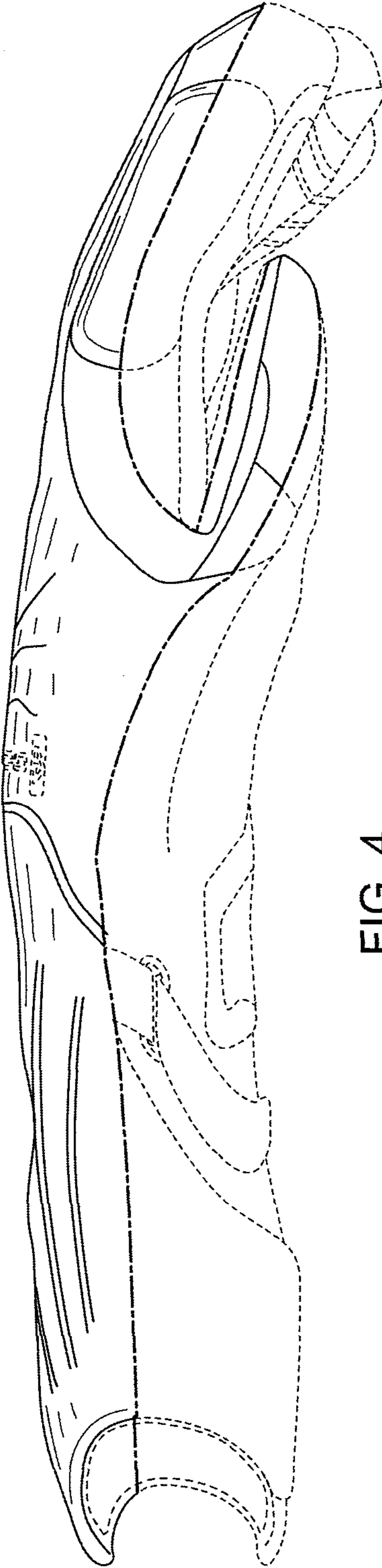

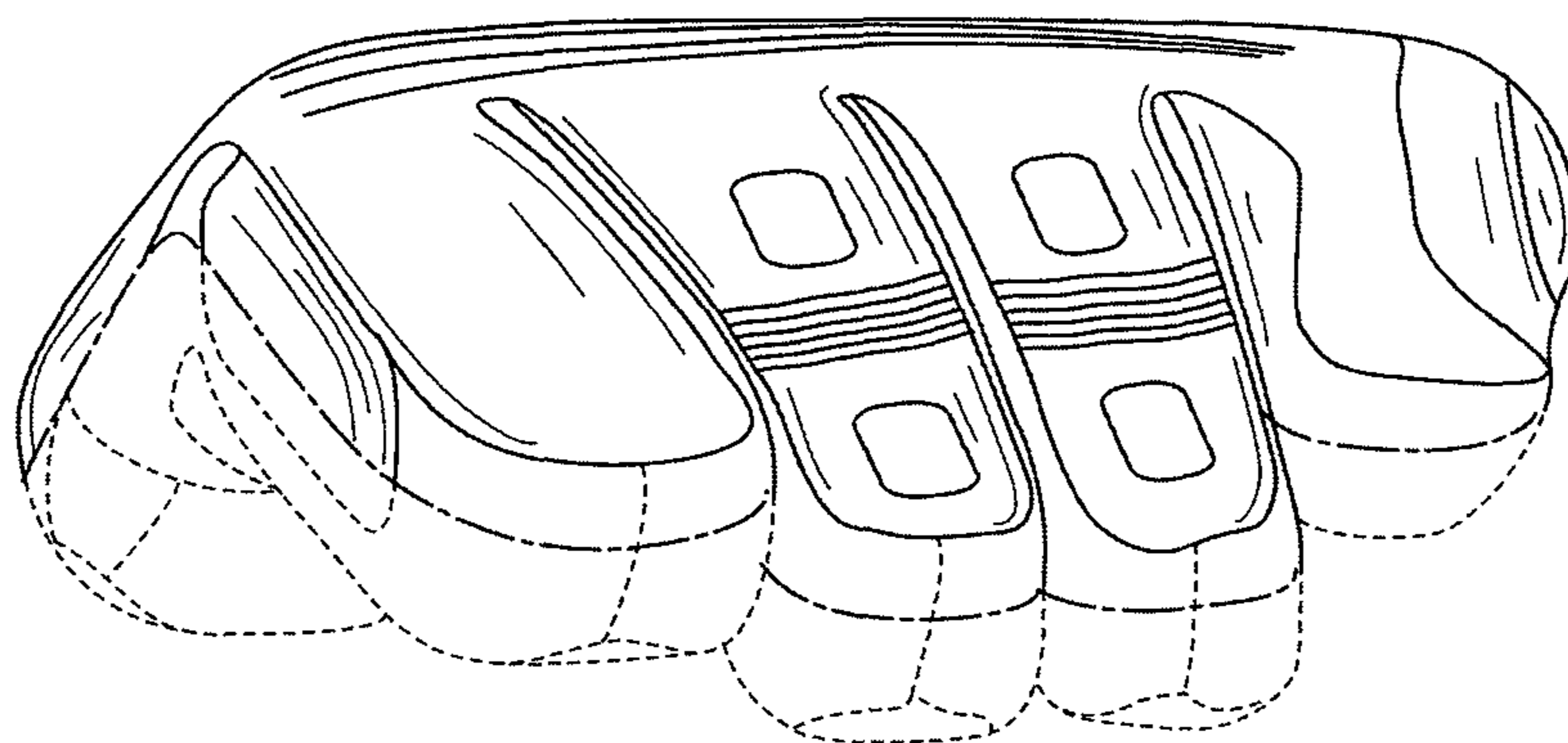

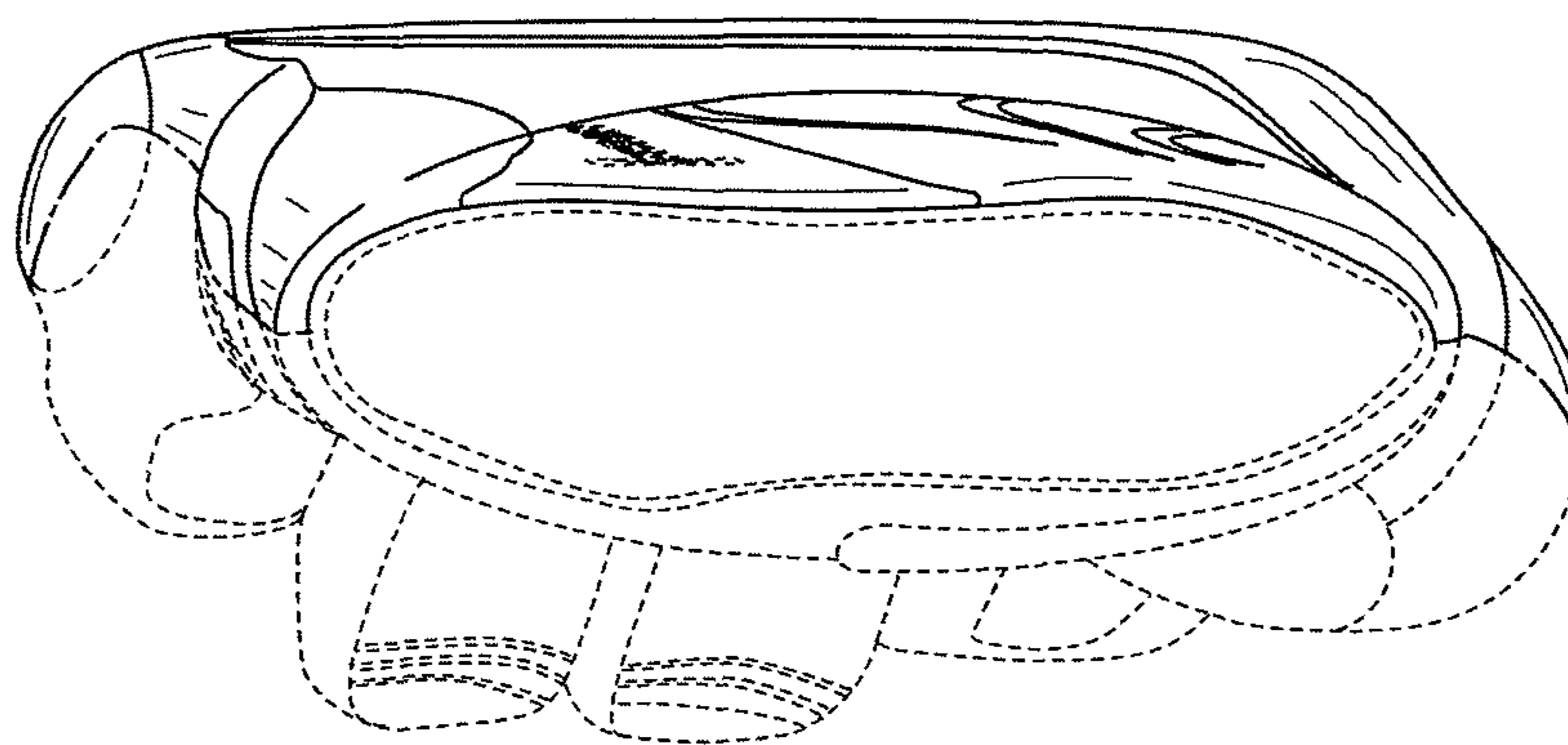
