shown and described.

DESCRIPTION

lid;

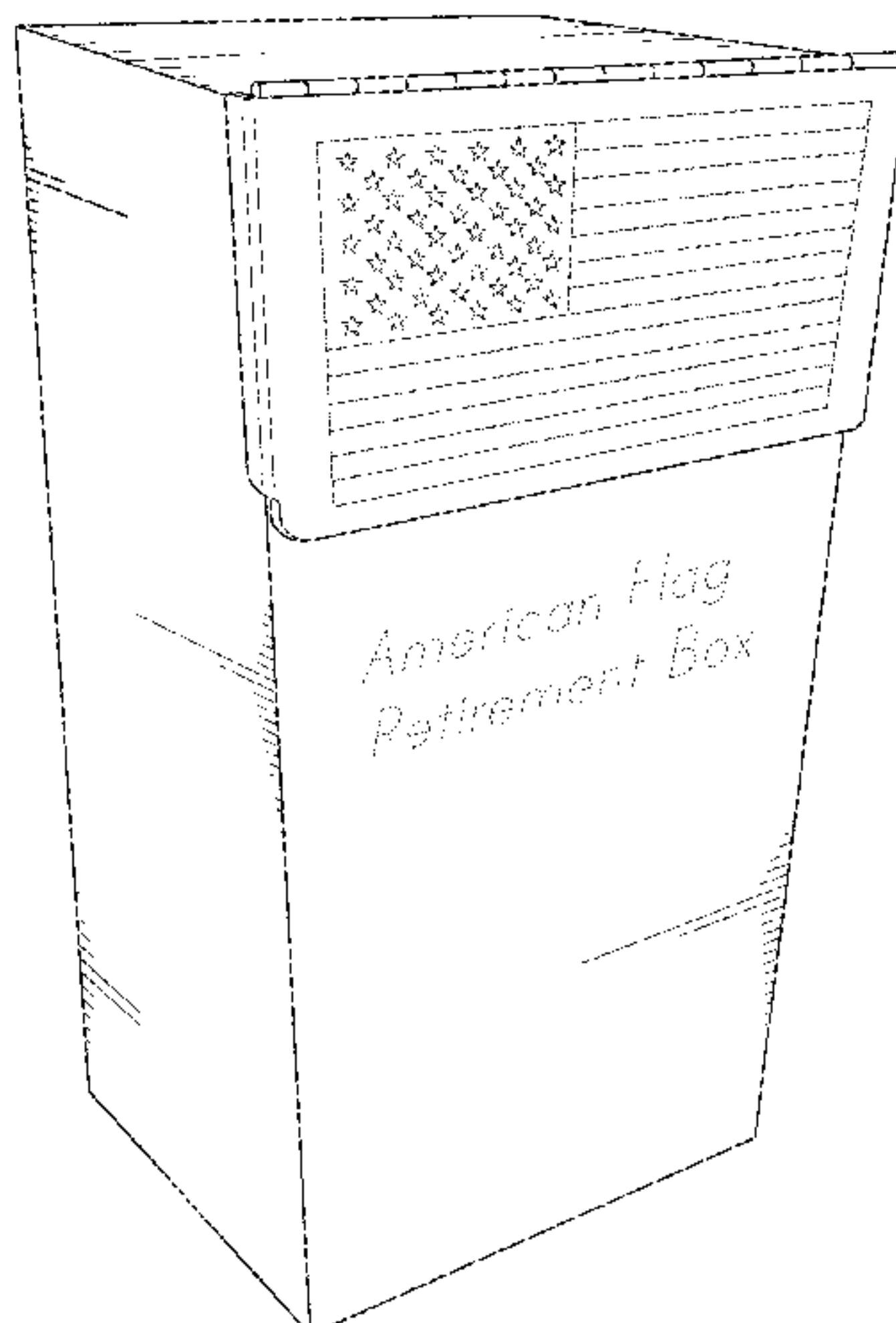
FIG. 9 is a side elevational view with a partially open lid;

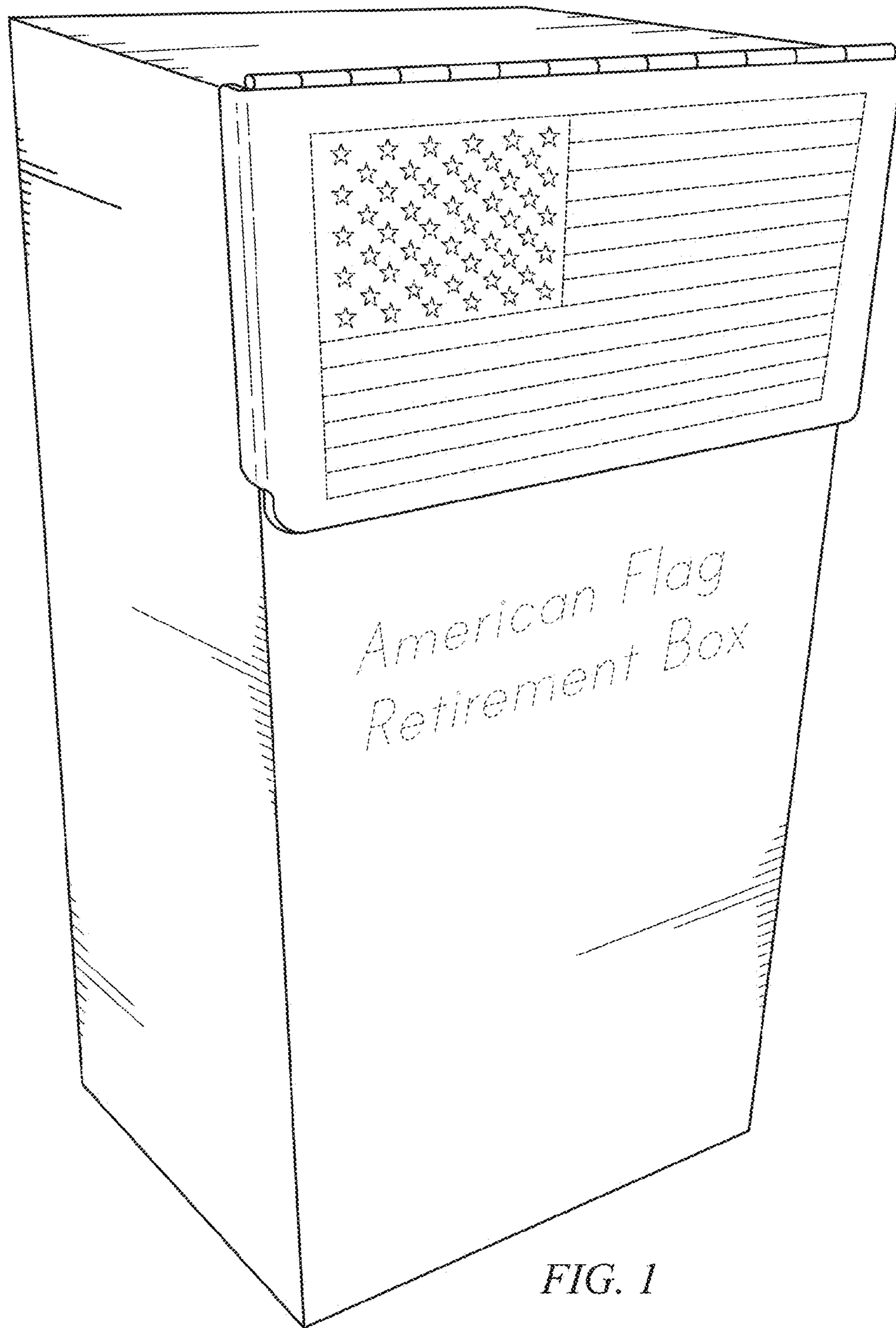
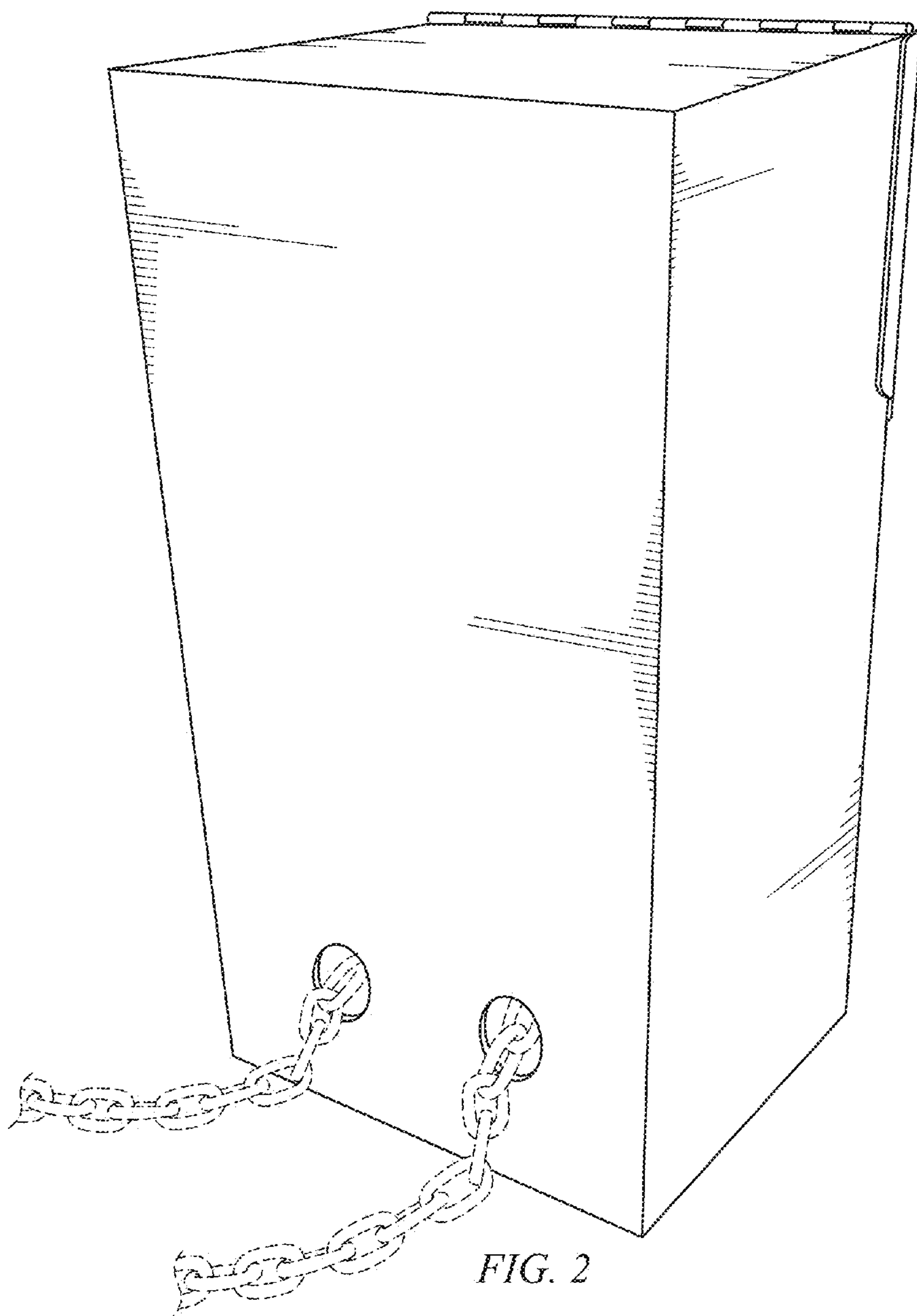

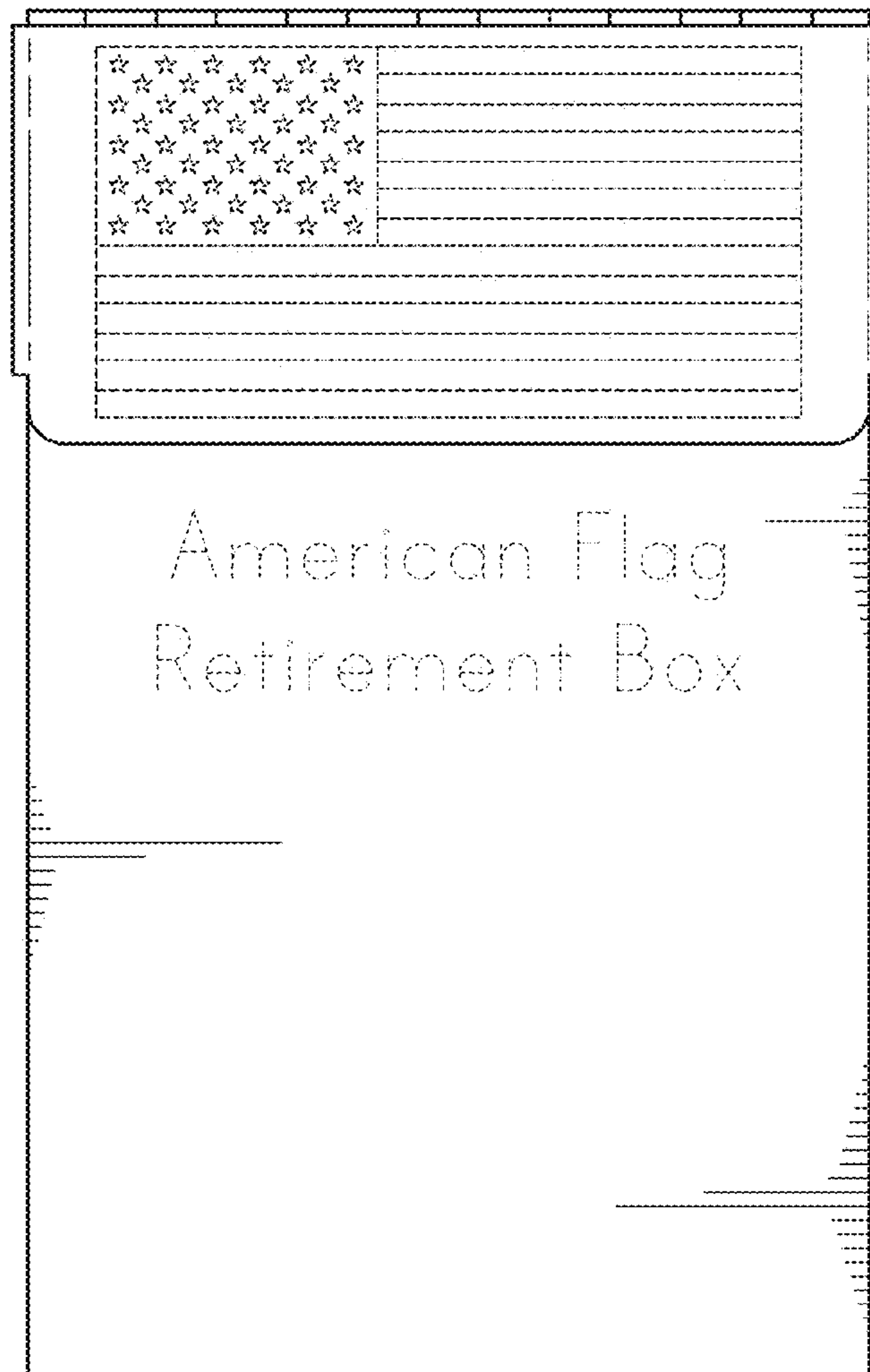

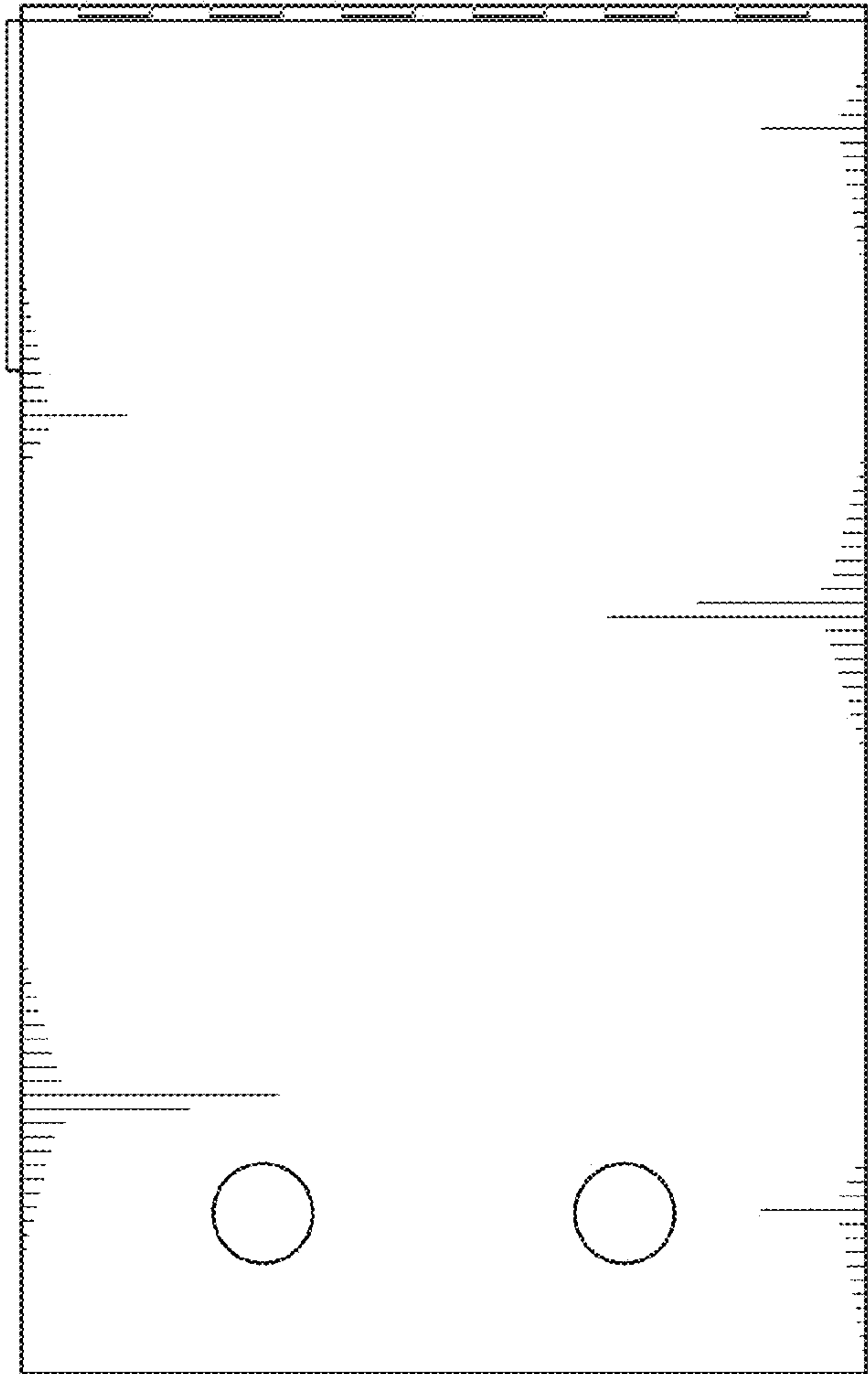

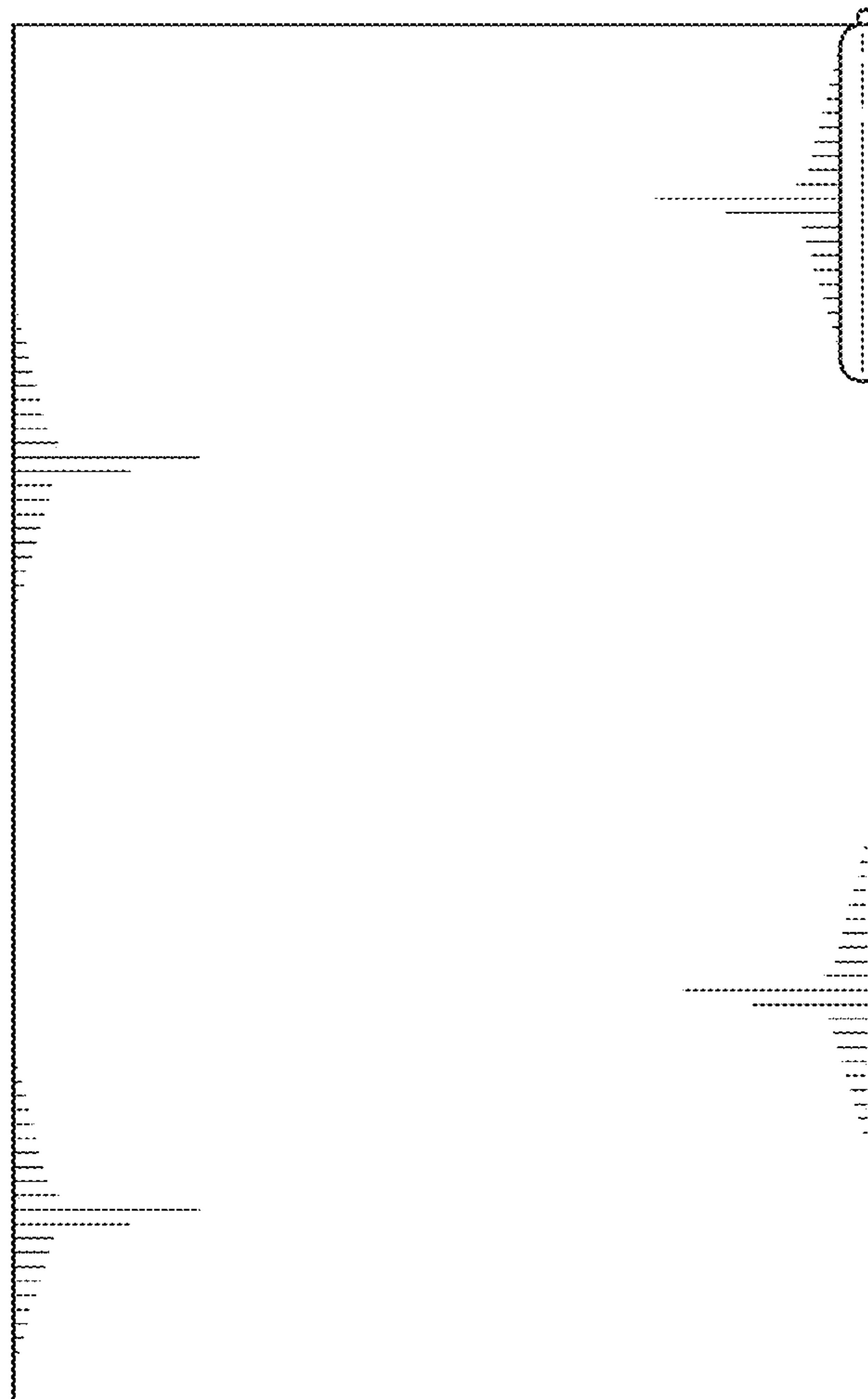

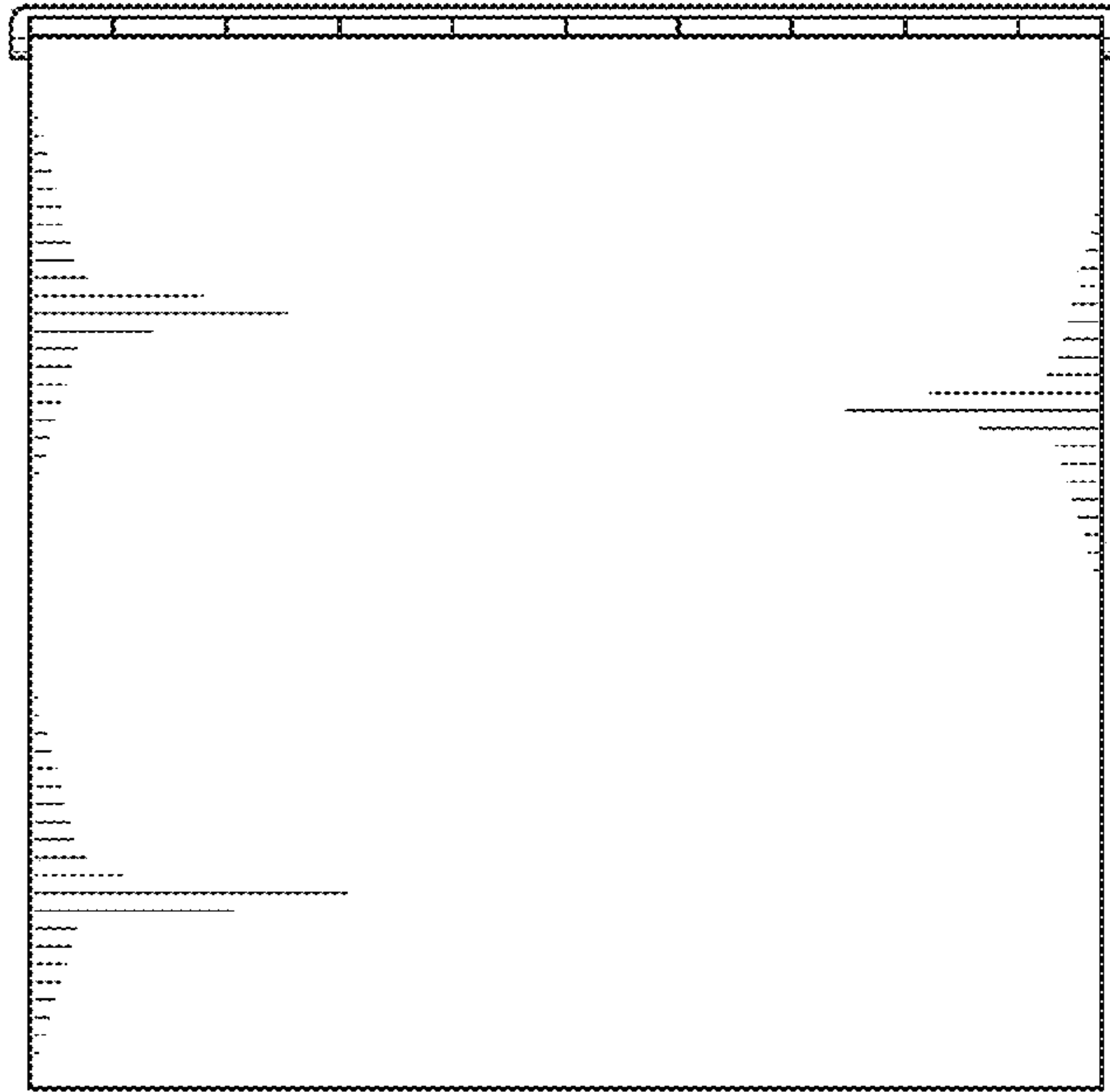

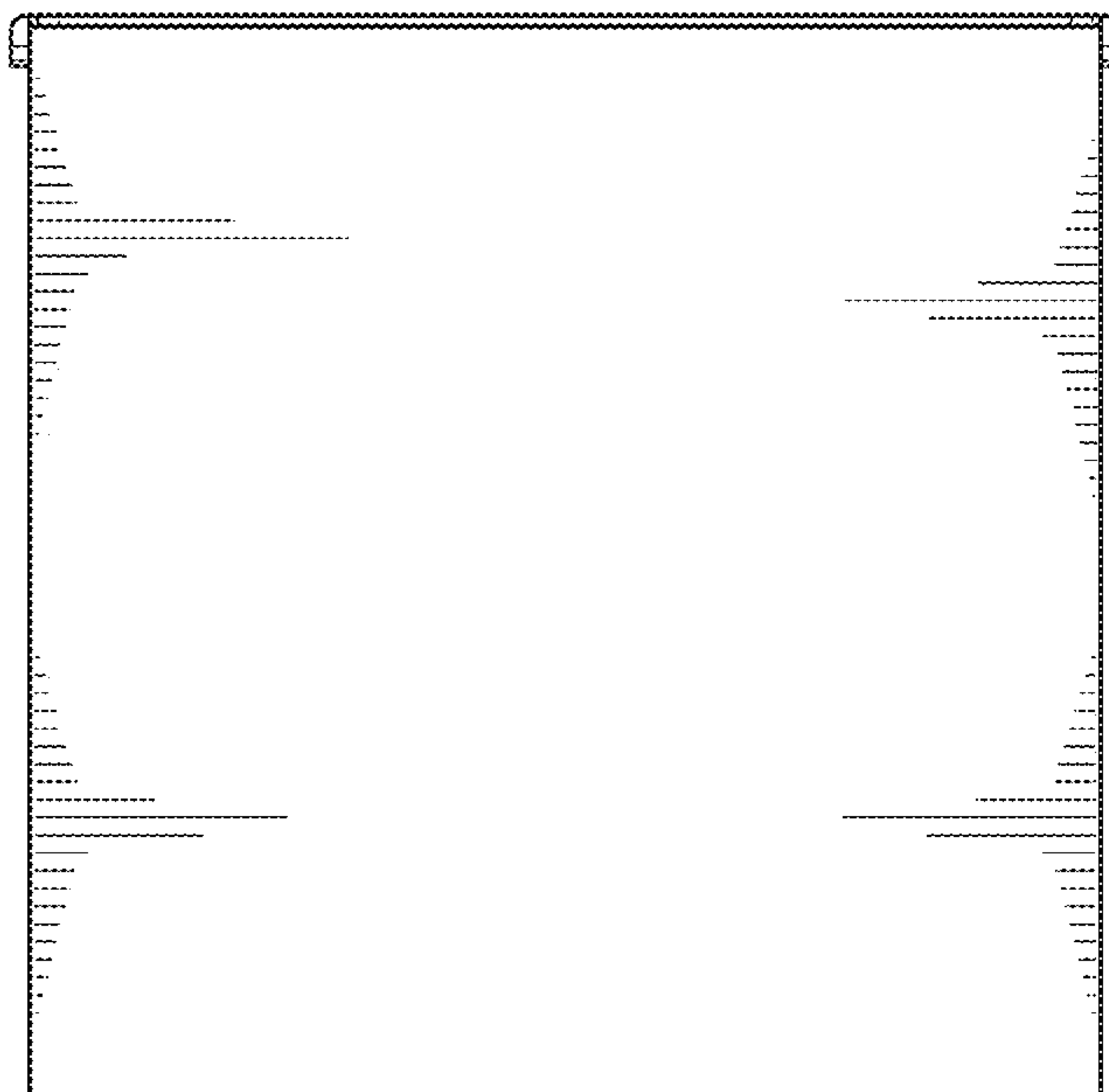

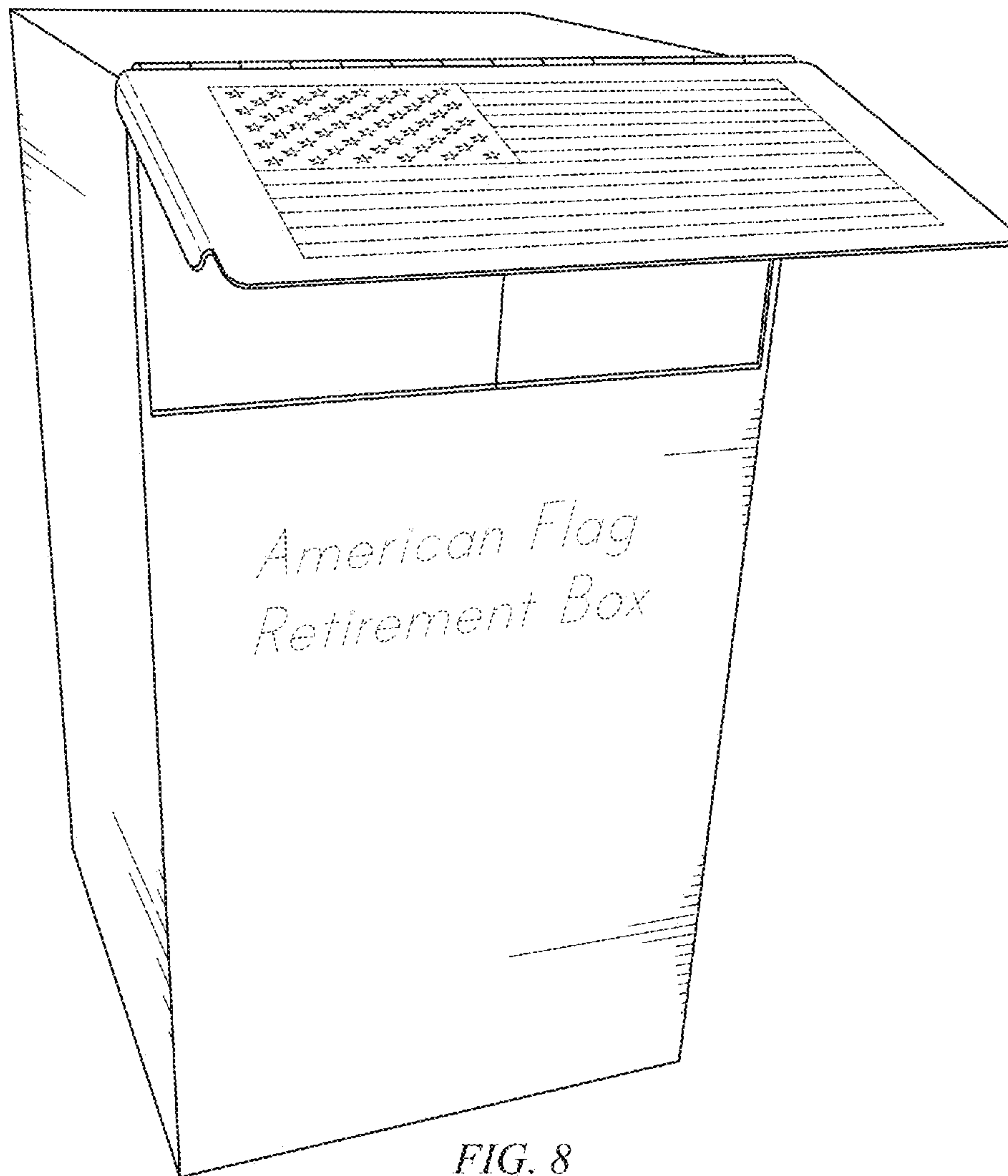

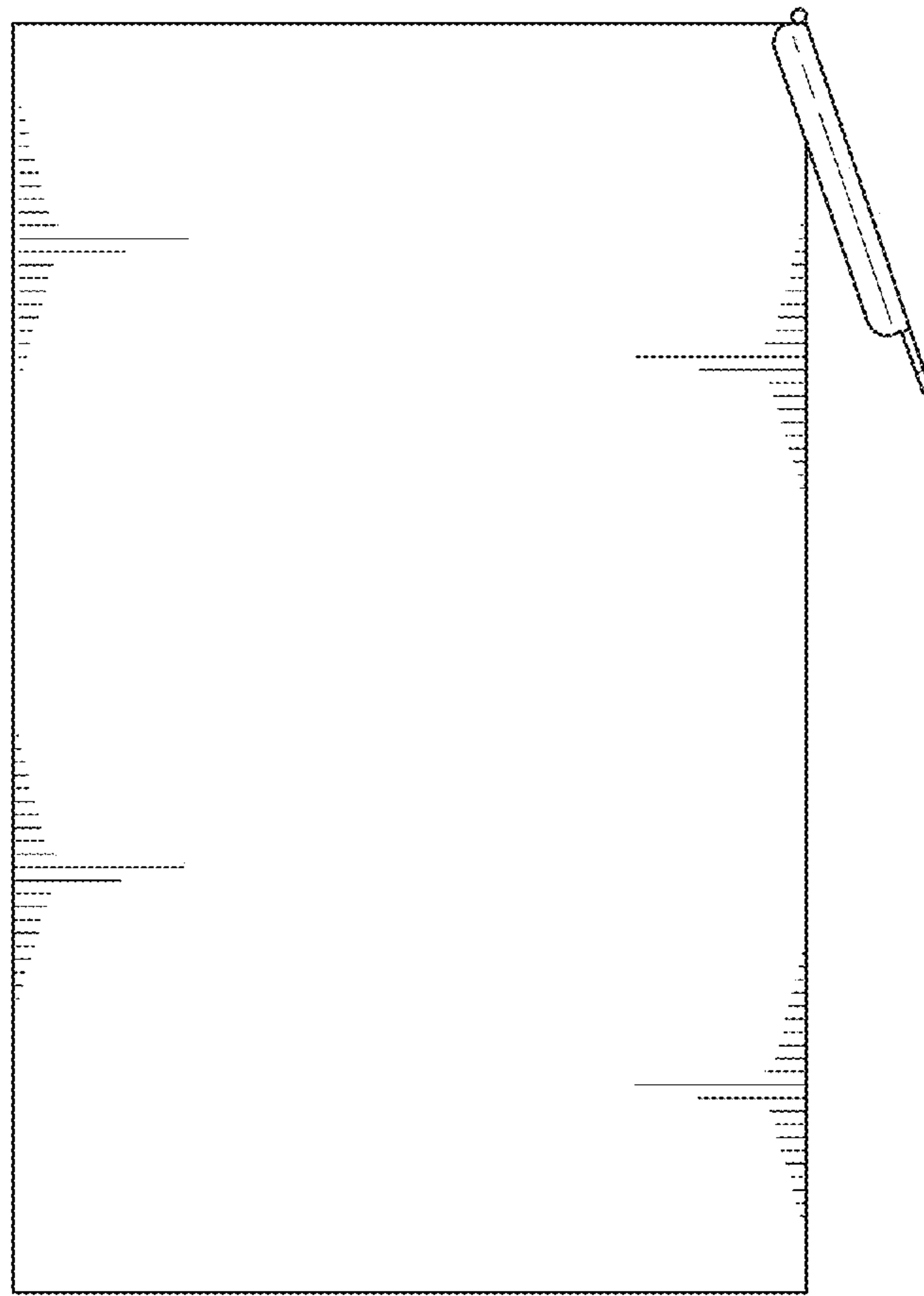

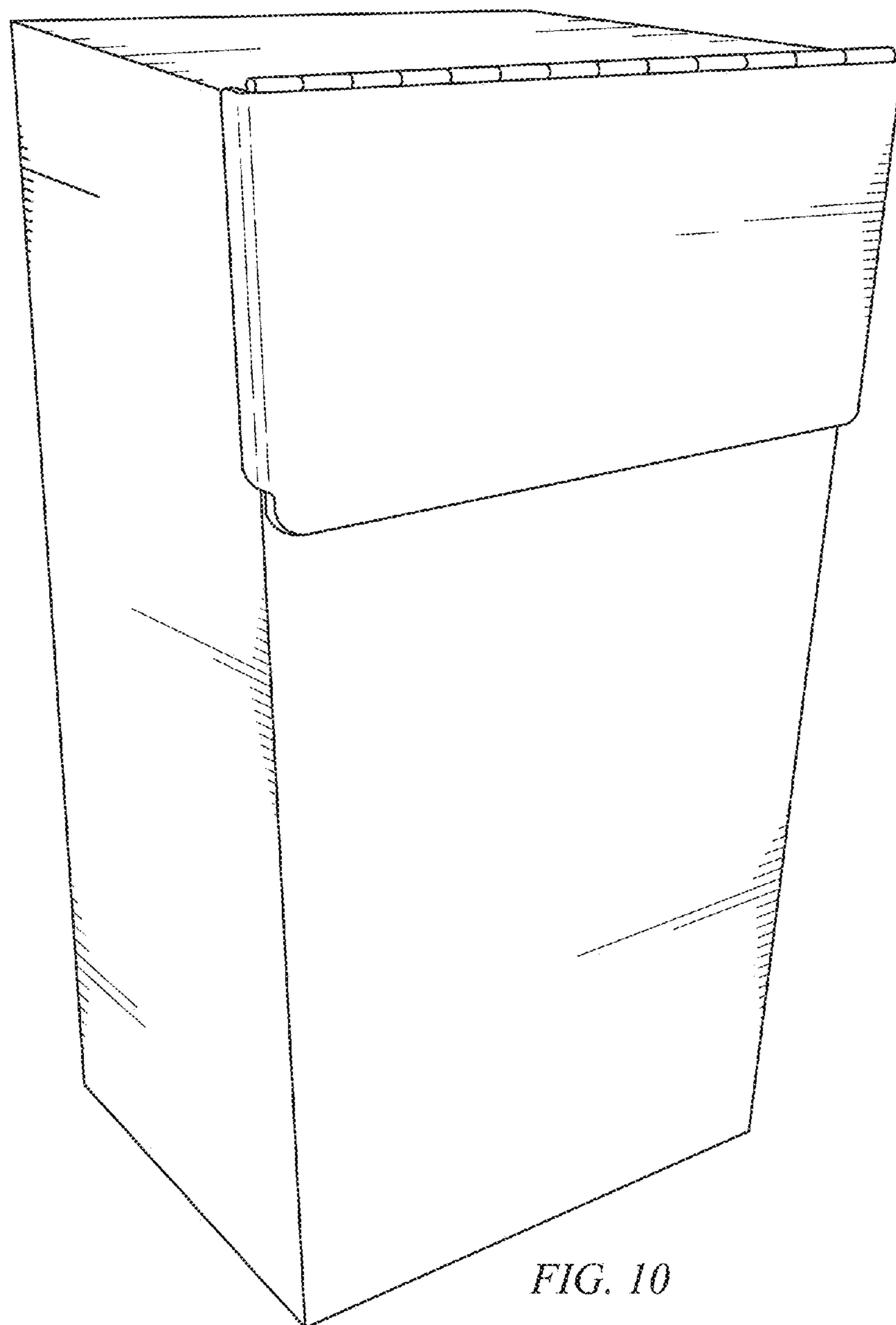

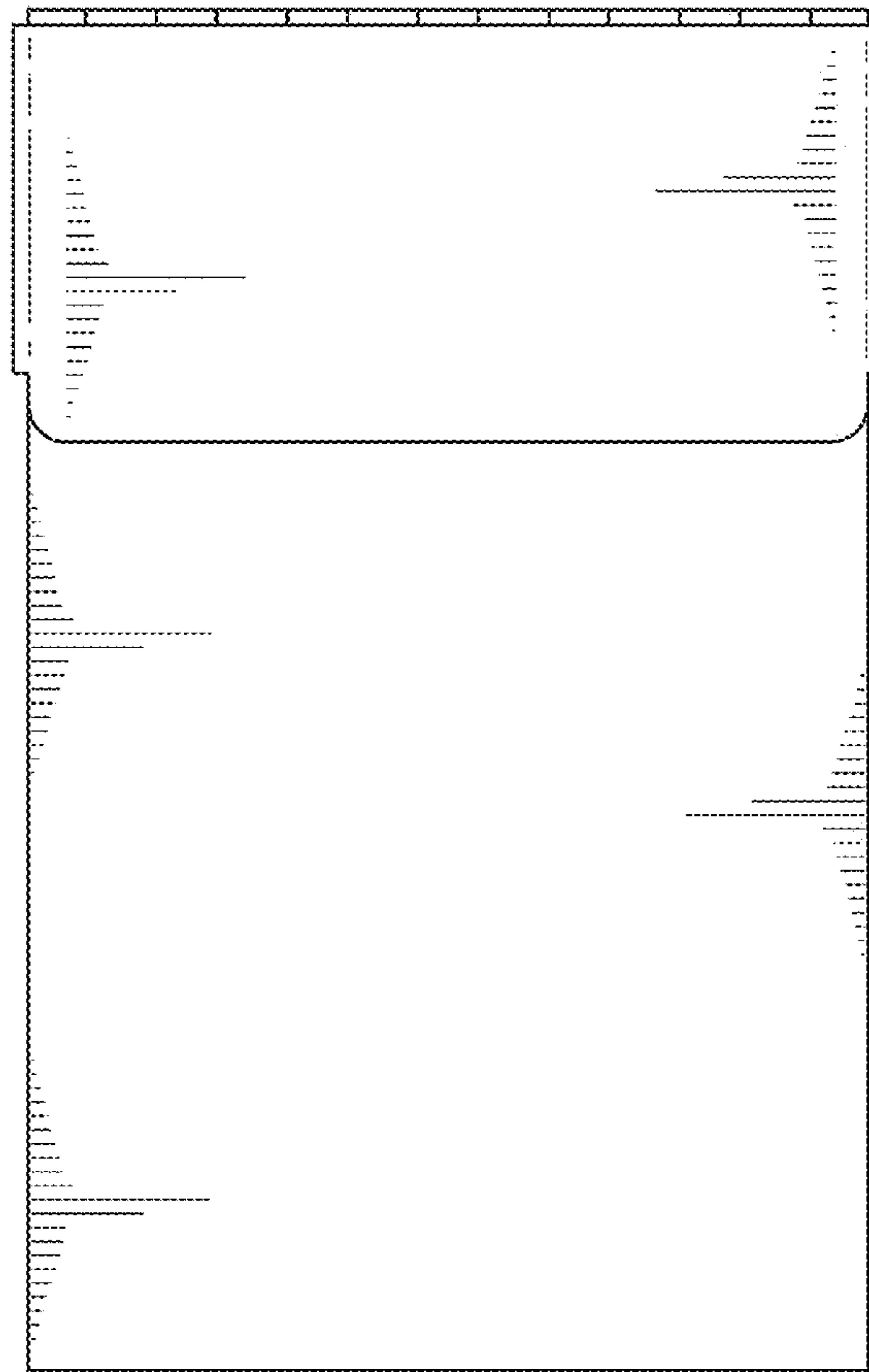
