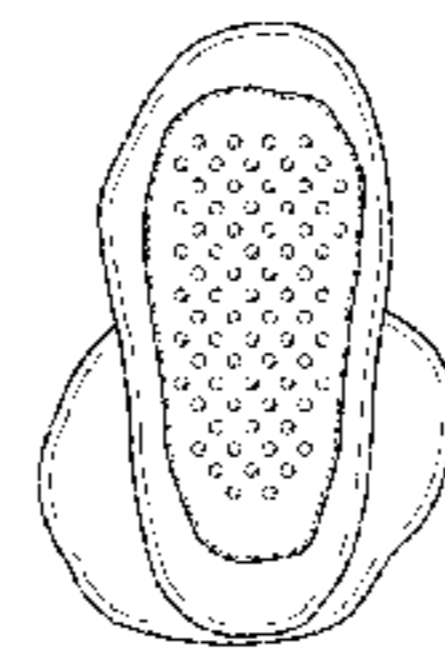
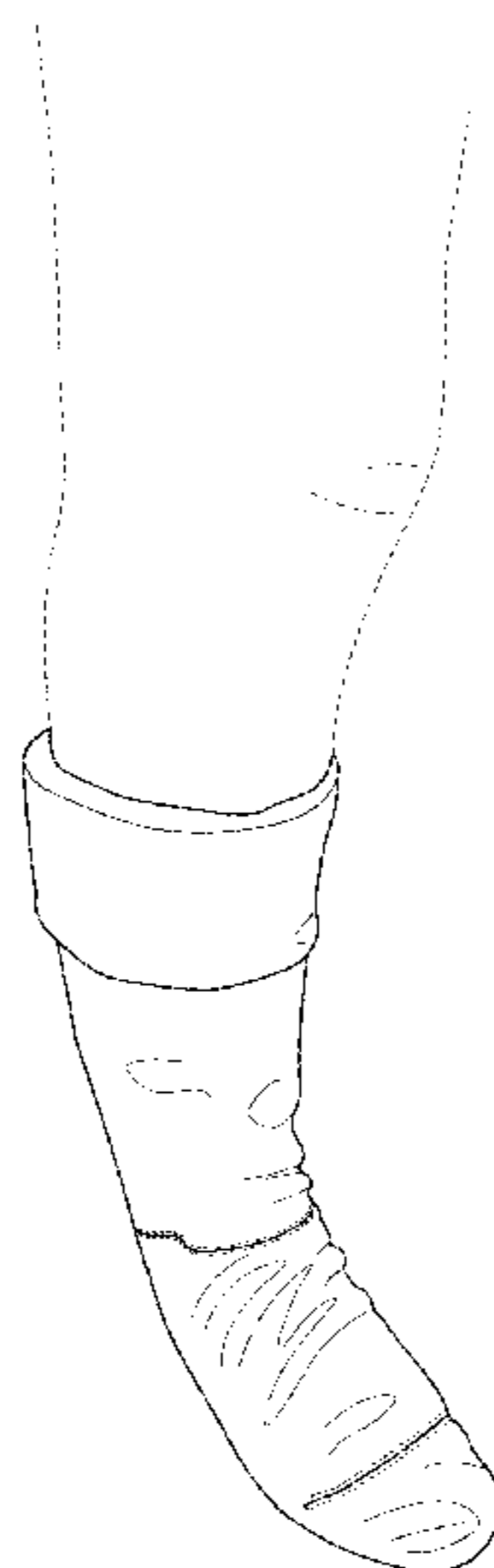
(57) **CLAIM**

The ornamental design for a footwear sock with treaded sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a footwear sock with treaded sole in a rolled-down position showing my new design. FIG. 2 is a front view of the footwear sock with treaded sole in the rolled-down position of FIG. 1; FIG. 3 is a back view of the footwear sock with treaded sole in the rolled-down position of FIG. 1; FIG. 4 is a left-side view of the footwear sock with treaded sole in the rolled-down position of FIG. 1; FIG. 5 is a right-side view of the footwear sock with treaded sole in the rolled-down position of FIG. 1; FIG. 6 is a bottom view of the footwear sock with treaded sole in the rolled-down position of FIG. 1; FIG. 7 is a perspective view of the footwear sock with treaded sole of FIG. 1, in an unrolled position; FIG. 8 is a front view of the footwear sock with treaded sole in the unrolled position of FIG. 7; FIG. 9 is a back view of the footwear sock with treaded sole in the unrolled position of FIG. 7; FIG. 10 is a left-side view of the footwear sock with treaded sole in the unrolled position of FIG. 7; and, FIG. 11 is a right-side view of the footwear sock with treaded sole in the unrolled position of FIG. 7.

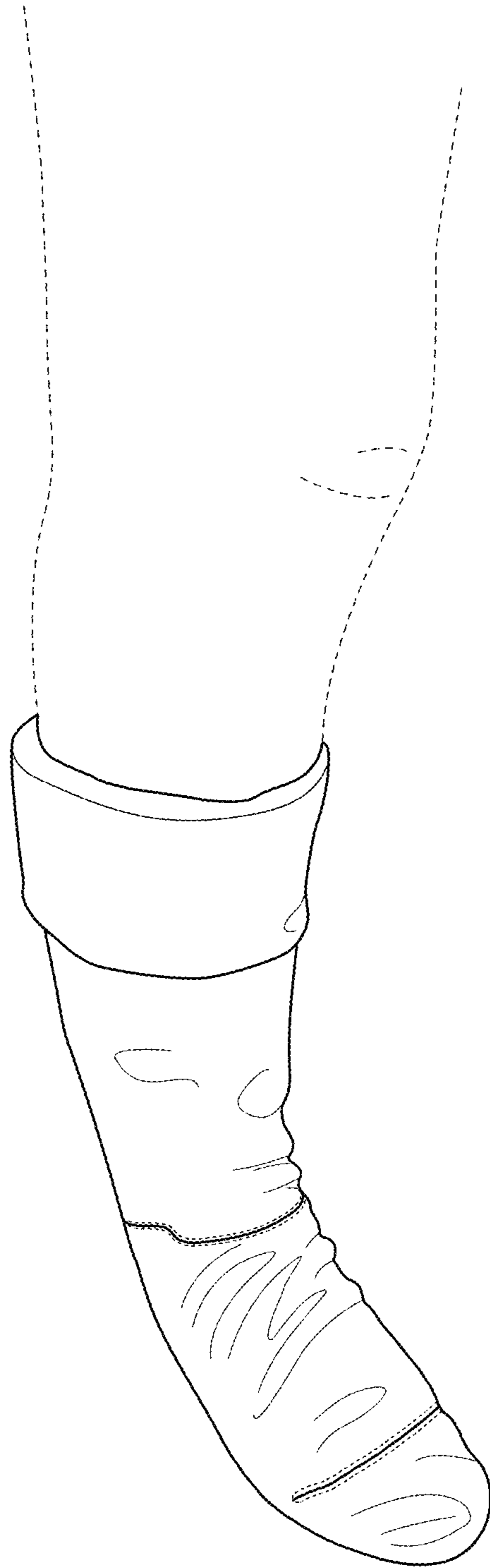

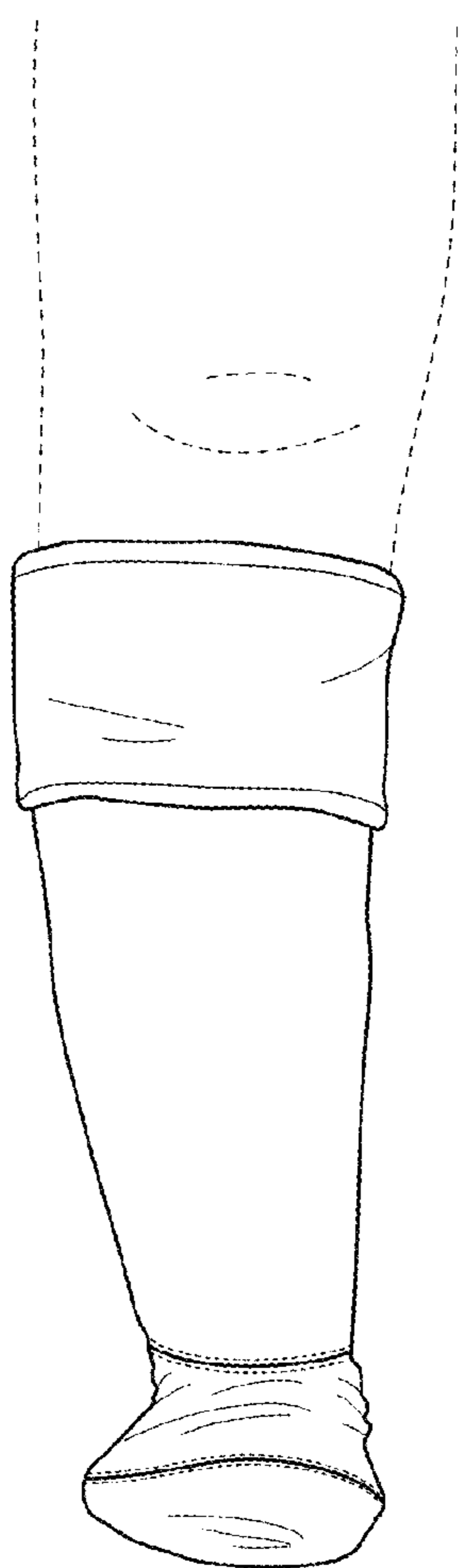

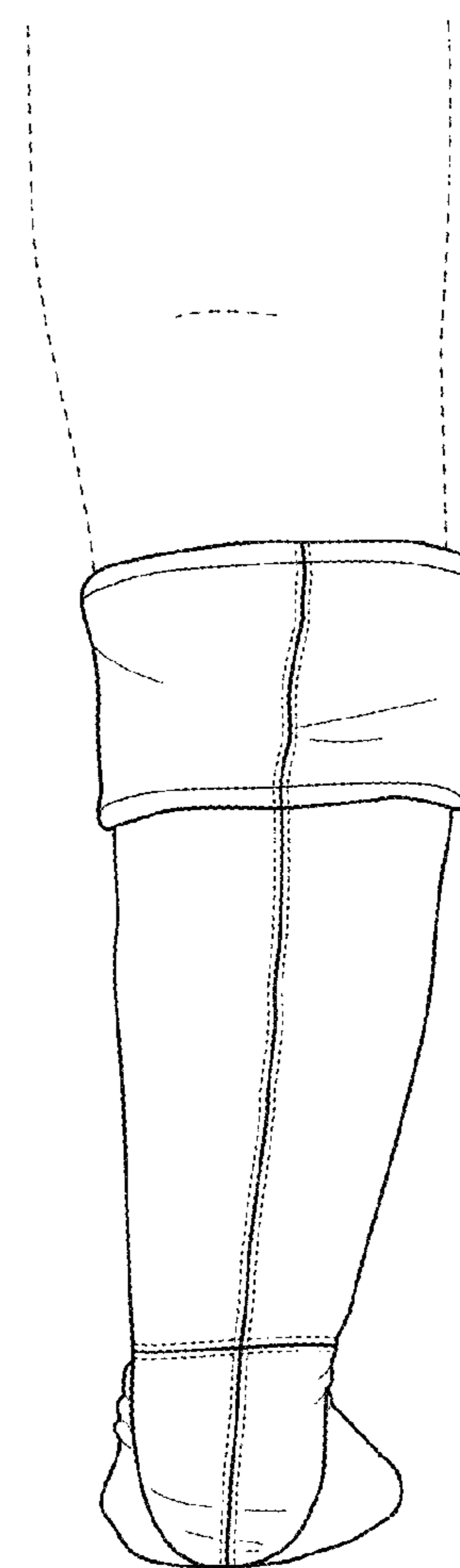

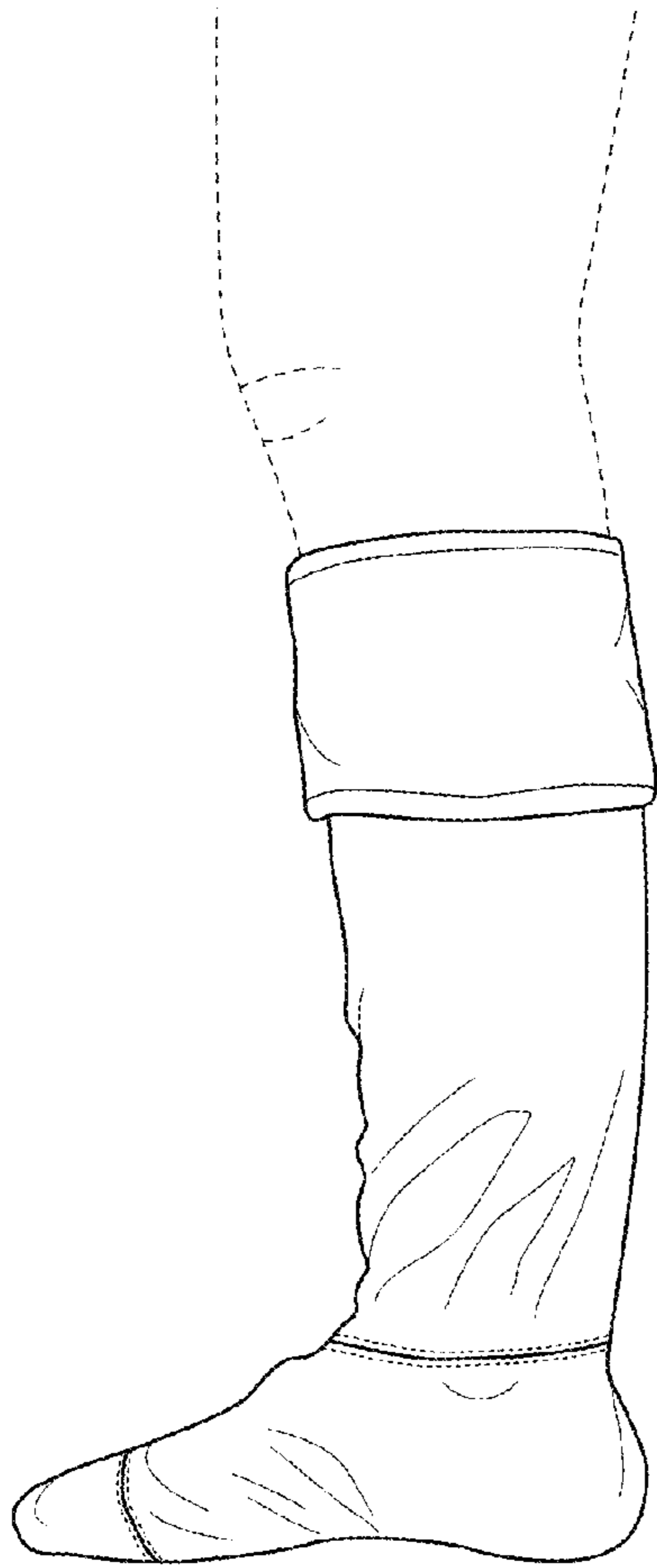

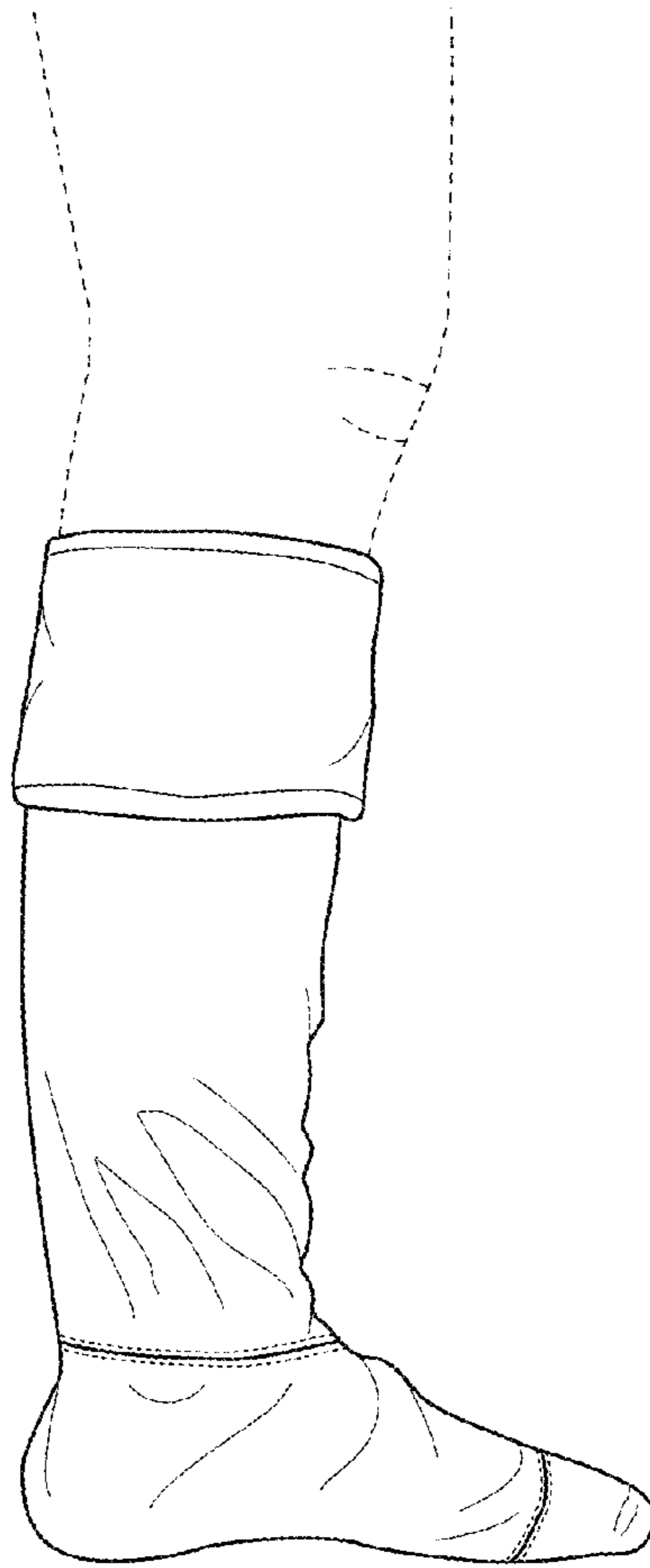

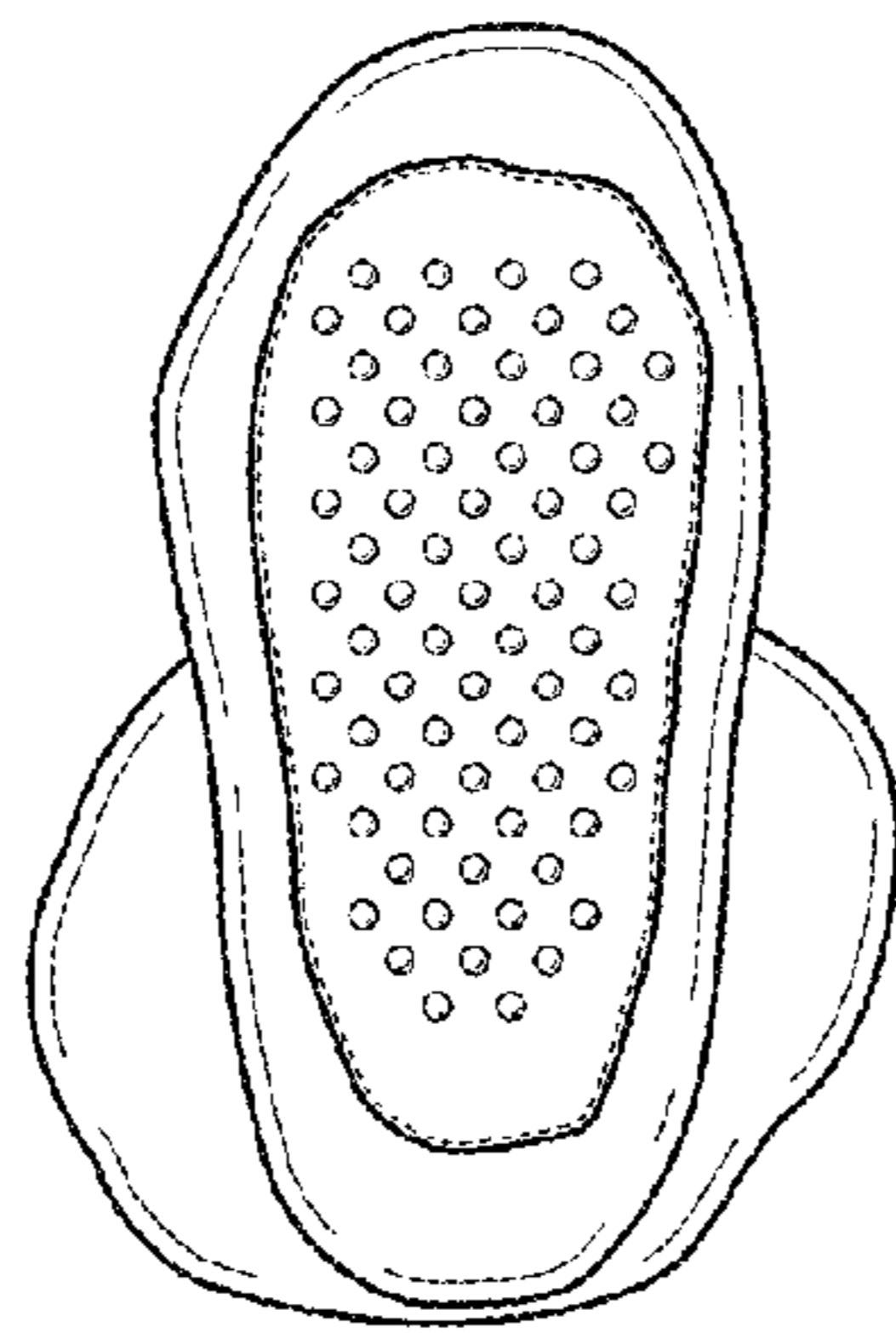

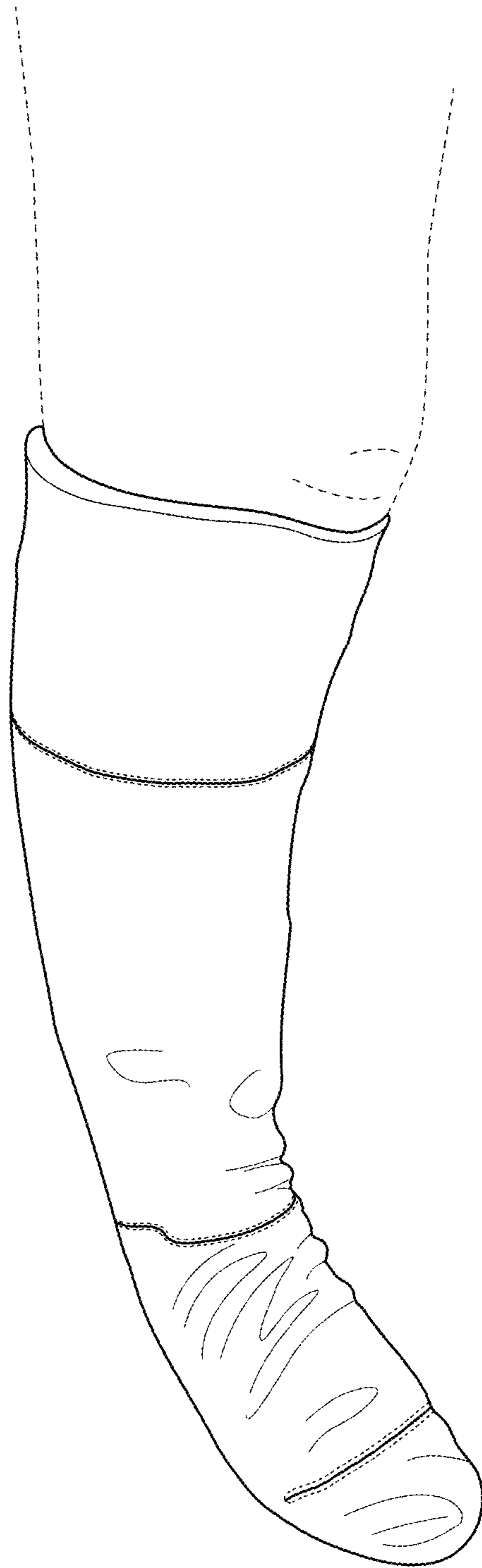

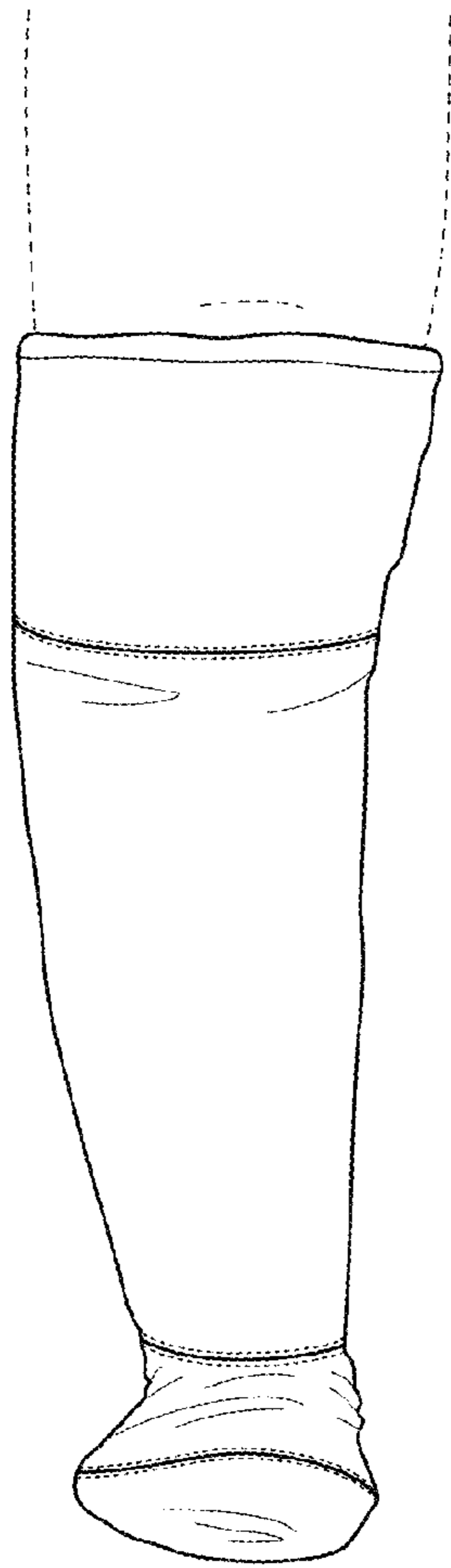

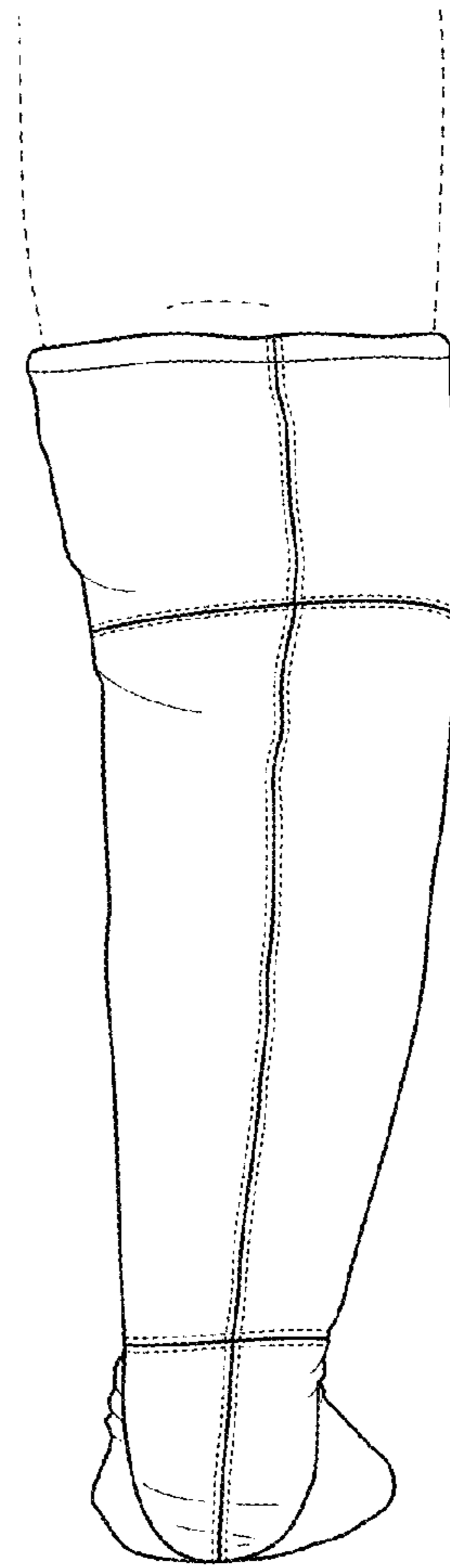

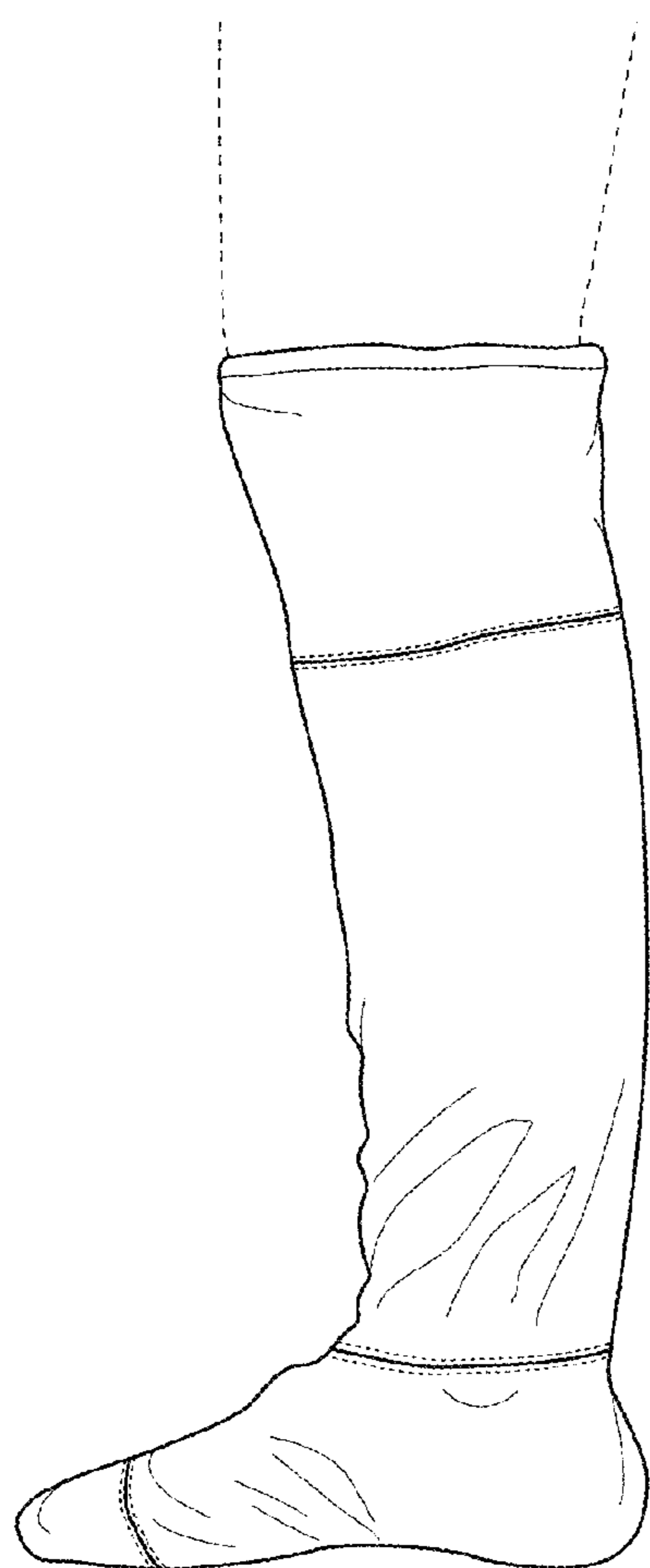

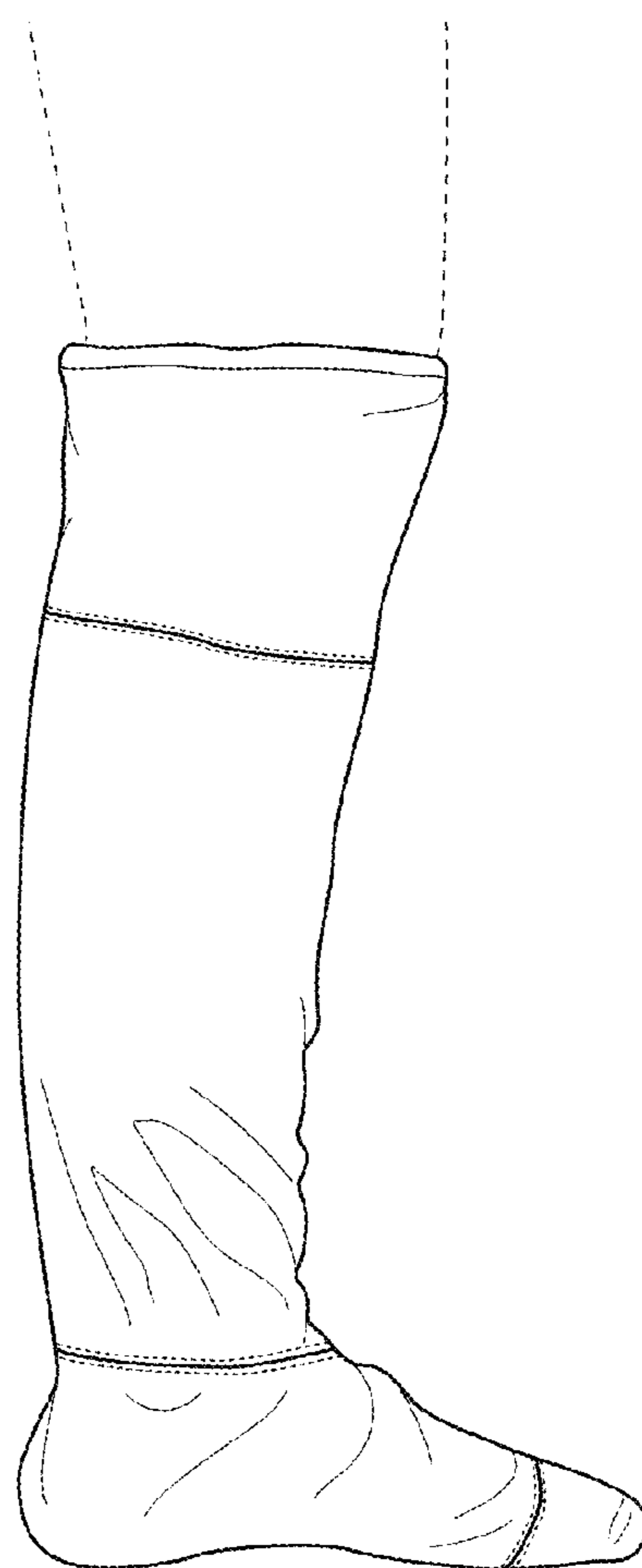
