The ornamental design for an accessory bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the accessory bag; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

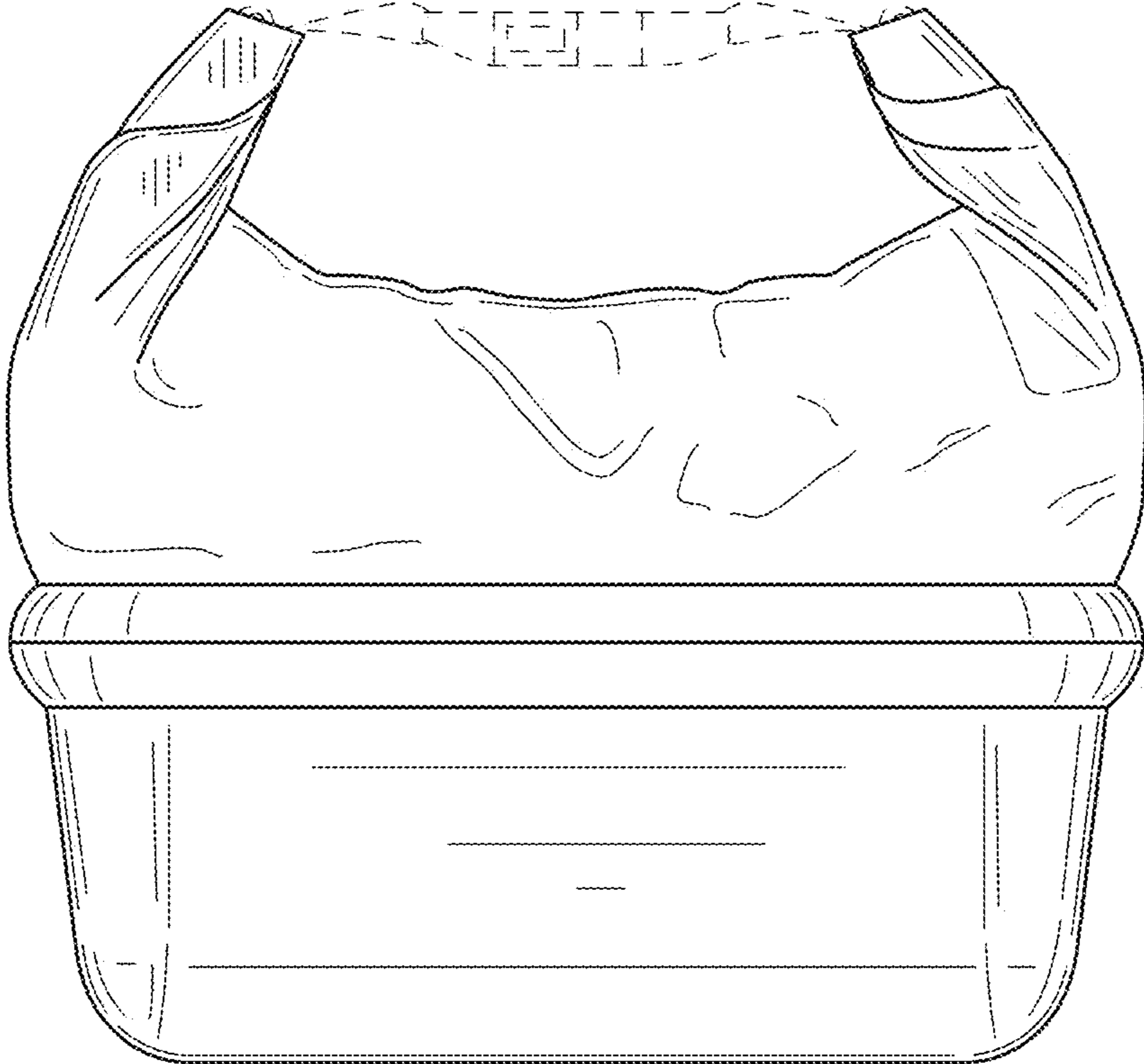

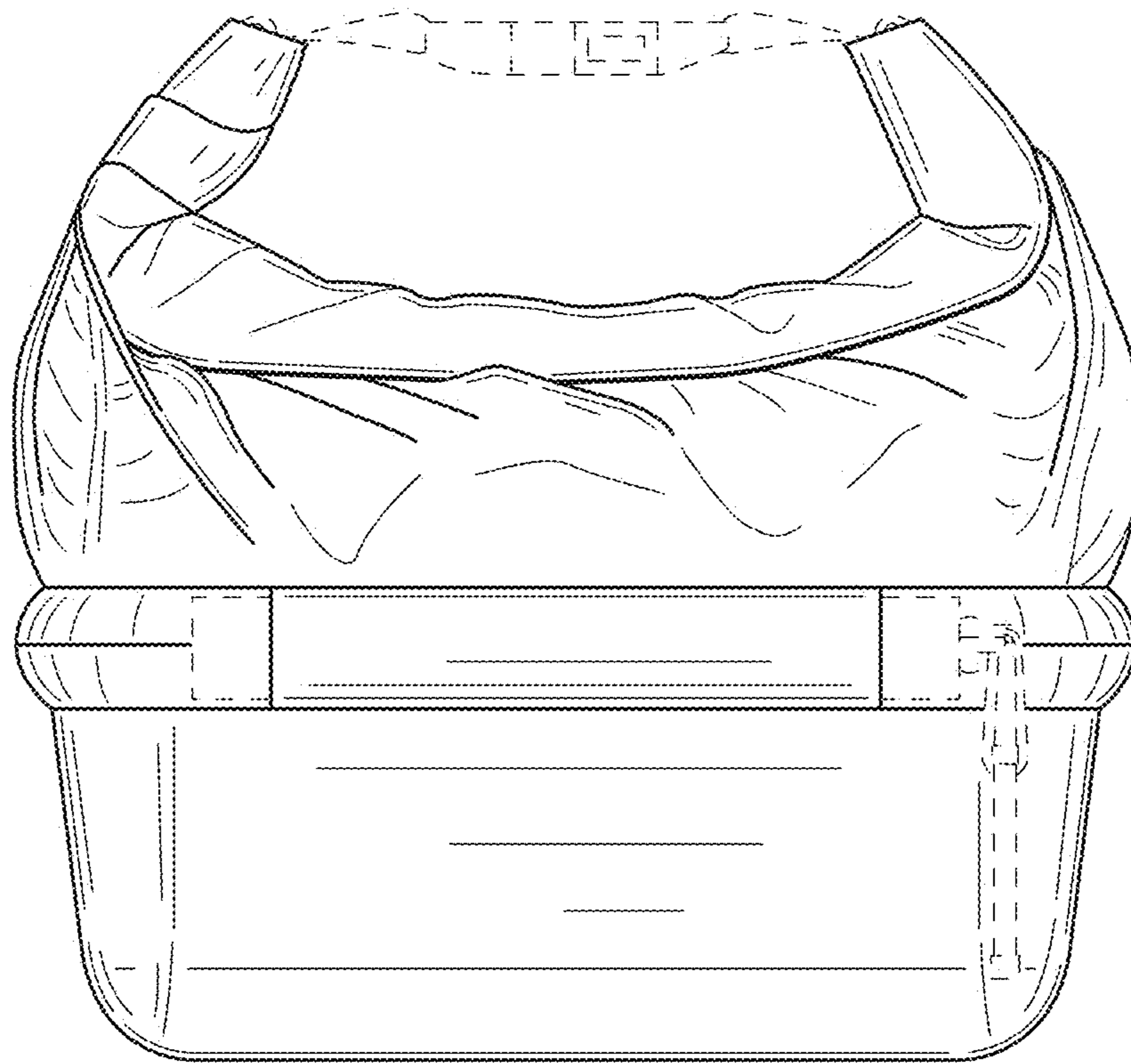

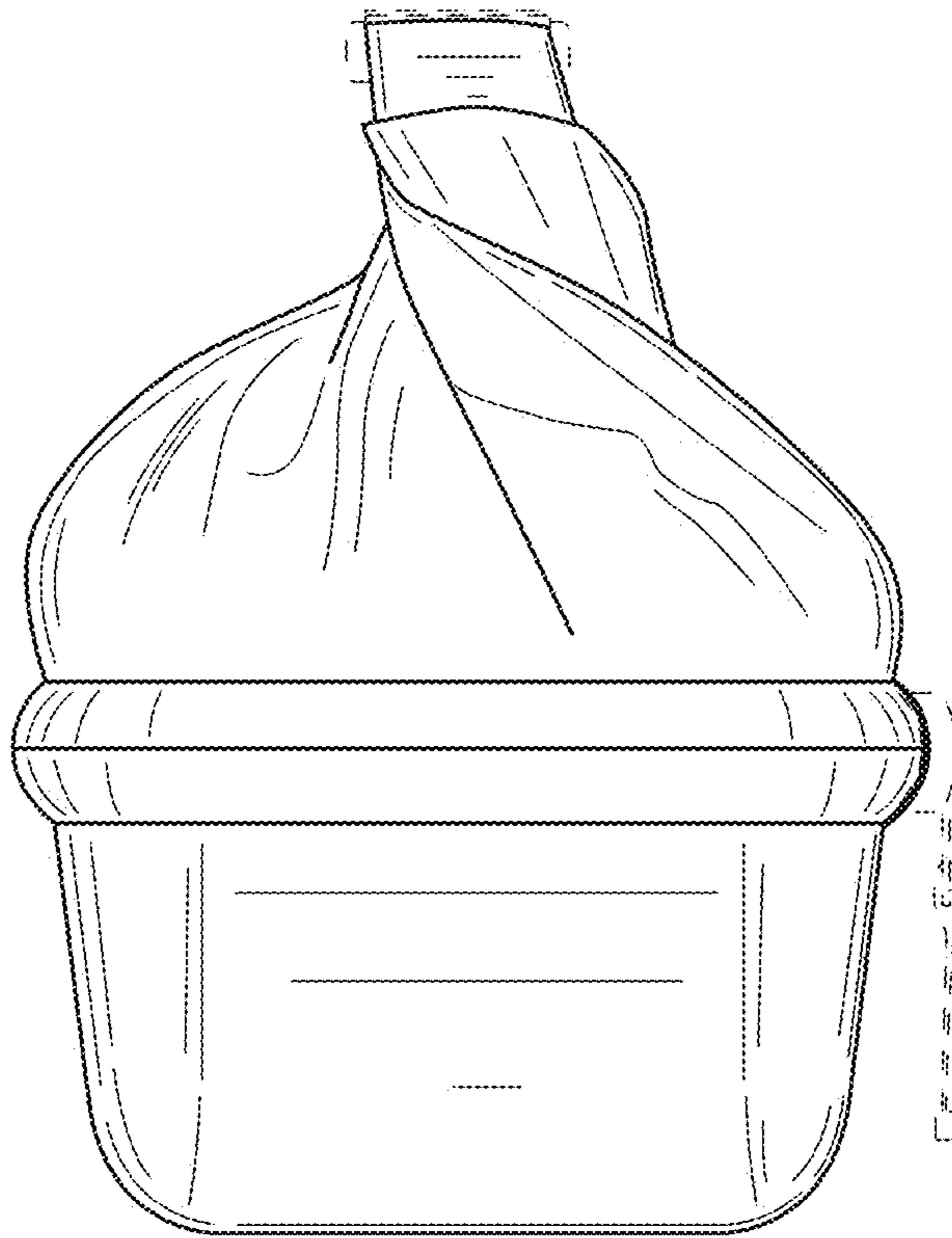

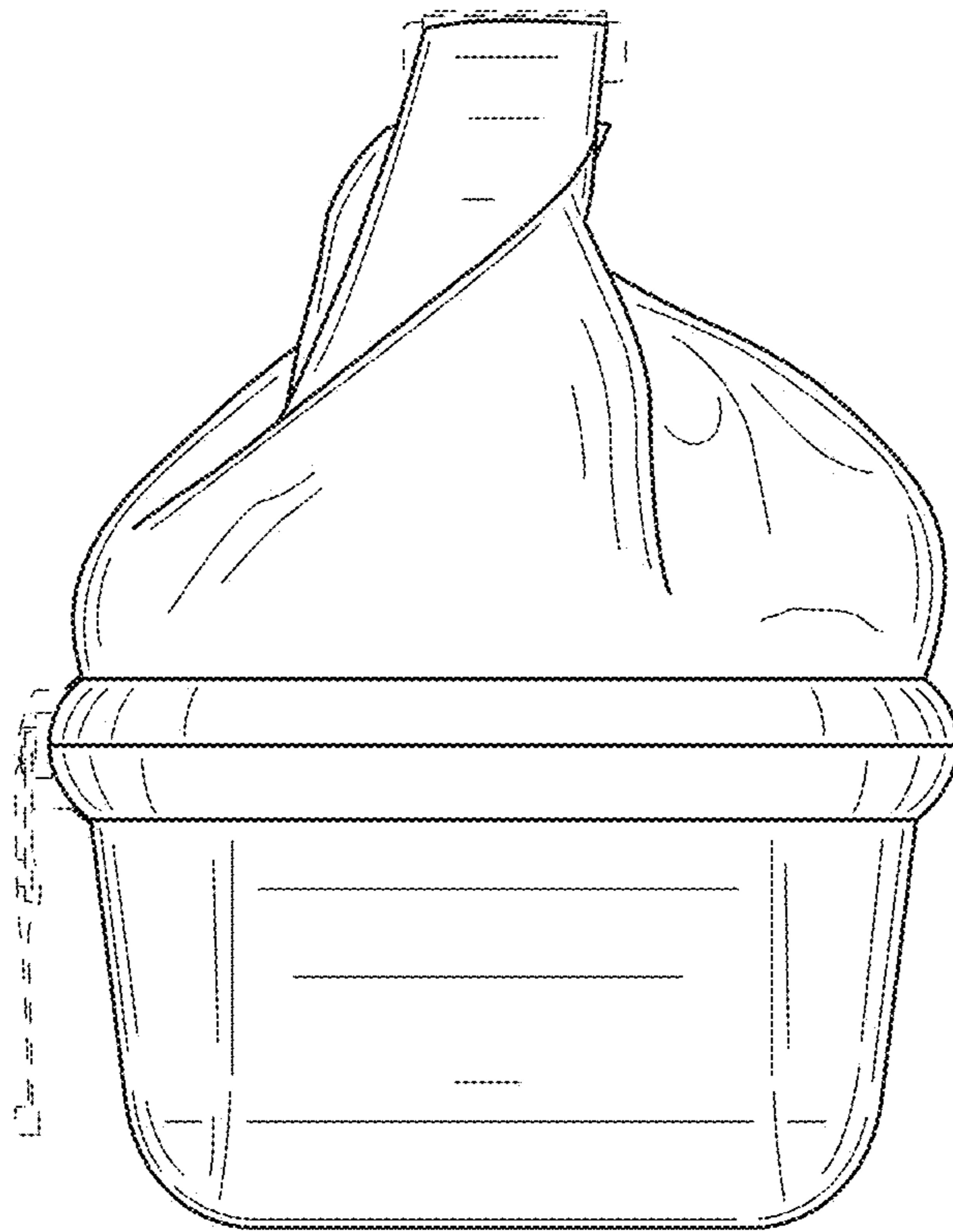

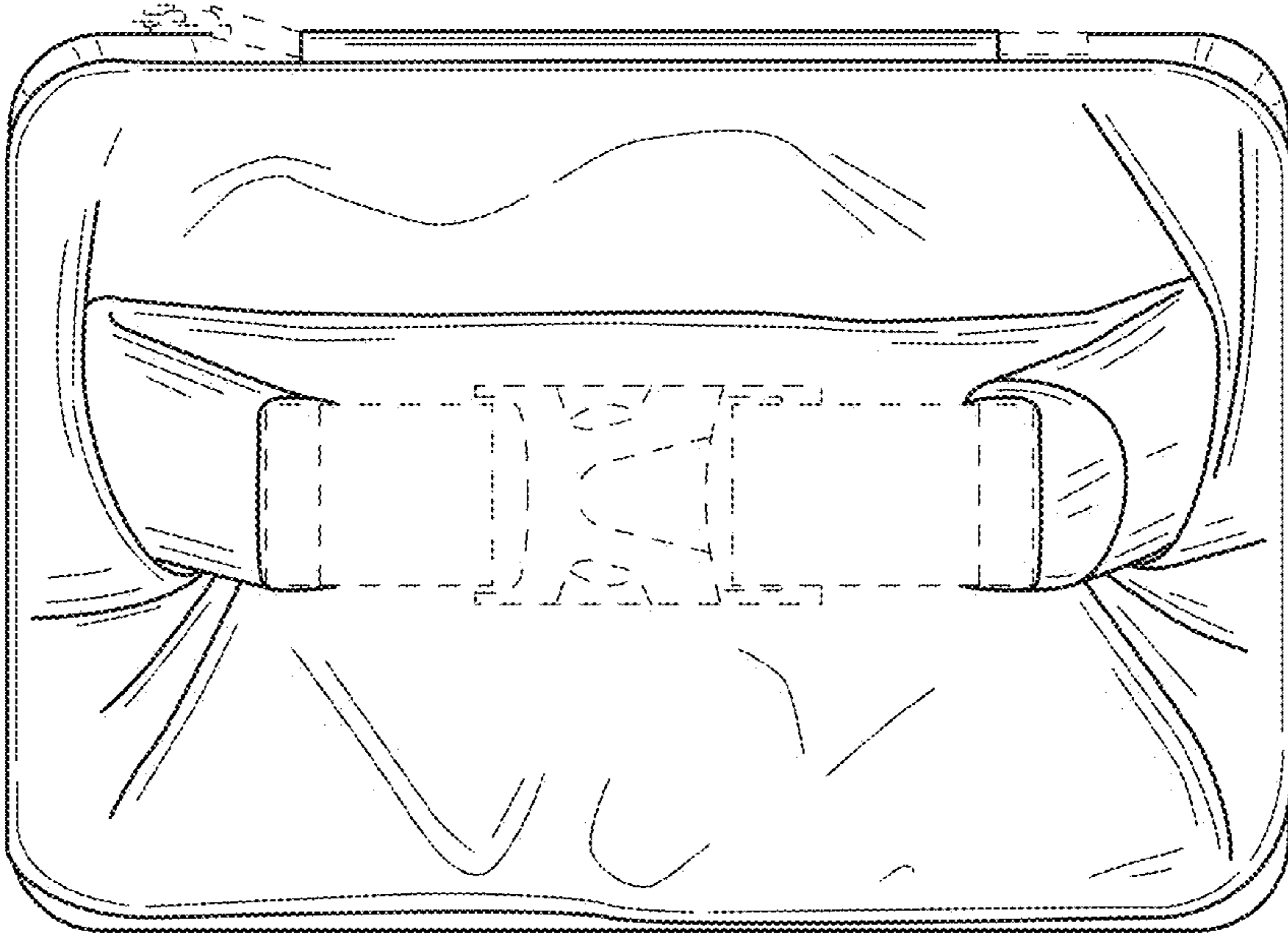

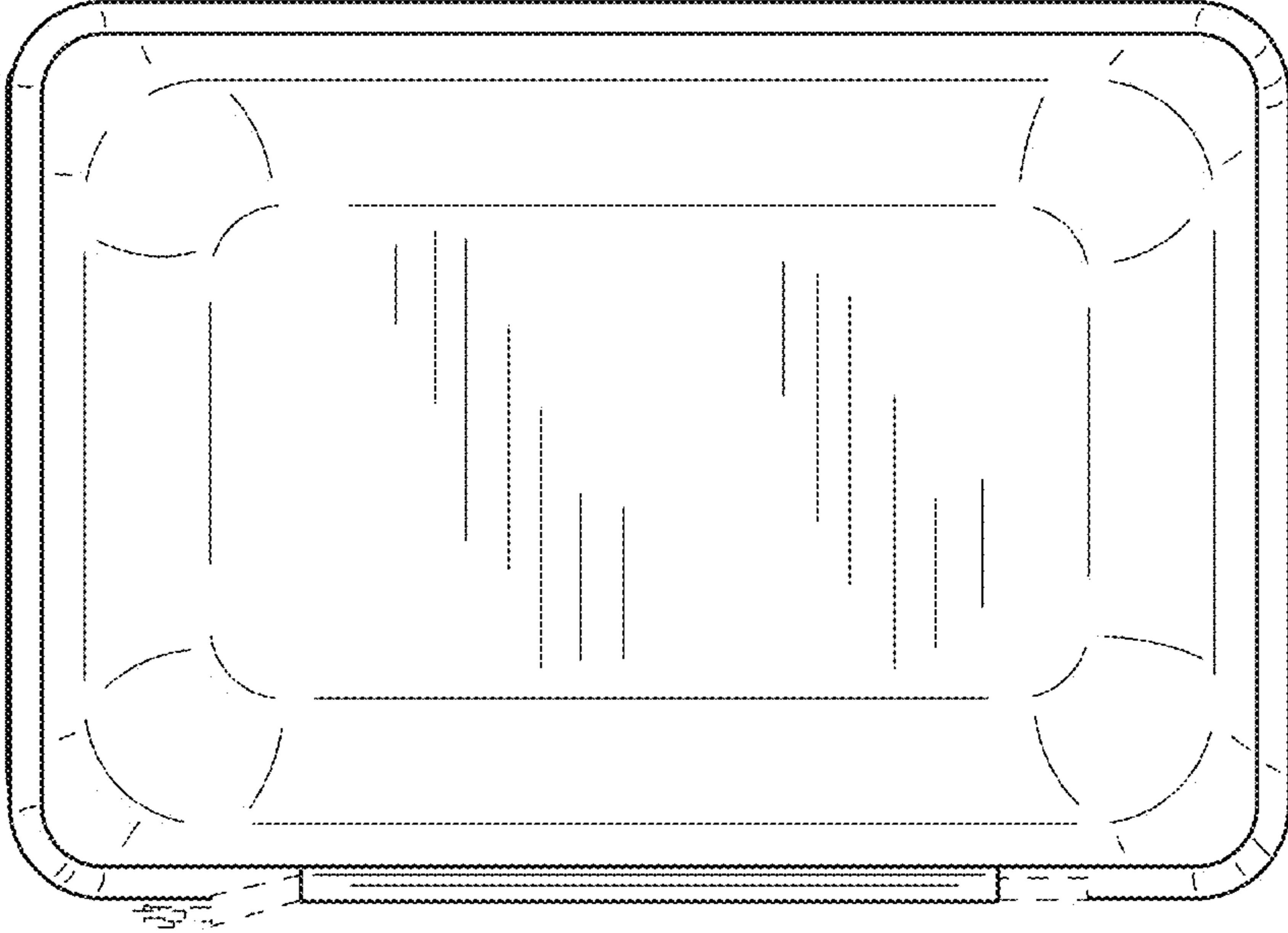
