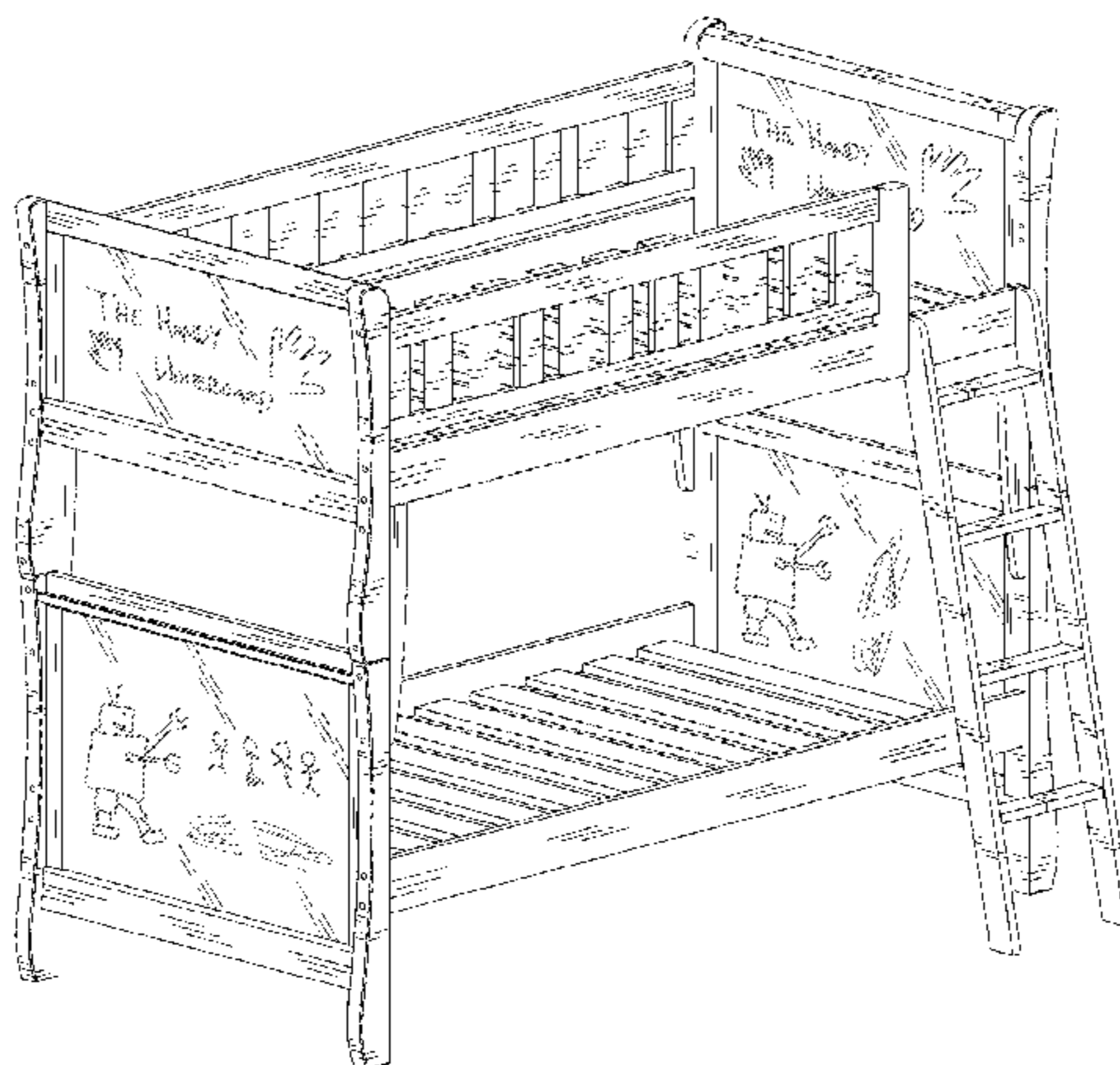
(57) **CLAIM**

The ornamental design for a bunk bed, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bunk bed showing our new design;  
FIG. 2 is a front, right perspective view of the bunk bed of FIG. 1;  
FIG. 3 is a left side view of the bunk bed of FIG. 1;  
FIG. 4 is a right side view of the bunk bed of FIG. 1;  
FIG. 5 is a perspective view of a bunk bed, showing an alternate environment of our new design;  
FIG. 6 is a front, right perspective view of the bunk bed of FIG. 5;  
FIG. 7 is a left side view of the bunk bed of FIG. 5;  
FIG. 8 is a right side view of the bunk bed of FIG. 5;  
FIG. 9 is a perspective view of a bunk bed, showing a second embodiment of our new design;  
FIG. 10 is a rear side view of the bunk bed of FIGS. 1 and 5;  
FIG. 11 is a top side view of the bunk bed of FIGS. 1 and 5;

FIG. 12 is a bottom side view of the bunk bed of FIGS. 1 and 5;  
FIG. 13 is a perspective view of a bunk bed, showing a third embodiment of our new design;  
FIG. 14 is a front, right perspective view of the bunk bed of FIG. 13;  
FIG. 15 is a left side view of the bunk bed of FIG. 13;  
FIG. 16 is a right side view of the bunk bed of FIG. 13;  
FIG. 17 is a front side view of the bunk bed of FIGS. 1, 5, 9, and 13;  
FIG. 18 is a rear side view of the bunk bed of FIGS. 1, 5, 9, and 13;  
FIG. 19 is a top side view of the bunk bed of FIGS. 1, 5, 9, and 13; and,  
FIG. 20 is a bottom side view of the bunk bed of FIGS. 1, 5, 9, and 13.

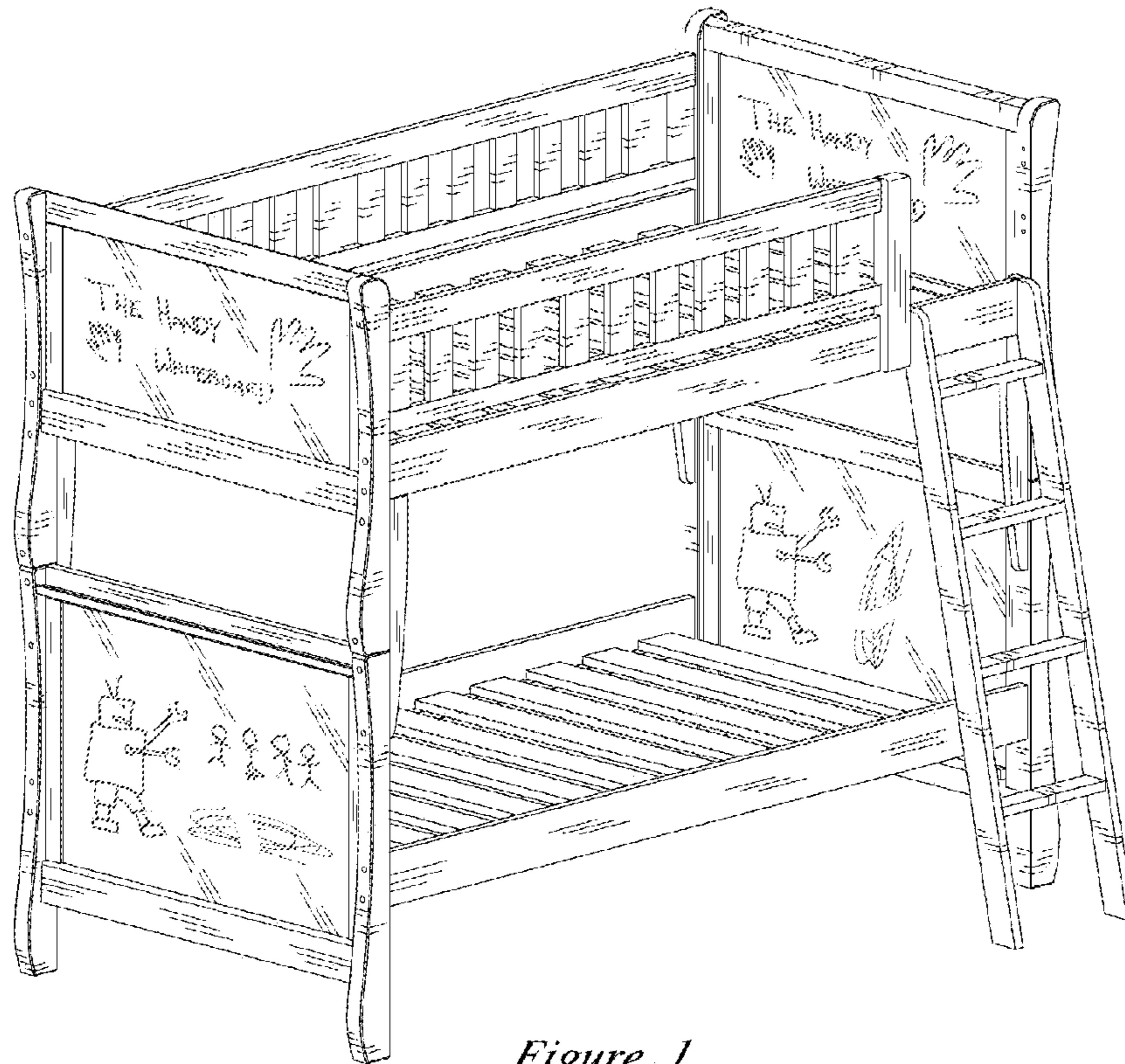

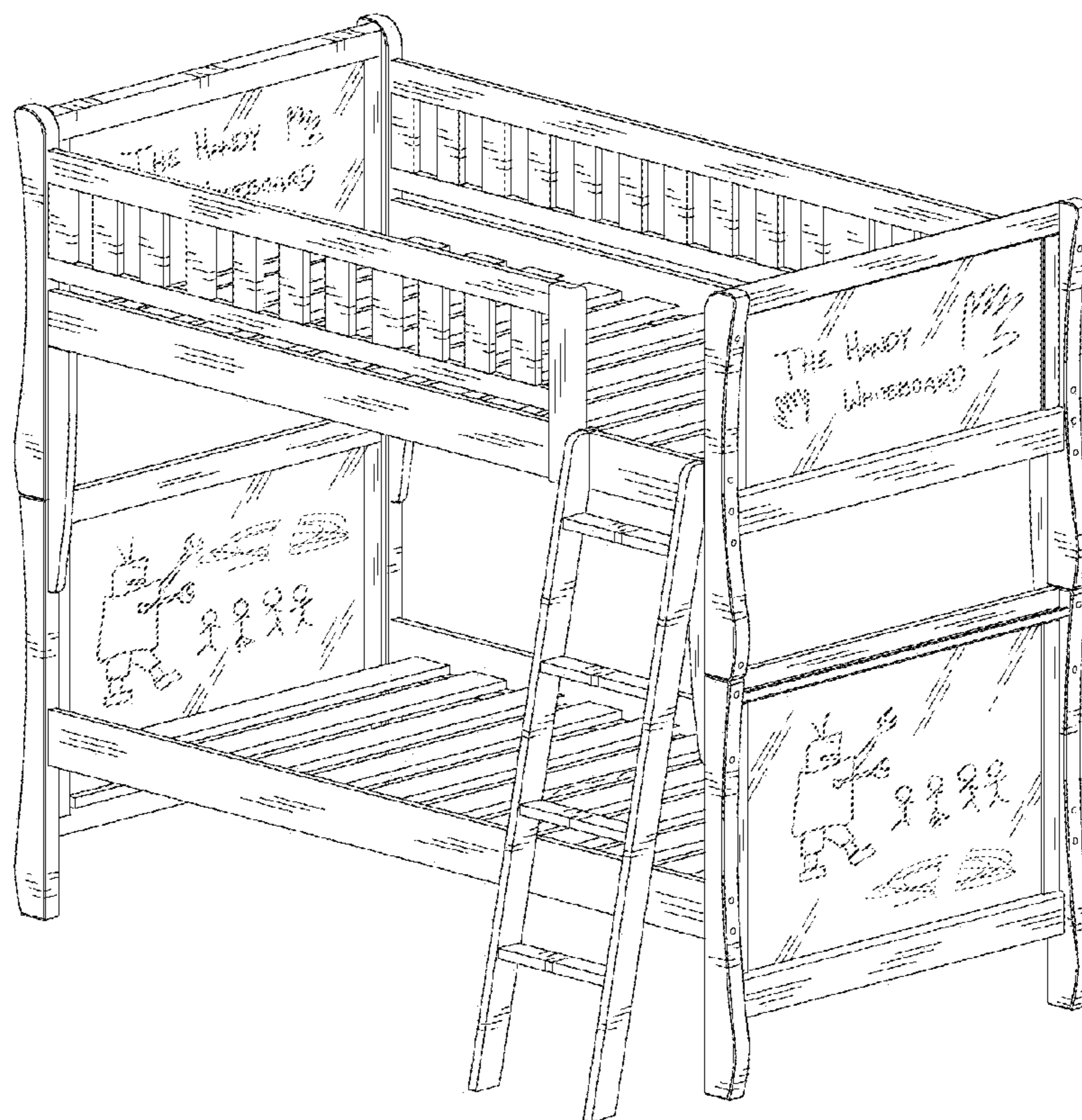

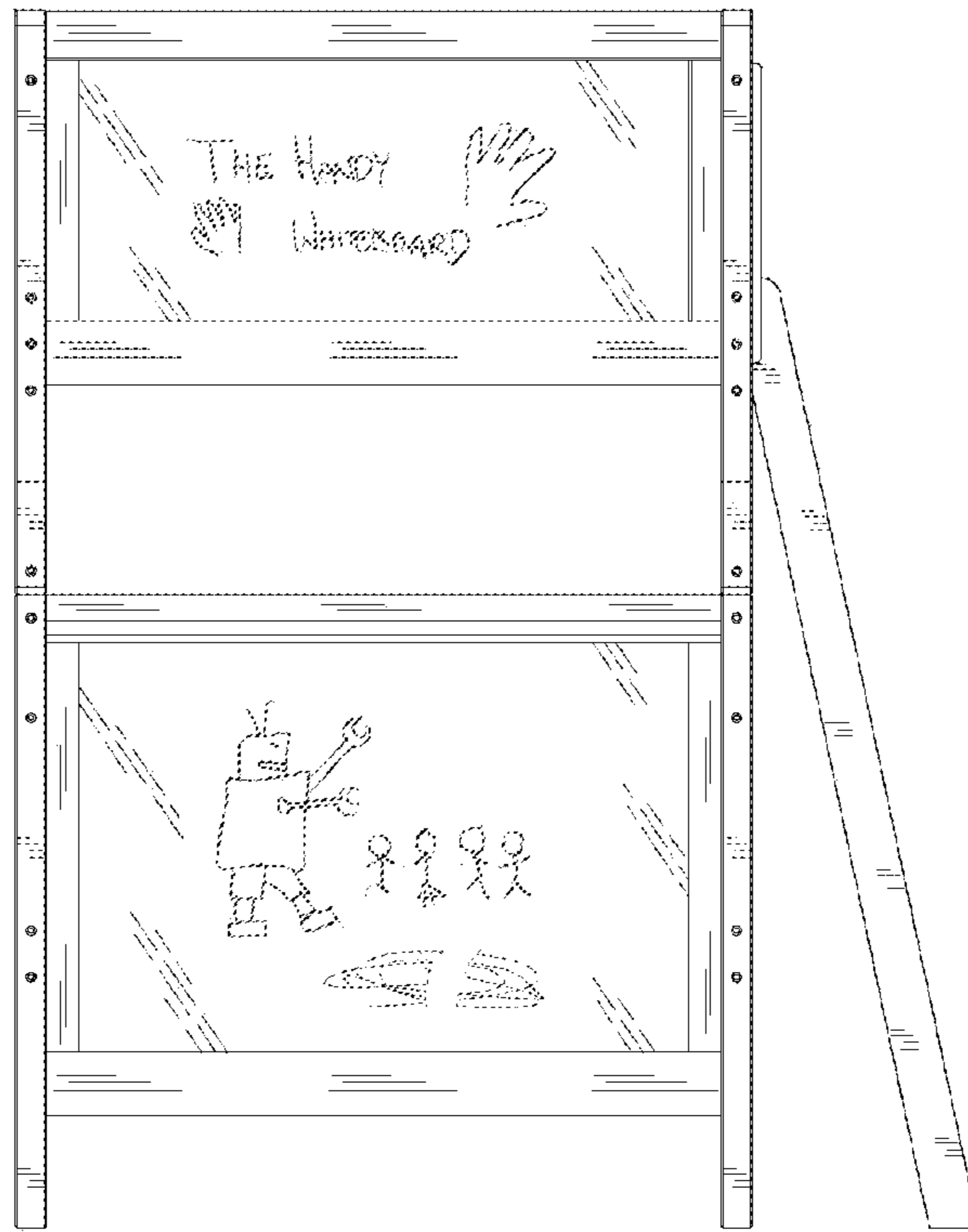

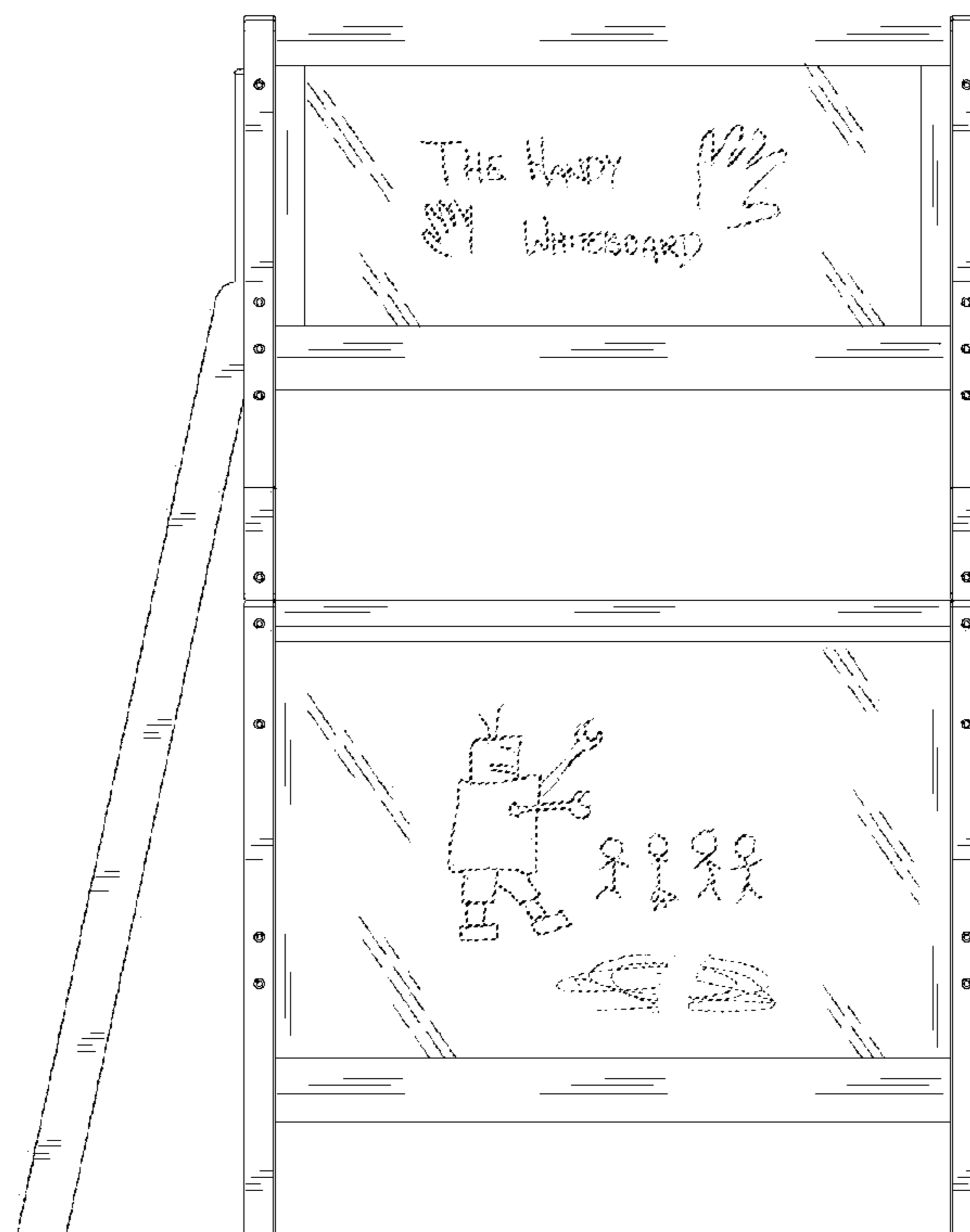

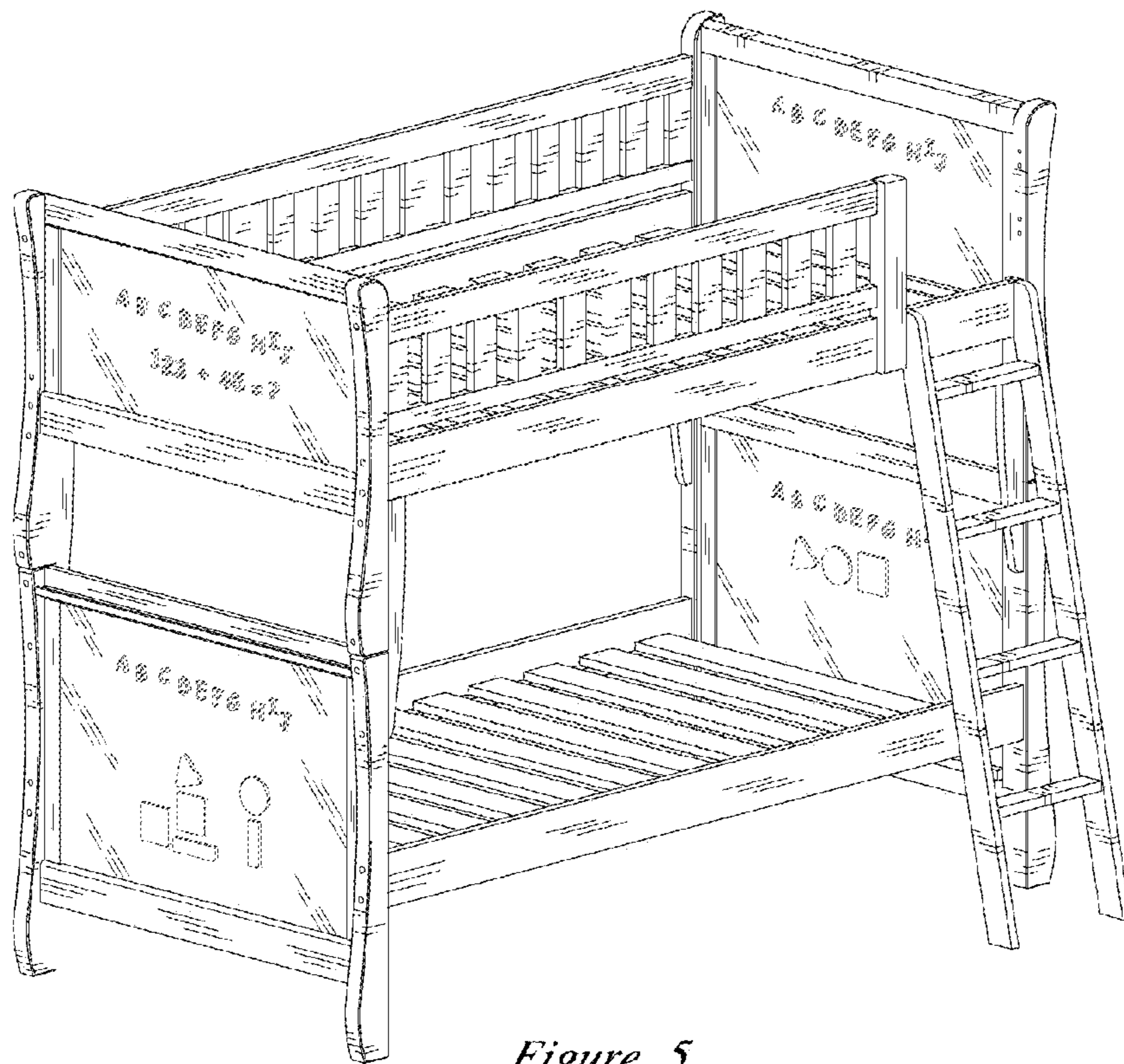

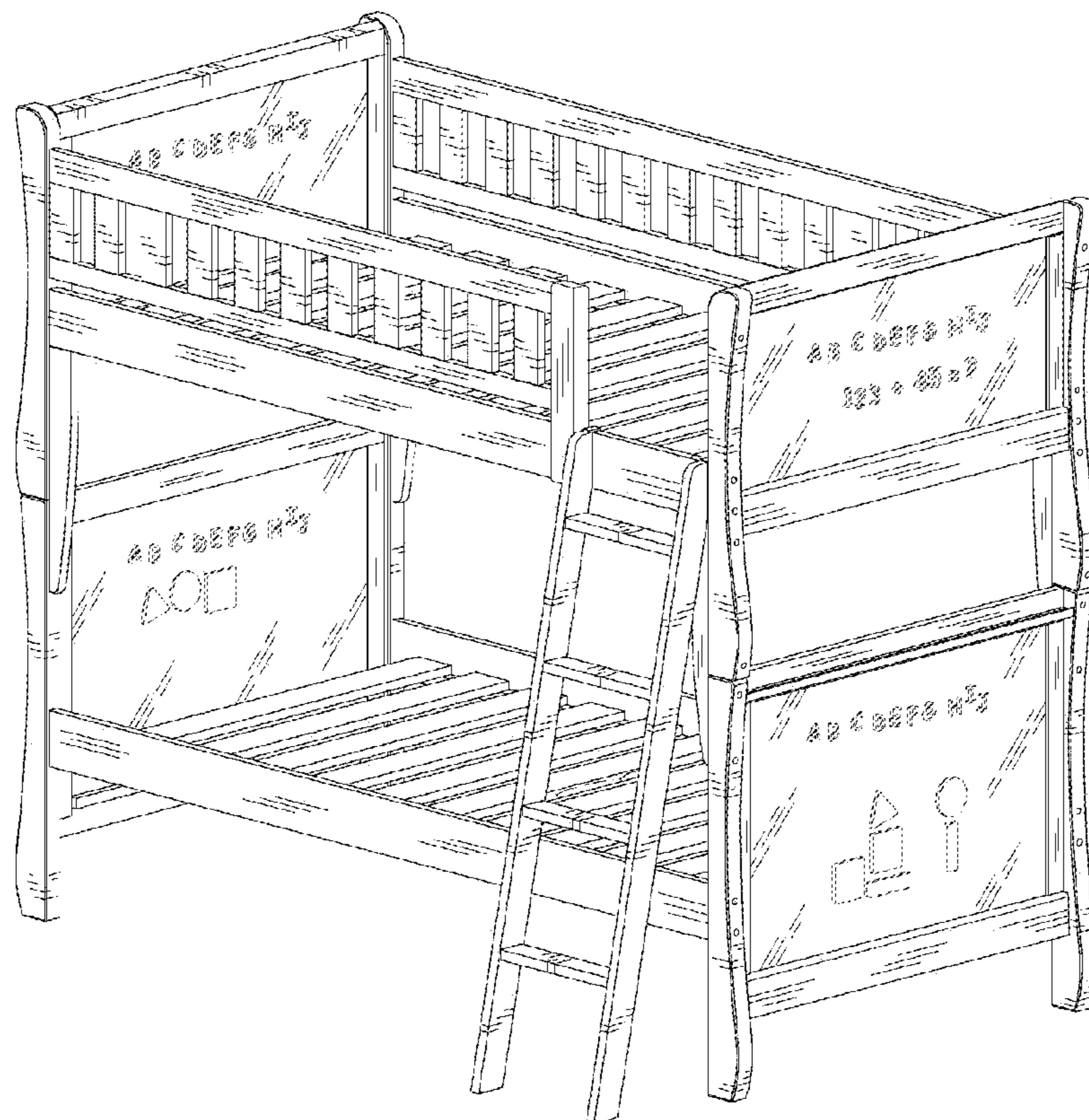

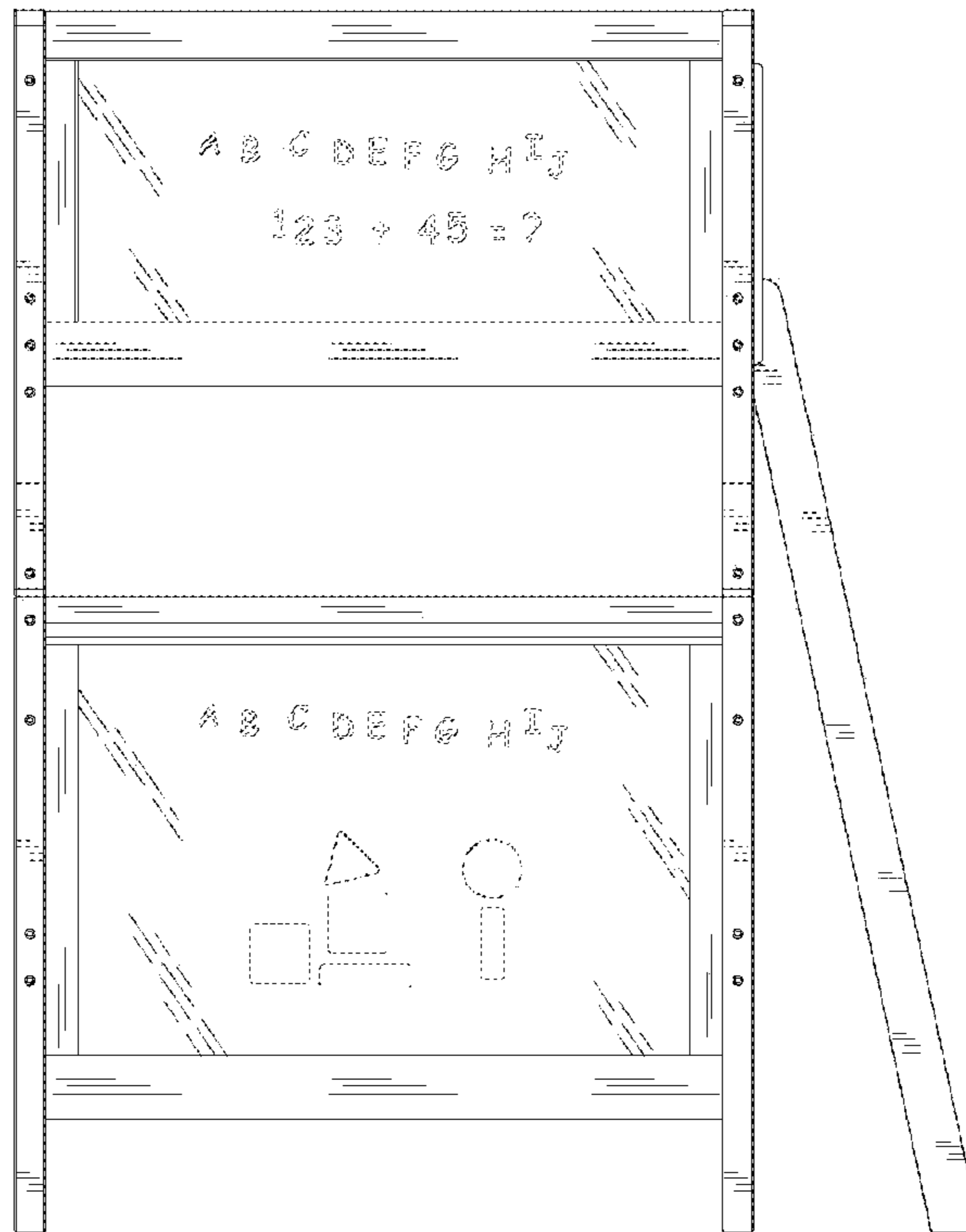

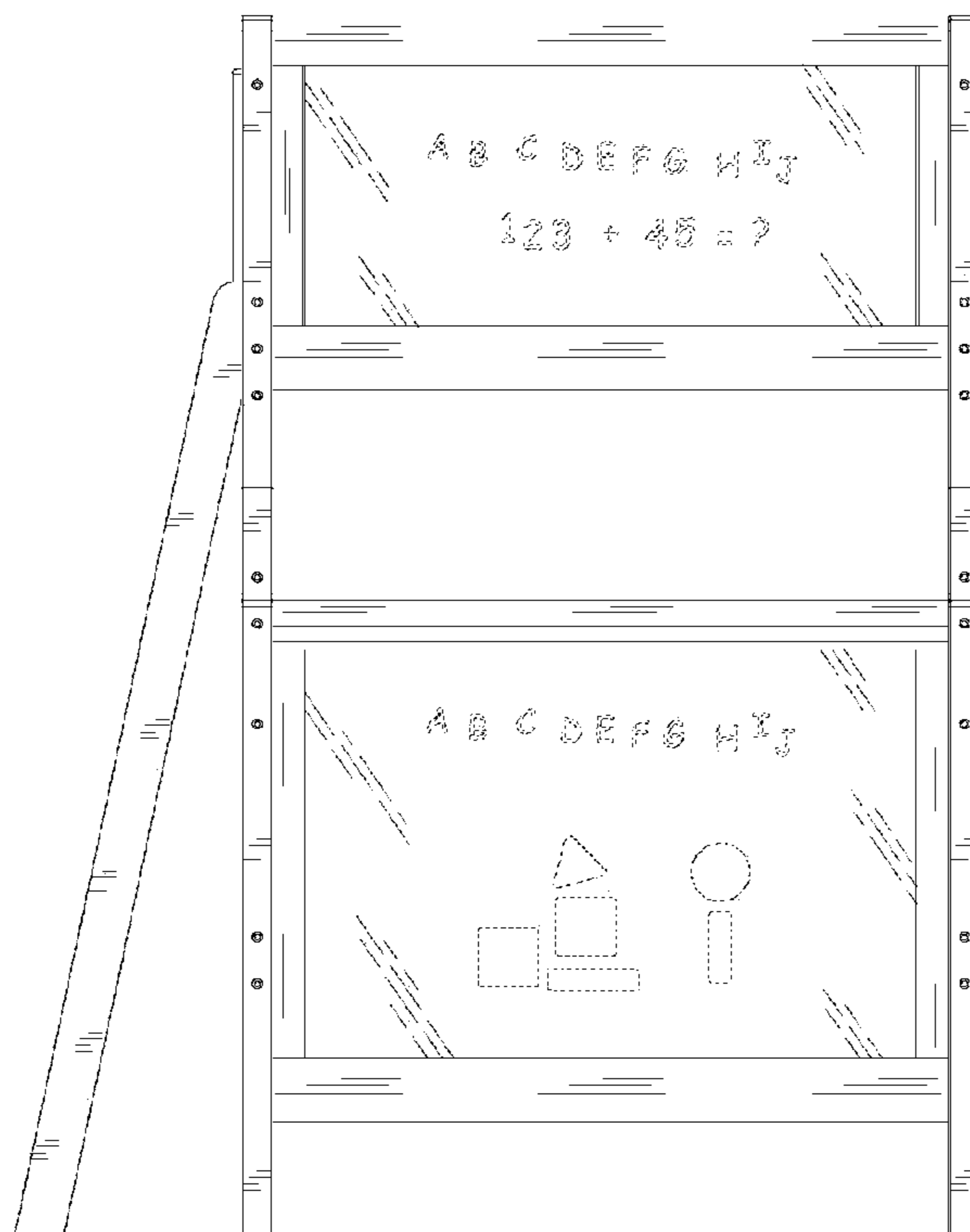

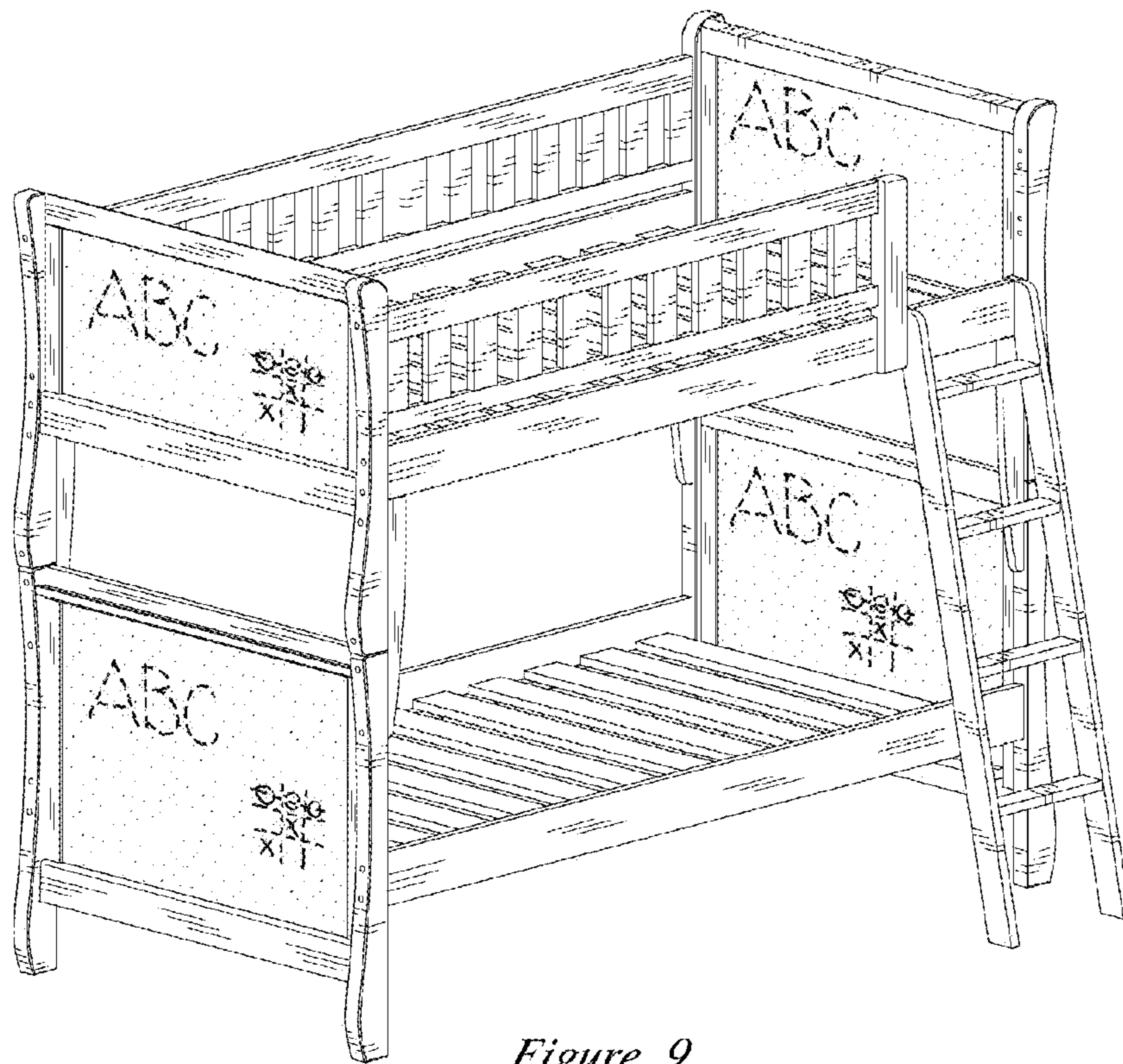

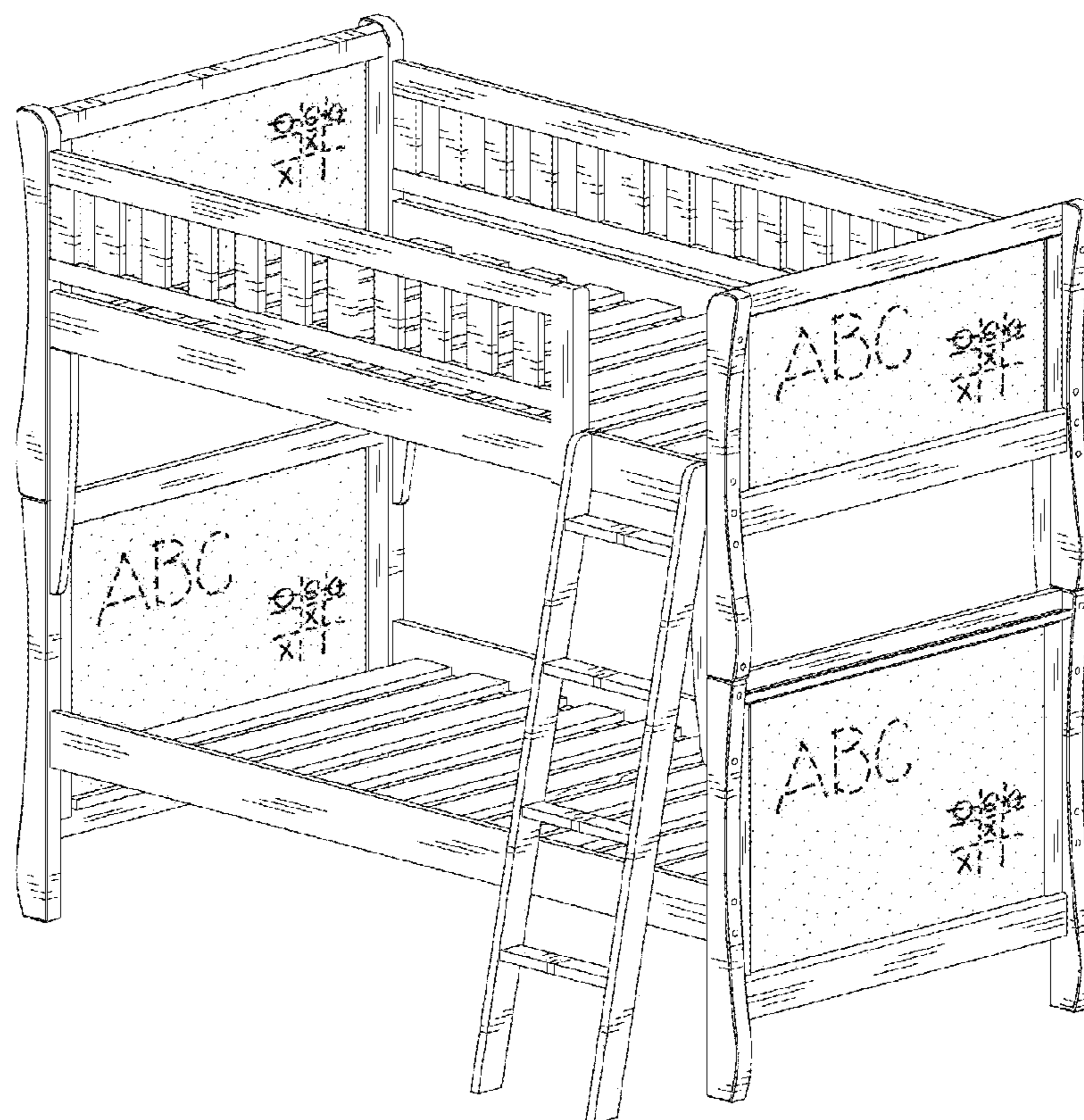

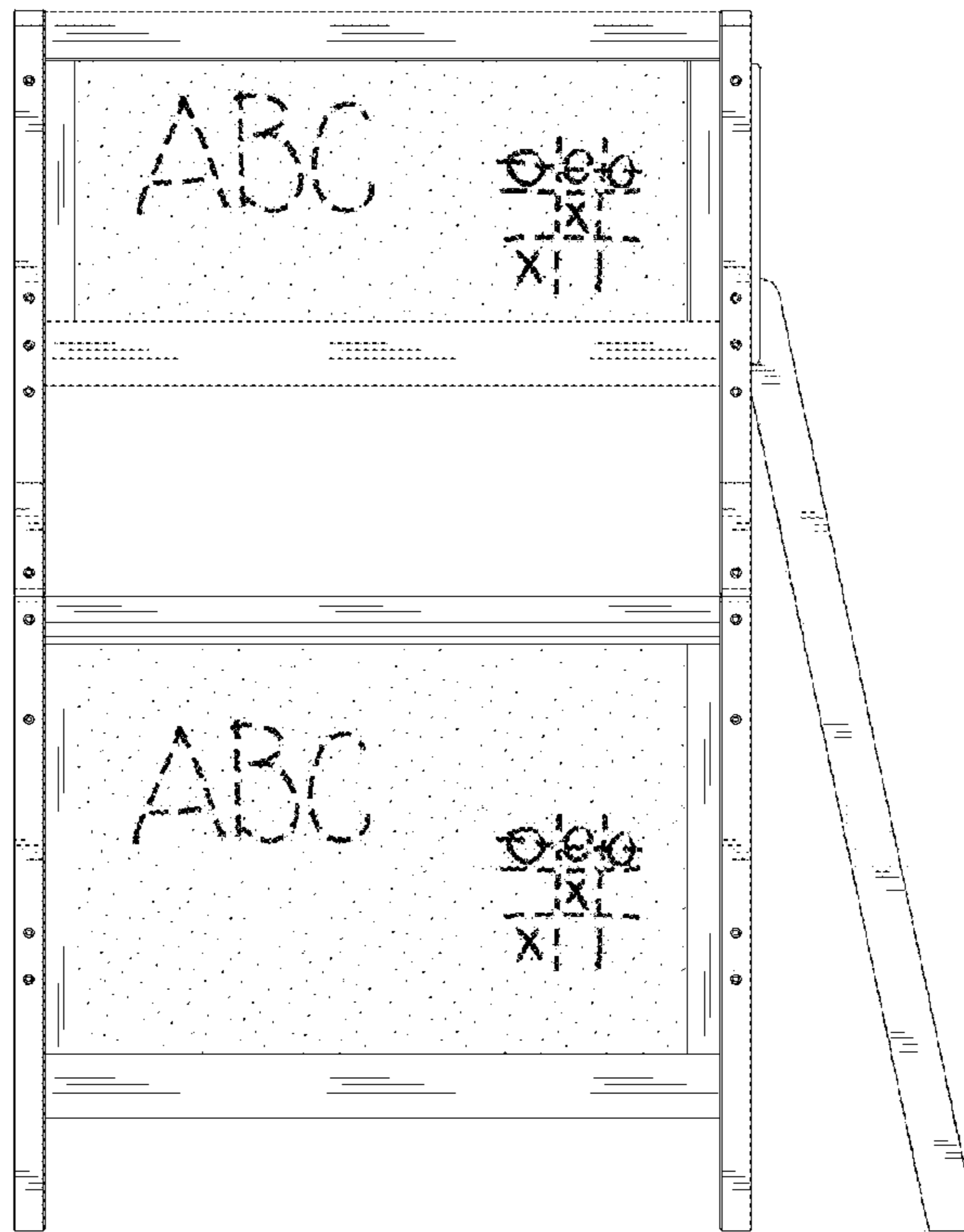

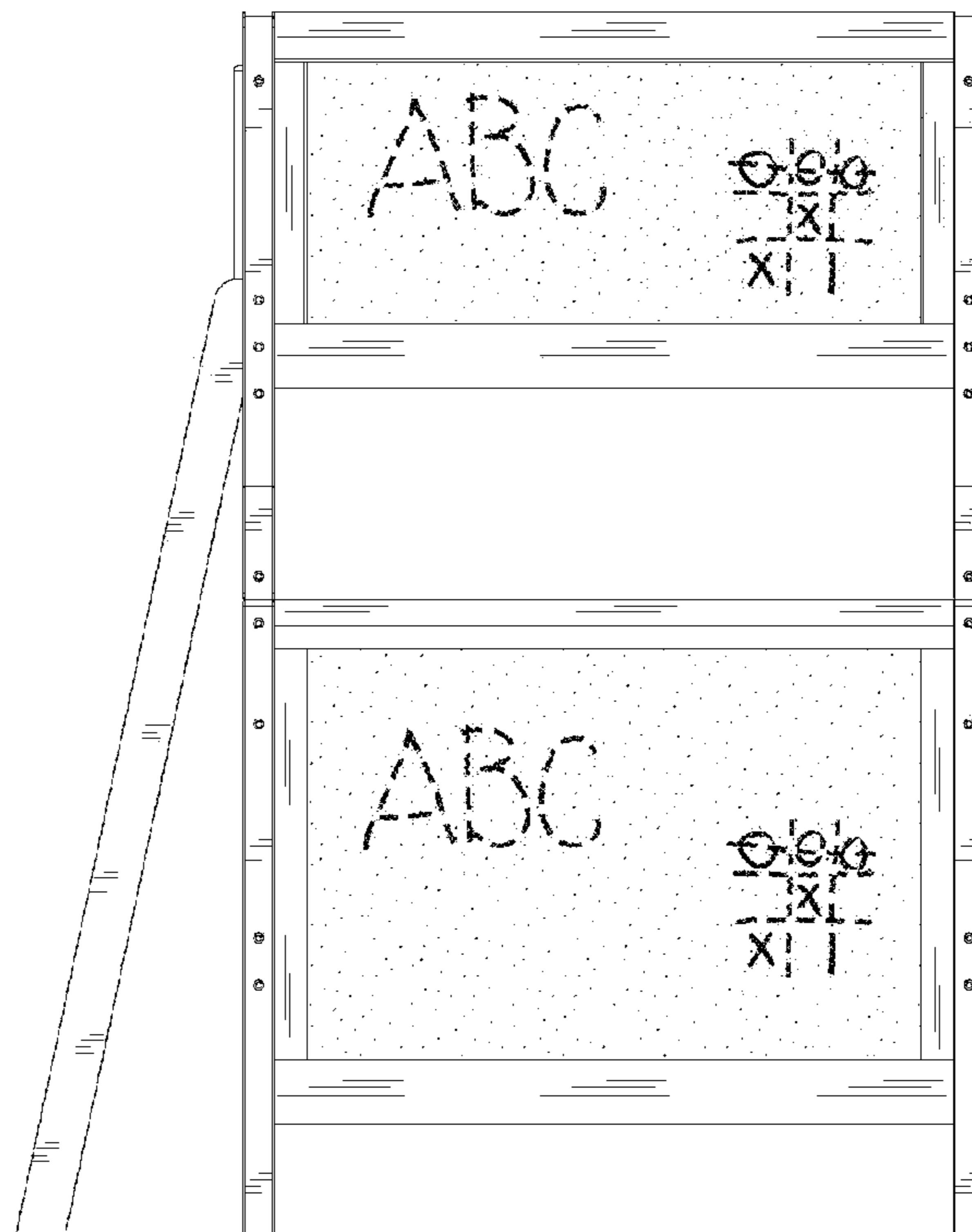

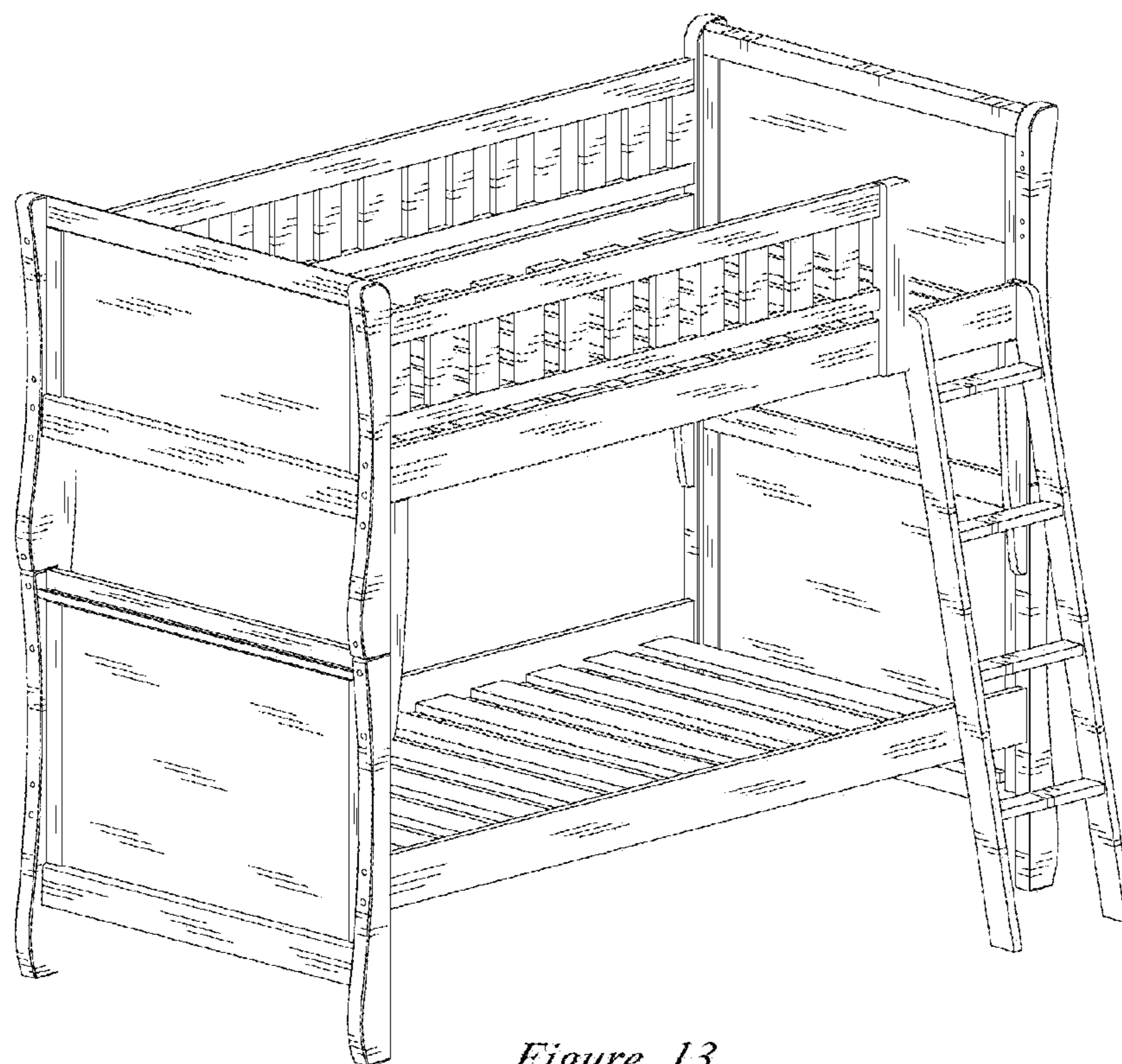

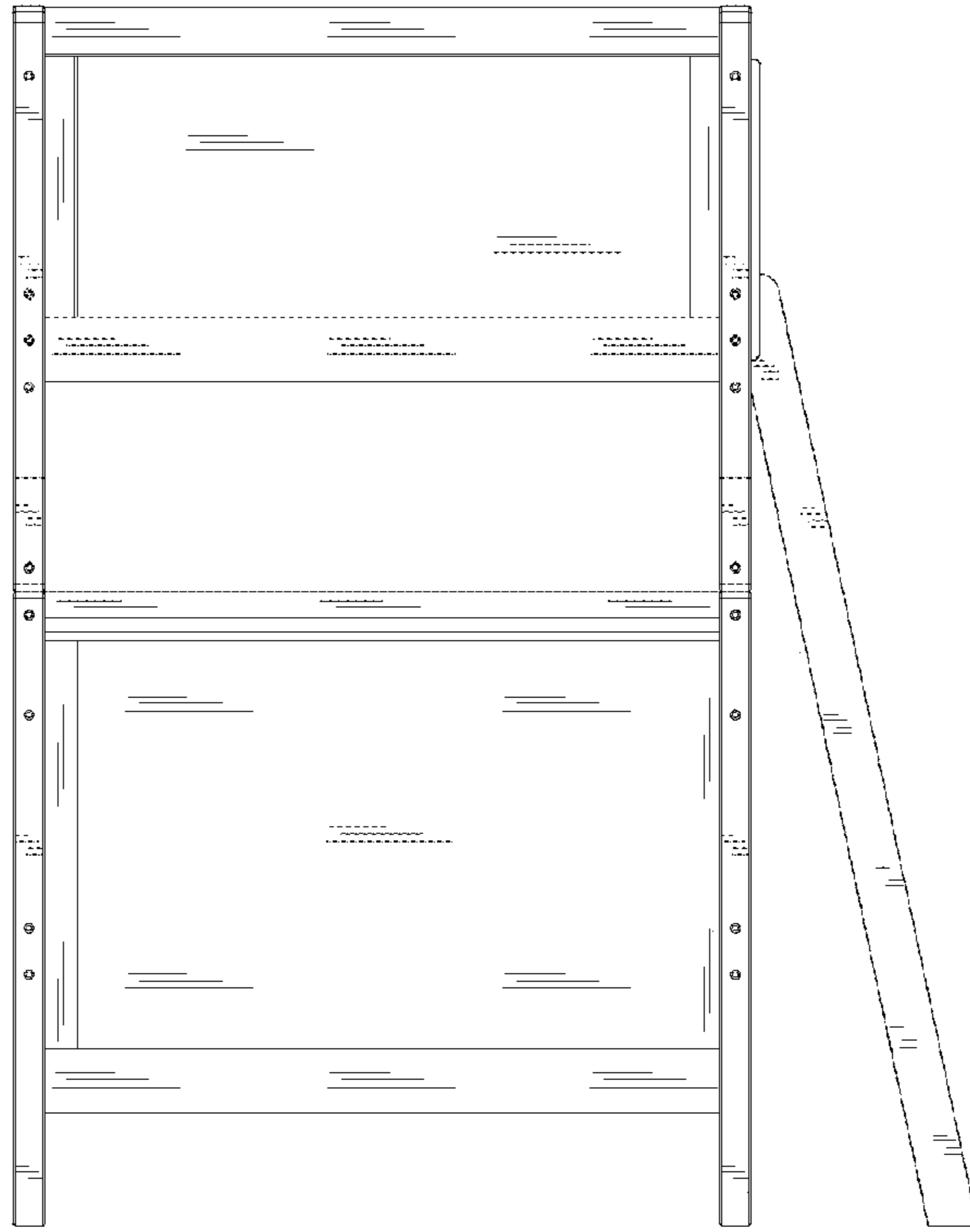

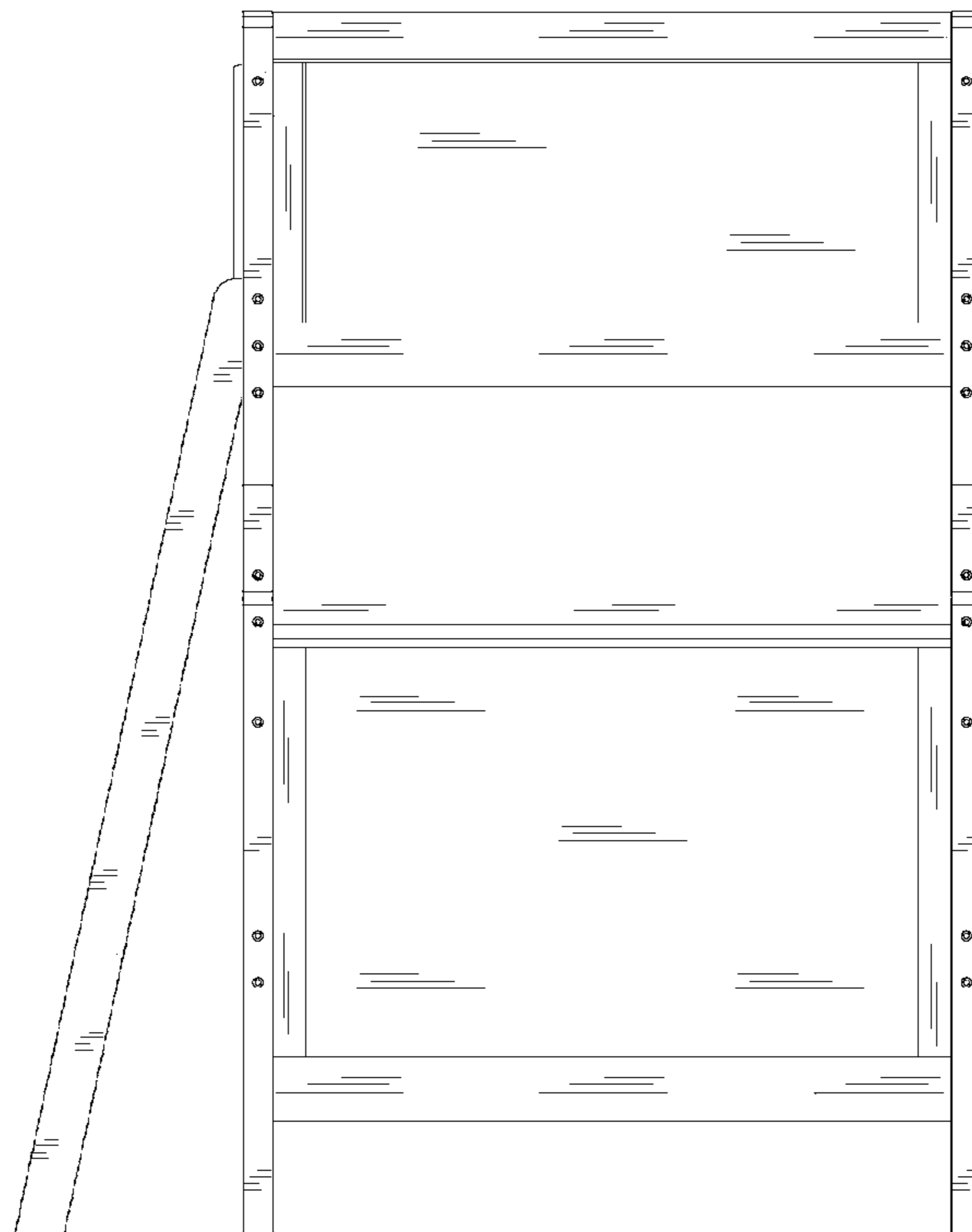
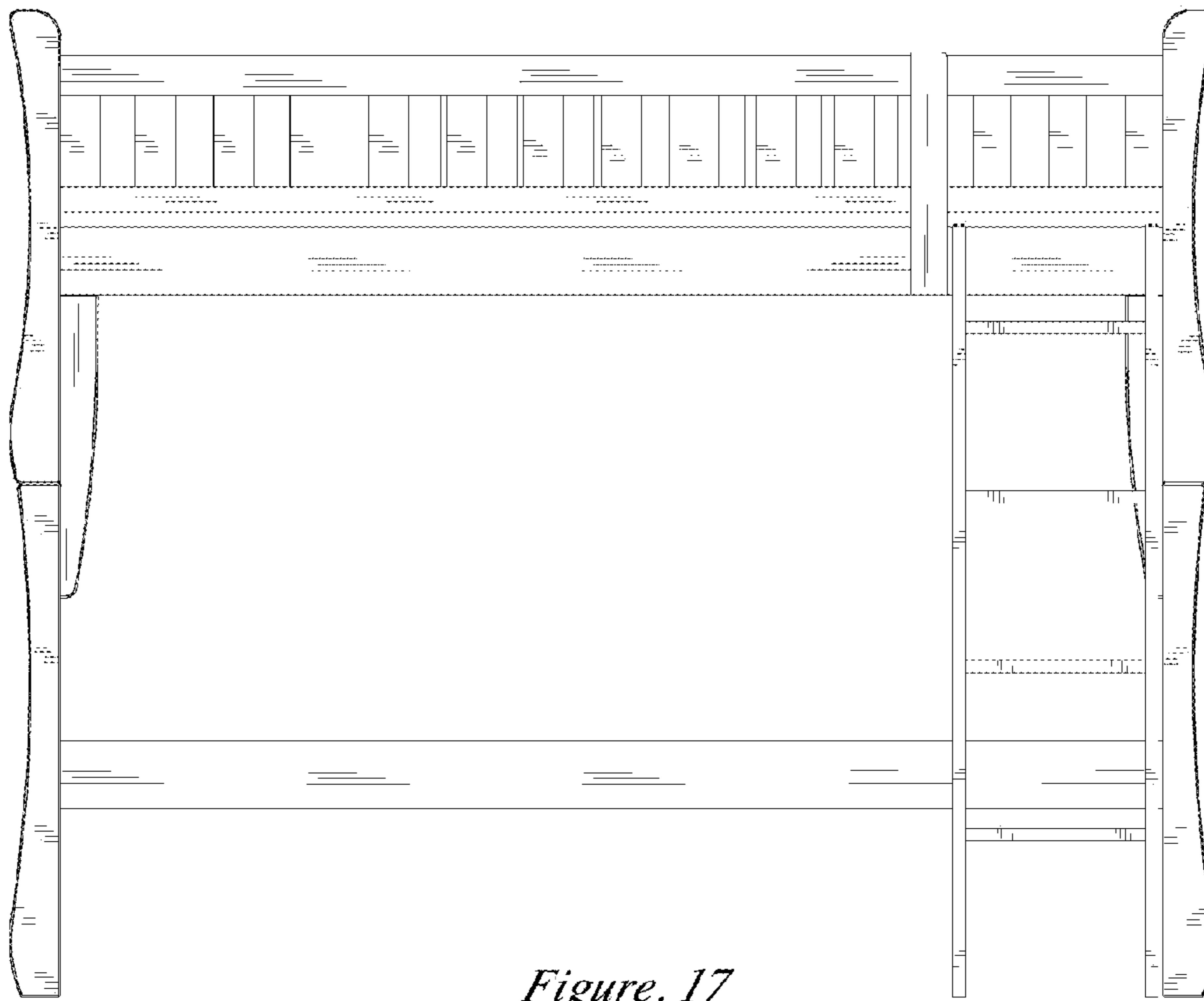
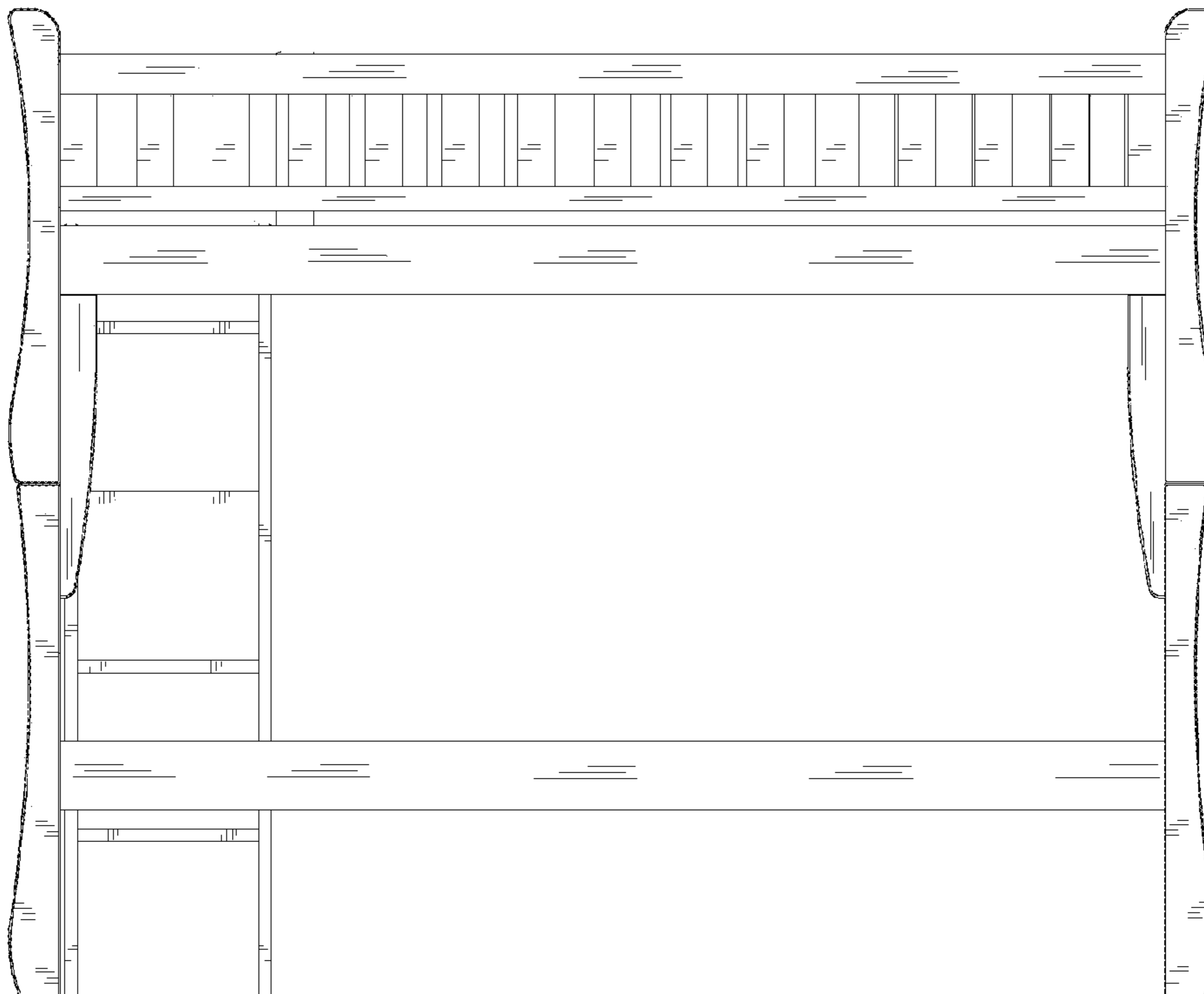


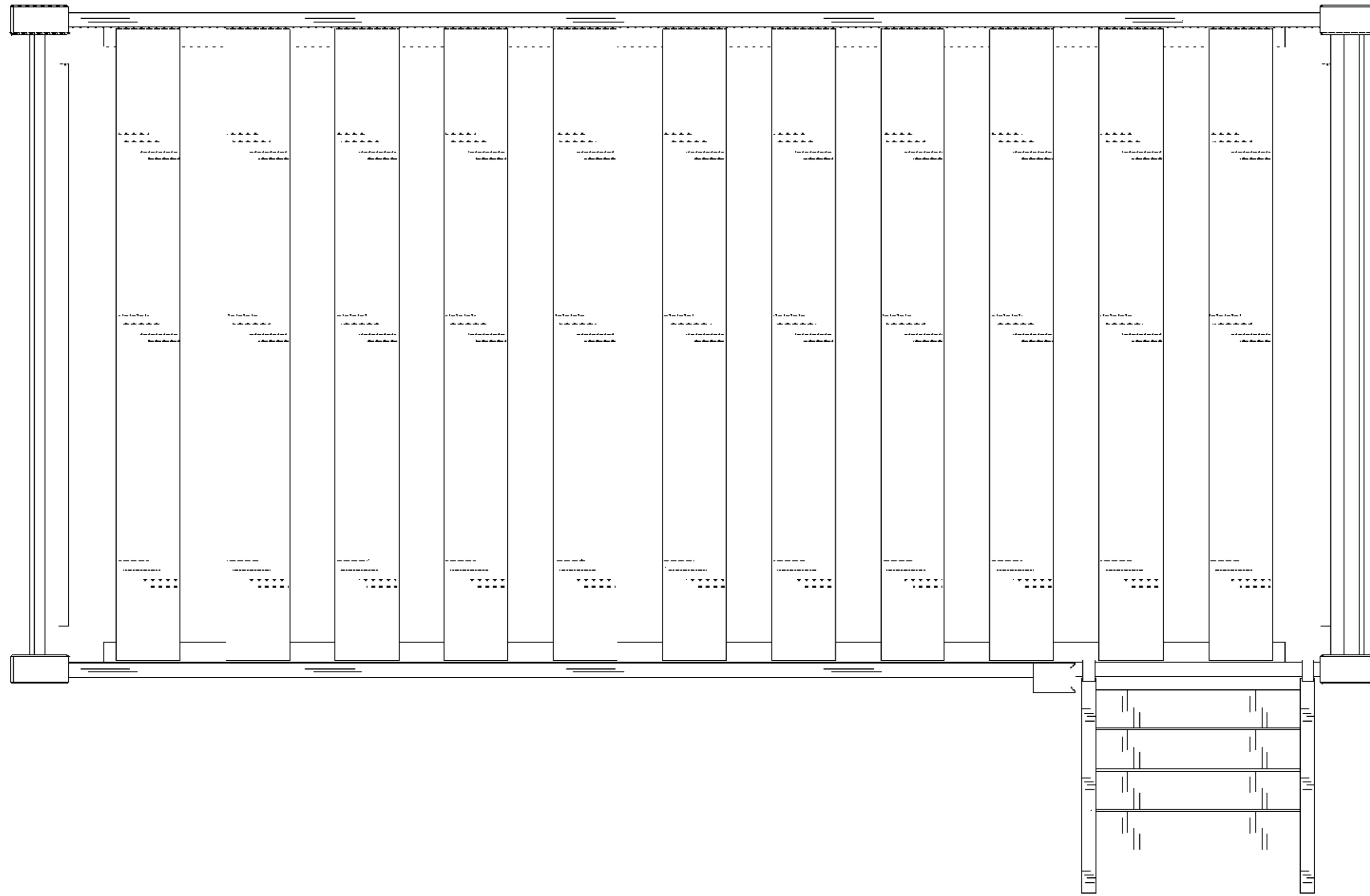
