(57) **CLAIM**

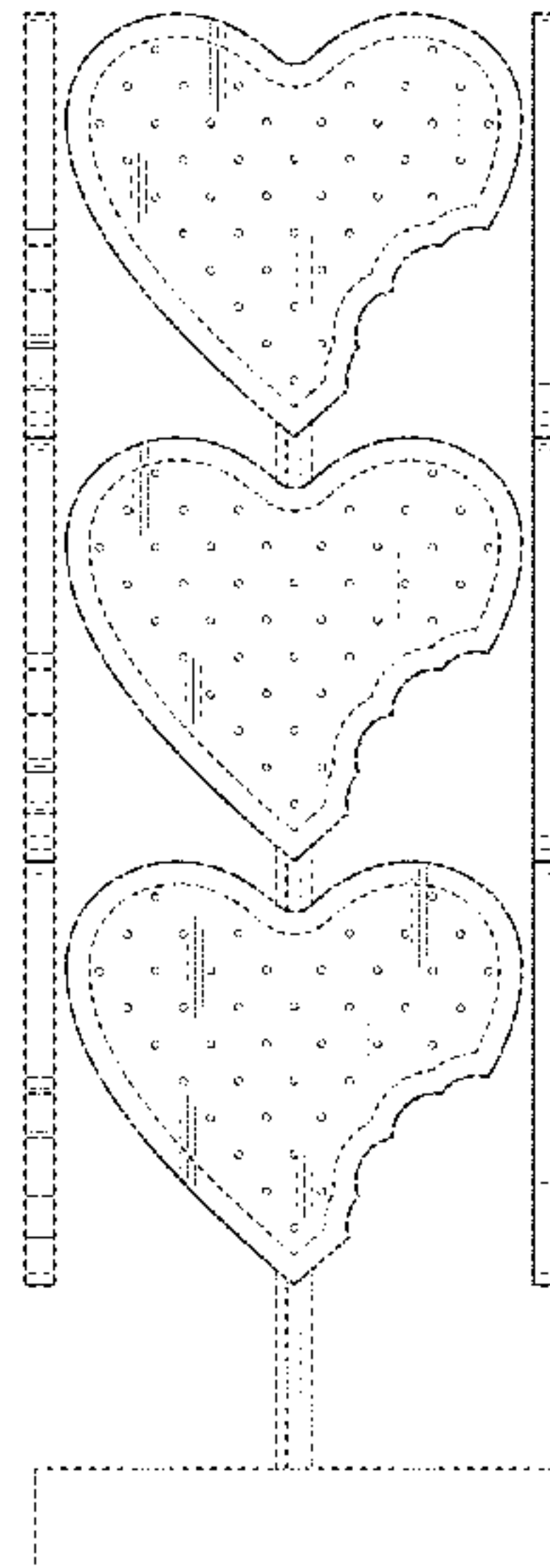
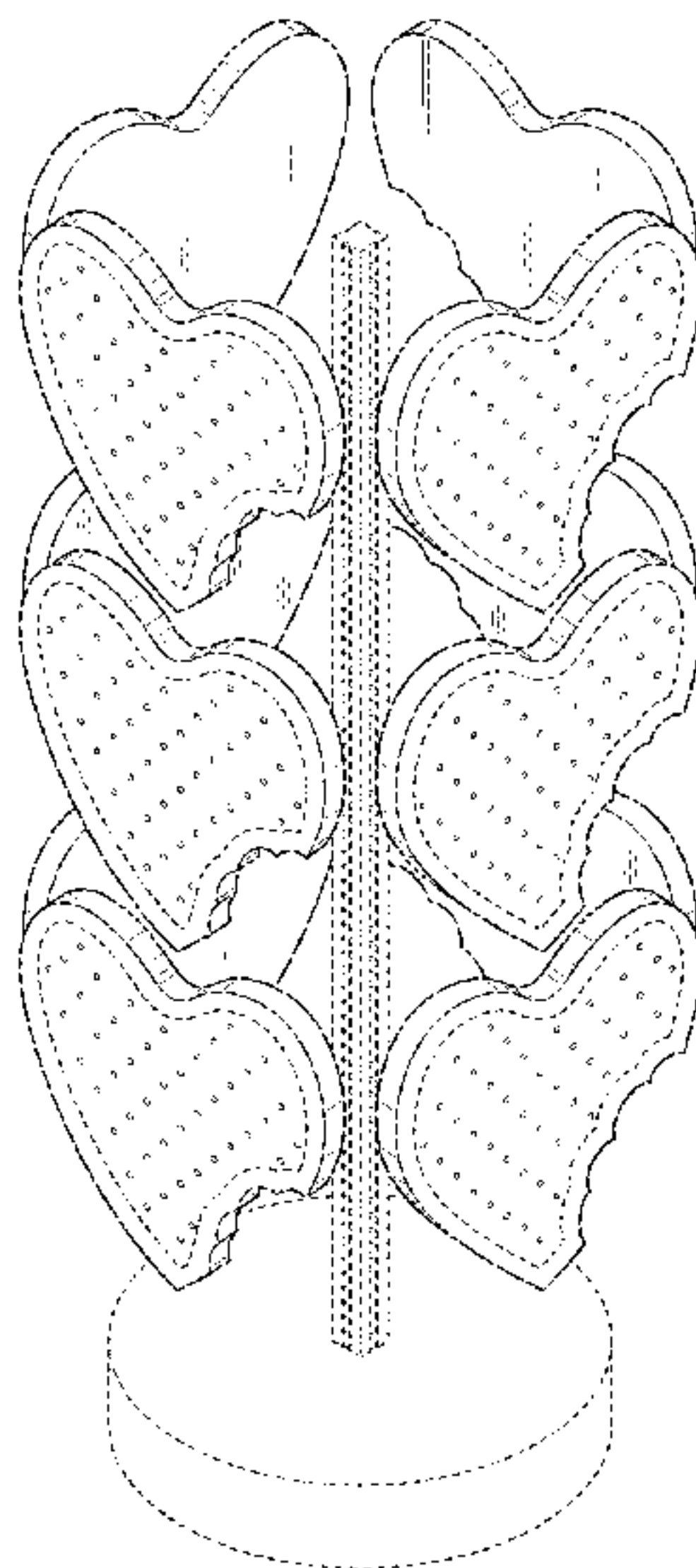
The ornamental design for a heart shaped candy display stand with a bite taken out of it, as shown and described.

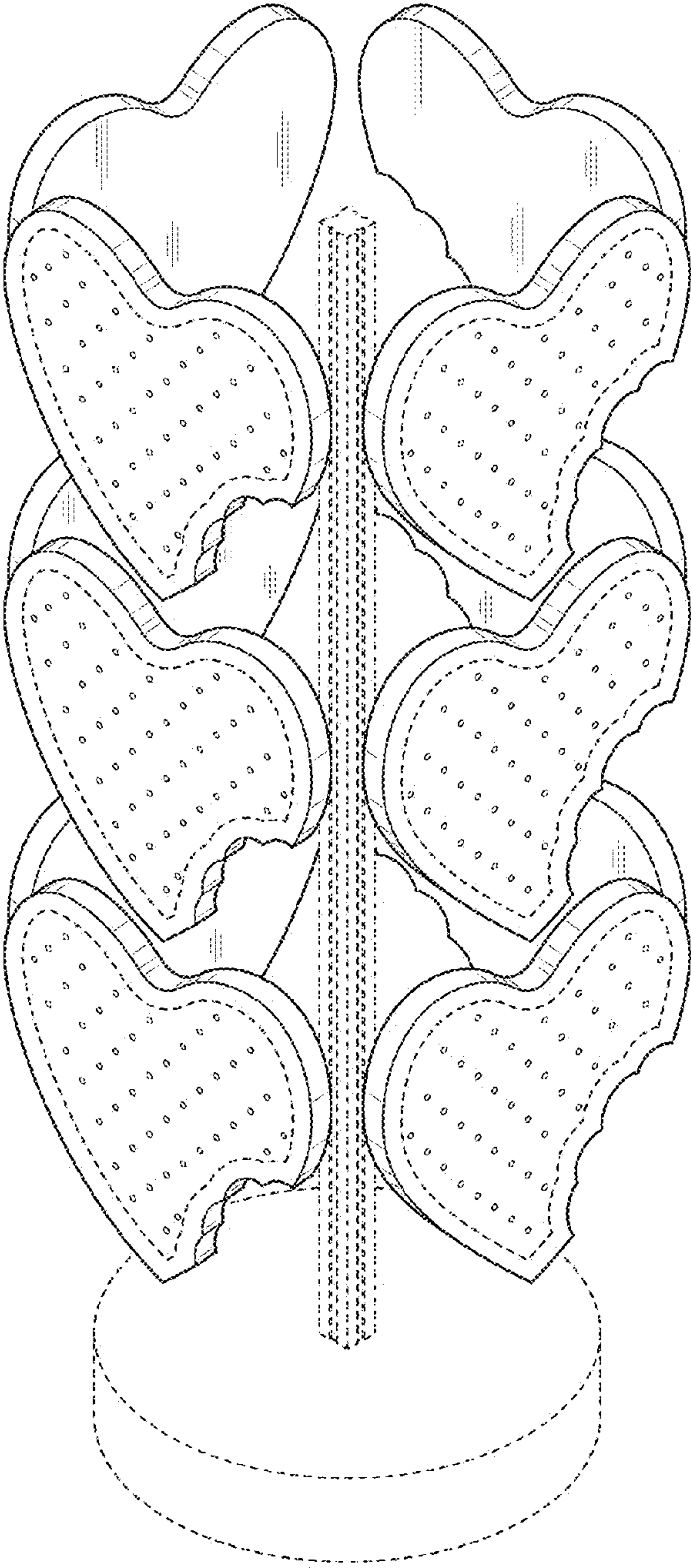

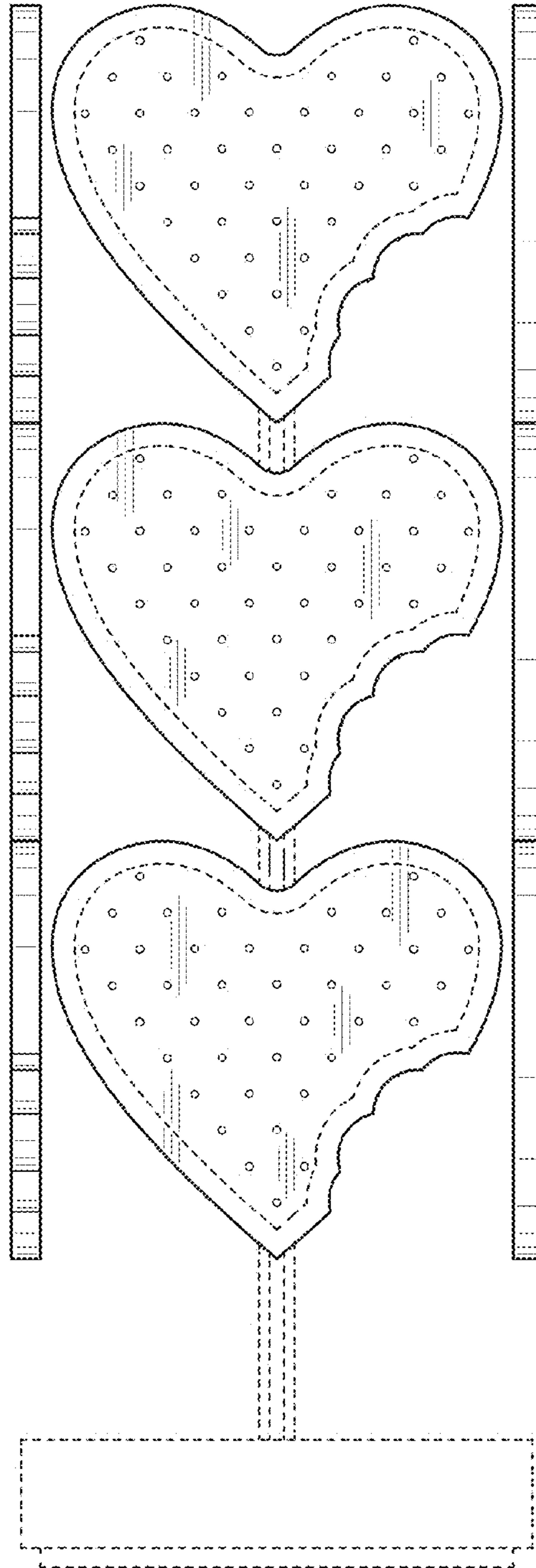
