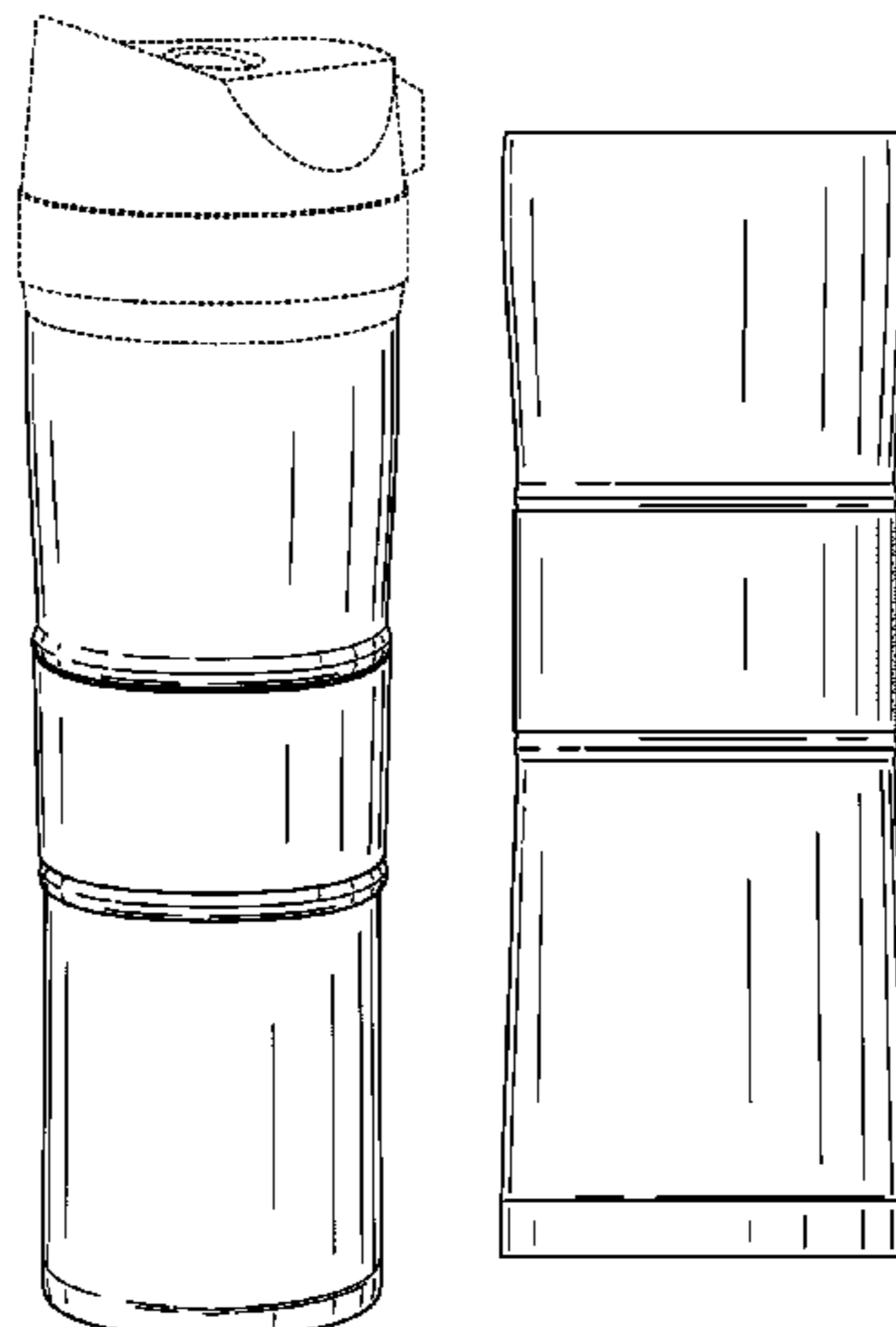
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an environmental front perspective view of a beverageware showing my new design;  
 FIG. 2 is a front view thereof; the rear view being a mirror image thereof;  
 FIG. 3 is a right side view thereof; the left side view being a mirror image thereof;  
 FIG. 4 is a top view thereof; and,  
 FIG. 5 is a bottom view thereof.  
 The broken lines illustrate unclaimed portions of the beverageware or environmental features that form no part of the claimed design.

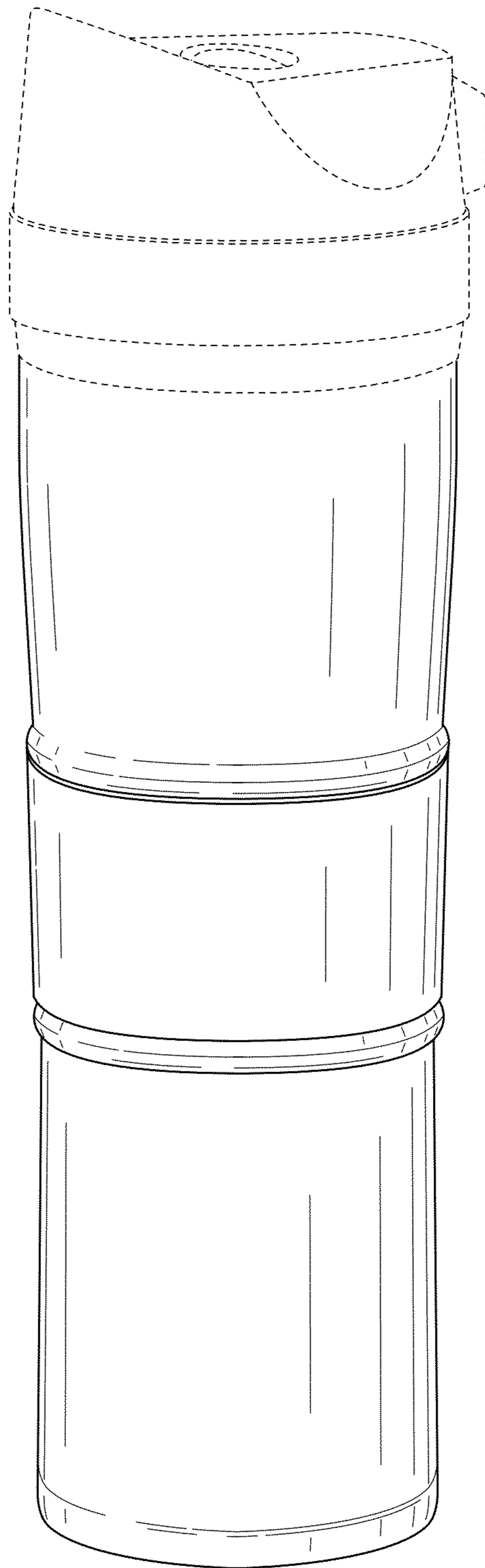

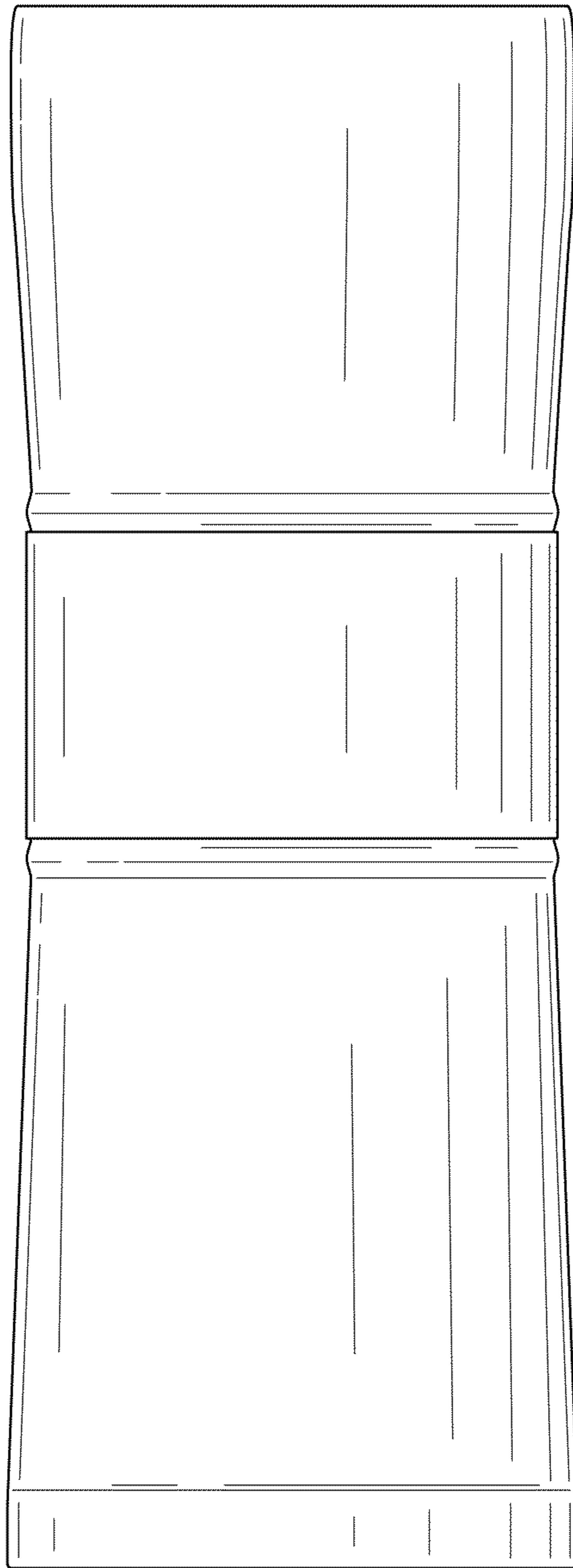

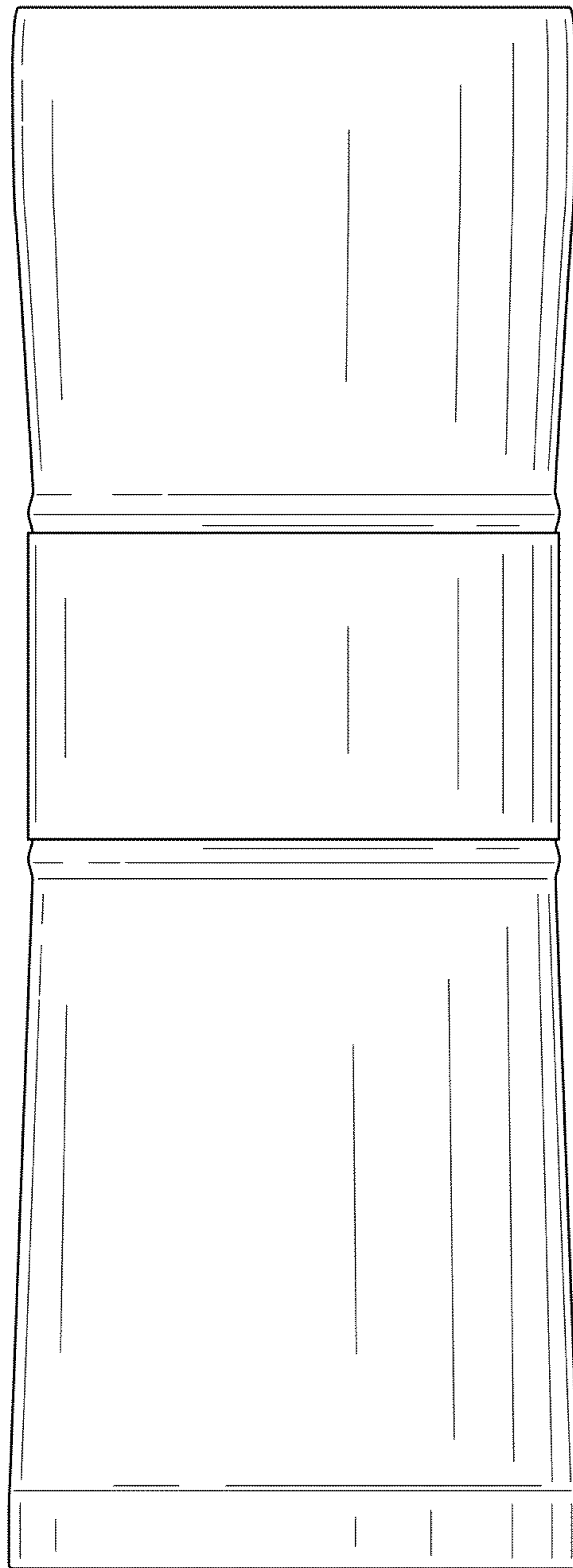

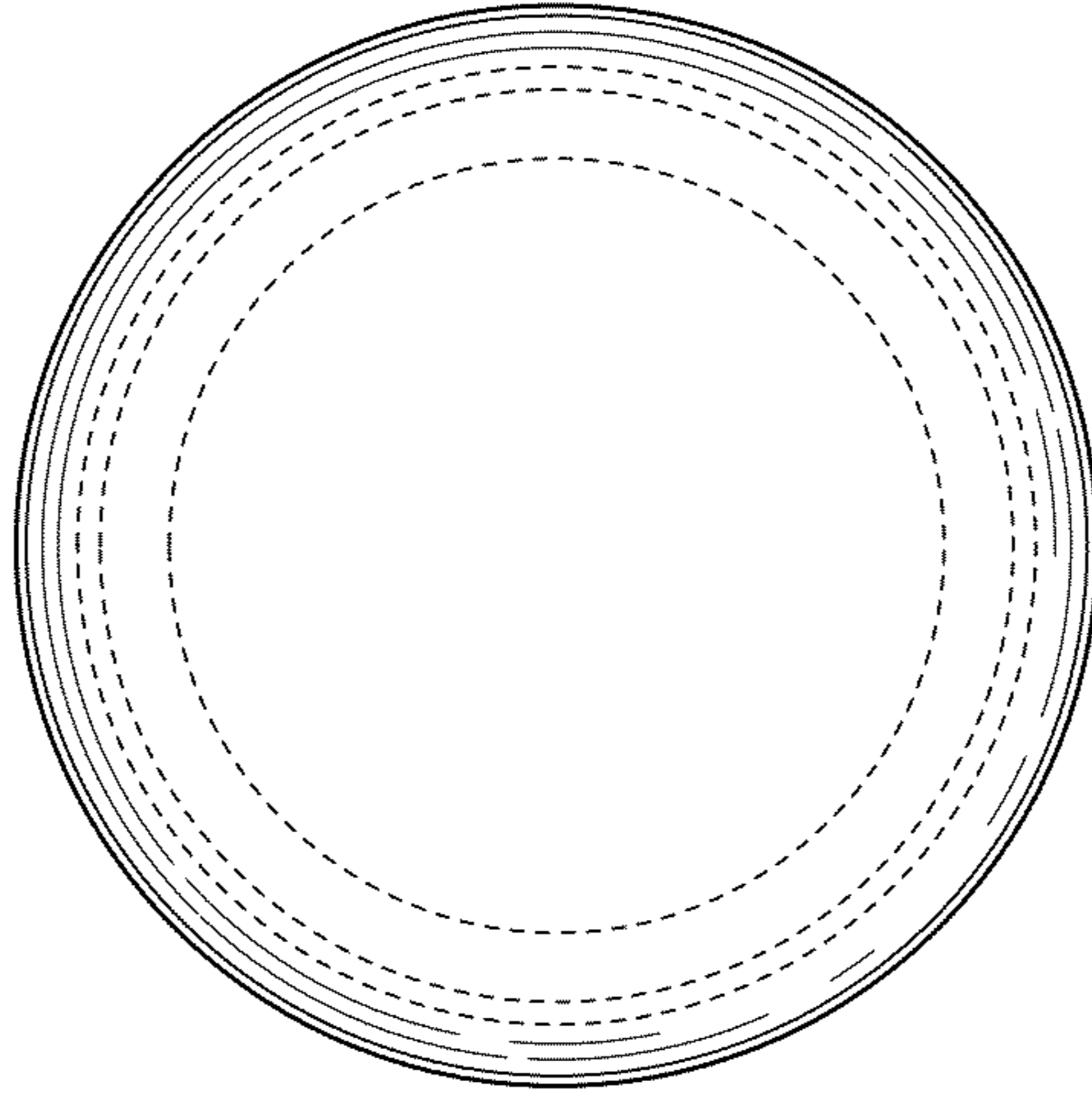

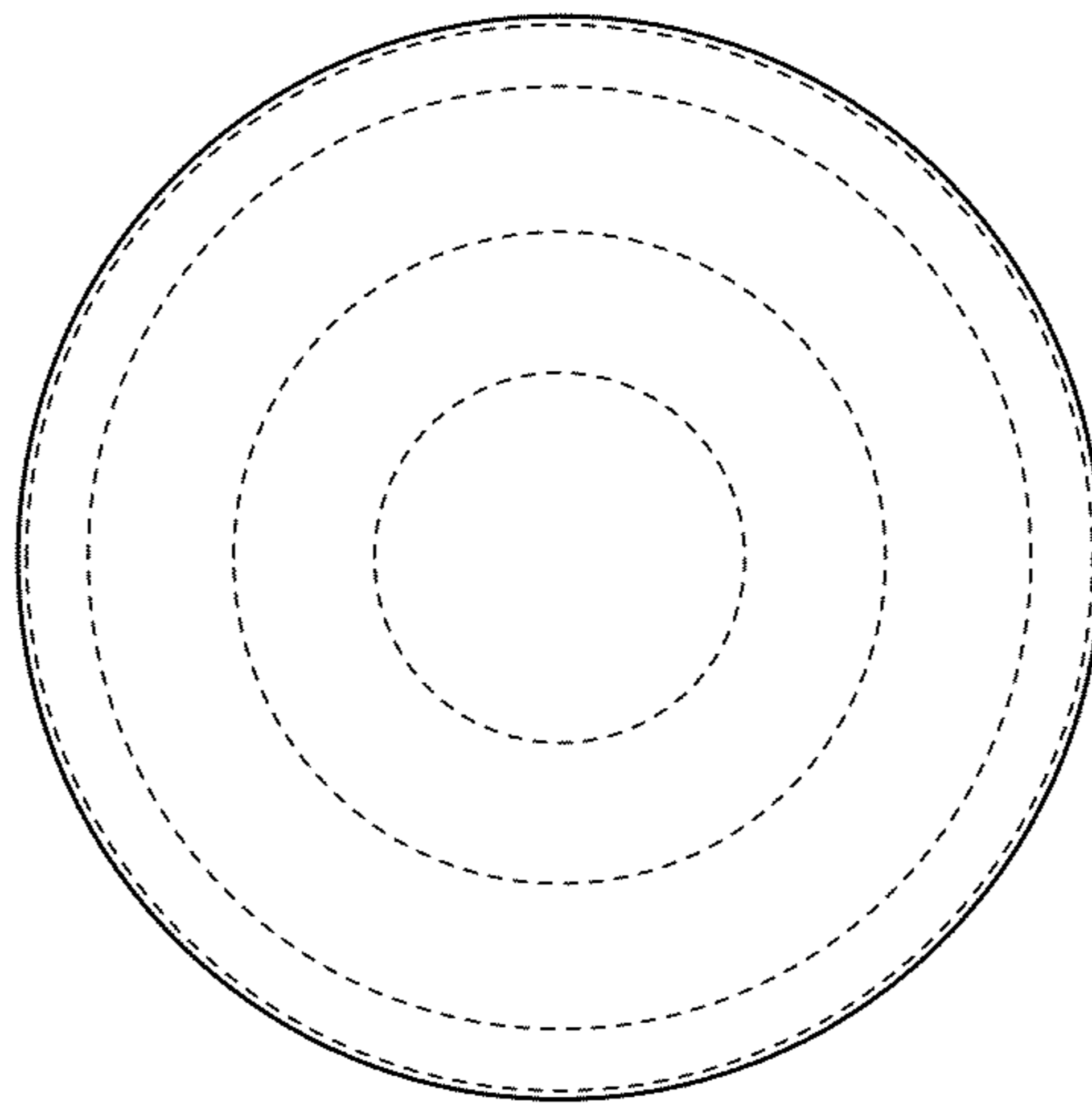
