(57) **CLAIM**

The ornamental design for a wrist watch case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wrist watch case showing our new design;  
 FIG. 2 is a front elevational view thereof, drawn to a reduced scale;  
 FIG. 3 is a left side elevational view thereof, drawn to the scale of FIG. 2;  
 FIG. 4 is a right side elevational view thereof, drawn to the scale of FIG. 2;  
 FIG. 5 is a rear elevational view thereof, drawn to the scale of FIG. 2;  
 FIG. 6 is a top plan view thereof, drawn to the scale of FIG. 2; and,  
 FIG. 7 is a bottom plan view thereof, drawn to the scale of FIG. 2.

The features depicted by broken lines in the drawings have been shown for the purpose of illustrating portions of the wrist watch case that form no part of the claimed design.

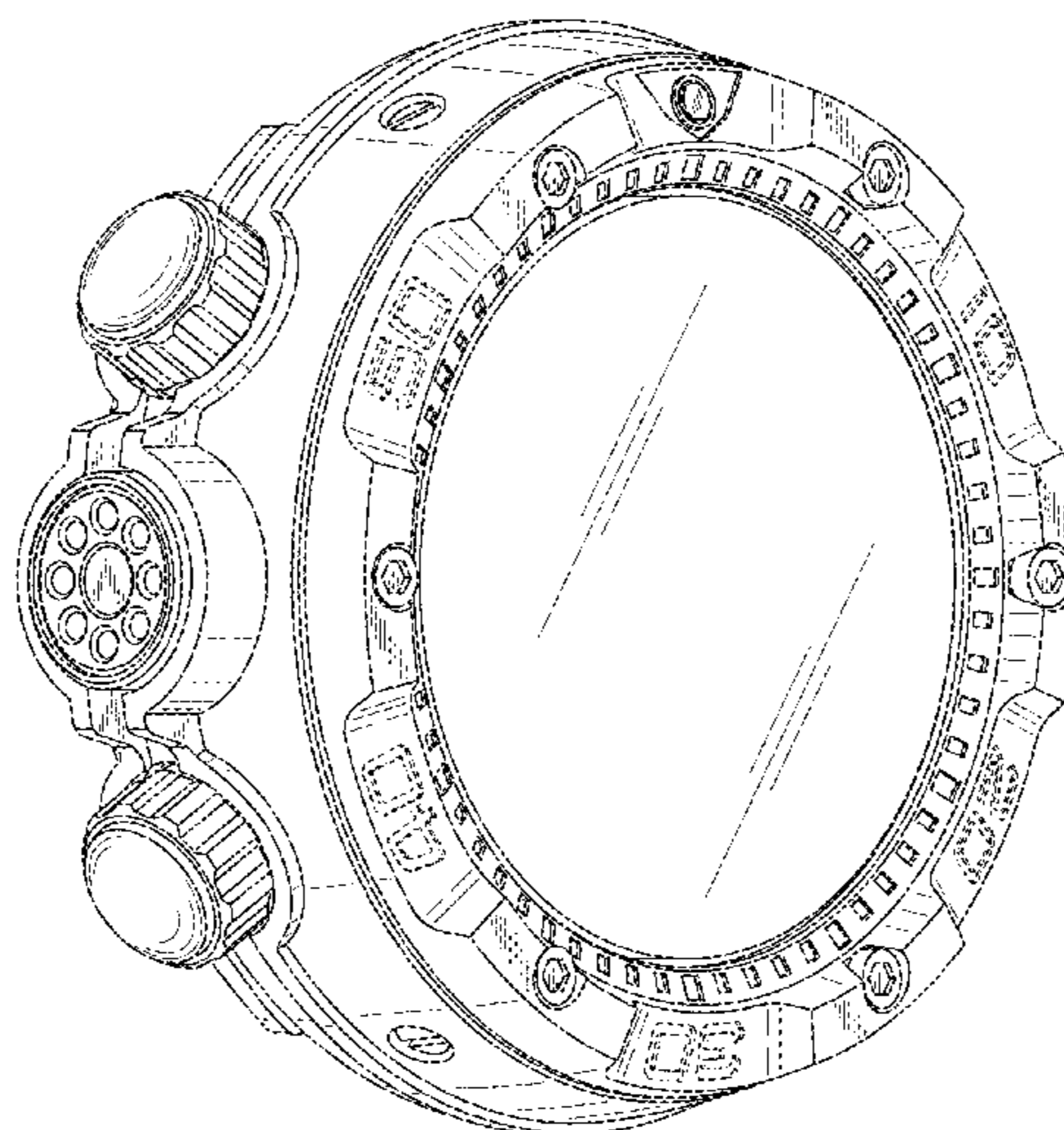

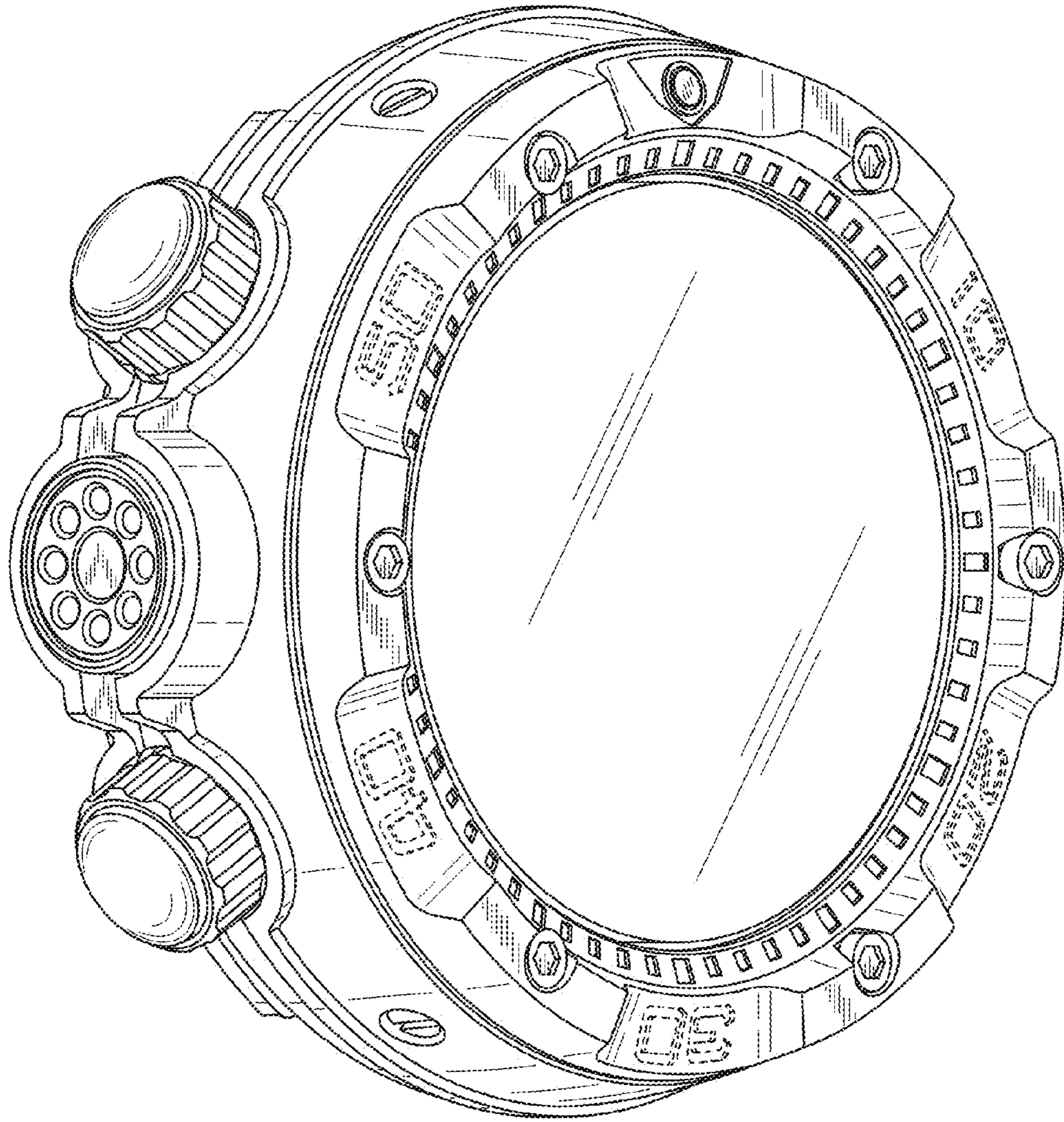

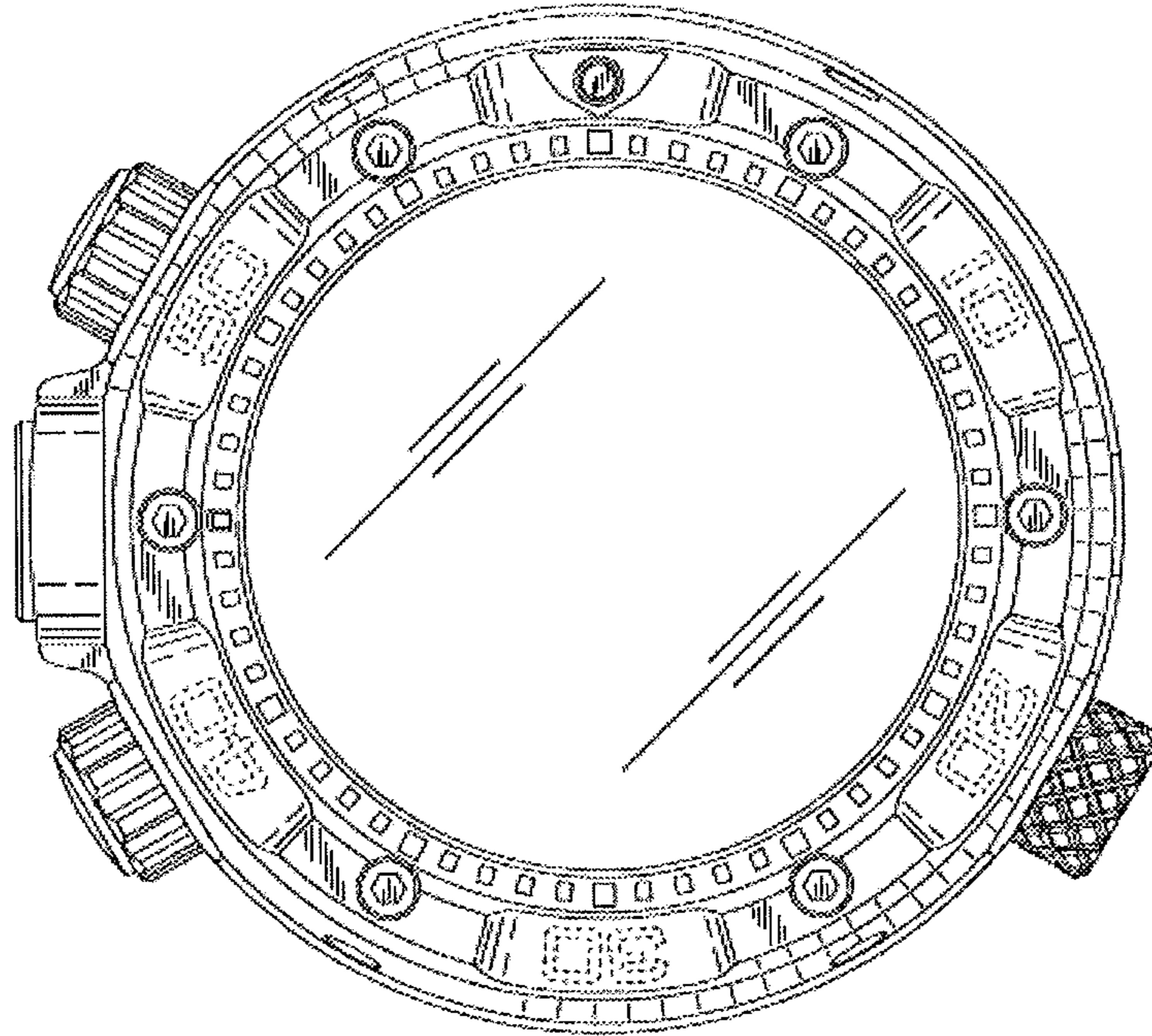

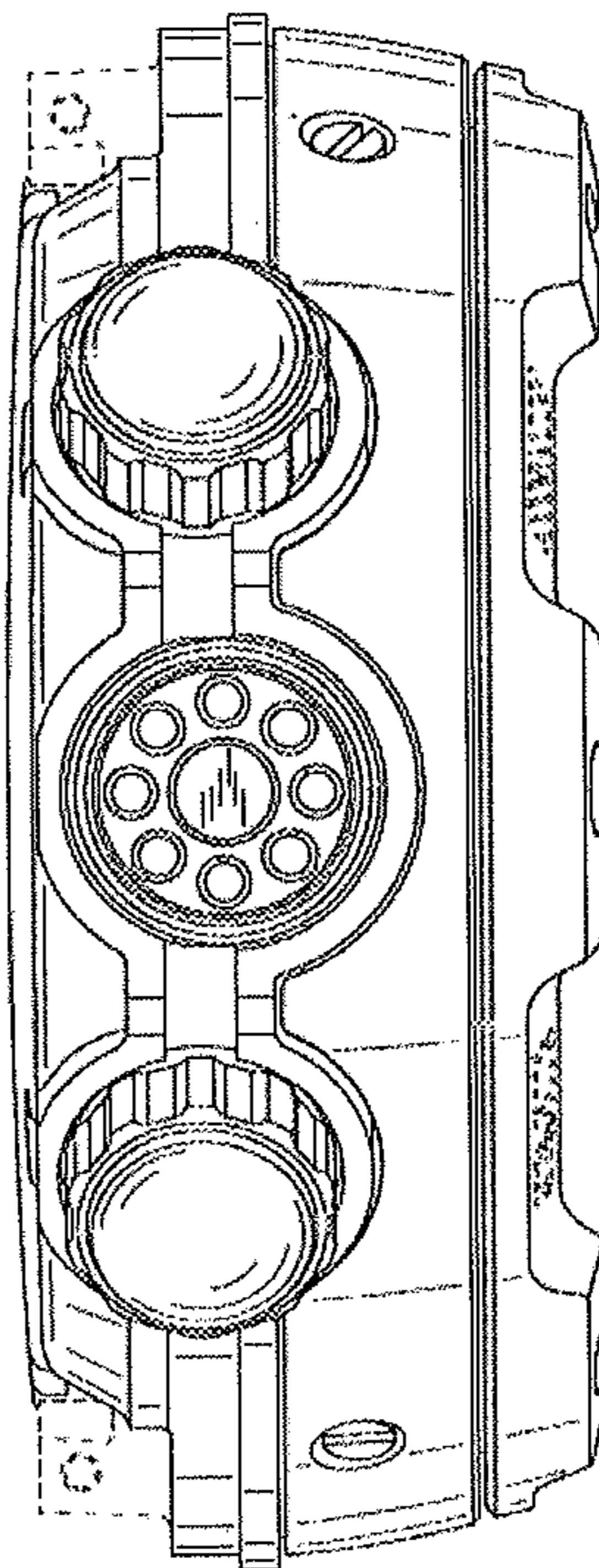

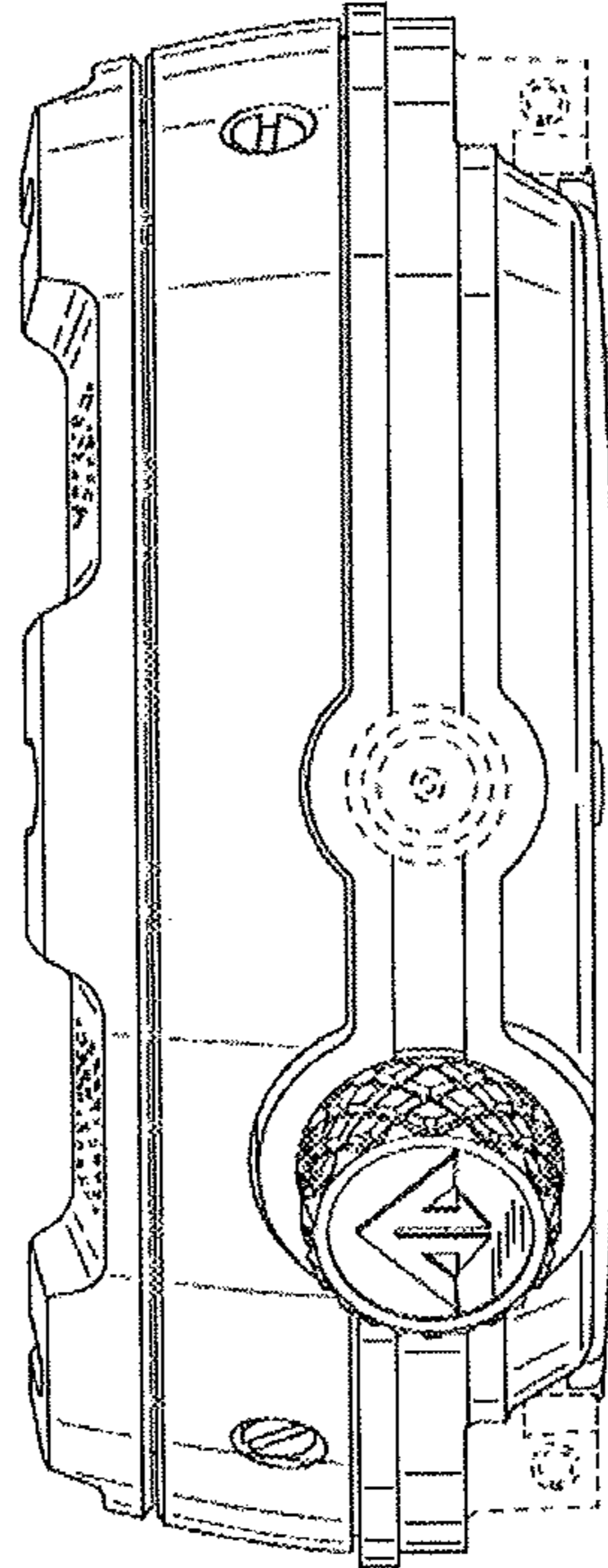

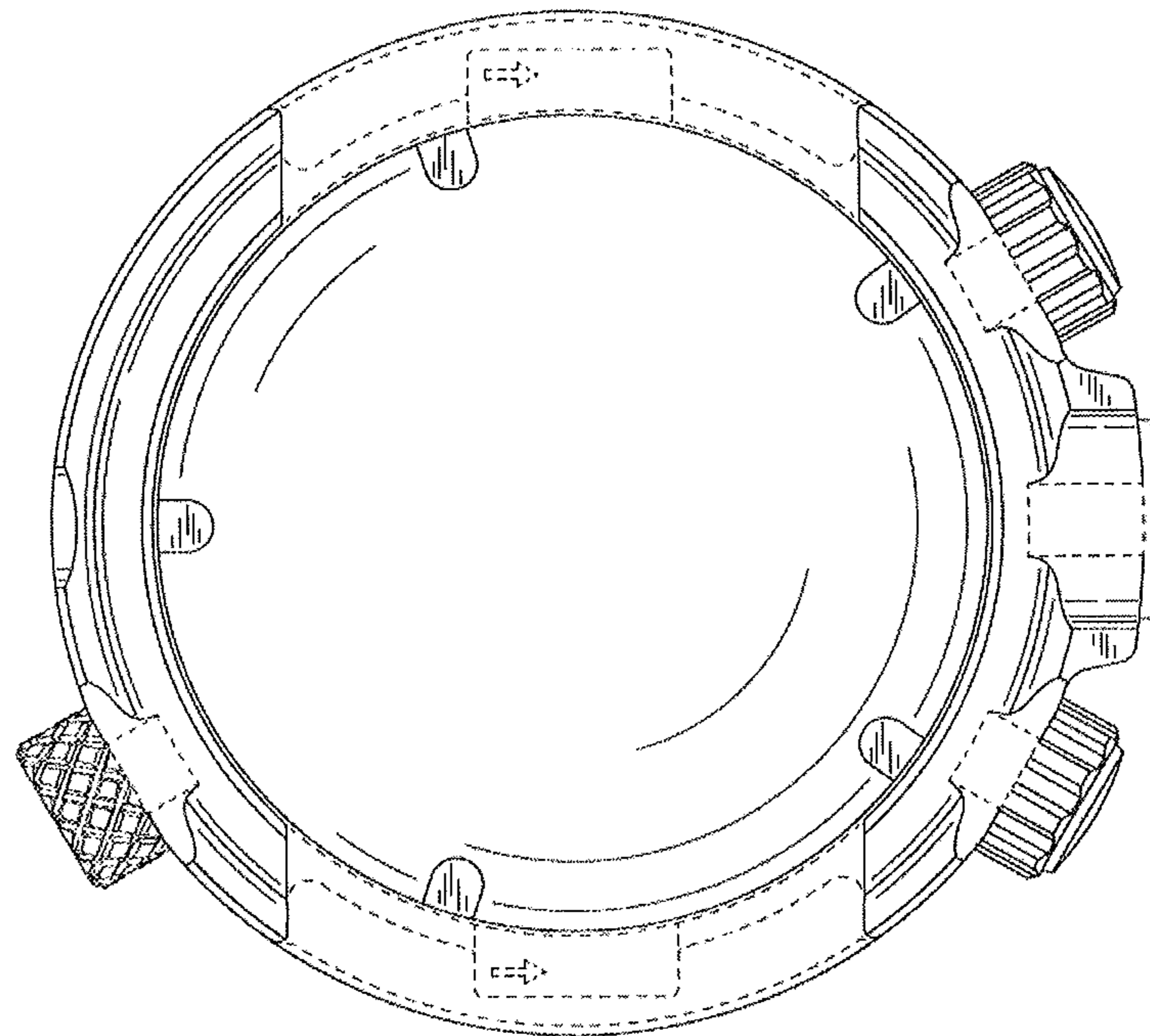

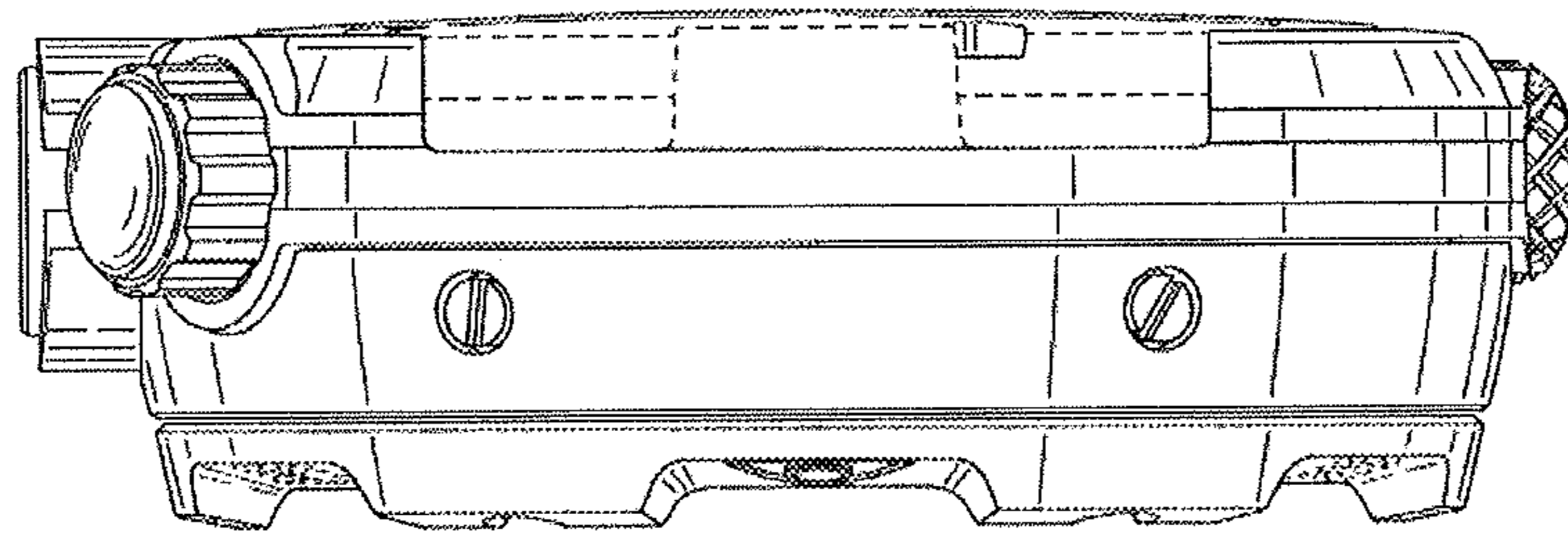
