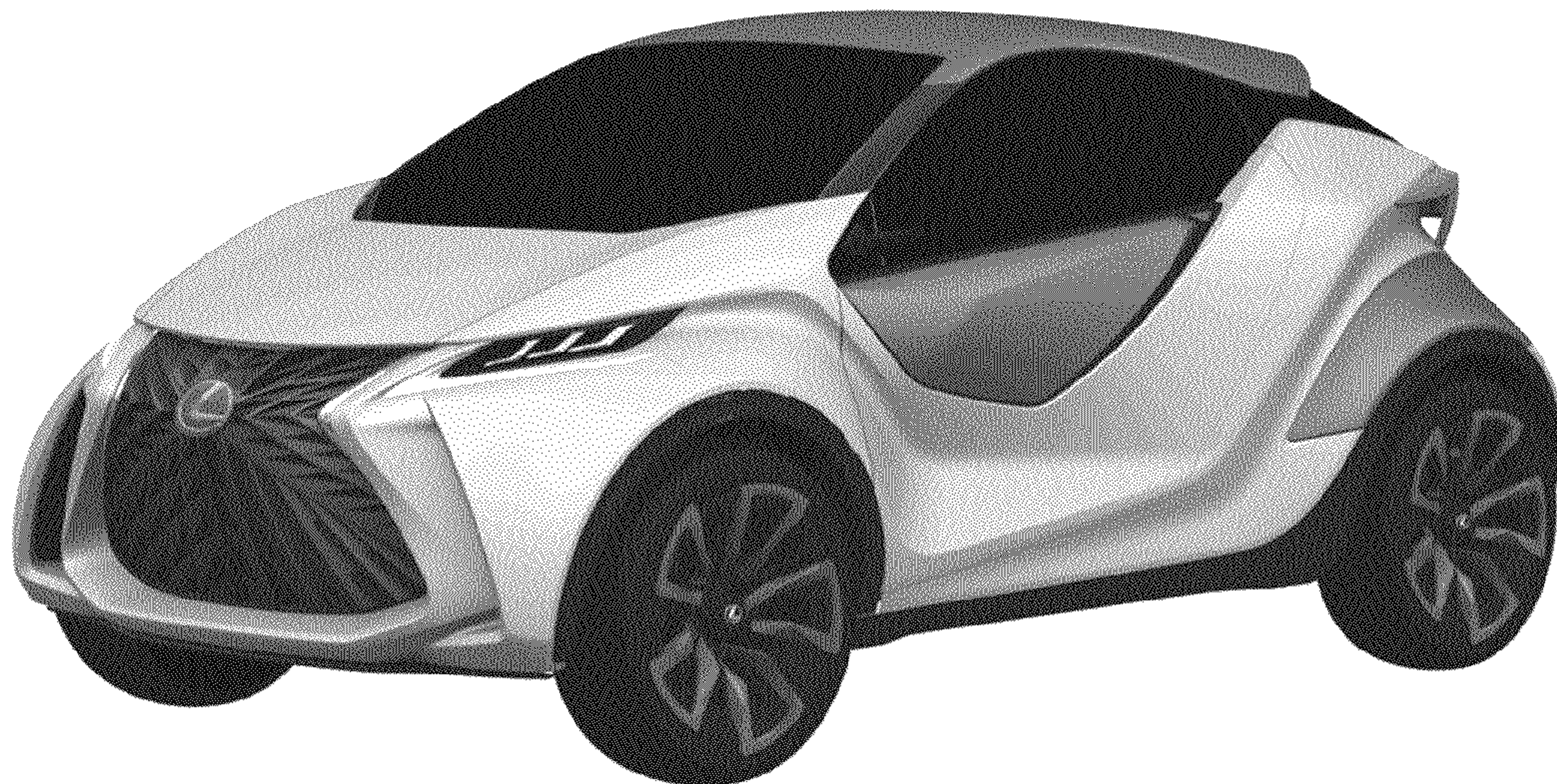
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a motor vehicle and/or toy replica thereof showing our new design;

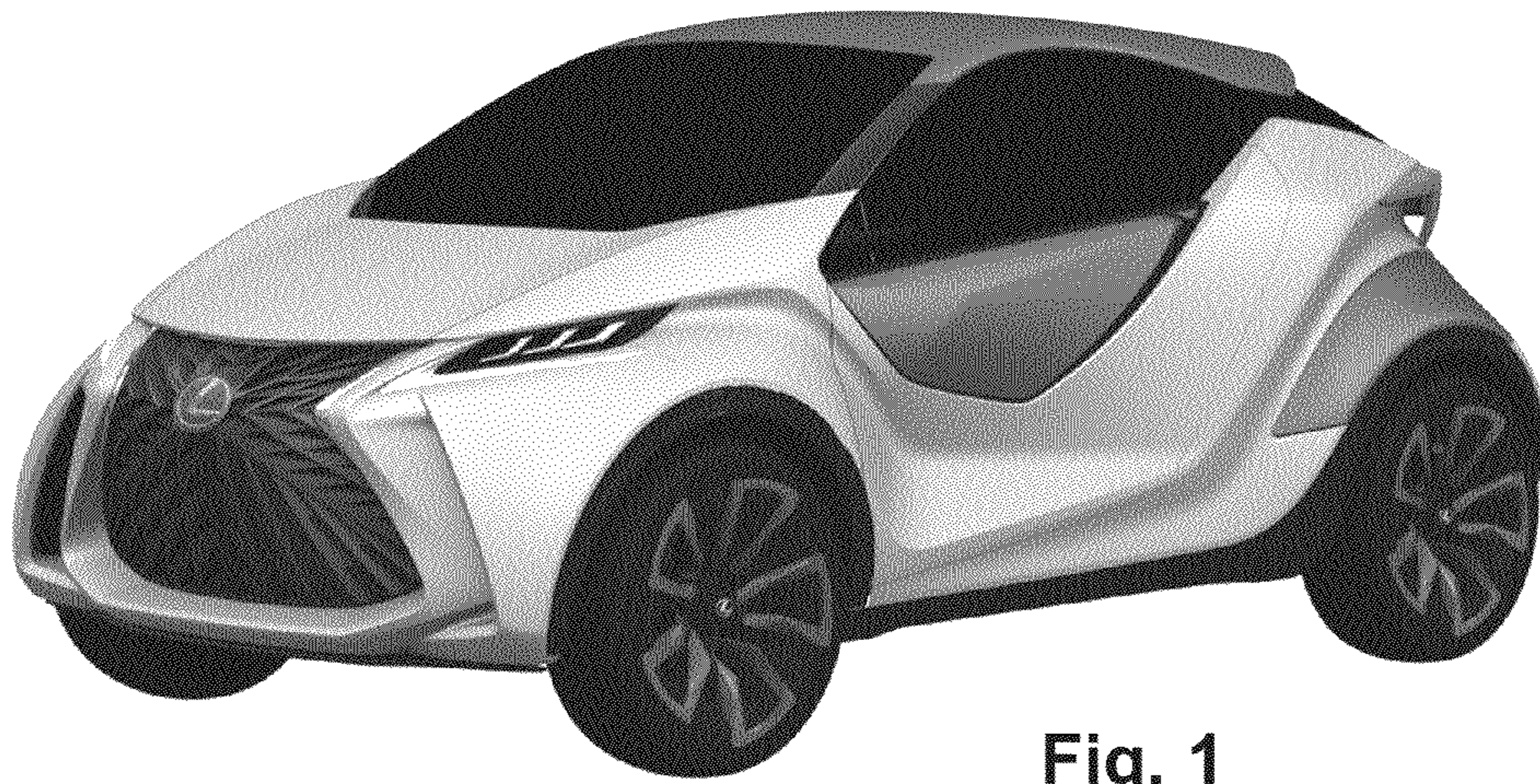

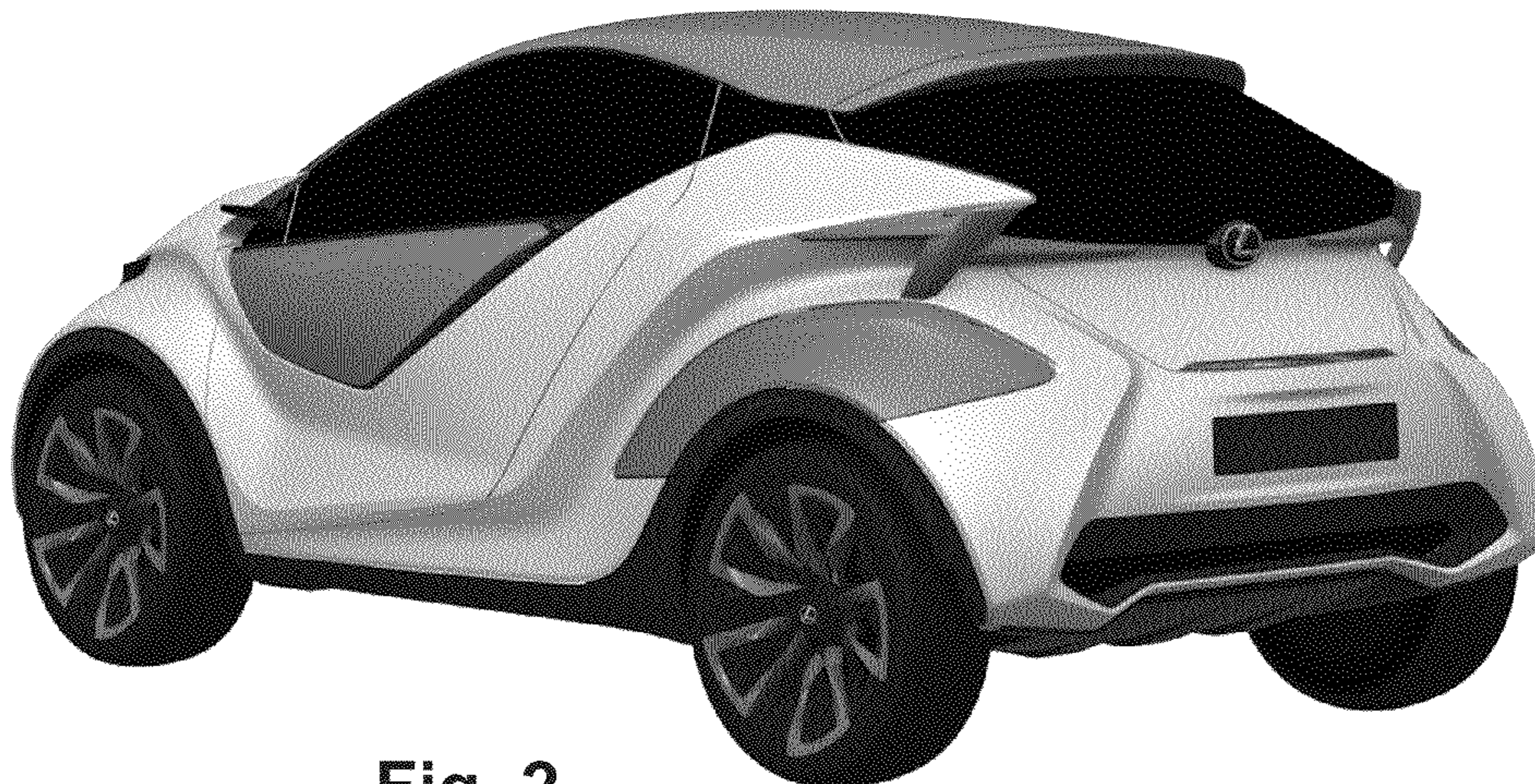

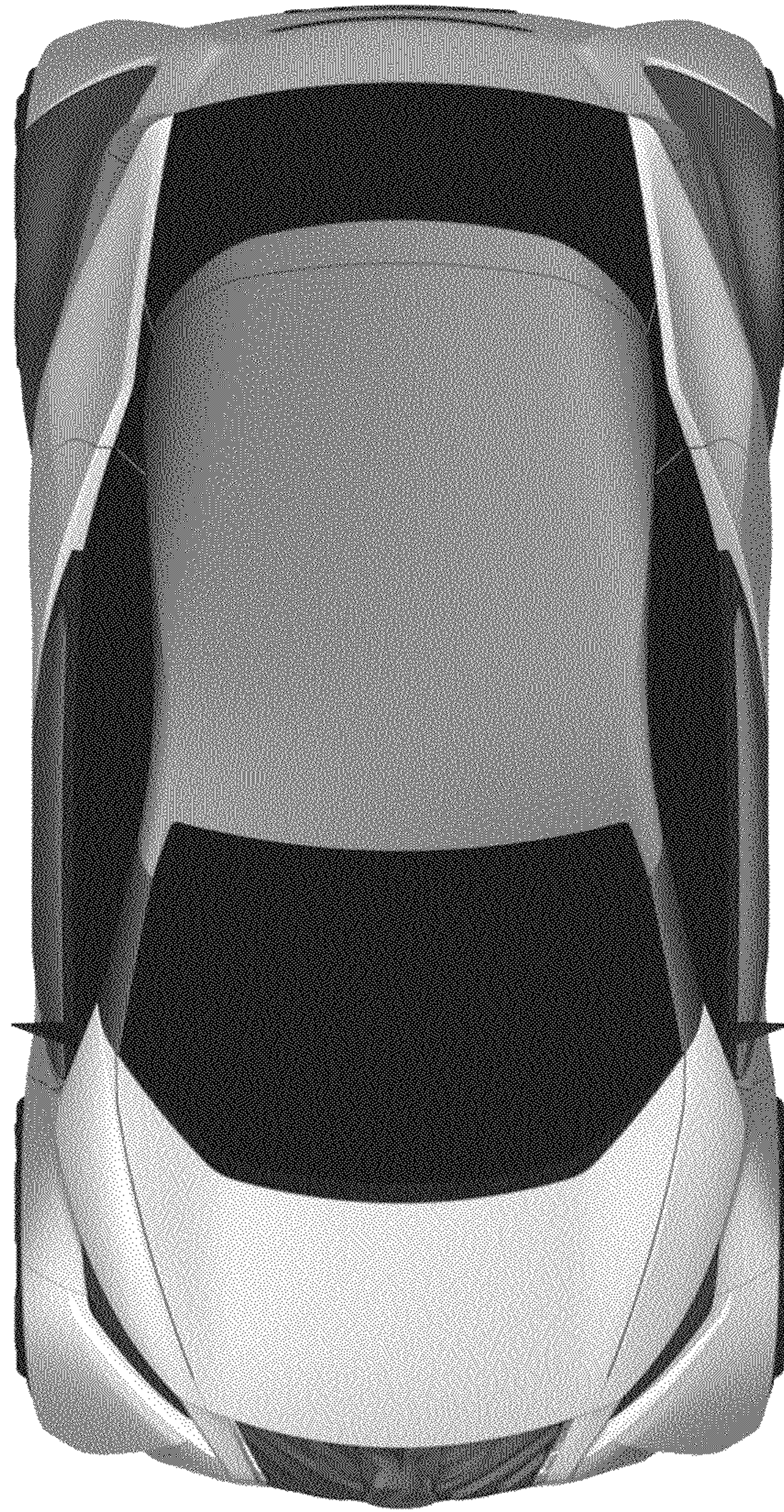

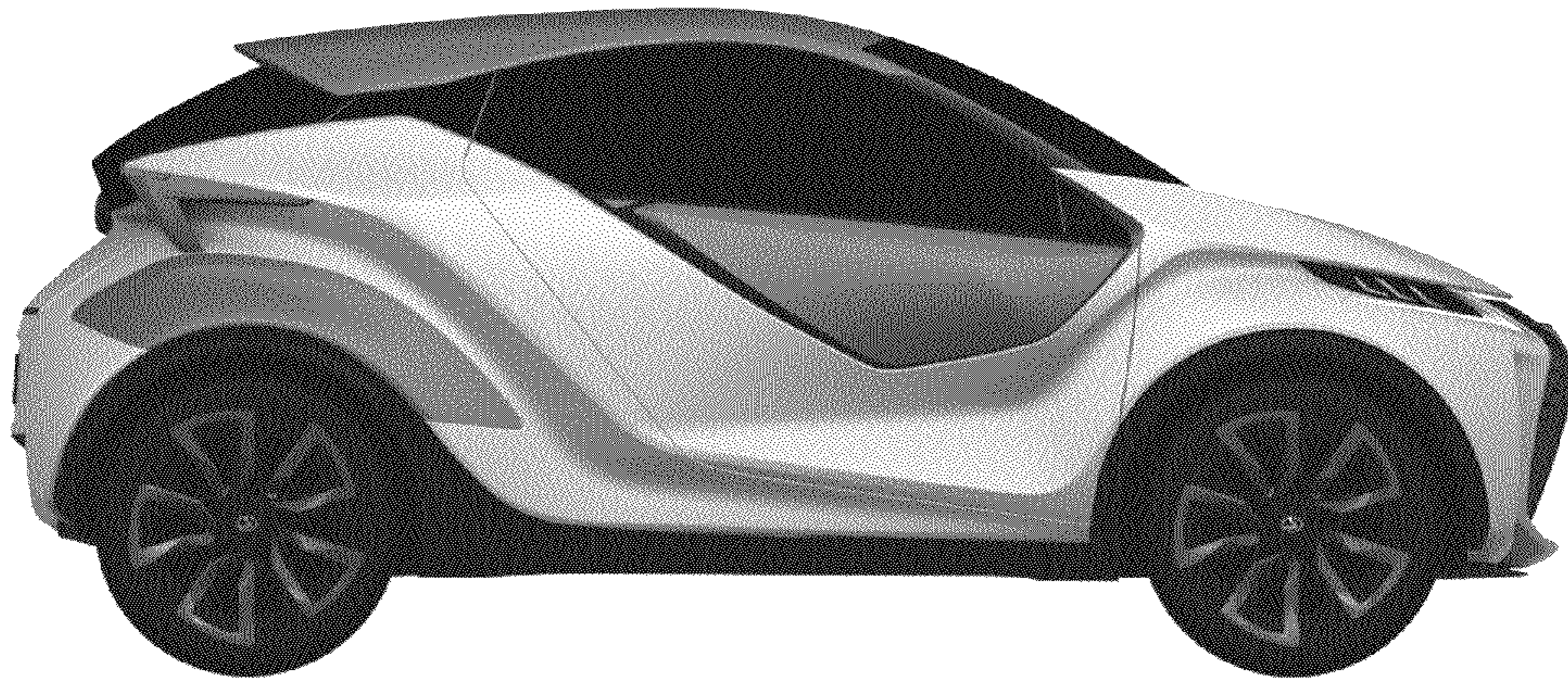

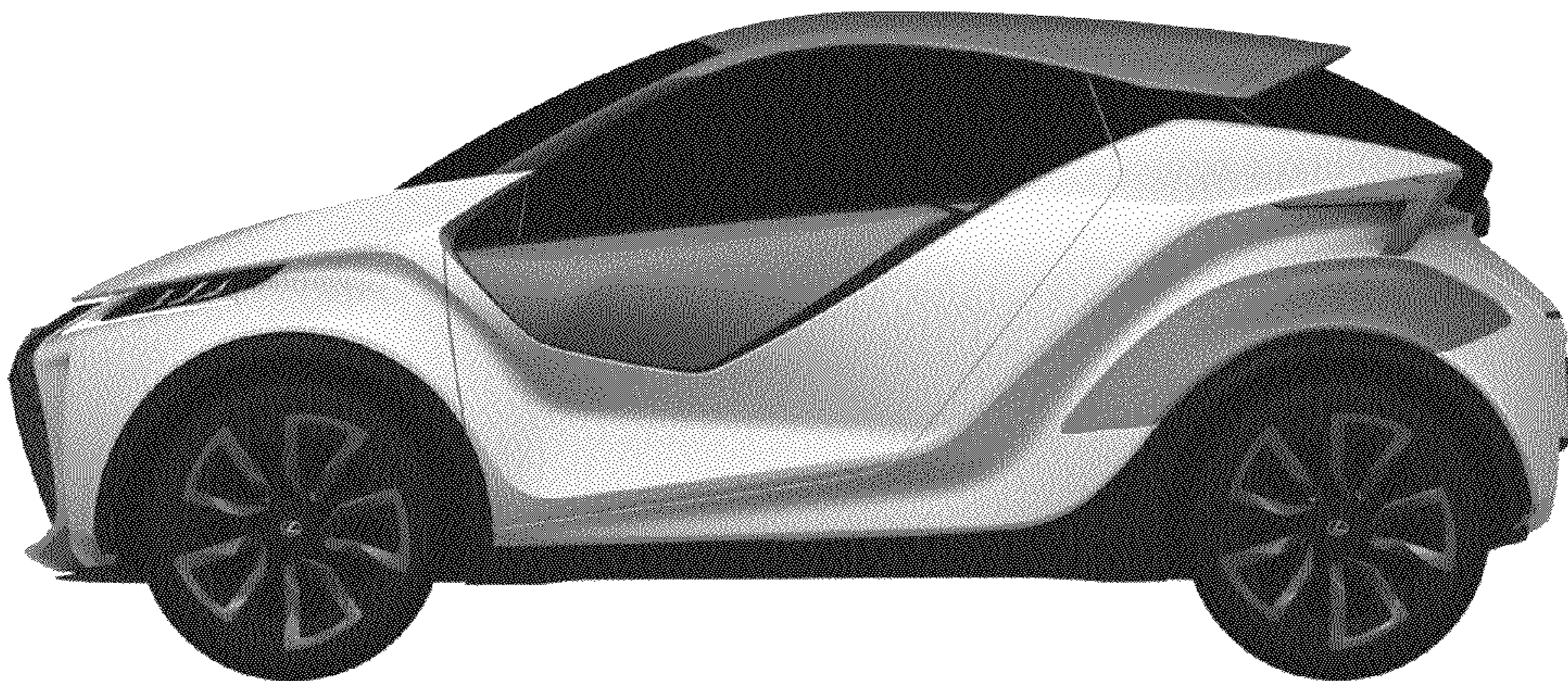
