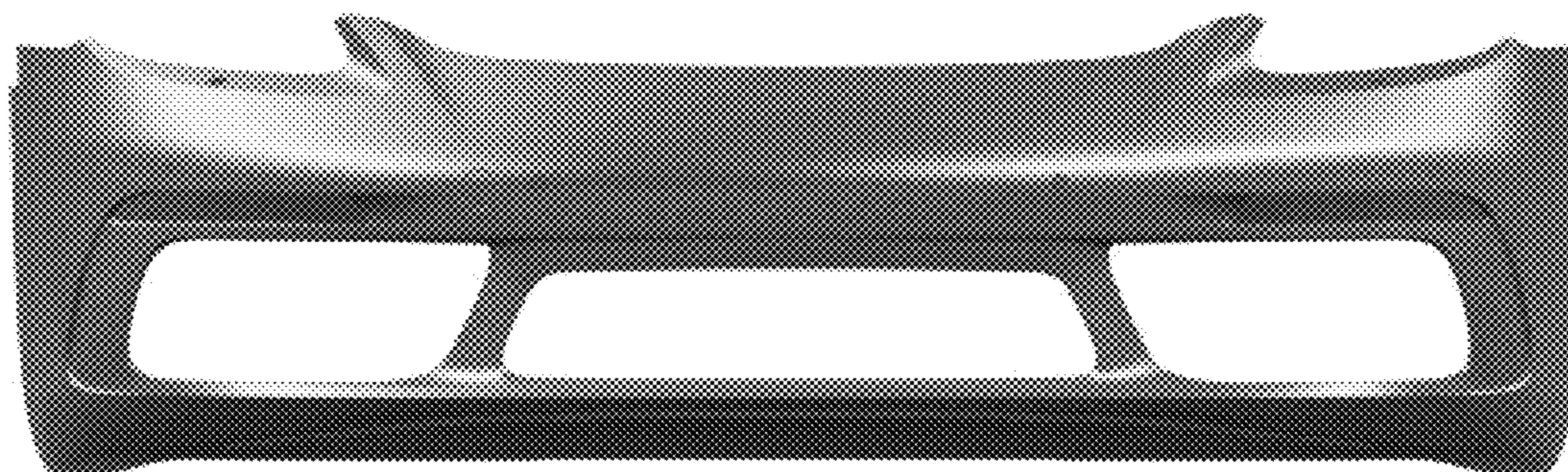

**DESCRIPTION**

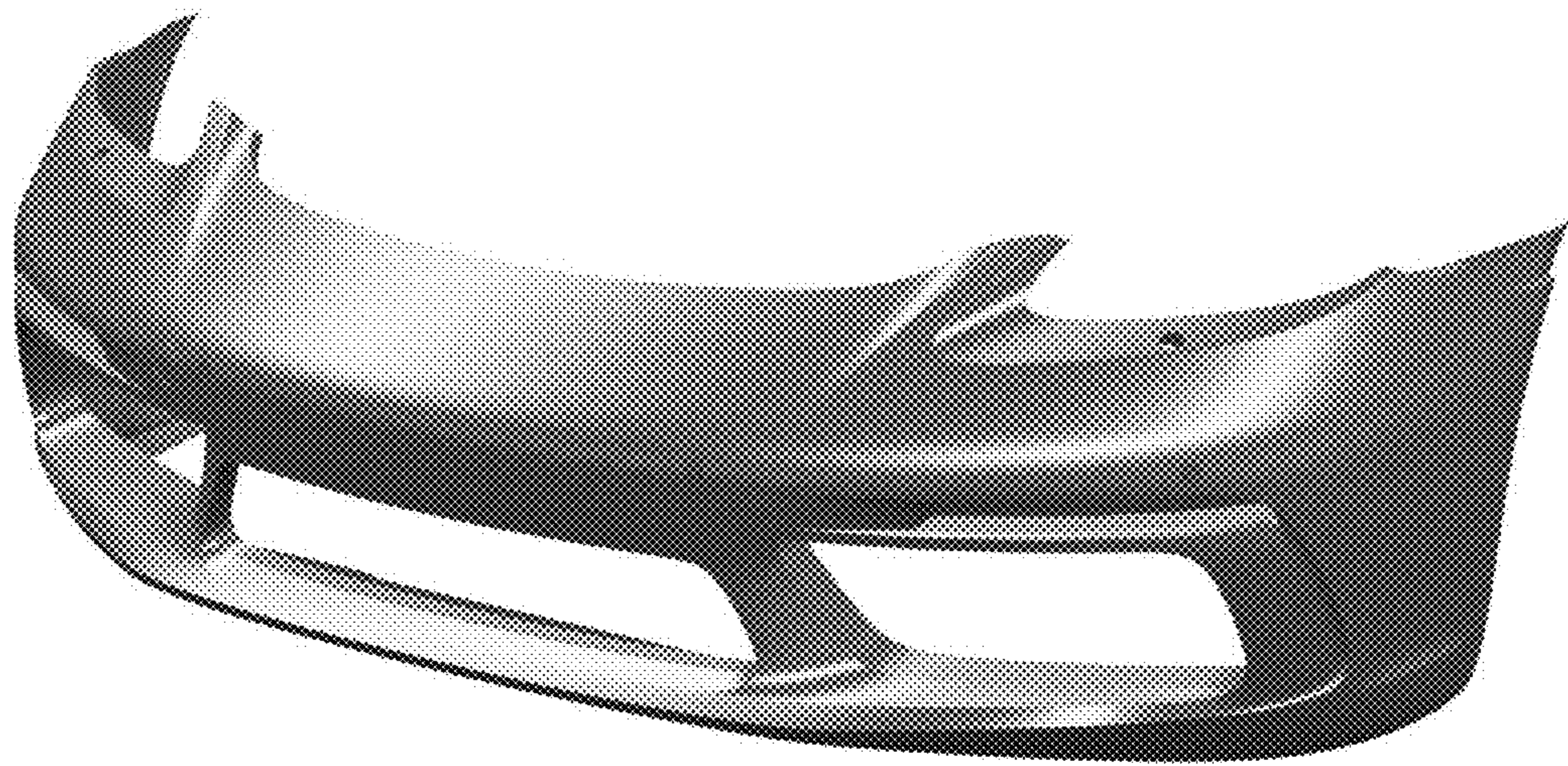

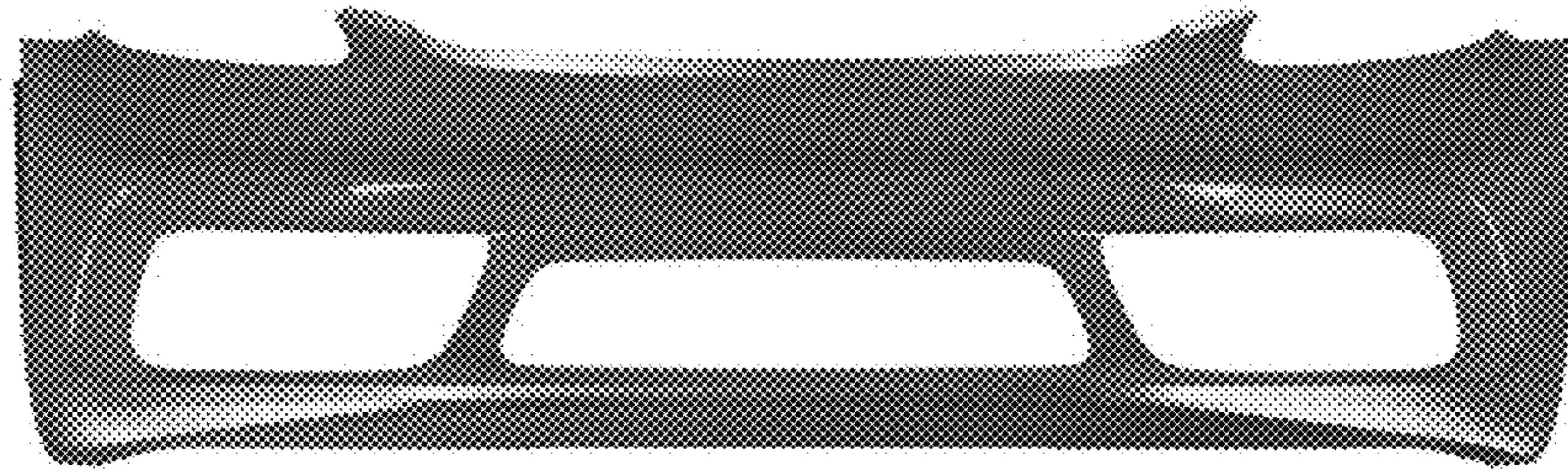

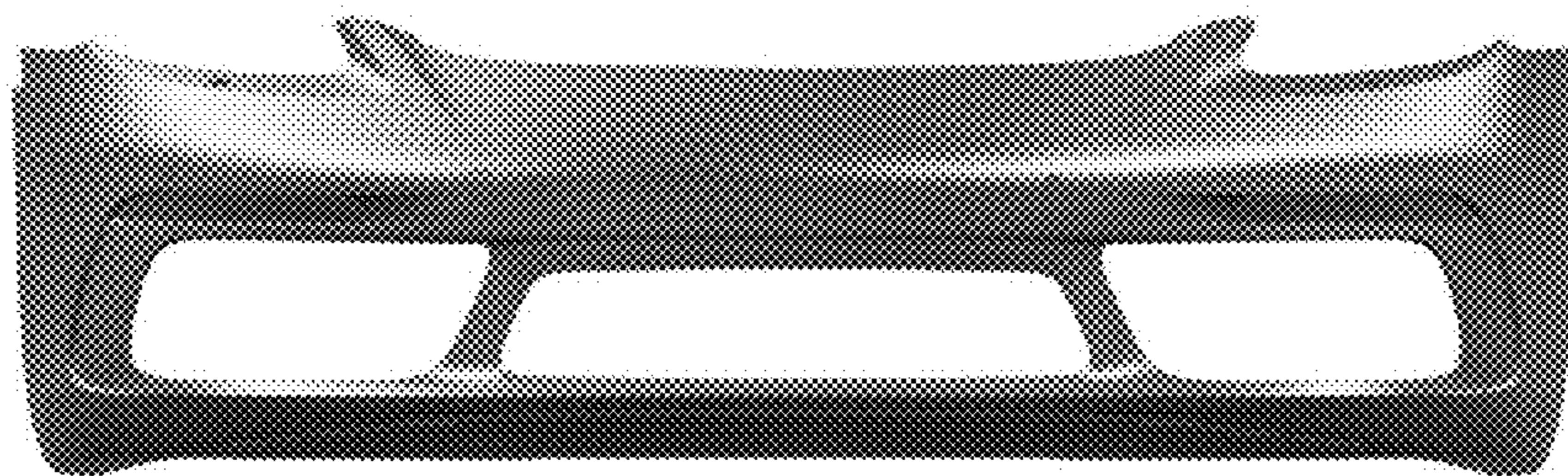

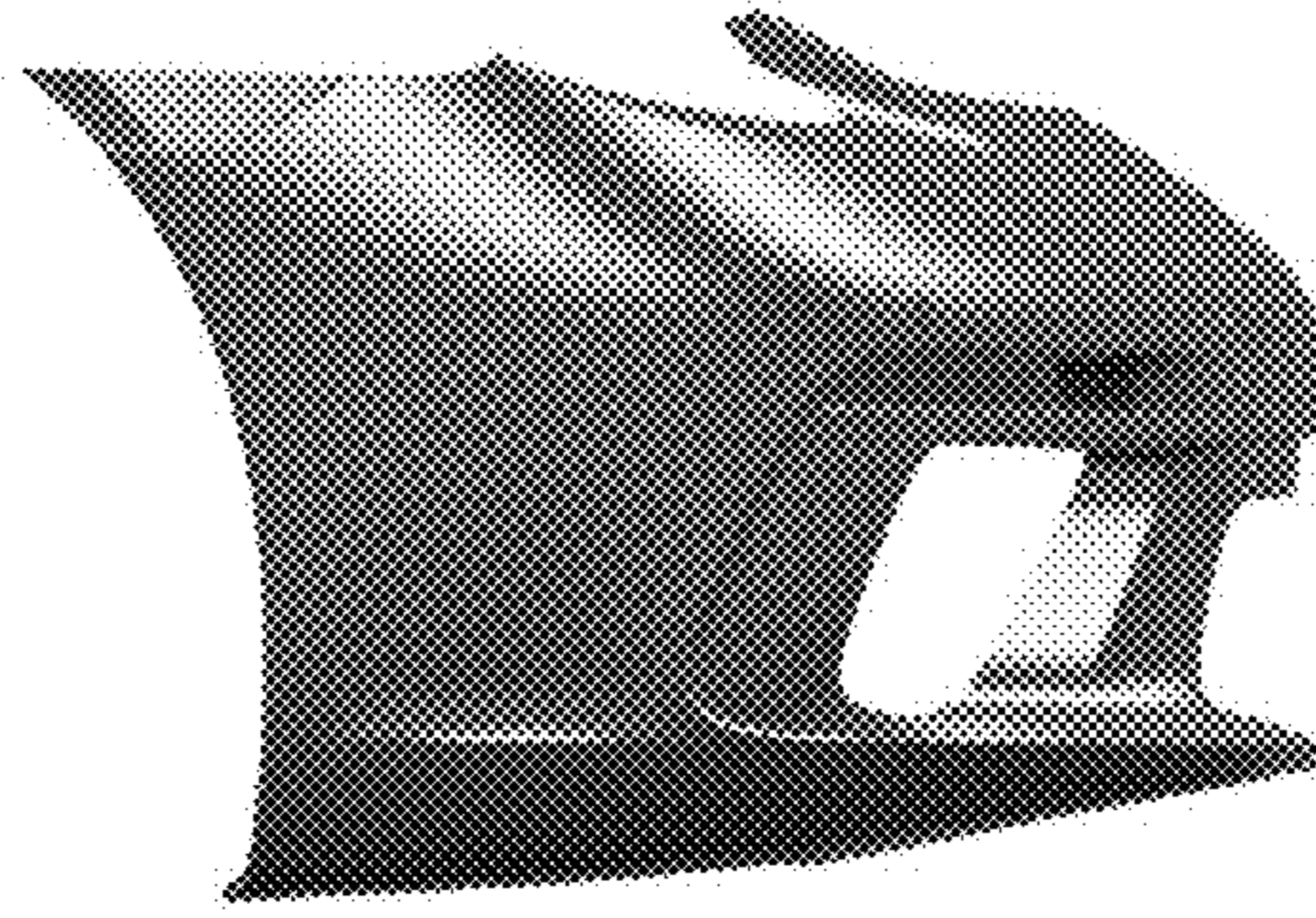

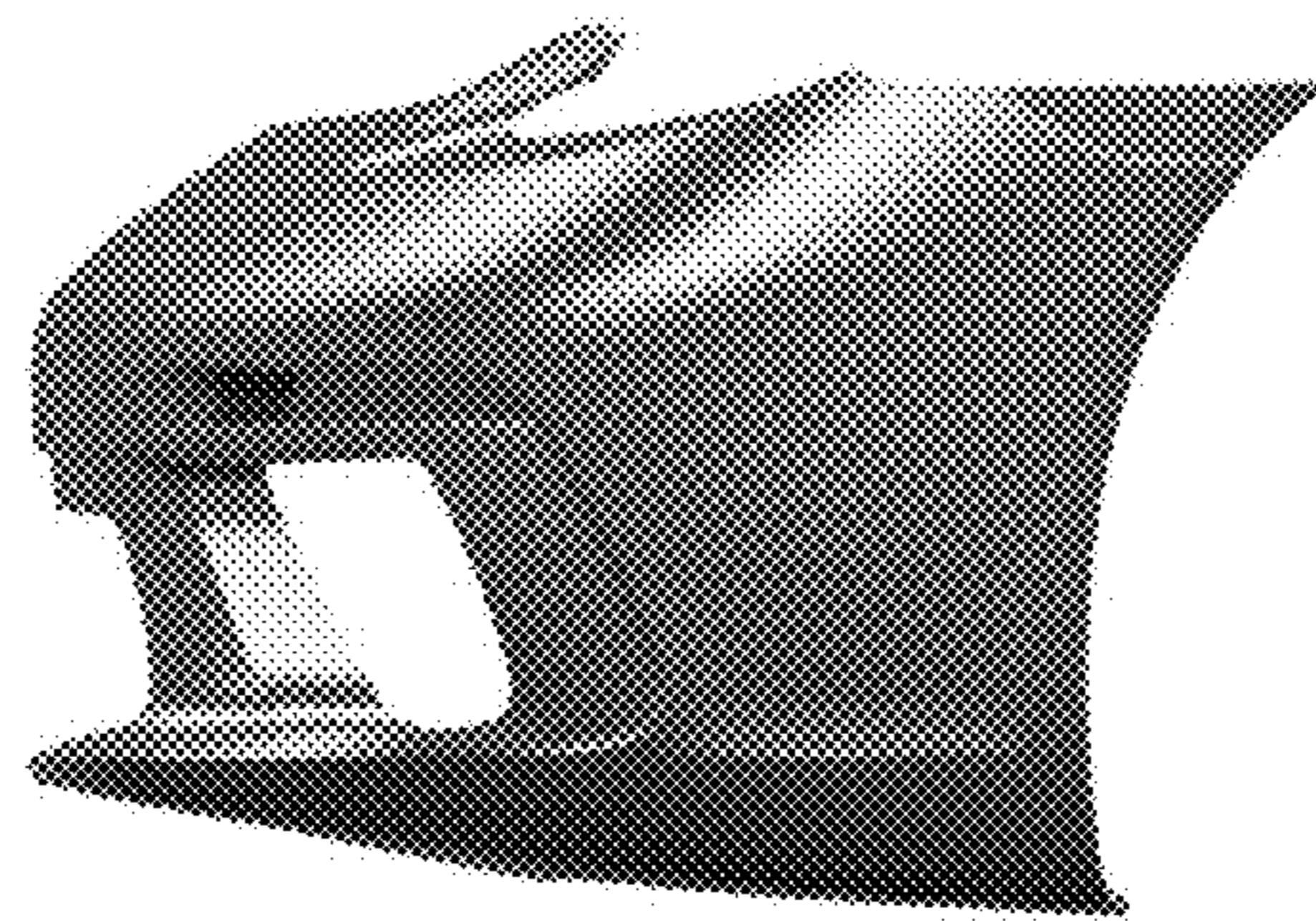

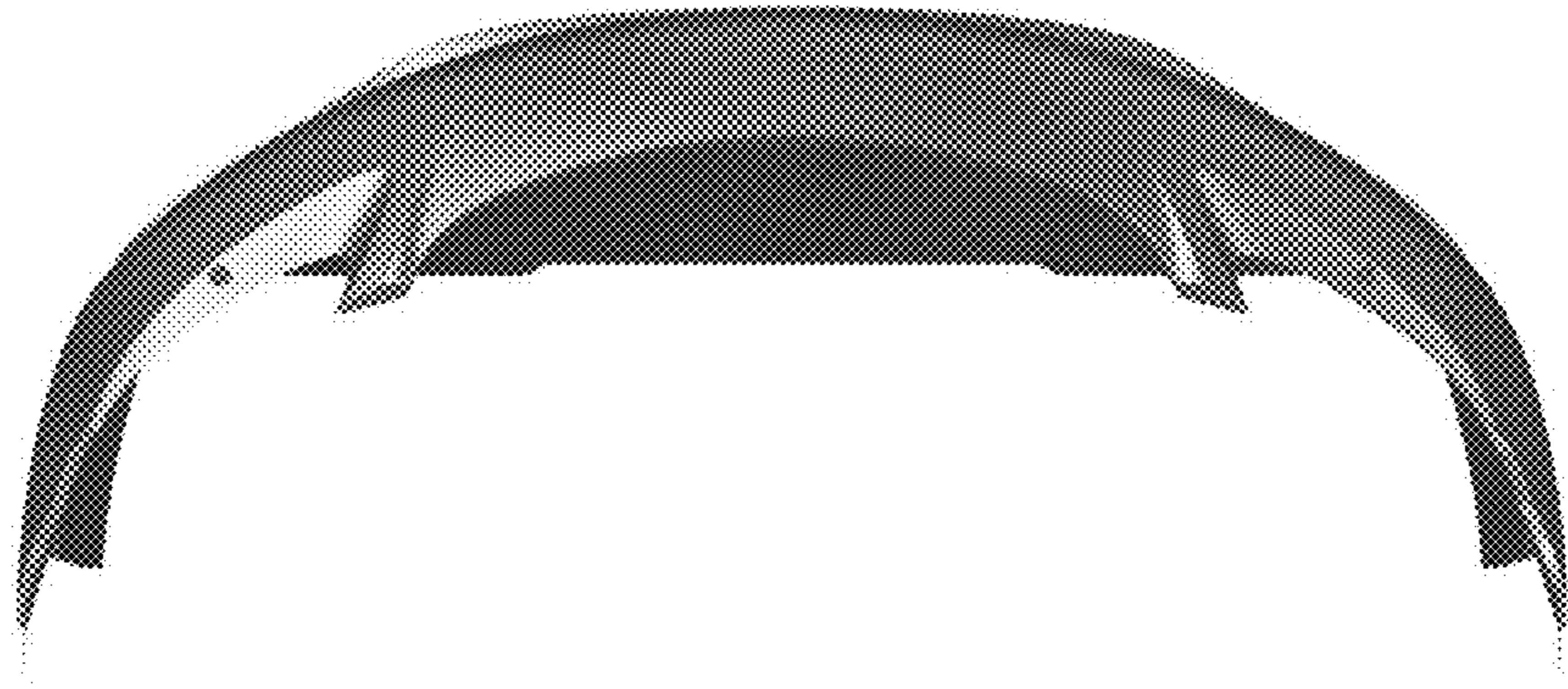
