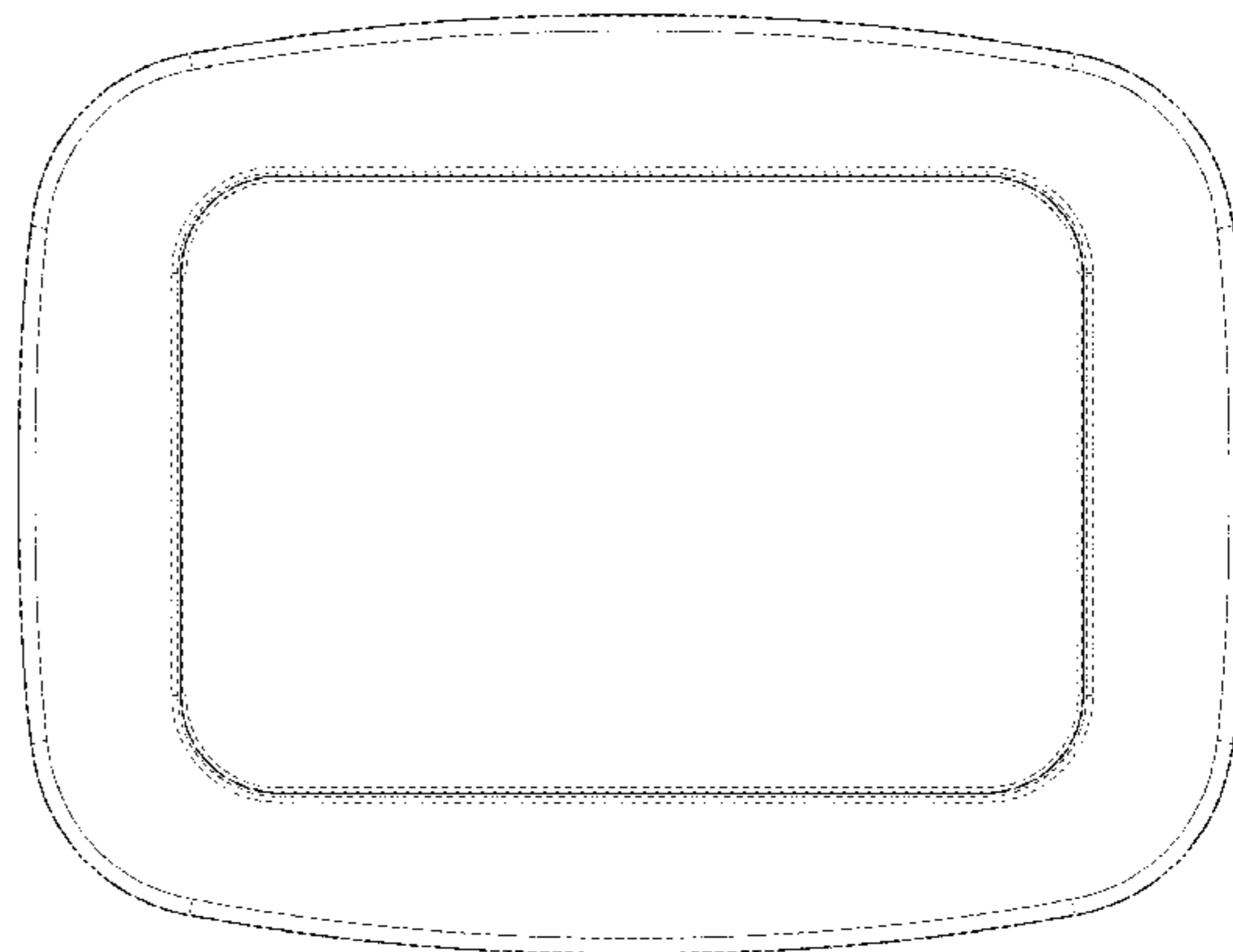
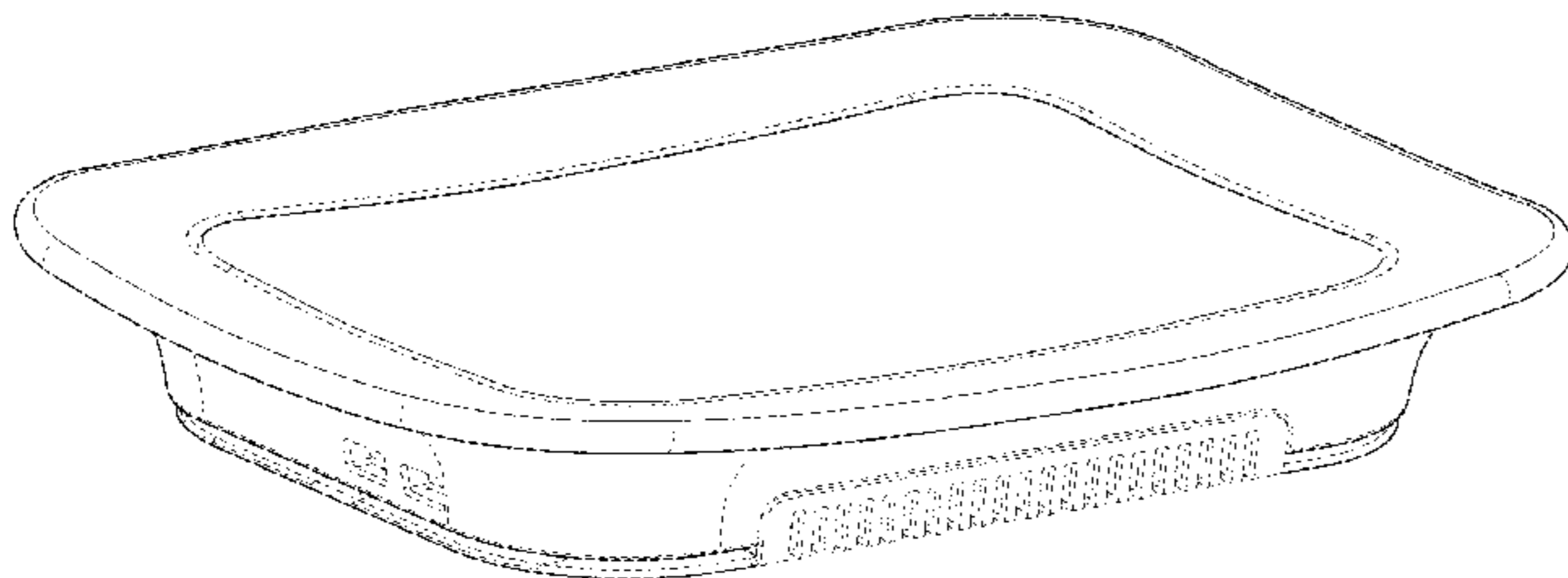

The ornamental design for a charging tray, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, left-hand side perspective view of a charging tray, showing our new, original and ornamental design;
FIG. 2 is a rear view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a right-hand side view thereof;
FIG. 5 is a left-hand side view thereof;
FIG. 6 is a top view thereof; and,

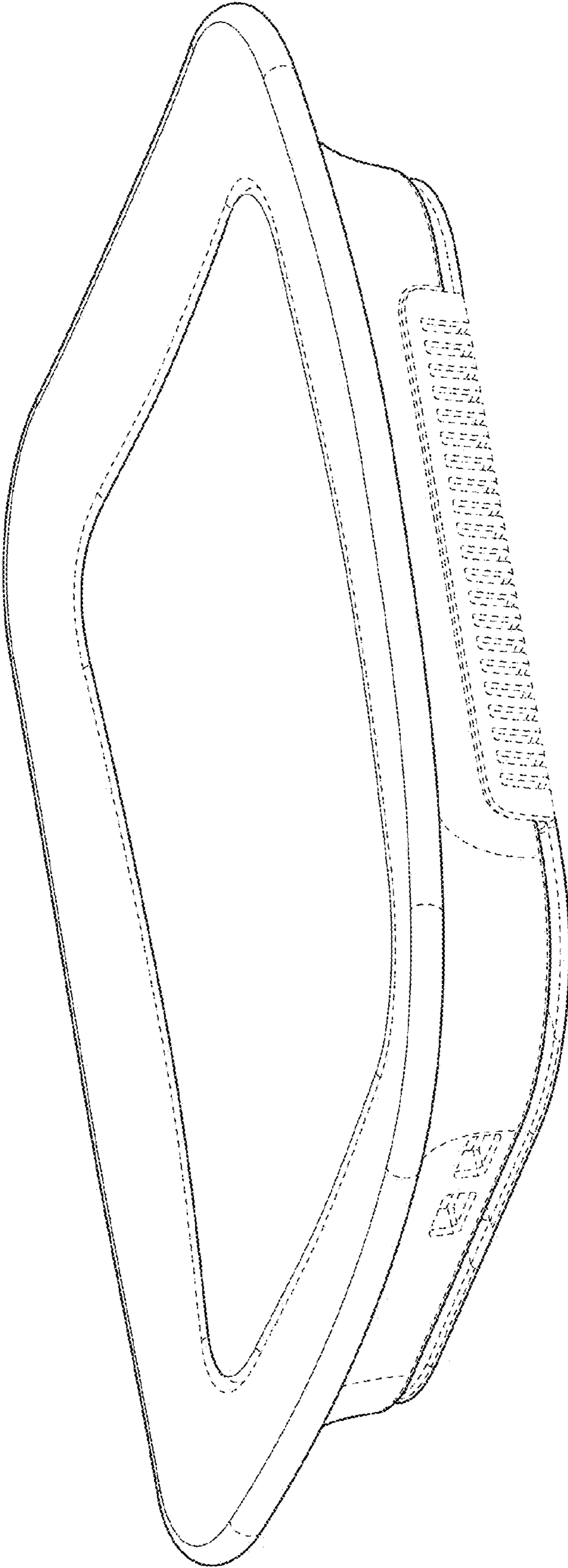

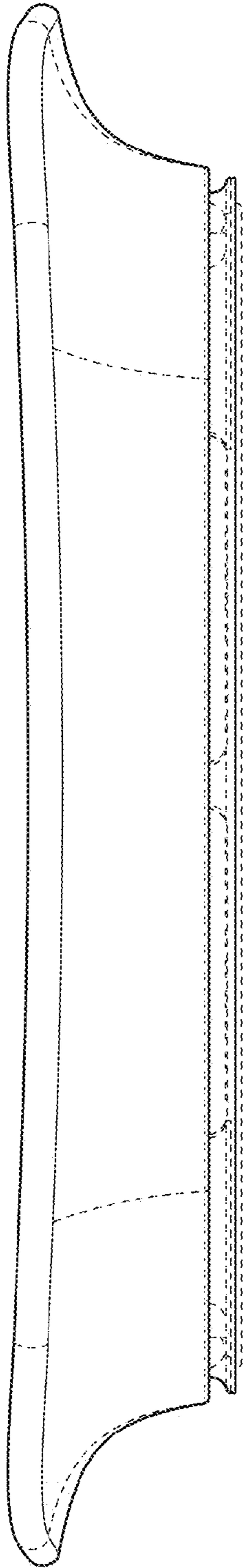

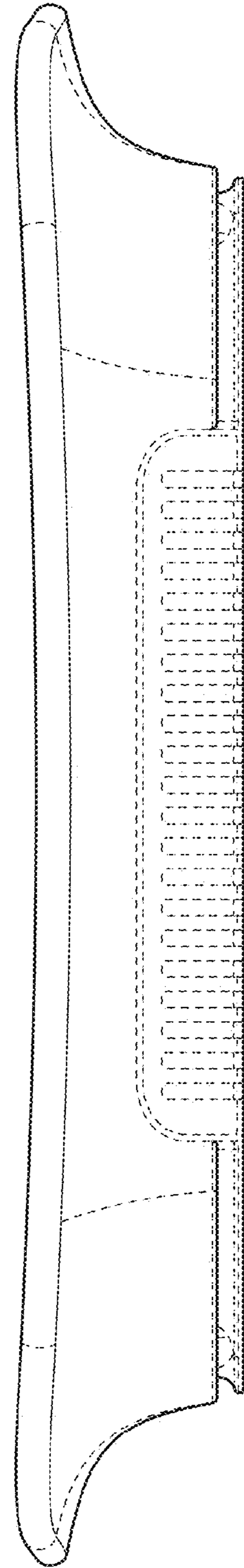

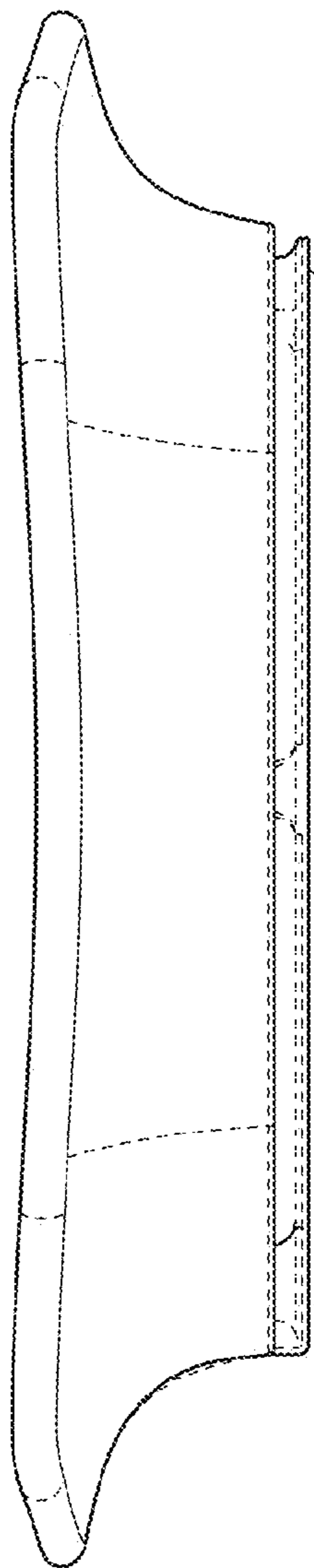

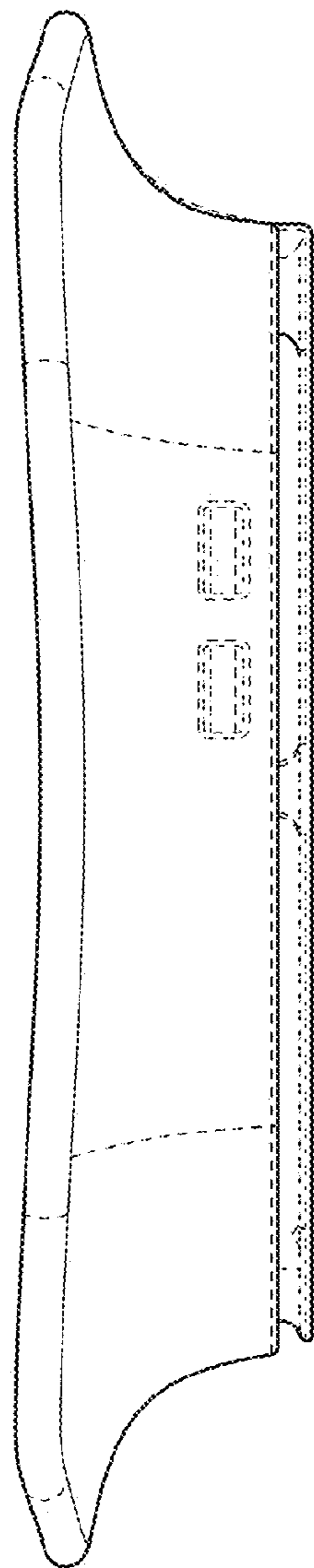

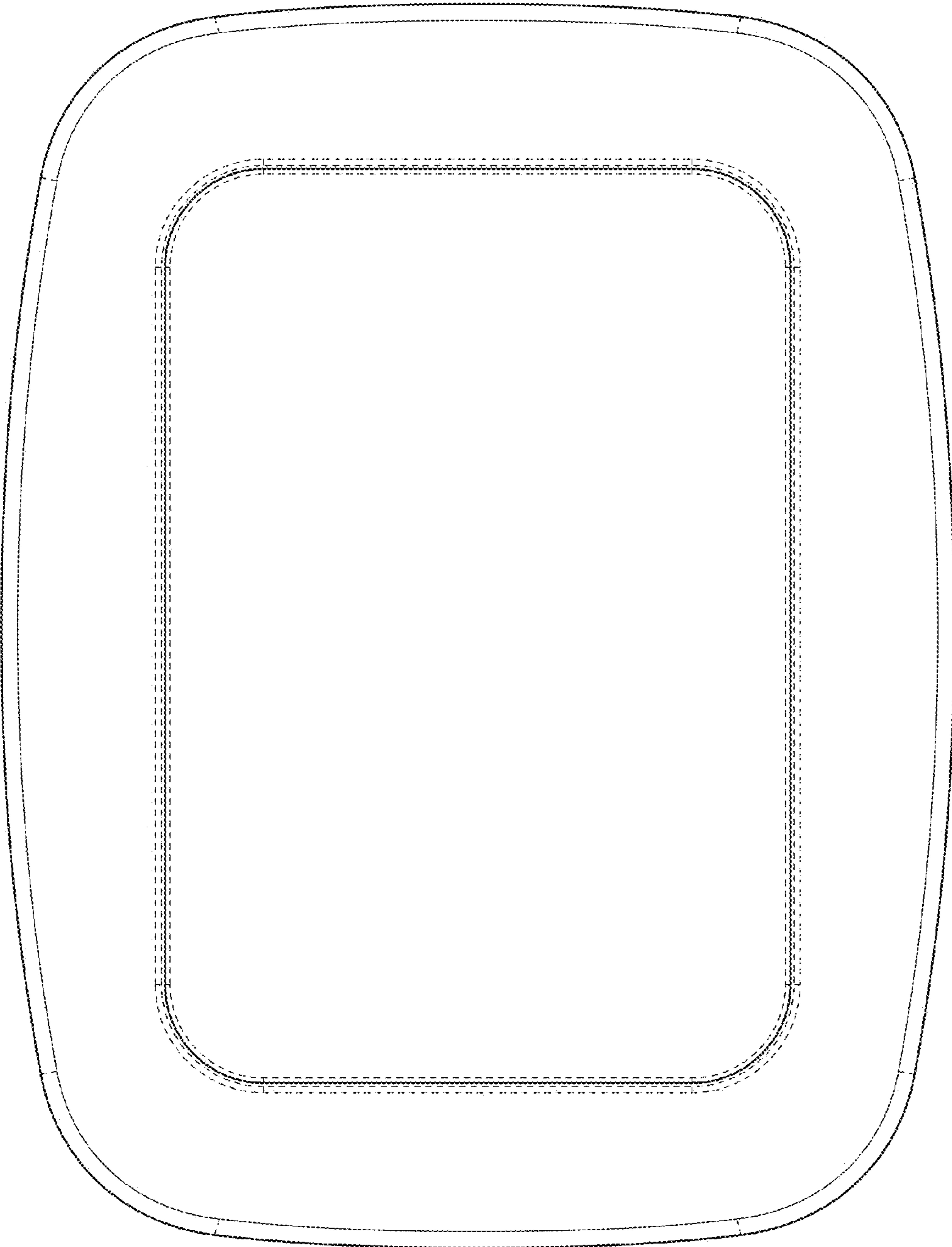

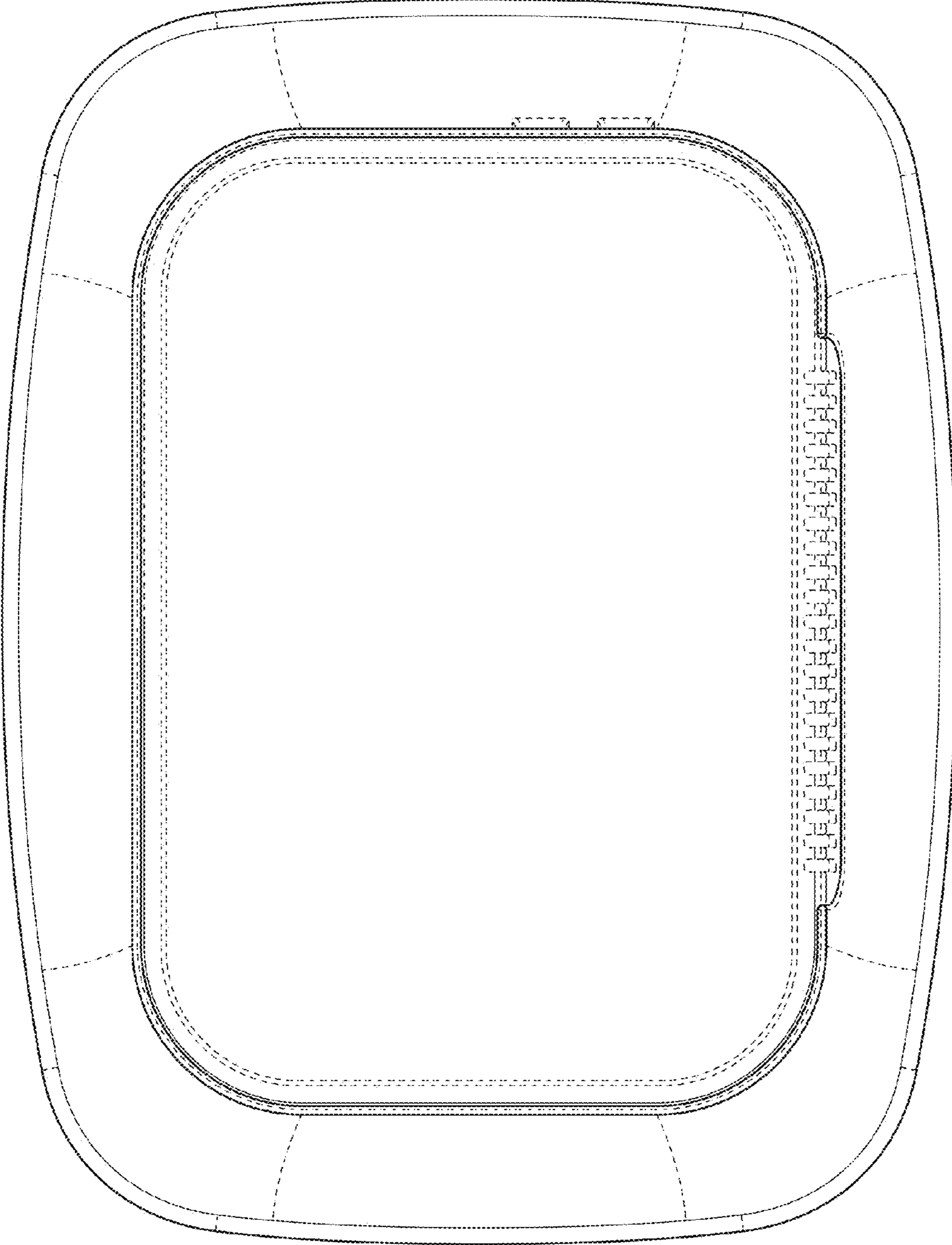
